Trust Deficit

ost people will agree that trust in government and in politicians has reached an all-time low. This is not a phenomenon confined to a few countries only. Democracies around the world are. according to the Edelman Trust Barometer, distrusted by a majority of their citizens; this was almost 80% of the people in 2018. The trust deficit locally is evidenced by the rising abstention rate at most elections, starting from 1995 with 20%, and reaching around 23% in 2019. If that trend were to continue. fewer Mauritians will trust their politicians and political institutions, resulting in ineffective government - "illegitimate" according to the opposition.

The present government was voted to power by only 37% of those who turned out to cast their votes - an electoral victory that should not have given great comfort to its leaders (and that has been challenged in court by the opposition), and one that it should have set out to fix since its early days in power. After an initial success at managing the challenges of the Covid-19 threat though marred by suspicions concerning the timing of the lockdown, allegedly decided to allow some VVIPs to fly back to the country in good time - its governance of the country has been marked by a series of scandals involving members of the government and their protégés that it could have done without. Whether it was about the "emergency procurement" of medical supplies and equipment (running into more than one billion rupees from dubious suppliers in some cases) to the St Louis Gate affair which led to the revocation of the former Deputy Prime minister, they all added up to diminish the social capital that the successful control of the pandemic was building up.

The latest downgrade follows upon the delayed response of the government to the shipwreck of the MV Wakashio off Pointe d'Esny on 25 July. The subsequent oil spill in the region 12 days later could have been averted, according to experts, if immediate measures had been taken - notwithstanding weather conditions - to pump out the oil from the ship. The reaction to the delay has been all manner of speculations and allegations in the press and on social media about suspicious goings-on since the day the ship ran aground and thereafter. The latest mishap is the death of several dolphins on the eastern coasts. It is inevitable that not only environmental campaigners but even the people at large would link these deaths to the oil spill

or to the authorities' decision to sink the ship's stem. The cause may not have as yet been firmly established by a post-mortem, but it is quite likely that the official report would be met with scepticism by the people given the trust deficit that has set in, widening further the gap between the government and the people.

In a contribution on 'trust and politicians', Mark Evans, Professor of Governance at the University of Canberra argues that 'weakening political trust erodes authority and civic engagement, reduces support for evidence-based public policies. This also creates the space for the rise of authoritarian-populist forces or other forms of independent representation'.

The major challenge that the government is facing now is how to recoup the lost trust and to reverse the continuing downward trend. Definitely there is a need for more openness and for giving the right information and answers that would lift the opaque veil that is surrounding this whole incident. Did Minister Sudheer Maudhoo genuinely think people would believe him when he said that the death of the dolphins was not due to the oil pollution? Wouldn't it have been better to admit that the cause was not known for certain as yet but that expert opinion was awaited and would be communicated to the people as soon as it was available?

That, in fact, is the crux of the matter: the communication gap that is feeding into the trust deficit. People would be loathe to trust a government that has lost its mojo in less than a year of its successfully having returned to power. And that would make governing difficult, an uphill task to convince people of the soundness of government's policies, what with the extra-parliamentary opposition that is made up of the triad of defeated parties that Labour Party, PMSD and MMM constitute.

Faced with all this, the government with more than four years to go has yet time to make amends and corrections, be more forthcoming and truthful so as to try and regain credibility. And if in a spirit of national interest it would not hesitate to rope in the best advice locally available about the way forward from wherever that comes, that would certainly be a start to build back the vital element of trust without which governing will continue to be difficult. The ball is in government's court.

The Conversation The right to vote is not in the Constitution

The framers of the Constitution never mentioned a right to vote. They didn't forget. They intentionally left it out.

f you're looking for the right to vote, you won't find it in the United States Constitution or the Bill of Rights.

The Bill of Rights recognizes the core rights of citizens in a democracy. including freedom of religion, speech, press and assembly. It then recognizes several insurance policies against an abusive government that would attempt to limit these liberties: weapons; the privacy of houses and personal information; protections against false criminal prosecution or repres-

sive civil trials; and limits on excessive punishments by the government.

But the framers of the Constitution never mentioned a right to vote. They didn't forget - they intentionally left it out. To put it most simply, the founders didn't trust ordinary citizens to endorse the rights of others.

They were creating a radical experiment in self-government paired with the protection of individual rights that are often resented by the majority. As a result, they did not lay out an inherent right to vote because they feared rule by the masses would mean the destruction of - not better protection for - all the other rights the Constitution and Bill of Rights uphold. Instead, they highlighted other core rights over the vote, creating a tension that remains today.

Relying on the elite to protect minority rights

Many of the rights the founders enumerated protect small groups from the power of the majority - for instance, those who would say or publish unpopular statements, or practice unpopular religions, or hold more property than others. James Madison, a principal architect of the U.S. Constitution and the drafter of the Bill of Rights, was an intellectual and landowner who saw the two as strongly linked.

At the Constitutional Convention in 1787, Madison expressed the prevailing view that "the freeholders of the country would be the safest depositories of republican liberty," meaning only

people who owned land debt-free, without mortgages, would be able to vote. The Constitution left voting rules to individual states, which had long-standing laws limiting the vote to those freeholders.

In the debates over the ratification of the Constitution, Madison trumpeted a benefit of the new system: the "total exclusion of the people in their collective capacity." Even as the nation shifted toward broader inclusion in politics, Madison maintained his view that rights were fragile and ordinary people untrustworthy. In his 70s, he opposed the expansion of the franchise to nonlanded citizens when it was considered at Virginia's Constitutional Convention in 1829, emphasizing that "the great danger is that the majority may not sufficiently respect the rights of the Minority."


The founders believed that freedoms and rights would require the protection of an educated elite group of citizens, against an intolerant majority. They understood that protected rights and mass voting could be contradictorv.

Scholarship in political science backs up many of the founders' assessments. One of the field's clear findings is that elites support the protection of minority rights far more than ordinary citizens do.

Protests: Facts more important than narrative



Protest movements across the world seem to have entered a new cycle beginning with the uprising in Tunisia in December 2010, then spreading in the Arab world – later to be known as the 'Arab Spring' – as a series of anti-government protests and armed rebellions in

the early 2010s. They were in response to oppressive regimes and a low standard of living.

This movement came a little over 40 years after the student revolt of Paris in 1968, which inspired student demonstrations in the US in the following year against the 'war in Vietnam and oppressive policing'. Students for a Democratic Society (SDS) led mass protests and sitins across the States but increasing factionalism within its ranks and the end of the Vietnam War contributed to its demise in the mid-Seventies (online source). Later student movements were 'against apartheid, nuclear weapons, destruction of the environment and cuts in funding for education'.

The current cycle entered a new phase with the protracted Gilets jaunes uprising in Paris that triggered similar protests in some European countries, and next the widespread street protests in Hong Kong before it came to an end with the imposition of recently passed legislation in the country. In India there were the anti-CAA protests that led to the Delhi riots. That was before the confinement because of Covid-19. The latest series of protests arose in the US after the killing of Black American George Floyd by the police a few weeks ago, which led to the Black Lives Matter (BLM) movement across the country that has since been ongoing. The latest incident that has literally added more fuel to the fire is the shooting of another Black American, Jacob Blake by the police in Kenosha, Wisconsin where protests were already under way. The shooting has sparked a further wave of protests, some of which have turned violent after two people were killed and

Inevitably, police present to maintain discipline get involved; in their turn they are attacked and retaliate, with shooting where police are allowed to be armed, and there then follows mayhem with arson, looting, damage to public property, attacks on innocent civilians, stone pelting, etc. Sadhguru of the Isha Foundation has made a very lucid and rational analysis of the phenomenon in a discussion with young people about the anti-CAA protests, which should be required viewing by anyone who is interested in gaining some understanding of the complexity of forces and issues that are involved.

In his analysis, Sadhguru with his own brand of subtle and intelligent humour puts emphasis on the facts which are the fundamental elements of concern for a truly objective assessment of any such situation, especially of the type that is about social issues which tend to raise passions. And this is the way it should be when any protest is undertaken, and I hope that this will be the case with the pacific march planned for tomorrow in Port Louis: stick to the facts, and not peddle narratives of a communal nature which are circulated on social media and taken as gospel truth. This is what happened with the flyers that were paraded during the earlier march which was about the injustices to workers that were deemed to be present in the

Covid-19 Bill that was passed by the National Assembly.

These days, most people tend to resort to social media as their sole source of knowledge, instead of thinking for themselves based on facts and figures available before drawing their own conclusion. The focus of tomorrow's march is supcountry – are known for. Besides, another major issue is the damage that has been caused to the marine ecosystem in that stretch of the ocean, which is recognized by the UN as a unique biodiversity site. There are short-term and long-term environmental impacts that are to be analysed, along with the measures that must be undertaken to mitigate, correct and compensate for them. On top of that come the claims that will be made directly related to the shipwreck itself, and to the subsequent oil spill, which are complex enough as it is with all the legal and other complications that they entail.

Put together, one can see that there are more than enough issues about which there has been no clarity, and here again, we can learn from Sadhguru, who did not hesitate to say that in relation to the anti-CAA protests, somewhere along the line there had been a deficiency in communication on the part of government. This is also the generalized feeling here in relation to what needs to be known about the Wakashio incident, and it will help to restore both trust and sanity if the authorities were more forthcoming about the real facts relating to that incident, and provide more convincing answers than has hitherto been the case to the queries that the citizens are posing.

And if the protest march keeps that in mind and is able to extract from the authorities that they come clean with the what, how and why of this disaster that





Can we risk opening our borders?

t took six months for the world to register 10 million cases of coronavirus. Despite the application of various sanitary measures and the enforcement of lockdowns by countries across the world to contain the spread of the virus, it took only six weeks for the number of Covid-19 cases in

the world to double. Coro-

navirus cases increased from 3 to 10 million in 38 days and rose from 15 to 20 million in only 20 days. The upshot is that Covid-19 is very much present in our midst across the world and is spreading faster than before.

Statistics compiled by Johns Hopkins University reveal that the United States. Brazil. India. South Africa. Colombia, Mexico, Peru, Argentina, Russia and the Philippines are the top 10 countries accounting most new cases of Covid-19 since July 22. Countries such as Israel, Australia, Peru, Japan, Germany, South Korea or New Zealand which had recorded initial success in containing the spread of the virus are now registering a spike in infections. The worldwide tally of recorded cases of Covid-19 in 188 countries has now exceeded 24 million. More than 830,000 people have died from the virus.

Some of the worst hit countries are those like the United States, Brazil or Mexico whose leaders have ignored the advice of health experts and resisted calls for strict lockdowns and the rigorous application of social distancing and hygiene rules and the wearing of masks.

Surge in Covid-19 cases

There is thus a surge in Covid-19 infection in many countries. Latin America is the current epicentre of the pandemic, according to the World Health Organization. Brazil has the second highest number of cases in the world, after the US, whereas Mexico has the second highest death toll in the region after Brazil. Colombia, Peru, Argentina and Venezuela have all recorded a surge in cases of Covid-19. In Asia, India, Indonesia and Iran have all registered a rise in the number of cases of coronavirus infection whereas in Africa, the number of Covid-19 cases has exceeded one million with South Africa and Egypt being the worst hit countries. South Africa is one of the seven countries in the world to record more than 500,000 cases of coronavirus.

Can we take the risk of a resurgence of Covid-19 which will once again put undue pressure on all the frontline workers of the country who have so valiantly fought the virus and helped save lives during the first wave of infection and risk overwhelming the health services of the country? Can we again put their lives at risk? A resurgence of Covid-19 in the country

will trigger strict confinement rules and a costly lockdown which will shut down economic activities, further slump the tourism sector and halt the sugar harvest and the resurgence of the other key sectors

of the formal and informal economy....*

In Europe, Spain, Italy, Germany, the United Kingdom and France have reported a rise in cases in recent weeks following the lifting of lockdown restrictions. In France, the average number of new daily cases has doubled during the last three weeks to 2000 a day. With schools opening on 1 September, the government has decreed that the wearing of masks in schools is mandatory. Italy has closed nightclubs again and made the wearing of

and the country are fully aware that Covid-19 was imported in Mauritius through carriers of the virus who were either foreign visitors from infected countries, Mauritians working on cruise vessels or repatriated nationals.

With the exception of the tourism sector, most of the important sectors of the economy have rebooted their activities under strict sanitary conditions and are adapting their strategies to surmount the challenges and seize the opportunities of a Covid-19 afflicted world. Mauritius being Covid-19 free, people feel safe to carry on with their daily business without the fear of infection. For example the sugar cane harvest is progressing normally with mask wearing cane cutters from different localities working and

masks compulsory. The spike in cases in Germany has been caused by the return of large numbers of German tourists from their holidays in Covid-19 affected countries. The UK has also enforced stricter restrictions in various areas including on the populous city of Birmingham. A number of countries have re-imposed localized lockdowns in their worst-affected regions. In Reunion, the wearing of masks has become mandatory in various localities and a range of restrictions have been imposed following a marked surge of new cases on the island.

Whilst older people accounted for the largest share of cases in the early months of the coronavirus outbreak in March and April, it is the 20 to 39-year-olds who now represent up to 40% of new infections in France, Germany, Spain, the Netherlands and Belgium. Data from national agencies show that surges in Covid-19 cases in countries across Europe are due largely to a rise in infections among young people.

In order to protect public health and safeguard the people from the risks of infected carriers of the virus entering the UK from countries which have recorded a surge in cases of Covid-19, the UK government has imposed a14-day self isolation period on all travellers from France, the Netherlands, Spain, Andorra, Belgium, Luxembourg, Monaco, Malta, Turks and Caicos, and Aruba.

Covid-free haven

Mauritius therefore enjoys a comforting sense of safety as there are no local cases of coronavirus in the country. With Covid-19 raging across the world, Mauritius remains a Covid-19 free haven so long as we keep our borders closed. Being an island adds an additional barrier of protection against the risks of infection. The people travelling together confident that they are safe from Covid-19. Exports are bustling again. The economy is gathering momentum and the informal sector is back in business.

A resumption of economic activities means a reduction of the government outlay on support measures to help the economic actors and employees tide over the adverse fallouts of the Covid-19 crisis. The country has also once again woken up to the short-sightedness of the government policy of heavily skewing through very generous incentives the main investment thrust of the economy towards real estate projects and smart cities dependent on the sale of high end villas and properties priced in hundreds of millions of rupees to wealthy foreigners.

Persistent lobbying

Despite such a grim international outlook caused by the rampant spread of Covid-19 in the world, there is a pressing lobbying from different quarters in the country to open our borders to enable the revival of the tourism sector forced into inactivity by the closure of our borders. Some political leaders are even callously sounding the alarm bells of the tourism sector losing market shares when the overriding consideration in a Covid-19 afflicted world should above all be about taking every precaution necessary to ensure that the lives of the people in the country are securely protected against a very contagious and deadly virus.

nuclear deal: UN rejects US bid to 'snapback' Iran

he UN Security Council has blocked a con-L troversial bid by the US to trigger the "snapback" of all sanctions on Iran lifted under a 2015 nuclear deal.

Indonesia's permanent representative, who holds the rotating presidency, said many of the 15 member states contested the move because the US withdrew from the accord two years ago.


The US envoy accused them of "standing in the company of terrorists".

Iran's foreign minister said "lawless bullying" had left the US isolated.

The Trump administration attempted to initiate the snapback process last week, after the Security Council rejected a draft US resolution that would have extended indefinitely an arms embargo on Iran due to expire in mid-October.

Under the nuclear deal, the P5+1 group of world powers - China, France, Russia, the UK, the US and Germany - gave Iran sanctions relief in return for limits on its sensitive activities to show it was not developing nuclear weapons.

The accord has been close to collapse since President Donald Trump abandoned it and reinstated US economic sanctions in 2018 in an attempt to force Iran to negotiate a replacement that would place indefinite curbs on its



nuclear programme and also halt its development of ballistic missiles.

Iran has so far refused and has retaliated against the US sanctions by rolling back a number of key commitments, including those on the production of enriched uranium, which can be used to make reactor fuel but also nuclear warheads.

Last Thursday, US Secretary of State Mike Pompeo formally submitted a complaint accusing Iran of "signifi-

cant non-compliance" with the nuclear deal and giving other security council members 30 days to adopt a resolution to stop the snapback.

He stressed that under security council resolution 2231, which endorsed the accord, the US had a legal right to do so because it was still named as a participant.

But the three European powers, China, Russia and Iran rejected the assertion.

At a virtual meeting on Tuesday, Indonesian permanent representative Dian Triansyah Djani announced that the Security Council was "not in a position to take further action" in response to the US request

"It is clear for me that there is one member which has a particular position on the issues, while there are significant numbers of members who have contesting views," he said.

Russia's envoy, Vassily Nebenzia, said he hoped the Trump administration would now drop its request, which he said was "not only illegal, but simply will not lead to achieving the result that was envisaged by the United States".

But the US mission to the UN insisted the fact that some council members had expressed disagreement with its position did "not have any legal effect".

Sri Lanka to follow 'India **First' Policy on strategic** security matters

In an outright display of thaw in ties between India and Sri Lanka, the Sri Lankan Foreign Secretary Jayanath Colombage has publically stated that the island nation will be pursuing an 'India First' policy on strategic and security matters, reports Times of India.

Speaking to a Sri Lankan TV channel on Monday (25 August), Colombage said, "President (Gotabaya Rajapaksa) has stated that in terms of strategic security, we will follow an 'India first' policy".

"We cannot afford to be a strategic security threat to India and we don't have to be. We need to benefit from India. The President has clearly said that you are our first priority as far as security is concerned but I have to deal with other players for economic prosperity,' Colombage added.

Colombage stated that while pursuing a 'neutral' foreign policy, Sri Lanka will protect India's strategic interests.

The Foreign Secretary also went on to call the past decision to give Sri Lanka's strategically located Hambantota deep-water port to China on a lease for 99-years a 'mistake'.

Pakistan's insistence that the Organization of Islamic Islamic 370, has caused a rift in its relations with Saudi Arabia.

The rift is also costing Islamabad financially as it has been forced to pay back a \$1 billion loan it availed from Saudi Arabia, which has also stopped supplying crude oil to Pakistan on deferred payments since May, reports Swarajya.

Both nations had announced in November 2018 a \$6.2 billion agreement to help Pakistan tide over its financial problems, with Saudi Arabia providing crude oil for \$3.2 billion under a deferred payment plan.

The agreement, which had a provision for extension by two years, expired in May. Pakistan's request for an extension of the facility has not got any response.

Cracks began to appear in Pakistan-Saudi Arabia relations after Pakistan Foreign Minister Shah Mehmood Qureshi asked Riyadh to convene a meeting of the OIC on Kashmir

In February, Pakistan made a request for an OIC meeting to discuss the Kashmir issue but Saudi Arabia turned it down

Qureshi, who has been vocal in criticising Riyadh for not considering its demand, threatened that Islamabad would convene a meeting of OIC members which supported its stand on the Kashmir issue.

On 22 May this year, Pakistan failed to garner support from OIC members on Kashmir. It led to its Prime Minister

Imran Khan commenting: "The reason (lack of OIC support) is that we have no voice and there is a total division amongst us. We cannot even come together as a whole on the OIC meeting on Kashmir."

Pakistan's problems have been compounded by improving bilateral relations between India and key OIC members such as Saudi Arabia and the United Arab Emirates (UAE).

Bilateral trade between India and Saudi Arabia has increased since the 2017-18 fiscal after a drop in 2016-17. More importantly, India's imports from the Gulf nation during 2017-18 and 2018-19 have increased by 10 per cent and 29 per cent respectively.

Some of the major Indian corporates such as L&T, Tatas, Wipro and TCS have a strong presence in Saudi Arabia, while some of Saudi firms such as Aramco and ADNOC have invested in India, especially in petrochemical projects.

Cambridge University starts vaccine race to fight all coronaviruses in future

The University of Cambridge on Wednesday confirmed plans to begin trials of a potential new vaccine not only against Covid-19 but all coronaviruses that may spill over from animals to humans in the future.

The new vaccine candidate, DIOS-CoVax2, uses banks of genetic sequences of all known coronaviruses, including those from bats, believed to be the natural hosts of many relatives of human coronaviruses.

A vaccine that clears all trials can then be delivered pain-free without a needle into the skin through a spring-powered jet injection.

"Our approach involves 3D computer modelling of the SARS-CoV-2 [Covid-19] virus' structure. It uses information on the virus itself as well as its relatives - SARS, MERS and other coronaviruses carried by animals that threaten to 'spill-over' to humans again to cause future human epidemics," said Professor Jonathan Heeney, head of the Laboratory of Viral Zoonotics



at the University of Cambridge, and founder of DIOSynVax - a Cambridge spinout company, reports PTI.

"We're looking for chinks in its armour, crucial pieces of the virus that we can use to construct the vaccine to direct the immune response in the right direction. Ultimately we aim to make a vaccine that will not only protect from SARS-CoV-2, but also other related coronaviruses that may spill over from animals to humans," he said.

Prof Heeney said his team's strategy involves targeting those domains of the virus' structure that are absolutely critical for docking with a cell, while avoiding the parts that could make things worse.

"What we end up with is a mimic, a synthetic part of the virus minus those nonessential elements that could trigger a bad immune response," he added.

The news comes as the University of Oxford revealed that its trials of a potential vaccine against Covid-19 being developed with AstraZeneca could be put before regulators this year if scientists are able to gather enough data.

The Oxford vaccine, as it is commonly known, showed early promise in the first human trial when it produced an immune response, underlining its position as one of the leading candidates in the race to help vaccinate humans against the deadly novel coronavirus.

Coronavirus: How are other countries getting children back to class?

French schoolchildren will be returning to school on 1 September with a somewhat relaxed version of the rules under which some of them went back to school in May.

For example, there will no longer be a limit on class sizes, and distancing is not compulsory in situations where it would stop a school being able to fit all its pupils in.

The exception to that is the use of masks, which will be compulsory indoors for staff and students over the age of 11, even if they manage to stay more than 1m apart. This means teachers will take lessons wearing masks.

Schools are no longer forced to prevent different classes and groups of students from mixing, but they are encouraged to stagger start and finish times to prevent large groups building up.

Italy: Class sizes will be smaller

* * *

Italy closed all schools in March and imposed one of the strictest lockdowns in Europe.

Children haven't had any classes even after lockdown measures started to ease in May.

The schools are now due to return on 14 September.

Students will be seated 1m apart so class sizes will become smaller. They will be divided into various learning groups, entry will be stag-

gered and schools will be open for lessons on Saturdays.

Students and teachers will have to wear masks, and teachers will wear face shields as well. Lessons will be held outdoors where possible or in big spaces like theatres or museums.

Distance learning will be available for secondary school students who live with vulnerable family members.

Germany: Do not touch the banisters

Germany's 16 states are in charge of education and the school year starts at different times in different states, but they all agreed in July that children should return to schools once the summer holidays were over.

Extra hygiene measures are advised, such as frequent handwashing and keeping hands off the banisters when taking the stairs. Masks are not obligatory and free testing is available for teachers.

Classes have been reorganised into so-called "cohorts" - groups of several hundred students. There are no social distancing rules within a cohort, but each group has its own area in the school grounds, cloakrooms and canteens.

In some states, both pupils and teachers will have to wear masks, while in others masks will not be required. Some are making them compulsory in corridors and other communal areas.



Hurricane Laura intensifying rapidly into an "extremely dangerous" event

Hurricane Laura strengthened into a Category 4 storm before it made landfall in Louisiana early on Thursday. The storm arrived with sustained 150mph winds as officials warned it would bring an "unsurvivable" storm surge as high as 20ft for coastal areas.

Authorities had urged residents on the coast to evacuate, but not everyone did before winds started buffeting trees and thousands of homes and businesses lost power. The US National Hurricane Center said that in the last 24 hours the storm has grown nearly 87 per cent in power, intensifying rapidly into an "extremely dangerous" event.

Officials said it was on track to hit land at high tide as the most powerful hurricane to strike the US so far this year and possibly the strongest ever to hit Louisiana.

Boris Johnson drops advice against face masks in schools in latest coronavirus U-turn

UK Prime Minister Boris Johnson has dropped advice against the use of face coverings in English schools, in an 11th-hour U-turn after he came under pressure from unions, opposition parties and schools, reports The Independent.

From 1 September, staff and pupils in secondary schools in local lockdown areas like Manchester and Birmingham will be required to wear face coverings when moving around the building and in communal areas where social distancing is difficult to maintain. Masks will not be mandated in the classroom.


Elsewhere in the UK, masks will not be obligatory but school leaders will have the discretion to require face coverings in communal areas if they believe that is "right in their particular circumstances". The new rules will also apply to sixth-form colleges.

A white supremacist who killed 51 worshippers at two mosques in the New Zealand city of Christchurch has been jailed for life without the possibility of parole, the first time the sentence has been used in the country.

Brenton Harrison Tarrant had pleaded guilty during court proceedings in Christchurch to murder, attempted murder and terrorism over the attacks in the city that left 51 people dead. The four-day hearing saw 90 survivors and family members talk about the pain of the March 2019 attacks at two mosques in the city.

Mauritius Times : Quelle analyse faites-vous de la démarche de l'"activiste social" Bruneau Laurette de porter plainte contre le ministre de l'Environnement Kavi Ramano et celui de la Pêche Sudheer Maudhoo suivant le naufrage du MV Wakashio ? Beaucoup de personnes se posent des questions concernant ses motivations et ses appuis. Qu'en pensez-vous ?

Jocelyn Chan Low : Dans le contexte actuel, cette initiative citoyenne est salutaire et rejoint dans une grande mesure le souhait d'une grande partie des Mauriciens, qui se posent toujours de nombreuses questions sur le manque de réactivité des autorités pendant plusieurs jours après l'échouage du Wakashio sur les récifs à En général, les citoyens se rassemblement quand ils ressentent un fort sentiment d'injustice envers des êtres vivants ou la société en général. Les abus des autorités, l'empiètement des droits citoyens ou l'usurpation des acquis renforcent le besoin de se libérer de ces chaînes. C'est un appel pour devenir acteur du changement attendu, pour renforcer la conscience que la société civile doit prendre en charge son destin en portant des valeurs communes et des objectifs similaires. Dans certains cas, l'enthousiasme est de courte durée. Mais, parfois, une mouvance citoyenne se dessine pour apporter une révolution des mentalités. Samedi, une manifestation citoyenne est prévue à Port-Louis. Nous avons invité Jocelyn Chan Low, historien, pour nous en dire plus.

Pointe d'Esny. Il y a effectivement trop de zones d'ombre autour de cette affaire qui méritent d'être élucidées devant un tribunal. Faut-il rappeler la position du DPP dans cette affaire qui va jusqu'à suggérer qu'après avoir étudié le dossier, il pourrait prendre l'affaire en main ?

En outre, qu'un simple citoyen puisse assigner deux ministres devant un tribunal selon les dispositions de la loi est une révolution en soi et est de très bon augure pour notre démocratie. Ainsi tout ministre est finalement 'accountable', et ce, pas uniquement devant l'électorat.

Quant aux motivations de Bruneau Laurette, sa démarche de travailleur social se situe dans le cadre du grand réveil des citoyens qu'on a pu constater depuis quelques temps et qui s'est manifesté, plus récemment, pendant la manifestation du 11 juillet dernier à Port Louis. Auparavant, et je cite à tout hasard, la marche citoyenne organisée en 2011 par Jameel Peerally. Il y avait aussi eu les actions du Bloc 104. Pourtant, à l'époque, les gens ne se posaient pas de questions sur les motivations et les soutiens de ces travailleurs sociaux.

D'ailleurs, quand Bruneau Laurette est venu de l'avant pour dénoncer la politique cruelle du Gouvernement de bulldozer tous les logements de fortune des squatters, y compris ceux des *genuine cases*, en plein confinement, il n'avait pas fait l'objet de tant d'attaques personnelles. Mais si c'est le cas aujourd'hui, c'est parce qu'il est perçu par ceux qui ne croient plus dans les partis traditionnels comme l'homme providentiel pouvant mettre un frein aux abus et dérives du régime en place. Or, il n'est que le catalyseur et le symbole du réveil citoyen. Et, c'est pour cela que, ses soutiens, il les recueille dans une très large frange de la population de l'île Maurice plurielle, y compris dans la diaspora mauricienne, toutes communautés confondues, n'en déplaise les esprits chagrins.

* La comparution de Bruneau Laurette au tribunal de Mahébourg, vendredi dernier, a donné lieu à des incidents impliquant certains de ses supporters et des activistes politiques venus d'autres régions pour soutenir les deux ministres, et il existe des craintes que sa marche de protestation prévue demain à Port Louis ne fragilise davantage l'harmonie dans le pays. Votre opinion ?

De quelle fragilité parle-t-on ? Le sens de patriotisme est très largement répandu à Maurice, comme l'a démontré d'ailleurs l'élan national des volontaires qui ont déferlé des quatre coins de l'île pour confectionner des booms artisanaux et protéger notre lagon.

Ce même élan patriotique, on l'avait vu pendant le *lockdown* à travers le travail formidable des bénévoles et des ONGs envers les plus démunis. Nous sommes une nation solidaire quand il s'agit de faire face à des calamités mais, aussi, pour dénoncer les abus et les incompétences.

C'est ainsi qu'à Mahébourg, on a vu des citoyens et des villageois de toutes communautés, déjà très touchés par la catastrophe écologique et les effets de la fermeture des frontières sur le secteur touristique, montrer leur désaccord face à des partisans qui, selon eux, étaient venus manifester - illégalement - devant le tribunal, avec banderoles, et se faisant passer pour des pêcheurs et des plaisanciers ; et tout cela dans le cadre d'un exercice de communication politique qui a mal tourné.

Il est vrai que certains pyromanes peuvent être tentés de semer le trouble pour discréditer le rassemblement citoyen prévu ce samedi. Mais ils sont très minoritaires et ne pourront pas empêcher la mobilisation et le grand réveil citoyen autour du drapeau national.

*Mais faut-il aussi que l'Etat prenne les actions qui s'imposent devant les propos à relents communaux et parfois racistes qui sont postés sur les réseaux sociaux, ce qui risque d'exacerber les tensions dans un pays multiethnique et multi-religieux, sans pour autant étouffer la liberté d'expression pour des raisons politiques...

Maurice est un pays pluriethnique. Les autorités coloniales ont toujours eu comme priorité la bonne gestion de relations interethniques. Et, depuis 1965, des lois très sévères ont été édictées pour éviter tout dérapage à caractère communal. Et à la fois les moyens techniques pour traquer les coupables et l'arsenal juridique disponibles sont amplement suffisants. Mais c'est aux autorités d'agir. D'ailleurs, des citoyens - à l'instar de Percy Yip Tong - ont déjà fait des dépositions à la police. Les autorités ont le devoir de sévir. Elles aussi sont 'accountable.'

Cela dit, à travers le monde, la mobilisation citoyenne - qui d'ailleurs a toujours comme symbole le drapeau national comme expression de sa légitimité en tant que représentant d'un peuple uni - fait peur à 'l'establishment' parce que cette mobilisation s'attaque aux travers du système qui nourrissent, favorisent et pérennisent ces mêmes élites. Et elles feront tout pour saborder le mouvement en suscitant des divisions.

* Ce qui est vrai aussi, c'est que le mystère entourant le naufrage du Wakashio reste entier et la réaction tardive des autorités a donné lieu à toutes sortes de spéculations. M. Laurette dit que l'Etat ne dit pas toute la vérité. Pensez-vous que toute cette agitation exprime aussi un manque de confiance dans le Gouvernement et sa manière de faire ?

La crise de confiance dans la classe politique dans son ensemble et dans les institutions ne date pas d'aujourd'hui. Elle est systémique. Et cette méfiance est même nourrie par les omissions grossières des bulletins d'informations de la télévision d'Etat car n'importe quel citoyen peut contre-vérifier les informations s'il a accès aux réseaux sociaux.

Faut-il rappeler que même Sébastien Lecornu, le ministre français des outremer, a publiquement déclaré que ce naufrage est 'curieux' pour employer un terme diplomatique ! On ne peut empêcher les Mauriciens de se référer maintenant à certaines conclusions du rapport Lam Shang Leen par rapport à la nécessité d'instituer une voie de navigation sous haute surveillance dans notre zone maritime pour prévenir tout trafic illicite.

De plus, Bruneau Laurette a soulevé une foule de questions avec preuves à l'appui. Mais il faudra sans doute attendre le rapport de l'enquête pour connaître les réponses.

* Pensez-vous qu'il faut vraiment voir cette agitation dans une perspective plus large qui dépasse l'affaire du naufrage du MV Wakashio, ou est-ce tout simplement le prélude à des revendications futures telles que les compensations?

De mon point de vue, Bruneau Laurette et l'affaire Wakashio n'ont été qu'un révélateur d'un mal plus profond. Il faut bien saisir le contexte politique, économique et social dans lequel l'affaire se déroule.

Nous avons un régime au pouvoir qui n'a recueilli que 37% des voix exprimés aux dernières élections générales, des élections qui sont d'ailleurs contestées en Cour suprême. Dans un tel contexte, le Gouvernement aurait dû faire preuve d'humilité et rechercher ce qu'on qualifie de *losers consent* car les perdants sont majoritaires dans le pays. Mais c'est exactement le contraire qu'on a vu.

Ce qui se passe au Parlement est une parfaite illustration de la politique de confrontation du Gouvernement face à l'opposition qui a fini par s'unir. C'est la même attitude qu'on perçoit par rapport à la société civile, les syndicats, les ONGs et la presse. C'est vrai que ce Gouvernement pense se tirer d'affaire à travers un exercice de communication tous azimuts et en créant un *feel-good factor* artificiel. Mais nous sommes en pleine crise économique et sociale.

Il est vrai que les partis de l'opposition ont vu leur hardcore se réduire, et il y a toujours un problème de crédibilité par rapport à certains de leurs leaders. Et c'est dans ce contexte qu'intervient le réveil citoyen, que certains ailleurs qualifieraient même de révolution citoyenne. Tout cela était à prévoir.

détruire tout ce qui a été accompli jusqu'ici, n'est-ce pas ?

Mais ce qu'on a construit est en train de se détruire tout seul! Il est évident que le système de démocratie parlementaire représentative est en crise, et pas seulement à Maurice.


Il y a tout d'abord une perte de confiance dans l'ensemble du personnel politique. On n'a qu'à voir la progression du taux d'abstention pour les élections, notamment chez les jeunes. La grève du vote est effectivement un des plus gros indicateurs de la faillite du système.

Ensuite, le système ne permet pas d'éradiquer la fraude, la corruption, le gaspillage, le clientélisme basé sur des considérations ethniques, communales et le copinage. En fait, il favorise la médiocratie au détriment de la méritocratie.

En outre, le choix des électeurs est restreint à quelques dynasties car les partis traditionnels ne sont, en fin de compte, que la propriété de quelques personnes.

Mais aujourd'hui avec l'élargissement de l'espace public, la circulation des idées et les réseaux sociaux, le citoyen ne veut plus se contenter d'accomplir son devoir civique, c'est-à-dire de voter une fois tous les cinq ans et rester spectateur de tous les frasques, abus, dérives et gaspillages de l'argent public jusqu'aux prochaines élections.

* Les révolutions citoyennes que ce soit le 'Printemps arabe', un mouvement inédit de contestation qui s'est rapidement propagé à d'autres pays du Maghreb et ailleurs, ou la révolution citoyenne 'Black Lives Matter' aux Etats-Unis n'ont pas produit des solutions durables... 'Le mur de Berlin va tomber à New-York', disait Jean-Luc Mélenchon sur Twitter en mai dernier. Or, il y est toujours...

Il faut bien comprendre de quoi il est question quand on parle de révolution citoyenne. A la différence des révolutions ouvrières du passé, il est question ici de l'ère du peuple qui inclut à la fois la classe moyenne et la classe des travailleurs. Et cette révolution citoyenne se déroule en général en trois phases :

- D'abord il y a la phase 'instituante' où une population s'organise en peuple autour du drapeau national, symbole de sa légitimité face à un *Establishment*, un pouvoir qui a perdu toute crédibilité. En général, cela se traduit à travers des manifestations pacifiques, des sits-ins, etc.

- Ensuite, il y a la phase 'destituante' ou dégagiste où le peuple exige que ses dirigeants qui ont perdu toute légitimité de *lev pake alle.*

- Et, finalement, on passe à la phase 'constituante' qui est la plus complexe car il s'agit de créer de nouvelles institutions et de transformer toutes les revendications en réalité. Et, souvent, c'est à ce moment qu'il y a des divisions, des ingérences extérieures qui entraînent le retour des anciennes élites.

Mais, ce qui est certain, c'est que ces révolutions citoyennes ont entraîné la chute de régimes totalitaires ou corrompus comme au Soudan, en Egypte ou encore tout récemment au Liban. Et certains ont été une réussite totale comme en Islande.

Quant au mouvement *Black Lives Matter,* il est bien sûr encore trop tôt pour évaluer son impact. Attendons les résultats des présidentielles américaines... Et même quand le mouvement n'a pas totalement réussi, il a quand même fait bouger certaines choses. Ainsi, avec les gilets jaunes, Macron qui se croyait Jupiter, est finalement redescendu sur terre...

* Pourquoi pensez-vous que les choses puissent être différentes à Maurice ? Rien n'a changé depuis la pandémie de la Covid-19. 'We have gone back to the old normal,' n'est-cepas ?

Pas si sûr que ça. Dans la population, il y a un vent de contestation qui souffle et on peut comprendre les raisons qui ne sont pas tous d'ordre politique. Le *feel-good factor* n'est plus là. Le secteur touristique est à l'arrêt. Les licenciements ne se comptent plus. La dépréciation de la roupie pèse très lourd dans les dépenses des ménages. Et le Gouvernement ne donne pas l'impression d'être un *caring government*. Le décès du petit Matteo est tout un symbole.

India is key for global access to a COVID-19 vaccine – here's why

India could help overcome 'vaccine nationalism' because it is the major supplier of medicines to the global south

The great COVID-19 vaccine race is on. Pharmaceutical companies around the world are going head to head, while governments scramble to get priority access to the most promising candidates.

But a richest-takes-all approach in the fight against the deadliest pandemic in living memory is bound to be counter productive, especially for the recovery of low and middle income countries. If governments cannot come together to agree a global strategy, then the global south may need to pin its hopes on the manufacturing might of India.

Tedros Adhanom Ghebreyesus, the director general of the World Health Organization, has warned that a nationalist approach "will not help" and will slow down the world's recovery. Yet vaccine nationalism looms large over the search for vaccines, with the US, the UK and the European Commission all signing various advance purchase agreements with manufacturers to secure privileged access to doses of the most promising candidates. The US alone has paid over US\$10 billion (£7.6 billion) for such access.

The ideal global distribution of a successful COVID-19 vaccine would look beyond which countries have the deepest pockets and instead prioritise health workers, followed by countries with major outbreaks and then those people who are particularly at risk.

India has the potential to play a key role in overcoming vaccine nationa-lism because it is the major supplier of medicines to the global south. Médecins Sans Frontières once dubbed the country the "pharmacy of the world". India also has, by far, the largest capacity to produce COVID-19 vaccines. Its role in manufacturing a vaccine could come in two different ways – mass-producing one deve-loped elsewhere (likely) or developing a new vaccine as well as manufacturing it (less likely, though not impossible).

Scaling up existing vaccines

India's Serum Institute has already started manufacturing the University of Oxford/AstraZeneca vaccine candidate before clinical trials have even been completed. This is to avoid any subsequent delay if the vaccine is approved. It is seen by many, including the WHO's chief scientist, as the world's leading prospect.

Serum Institute, based in the western city of Pune, is the largest vaccine manufac-turer in the world and has a deal to supply 400 million doses by the end of 2020 (1 billion in total). It has also inked a deal for the manufacturing and commercialisation of American firm Novavax's COVID-19 candidate.

Another Indian

pharma company, Biological E (BE), has agreed to ma-nufacture the vaccine candidate of Johnson & Johnson's subsidiary, Janssen Pharmaceutica NV. The Hyderabad-based firm has since announced its acquisition of Akorn India in order to boost its manufacturing capacity.

Despite India's success in mass manufacturing, the transition to innovation and new product development has been more of a struggle. Nevertheless the Serum Institute, Aurobindo Pharma, Bharat Biotech, BE, Indian Immunologicals, Mynvax, Panacea Biotech and Zydus Cadila are all attempting to develop their own vaccines.

Bharat Biotech's Covaxin has attracted the most attention and controversy. The Indian Council of Medical Research wrote to a number of hospitals seeking their help in fasttracking the clinical trials of the drug, which was developed in collaboration with the National Institute of Virology. The aim had been to launch it by August 15 (Indian Independence Day). Despite the feasibility of that timeline being widely questioned, trials of Covaxin did begin in Delhi on July 15.

Who gets the vaccines?

Uncertainty reigns over who will get these vaccines manufactured in India – and there have been very mixed messages. Regarding the much-hyped Oxford/AstraZeneca vaccine, Adar Poonawalla, the Serum Institute's CEO, said, "a majority of the vaccine, at least initially, would have to go to our countrymen before it goes abroad".

He added that the Indian government would decide how much other countries get, and when. In a later interview the CEO went further, adding: "Out of whatever I produce, 50% to India and 50% to the rest of the world". He also said the Indian government had not objected to this idea.

Vaccine diplomacy may come into play, as indicated by India's foreign



secretary, Harsh Shringla, on a visit to Dhaka. He promised that India would supply vaccines to Bangladesh on "priority basis", stating that India's "closest neighbours, friends, partners and other countries" will receive privileged access.

Meanwhile, a recent agreement provided a firmer guarantee of Serum-Institute-produced vaccines being supplied outside of the country – at least in 2021. On August 7, Gavi (the global vaccine alliance) announced a collaboration with the Serum Institute and the Bill & Melinda Gates Foundation. The deal provides US\$150m of financial support for the Serum Institute to manufacture and supply 100 million doses of vaccines to the COVID-19 Vaccine Global Access Facility (COVAX) for distribution in low and middle-income countries in 2021.

The deal will support the company's manufacture of both the Astra-Zeneca and Novavax candidates and guarantees a price of US\$3 per dose. AstraZeneca's candidate will be available to 57 Gavi-eligible countries, while the Novavax treatment will be available to 92.

With almost 18% of the world's population, India has strong demand for COVID-19 vaccines. Export bans on some personal protective equipment and key medicines in March set a precedent for prioritising supply to India first. But the bans were short lived and exports continued.

Thanks to its vast manufacturing capacity, India will undoubtedly export vaccines, continuing its role as the "pharmacy of the developing world". Vinod Paul, chair of India's National COVID-19 Task Force, has spoken openly of his desire to see India play a global role, saying: "The vaccine is not just for India and Indians but for the world and humanity." The question is when. Many in low and middle-income countries will undoubtedly be hoping it will be sooner rather than later.

C'est tout à fait compréhensible qu'ils ne souhaitent pas rester à l'écart d'un grand mouvement de contestation de la population. Mais c'est aussi vrai qu'ils y participeront en tant que citoyens, et cela est tout à fait légitime.

Bien sûr, il y a aussi le danger de récupération mais il est très éloigné. D'ailleurs, le mouvement citoyen aurait tout à gagner à très bien formuler leurs propositions et à exiger que leurs demandes soient inscrites sur l'agenda politique de ces partis aux prochaines élections générales.

Il n'est pas question de changer d'hommes mais de système. Il faudrait trouver un mécanisme institutionnel pour que le citoyen ne soit plus réduit qu'à un simple votant chaque cinq ans. Il faut mettre fin à l'ère des députés intouchables et tout-puissants. Ce serait là aussi une manière de mettre fin aux dérives dans les institutions.

Can we risk opening our borders?

The people must have their say on the matter as it concerns their safety, the risks to their lives and that of their families. Ask the people if they want our borders to be opened in the present state of the Covid-19 infection in the world and in particular in countries which are our main sources of tourists such as France, the UK, Germany, South Africa, Reunion, India or China? The spontaneous answer from the multitude is a horrified: No! Do the employees of the tourism sector, the hotel staff and all those who would be in direct contact with tourists want our borders to be opened, despite all sanitary precautions taken?

No amount of testing, sanitary precautions and elaborate screening protocols can guarantee that the influx of tens of thousands of tourists in the country every month in the present pervasive state of Covid-19 infection in the world would not import the virus and trigger a new wave of infection in the country. Experience with the repatriation of a few thousand nationals has shown that despite being tested negative prior to embarkation, some among the repatriated were found to be Covid-19 positive when tested on arrival or during their guarantine period. Can we seriously take the risk of allowing undetected foreign carriers of coronavirus infect the hotel staff, the frontline employees of the tourism sector and the population at large? This is why some key economic actors of the tourist industry have sensibly declared their opposition to the opening of our borders.

Courting disaster

It is better for the country and the government to be overcautious than to be foolhardy and irresponsible. As a nation, are we prepared to jeopardize the broad range of sectors of the economy which are striving to restore their activities to pre-Covid-19 levels and risk the trauma and heavy costs of a resurgence of coronavirus infection in the country for the sake of the tourism sector? Do we want the green shoots of recovery to be nipped in the bud? Are we prepared to endanger the pervasive sense of safety in the country obtained through our collective discipline to contain and make the country Covid-19 free by taking the rash decision to open our frontiers to tourists? Are those lobbving to open our borders to tourists callously ready to recklessly risk exposing the people to a resurgence of Covid-19 infection and casualties in the country? Are they blindly courting another costly and life threatening catastrophe after the Wakashio disaster through inept and misguided decisions? Can we as a nation irresponsibly make the elderly, the ailing and other vulnerable groups in the country once again endure the fear, trauma, solitude and preca-



Italy has closed nightclubs again and made the wearing of masks compulsory. The spike in cases in Germany has been caused by the return of large numbers of German tourists from their holidays in Covid-19 affected countries. The UK has also enforced stricter restrictions in various areas including on the populous city of Birmingham. A number of countries have re-imposed localized lockdowns in their worst-affected regions. In Reunion, the wearing of masks has become mandatory in various localities and a range of restrictions have been imposed following a marked surge of new cases on the island...³⁹

rity of another wave of Covid-19 infection in the country?

Can we take the risk of a resurgence of Covid-19 which will once again put undue pressure on all the frontline workers of the country who have so valiantly fought the virus and helped save lives during the first wave of infection and risk overwhelming the health services of the country? Can we again put their lives at risk? A resurgence of Covid-19 in the country will trigger strict confinement rules and a costly lockdown which will shut down economic activities, further slump the tourism sector and halt the sugar harvest and the resurgence of the other key sectors of the formal and informal economy. It will blow up the costs of diverse government support measures and wage assistance and self-employed assistance schemes and undermine government finances. Schools and the University would be closed causing added hardships to students.

There cannot be any risky tradeoff between the safety and lives of the hotel staff, those working in the tourism sector and the people at large and the parochial objective of bolstering the tourism sector against the backdrop of the potent threat of the Covid-19 pandemic in the world. People cannot be made to serve as cannon fodder to save the tourism sector from its present setback. The tourism sector will bounce back and every support must be given to the sector to sustain it over the Covid-19 crisis, especially as major developments in scientific research provide potent hopes that efficient treatments and vaccines are on track and could be available sooner than expected.

Let us not court another costly disaster when we can sensibly avoid it.

The World Health Organization has described obesity as a global epidemic and one of today's "most blatantly visible yet neglected public health problems". In the last few years reports on the rise of this life-threatening condition among children and adults across the globe have been alarming.

A total of 107.7 million children and 603.7 million adults were considered to be obese in 2015. But now our research shows that obesity is even more common than these reports suggest, and that in many countries most people are now living with obesity.

Obesity is a disease in which the amount of body fat is too high – high enough to harm health. It can increase the risk of diabetes, high blood pressure, heart problems, stroke and some cancers. But measuring body fatness accurately is difficult – and so most scientific studies and national surveys do not measure it, but use instead the weight-to-height body mass index (BMI) as a simple proxy for body fatness.

But the issue here is that the BMI can be a misleading proxy for high body fatness in both children and adults – and even more so in particular ethnic groups. This means that many people with apparently healthy BMI will actually be living with high body fatness without being aware of it, and so be at risk of the serious health consequences without realising it. Our research aimed to assess how problematic BMI is when used as a proxy for high body fatness in African children.

The problem with body-mass index

A high BMI or BMI-for-age – in children and adolescents BMI has to be adjusted for age because it increases with growth and

maturation – is usually taken to represent high body fatness. The problem is that while almost all adults and children who have a high BMI will have a high level of body fat, many people with an apparently healthy BMI will also have a high level of body fat.

It is well known that BMI misclassifies the body fatness of athletes, bodybuilders and sportsmen and women, because a high muscle mass produces a high BMI. Only a small proportion of the population are athletic though, and the far more common problem with BMI is that it misclassifies body fatness of this much larger, nonathletic portion of the population – but in the opposite direction, meaning it downplays its extent.

The extent of the misclassifying of body fatness by BMI matters. Most studies which have measured both body fatness and BMI have taken place in Europe and North America – and in these studies the prevalence of high body fatness has been as much as two to three times greater than the prevalence of high BMI. In one example 26% of US adults were obese according to their BMI, while 64% of the same adults were obese according to a more accurate measure which images the amount of fat in the body directly using X-rays.

Obesity and ethnicity

The problem of underestimating obesity is even worse in some population groups. The extent to which the BMI misclassifies the body fatness of people depends on their ethnicity. It is well established, but not well known, that BMI misclassifies children and adults in south and east Asia even more than Europeans.

There is emerging evidence that this problem extends to using BMI in other po-

pulation groups too. In our recent study of children living in eight cities across Africa from Windhoek in the south to Tunis in the north, we found that 9% were obese according to their BMI-for-age, but 29% had high body fat according to a stable isotope technique designed for measuring body fatness.

By underestimating the prevalence of obesity because of reliance on BMI in clinics, research studies and national health surveys, we also underestimate the need for action to prevent and treat obesity. To use our African study as an example, the case for action at a 29% prevalence of obesity is much stronger than at a prevalence of 9%. Obesity is far more common than it seems, and it requires much greater effort and more urgent attention than it is currently receiving.

As we enter a new decade it is time for national resolutions that are more ambitious. The main drivers of the global obesity epidemic are well known: excessive fat and sugar intake, lack of sleep, too much screen time, insufficient physical activity. We need global measures across all age groups to address these elements and we need them now.

The right to vote is not in the Constitution

Research has also shown that ordinary Americans are remarkably ignorant of public policies and politicians, lacking even basic political knowledge.

Is there a right to vote?

What Americans think of as the right to vote doesn't reside in the Constitution, but results from broad shifts in American public beliefs during the early 1800s. The new states that entered the union after the original 13 – beginning with Vermont, Kentucky and Tennessee – did not limit voting to property owners. Many of the new state constitutions also explicitly recognized voting rights.

As the nation grew, the idea of universal white male suffrage – championed by the commoner-President Andrew Jackson – became an article of popular faith, if not a constitutional right.

After the Civil War, the 15th

Amendment, ratified in 1870, guaranteed that the right to vote would not be denied on account of race: If some white people could vote, so could similarly qualified nonwhite people. But that still didn't recognize a right to vote – only the right of equal treatment. Similarly, the 19th Amendment, now 100 years old, banned voting discrimination on the basis of sex, but did not recognize an inherent right to vote.

Debates about voting rights

Today, the country remains engaged in a long-running debate about what counts as voter suppression versus what are legitimate limits or regulations on voting – like requiring voters to provide identification, barring felons from voting or removing infrequent voters from the rolls.

These disputes often invoke an incorrect assumption – that voting is a constitutional right protected from the nation's



birth. The national debate over representation and rights is the product of a longrun movement toward mass voting paired with the longstanding fear of its results.

The nation has evolved from being led by an elitist set of beliefs toward a much more universal and inclusive set of assumptions. But the founders' fears are still coming true: Levels of support for the rights of opposing parties or people of other religions are strikingly weak in the U.S. as well as around the world. Many Americans support their own rights to free speech but want to suppress the speech of those with whom they disagree. Americans may have come to believe in a universal vote, but that value does not come from the Constitution, which saw a different path to the protection of rights. Unwind



Improve every day


Most people don't have the patience and drive to improve. Recently, a person who bought my writing course said it was too much work to improve their writing. No kidding?!

But none of the above means you should *always* think about the future. Life happens NOW.


Working from home, reading a book, going for a walk, spending time with loved ones; all those things happen right now. You're not helping yourself by being lost in your thoughts.

Padmavyuha actor Pooja Batra on her film: 'You can take any religion and it will fit into the narrative'

Filmmaker Raj Krishna and actor Pooja Batra talk about their new film, Padmavyuha



Actor Pooja Batra, who has a special appearance in a short film *Padmavyuh* that explores the various facets of religion, has said that what she liked about it was its nonjudgmental approach. Pooja, along with film director Raj Krishna talk about their film in an exclusive interview with Hindustan Times.

Padmavyuha, screened at the International Indian Film Festival Toronto last week, traces a professor of religious studies who receives a mysterious phone call. With time, he traverses



the tricky path from a non-believer to one who not just believes in faith and religion but is willing to take extreme steps for its sake, unearthing how many play politics in the name of religion. Pooja essays a character who went missing years before the story begins in the film. American actor Nikhil Prakash essays the main role of the professor in the film.

Given that *Padmavyuha* is the brain child of a second-generation NRI, is it an outsider's view of the religion? Pooja said, "I think it was also vaguely ambiguous because if you take any religion, it would all still apply. It is an exploration of morality. The best part about the film is that you can take any religion -Hinduism, Christianity - any religion and it will all fit in perfectly into the film's narrative."

Raj, however, said, "I think I am making these films because I want to explore and understand Hinduism. I am a second generation American Indian (my mom is a Hindi teacher and that is how I know how to read and write Hindi). This is also my way of connecting with my heritage and that part of world."

He added, "The film is an exploration of faith at its highest level. A religion studies professor has lost his faith and





dégoût durant nos années d'adolescence pour nous pousser à plier bagages et à voir la vie différemment sous d'autres cieux plus cléments où l'évolution de la société a fait place à la Raison dans les échanges et les rapports sociaux, une raison qui favorise des rapports civilisés, et par conséquent, apaisés.

Si ce n'était que les mâles ! Au fil du temps, il semble que les 'femelles', au sens premier du terme, ont intériorisé le même comportement dans l'espace médiatique, empiré par le cloisonnement insulaire.
