

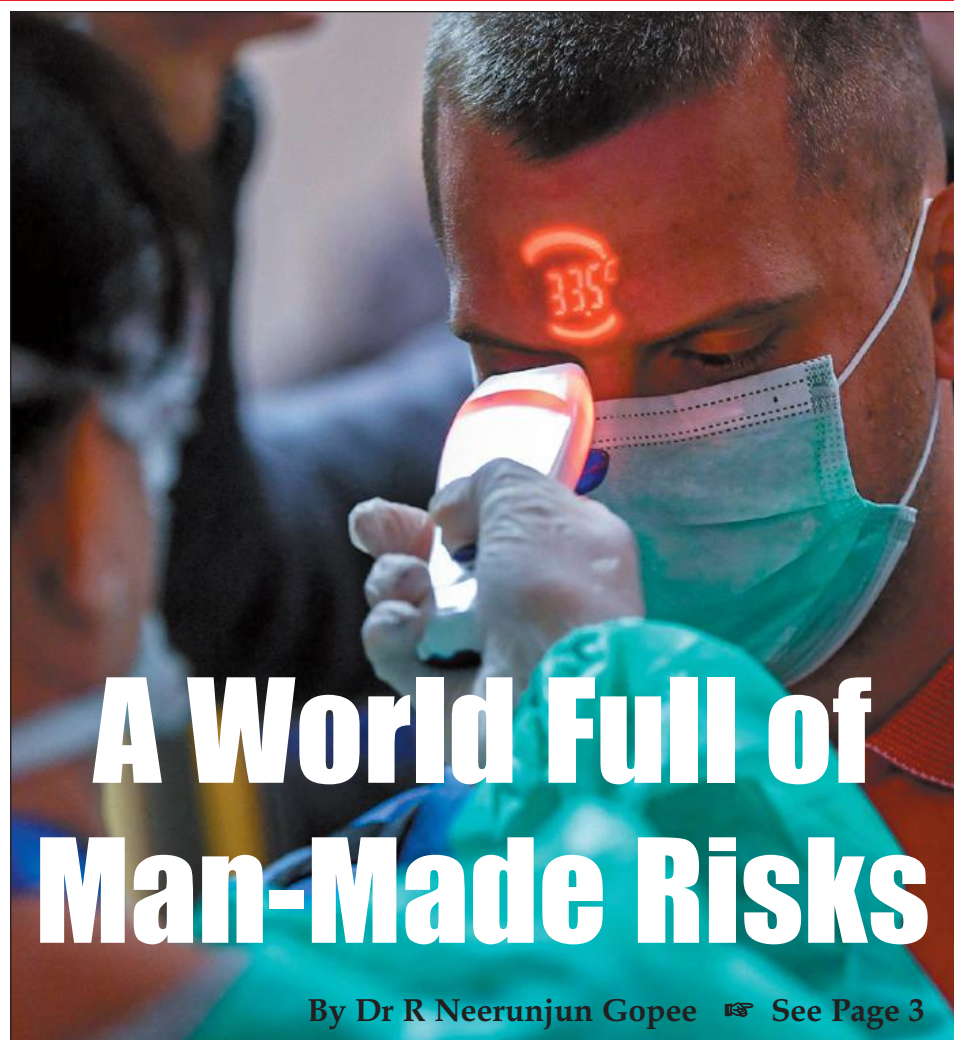

# Sir Anerood Jugnauth

**O**n Thursday 3rd June 2021 Mauritius lost one of its most illustrious sons of the soil, Sir Anerood Jugnauth, former Prime Minister and President of the Republic. He was among the longest serving political leaders in any democratic country, his active engagement in politics extending over six decades, which also made him one of the oldest statesmen in the world at the time that he stepped down as Prime Minister in 2018. He had led his party, the MSM formed after breaking away from the MMM in 1983, to victory five times in alliance with other parties.

Hailed for leading the country towards an accelerated industrialization after the defeat of the Labour Party in 1982, he achieved national, regional and international stature over the years. Thus, he was honoured at the Pravasi Bharatiya Divas held in India, the global forum of the almost 30 million strong Indian Diaspora, and subsequently was awarded the Padma Vibhushan by the Government of India. He got enhanced recognition internationally when he took it upon himself to defend the cause of the Chagossians at the International Court of Justice at the Hague and at the UN afterwards.

Like most Indo-Mauritians of his generation, he was born and brought up in a poor family in Palma, and faced the hurdles that such circumstances place in the way of obtaining proper primary and secondary education, before proceeding to London to study law and returning to Mauritius after completion of his studies.

Given this background, it was quite natural that he would have the interest of the poor and the downtrodden at heart, and his profession as lawyer no doubt placed him in a position to gain more awareness about their plight and the need to defend their rights and improve their conditions. He saw education as key to this, which is the reason that he rejected the recommendation of the IMF in 1982 to cut the education budget, as Suren Bissoondoyal points out in his interview to this paper today.

In fact, as the interview shows, he was influenced by the activism of the Bissoondoyal brothers in the social and political fields, and this led him to join the Independent Forward Bloc founded by Sookdeo Bissoondoyal. He stood as its candidate in 1963 at Riviere du Rempart and defeated the Labour Party stalwart Anauth Beejadhur. This political engagement was complemented by his involvement in the All Hindu Congress, which had a socio-cultural focus.

As is well known, the IFB joined with the Labour Party and the CAM to fight for Independence, but split from the LP shortly after independence was won. The next stop of Anerood Jugnauth was the MMM from the 1970s onwards, until he formed his own party MSM in 1983, and leading it to five successive victories by forming alliances with other parties, including LP.

The new breed of leaders have not been exposed to the kind of hardships that SAJ and others of his generation went through, having grown up in relatively more well to do circumstances. This is all the more reason for them to be inspired by the trajectories of those who have assumed the responsibilities of the highest offices of the land with honour and dignity.

# How virus detectives trace the origins of an outbreak – and why it's so tricky

*Bat hosts, lab leaks – tracing SARS-CoV-2 to its origins involves more than just tracking down patient zero.*

**E**very time there is a major disease outbreak, one of the first questions scientists and the public ask is: "Where did this come from?"

In order to predict and prevent future pandemics like COVID-19, researchers need to find the origin of the viruses that cause them. This is not a trivial task. The origin of HIV was not clear until 20 years after it spread around the world. Scientists still don't know the origin of Ebola, even though it has caused periodic epidemics since the 1970s.

As an expert in viral ecology, I am often asked how scientists trace the origins of a virus. In my work, I have found many new viruses and some well-known pathogens that infect wild plants without causing any disease. Plant, animal or human, the methods are largely the same. Tracking down the origins of a virus involves a combination of extensive fieldwork, thorough lab testing and quite a bit of luck.

## Viruses jump from wild animal hosts to humans

Many viruses and other disease agents that infect people originate in animals. These diseases are zoonotic, meaning they are caused by animal viruses that jumped to people and adapted to spread through the human population.

It might be tempting to start the viral origin search by testing sick animals at the site of the first known human infection, but wild hosts often don't show any symptoms. Viruses and their hosts adapt to each other over time, so viruses often don't cause obvious disease symptoms until they've jumped to a new host species. Researchers can't just look for sick animals.

Another problem is that people and their food animals aren't stationary. The place where researchers find the first infected person is not necessarily close to the place where the virus first emerged.

In the case of COVID-19, bats were an obvious first place to look. They're known hosts for many coronaviruses and are the probable source of other zoonotic diseases like SARS and MERS.

For SARS-CoV-2, the virus that causes COVID-19, the nearest relative scientists have found so far is BatCoV RaTG13. This virus is part of a collection of bat coronaviruses discovered in 2011 and 2012 by virologists from the Wuhan Virology Institute. The virologists were looking for SARS-related coronaviruses in bats after the SARS-CoV-1 pandemic in 2003. They collected fecal samples and throat swabs from bats at a site in Yunnan Province about 932 miles (1,500 kilometers) from the institute's lab in Wuhan, where they brought samples back for further study.

To test whether the bat coronaviruses could spread into people, researchers infected monkey kidney cells and human tumor-derived cells with the Yunnan samples. They found that a number of the viruses from this collection could replicate in the human cells, meaning they could potentially be transmitted directly from bats to humans without an intermediate host. Bats and people don't come into direct contact very often, however, so an intermediate host is still quite likely.

## Finding the nearest relatives

The next step is to determine how closely related a suspected wildlife virus is to the one infecting humans. Scientists do this by figuring out the genetic sequence of the virus, which involves determining the order of the basic building blocks, or nucleotides, that make up the genome. The more nucleotides two genetic sequences share, the more closely related they are.

Genetic sequencing of bat coronavirus RaTG13 showed it to be over 96% identical to SARS-CoV-2. This level of similarity means that RaTG13 is a pretty close relative to SARS-CoV-2, confirming that SARS-CoV-2 probably originated in bats, but is still too distant to be a direct ancestor. There likely was another host that caught the virus from bats and passed it on to humans.

Because some of the earliest cases of COVID-19 were found in people associated with the wildlife market in Wuhan, there was speculation that a wild animal from this market was the intermediate host between bats and humans. However, researchers never found the coronavirus in animals from the market.

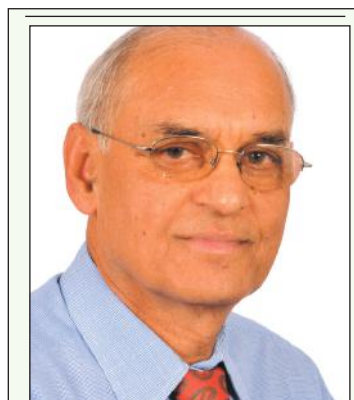

Even as the Covid-19 pandemic seems to be finally abating in terms of the total numbers of cases and deaths that are being reported regularly, another controversy that has now gone mainstream is the theory of the lab-leak which is receiving extensive coverage in the US media in particular. Much of the research about the sanitary measures had been done there initially, and then crystallized into the recommendations made by the US Centres for Disease Control, which were broadly accepted and followed by most countries, as they were also articulated by the WHO.

One would recall the expert who was on American TV almost daily, and invariably when President Trump would be giving his briefings, namely Dr Antony Fauci, considered to be the top infectious diseases specialist in the US and Director of its National Institute of Allergy and Infectious Diseases. As 2020 rolled out, gradually Dr Fauci's appearances diminished, until finally he was no longer present at all in these briefings.

Things have taken a 180-degree turn about him following the availability of his 900 emails totaling over 3000 pages. According to US news channels, they have revealed correspondence between him and the Wuhan Institute of Virology, with US scientists and researchers working in collaboration with the Institute and funded via an entity called Ecohealth Alliance to carry out what is called 'gain of function' research on coronaviruses. Other than engineering these viruses to make them more lethal and produce corresponding diseases that could then be studied, so that scientists and doctors would be more prepared to face them should they erupt in future, at some stage concern was raised about this line of research becoming 'too risky.' The worry was about using such engineered viruses for biowarfare. Whether or not that research was stopped is yet to be determined, and hopefully the task force set up by President Biden to investigate the

origins of the Wuhan virus will come up with a more definitive answer than the WHO team has.

Meanwhile the pandemic has swept across the world, infecting hundreds of millions and killing millions, and leaving in its long trail medical and health devastations, as well as social and economic impacts that will disrupt lives and societies far into the future.

This pitches the debate to one between private choice and public good, posing a challenge to authorities everywhere, and making the prospect of total immunity recede even farther. Each country has to take this call for itself about how best it can achieve its vaccination goal, and some hard decisions no doubt have to be made.

## Protecting ourselves from films and social media

*The golden rule should now be: everything is fake until proved otherwise*

The recent discovery of the bodies of two young women in a fruit orchard in Mare d'Albert, suspected of being murdered by an alleged serial killer, brings to the fore once again the vulnerability of people to the perverse influence of forms of the media that exert inordinate influence on our lives - and sends alarm bells about how all of us should be extremely careful in our responses to what we view.

The golden rule should now be: **everything is fake until proved otherwise.**

Several years ago, before the explosion of social media, I had written an article titled 'Reel life is not real life.' It was to caution youngsters of an impressionable age about the dangers of an over-exposure to Bollywood films in particular. I had observed: 'There are many films which provide wholesome entertainment. Unfortunately, many of the more popular ones, which tend to be lapped up and therefore imitated uncritically by the credulous - especially in matters of dress and "style" - fall into the "misguiding" category. And this applies in particular to the Bollywoodian films which depict heady romanticisms centred around the stale love triangles of cavorting macho-looking actors and actresses aping their

Western counterparts, in tropical locations far removed from the context and realities of India. *Et pour cause* - because these films are targeted essentially at the Indian masses who need to escape from the tedium of their daily grind.'

I had quoted the remarks of Bollywood actor Shatrughan Sinha, who had then been appointed Union minister of Health: 'I deeply regret misguiding the youth in my films with the villainy antics...my style of smoking and drinking in the films might have misled many youths and I am sorry for that,' adding that he quit posing for a liquor brand after doing so only once because of the money.

While many youths, female and male keep succumbing to the fakes peddled in Bollywood films, social media with Facebook leading has now emerged as a major corrupting influence if not properly used. This was highlighted in last week's editorial in this paper about **the dark, dangerous side of social media**: about cases of 'especially women in vulnerable situations, taken in by the false promises being made, using fake identities and changed names. Unsuspectingly, they believe that the names being used and the promises being made - of marriage, or travel outside/settling abroad - are genuine, and it is too late by the time they realise and then can't escape because of blackmail, well-known being photos of the victims in compromising

postures being surreptitiously taken and made to go viral on social media. In extreme cases, these lead to suicide, or to the killing of these subjects.'

Was also emphasized 'that the responsibility of protecting oneself lies squarely on the shoulders of the individual... since it would appear that many people, especially those in difficulty, are not aware of the dangers that await them on Facebook.' Further, 'everyone must be extremely careful in using Facebook, whether it is posting material especially personal details, or responding to posts. They **must check, check, check** before they take any step forward if they do not want to end up cheated or dead.'

It is therefore up to parents and family, NGOs and civil society organizations to take the lead in creating the necessary awareness among citizens. But, at the same time, the State should also step in and launch a campaign to supplement the efforts of non-State actors in this project. There is a very valid reason for the State to be involved: in the protection of the citizens of the country, fundamentally, and eventually, when a crime is committed, it is the State's human and logistical resources that are mobilized to investigate and try to solve the crime, resources which could otherwise be put in service elsewhere.

This is a world full of risks at every bend. It's up to us, both individually and collectively, to be extremely vigilant at all times. And seek help if we are not sure.



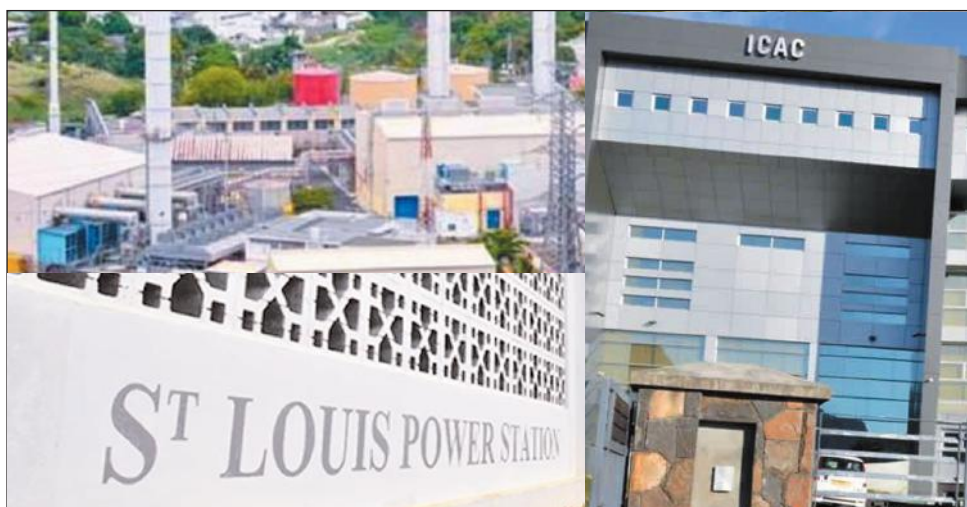
## ICAC's Parliamentary Committee

# “The perception in the public is that ICAC is not functioning independently.

Why, it may be asked, but this would be a rhetorical question”

**T**he performance of the institution set up in 2002 to help combat corruption and money-laundering, ICAC, has been under the scanner recently with a large number of high-profile cases that have been reportedly sent its way. Despite a sizable budget and experienced investigative staff, the general perception in the public is that it is not living up to expectations. Wherein lies the problem, the governing law, the mode of appointment of the DG, the parliamentary monitoring mechanism, or the inherent complexity of financial scams that elude its investigative powers? We have asked LEX to weigh in.

\* The Independent Commission Against Corruption (ICAC) has lately been heard proceeding apace with the investigation into the case of alleged corruption in the St Louis Power Station Redevelopment Project. Bertrand Lagesse, head of AMB Lagesse Business and Engineering Consultancy, and Philippe Hao Thyn Chuan Ha Shun of PAD Co had been called, late May 2021, for further inquiries. Whether this would qualify as a complex inquiry or not and why it is taking so long for ICAC to conclude the investigation are not known, but things are moving... and that should be sufficient, isn't it?

Financial crimes are not easy to investigate in view of their complexity and ramifications. Today financial crimes are not frontier-bound; they have become transnational. This necessitates international assistance, and requests for mutual assistance may give rise to legal issues in the

country that receives the request for assistance. Of course there are financial crimes which have a local component only, and these should move quickly as far as the investigation is concerned.

\* The Prevention of Corruption Act 2002 does not seem to provide for any oversight mechanism that could have monitored the ICAC at its operational level, especially as regards the conduct of investigations. Moreover, Section 20 (2) & (3) provides that 'The Commission shall act independently, impartially, fairly and in the public interest', and 'Subject to this Act, the Director-General shall not be under the control, direction of any other person or authority' respectively. Is it in the public interest that such should be the case?

Yes, it is in the public interest, and for the sake of the integrity of investigations it is necessary that an institution that is man-

dated to fight financial crimes should be independent and not be under the control or authority of anybody or any other institution. The only monitoring mechanism resides in the people who man ICAC. How they do it and how the public react to their actions can be said to constitute a form of monitoring.

\* Moreover, Section 19 (4) provides for the appointment of the Director-General of ICAC by the Prime Minister after consultation with the Leader of the Opposition. It does not seem the Director-General enjoys the same constitutional protection as the Director of Public Prosecutions or of Judges. Without putting in doubt the integrity of the holder of the post, this may place the Director-General of ICAC in an uncomfortable position vis-à-vis the head of government, isn't it?

An institution is an inert body. It becomes functional and operative when persons are appointed to man it. Its function depends on how the person so appointed does it. Independence is a state of mind. If the head of ICAC decides to jettison his independence and kow-tows to orders or instructions from the person who appointed him, then the only solution is to shut down the institution.

\* We have not heard from Opposition politicians, now or during the time when they were at the helm of the affairs of the country, taking issue with this state of affairs and taking any corrective measures. All politicians want to have the ICAC under their thumb, right?

We do not know whether all politicians want ICAC to be under their thumb. The Prevention of Corruption Act 2002 guarantees the independence of ICAC. We have never had under any previous regime since ICAC was established such a perception of a total lack of independence from ICAC when it comes to some specific investigations. It is a real cause for concern.

\* The Prevention of Corruption Act 2002 has also provided for a Parliamentary Committee, 'composed of 9 members, 5 of whom shall be designated by the Prime Minister and 4 of whom shall be designated by the Leader of the Opposition', whose functions is to 'monitor and review the manner in which the Commission fulfils its functions, but cannot intervene nor interfere in any 'specific case under investigation by the Commission'. Opposition members on that Committee

have expressed dissatisfaction with its workings and the irregular or delayed holding of meetings. What would this suggest?

This is what appears on the website of ICAC: 'The Parliamentary Committee monitors and reviews the manner in which the Commission fulfils its functions under the Act, reviews the budgetary estimates of the Commission, and issues such instructions as it considers appropriate with regard to the financial management, and the staffing requirements of the Commission, as well as the allocation of resources to the various operations of the Commission.'

The Parliamentary Committee's role does not extend to monitoring a matter related to any investigation being carried out by ICAC or the findings of the Commission in relation to a particular investigation. The ICAC accounts for its investigative decisions through a separate mechanism, i.e. to the judiciary.

The question may be asked as to whether since the formation of the new government in 2019 and the composition of the Parliamentary Committee, the Committee is living up to its mandate. It would appear this has not been the case, hence the dissatisfaction of the Members of the Opposition.

The impression is that the government, the Parliamentary Committee and ICAC constitute a close-knit confederation.

\* We have seen recently the Integrity Reporting Services Agency dragging the ICAC to Court for failure to furnish it with detailed reports on cases of unexplained wealth. Could the Opposition, if it wanted to make its voices heard within the Committee and ensure that it is allowed to carry out the functions as prescribed by the Act, have in the same manner gone to the Supreme Court for redress?

The Parliamentary Committee is an emanation of Parliament, and it is unlikely that the Supreme Court would intervene in the manner in which it functions. But there is no harm in trying by filing a test case.

On the other hand, the case filed against ICAC by the Integrity Reporting Services Agency concerns an administrative matter in the sense that ICAC as an institution, outside the purview of Parliament, as regards its powers, apparently failed to submit detailed reports on certain matters to the Agency. Let us wait for the outcome.

Buckingham Palace said the allegations of racism made by the couple were "concerning." The royal family said the issue would be addressed privately.

In early 2020, Meghan and Harry announced they were quitting royal duties and moving to North America, citing what they said were the unbearable intrusions and racist attitudes of the British media. They live in Montecito, a posh area recently bought a house in Santa Barbara, California.

## G7 leaders strike deal to tax Google, Amazon and other tech giants

The United States, Britain and other large, rich nations reached a landmark deal on Saturday to squeeze more money out of multinational companies such as Amazon and Google and reduce their incentive to shift profits to low-tax offshore havens.

Hundreds of billions of dollars could flow into the coffers of governments left cash-strapped by the coronavirus disease (Covid-19) pandemic after the G7 advanced economies agreed to back a minimum global corporate tax rate of at least 15%.

The decision was taken at the meeting of G7 finance ministers in London, reports Amit Chaturvedi of Hindustan Times.

British Treasury chief

Rishi Sunak posted a Twitter thread where he explained what the deal means. "Under the principles of the landmark reforms, the largest global firms with profit margins of at least 10% will be in scope - with 20% of any profit above the 10% margin reallocated and then subjected to tax in the countries where they make sales," he said in one of the tweets.

US Treasury Secretary Janet Yellen said the agreement "provides tremendous momentum" for reaching a global deal that "would end the race-to-the-bottom in corporate taxation and ensure fairness for the middle class and working people in the U.S. and around the world."

## US lawmakers push Biden for more Covid-19 vaccines and medical aid to India

Several US lawmakers have urged the Biden administration to ensure that India receives enough Covid-19 vaccines and medical aid, saying the health crisis in the country is "devastating" and America has a responsibility to help its close allies defeat the pandemic, reports Hindustan Times.

Biden said the US will share the vaccine to many countries to fight the pandemic through the UN-backed COVAX global vaccine sharing programme as part of his administration's framework for sharing 80 million vaccines globally.

"The crisis in India is devastating and demands more action from (President Joe) Biden. More Covid-19 vaccines and medical supplies are needed to help one of our most important global allies fight this virus," Texas Governor Greg Abbott said.

In a tweet, the Republican governor urged US citizens to join him in praying for India.

Republican Senator Ted Cruz said that almost 300 million doses of Covid-19 vaccines have been administered in the US.

"India is a critical friend of the US. Biden's vaccine sharing programme is flawed: We should prioritise our allies such as India, and make sure it receives the Covid-19 vaccines they desperately need," he said.

Senator Roger Wicker from the Senate Armed Services Committee said that it is important for the US to continue helping other nations beat the coronavirus. "Sending excess vaccines to close allies like India doesn't just make sense, it is the right thing to do," he said.

Indian-American Congressman Ro Khanna, also a member of the House Armed Services Committee,



said to help India deal with shortage, the US needs to send those vaccines that it will never use, just like India helped America in its time of need.

Congressman Dan Crenshaw said Houston is home to a large Indian community with friends and families in need back in India. "It should be a priority within this international programme," he tweeted.

Observing that the Covid-19 situa-

tion in India is "heartbreaking", Congressman August Pfluger said that the US has a responsibility to help its ally.

The US has also sent critical medical equipment and medicines to India to fight the second wave of Covid-19.

## France fines Google 220 million euros for abusing market spot with online ads



based on prices offered by other so-called ad servers.

At the same time, Google arranged for AdX, its own supply-side platform (SSP), to give preferential treatment to offers emanating from Doubleclick -- effectively squeezing out competitors such as Xandr or Index Exchange.

"The practices are particularly serious because they are penalising Google's competitors in the SSP market as well as the editors of websites and mobile apps," the regulator said in a statement.

Media groups saw their online ad revenues crimped "even as their business model has been strongly undermined by the decline in paper subscriptions and the associated drop in advertising revenue," it said.

Le Figaro eventually dropped its complaint.

Google did not contest the findings, and the regulator said the company has committed to operational changes including improved inter-operability with third-party ad placement providers.

The fine represents just a tiny fraction of the \$55.3 billion in revenue booked by Google in the first quarter of this year alone, mainly from online ad sales.

France's competition regulator on Monday fined Google 220 million euros after finding it had abused its dominant market position for placing online ads, as US tech giants face growing pressure in Europe, reports AFP.

The penalty is part of a settlement reached after three media groups -- News Corp, French daily Le Figaro, and Belgium's Groupe Rossel -- accused Google of effectively having a monopoly over ad sales for their websites and apps.

The competition authority determined that Google gave preferential treatment to its own ad inventory auction service AdX and to Doubleclick

Ad Exchange, its real-time platform for letting clients choose and buy ads.

"It is the first ruling in the world to scrutinise the complex algorithmic processes for the auctions that determine online 'display' advertising," the authority's president Isabelle de Silva said.

Media groups looking to sell ad space on their internet sites or mobile apps using rival platforms often found that Google's services were unfairly competing against rivals, using a variety of methods.

For example, regulators found that Doubleclick would vary the commission it took when making a sale

## Pandemic wanes in US, other markets, China's exports and imports surge

Beijing's politically sensitive trade surplus with the United States rose 14% to \$31.8 billion, while the surplus with the European Union fell 43% to \$12.7 billion.

China has reported its exports and imports surged in May on growing demand as the pandemic was waning in the US and other key markets, though the pace of growth is leveling off.

Customs data released Monday showed exports rose 28% from a year earlier and imports soared 51% - at the fastest annual pace in over a decade. Total exports climbed 40% in the first five months of the year from a year earlier. They were up 29% from the same period in 2019, reports AP.

China has led the global recovery from the pandemic, which is still raging in many parts of the globe but receding in some places, mostly where vaccinations have been widely deployed.

Chinese manufacturers benefited from strong demand for protective gear and other products as other countries battled Covid-19, gaining market share from competitors.

## Nepal signed non-disclosure agreement for Sinopharm jabs: Report

Nepal has had to sign a non-disclosure agreement with the makers of China's Sinopharm Covid-19 vaccine in order to gain access to doses amid questions about the legality of such an undertaking, according to a media report on Monday.

The Nepal government has been desperately looking for alternate sources of vaccines after India temporarily halted the export of jabs in late March to cope with a devastating second wave. Close to a million people in Nepal who received the first dose of the Covishield vaccine are currently waiting for their second dose after the passage of more than two months, reports Hindustan Times.

Sinopharm's proposal for a non-disclosure agreement created a dilemma among officials of Nepal's health ministry as the country's laws don't have a provision for non-disclosure agreements in public procurements, The Kathmandu Post reported.

The official further said the China National Pharmaceutical Group, the maker of Sinopharm, will quote a price after Nepal states how many doses it intends to procure. "Then the procurement process will move forward. I cannot say when the vaccines will be available," the official said.

China earlier supplied 1.8 million doses of the Sinopharm vaccine as grants to Nepal.

Nepal's Public Procurement Act of 2007 and the recent Covid-19 Crisis Management Ordinance are silent on non-disclosure agreements, though they allow the



government to procure directly from suppliers or manufacturers without competitive bidding in extraordinary situations.

According to Nepal's Public Procurement Monitoring Office, details of all procurements must be disclosed under the existing law, except in situations where the government procures defence-related materials that are sensitive from a national security point of view.

"If the existing procurement law and the ordinance don't allow us to procure the much-needed vaccines through the non-disclosure agreement, the procurement

process can move ahead only through a policy decision of the Cabinet," said Taranath Pokharel, director of the Family Welfare Division of Nepal's health ministry.

"I think the Cabinet will take a decision to facilitate the vaccine procurement in the current pressing time," he added.

The controversy over Sinopharm vaccine in Nepal follows rows related to the jab in other countries.

The procurement price of the Sinopharm vaccine in Sri Lanka triggered a row after reports emerged that Colombo paid a higher per-dose price than Bangladesh. Sri Lanka is paying \$15 a dose, or \$5 higher than what Bangladesh paid.

Bahrain, which was one of the first countries to back the Sinopharm vaccine last year, has raised doubts about the jab's effectiveness. Bahraini officials recently told the media that authorities will offer the Pfizer vaccine to high-risk individuals who had received two Sinopharm doses because these jabs didn't appear to be enough in the face of a new wave of Covid-19 infections in the West Asian country.

# “Anerood Jugnauth was a pragmatist... It was the final objective that mattered to him”

**S**urendra Bissoondoyal has been a prominent figure in the education sector at all levels, and as a scion of the Bissoondoyal family has had a ringside view of the political developments in Mauritius from the pre-Independence days. And that includes a close knowledge of the interactions between the young politician and activist Anerood Jugnauth and the Bissoondoyal brothers, as well as the subsequent events that made and separated and re-made party alliances, and the impact on the socio-economic development of Mauritius in which Anerood Jugnauth was a key player. In this interview he sheds more light on these important aspects of Mauritian politics which are not as well known to the public.

**Mauritius Times:** We understand you had become acquainted with Anerood Jugnauth since his early days in politics or even prior to that, when he would come visiting Basdeo and Sookdeo Bissoondoyal before eventually joining the Independent Forward Bloc (IFB) and standing as an IFB candidate in the 1963 elections. Would it be right to say that the influence of the Bissoondoyal Brothers and of the Jan Andolan have had a determining impact on his political choices and on his politics?

young age, he eventually became a 'Bissoondoyalist' himself. I suppose the influence you undergo when you are young stays with you much longer than when you have already grown up. That influence must have stayed on with him.

That could be the reason why he decided that the Esplanade at the Port-Louis Harbour should be named after Basdeo Bissoondoyal despite the entreaties of some government officials to have his own name instead. Anerood Jugnauth became and remained a

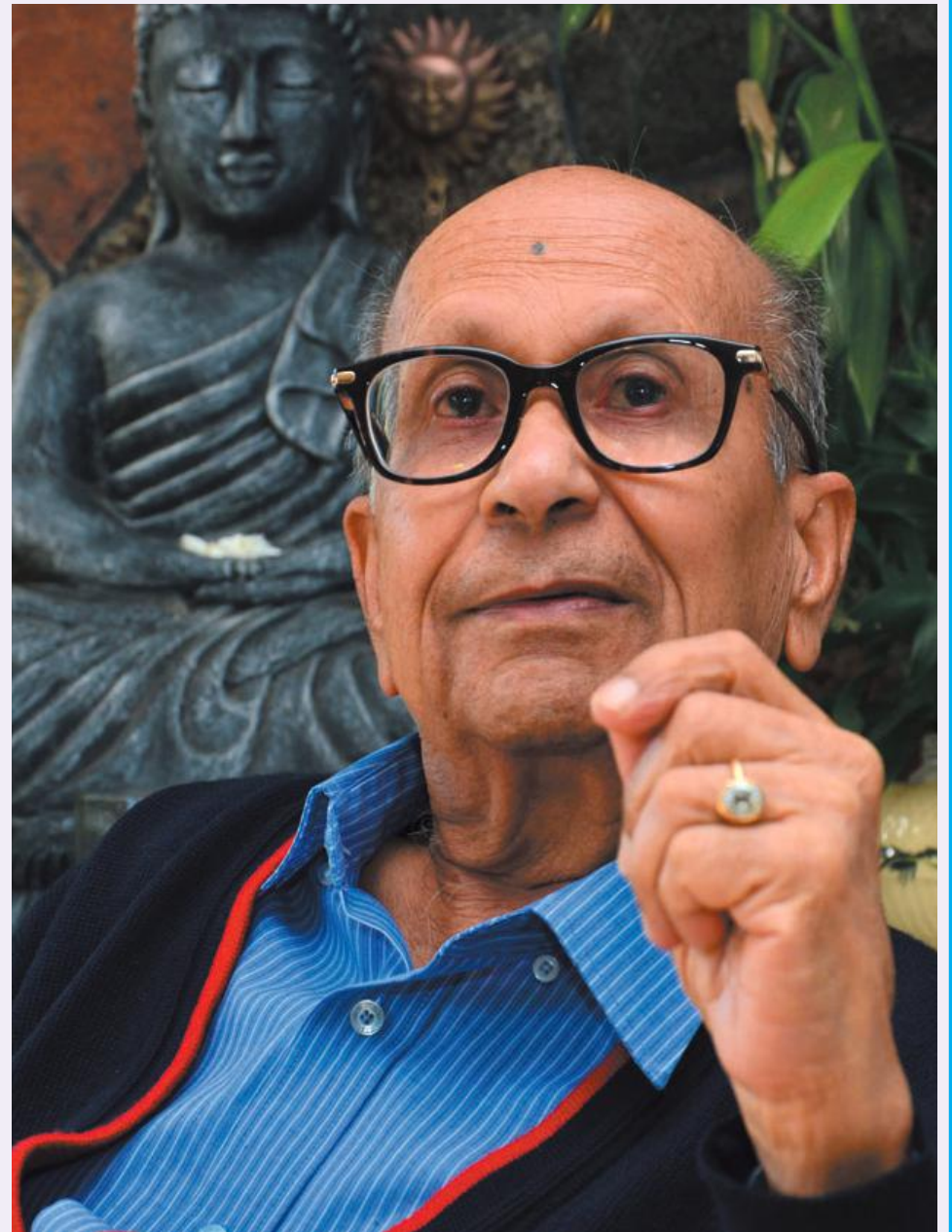
**Surendra Bissoondoyal:** I was studying in London at that time, so I did not know Sir Anerood Jugnauth from close quarters. But I got the news about his election in 1963 -- not an easy victory though, since he had to stand against Anauth Beejadhur, the sitting member in that constituency. That was to earn him the reputation of 'giant killer'.

When I came back in 1965, he was sitting in the Legislative Council and had become Deputy Leader of the IFB in a short time. I watched him recently in a film produced by the Basdeo Bissoondoyal Trust Fund recalling his childhood days when he would accompany, as a child of around 10 years, his father to the sermons of Basdeo on the Hindu scriptures in Palma. His father was a 'Bissoondoyalist', he said, and though he could not grasp what it meant at his

'Bissoondoyalist', and that is why he himself and his wife Sarojini made it a point to attend the sermons of Basdeo at Rivière du Rempart or wherever they were held.

\* You said that Sir Anerood Jugnauth became a 'Bissoondoyalist', what did it imply to be a 'Bissoondoyalist'?

At that time, the discrimination that the Indian community faced put them at a terrible disadvantage. When Basdeo Bissoondoyal came back from India, he wanted them to be proud of their culture and to fight for their rights so as to earn respect. He instilled a new spirit in the people: Stand up and fight discrimination and exclusion; it was a spirit of empowerment. That spirit was reflected when the people responded positively to the appeal

of Basdeo and Sookdeo to boycott the notorious 'Le Course Malbar', a term used in a derogatory manner to diminish them as inferiors - only worthy of making a spectacle of themselves at the Champ de Mars on that particular racing day.

\* What do you think caused him to leave the IFB to found the All Mauritius Hindu Congress? Could it be said that the Congress' harder line appeared more appealing to the young Jugnauth

than the IFB's ideology?

He did not really leave the IFB. The Hindu Congress had no intention to evolve into a political party, but probably under the influence of Basdeo and Sookdeo sought to empower the Hindu community. In fact, Anerood Jugnauth, whilst staying with in the IFB, joined the Hindu Congress.

The affinity between those two movements - one political, and the other socio-cultural - was such that during a ceremony in Flacq, Sookdeo garlanded the leader of the Hindu Congress.

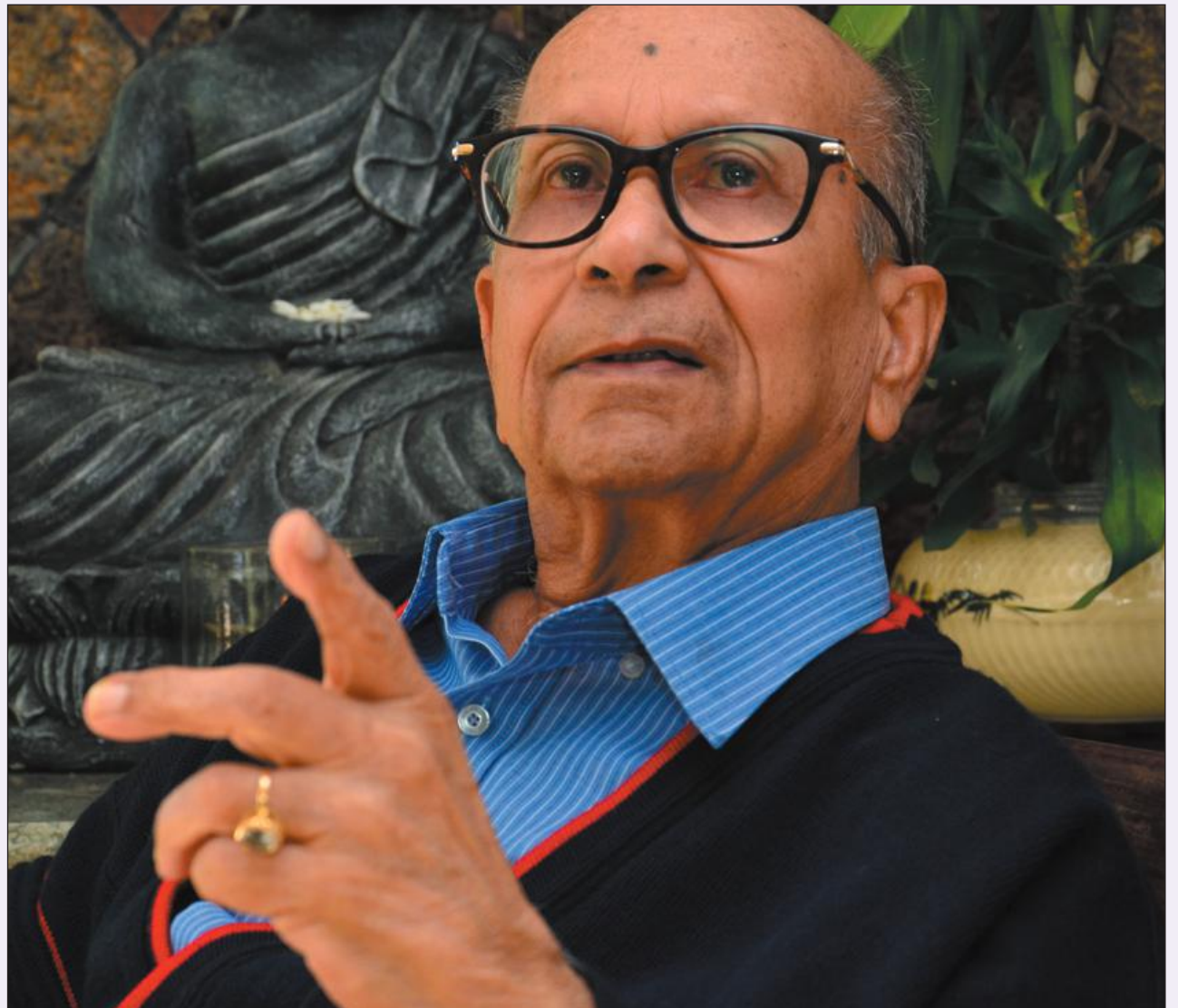

As regards what is perceived as the harder line approach of the Congress, it was clear that the Congress openly pursued a pro-Hindu agenda, which was not the case insofar the IFB was concerned and which also brought together non-Hindu members and election candidates. That is how in the 1963 elections, Abdool Wahab Foondun, a Muslim IFB candidate, got elected in a predominantly Hindu constituency: Bon Accueil. The ambition was to build the IFB into a national party, not one reserved for a particular community. That is also why Sookdeo Bissonndoyal, as Member of the Legislative Council, obtained in those days the full support of Dr Edgar Millien of *L'Oeuvre*. When he was suspended from the Council by the Governor, it was Guy Forget of the Labour Party who tabled a motion to repeal the suspension.

\* The IFB and the Labour Party did come together for the 1967 elections, but their alliance did not last long. Even in later years the MSM, founded by Anerood Jugnauth, went into another alliance with the LP, then headed by the son of SSR. Why do you think they could not click? Was it due to ideology, personality clashes or different political cultures?

I suppose it was to some extent a question of personalities as well as the approach to be adopted vis-à-vis the colonial authorities. Sookdeo and Basdeo were more vigorous in their defence of the people than SSR and Seeneevassen, who appeared more inclined to make all sorts of compromises, which Sookdeo in particular was not prepared to do. That did not deter them however from coming together for the 1967 elections when there was something greater at stake.

But again, as regards their differences, it could also have to do with their political grooming - one British and the Bissoondoyal's Indian. Basdeo had been to India at a time when the Indians were fighting against the British for their independence. There was beside the non-violent movement of the Indian National Congress the more

vigorous Azad Hind Movement of Subhash Chandra Bose, who would also found his party, the Forward Bloc. The inspiration for the name of the Independent Forward Bloc no doubt came from Subhash Chandra Bose's Forward Bloc whereas SSR inherited the Labour Party which was based on the British Labour Party.

\* Fifty years down the line, who do you think was right in terms of political ideology and approach: SSR or Basdeo/Sookdeo?

It is a difficult question to answer, but what played in

SSR's favour was that he had the support of the Governor and of the British at that time, who wanted him because of his pro-British inclination rather than Sookdeo to become head of independent Mauritius. Even in India, at that time, there was Jawarharlal Nehru whose approach was much like SSR's - and therefore more accommodating and acceptable to the British to be the Prime minister of India. Subhash Chandra Bose, on the other hand, was a fighter - just like Nehru was also - but less accommodating.

\* To come back to Anerood Jugnauth, even if the MSM were to go into alliances with the LP, PMSD, MMM, etc., in later years, could it also be said that the IFB's ideology had remained with and influenced Anerood Jugnauth's prime ministership down the years? For example, when you consider his position towards electoral reform, the language issue...

When you consider all these issues, I would say he was more in line with the thinking of the Bissoondoyals. But you have to first get yourself elected and thereafter have the free hand to be able to implement your ideology.

That's why he broke up with the MMM in 1982-1983. It was a mistake of Berenger to try to usurp his powers as Prime Minister. You can be the real leader of the party, but once you have chosen somebody else to be the leader of the alliance, in this case the MMM-PSM alliance, you must play by the rules. Berenger instead was disrespectful towards SAJ, and was all the time trying to convey the impression that he was the leader of that alliance.

Sir Anerood Jugnauth could not accept that. down Paul Berenger's proposal to head an MMM-IFB alliance as prime ministerial candidate, and so did Satcam Boolell in 1991. Anerood Jugnauth used realpolitik extensively and with tremendous success, joining forces with different parties - the MMM, LP, PMSD - at different times to ensure his political survival. In fact, he survived the IFB itself. What do you think?

Anerood Jugnauth was a pragmatist who knew how to take advantage of some given situation and used it effectively. He knew that the MSM on its own would not be able to fight the MMM, so he enlisted the support of the Labour Party and the PMSD. He knew what was required and how he could get it. It was the final objective that mattered to him.

\* In a way, he was more like SSR than Sookdeo Bissoondoyal, isn't it? If the latter had adopted the same approach, he might have gone much farther...

You have a point there, but when it comes to practising accommodation as a political strategy, there is a limit to which you can go to if you have lived and operated by some principles and also what your final objective is. Both Basdeo and Sookdeo were firm about their principles. They would be prepared to accommodate to some extent - but no further... because they believed that they have to live by their principles. They were really not interested with power just for power's sake.

\* It has been said recently that it was Sir Anerood Jugnauth in the main who resisted the IMF and World Bank's recommendations to slash the Education budget in 1982 at a time when the economy was doing badly. You have interacted with him in your capacity as director of the MES and later as Pro-Chancellor of the UOM. What were your impressions then of the stand he had taken?

I have been the Director of the MES for 13 years and Pro-chancellor for 17 years, and I have to say that Sir Anerood Jugnauth did not interfere in the day-to-day running of the UOM. There was never a time when he would ask me to do something, because he simply did not want to interfere. Even when Jagadish Manrakhan left as Vice-chancellor, he never sought to influence the decision-making process for the appointment of the new Vice-chancellor. It was only after we had chosen the best candidate and appointed Prof Mohamedbhai that we informed him of our decision.

As far as the IMF and World Bank are concerned, for having known poverty and the difficulty of access to education by the poor, Anerood Jugnauth was very much aware of the importance of education for the poor in our towns and villages. That is why he did not accept to slash the education budget. Also, it was during his tenure as Prime Minister, from 2000 to 2003, that his Minister of Education, Steven Obeegadoo embarked on the most ambitious project of setting up 30 State Secondary Schools and even allowed MGI to build three more secondary schools. I was adviser at that time to Steven Obegadoo, and I can tell you that he worked very hard to make that happen. The result was that access to State schools was fundamentally improved.

\* The ensuing conflict with the confessional authorities when the latter reneged on the deal relating to the trade-off Reserved Seats and Inclusion of Oriental Languages must have shaken SAJ. His hard-hitting reaction at the airport had remained stuck with him for a long time. What do you remember about that episode, and was SAJ fundamentally right at that time?

I believe he was aware, just like SSR was, that the Roman Catholic schools had done a good job and that we had to accommodate them to some extent. Thankfully, a solution for the reserved seats (50:50) was found and the government accepted the solution, which I think was in the best interests of everybody. Thereafter Oriental languages was finally accepted for inclusion for exam purposes.



# SAJ : Naissance d'un homme d'Etat

**L**es neuf mois de vie de l'alliance MMM-PSM et la bataille électorale de 1983 auront constitué l'épreuve principale de feu Anerood Jugnauth. Ils le font sortir de l'ombre géante de Paul Bérenger pour le propulser en pleine lumière au devant de la scène, en pleine possession, dorénavant, de ses moyens, pour devenir un véritable homme d'Etat.

Ses traits de caractère tels que la sincérité, l'intégrité, le sens de la discipline et le travail bien fait en sortiront renforcés.

## Les valeurs de Anerood Jugnauth

Au cours de ces neuf mois balisant deux épisodes charnières de l'histoire politique mauricienne, il aura su apprécier l'importance de l'amitié, le respect de la parole donnée, et la nécessité d'un dialogue permanent avec la population. Il aura, en même temps, fait preuve d'une énergie farouche dans la défense de ses idéaux et de sa vision pour un pays où règne la justice sociale.

La lutte contre la pauvreté et la protection des plus défavorisés lui donne l'énergie nécessaire pour résister, à l'opposé de Paul Bérenger, aux exigences du Fonds monétaire international (FMI) en ce qui concerne l'enlèvement des subsides sur le riz et la farine et l'élimination de l'éducation gratuite au niveau du secondaire.

## Conflits internes au MMM

Ce fut une décision historique qui a changé les données de la politique mauricienne de façon durable.

Il a assuré la santé financière du parti en construisant le Sun Trust à partir des donations faites au MSM pendant la campagne électorale et dont les revenus assureraient le financement des activités du parti. Anerood

Jugnauth avait toujours revendiqué la transparence dans cette entreprise tandis que d'autres qualifient l'immeuble de “bâtiment de la honte”.

## Contact permanent avec l'électorat

Une dernière remarque peut être faite au sujet du déroulement des événements de 1982 à 1983 : c'est la volonté affichée par Anerood Jugnauth d'être en contact permanent avec son électorat en organisant des réunions privées, des meetings régionaux, et des meetings nationaux, d'une part pour obtenir le soutien de cet électorat, répondre aux critiques de l'adversaire et contrer l'activisme de son principal adversaire sur le terrain.

Pendant la campagne électorale de 1983, malgré sa santé fragile, Anerood Jugnauth mettait la main à la pâte pour l'organisation des activités du parti et descendait sur le terrain pour sillonner les circonscriptions et contrer les thématiques de l'opposition.

Cette proximité et cette mobilisation constante sera sans doute capitale pour se dépêtrer du désastre potentiel de l'affaire dite des “Amsterdam Boys” qui éclate en 1985. Le MSM était très présent sur le terrain après les élections de 1983 alors que Harish Boodhoo en était responsable de l'organisation et, plus tard, le Dr Dinesh Ramjuttun prit la relève : c'est ainsi que le MSM triompha du MMM aux élections de remplacement de Ivan Collendavelloo dans la circonscription de La Caverne/Phoenix en 1989 suite à la démission de ce dernier du Parlement.

Pour remporter les élections générales de 1983 face à un MMM présent sur le terrain depuis 1969, ayant une profonde influence sur le monde syndical, Anerood Jugnauth fit l'ouverture politique vers le PTr et le PMSD, au-delà de leurs différences idéologiques, afin de constituer l'alliance bleu-blanc-rouge qui sera présentée comme le rassemblement de la grande famille mauricienne. C'est une volonté pragmatique de rassembler toutes les bonnes volontés et les compétences afin de mettre en commun leurs efforts et leurs expériences pour relever les défis énormes sur les plans économiques et sociaux.

## Nouveau départ

Le décor est ainsi planté pour que le pays prenne un nouveau départ. Le gouvernement rassemblé en 1983 sous la direction d'Anerood Jugnauth a sans doute été le meilleur dans l'Histoire du pays tant sur le plan politique que sur celui de la compétence : quelques noms restent gravés pour la postérité : Sir Gaëtan Duval, Sir Satcam Boolell, Vishnu Lutchmeenaraidoo, Kishore Deerpalsing, Armoogum Parsuramen, Kadress Pillay, travaillant de concert avec le soutien actif de Sir Seewoosagur Ramgoolam et de Harish Boodhoo.

# How virus detectives trace the origins of an outbreak – and why it's so tricky

Likewise, when a related coronavirus was identified in pangolins confiscated in an anti-smuggling operation in southern China, many leaped to the conclusion that SARS-CoV-2 had jumped from bats to pangolins to humans. The pangolin virus was found to be only 91% identical to SARS-CoV-2, though, making it unlikely to be a direct ancestor of the human virus.

To pinpoint the origin of SARS-CoV-2, a lot more wild samples need to be collected. This is a difficult task – sampling bats is time-consuming and requires strict precautions against accidental infection. Since SARS-related coronaviruses are found in bats across Asia, including Thailand and Japan, it's a very big haystack to search for a very small needle.

## Creating a family tree for SARS-CoV-2

In order to sort out the puzzle of viral origins and movement, scientists not only have to find the missing pieces, but also figure out how they all fit together. This requires collecting viral samples from human infections and comparing those genetic sequences

both to each other and to other animal-derived viruses.

To determine how these viral samples are related to each other, researchers use computer tools to construct the virus's family tree, or phylogeny. Researchers compare the genetic sequences of each viral sample and construct relationships by aligning and ranking genetic similarities and differences.

The direct ancestor to the virus, sharing the greatest genetic similarity, could be thought of as its parent. Variants sharing that same parent sequence but with enough changes to make them distinct from each other are like siblings. In the case of SARS-CoV-2, the South African variant, B.1.351, and the U.K. variant, B.1.1.7, are siblings.

Building a family tree is complicated by the fact that different analysis parameters can give different results: The same set of genetic sequences can produce two very different family trees.

For SARS-CoV-2, phylogenetic analysis proves particularly difficult. Though tens of thousands of SARS-CoV-2 sequences are now available, they don't differ from one another enough to form a clear picture of

how they're related to each other.

## The current debate: Wild host or lab spillover?

Could SARS-CoV-2 have been released from a research lab? Although current evidence implies that this is not the case, 18 prominent virologists recently suggested that this question should be further investigated.

Although there has been speculation about SARS-CoV-2 being engineered in a lab, this possibility seems highly unlikely. When comparing the genetic sequence of wild RaTG13 with SARS-CoV-2, differences are randomly spread across the genome. In an engineered virus, there would be clear blocks of changes that represent introduced sequences from a different viral source.

There is one unique sequence in the SARS-CoV-2 genome that codes for a part of the spike protein that seems to play an important role in infecting people. Interestingly, a similar sequence is found in the MERS coronavirus that causes a disease similar to COVID-19.

Though it is not clear how SARS-CoV-2 acquired these sequences, viral evolution

suggests they arose from natural processes. Viruses accumulate changes either by genetic exchange with other viruses and their hosts, or by random mistakes during replication. Viruses that gain a genetic change that gives them a reproductive advantage would typically continue to pass it on through replication. That MERS and SARS-CoV-2 share a similar sequence in this part of the genome suggests that it naturally evolved in both and spread because it helps them infect human cells.

## Where to go from here?

Figuring out the origin of SARS-CoV-2 could give us clues to understand and predict future pandemics, but we may never know exactly where it came from. Regardless of how the SARS-CoV-2 jumped into humans, it's here now, and it's probably here to stay. Going forward, researchers need to continue monitoring its spread, and get as many people vaccinated as possible.

\* Section 20 (1) f & g prescribe that the functions of the ICAC shall be to, *inter alia*, 'monitor... the implementation of any contract awarded by a public body, with a view to ensuring that no irregularity or impropriety is involved therein'; and 'examine the practices and procedures of any public body in order to facilitate the discovery of acts of corruption and to secure the revision of methods of work or procedures which, in its opinion, may be conducive to corruption'. That seems to be too heavy a load on the shoulders of the Commission, isn't it, what with so many cases still under investigation?

There is no doubt that ICAC is confronted with a whole load of cases. It has quite a numerous staff. If ICAC carries out its function without *guette figir* and in total independence from the government, it could have achieved more.

\* After all is said, will it be correct to say that The Prevention of Corruption Act 2002 does provide the adequate framework and mechanism to fight corruption?

The law is there. Its proper functioning depends on the holders of power within the ICAC. The perception in the public is that it is not functioning independently. Why, it may be asked, but this would be a rhetorical question.

### DEADLINE FOR SUBMISSION OF TAX RETURNS & APPLICATION FOR TAX ARREARS SETTLEMENT SCHEME (TASS)

The Mauritius Revenue Authority (MRA) reminds the public that the deadline for the submission of the following returns and payment of tax, if any, is **28 June 2021**.

#### • Advance Payment System (APS)

APS statements and payment of the tax by companies for any quarter ended in August 2020, and up to quarter ended in March 2021.

Payment of the 2<sup>nd</sup> instalment of tax under APS by companies operating in the tourism industry and having opted to pay tax under APS, for quarters ended in October 2019 and up to September 2020, in two equal instalments. The 1<sup>st</sup> instalment was payable on or before 29 December 2020.

#### • Corporate Tax

Payment of the 2<sup>nd</sup> instalment of corporate tax by companies operating in the tourism industry and having opted to pay corporate tax, for accounting periods ended in September 2019 and up to June 2020, in two equal instalments. The 1<sup>st</sup> instalment was payable on or before 29 December 2020.

Companies whose accounting period ends in December 2020 are also required to submit their annual income tax return and effect payment of tax, if any, by 28 June 2021.

#### • Returns and Payment of tax due in May 2021

Returns and Payment of tax, if any, that were due in the month of May 2021 from all taxpayers and employers.

#### VAT Return and Payment of VAT for the month of February 2021

Small and Medium Enterprises (SMEs), with turnover not exceeding Rs 50 million, will have up to 15 July 2021 for the submission of VAT return and payment of VAT, if any, for the month of February 2021 and that were due on 31 March 2021.

#### Tax Arrears Settlement Scheme (TASS)

Taxpayers having tax arrears, outstanding as at 31 October 2020, under an assessment issued or a return submitted on or before 31 October 2020, under the Income Tax Act, the VAT Act and the Gambling Regulatory Authority Act, are reminded that the deadline to make an application to the MRA to join the TASS is 30 June 2021.

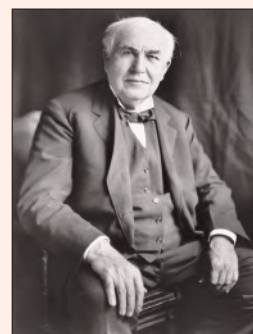

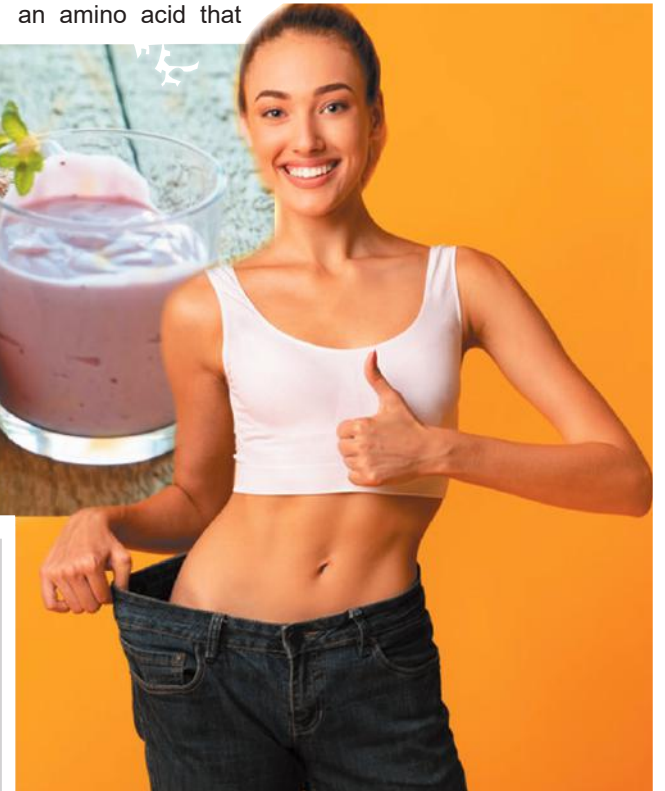
## Banana

**Conversations** - Talking to your kids and listening to them plays a big role in parenting. Hearing your kids out is as important as talking to them.

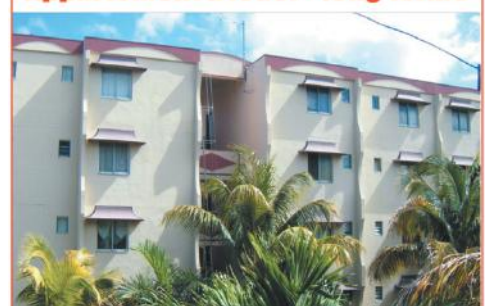

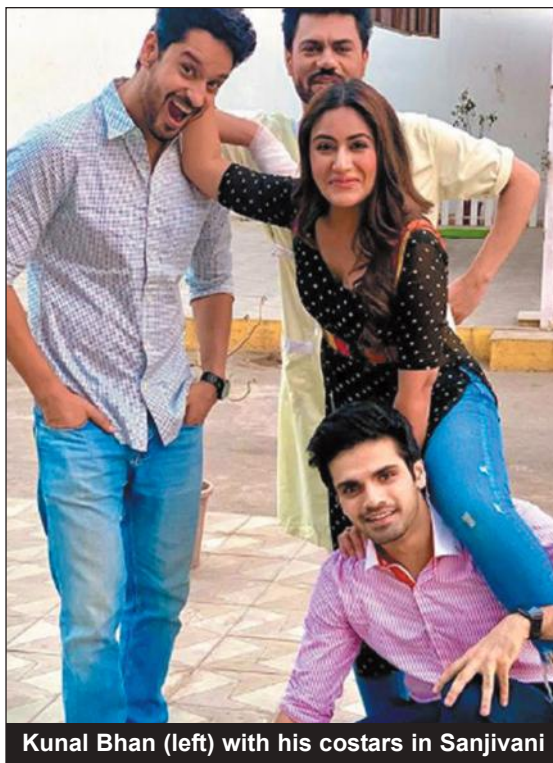

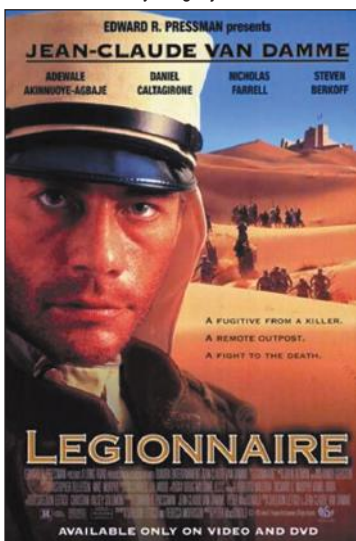

There is no doubt that nearly a century of Mauritian history unfolded in the tribute paid to Sir Anerood Jugnauth, former Prime Minister and President of the Republic of Mauritius, who had been in the limelight of Mauritian politics for six decades. Homage came pouring in from across the political, economic and social spectrum of the country after news of his demise was made public on Thursday June 3rd. The sad news made people realize that Sir Anerood Jugnauth had definitely left the political landscape of the country, of which he was, undeniably, a dominant giant. Only now that he is no more do the people of Mauritius take full measure of the extent of his commitment to politics starting from the pre-Independence era.

The media coverage of his political career is most instructive and informative to the younger generation and serves as a reminder to one and all that SAJ's engagement spans almost three generations of Mauritian politics. He joined the charismatic highly-outspoken intellectual figures, the Bissoondoyal brothers of the Independent Forward Bloc, participated in delegations to England, actively engaged in elections during the colonial days. His engagement with the MMM in the late 70s paved the way to a promising career marked by his strong personality and commitment to play a leading role in the political affairs of the country. After a brief passage in the PSM, the foundation of his own party in the 1980s, the MSM, definitely made SAJ an indisputable player in the political arena to reckon with ever since.

Destiny plays a big part in life: this was SAJ's firm belief, judging from several statements he made on his career and even on the access of his son to the post of PM in 2017. What with his meeting with world figures like Nehru and Nkrumah in England and the fire he sensed burning in them that he felt would propel them to lead and shine as prominent figures in their respective countries, we must acknowledge that his career illustrated his belief in destiny. His lucky stars shone when several external factors combined to create a rapid development of the industrial zone, namely the investment from Hong Kong industrialists in the textile industry at a time when Sir Anerood was at the helm of power. The early eighties were a

continuation of hard times which SAJ tackled with a policy of austerity advocated by the MMM, implying sacrifices people had to go through. A flourishing tourism industry and export in textiles signaled the light at the end of the tunnel, lifted thousands of Mauritians out of poverty, increased purchasing power and improved general living conditions of thousands of citizens.

Why were other charismatic leaders overshadowed by SAJ? Seasoned politicians like Sir Satcam Boolell and Sir Gaëtan Duval were great patriots and equally committed to the development of Mauritius. No one denies the contribution of SGD, mainly to the tourism industry. In general perception of politics, the former belonged to the past batch of politicians led by SSR while the latter was striding between controversial early beginnings in politics and the popularity he enjoyed thanks to his outgoing personality and a successful tourism policy he spearheaded for some years. Sir Anerood had a special drive to take the country forward, was imbued with a deep sense of patriotism to improve the life of citizens, seized the right economic opportunities by engaging with business barons of the private sector in further investments which were set to open further avenues for economic development.

SAJ's strong personality and no-nonsense style of governance combined with a sense of discipline and principle of hard work played a major role in building up a positive reputation in the population. His straightforwardness in language and rela-

tions accounted for a few abrasive statements and blunt replies to critics. These were generally brushed aside by a public to whom his leadership qualities and contribution to economic development mattered more than the choice of words and tone in heated verbal exchanges among politicians, or undiluted remarks SAJ nervously hurled at any group that he may have antagonized. His village background at Palma certainly left a deep imprint on the natural way he behaved, spoke and connected to others. I think he cared less for his image to please others than concrete actions he undertook. Anyway, politics is not an assembly of choir boys, but an arena for fighters to outsmart rivals, defend political agendas, convince others with the best arguments, promote one's worth and keep the reins of power in the party's hands.

What also endeared SAJ to the public in a way that no other party leaders of the time could was the simplicity of his village background, which he kept all his life and never disowned. He spoke spontaneously and naturally to one and all and remained a gaon man all his life. Mauritius is full of villagers who appreciate the simple way of connecting between politicians and the people, a phenomenon which is often overlooked in assessing merits and defaults of public figures.

My brother Kantilall keeps a fond memory of the Prime Minister when he was tasked by the management of Touessrok Hotel to accompany him in boat trips. SAJ wore a beret and a scarf round his neck, and was in a most relaxed mood

on such occasions. Care was taken not to pester the Prime Minister with questions; however, he spoke out and commented naturally and simply on any topic. He expected no grand reception on private visits. My youngest sister Brinda was instructed to meet SAJ with an umbrella to protect him from drops of rain a few yards away from the reception hall of Trou aux Biches Hotel. He declined the offer saying: *I am fine. Protect yourself, daughter (mo tifi)*. She obeyed, and of course, she was scolded by the administration for not insisting!. As for me, I always sensed an air of melancholy emanating from his face, which is perhaps linked to his childhood experiences.

I gauged the mood of the country on every visit during my globe-trotting experience in Europe, North Africa, the West Indies, Africa and Asia. Conversations with relatives, friends, casual encounters with all and sundry across the island conveyed a realistic overview of the hardships many folks were facing in the early 80s. Bright former Q.E.C students were jobless after completing their studies abroad. Once, I invited a couple of Sino-Mauritian girls to the house at Triolet when they knocked at the door to distribute leaflets for the Catholic Church in Port-Louis. They studied Accountancy and Architecture in Australia, and were unemployed. Faith instilled hope in them. Forget purchasing power; austerity and belt-tightening was the rule.

'Your country has refunded all its debts,' was the good news I heard from a Frenchman abroad, who had just come back from a cooperation mission in Mauritius in mid-1986. The gate was wide open to a new era of opportunities, investments, employment and prosperity. Educated young adults could not believe their eyes when they were summoned for job interviews, and were recruited. No backing or caste-preferences! Girls could find jobs and husbands as factories were set up in the villages, an idea emanating from the PMO. The pace of development gathered momentum in the early 90s. A feel-good factor pervaded society. Mauritius gained status in the region and at international level. It made Mauritians abroad proud of their country.

No wonder SAJ was disappointed at not being re-elected in 1995. There are ups and downs in every mortal's life, and no one is perfect. Destiny smiled again at him in 2000, and wiped out the humiliation of 2010 in the 2014 elections.

India did a great honour to Mauritius in declaring a mourning day on June 5th, 2021. The demise of Sir Anerood Jugnauth jolts the population, and mainly, the younger generation into an awareness of his achievements throughout his political career, and all the benefits people are enjoying today. He was the last representative of an early breed of politicians of high mettle. It is the end of an era in Mauritius. Our thoughts go to Lady Sarojini, his daughter and son, the Prime Minister, his wife, daughters and relatives. We can only say: Thank you, Sir Anerood.
