

## **Another Hit to Consumers Purse**

Yet another hit to consumers purse with the announcement of the fourth increase of petrol and diesel prices within the last five months: today Mauritians are having to fork out Rs74.10 for petrol and Rs 54.55, representing an increase of 10% over the last price increase effective as from April 19, or 40% higher than the prices that prevailed last February. The cascading adverse effects of these never-ending price increases of essential goods and other commodities coupled with those of petrol and diesel on the purchasing power of all Mauritians generally, in particular the already squeezed low-income groups and middle class cannot go unattended by the government and it is expected to do an immediate job - address the population's concern with the rising cost of living.

What is regrettable is that the country is today paying the price for past rash decisions which have resulted in the depletion of the STC's Price Stabilisation Account. First, the unjustified breach of the Betamax contract by the SAJ-led government resulting in the decision of the Singapore International Arbitration Centre in favour of Betamax instructing the payment of damages amounting to between \$115-125 million with interest, decision confirmed by the Privy Council. Another of the same nature was the nonrenewal of the contract negotiated by the LP-PMSD government with Mangalore Refinery and Petrochemicals Limited, India, for the supply of our oil products at fixed prices. It will be recalled that the exclusivity contract entered upon since 2006 contained guarantees of supply independently of any disruptions on the world market. The resulting security and quality of petroleum products supplied by Mangalore Refinery and Petrochemicals Limited were such that the contract was renewed on a three-year basis in July 2007, 2010 and 2013.

Following two years of pandemic-induced hardships, now compounded by the impacts of the Ukraine conflict on the global economy, the government should come out and tell the population what it plans to do for tackling mounting fuel, food and other prices rather than wait for the forthcoming budget to indulge in some false political bravado, as it is widely suspected, with announcements of symbolic measures to alleviate the hardships of Mauritian households. Telling the people that most of what's happening is beyond the government's control is not going to be convincing since it is public knowledge that almost 50% on the price of petrol and diesel go towards excise duty and other taxes as well as to the Covid and other solidarity funds.

Handing out something tangible is imperative today: a cost-ofliving package, including a one-off cash payment for low- and middle-income earners, as has been suggested by numerous economists, or waiver over a period of time to be determined on utilities bills and extended public transport subsidies and fuel excise and other tax cuts. The sooner the better.



## **Public Enemy Number 1**

Inflation is bad for any country's economy. It also hurts the wealth and financial well-being of individuals and households

nflation is a process of sustained increases in the general price level over a period of time, typically 12

Inflation can be calculated for a country, for specific regions in a country and for different income and demographic groups, for instance pensioners.

These different calculations are important because the spending patterns of regions and groups differ. That means that their rates of inflation also differ. It is therefore important for each household to

have a clear understanding of its own inflation rate.

A number of countries allow for the development of this improved understanding. For example, South African households can use an Internet tool such as the personal inflation calculator of Statistics SA. A personal inflation calculator, based on the spending patterns of household, is also available for the Euro area, Canada and New Zealand.

The phrase describing inflation as 'enemy number one' is borrowed from the research done by South African businessman Dr Anton Rupert on the world-wide inflation problem suffered in the 1970s.

He described inflation this way due to its distortive impact on the economies of countries and the wealth and financial well-being of households.

But the word inflation has a much earlier origin. Its first use was in the US between 1830 and 1860, when the US dollar started losing value.

In short, people experience inflation as sustained price increases. Prices continue to increase and the same amount of money buys less goods and services over time.

#### Why is it so bad?

Inflation is bad because people on fixed incomes such as pensioners get poorer over time. The buying power of their money is eroded.

A further problem is that borrowers enjoy an advantage over savers. With high inflation, the capital value of savings is eroded, while the real burden of borrowing declines. It becomes easier to repay debt. Although interest rates increase with higher inflation, the real value of the amount borrowed that has to be repaid, declines as percentage of salaries that are adjusted for inflation.

Governments are the largest borrowers in the world. They are therefore the major beneficiaries of inflation, as the real value of their debt is eroded at the expense of the taxpayers in their countries. Tax collections increase with higher inflation and government debt becomes a smaller percentage of



government revenue raised from taxes.

#### Who manages inflation and what instruments can they use?

Central banks have responsibility for containing inflation. They use the level of interest rates to con-

This responsibility for containing inflation is most noticeable in countries that use inflation targeting. In these countries, central banks adjust interest rates in line with the rate of inflation and its expected future level to contain it to the target range.

To contain inflation, central banks must keep interest rates above the inflation. This difference between the rate of inflation and the interest rate is called the real rate). When the rate of inflation accelerates and is expected to continue this trend, the central bank's policy response is a higher interest rate level (both nominal and real), commensurate with the change in the inflation trajectory.

#### What can go wrong?

Central banks can make wrong assumptions and use wrong projections in their assessment of future inflation. This can lead them to set interest rates at an inappropriate level.

An example is the recent acceleration in the inflation rate in the US to a level above 8%. At an average of around 3% per annum, the US inflation rate was at a very low level for the last four decades). Recently the rate accelerated to above 8%, without an appropriate policy response by the US Federal Reserve.

As a result, US inflation could become a persistent problem.

This unexpected acceleration in prices caught US households by surprise.

## What Pandemic Fatigue?

he term pandemic fatigue, which may have been mentioned here and elsewhere over the past year or so, does not refer to weariness with sanitary protocols and restrictions that were absolutely vital to contain the viral spread and our individual health once the virus hit our shores. Most people, especially those with co-morbidities or the elderly, perhaps more willingly than others, have overcome whatever initial resistance to mandatory discharge forms and early internet-based disinformation that had been around, have gueued up for long hours under rain or sun occasionally to get their initial and booster doses of vaccines done. Most people, shops and supermarkets have largely

respected the authorities' instructions for distancing or alphabetical listings, for regular hand disinfection, social distancing and wearing of masks in public places as were required. Government and health statistics bear out those general perceptions that justify decision-making.

Nevertheless, the authorities would have also noted the reluctance of many in the non-vulnerable groups probably to get enticed into a third booster dose, which is according to their and perhaps WHO reading, unnecessary even with new variants that have been cropping up. They would have also noted the somewhat absurd situation where tourists coming from source countries where face masks are no longer mandatory in public, have to find and wear face masks here as they trudge around the island. Half of Western Europe has indeed dropped such a requirement weeks or months ago and football stadiums have been packed to capacity in UK and elsewhere without any consequential rise in Covid-related cases. Where are the Ministers who only recently were vaunting on international media that we have vanquished the pandemic and Mauritius was open for business and visitors even without specifying that Mauritians would continue to be weighed down by heavy policing hands?

Ordinary citizens are entitled to be troubled by our inconsistencies when according to responsible Ministers we are targeting some 100,000 inbound tourists monthly. They are entitled to be aggrieved when police circulars leaked seem to send officers to rake in more fixed penalty fines for not wearing masks properly with quotas imposed on the junior rungs. They are entitled to be indignant when the authorities disburse public funds, first-class tickets and huge perdiems to a flying posse of Ministers with civil servants in tow, heading to the Dubai jalsa in the midst of difficult times and escalating prices of food, pharmaceuticals and fuel. They are entitled to ask why the emergency pandemic conditions that curtail and severely restrict our freedoms and rights are still operative now that the worst is behind us. So, what would the term "pandemic fatigue", in so far as it reflects an issue, be really about?

In a recent opinion piece, which appeared in one of Britain's most respected medical journals, the British Medical Journal of 11th May this year, entitled 'Is it really time to ditch the mask?' the authors note that face masks as a useful mitigating measure to prevent the spread of Covid-19 have been ditched in most of Western Europe and analyse the pandemic fatigue which may have set in. The idea that public adherence to risk reduction strategies diminishes over time, they note, has been contradicted by several surveys and studies, but if the public now seem exasperated by Covid measures, it may well express a high skepticism and resentment not with health measures but with factors associated with the pandemic environment and its handling. That exasperation may be due to "a perceived break in the social contract and a lack of perceived coherence, transparency, communication or justification for decisionmaking".

Today, when general economic distress, joblessness, rupee depreciation of some 20% over the past two years, and the escalation of taxes, duties and levies including VAT hit the pumps, "pandemic fatigue" refers clearly to matters beyond sanitary protocols. When in our island context, the authorities may feel some justification in the continuance of the emergency conditions that have prevailed since 2, for many citizens there is need for better justification for such a prolonged state of affairs now. Continued emergency conditions have been associated, rightly or wrongly, with the dismissal of municipal elections, with large public sector contracts being allocated without the full operation and scrutiny of tender procedures and with policing that has become an irritating constraint on our civil rights and freedoms that should operate under normal conditions.

This may be the real "pandemic fatigue" that percolates through sections of society.

A Lady as French PM

rench President Emmanuel Macron has appointed a lady as his Prime Minister responsible for coordinating a ministerial team towards generally implementing his policies. Are there cultural factors at play? In an aside, are our contexts closer to the Mediterranean mould or the wider world?

## **World in Need of Reconciliation and Healing**

The idea of healing by openly exposing hitherto hidden truths that have caused immense suffering to so many people across the world is not new, the hope being that such candid revelations publicly made would constitute a kind of collective catharsis

he latest that I have come across about the Ukrainian war is that President Zelensky has declared that he is now prepared to consider neutrality, that is not tilt towards the West - US and Europe or towards Russia, and not push for NATO membership which would automatically mean being pro-West. In this regard, it is now public knowledge that Ukraine joining NATO was never going to be a walk-over, despite Zelensky's expectation, wish or hope. In fact, the process is now pushed back even further because after the war has started there are so many conditions that must be met by Ukraine.

Paradoxically, Finland and Sweden which had maintained neutrality so far have now applied to join NATO. Apparently, this is being considered favourably, and the adhesion may not be far away. It is worth noting that Russia has declared that should this happen, it mustn't be expected that there will be no response from its side. Does this mean the opening of another theatre of war in Europe? Is that what has all the while been implied by the constant drumming about World War III?

Already, that conflict is impacting the whole world adversely on so many fronts – supply of sunflower oil, wheat, raw materials, petrol and gas, with prices shooting up everywhere and causing great hardship across the board. As regards petrol and gas, it appears that surreptitiously European countries continue to be supplied from Russia, for which they are paying in billions of dollars or rubles, and this is obviously allowing the perpetuation of the war, a classic case of positive feedback.

All countries have therefore a vested interest in seeing an end to this mayhem as soon as possible – although those who are profiting from it may not agree. The question that arises is whether it could have been prevented. At least to me this possibility seems to have existed – if only at the outset President Zelensky had anticipated the Russian intention and the ferocity of its assault, and chosen THEN rather than NOW to opt for neutrality, as former US Secretary of State Henry Kissinger had put forward, and apparently that was the Russian stance too. That opportunity having been lost, what can be done now? Has President Zelensky officially communicated his revised position to the Russian President?

That is certainly a crucial step, because it should be clear that for the sake of the whole world there is now a great need for reconciliation and healing between these two warring parties, whether by direct negotiation – which would probably be better – or by intermediaries, which would mean US and NATO pitching in. It is for

these two brother-countries to decide what is best for them, but there can be no gainsaying that it is high time to stop the destruction and unnecessary deaths of innocents on both sides of the divide.

#### **Truth Commissions**

The idea of healing by openly exposing hitherto hidden truths that have caused immense suffering to so many people across the world is not new, the hope being that such candid revelations on the part of the victims as well as the perpetrators publicly made would constitute a kind of collective catharsis that would then lead to reconciliation. Thus, the setting up of Truth & Reconciliation or Justice Commissions with a broad mandate that goes beyond the purely legal to

touch the core human dimension.

in South Africa to hear witnesses' accounts of their experiences of apartheid. It was chaired by the iconic Bishop Desmond Tutu who passed away recently, but he was no doubt the most appropriate person to occupy that office. The outcome may not have been as much as expected, but at least it hopefully set the people thinking about what happens when there is a permanent atmosphere of antagonism and enmity that is created by one party that seeks to dominate the other, and not allow such a situation to ever occur again.

There have been such commissions set up elsewhere earlier, such as in the US, as is detailed in an article 'The impossible task of truth and reconciliation' in Vox News byJen Kirbyjen on March 24, 2022, 'to look at the effects of slavery and institutional racism in America.' It is worth pondering what he writes:

'There is no one-size-fits-all truth commission, but in the past 50 years, this form of transitional justice has become a common tool to help societies move away from war or authoritarianism. More than 40 countries have used them in the aftermath of a major rupture — the fall of a dictatorship, a civil war, a genocide,' and alludes to the TRC of South Africa.

Further, he continues, 'The best truth commissions, experts say, are those that center victims, specifically the people or communities most marginalized by abuses or atrocities. This often means giving victims or their descendants a chance to testify, sometimes publicly, about how abuse or oppression affected them or their communities. Sometimes, commissions invite perpetrators, too, to testify or admit their roles in violence or abuse. Sometimes, they are there solely to bear witness to the harm they've caused.

"Victims" and "perpetrators" are black-and-white terms for situations that are almost always more complicated, and those distinctions can blur in times of war and oppression. Truth commissions exist because they deal with issues that are too big and too systemic to fit into the parameters of, say, a criminal trial. They operate

under a radical concept: that all of society has a right to fully know what happened, and how, and why. They expose the extent of the atrocities and aim to unravel what allowed them to happen, in the hope that the knowledge could prevent them from happening again.'

#### Inconvenient truths

Apart from Ukraine-Russia, there are other countries and regions where TRCs are urgently needed to prevent descent into mayhem, and each case has to be dealt with separately. Syria comes to mind, as well as Yemen/Saudi Arabia, Afghanistan, and India where currently there is much animosity between the two main communities, Hindus and Muslims, because of inconvenient truths that are being revealed by archaeological and other findings, currently concerning the Gyanwapi mosque-mandir in Varanasi. Such findings — among other ones —laboriously and meticulously discovered, collected, documented and presented by archaeologist KK Mohammad to the Supreme Court when the case was being examined helped immensely to set to rest once for all the Ram Mandir issue at Ayodhya.

With a desire to stick to truths similarly revealed by established scientific and archaeological methods in the case of the Gyanvapi mosque-mandir, and goodwill on both sides, there is no reason why an outcome akin to the Ayodhya one cannot be reached.

In this respect, two very well-articulated and sober articles in the Indian press rise above the din and provide very balanced insights that can contribute to the way forward towards reconciliation and healing. They are 'Beyond Politics, Gyanvapi Is About The Hindu Civilisation' in *Swarajya* magazine of May 16, 2022 by Taushar Gupta, sub-editor, and 'The Places of Worship Act is a generous law. Indian Muslims can best reciprocate this generosity by adhering to the Quranic morality in Gyanvapi Masjid's case,' by Ibn Khaldun Bharati in *The Print* of 17 May, 2022.

Yes, the whole world is in great need of reconciliation and healing.

Judicial Independence

## "There is no reason to believe that the judiciary in Mauritius is not independent"

here are no indications that our judiciary does not value its independence even if the current mode of appointment of the Chief Justice, by the President on the advice of the PM, may have to be looked into. Our Supreme Court operates differently from the judicial activism and public interest litigation that were pioneered by the Supreme Court of India.

Nevertheless, it has important roles for instance in upholding the sanctity of our electoral processes. Lex shares his views.

#### **LEX**

\* The textbook explanation of judicial independence is that the judiciary should be independent from the other branches of government, that is courts should not be subject to 'improper influence from the other branches of government or from private or partisan interests'. Does our judiciary meet those criteria?

As at present advised, there is no reason to believe that the judiciary in Mauritius is not independent. Rumours create an atmosphere of mistrust, and any allegation which suggests otherwise has to be proved.

\* Besides constitutional safeguards, could it be said that security of tenure and proper terms and conditions of service as well as prohibition of practice after retirement do contribute towards promoting the independence of our judiciary?

Of course, security of tenure is a key factor in maintaining the independence of judges. The prohibition to practise is only modelled on a British tradition that judges should not go into private practice as barristers. But they can act as consultants.

\* It's said and expected that that the independence of the judiciary has to be promoted or led by the Supreme Court, the highest judicial authority in the land. Have there been instances where our Honourable Judges have stepped forward to check unwarranted attempts to exercise control over the judiciary or to ensure that there is no misuse of power by any section of the government or political authority?

Judges are not supposed to enter into any public controversy. It is because of this that those who aim to or do criticize judges, either in private or in public, should bear in mind this factor.

In the case of the Slovak national, for example, the judge whose order was breached referred the matter to the DPP

\* What is the judiciary, as presently constituted, doing to ensure its independence?

The Chief Justice is appointed by the President on the recommendation of the Prime Minister. Is this the right way to go about it? It's a question worth pondering. It could be left to the President to appoint the Chief Justice in his own deliberate judgment. But again, the President is a political nominee. All this does not look healthy. But once

the Chief Justice is appointed, he/she should be totally immune from any influence from the Executive.

\* The Supreme Court has no power to enforce its decisions. What if the Executive and Legislative branches refuse to carry out its rulings?

Anybody or any institution that does not obey or comply with a court order is amenable to being punished for contempt of court.

\* There have been reports recently of some young lady magistrates, mostly of the Intermediate Court, taking to task other powerful arms of the government — the police or even the SLO — and refusing to receive instructions in the exercise of their jurisdiction. A welcome change?

Any magistrate or any judge is a buffer between the Executive represented by the police, the Office of the DPP or the State and the general public. This is not to be viewed as a welcome change. This has always been the case though unfortunately some magistrates are perceived to be very leaning towards the police.

\* The judiciary can also play an important role in ensuring that democracy does not give way to any form of dictatorship. But it can only play this role if it's independent. Are there lessons to draw from the Indian judiciary, known for its independence and extensive powers, in that regard?

One cannot compare the Mauritius Supreme Court to the Indian Supreme Court. In India there is a very active and vibrant Supreme Court that places the rights of the individual at the forefront of its concerns without relinquishing its independence or its commitment towards fairness and impartiality. Take, for example, the notion of public interest litigation that has been created by the Supreme Court of India. Do you see this happening here? In Mauritius before anybody can challenge any matter of general public interest, he must show how he has an interest in the matter, in other words he has to demonstrate that he has locus standi.

\* The Supreme Court of India is said to have become 'more active through constitutional interpretation', and that is why judicial activism there has become quite popular with judges 'protecting the rights of citizens or from political unfairness, formulating social policies, and ensuring justice even when the relevant federal bodies are not performing their duties'. Why was the judicial activism necessary when it's the Supreme Court's mandate to safeguard people's rights and freedoms and ensure equal protection for all in the first

Indeed. The Indian Supreme Court is viewed as a very liberal and active court unlike the Mauritius Supreme Court that is consi-dered to be quite conservative on many issues.

\* The judiciary's role in deciding the validity of parliamentary elections also necessitates independence of the judiciary. Have we done fairly well on that count, isn't it?

Independence of judges in determining election petitions is of the utmost importance.

No election petition has been successful since the 2019 elections. This is not to say that the judges have not discharged their judicial functions independently.

However, one is entitled to ask questions about the recourse to computers on Counting Day. How could that be normal and legal? As a matter of fact, the failure of the Electoral Commission to inform candidates of the presence of the computer room, an issue that had been flagged by the opposition parties to contest the legality of the 2019 general elections, was noted by the Judges in the Erza Jhuboo petition when they said that it was a matter of "serious concern as it unnecessarily creates a situation whereby doubts as to the integrity of the counting process may arise".

There is also the point made by Darmajai Mulloo, Chief Electoral Officer, before the Court that "partial results are not regulated by any enactment but still they are announced by the Returning Officers... and in the same manner, the computer room could be set up in the absence of any rules". How could that be normal and legal?

\* On the other hand, judges are not democratically accountable to the people, and there is the risk that an extremely independent judiciary might lack judicial accountability with possible abuse of power made by judges. What's your take on that?

The only accountability is public opinion. Judges' reputation rises or falls according to the perception that the public has of their decisions.

## The Most Dangerous Branch – Justice Alito's un-American Screed

It is a sad commentary that courts in Colombia, Argentina, and Mexico have ruled to decriminalize abortion while the American Ayatollahs of the US Supreme Court yank us backward with their medieval thinking

n Federalist 78, Alexander Hamilton spoke to the division of power among the different departments or branches

established by the new Constitution of the United States. In describing the judiciary as the least dangerous department or branch, he wrote: "Whoever attentively considers the different departments of power must perceive, that in a government in which they are separated from each other, the judiciary, from the nature of its functions, will always be the least dangerous to the political rights of the constitution; because it will be least in a capacity to annoy or injure them. The executive not only dispenses the honors, but holds the sword of the community. The legislature not only commands the purse, but prescribes the rules by which the duties and rights of every citizen are to be regulated. The judiciary on the contrary has no influence over either the sword or the purse."

Little did he know that the Supreme Court would one day strive to control women's fallopian tubes and the uterus and thus become the most dangerous branch of government as its right-wing judges pander to the preferences of the Republican senators who put them there.

Justice Alito's draft opinion (circulated among US Supreme Court justices, and which suggested that earlier this year a majority of them had thrown support behind overturning the 1973 case Roe v. Wade that legalized abortion in the US) is a tour de force of shoddy reasoning, willful evasion, and reflects a hell-bent determination to do something that is un-American to the core: declare that a fundamental right can be legislated away by a state. It is an invitation for a minority view of morality to be imposed on those who do not share such a view. It is a march back to the 12th Century or before.

Before we explore why Justice Alito's pronouncements do not hold water, let us go back and understand what *Roe v. Wade* really decided and how the *Planned Parenthood v. Casey* decision clarified the Roe's essential holding. Then we can see why Justice Alito either misunderstands or misstates these holdings and why his decision tramples on fundamental values. In fact, we will see that for a man who professes to be a strict constructionist, applying only the language of the Constitution, he in fact ignores the plain words of that document.

#### The Core Ruling of Roe v. Wade

In Roe v. Wade, the court acknowledged that the Constitution does not explicitly mention any right of privacy. Nevertheless, in decisions going back at least to 1891, the Supreme Court has recognized a right to privacy. In the Union Pacific R. Co. v. Botsford case, the court declared: "No right is held more sacred or is more carefully guarded by the common law than the right of every individual to the possession and control of his own person, free from all restraint or interference of others unless by clear and unquestionable authority of law." That was in 1891. Note that the court adverted to the common law, meaning that this recognition was of long-standing duration and indeed, before the first settlers arrived to colonize America.

In 1969, four years before Roe was decided, the Supreme Court observed in Stanley v. Georgia, "Also fundamental is the right to be free, except in very limited circumstances, from unwanted governmental intrusions into one's privacy." Justice Blackmun writing for the court, gave other examples and noted that some courts had found the right to privacy inheres in the due process clause of the fourteenth amendment to the US Constitution. In the 1923 case Meyer v. Nebraska, the court expressed it thus: "Without doubt, it denotes not merely freedom from bodily restraint, but also the right of the individual to contract, to engage in any of the common occupations of life, to acquire useful knowledge, to marry, establish a home and bring up children, to worship God according to the dictates of his own conscience, and generally to enjoy those privileges long recognized at common law as essential to the orderly pursuit of happiness by free men."

I note that the freedom to marry, establish a home, and to bring up children cannot be freedoms unless the concept includes the right NOT to marry, NOT to establish a (marital) home, and NOT to have children.

Importantly, in the *Meyer case*, the court stated: "The established doctrine is that this liberty may not be interfered with, under the guise of protecting the public interest, by legislative action which is arbitrary or without reasonable relation to some purpose within the competency of the State to effect. Determination by the legislature of what constitutes proper exercise of police power is not final or conclusive but is subject to supervision by the courts."

With this historical recognition of the right, the Supreme Court in *Roe* ruled that the right to privacy "is broad enough to encompass a woman's decision whether or not to terminate her pregnancy."

It is important to remember that the opinion in Roe explicitly states that the woman's right to decide the abortion question is founded in the Fourteenth Amendment's concept of personal liberty and restrictions upon state action, but also acknowledges, without criticizing the ruling, that the lower court found the right to be within those reserved by the Ninth Amendment to the people. I will return to the Ninth Amendment later in this review

The rest of the court's opinion in *Roe* dealt with the recognition that the right to terminate a pregnancy is not unfettered through the entire period of gestation but must bear some relationship to viability of the fetus and that the state has a legitimate interest in preserving the life of both the mother and the unborn child. As a result, the court seeing no bright line where viability is conclusive, established markers based on the three trimesters of pregnancy. To be sure, there is no constitutional imperative to these lines, but they do deal with the constitutional imperative of securing fundamental rights of the mother, while also pre-

serving the *legitimate* interest of the state in reasonable *regulation* through legislation.

#### Roe v. Wade Ratified

In the *Planned Parenthood v. Casey* decision, the Supreme Court reaffirmed the essential holding of *Roe*. And the court took pains to explain that the holding of *Roe* has three parts. First is the right of the woman to have an abortion before viability without undue interference from the state. Second, it confirms the power of the state to restrict abortions after fetal viability so long as the law does not reach so far as to restrict them when the woman's life or health is in danger. Third, the state has a legitimate interest from the outset of the pregnancy in protecting the health of the woman and the life of the fetus that may become a child. The court did not see these principles as contradicting one another.

Significantly, the court in *Casey* reiterated that this constitutional right derives from the Fourteenth Amendment which declares that no State shall "deprive any person of life, liberty, or property, without due process of law." The concept of "liberty" is at issue and the Due Process clause has been interpreted as protecting all fundamental rights comprised within the term "liberty." These guarantees of due process are longstanding, having their roots in Magna Carta and, in the United States, they have become bulwarks against arbitrary legislation regardless of the procedures used to adopt such laws.

The Constitution does not mention the word "marriage". Nevertheless, the substantive due process rights have led to protection of both interracial and same-sex marriage.

Similar protections have been extended to rights of procreation, contraception, family relationships, child rearing, and education. None of these is explicitly mentioned in the Constitution.

The Casey case clarified that the right to liberty is not a series of isolated points that are limited to those rights mentioned in the Bill of Rights, i.e., the taking of property, freedom of speech, press, and religion, the right to keep and bear arms, or freedom from unreasonable searches and seizures, but rather it is a rational continuum which, broadly speaking, includes a freedom from all substantial arbitrary impositions and purposeless restraints.

Where there are differences of opinion based on morality, here's what the court in Casey said: "Men and women of good conscience can disagree, and we suppose some always shall disagree, about the profound moral and spiritual implications of terminating a pregnancy, even in its earliest stage. Some of us as individuals find abortion offensive to our most basic principles of morality, but that cannot control our decision. Our obligation is to define the liberty of all, not to mandate our own moral code. The underlying constitutional issue is whether the State can resolve these philosophic questions in such a definitive way that a woman lacks all choice in the matter, except perhaps in those rare circumstances in which the pregnancy is itself a danger to her own life or health or is the result of rape or incest."

And the Casey court explained that ultimately, "It is conventional constitutional doctrine that where reasonable people disagree the government can adopt one position or the other. That theorem, however, assumes a state of affairs in which the choice does not intrude upon a protected liberty."

To make it clear, the state may NOT intrude upon a protected liberty by endorsing one moral choice over another.

#### **The Ninth Amendment**

The Ninth Amendment to the Constitution is strikingly straightforward: "The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people."

The meaning of this language is simple and straightforward. It means simply that the fact that, for example, the right to free speech is listed as a protected right, does not mean that another right, for example, the right to privacy or liberty, may be denied or disparaged.

This may be obvious, but it is worth noting that the framers of the Constitution were expressly stating that the people have more rights than those specifically mentioned in the Constitution.

#### The Right to Liberty

Is there a right to liberty? And, if so, is it one of long standing and recognition?

The answer is as strikingly straightforward as is the Ninth Amendment. The Declaration of Independence, which predated the Constitution by eleven years, declared: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed."

The document that set out the basis on which this nation was conceived declared liberty not only a right but an unalienable right. It is worth noting that in his Gettysburg Address, President Lincoln spoke of a nation "conceived in

liberty."

The significance of the Declaration of Independence was not lost on the framers of the Constitution. The Preamble to the Constitution states: "We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America." The very purpose of the Constitution is stated to be to secure the Blessings of Liberty.

There is no question that Liberty is a right protected by the Constitution.

#### **Justice Alito's Opinion**

With that background in what the Supreme Court had decided, let us turn to Alito's draft opinion.

At the outset, Alito falsely states that the opinion of the justices who upheld *Roe* did not endorse *Roe's* reasoning. As we have seen, this is emphatically not so. Nor did any of the justices have reservations

about whether the Constitution protects a right to abortion as Alito states. In fact, the statement of the court on this aspect of the matter bears our attention: "Though abortion is conduct, it does not follow that the State is entitled to proscribe it in all instances. That is because the liberty of the woman is at stake in a sense unique to the human condition and so unique to the law. The mother who carries a child to full term is subject to anxieties, to physical constraints, to pain that only she must bear. That these sacrifices have from the beginning of the human race been endured by woman with a pride that ennobles her in the eves of others and gives to the infant a bond of love cannot alone be grounds for the State to insist she make the sacrifice. Her suffering is too intimate and personal for the State to insist, without more, upon its own vision of the woman's role, however dominant that vision has been in the course of our history and our culture. The destiny of the woman must be shaped to a large extent on her own conception of her spiritual imperatives and her place in society."

Alito's next attack was on the rationale of *Roe* as confirmed and ratified by *Casey*. He declared that the Constitution makes no reference to abortion and "no such right is implicitly protected by any constitutional provision, including ... the Due Process Clause of the Fourteenth Amendment. That provision has been held to guarantee the rights that are not mentioned in the Constitution, but any such right must be 'deeply rooted in this Nation's history and tradition."

There are three responses to this nonsensical statement. *First*, no right could more deeply rooted in American history and tradition than the right to liberty as we have seen. *Second*, since Alito claims to be a strict constructionist who adheres to the language of the Constitution, why does the Ninth Amendment not prevent him from denying a right based on liberty? *Third*, Alito cites the case of *Washington v. Glucksberg*, but that case does not stand for the proposition that he attributes to it. In that case, the court held that a law preventing assisted suicide was not unconstitutional because assisting suicide had never been deemed a right and neither had any right to commit suicide ever been recognized.

Ultimately, Alito's opinion depends on a view of morality that is as un-American as any ever stated by a court. He begins his opinion by stating: "Abortion presents a profound

moral issue on which Americans' hold sharply conflicting views." His opinion ends with this: "We end this opinion where we began. Abortion presents a profound moral question. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion. Roe and Casey arrogated that authority. We now overrule those decisions." In between, he wrote: "It is time to heed the Constitution and return the issue of abortion to the people's elected representatives." Of course, this is nonsense. As he already stated, the Constitution does not mention abortion, let alone stating that the issue should be decided by the people's elected representatives.

Nor does Alito ever explain why the majority, or a minority for that matter, is entitled to legislate its view of morality in curbing the rights of individuals who disagree with the views of morality adopted by their fellow citizens or elected representatives.

#### A Profoundly un-American Decision

Justice Alito's view of the power of the government to dictate what free individuals are allowed to do and what they may not do in pursuing their own happiness is at odds with the Declaration of Independence and the Preamble to the Constitution. It is also at variance with the Fourteenth Amendment and the Ninth Amendment.

Nor is what he writes sound constitutional interpretation. The Constitution expressly declares that rights not enumerated shall not be denied or abridged. The right to liberty is a fundamental right. Yet, Alito suggests that a legislature in one state elected by Republicans may deny such a right whereas a legislature elected by Democrats in another state may grant and enlarge such a right. Where is equality in that concept of government?

Alito may have profound religious objections to abortion. The simple answer is, if you are opposed to abortion, don't have one. There is nothing in our Constitution that permits the followers of one religion to impose their views of morality on others.

It is a sad commentary that courts in Colombia, Argentina, and Mexico have ruled to decriminalize abortion while the American Ayatollahs of the US Supreme Court yank us backward with their medieval thinking.

## North Korea's suspected Covid-19 caseload nears two million

North Korea on Thursday reported 262,270 more suspected Covid-19 cases as its pandemic caseload neared 2 million — a week after the country acknowledged the outbreak and scrambled to slow infections in its unvaccinated population.

The country is also trying to prevent its fragile economy from deteriorating further, but the outbreak could be worse than officially reported since the country lacks virus tests and other health care resources and may be underreporting deaths to soften the political impact on authoritarian leader Kim Jong Un.

North Korea's anti-virus headquarters reported a single additional death, raising its toll to 63, which experts have said is abnormally small compared to the suspected number of coronavirus infections, reports AP.

The official Korean Central News Agency said more than 1.98 million people have become sick with fever since late April. Most are believed to have Covid-19, though only a few omicron variant infections have been confirmed. At least 740,160 people are in quarantine, the news agency reported.

After maintaining a dubious claim that it had kept the virus out of the country for two and a half years, North Korea acknowledged its first Covid-19 infections May 12 and has

described a rapid spread since.

Kim has called the outbreak a "great upheaval," berated officials for letting the virus spread and restricted the movement of people and supplies between cities and regions.

Workers were mobilized to find people with suspected Covid-19 symptoms who were then sent to quarantine — the main method of curbing the outbreak since North Korea is short of medical supplies and intensive care units that lowered Covid-19 hospitalizations and deaths in other nations.

Experts say North Korea cannot afford a lockdown that would hinder production in an economy already broken by mismanagement, crippling U.S.-led sanctions over Kim's nuclear weapons ambitions and pandemic border closures.

It's unclear, however, if North Korea would accept outside help. It already shunned vaccines offered by the U.N.-backed Covax distribution program, and the nation's leaders have expressed confidence the country can overcome the crisis on its own

Experts have said North Korea may be more willing to accept help from China, its main ally. South Korea's government had said it couldn't confirm media reports that North Korea flew planes to bring back emergency supplies from China this week.

#### Sri Lanka economic crisis: CID interrogates 4 MPs over attacks on protesters

Officers from Sri Lanka Police's Criminal Investigation Department have questioned four Members of Parliament, including two former ministers, over last week's violence against protesters at two protest sites in Colombo, the country's largest city.

According to reports, a CID team arrived at the Parliament Complex on Wednesday to interrogate -- with the Speaker's permission -- and record the statements of Rohitha Abeygunawardena and CB Ratnayake, the two ex-ministers. The team also questioned and recorded the statements of MPs Sahan Pradeep and Sanjeewa Edirimanne, reports Hindustan Times.

On Tuesday too, a CID team questioned several parliamentarians in connection with the May 9 attacks on demonstrators by supporters of President Gotabaya Rajapaksa and his older brother, then-Prime Minister Mahinda Rajapaksa, at the 'Main Go Gama' and 'Gota Go Gama' protest sites, at Temple Trees and Galle Face Green, respectively, in Colombo.

More than 100 protesters were injured at Galle Face Green as a result of the mob attack. This prompted Mahinda Rajapaksa, already under pressure to step down due to the island nation's worst economic crisis, to resign.

Later that day, furious agitators laid siege to Temple Trees, the official residence of the Prime Minister of Sri Lanka, forcing the military to intervene and whisk Mahinda Rajapaksa and his family away to safety.

With no government in place, President Gotabaya Rajapaksa, last Thursday, appointed Ranil Wickremesinghe as the Prime Minister, which marked the latter's record sixth stint in the position. In a national address on May 16, Wickremesinghe said, among other things, that the country's economy was in a 'precarious condition' and that the nation of 22 million inhabitants was 'currently out of petrol.'

## World Bank to offer \$30 billion as Ukraine war threatens food security

The World Bank said on Wednesday it will make \$30 billion available to help stem a food security crisis threatened by Russia's war in Ukraine, which has cut off most grain exports from the two countries.

The total will include \$12 billion in new projects and over \$18 billion funds from existing food and nutrition-related projects that have been approved but have not yet been disbursed, the bank said.

The bank said the new projects are expected to support agriculture, social protection to cushion the effects of higher food prices on the poor, and water and irrigation projects. The majority of resources going to Africa and the Middle East, Eastern Europe and Central Asia, and South Asia, reports Reuters.

These areas are among the hardest hit by the impact of the war in Ukraine on grain supplies. Countries such as Egypt are highly dependent on Ukrainian and Russian wheat and are scrambling for supplies as Russia has blockaded Ukraine's agricultural exports from Black Sea ports and has imposed domestic export



restrictions.

The European Bank for Reconstruction and Development plans to make 500 million euros available for food security and trade finance for agricultural and food products, out of a 2 billion euro package for Ukraine and neighboring countries affected by the war, the Treasury report said. Ukraine would

get 200 million euros and neighboring countries would get 300 million euros.

The International Monetary Fund will provide financing support through its normal channels, which are limited by countries' shareholdings and whether their debt is deemed sustainable.

#### US to offer India \$500 mn in military aid to reduce Russia dependence

The US is preparing a military aid package for India to deepen security ties and reduce the country's dependence on Russian weapons, people familiar with the matter said.

The package under consideration would include foreign military financing of as much as \$500 million dollars, according to one person, which would make India one of the largest recipients of such aid behind Israel and Egypt. It's unclear when the deal would be announced, or what weapons would be included.

The effort is part of a much larger initiative by President Joe Biden's administration to court India as a long-term security partner, despite its reluctance to criticize Russia for its invasion of Ukraine, according to a senior US official who asked not to be named, reports Bloomberg.

Washington wants to be seen as a reliable partner for India across the board, the official added, and the administration is working with other nations including France to make sure Prime Minister Narendra Modi's government has the equipment it needs. While India is already diversifying its military platforms away from Russia, the US wants to help make that happen faster, the official said.



The major challenge remains how to provide India major platforms like fighter jets, naval ships and battle tanks, the official said, adding that the administration is looking for a breakthrough in one of these areas. The financing package being discussed would do little to make those types of systems -- which can cost billions or tens of billions of dollars -- more affordable, but it would be a significant symbolic sign of support.

India's Foreign Ministry didn't immediately respond to a request for comment. Officials at the State Department and US embassy in New Delhi didn't immediately respond to a request for comment.

India is the world's largest buyer of Russian weapons, although it has scaled back that relationship of late.

Over the past decade, India has bought more than \$4 billion worth of military equipment from the US and more than \$25 billion from Russia, according to the Stockholm International Peace Research Institute.

India's dependence on Russia for weapons against neighbours China and Pakistan is a big reason Modi's government has avoided criticizing Russian President Vladimir Putin over the war in Ukraine. As the US, Europe, Australia and Japan piled economic sanctions on

Russia, India has held off and instead continued imports of discounted Russian oil.

While the US and its allies were initially frustrated with India, they have sought to woo Modi's government as a key security partner -- including against China in the Indo-Pacific region. Modi is set to join a summit with Biden next week in South Korea that also includes Quad members Japan and Australia, and the Indian leader also received an invitation to join the Group of Seven leaders in Germany next month.

Links between the US and India have steadily deepened over the past two decades, with the two sides reaching agreements that allow for more interoperability between their military platforms.

Still, it remains to be seen how far India will go in accepting US military assistance. Russia has historically supplied the majority of India's military hardware, including fighter jets and missiles, as well as almost all its tanks and helicopters. Modi's government has told the US the alternatives to moving away completely from Russian weapons imports are too expensive, according to people familiar with the situation.

## A third of US should be considering masks, officials say

covid-19 cases are increasing in the United States — and could get even worse over the coming months, federal health officials warned Wednesday in urging areas hardest hit to consider reissuing calls for indoor masking.


Right now, about a third of the US population lives in areas that are considered at higher risk — mostly in the Northeast and Midwest. Those are areas where people should already be considering wearing masks indoors — but Americans elsewhere should also take notice, reports AP.

However, officials were cautious about making concrete predictions, saying how much worse the pandemic gets will depend on several factors, including to what degree previous infections will protect against new variants.

Last week, White House Covid-19 coordinator Dr Ashish Jha warned in an interview with The Associated Press the US will be increasingly vulnerable to the coronavirus this fall and winter if Congress doesn't swiftly approve new funding for more vaccines and treatments.

Jha warned that without additional funding from Congress for the virus would cause "unnecessary loss of life" in the fall and winter, when the US runs out of treatments.

The pandemic is now 2 1/2 years old. And the US has seen — depending how you count them — five waves of Covid-19



during that time, with the later surges driven by mutated versions of the coronavirus. A fifth wave occurred mainly in December and January, caused by the omicron variant.

The omicron variant spread much more easily than earlier versions. Some experts are worried the country now is seeing signs of a sixth wave, driven by an omicron subvariant.

Hospitalizations also are rising, up 19% in the past week, though they remain much lower than during the omicron wave.

Officials said they are concerned that waning immunity and relaxed mitigation measures across the country may contribute to a continued rise in infections and illnesses across the country. They encouraged people — particularly older adults — to get boosters.

## Why monkeypox cases are rising in Europe

Ahave now been reported or are suspected in the United Kingdom, Portugal and Spain.

The outbreaks are raising alarm because the disease mostly occurs in west and central Africa, and only very occasionally spreads elsewhere, reports Reuters.

Here's what scientists know so far.

Monkeypox is a virus that causes fever symptoms as well as a distinctive bumpy rash. It is usually mild, although there are two main strains: the Congo strain, which is more severe – with up to 10% mortality – and the West African strain, which has a fatality rate of more like 1% of cases. The UK cases are least have been reported as the West African strain.

Portugal has logged five confirmed cases, and Spain is testing 23 potential cases. Neither country has reported cases before.

#### **Transmission**

The virus spreads through close contact, both in spillovers from animal hosts and, less commonly, between humans. It was first found in monkeys in 1958, hence the name, although rodents are now seen as the main source of transmission.

Transmission this time is puzzling experts, because a number of the cases

in the United Kingdom - nine as of May 18 - have no known connection with each other. Only the first case reported on May 6 had recently travelled to Nigeria.

As such, experts have warned of wider transmission if cases have gone unreported.

The UK Health Security Agency's alert also highlighted that the recent cases were predominantly among men who self-identified as gay, bisexual or men who have sex with men, and advised those groups to be alert.

Scientists will now sequence the virus to see if they are linked, the World Health Organization (WHO) said this week.

One likely scenario behind the increase in cases is increased travel as Covid restrictions are lifted.

Monkeypox puts virologists on the alert because it is in the smallpox family, although it causes less serious illness.

Smallpox was eradicated by vaccination in 1980, and the shot has been phased out. But it also protects against monkeypox, and so the winding down of vaccination campaigns has led to a jump in monkeypox cases, according to Anne Rimoin, an epidemiology professor at UCLA in California.

But experts urged people not to panic.



## What they teach you in Business School

If we divide jobs into technical and generalist jobs, engineers, doctors, educationists, agriculturists and scientists would fall in the first category while managers and administrators would come under the second


or the last several years I have been writing about how our skewed remuneration structure is disincentivising the study of pure sciences, mathematics, technology and medicine amongst our best youngsters. It is natural for young men and women to veer towards careers where they will earn the best salaries. We therefore see an increasing number of bright youngsters, who graduate from technical and medical institutes, go in for an MBA to better their earning potential. So, what do these technically qualified youngsters learn at business schools, which they have not been able to learn till their graduation?

After five years of engineering studies, I also joined an MTech program in Systems Management. This was an MBA program for engineers, designed after the Harvard Business School model, with added inputs of Operations Research, Systems Modelling, Project Management and Computer applications. It was an interesting program with a lot of case studies, discussions and presentation of reports. Corporate Social Responsibility and Ethics was one of the subjects, as a part of which we had to write a long paper on Business Ethics. I decided to write on 'Ethics in Advertising'.

#### **Hidden Persuaders**

I had recently picked up a book by Vance Packard from a roadside seller. The 'Hidden Persuaders' dealt with subjects like subliminal messaging and how advertisers, instead of projecting the qualities and worth of their products, were trying to play on the fears, anxieties, poor selfworth of the consumer and their need for keeping up with the Joneses, to pitch their products through human gullibility. I thought this was unethical because we had been told that in the true spirit of laissez-faire and a perfectly competitive market, you needed to build a more effective rat trap if you wanted to beat the competition

So, my long paper dealt with these



In interactions with several directors and senior professors of leading management schools I have asked a simple question. "When a graduate engineer from our leading technology institutes like the IITs steps into the job market after four years she can, on an average, expect a pay package of around Rs 600,000 to Rs 1million, but after going through a two-year MBA program at an IIM the same youngster can command a package of up to Rs 5 million per annum or even more. My question is what do you teach them in two years that their market worth is multiplied five-fold?"

issues and raised the spectre that if we did not stop these unfair practices, we would soon see a day when advertisers would try to defeat common sense, good education and rational behaviour with attempts to manipulate the minds of the consumer and sell worthless items, crea-ting needs where none existed. A day would also come when a seller would knock you down with a whack on the head, or drug you, or blunt your rationality and, in a semiconscious state, make you sign the sale deed! We now see this happening all around us. Our minds are numbed by false claims of 'super efficiency'. No Sir, super efficiency is a chimera - it is a con.

Just as Value Engineering taught us that the importance of aesthetics has to be kept in mind, and a paper clip cannot replace a tie pin, societal needs cannot be discarded at the altar of the efficiency being promised by the endless supply of Apps being pushed down our throats. These Apps monitor all your habits and evaluate your vulnerabilities which, fed into sophisticated algorithms, reinforce preju-

dices and lead you into directions of behaviour without your realising that you have lost control of the stick and rudder. The scary part is that, with our minds taken over by these unscrupulous professional manipulators, we are demanding more and more of the junk - whether it is technology, food, entertainment or social media

Going back to my long paper on Business Ethics, Prof Nader who taught the subject evaluated it at a high score of nine upon ten. As part of corporate policy, we knew the concepts of insider trading, creative writing of accounts and balance sheets, booking profits at opportune times, etc. Many of our guest faculty were notable gentlemen from the corporate world, both professional managers and promoters, who showed us how to bend regulations and work around the laws and rules of the country to maximize their profits.

Fortunately, non performing assets (NPAs) and their creative use, and influencing government policy through politicians, were still not standard business strategy,

or were considered too sensitive to be discussed with greenhorn management students. Seeing the business acumen and value systems of these top corporate honchos. I had no doubt that most of them would have evaluated my ethics paper at a comprehensive zero! So, I decided it was best I stay away from the idea of working for the business world. I chose another career path.

#### The nation's wealth

Several years later, talking to a graduating class at an IIM convocation function, I stated that while – "we all know that business enterprises exist to maximise profits for the promoters, investors and the shareholders, we always forget one stakeholder. In addition to finance and human resources every enterprise also needs natural resources i.e., land, mine-rals, forest produce, water, air, wave length, etc. These natural resources are the nation's wealth – they belong equally to each and every citizen of this country – each and every one from the richest to the poorest – and equally!

"The common man entrusts these resources to his elected representatives, who are expected to invest them to maximise the returns for him, through use by private and public enterprise. Therefore, as professional managers while you must give your best to maximise your company's profits, you should not forget your obligation to the common man, the forgotten, faceless stakeholder, who is the owner of the resources you are using to generate those profits.

"You have to take only an equitable proportion out of the profits, even as you plough back remaining profits into the company or give out to society. In doing so, you are actually doing a good turn to yourself. Industry can grow only when you increase the purchasing power of more and more people. This can only happen by generating employment, giving fair wages and ensuring equitable distribution of the corporate profits."

I told them that, having studied at a prestigious IIM, they were obviously intelligent, motivated and socially responsible youngsters, who should vow not to become compliant professionals. "Your pay and perks should not lull you into accepting the status quo. Do not create false needs and desires amongst gullible people - which will eventually include your own children someday. Look upon yourselves as leaders who will help society discern between real needs and artificially created needs. Remain committed that your work should not lead to exploitation of human, financial or natural resources. From your position of leadership, send out a subtle but firm message that you stand for the larger public interest. The claim that someone is wealthy because he works harder and is smarter is a false narrative. There is no justification for ostentatious living and profiteering."

From the workers' side too came a few replies and today, when the workers' efforts to get a better Constitution have been crowned with success, we reproduce from 'Advance' of 14 February 50 one of the greatest articles published in defence of the workers of Mauritius.

or some time now an intense and systematic propaganda is going on in the capitalist press against the new Constitution and against any progress towards the betterment of the working class generally. This propaganda takes all shapes, and it infiltrates even the ranks of the workers through people who are in the hands of those who are against any change in society. The whole movement is being directed from behind the scenes.

Where arguments are lacking, other methods are being adopted to bring down the prestige of those who are determined to see that justice is meted out to all alike. The capitalist press will go even to the extent of trying to hold the accredited leaders of the people to ridicule. This time the Mauricien and the Cernéen, the apostles of reaction and obscurantism, have begun their pilgrimage of hate together. Cerisier, writing in the Cernéen, says that "Mon cher confrère (of the Mauricien) a fait naitre brusquement en moi la vocation d'écrire" and he is "contraint de me soumettre à son impératif commandement". But to complete thispicture of the common consent and collusion, let us see further: "Par l'une de ses fantaisies dont la nature est coutumière, nos prénoms à tous deux fleurent la grand opéra, et que mon patronyme, comme le vôtre évoque un spécimen fructueux et sympathique du règne végétal".

After that the whole article is devoted to a wholesale attack against the awakening that is taking place among Indo-Mauritian workers. So we have it, you have given yourselves away Messrs Cherry Tree and Plum Tree, for your agreeing together and your similarity in outlook and make-up are not mere coincidences, but the inevitable alignment of the forces of reaction to delay the certain evolution of the workers. St Simon saw through it, and more practical men saw it after him and made it possible for history to be reversed in a manner that is not only distasteful to your class but also distressing to the big magnates who can no longer command the will of the needy.

Your "patronyme", Mr Cherry, "évoque un spécimen fructueux et sympathique du règne végétal". You are quite right. At times you can think clearly in your own way. You can smell the decay that is going on in you. The "grand opéra" is your scene of operation. For you and for those you are serving it is an opera; for the great mass exploited by your class it is an existence of drudgery, poverty and want and disease.

Your "prénoms fleurent le grand opéra". It is only natural. You belong to the same class, the class of minority which for the protection of its vested interests will mislead and misuse a brave people because they were not born of greedy silver spoons in their mouths. You have reason to congratulate yourself and sneer at our ragged fragments, for you have at least the advantage of wealth and power for the time being.

We know that your only interest in the underdog is how much you can get out of him, with the least necessary to keep him enchained in perpetual want. Our interest in him, to your great chagrin, is what we can do for him so that he may rehabilitate himself in society. You can see this cannot be a mere misunderstanding between us, as some would have us think. It is a guestion of ideologies. There is a vast gulf which separates us, a gulf in which thousands of our class have been drowned in their common struggle for economic and social uplift. Do you think you can bridge that, and teach us to accommodate ourselves with your ideas? No! A thousand times, no! You must realize once for all that only a radical readjustment of our social system will satisfy us. Your heartache is only beginning. Between you and the people there is a vast difference in outlook, just because the trends of events in the world and the conflicts of interests rule that the proletariat cannot accommodate itself with a society it is out to destroy, in order to build in its stead a world in which each will draw according to his need - not as in your scheme of things in which a few wallow in wealth and a large number of men and women is held in pawn.

You and your likes may be clever artificers, but we have seen through the game. You cannot sell us that puppy again. Your time is done. It is best that you leave it to the rising proletariat to clean the Augean stable you will surely leave behind you — your remnant of corruption, your social injustices, your inequalities, your nepotism and your grab and take practices. We want to build us a society which will not be your oyster. We want to renew humanity, and in this natural process your skeleton is required for the museum of the future, so that pos-

terity can realize what monsters you had been, and how stupid we had been to allow you to usurp our heritage for so long.

You may attempt to ridicule honest men like Dr Ramgoolam, and your hirelings and snivellers can pour out all the wrath on them, but all these crafty devices will no longer avail you against the tidal wave of workers' awakening which will swallow you. You may fling epithets at us that will do no credit to anyone — which is unchristian, and you are presumably a devotee of Christ, the redeemer of mankind, the Christ that your class crucified in its scramble for power, because He stood for equality among men.

You may stick any labels on us. Our class is humanity itself, and we would not have worried about them, had it not been for the unwary you may entrap like a vampire in your hypocritical embrace. What child does not know the story of Little Red Riding Hood and the bear which grew big teeth to eat her the better. Your stomach is bursting with iniquities, and your brain is getting delirious with what is coming to you.

You and your masters tried to annex this country to South Africa where they are gradually sending their money, because in that subhuman continent human lives have no value and the South African negroes are looked upon as mere toys. There they will also find a readier market for their depredations.

When the cat is out of the bag, you attempt to turn the table on Indo-Mauritians. You must be taking people for simpletons; you are, indeed, doing wishful thinking and provoking the proletariat to do things that you would have liked it to do, so as to harass it the better. We are not your men; you have a few from our side who are helping you to do that work, but even they, with your press behind them and with their exaggerations and vilifying tongues, are not in a position to deliver the goods. They have been found out. You are, therefore, in a sad plight and in your anger you must be careful not to cut off your nose just to spite your face, for without my class your masters will go bankrupt. My class is the backbone of everything in Society, and without it all your big monopolies and trusts and combines, with their tentacles and vast wealth would be reduced to naught.

Plums and Cherries may agree, but the fight goes on relentlessly and fated to end to your disadvantage. Just to remind you: plums and cherries are commodities that the proletariat can devour. As for the trees, you know the wood cutter and his glistening axe. We can leave them to him. So, you need not flatter and din your tympanic bellies. That is the sound of the dying man. But meanwhile you can sing the swan song of a dying epoch.

### **Inflation: Public Enemy Number 1**

Many households (for instance pensioners) who assumed that inflation would remain under control, are now faced with much higher expenses without a commensurate increase in income.

It is therefore important that central banks are constantly vigilant and respond to accelerating inflation. Inevitably, this implies setting interest rates at an appropriate real level above the rate of inflation.

The real rate of interest rates can be calculated in several ways. The simplest and easiest way to calculate is by deducting the rate of inflation from the nominal interest rate.

Some African countries suffer persistent inflation problems, with rates much higher than in developed economies. The Zimbabwean inflation rate for the year to April 2022 accelerated to 96.4%, while Ghana's inflation rate was 19.4% over the same period.

Countries suffering high inflation experience exchange rate pressure, with declining currency values. The exchange rate of the currency will remain under downward pressure as long as high inflation persists. Owing to high inflation, investment in the country becomes unattractive. The demand for the currency therefore declines, which puts the exchange rate of the country with high inflation under pressure.

The Ghanaian currency has already depreciated by 18% against the US dollar this year. A further value decline is expected for the rest of this year.

Over the past year, the



Zimbabwean RTGS dollar has lost more than half its value against the US dollar).

Owing to sharp currency depreciation, the domestic prices of imported goods and services in countries like Ghana and Zimbabwe have increased sharply and continue to increase each time the currency depreciates.

Consumers in those countries who earn income in local currency experience increasing difficulty to afford imported goods and services.

#### The trust deficit

A problem in an environment of sustained inflation is that people do not trust the official published rate of inflation. Inflation rates are distrusted for several reasons. The first is a general distrust of government conduct. This results in a view that inflation rates are manipulated by government agencies responsible for their publication to report lower price increases than is actually the case.

Secondly, increased prices for goods such as fuel that receive considerable publicity, lead to perceptions of general price increases. This problem is linked to the fact that price increases are much more visible to consumers and attract more attention than price declines.

Lastly, inflation measures price increases on a cumulative basis, using each previous year's price level as the base for calculations. This implies that each previous year's inflated price level is used to measure the rate of inflation in the next year. Over time the cumulative effect of sustained inflation becomes quite large.

This can be explained in a different way. With a sustained inflation rate constant at 5% per annum, the intuitive perception is that prices will double every 20 years. In practice, however, under these conditions, prices will double every 14.4 years. Price increases therefore exceed the perceptions of consumers.

Given the negative impact of inflation, it is in the interest of all consumers that the authorities should always apply policies that prevent price increases or keep such increases to a minimum level.

Inflation does not make people wealthy, despite the fact the governments and borrowers enjoy benefits from inflation. Which is why the description that inflation is public enemy number 1 is so accurate.

## What they teach you in Business School

In subsequent interactions with several directors and senior professors of leading management schools I have asked a simple question. "When a graduate engineer from our leading technology institutes like the IITs steps into the job market after four years she can, on an average, expect a pay package of around Rs 600,000 to Rs 1million, but after going through a two-year MBA program at an IIM the same youngster can command a package of up to Rs 5 million per annum or even more. My question is what do you teach them in two years that their market worth is multiplied fivefold and again why can't the BTech program be extended by a year and the MBA education be packed into all standard engineering curriculum?" I have never received a convincing response, frankly because there is none.

#### Anomaly in remuneration policy

In writing this article, my intent is not to demean the value of business schools, I only wish to highlight the huge anomaly in our remuneration policy which is destroying the real physical economy, where people work with hands and machines to produce tangible goods. If we divide all jobs into technical jobs and generalist jobs, the engineers, doctors, educationists, agriculturists, scientists, etc., would fall in the first category while managers and admi-

nistrators would come under the second. Professionals under the first category form the foundation of a developing economy. The second category is to service the activity of the first. There is no role, or need, for the service sector unless we have robust and dynamic physical economic activity in the country. Once we accept this, the remuneration systems strike you as blatantly upside-down. Better salaries in the services sector - banking, finance, IT, accounting, etc., - are absolutely contra-intuitive.

Unless we set this right, we will keep on seeing engineers and doctors doing MBA and joining the civil services or taking up managerial jobs in marketing, finance and HR, etc., in the corporate world. The service sector can continue to do what it does best, including its role in administration and coordination, but the nation should attract the best young talent to the core physical economic activity. The best students should find the motivation to study the sciences and maths and be placed at the top of the wages pyramid. Why are we not able to do this? We need to find an answer urgently.

### European outbreak of monkeypox: what you need to know

#### There are some concerns of human-to-human transmission.

Four new cases of monkeypox have been reported in the UK, bringing the total number of confirmed cases to seven. The UK Health Security Agency (UKHSA) is urgently looking for the source of the outbreak.

The first case in the current outbreak was confirmed on May 6. But this is not the first time monkeypox has been reported in the UK. Three cases were also reported in 2021 and one in 2018. However, these infections are rarely seen in the UK and are overwhelmingly linked to international travel from endemic areas, including parts of west and central Africa.

On May 18 five cases of monkeypox were reported in Portugal, with investigations into 20 further suspected cases. On the same day, the Spanish health authorities reported eight suspected cases in men who have sex with men.

This is the largest monkeypox outbreak ever seen in Europe. It is not known if the cases are linked.

#### Misnomer

Monkeypox, as the name suggests, was first found in laboratory monkeys in the late 1950s. However, scientists aren't sure if monkeys are the main animal

reservoirs (carriers of the virus), so the name may be a bit of a misnomer. The latest thinking is that the main reservoir is probably smaller animals, such as rodents.

Unlike COVID, monkeypox does not spread easily from human to human. It typically requires interaction with animals that carry the virus, or being in very close contact with infected people, or having contact with "fomites" (such as contaminated clothes, towels or furniture). Also unlike COVID, monkeypox is not known to spread asymptomatically. However, the evidence on monkeypox is thin, and the current outbreaks will provide new knowledge around its impact and transmission.

Monkeypox belongs to the same family of viruses as smallpox, but is less transmissible. People who catch it typically develop a fever and a distinctive rash and blisters. The disease is usually self-limi-ting, with symptoms disappearing after a few weeks. However, monkeypox can cause severe illness, with outbreaks typically showing a case-fatality rate (the proportion of people with the disease who die from it) of between 1% and 15%, with severe disease and death more likely among children.

#### **Sexually transmitted?**

The UKHSA says that some cases in the May 2022 outbreak cannot be explained by recent international travel, suggesting that there has probably been some "community transmission". Four of the seven cases are in people who identify as gay, bisexual or other men who have sex with men. A UKHSA epidemiologist tweeted that this is "highly suggestive of spread in sexual networks". The cases in Spain may also fall under similar consideration.

So the transmission here may be a little unusual compared with previous outbreaks. While there is a lot we don't know about monkeypox, we do know the virus



can be transmitted via close contact, for example, including prolonged skin-to-skin contact.

There is no evidence that it is a s exually transmitted infection in the manner of HIV or chlamydia. It's more that, in the UK outbreak, the close contact during sexual or intimate activity may have been a key factor during transmission.

This may be the first time transmission of monkeypox via sexual contact or intimate activity has been documented. But the implications are not so significant in that we know close contact is required for transmission. The social dynamics around the transmission of infectious diseases means this finding may be most useful for the public health teams involved in "contact tracing" — finding other people who may have been exposed to the virus.

#### Very low risks for the general public

The monkeypox risks to the wider UK public are extremely low, and the NHS has specialist units that focus on treating these sorts of tropical infections. And, thankfully, there are ways of bringing the virus to heel.

The US Centers for Disease Control

and Prevention highlights how the small-pox vaccine, cidofovir (an anti-viral drug), and vaccinia immune globulin can be used to control a monkeypox outbreak.

However, beyond the smallpox vaccine, there is no specific vaccine to protect against monkeypox. Some experts have suggested that stopping widespread vaccination against smallpox might have lowered population immunity against monkeypox, thus making cases and outbreaks more likely.

A 2019 meeting at Chatham House in London suggested that an unintended consequence of smallpox eradication could be that "emergent or re-emergent human monkeypox might fill the epidemiological niche vacated by smallpox".

However, these imported monkeypox cases and other tropical infections (such as Ebola, malaria and Lassa fever) indicate a wider burden of disease elsewhere in the world, typically in low-income countries with limited access to healthcare. It may be that in a post-pandemic environment, we should give more consideration to understanding the local and global implications of Lassa, monkeypox, Ebola and other rare but serious pathogens.

Listening to the PM in answer to a PQ in Parliament reeling out lengthy and detailed data and statistics about criminality, drug seizures and assets forfeited, all very useful, one cannot but wonder why for the sake of greater transparency, such information is not made periodically available as a matter of normal functioning on one or more appropriate government websites. For that matter why the independent regulatory authorities, even with restrictions where inquiries are ongoing, cannot provide every quarter or semester such information as normal practice? It would be mystifying in the 21st century if raw data and statistics of the type provided by the PM or other Ministers in Parliament could not be uploaded and updated regularly with the IT specialists at the disposal of authorities. Are there national security reasons that prevent greater transparency when all sectors of

the population are doing their best to survive or thrive. One can imagine the number of PQs that would be unrequited as a means of obtaining simple data and statistics pertaining to government action in most spheres.

On the same theme of greater transparency, it is understood that government through the state utility company CEB, may be reviewing shortly the terms, conditions and duration of contracts from IPP suppliers who have by now largely and handsomely amortized their investment costs to generate electricity since twenty years ago. We would not understand that contracts that were made public some years back by a previous government should be considered as confidential or too commercially sensitive for public disclosure. We trust this will not be the case and that public interest will prevail.

## What's the bottom line when it comes to weight loss?

Then it comes to weight loss, many of us have dabbled in the latest diets. But whether you're cutting carbs or keeping to keto, new research from the University of South Australia shows that diet trends can cost more than your waistline and leave a hefty hole in your hip pocket.

In a new study, UniSA researchers have evaluated the affordability of popular diets, comparing them to the recommendations within the Australian Guide to Health Eating (AGHE), and the Mediterranean Diet, finding that costs of cutting your calories can vary by up to \$300 per week.

The research shows that the most cost-effective diet was modelled from the AGHE and adapted for weight loss through calorie restriction. This meal plan included all five core food groups and a range of affordable staple



items such as breads, pasta, and legumes, as well as lower amounts of animal products.

The diet plans that were most expensive typically restricted multiple food groups and included premium products such as organic produce, protein supplements, low-carbohydrate replacements, and high protein bread.

Lead researcher Associate Prof Karen Murphy says understanding the costs of weight loss programs is important, especially when people are facing financial struggles and reduced access to fresh produce amid Covid-19 and current floods.

"In Australia, around 12.5 million adults are overweight or obese. In our research, we assessed the weekly costs of seven different meal plans and found that weekly grocery shopping of entire product units cost between \$345-\$625, which is substantially higher than more than what the average Australian spends on groceries each week.

"Understanding the costs behind the range of diets on offer is important as the financial feasibility of sticking to these programs may be questionable for certain people, including low-income earners.

"Additionally, there tends to be a misconception that consuming a healthy diet made up of the five key food groups, like the AGHE, is too expensive, which it's really not."

In addition to costs, UniSA PhD candidate, Ella Bracci, says nutrition is also key to starting a new diet. "It doesn't matter whether you chose keto or carb-free, weight loss is always linked to calorie intake -- if you reduce the number of calories you consume, you will lose weight," Bracci says.

Eating a healthy diet doesn't need to break the bank. "Shop for specials and mark-downs, buy in season or frozen, dried and canned produce, choose home-brand or non-premium products where possible, and buy in bulk where appropriate."

#### Mindfulness can get wandering thoughts back on track

Everyone has times where their mind won't stay on task. For example, you might be listening to someone talk in a meeting or class and your mind wanders to your dinner plans. Notably, research suggests that 30% to 50% of our daily thoughts are spent on this kind of mind wandering, and that excessive mind wandering can lead to many negative outcomes like poorer performance on standardized tests and poorer recall of information.

"While zoning out for a few minutes during a meeting may not hurt, it can impact you negatively if it goes on for long periods of time," says Lynley Turkelson, a University of Cincinnati doctoral student and lead author of a new study on mindfulness and mind wandering published in the 'Journal of Cognitive Enhancement'.

Methods of practicing mindfulness vary but include practices such as breath-work and meditation.

For example, Turkelson says, one can practice mindfulness by paying attention to the experience of eating a favourite food: "You may start by noticing the smell of the food before you eat it, what it feels like as you bite into it, how it feels in your mouth, and the taste. Or perhaps you pay attention to the flow of breath in and out of your lungs or on the sensations you experience in various parts of the body."

"During Covid, people are facing even more distractions than normal, so it is important to find research-based ways to decrease mind wandering and improve attention," says Turkelson.





#### Curious Why do we see the 'sky' during the day, but the galaxy at night?

The sky on other planets doesn't look the same as the sky on Earth does. And that's because of the different gases in Earth's atmosphere.

To put it simply, the reason the sky looks different to us between daytime and nighttime is mostly because of our atmosphere.

The atmosphere surrounds Earth, and extends from the ground to outer space. It's made of different gases including oxygen (which keeps us alive as we breathe it in), carbon dioxide (which we breathe out), methane (which is also in our farts), nitrogen and argon.

All these gases, as well as all solids and liquids, are made of molecules. Molecules are collections of atoms which are much too small for us to see, but are the basic building blocks of everything that exists. Importantly, different molecules have different combinations of atoms and come in different sizes.

A molecule's size plays a role in how the molecule interacts with light. Light from the Sun isn't one colour — it's made up of all the colours of the rainbow (which is why we see a rainbow when light behaves in a certain way).



Some of the molecules in Earth's atmosphere are just the right size that the blue part of the light from the Sun bounces off them, scattering in different directions.

So when we look towards the Sun during the day (remembering that you should never look directly at the Sun), we see rays of light that have come from the Sun straight down to us.

But when we look away from the Sun we see the blue light rays scattering from

the part of the atmosphere we are looking at. That's why the sky is so bright — and blue — during the day.

#### The galaxy at night

At night we see stars in a dark sky, and these stars make up our galaxy, the Milky Way. The Milky Way is made of a huge number of stars, including the Sun.

Compared with other stars, the Sun actually isn't that bright, but it looks very bright to us because it's much closer to Earth than other stars are.

At night, when your side of Earth is facing away from the Sun, the only light that reaches you is from other stars. This starlight also scatters off molecules in the atmosphere, but as there's less of it, not much scattering goes on.

This is why, at night when we're facing away from the Sun, we don't see the same thing as when we are facing the Sun during the day. Instead, we can look through the atmosphere and beyond at the big, dark expanse of space around us and the many, many faraway stars in our

galaxy.

#### The sky on other planets

Other planets in our Solar System have different molecules in their atmosphere compared with Earth, which means their skies look different during the day and night.

The atmosphere on Venus, for example, is so thick you would never see the Sun — not even during the day when you were facing towards it. The stars are not visible at night, either.

Astronauts who are above our atmosphere, such as on the International Space Station or on the Moon, don't see the bright blue sky we see on Earth. Instead, they see the Sun as a large nearby star against a black sky.

And they can see the galaxy all the time.




Thirsty, but now quite intrigued with the profoundness of this old lady, Kalidasa said, "I am a tolerant person, mother."



## **Surprising Uses for Everyday Household Products**

Sodium bicarbonate can absorb odours in your fridge or under your armpits. It's only mildly abrasive. That means it'll clean your dishes, tub, or teeth without scratching them. Mix with water and swish some around if you have morning sickness or throw up after cancer treatment. It can wash away stomach acid that might hurt your teeth. Here are more tips on how to use baking soda:

General cleaner. Add 4 tablespoons of baking soda to 1 quart of water, or sprinkle some on a wet sponge.

Mouth rinse. Mix 1 teaspoon of baking soda with 4 cups of water.

Ease itchiness from poison ivy or bug bites. Mix with water to make a paste and put it on your skin.

Deodorant. Pat some under your arm. For fresh laundry. Add a 1/2 cup of baking soda to the wash.

#### Vinegar and your body

Studies show 1-2 tablespoons of vinegar (white or apple cider) might help control your blood sugar after a meal. It can't fix an unhealthy diet or replace your medicine if you have type 2 diabetes, but it may ease symptoms. Don't drink large amounts because that might hurt your stomach. Talk to your doctor before you use vinegar on your head or body. It may soothe dandruff or itchiness from psoriasis, but it could also bother your scalp or skin.

#### Vinegar and your home

Use distilled white vinegar to clean glass or:

Kill food germs. Leave surface visibly wet for 10 minutes to kill salmonella. Vinegar isn't effective on most other viruses and bacteria.

Clean pet stains. Mix 1/2 cup vinegar with 1 quart of water. Dab the area and let sit for a few minutes. Test a small area first. Vinegar can fade colours.

Get rid of sweat stains. Spray the armpits or collars. Let soak for 24 hours in cold water before washing.

Clean your coffee pot. Use a 1:1 mix of vinegar and water, like 3 cups of water

and 3 cups of vinegar. Run through your pot like you would coffee.

Take away soap scum. Clean your shower head or curtain with full-strength white vinegar.

Get rid of odours. Place cups with 1-2 ounces of vinegar around your house.

#### **Petroleum Jelly**

This oily moisturizer can soothe dry skin, including your nails and cuticles. Put it on small cuts and scratches to help them heal faster. It also treats diaper rash and might ease symptoms of atopic dermatitis or psoriasis. There's some evidence that it works better than other home remedies to suffocate adult lice. But it won't kill their eggs. You'll need a special medicine to do that.

#### Bleach

Chlorine bleach -- the kind that's not safe for coloured clothes -- is a cheap and strong way to kill germs. It can tackle the bacteria that make your toilet bowl pink and the virus that causes Covid-19. To make your own solution, mix 4 teaspoons of bleach with 1 quart of room temperature water. Open windows and doors, and keep your eyes and skin covered. Wipe the surface and leave it visibly wet for at least 1 minute. Make a new batch every 24 hours. Always use bleach exactly as directed. Never mix it with another cleaning product. This can make toxic furnes.

#### Hydrogen peroxide

A few drops of hydrogen peroxide can soften earwax build-up. Rinse with half hydrogen peroxide and half water to kill the bacteria that cause gingivitis. Try not to swallow any. You'll probably be OK if it's just a little bit, but large amounts can hurt your stomach or make you throw up. Don't use it to clean wounds. It does kill bacteria, but it may worsen scarring or cause inflammation. Use soap and water instead.

#### Rubbing (isopropyl) alcohol

It can kill germs, but it evaporates really fast. The wetness needs to linger for at least 30 seconds to kill germs. That's why it's best to use rubbing alcohol on

#### Mayonnaise

Full-fat mayonnaise can get rid of cloudy water stains on your wood table. All you do is spread the mayo out and let it sit for several hours. Let it soak overnight for old stains. Cover it up if you think your pets will lick it. Do it again if you need to.

Some people use mayonnaise to kill head lice. But there's no evidence that this works.

#### Virgin coconut oil

It's a natural moisturizer. It's also antiinflammatory and antibacterial. Experts think that might be why it seems to ease certain skin conditions, like atopic dermatitis. Just don't slather it all over your face, especially if you have oily skin. It might clog your pores. There's some evidence that coconut oil can protect your hair from damage if you put it on before you shower. It's also a natural way to take off your eye makeup.

#### Olive oil

This kitchen staple might help a cut heal faster, but you probably don't want to use it as an all-over moisturizer. It's made mostly of oleic acid. Studies show that can break down certain layers of your skin.

#### Baby oil

It's best to use it on places like your legs, hands, and feet. It might clog your pores if you put it on your face. You can also use it to ease the dryness and itchiness that comes with dandruff or scalp eczema. Let the baby oil soak on your head for about an hour. Then run a comb through your hair before you wash it.

#### Ketchup

This popular condiment can also shine your silver. The secret is the acetic acid. That's another name for vinegar, which breaks down the chemicals that make silver look dull. Just put some ketchup in a dish and drop your silver in. Make sure it's fully covered. Let it sit for 5-10 minutes. Wash off the ketchup with warm water and dry with a cloth.

## What Ayurveda says about leaving hair oil overnight; is it healthy or harmful?

Oiling your hair has always been considered an important part of hair care routine and our mothers and grandmothers have always believed oil massages are the secret behind long and luscious hair. However, our elders remain divided on whether or not to leave oil in the hair overnight. The traditional wisdom of leaving hair oil overnight might be different from what Ayurveda

suggests. The ancient medicinal practice recommends washing your hair soon after oiling your hair, reports Parmita Uniyal of Hindustan Times.

Ayurveda expert Dr Rekha Radhamony says leaving hair oil overnight can aggravate Kapha and should be avoided. "One should not leave hair oil for more than 30 to 45 minutes, depending on your dosha imbalances. As soon as you finish oiling, you must take a head shower," suggests the Ayurveda expert.

Dr Radhamony says this piece of advice comes from Ayurveda practices of Kerala as it's the state that's closest to the ancient medicinal practice than others.

The Ayurveda expert says there are a lot of practices today that are termed as traditional but are more of "western-influenced wisdom". She gives an example of



teaming raw salads with lunch which was never a practice in India before the British rule. Ayurveda generally recommends warm and cooked food for all, especially those with weak Agni or digestive fire, and doesn't promote eating salad with food. According to Ayurveda, the best time to eat salads is noon and summer season, when the digestive fire is good.

### India takes over the Cannes Market

India is the country of honour at the Cannes Film Market and consequently a massive contingent from the country is descending upon the Croisette reports Naman Ramachandran and Patrick Frater of Variety.

That stands in contrast with the attendance from other parts of Asia, further East. Attendance of participants from Hong Kong and China is massively down compared with pre-Covid times. Korean companies are back in respectable numbers. The solid attendance of Korean executives also reflects the selection of Korean films across multiple sections of the festival.

The Covid era, however, has coincided with a more generalized slowdown of the Chinese film market and a politically directed retrenchment towards local content. That makes it difficult to quantify China's loss to Cannes.

But it is perhaps more than symbolic that Wednesday's Cannes Market opening party, is this year sponsored by India. China had been its sponsor for several years.

Anurag Thakur, India's Minister of Information and Broadcasting, will inaugurate the Indian Pavilion in the presence of actor R. Madhavan, whose directorial debut "Rocketry" is premiering at the market, and a plethora of



actors including Nawazuddin Siddiqui, Pooja Hegde, Tamannaah Bhatia and Aditi Rao Hydari. Akshay Kumar was due to be at the pavilion inauguration, but contracted Covid

India will be prominently visible throughout the festival this year. Deepika Padukone is on the jury for the main feature film competition. Oscar-winner A.R. Rahman's directorial debut, "Le Musk," is premiering at the market's Cannes XR program. Indian filmmaker Shaunak Sen's Sundance grand jury prize winning documentary "All That Breathes" is showing as a special screening. And Indian auteur Satyajit Ray's "The Adversary" (1970) and

Aravindan Govindan's "The Circus Tent" will be screened at the festival's Cannes Classics strand.

TV star Helly Shah will walk the red carpet for L'Oreal and also promote her film debut "Kaya Palat." Multihyphenate Kamal Haasan will be present to promote his new film "Vikram." There will be plenty of first looks unveiled, including for Shyam Benegal's "Mujib: The Making of a Nation," the biopic of late Bangladeshi leader Sheikh Mujibur Rahman, for which top Bangladeshi star Nusrat Imrose Tisha is expected alongside her filmmaker partner Mostofa Sarwar Farooki. Bangladeshi director/producer

Abu Shahed Emon is also due at Cannes. First looks are also being unveiled for Pushan Kripalani's "Goldfish" and Sandeep Singh's "Safed."

"When you are a country of honour at the world's largest film market you are on the radar of the Western world — it could be because of your creativity and international appeal, or maybe because of business potential and mass audience reach. We seem to be better-known for the latter," said Samir Sarkar, who is co-producing Cannes' La Fabrique project selection "Starfruits" via his Indo-Singaporean outfit Magic Hour Films.

'Every time, I'll be compared to you, and I don't want to be in that position'."



After suffocating heat up to 46° in New Delhi, which sent common folks gasping for breath, thick clouds threaten to break into torrential rainfalls and flood towns and villages. Tons of water unleashed angrily and spiralling out of control are a familiar sight to locals, a prelude to the monsoon season. No good news as well in the north of Pakistan where the heat skyrockets to 50°, and the land is predicted to be uninhabitable for human beings to survive in the decades ahead.

Figuratively, the old adage - it never rains, it pours - also means at this moment a deluge of sanctions falling on Russia. It leaves us wondering how many more sanctions the EU and the US have in store for Russia. Western countries never run short of ideas on how to isolate, weaken and finish off a country they perceive to be a threat to

their hegemony on the world stage.

#### Operation 2000. The Fall of Mariupol

Russia showers a string of bombings on the sprawling Azovstal factory complex where about 2000 Ukrainian soldiers are hiding away, many of whom are from the 'Nazi' Azov Battalion. The Ukrainian authorities and Western media have up to now lauded the bravery of the soldiers to resist to their last breath.

As I am writing these lines tonight, Tuesday 17th May, news of the surrender of the 2000 soldiers has been released. The identity of a first batch of 265 men is being checked. Contradictory information on the decision of the Kremlin is being issued. First, the safety of the soldiers is said to be guaranteed by President Putin. Then, Russian authorities are quoted as stating in blunt terms that Azov soldiers are "beasts disguised as humans", which seals their fate before any trial. At best, Ukraine will be relieved if there is an exchange of prisoners. A serious cause for concern is that the soldiers will apparently be taken to Russia for trial. Negotiations going on presently may determine whether the 'Nazi' battalion will be condemned to death or not.

Needless to add that journalists of mainstream Western media look disappointed at the fall of Mariupol into Russian hands. Western nations have

sent weapons, planes, drones, financial aid and men to Ukraine, and the forces have managed to sink two Russian warships. The surrender is therefore viewed as a defeat of the Western alliance with Ukraine against Russia though it is not going to be explicitly admitted in Western political and media sphere. For the past week Western media spokespersons have been hopefully anticipating a possible victory for Ukraine. With a sullen expression on their faces, they are lauding the humanism of President Zelensky for asking the army to surrender. The truth might be that the former comedian-turned-president is now feeling the heat from public opinion to put an end to the

What will Putin and his key aides decide? Since 2014, after the coup in Ukraine, 14,000 people were killed in the Russophone region of Donbas, 50 people were burnt alive, hospitals and schools were bombed, and one million refugees crossed over to Russia. Now among the Ukrainian soldiers who have surrendered, there are said to be American, British, and French soldiers. Negotiations are likely to be tough.

#### End of Special Military Operation and the Battle for Wheat?

On 14th March the Secretary General of the UN warned about the threat of a collapse of the world food system which will impact millions of people. Six million tons of wheat are blocked in the Ukrainian ports of Odessa and Mariupol as access to the Black Sea is under Russian control. Out of its 41.5 million hectares of agricultural lands, Ukraine has lost 30% of the surface area since the conflict. Eritrea, Somalia, Tanzania, Mauritania, and Turkey are 100% dependent on either Ukrainian or Russian wheat.

Russia was the world's top exporter of wheat in 2021, Ukraine ranked fifth. At an average price of \$255 a ton from Ukraine and Russia, the price of wheat has soared to \$400 in the US, and at a forbidding price of \$485 in France, which makes it hard for poorer nations to purchase from the two Western countries. Up to 90 million tons of wheat were consumed in India last year out of a total production of 109 million tons. While India has been the world's second-largest producer of the commodity, most of it is used domestically. Its share in the global wheat exports has been only around 1%. High internal demand for wheat prompted India to ban its wheat export; Slovakia did the same, and Indonesia banned palm oil exports. Countries are prioritizing national interests first. Hence the scramble for wheat worldwide.

Finally, it all depends on whether the "special military operation", as defined by Putin for Russia's military intervention in Ukraine, will stop or not. Russia seems willing to halt the operation and invites Europe not to head towards political suicide by boycotting Russian oil. It can be a face-saving exit for all stakeholders. Will Europe listen? France promises more weapons to Ukraine. Overzealous to please its American mentor? Or is the bell tolling for US hegemony?
