<u>Suren Dayal vs Pravind Jugnauth</u> Electoral Petition Dismissed

The Supreme Court has today delivered its judgement in the case lodged by unreturned candidate Suren Dayal at the last general elections in Constituency No. 8. The petition called for the invalidation of the election of the Prime Minister and leader of the MSM, Pravind Jugnauth, and his two running mates, the Deputy Prime Minister and Minister of Education, Leela Devi Dookun-Luchoomun and former Minister of Commerce Yogida Sawmynaden, in Quartier-Militaire/Moka.

Unlike other electoral petitions lodged by a number of unreturned candidates in different constituencies, which were grounded on objections relating to, amongst others, the "glaring and unexplained discrepancies in the Recapitulation of Votes form that are on record and point to prima facie to mistakes in the counting process", as noted by Justices Aruna Narain and Denis Mootoo in the case Adebiro O.J. v Collendavelloo I.L. & Ors, and the opacity surrounding the operation of Computer Rooms at Counting Centres, the main arguments put forward by Suren Dayal relate to alleged electoral bribery/corruption or the undue influence of electors in No 8.

The five main grounds of the petition against the election of the three candidates in Constituency No. 8 included the promise of a substantial upward revision of the retirement pension to Rs 9,000 in January 2020, contrary to what was stated in the 2019-2020 Budget Speech which referred an increase of Rs 500, the accelerated implementation of the Pay Research Bureau report in favour of public sector employees as from January 2020, the promise to pay more than Rs 3 billion to holders of the Super Cash Back Gold plan and those of Bramer Asset Management Ltd, the announcement of the payment of a performance bonus to police officers, fire-fighters and prison officers.

The petitioner also argued his case against what he considered to constitute the misuse of the state apparatus, more particularly of the Mauritius Broadcasting Corporation (MBC), which would have also contributed to unduly influence voters in general, including those in Constituency No. 8. Suren Dayal also took objection to the announcement made by Pravind Jugnauth at an official function organized on October 1, 2019 at the Swami Vivekananda International Convention Center, Pailles, on the occasion of the International Day for Older Persons, which had been broadcast live on television and taken up in the news bulletins of the MBC, relating to an increase in the old age pension from Rs 6,210 to Rs 13,500.

Our legal contributor Lex has clearly expounded on the attitude and approach of our Supreme Court towards electoral petitions as illustrated in recent judgements. The Supreme Court, he argued, will not easily and readily upset the results of an election, which are after all the will of the people. 'The Court will tread carefully and cautiously before upsetting the will of the electorate,' although it did previously invalidate the election of Ashock Jugnauth who was elected at the 2005 general elections (in the same constituency which elected Pravind Jugnauth, Leela Devi Dookun-Luchoomun and Yoqida Sawmynaden in 2019), following a case lodged by unreturned candidate Raj Ringadoo. Ashok Jugnauth was accused of electoral bribery in the form of a promised new Muslim cemetery and jobs to 101 healthcare assistants in exchange for votes in his favour. The Privy Council upheld the judgment. Furthermore, the election of Romriky Ramsamy who had defeated Gaetan Duval at the 1959 elections was invalidated on the ground that he did not inscribe his name properly on the Nomination Paper.

Not being in receipt at this point in time of the full text of the judgement from the two learned judges, we will abstain from further comments at this stage. However, our understanding of the ruling is that promises, however populist, made countrywide and any alleged and visible bias in national TV coverage, were not matters specific to one particular constituency and they accordingly dismissed the petitioner's claims. That reading, if correct, may be unsettling since it would confer for instance unlimited abuse of national airwaves or populist announcements in the final weeks of electoral hustlings without much recourse since our Representation of Peoples Act has a very narrow approach to breaches in electoral etiquette or procedures. Furthermore, a decision announced so late in the day, three years after the facts, may severely limit any effective recourse to the Law Lords, in so far as this might be entertained by the legal team of the petitioner. There is much the body politic should consider reviewing to make the laws and processes overseeing our democracy more effective and commensurate with better practices elsewhere in the Commonwealth.

When the IMF comes to town: why they visit and what to watch out for

The IMF sends its staff on two types of mission to member countries: to assess the state of the country's macro economy or to assess the need for financial support.

In most rich countries the news that a mission from the International Monetary Fund (IMF) is coming to visit is met with indifference. But, in most African countries the news can



cause great consternation.

Why the difference?

History has a lot to do with it. The citizens of many African countries have suffered through their governments, under IMF pressure, cutting subsidies and social spending, firing public sector workers and increasing taxes. For example, a 2021 Oxfam study, found that the IMF encouraged 33 African countries to adopt austerity policies in the wake of the COVID pandemic.

On the other hand, with a few exceptions, such as Greece, citizens of rich countries have not experienced the IMF having any direct impact on their lives.

Another important reason is lack of knowledge. Usually, when the IMF comes to town, the public gets little information about the purpose of the IMF's visit – or its likely outcomes. In other cases, people are concerned that they have limited ability to influence the outcome of the visit or its impact on their lives.

This article seeks to remove some of the mystery surrounding IMF visits to a country. It explains the two basic reasons for the IMF sending its staff on "missions" to a country. And what can be expected in each case.

The IMF's remit

According to its Articles of Agreement, the IMF's purposes include promoting monetary cooperation among its 190 member states so that they can more sustainably manage their macroeconomic situations and their international financial relations. This should help them promote and maintain high levels of employment and real income and develop their productive resources.

The IMF also provides financing to countries that do not have sufficient foreign exchange to meet all their needs and obligations so they do not have to resort to measures that are destructive of "national or international prosperity".

To fulfil these responsibilities, the IMF sends its staff on two basic types of missions to member countries.

Clarity In The Political Cauldron?

The political chessboard may become clearer this week as Pravind Jugnauth goes on a rally tour of rural constituencies starting this Friday in the northern segment. It may be revealing of the fortunes of the ruling regime that when long overdue municipal elections are expected this year, the MSM should be seen as shoring up its standing in the rural half of Mauritius.

Attendees will likely be bussed and treated with good fare and neither the crowd-pull nor their rumbustious cheers would be any gauge of popularity. What could be of potential interest is the PM's ability to get carried away and go off-script either veering into attacks of the Opposition and the media or step into more controversy with the national security issue of SAFE cable survey/sniffing allegations following the defection and allegations of his erstwhile confidante, Sherry Singh. Unwise commentary by the PM after some functions and some untutored ministerial live radio-web-TV commentaries have already fuelled the beginnings of a diplomatic and geopolitical row with India and China-Huawei, both understandably annoved at being thrust into the limelight over the local snafus.

Much of the attendance may not be worried by their leader's wrangling on the diplomatic front or by last year's White Paper proposal to control internet and social media traffic, perhaps not even miffed by the various PM versions of the SAFE cable network survey. We suspect that their essential worries are about unchecked supermarket prices, the continued devaluation of the rupee, the high taxes on fuel at gas station prices, the limited availability of foreign exchange or the worrying impact of drug abuse and violence even in village life and the absence of some pharmaceuticals from outlets.

While the authorities seem bent on their borrow, tax, and spend policies, relying on one-off fire-sales of public assets and the opening of the country to foreign property purchases may provide some artificial comfort to Minister Padayachy, but the international watchers (IMF, World Bank, Moody's) are not buying the Ministry of Finance's fuzzy public debt data, nor the

pitch that all is well. Even if there is some logic to steer the buzz away from the accumulating bad news, the PM's advisors would be well-advised to keep the PM on a more sober track, rather than opting for bush warfare and theatrics.

Traditional tripartite entente

Clarity also seems in the air regarding the Opposition forces and, as some might have expected and in response to demand from a wide section of the population, there is a pressure felt by the "traditional" political parties to unite their forces at least for the upcoming municipals against a ruling regime that has a reported massive war chest and considerable levers of office at its disposal. The LP. PMSD and MMM. after the Entente de l'Espoir's manifest inability to establish itself as a workable political formula, have decided to set aside their differences, egos, and ambitions for a return to a more feasible traditional tripartite entente between Opposition parties. This leaves Roshi Bhadain to follow the mandate of its recent Reform Party assembly and Nando Bodha to chalk out his role after talks with the PMSD and MMM.

The impression that there were too many aspiring PMs in the Opposition's bandwagon will also have been dispelled this week. The agreement confirms a tri-

The LP is reckoned to have the loyalty of a significant proportion of both the urban or rural population, many of whom have been deeply aggrieved by the vendetta politics practised since 2015. They are enough to constitute the driving force of any Opposition alliance as most observers have acknowledged, but whether such an electoral pact passes muster and gets traction in the electorate will depend on several factors. The first concerns probably the reaction and stance of non-parliamentary Opposition voices and parties, as they figure out whether their primary objective is to rid the country of the current ruling dispensation or take the risk of furthering a divisive confetti that can only suit the MSM hopes. Some, like Resistans ek Alternativ, have more of a specific agenda of electoral reform and might seek answers that have been largely ignored since 2015. The Reform Party, the sputtering Linion Pep Mauricien or Bruno Laurette, as other NGOs and erstwhile newby forces, will have to sort out their political priorities over the coming weeks and months.

But if the more traditional LP-PMSD-MMM pact has thrashed and sorted out the more thorny leadership, personnel and party roles that hover above alliances, all is not cut and dry. There is such disenchantment among the majority of the population that the combined Opposition leaders' energies, beyond each party's announced agenda, should turn to the formulation of a credible framework of economic, social, development policies and the sterling management principles covering the immediate, short-term future as much as the longer-term.

In the difficult straits facing the country and its population, nobody perhaps expects a program to "make us dream". However, the status quo, the gallivanting wastes, the structural independence and credibility of key institutions, the curbing of lavish lifestyles, the impunity of corruption, the unalloyed nepotism of appointees, courtiers and intrigants, the sale of the countryside to foreigners, the borrow and spend policies that will be paid for by our children and grandchildren, simply cannot go on.

Many therefore are the institutional reforms needed to buck the trends and restore the sense of belonging and pride in our flag and confidence of our youth in a future that embraces rather than divides recklessly. That backbone program needs not be a daunting task and can be completed even before the announced LP Congress of this month end.

How the electoral pact rolls out and projects itself from there on to the necessary grassroots mobilisation will provide indication if the Opposition has a concrete alternative and hope to offer the population and the country.

ex is invited to share his legal insight into various matters related to the holding of general or local municipal elections. Namely the unfettered powers granted to the PM under the Westminster system for fixing the date of general elections at the time of his chosing within the five-year mandate and whether this should be checked. * On 7 May 2021 Cabinet took the decision to introduce the Local Government (Amendment) Bill into the National Assembly with a view to extending "the life of 6 years of the entire Municipal City Council and Municipal Town Councils, or entire Village Councils, by not more than one year at a time, provided that the life of the Councils shall not be extended for more than 2 years". Would it be correct to conclude that the government would be bound, on the basis of that amendment, to hold the next municipal councils elections, last held in 2015, this year?

It would be possible to extend the life of a municipal council indefinitely under the Local Government Act. When the law was amended in June 2021, the object of the Local Government (Amendment) Bill read as follows: 'The object of this Bill is to amend the Local Government Act so as to provide that, at any time, when - (a) a period of public emergency is in force in Mauritius; and (b) there is, or there is likely to be, an epidemic of a communicable disease in Mauritius and a quarantine period is in force in Mauritius, the President, acting in accordance with the advice of the Prime Minister, shall, by Proclamation, extend, during such periods, from time to

time the life of 6 years of the entire Municipal City Council and Municipal Town Councils, or entire Village Councils, by not more than one year at a time, provided that the life of the Councils shall not be extended for more than 2 years.'

It will be noticed that the justification for the extension of the life of municipal and village councils was a public emergency or an epidemic. Even if there may not be an epidemic, the government might still fall back on public emergency situations to extend the life of these councils again. Any event can be invoked as a public emergency. * What if the government were to seek to circumvent that legal obligation with a view to extending further the life of the municipal councils? Can it possibly do that and, if so, is there any way this could be prevented?

Not really. The Local Government Act can be amended by a simple majority and does not require a weighted majority of three quarters or two thirds of the votes in Parliament. Those who want to challenge any further amendment may invoke the anti-democratic nature of any further amendment. However, this would be very difficult to establish.

* In South Africa efforts were under way to postpone local government elections, set for October 2021 as per the current constitutional requirement that such elections be held every five years, because of the Covid-19 pandemic. But the application by the South African Electoral Commission for postponement was dismissed by the Constitutional Court, which ordered that the polls must go ahead. What lessons should we draw from South Africa in that regard?

* Even if one of the defining characteristics of a democracy is that it holds regular, periodic elections - a requirement enshrined into Article 21(3) of the Universal Declaration of Human Rights (UN General Assembly 1948) -, between February 21 and August 18, 2020, elections in at least 70 countries and territories across the globe had been postponed. Yet during the same time period, plans for national or subnational elections in at least 54 countries continued (International IDEA 2020a). Would you say therefore that once an election has been scheduled, it should take place come what may?

That should be the rule. Elections can only be postponed in exceptional circumstances. Only extreme situations can give rise to exceptional circumstances. Now that restrictions have been lifted and the wearing of masks is not compulsory what would prevent the government from holding the local elections? The fear of a massive defeat looming ahead? There is no other justification.

* The constitutional amendments of 1982 have made the holding of general elections every five years obligatory. There is no such obligation as regards municipal and village councils elections. What would explain that omission by the then MMM-PSM government?

From its creation the MMM led by Sir Anerood Jugnauth led a ferocious campaign against the postponement of general elections that were due in 1972 to another additional five years. The MMM argued that this was unconstitutional though the vote was a weighted one of three quarters. A challenge was made in the Supreme Court in 1983 and the Court held as long as the amendment to the Constitution was done according to the procedure laid down in the Constitution for amending any of its provisions, the amendment to postpone the general elections was legal. The Court did not venture to make any pronouncement on the political aspect of the amendment.

One of the main reasons why many students would choose the UK prime ministership is because he holds the prerogative for the timing of elections. It might not be democratic strictly speaking, but this is how it works. It is a powerful political weapon in the hands of a Prime Minister in the Westminster system. In the US, an election for President of the United States happens every four years on the first Tuesday after the first Monday in November, and the President can serve only two terms. There is no such restriction on the number of terms a British Prime Minister can serve.

Given this power of the Prime Minister in the Westminster model, who would want to give it up?

The Sachs Commission proposed the following: 'We feel that in order to provide a level playing field to all the political parties it should be the Electoral Supervisory

Commission in consultation with the Electoral Commissioner which should be in a position to activate the electoral machinery for the holding of general elections or by-elections. The date of the elections should therefore be fixed by the Electoral Supervisory Commission in consultation with the Electoral Commissioner. No other authority should have a role in this regard.'

especially following the last general elections?

* The UK parliament has paved the way for fixed terms with the introduction of the Fixed Term Parliament (FTP) Act 2011, which introduces the element of certainty in the electoral process, and it's Parliament, not the Prime minister, that may call for an early election on the strength of a two-third majority vote. Furthermore the Electoral Commission has been empowered to start monitoring electoral expenses of political parties and candidates as from the 55th month from the date the last general elections. What's your take on that?

The amendment restricts the power of the Prime Minister to call an election before the expiry of the life of Parliament. But if the Prime Minister has the required majority he can still go for an early election and there is no doubt that the Opposition would vote for such a law.

* In France, where there is some form of state refund of electoral campaigns, there is a credible mechanism to vet those declared expenses before any refund is entertained. Victoria Hospital: 100 years



While a centenary is no doubt cause for celebration, one may ponder, or wonder, whether the expansion of hospital services is a marker of good health or rather one indicating that we are in fact a sick population!

Provide the set of the value of the Victoria Hospital (VH), which was opened on July 6, 1922, converted from army barracks. At that time, it was the largest and most modern hospital in the country that could accommodate about 240 patients, who came from both Plaines Wilhems and Black River districts. Dr Lucien de Chazal, MD London was the Medical Superintendent and Dr P. de Chaumont the resident medical officer. VH had medical, surgical and obstetric wards, and later ENT and eye patients were also treated.

It has now come a long way indeed, the bed capacity being now 956, and the range of services offered has expanded to respond to the changing disease profile that has been taking place since the early 1980s. One of the first specialist services that was established in the country was Orthopaedics, with the inauguration of the Princess Margaret Orthopaedic Centre, better known as PMOC, in 1956, in the same compound as VH. Princess Margaret of the British Royal Family came over to do the inauguration.

When I was growing up in the 1950s, hardly anyone used the name Victoria Hospital: it was more commonly referred to as 'L'Hopital Candos' where it was situated, and interestingly, these three appellations - PMOC, L'Hopital Victoria and L'Hopital Candos – are still used interchangeably. People don't really make the distinction that PMOC is meant for treatment of orthopaedic problems, but that is not of material consequence as far as the patient is concerned.

Yesterday's celebration programme comprised a video clip of the hospital with some pictures of the historical buildings as well as visuals of the latest modern



services and equipments available, official discourses on the part of the Prime Minister and the Minister of Heath & Wellness, launching of a souvenir e-magazine, and award of shields to former medical and nursing staff of the hospital for their long and dedicated years of service there.

Further, there was also the presentation of the latest Report on the Survey of NCDs (2021). As for previous ones, this one too is the result of painstaking and meticulous collection and analysis of data by the collaboration of the local team and our valued overseas partners since long, under the ever-generous guidance and support of Prof Paul Zimmet who has been at the origin of all the projects and programmes that are being run today as regards the noncommunicable diseases.

This latest Report has shown some favourable trends compared to the previous one of five years ago, namely encouraging decreases or stabilization in the prevalence of these diseases, reductions in alcohol and tobacco consumption amongst others. While this is no doubt a good sign, the fact remains, however, that increasing numbers of patients are requiring treatment for complications of these diseases affecting the heart, the kidneys - 210,000 annually now being the number of dialyses being carried out – the eyes, the limbs, in fact all the organs systems of the body, so that the health budget keeps increasing.

While a centenary is no doubt cause for celebration, even that of a hospital, one may ponder, or wonder, whether the expansion of hospital services is a marker of good health or rather one indicating that we are in fact a sick population! However, this is another level of debate that I would prefer not to engage in here.

> But one thing that certainly needs to be pointed out is that in the midst of all these hifi developments, the one vital ingredient that we must never forget is the human touch which all patients crave for. We may have a lot of hardware that facilitates diagnosis and treatment, for which the hardware uses physical software i.e., the operating systems, but all of us health professionals often forget that other software that only human beings can provide – communication and attitude.

Instead of calling upon lay customer care professionals or communication specialists to lecture young doctors about how to engage with their patients, this is something that can only and genuinely be learnt through apprenticeship with senior doctors. This responsibility falls squarely upon their shoulders and it is one they should gladly assume if they truly care for the image of the medical and health professions in general. I must concede that this is not always the case, which is all the more reason for us to emphasise its importance.

The starting premise for this is that we should not look upon the patient as a faulty machine that needs fixing up, but as a human being who needs not only our technical expertise but also our care and benevolence. In other words, we must change from thinking that we are treating a disease in a patient to the more humane one of considering that we are facing a patient with a

disease. This is a paradigm shift in the sense that it forces us to take into account all the other determinants of health that come into play, family, social, economic, cultural factors that we need to factor so as to not only tackle the disease but also comfort the patient and family.


In the days of yore, this was a mainstay of medical practice, since there were not effective treatments for many diseases, and disease mortality was high. Perhaps it is such circumstances that led the famous 18th century surgeon Ambroise Pare to come up with the saying the role of the doctor is: *guerir parfois, soulager souvent, consoler toujours.* However technologically advanced medicine may become, this truism will be ever relevant.

66We should not look upon the patient as a faulty machine that needs fixing up, but as a human being who needs not only our technical expertise but also our care and benevolence. In other words, we must change from thinking that we are treating a disease in a patient to the more humane one of considering that we are facing a patient with a disease. This is a paradigm shift in the sense that it forces us to take into account all the other determinants of health that come into play, family, social, economic, cultural factors that we need to factor..."

If only for this reason, that is why it is important for all of us, and doctors in particular, to know about the history of medicine. I have tried to cover this dimension for Victoria Hospital in an article I have written for the souvenir e-magazine.

However, it is only professional historians who can give a more comprehensive narrative about the evolution of the medical and health services in the country, as they have the methodology to research sources and materials and wrap up their findings in a more coherent manner. I think it is vitally important not only for health professionals but also for the population to be aware of the major historical landmarks in the development of our health system.

I sincerely believe that it would be well worth it for the MOH to contract out the writing of our medical history to historians who may be interested in particular aspects, such as the history of infectious disease in the pre-mentioned book. But it also behoves individual doctors to take the pain to delve into the past of their own specialties and areas of interest and share this with the medical community and the population at large.

In major policy shift, China says it will take Taiwan by force if necessary

hina on Wednesday, in only its third white paper on Taiwan since 1993 and the first after President Xi Jinping came to power in 2012, said it will not "renounce" the use of military force to bring the self-governed island under its control as its armed forces concluded the largest ever exercises around the island but announced that it will conduct regular patrols in the region.

The military exercise announced last week in response to US House Speaker Nancy Pelosi's Taiwan visit - which extended beyond the initial four-day schedule - ended on Wednesday, said the People's Liberation Army's (PLA).

The eastern command said: "Theatre forces will keep an eye on the changes in the situation in the Taiwan Strait, continue to carry out training and preparation for combat, organise regular combat readiness patrols in the direction of the Taiwan Strait, and resolutely defend national sovereignty and territorial integrity."

China's decision to conduct "regular patrols" in the region means it is in no mood to relent from its posturing against Taiwan, a self-ruled democracy which

Beijing claims as a renegade region, reports Hindustan Times.

For nearly a week, the PLA fired missiles over the island, while its fighter jets and warships entered into Taiwan's air and water space with impunity, crossing the notional median line on the Taiwan Strait.

Chinese state media said the unprecedented military drills were a practice for the final "reunification" of Taiwan and a blueprint to blockade it.

Against the backdrop of rising tension in the region, the Chinese government's latest policy paper on Taiwan released on Wednesday reiterated Beijing's tough stance even as it talked about peace.

The previous editions of the documents were 'The Taiwan Question and Reunification of China' (1993) and 'The One-China Principle and the Taiwan Question' (2000), a state media report said.

China will seek "peaceful reunification," but "will not renounce the use of force, and we reserve the option of taking all necessary measures," said the white paper titled 'The Taiwan Question and China's Reunification in the New Era'. It was released by the Taiwan affairs office of the state council (China's Cabinet) and its information department.

Without naming the US, the white paper criticised "external forces" for instigating provocative action in the region.

A Reuters report pointed out that in the latest document China had withdrawn an assurance not to send troops or administrators to Taiwan after taking it back unlike in the past two documents (1993 and 2000), "...signalling a decision by President Xi Jinping to grant less autonomy than previously suggested".

Russia launches Iranian satellite amid Ukraine war concerns

n Iranian satellite launched by Russia Ablasted off from Kazakhstan Tuesday and reached orbit amid controversy that Moscow might use it to boost its surveillance of military targets in Ukraine.

As Russia's international isolation grows following Western sanctions over its invasion of Ukraine, the Kremlin is seeking to pivot towards the Middle East, Asia and Africa and find new clients for its embattled space programme, reports AFP

Speaking at the Moscow-controlled Baikonur Cosmodrome in the Kazakh steppe, Russian space chief Yury Borisov hailed "an important milestone in RussianIranian bilateral cooperation, opening the way to the implementation of new and even larger projects".

Iran, which has maintained ties with Moscow and refrained from criticism of the Ukraine invasion, has sought to deflect suspicions that Moscow could use Khayyam to spy on Ukraine

Responding to the launch, Washington said Russia's growing cooperation with Iran should be viewed as a "profound threat".

Last week, The Washington Post quoted anonymous Western intelligence officials as saving that Russia "plans to use the satellite for several months or longer" to assist its war efforts before allowing Iran to take control.

Less than two hours after the satellite was launched on a Soyuz-2.1b rocket, the Iran Space Agency (ISA) said "ground stations of the Iran Space Agency" had already received "first telemetric data".

The space agency stressed on Sunday that the Islamic republic would control the satellite "from day one" in an apparent reaction to the Post's report.

The purpose of Khayyam is to "monitor the country's borders", enhance agricultural productivity and monitor water resources and natural disasters, according to the space agency.

Joe Biden formalises US support for Finland, Sweden joining Nato

Dresident Joe Biden formally welcomed Finland and Sweden joining the Nato alliance Tuesday as he signed the instruments of ratification that delivered the US's formal backing of the Nordic nations entering the mutual defense pact, part of a reshaping of the European security posture after Russia's invasion of Ukraine.

The US became the 23rd ally to approve Nato membership for the two countries. Biden said he spoke with the heads of both nations before signing the ratification and urged the remaining Nato members to finish their own ratification process "as quickly as possible."

The countries sought out Nato membership earlier this year to guarantee their security in the wake of Russia's offensive in Ukraine. The North Atlantic Treaty Organization's rules require the consent of all of its 30 existing members before Finland and Sweden can officially accede

into the alliance, which is expected in the coming months.

The candidacies of the two prosperous Northern European nations have won ratification from more than half of the Nato member nations in the roughly three months since the two applied. It marks one of the speediest expansions of the pact of mutual defense among the United States and democratic allies in Europe in its 73-year history.

Sweden and Finland applied to join Nato in May, setting aside their longstanding stance of military nonalignment. It was a major shift of security arrangements for the two countries. Biden encouraged their joining and welcomed the two countries' government heads to the White House in May, standing side by side with them in a display of US backing.

77 years for atomic bombing -- Nagasaki marks anniversary

Nagasaki paid tribute to the victims of the US atomic bombing 77 years ago on Aug 9, with the mayor TomihisaTaue saying, in his speech Tuesday at the Nagasaki Peace Park, Russia's war on Ukraine showed the world that another nuclear attack is not just a worry but "a tangible and present crisis", reports PTI.

The United States dropped the world's first atomic bomb on Hiroshima on Aug 6, 1945, destroying the city and killing 140,000 people. It dropped a second bomb three days later on Nagasaki, killing another 70,000. Japan surrendered on Aug. 15, ending World War II and Japan's nearly half-century of aggression in Asia.

Participants, including diplomats from nuclear states, observed a moment of silence at 11:02 am, the moment



the bomb exploded above the southern Japanese city on Aug. 9, 1945.

Although Russia last week tried to roll back on Putin's warning, fears of a third atomic bombing have grown amid Russia's threats of nuclear attack since its war on

Ukraine began in February. Russia last week shelled a Ukrainian city close to Europe's largest nuclear plant.

Japanese officials worry that the conflict may embolden China to be even more assertive in East Asia, and the government is pushing to further step up its military capability and spending.

Japan renounces its own possession, production or hosting of nuclear weapons, but as a US ally Japan hosts 50,000 American troops and is protected by the US nuclear umbrella. Still, Russia's nuclear threat has prompted some hawkish lawmakers in the governing party have also proposed a possibility of nuclear sharing with the United States.

Prime Minister Fumio Kishida said, "Even though we face a severe security environment, we must pursue the history of non-nuclear use and make Nagasaki the last place of nuclear attack."

Many survivors of the bombings have lasting injuries and illnesses resulting from the explosions and radiation exposure and have faced discrimination in Japan.

'Extreme heat' warning begins in UK even as France battles 'devastating wildfire'

A four-day "extreme heat" warning came into force across England, Wales, and parts of Northern Ireland and Scotland on Thursday as temperatures are expected to breach 35 degree Celsius. The heatwave is likely to affect water supplies and transport services, the weather office said.

The Met office sounded its 'amber' warning, the second-highest alert after red, and cautioned people vulnerable to the extreme heat of "sunny and hot or very hot" weather that could lead to adverse health effects. The amber warning follows Britain's first-ever red "extreme heat" warning in July, following months of minimal rainfall, reports Hindustan Times.

Photos of a parched River Thames were shared online amid the scorching heat over the past few days. Fears are that an official drought will soon be declared. "It's completely dried up," said an IT worker from northern England, who was on holiday in the area and planned to walk the Thames Path with his wife.

Even England's famously lush countryside went from shades of green to yellow. "It was like walking across the savannah in Africa because it's so arid and so dry," a 60-year-old retiree told news agency AFP.

England's heatwave warning comes amid a devastating wildfire in southern France. More than 1000 firefighters and a water-bombing aircraft battled a "monster" wildfire near the wine-growing heartland of Bordeaux for a third day, with no relief from the blistering temperatures, forcing thousands of people to flee from their homes.

The fires have reportedly destroyed



more than a dozen properties and b scorched more than 6800 hectares of forest. "It's a disaster, economically, ecologically, it's awful," Jean-Louis Dartiailh, the mayor of Hostens, a small town close to the fire, told Radio Classique, as quoted 4

by Reuters. "The area istotallydisfigured. We'reheartbroken, we'reexhausted."

Other European nations have also faced a scorching heatwave in recent weeks with temperatures often exceeding 40 degrees.

Did Trump break the law? FBI search raises fresh questions

The year was 2016, the presidential candidate under investigation was Hillary Clinton and the FBI director at the time, James Comey, laid out the factors the Justice Department weighs in deciding whether to charge someone with mishandling classified records.

Fast forward to 2022 and that tutorial proves instructive as another candidate from that election, Donald Trump, is entangled in an FBI probe relat-

ed to sensitive government documents, reports AP.

Whether an FBI search of Trump's Mar-a-Lago residence is a prelude to criminal charges is unknown. The action Monday nonetheless focuses attention on the thicket of statutes that govern the handling of government records, though the department's own history of prosecutorial discretion — some high-profile investigations have ended without charges or in misde-

happen this time. Much remains uncertain about Monday's search, including precisely what documents the FBI was looking for — Trump says agents opened a safe — or why it acted when it did. But people familiar with the matter say it relates to an ongoing Justice Department investigation into the discovery of classified material in boxes of White House records the National Archives and Records Administration recovered from Mar-A-Lago earlier this year.

To obtain a search warrant, the Justice Department would have had to persuade a judge that probable cause existed that a crime was committed, though what statute officials think may have been violated is unclear.

Multiple federal laws require the safekeeping of government secrets. One potentially relevant

statute makes it a crime to remove classified information and retain it an unauthorized location. Another makes it illegal to mishandle national defense information, including maps, photographs and documents, or transmit it to a person not authorized to receive it.

But if past is any precedent, the mere mishandling of classified information isn't always enough for a felony conviction — or any charges at all.





Is race an issue for Rishi Sunak?

No one says 'yes, ethnicity is an issue for me' when pollsters ask but Conservative party members do show an above average opposition to diversity drives

YouGov poll of party | members completed on August 2 shows Rishi Sunak to be trailing Liz Truss 31% to 69% in the Conservative leadership contest. A similar poll completed on July 21 had him on 38% to her 62%. She appears to be winning the contest hands down.

This is surprising given that Sunak was a very popular chancellor at the time

of the Covid lockdown, in large part due to his generosity in supporting workers with the furlough scheme. But the survey shows that the members prefer Truss to him by large margins on the key policy issues such as the cost of living, the NHS, asylum seekers, housing and defence.

In addition, they think she is more likely to deliver a Conservative victory in the next election - although many are pessimistic about whether this can be achieved. This raises the interesting question: why he is doing so badly among the party members?

One reason is the "stab-in-the-back" narrative - the idea that Sunak was disloyal to his boss by resigning as chancellor. This set off an avalanche of departures from the government that brought prime minister Boris Johnson down. Altogether 51% of respondents to the survey thought it was wrong for him to resign and only 40% thought this was the right thing to do. In addition, only 27% of members thought he was "trustworthy", compared with 60% who thought the same thing about Truss. It looks like his early resignation damaged him a lot in the leadership race.

But there is another factor which has not been discussed at all. This is the possibility that some Conservative party members are prejudiced against him because he comes from an ethnic minority background. In a country striving for greater equality, this is not a question that should be avoided. Indeed, were this a general election, some discussion of this would surely be happening. Inequality cannot be addressed without evidence and honesty - a fact that is accepted by businesses, government organisations and indeed parliamentary parties.

When David Cameron was party leader, he promoted the cause of inclusion in the parliamentary party for ethnic minorities. He made key appointments to his cabinet that could be seen as shifting the dial. So the Conservative parliamentary party cannot be accused of ignoring this issue. But the same may not be true of the party members. Is prejudice among the members a fact that dare not speak its name?

If prime ministers are to be selected via party elections, this is an issue that must be at least considered

because it is seen as socially undesirable. They are highly unlikely to say outright that they don't want a leader from an ethnic minority. And indeed, many will proudly state that it isn't an issue when asked. There are some methodological techniques for finding out how people really feel, such as list experiments, in which some people are asked to give their view on a sensitive issue and others are not. More generally, we have to find these things out using indirect methods rather than direct questions.

When it comes to the party membership election specifically, pollsters face another problem: it's tricky to harvest a representative


sample since they only make up a relatively small percentage of the population. National polls of the electorate typically involve about 1,000 to 1,500 respondents and so there are too few party members in these surveys to do any analysis. YouGov solves this problem by drawing on its very large panel of potential respondents who are paid to take surveys, and this allows them to identify a reasonably sized sample of Conservative party members.

What the data does tell us

We can, however, get around both problems with the help of a very large online survey conducted by the British Election Study just prior to the 2019 general election. This survey had more than 34,000 respondents and included just over 2500 members from the major parties. It also asked some indirect questions which help us to identify prejudice against ethnic minorities.

One question asked respondents if they thought that policies aimed at giving ethnic minorities equal opportunities in society had "gone too far" or had not "gone far enough".







About 10% of non-Conservative voters thought these policies had "gone much too far" - roughly the same as Conservative voters at 11%. In contrast some 14% of Conservative party members thought this, a statistically significant difference from the voters. At the "not gone nearly far enough" end of the scale these differences were even more marked. Only 1% of Conservative party members and 2% of Conservative voters thought this, compared with 7% of other party voters.

These differences were replicated in the "not gone far enough" and "gone too far" categories as well. Conservative party members are consistently more opposed to the levelling up of ethnic minorities compared with voters in general, including Conservative voters.

A second indirect question asked about opposition to further immigration into Britain. Responses showed that 19% of non-Conservative voters were strongly opposed to this, compared with 38% of Conservative voters and 45% of Conservative party members.

It looks like some Tory grassroots members hold views that would imply they do not want an ethnic minority politician as their prime minister. Knowing this with certainty is always a problem but if results of this kind were thrown up in another context - such as in a parliamentary party - they would be recognised as warranting deeper thought and investigation. As things stand, this probably contributes to Sunak's poor performance among the party members who are after all choosing the next prime minister. This issue does not appear to be attracting nearly enough attention.



• Cont. from page 2 Surveillance missions

The first are surveillance missions. Article IV says that the IMF should exercise "firm surveillance" over the efforts of its member states to try and direct their economic and financial policies towards the objective of fostering orderly economic growth with reasonable price stability.

Thus, the IMF regularly – usually annually – sends a staff team to assess the state of each country's macro economy, the risks it faces and its capacity to continue evolving in a sustainable way. This team usually meets with officials in each country's ministry of finance and central bank. In addition, they can ask to meet other government officials. For example, during COVID, the IMF might have been interested in meeting with health department officials.

The IMF staff will also normally meet with members of parliament and with representatives of business and labour. They may also meet with representatives of civil society.

There are four important points to note about these missions.

First, while the IMF provides some guidance to its staff, it does not require them to follow any particular procedures for informing interested parties that it is visiting the country. The result is that it's difficult for anybody interested in the visit to learn how they might engage with the mission or provide it with information.

Second, in principle, there is no limit on what issues the

When the IMF comes to town: why they visit and what to watch out for

IMF can focus on during its mission. Consequently, IMF staff can raise any issue and request whatever information they think is relevant to assessing the state of the country's macroeconomic situation. This has led to a gradual expansion in the range of issues the IMF may raise in these missions. They now range from fiscal policy, inflation and unemployment rates, and balance of payments deficits to issues about how the country is dealing with climate change, gender discrimination, public health and wealth inequality.

Third, the outcome of the mission is a report prepared by the staff that is discussed by the IMF's Board of Executive Directors. The report is usually made public after the discussion, together with a press release.

The IMF also uses the information in preparing its reports on the global economy.

Fourth, the IMF can make recommendations to the government on actions that it should take to deal with any challenges that have been identified.

These recommendations are purely advisory. In principle, the country is free to ignore them. This may be the case if the country is confident that it will not need IMF financing in the future. This is the reason that the citizens of rich countries do not usually care that an IMF mission is visiting their countries. However, this is a luxury that a country cannot afford if it thinks it may need IMF financial support. Or that its access to international financial markets may be influenced by the IMF's view. This, of course, is the case for most African countries.

Financing missions

The second type of mission is initiated by requests for IMF financing.

Their purpose is to assess the country's need for financial support. And to negotiate the terms on which it will be provided. The IMF effectively acts as a lender of last resort. Consequently, governments are reluctant to ask for IMF financing unless they cannot get enough foreign exchange from other sources.

The IMF provides the financing on an unsecured basis. It tries to ensure that it will be repaid by making the financing subject to policy conditions, known as conditionalities. The premise of these conditionalities is that the country is essentially living beyond its means and must reduce its expenditures to the level of its income, including the funds contributed by the IMF. In short, the IMF is demanding that the country makes sacrifices.

This means, inevitably, that the terms of IMF financing are controversial. First, the scale of the sacrifices necessary to restore a country to macroeconomic health are not easily determined. They depend on perceptions of the causes of the country's crisis, assumptions about future economic developments and the capacity of the government to implement policy changes and the public to accept and absorb these changes. Reasonable people can, of course, have different views on these issues.

Second, the scope, terms and number of conditionalities the IMF chooses to attach to its financing can be very broad, or quite specific. For example, it can merely state the size of budget cuts that the country must make or the amount of additional revenues it must raise and then leave it up to the country to decide how to meet these conditions. Alternatively, it can specify which budget items should be cut, which taxes should be increased, and which structural reforms must be implemented in order to get IMF financing.

This effectively means that the conditionalities are matters for negotiation between the government and the IMF and that they depend on the balance of bargaining power between them. This means that the IMF is effectively a player in the domestic economic policy making process of countries that need its financing.

However, the IMF is not subject to the same legal requirements regarding participation or transparency as other players in this process. It is also less accountable to those who will be affected by its policy choices than the government itself.

Men's fertility also declines with age — here's what to know if you're planning to wait to have kids

Despite what many men believe, they might not have all the time in the world when it comes to having children

While women are often reminded about their "biological clock," many guys just don't feel the same pressures when it comes to settling down and starting a family. In fact, a lot of men in their 20s – especially cisgender, heterosexual men – don't think a great deal about having children or when they might want to have children.

This might be because many people think men have all the time in the world when it comes to having children. Exceptional examples such as Mick Jagger – who had a child when he was 73 years old – are often cited to reinforce this argument. But in reality, there are many things men need to bear in mind when it comes to their fertility and starting a family.

In recent decades we have seen a gradual shift towards more people becoming parents later in life. In England and Wales, both men and women are having children later than ever before in recorded history. Men alone now have children on average aged nearly 34-years-old, compared to around 29-years-old in the mid-70s.

There are multiple, complex reasons for this – including young people facing more difficulties buying houses and living in an uncertain economic climate, alongside changes in the way people date and form relationships. Another factor is that both women and men are staying in education longer, and taking longer to establish careers. Alongside this, people appear to feel more pressure to have children at a time when they can give them the "best start" in life.

While some people can have children in their 30s, 40s and beyond with ease, others may struggle. There are often misconceptions that only women face fertility difficulties the older they get but growing evidence suggests that age also affects a man's fertility, too – from around about 40 onwards. In fact, age has been shown to negatively affect sperm quality, reduce fertility, and carry a greater likelihood of both miscarriage and health conditions in children – particularly autism, schizophrenia, bipolar disorder and childhood leukaemia.

But this evidence is rarely talked about – and men often aren't aware their fertility can decline as they get older. While this is not a reason to panic – arguably the risks still remain low – it is something to be aware of if you are planning to wait to have kids.

Improving your odds

So what can you do then to make sure you have the best chance possible when you do want to have children? There are a couple of factors to take into account.

The first is your lifestyle. Research shows that many different lifestyle factors can affect a man's fertility. In particular, research suggests avoiding smoking and excess alcohol intake, as well as having a healthy diet and BMI, are important for healthy sperm and for fertility. Men (and women) are encouraged to think about these things – and others such as avoiding tight underwear, drugs and steroids – in their teens and 20s.

But having a healthy lifestyle is only one part of the equation. Another key part is age. Ideally, you ant to try to have children before "fertility ageing" becomes a problem - that is, before age may affect your chance of conceiving or the wellbeing of your children. Although many people believe that men can continue having children well into old age, the evidence shows us that this may not necessarily be true - and may also come with risks. This is why it may be important for more young men to start thinking about whether, when and under what circumstances they may want children, and build these ideas into how they plan and live their life.

Being single is a key reason why both men and women aren't able to have children at their ideal time – and why some remain childless even if they wanted children. So it's important to keep fatherhood in mind when navigating dating and relationships. Both avoiding "settling down" or staying with the wrong person for too long can affect your (and your partner's) chances of finding the right person to have children with in the future.

Fertility isn't just down to one person. If you do have a partner, it may be important to consider both of your ages and fertility when considering having kids. A woman's fertility decreases faster than a man's does, so having frank and honest conversations about if and when you'd both like to become parents may help you avoid



future arguments and disappointments.

New technologies continue to be developed which may help people increase their odds of becoming parents in the middle and older age. In particular, egg freezing is a growing phenomenon and some suggest sperm freezing in younger adulthood can help men have children later in life but using the best quality sperm. But just because these technologies may make it possible, doesn't mean you shouldn't still think about whether and when you want to have children as you begin to plan your adult life.

In women, higher body fat may protect against heart disease death, study shows

A new UCLA study shows that while men and women who have high muscle mass are less likely to die from heart disease, it also appears that women who have higher levels of body fat -- regardless of their muscle mass -- have a greater degree of protection than women with less fat.

The researchers analyzed national health survey data collected over a 15year period and found that heart diseaserelated death in women with high muscle mass and high body fat was 42% lower than in a comparison group of women with low muscle mass and low body fat. However, women who had high muscle mass and low body fat did not appear have a significant advantage over the comparison group.

Among men, on the other hand, while having high muscle mass and high body fat decreased their risk by 26% (compared to those with low muscle mass and low body fat), having high muscle mass and low body fat decreased their risk by 60%.

The American Heart Association estimates that 5 million men and 3 million women have heart attacks annually. Yet despite this wide gender gap and an overall decrease in heart attack-related deaths for both men and women over the past 50 years, an equal number of men and women still die from heart disease.

In addition, mortality among women

over those five decades has fallen at a slower rate than for men, and the incidence of heart attacks appears to be increasing among women between the ages of 35 and 54. Recent research has also found that women have significantly higher levels of risk factors associated with adverse heart disease than men.

The researchers analyzed body composition data from the National Health and Nutrition Examination Survey 1999-2004 and cardiovascular disease data from the National Health and Nutrition Examination Survey 1999-2014.

The findings highlight the importance of recognizing physiological differences between women and men when considering body composition and the risk of death from heart disease, particularly when it comes to how differences in body fat may modify that risk.

The research also underscores the need to develop sex-appropriate guidelines with respect to exercise and nutrition as preventive strategies against the development of cardiovascular disease.

The right '5-a-day' mix is 2 fruit and 3 vegetable servings for longer life

Studies representing nearly 2 million adults worldwide show that eating about five daily servings of fruits and vegetables, in which 2 are fruits and 3 are vegetables, is likely the optimal amount for a longer life, according to new research published in the American Heart Association's flagship journal Circulation.

Diets rich in fruits and vegetables help reduce risk for numerous chronic health conditions that are leading causes of death, including cardiovascular

disease and cancer. Yet, only about one in 10 adults eat enough fruits or vegetables, according to the U.S. Centers for Disease Control and Prevention.

"While groups like the American Heart Association recommend four to five servings each of fruits and vegetables daily, consumers likely get inconsistent messages about what defines optimal daily intake of fruits and vegetables such as the recommended amount, and which foods to include and avoid," said lead study author Dong D. Wang, an epidemiologist, nutritionisT..

Wang and colleagues analyzed data from the Nurses' Health Study and the Health Professionals Follow-Up Study, two studies including more than 100,000



environment. And it's not just the air. Very little liquid water is on the Martian surface. Temperatures are incredibly cold – at night, it's more than -100 degrees Fahrenheit (-73 degrees Celsius).

But plenty of organisms on Earth survive extreme environments. Life has been found in the Antarctic ice, at the bottom of the ocean and miles below the Earth's surface. Many of those places have extremely hot or cold temperatures, almost no water and little to no oxygen.

And even if life no longer exists on Mars, maybe it did billions of years ago, when it had a thicker atmosphere, more oxygen, warmer temperatures and significant amounts of liquid water on the surface.

That's one of the goals of NASA's Mars Perseverance rover mission – to look for signs of ancient Martian life. That's why Perseverance is searching within the Martian rocks for fossils of organisms that adults who were followed for up to 30 years. Analysis of all studies, with a composite of more than 2 million participants, revealed:

Intake of about five servings of fruits and vegetables daily was associated with the lowest risk of death. Eating more than



five servings was not associated with additional benefit.

Eating about two servings daily of fruits and three servings daily of vegetables was associated with the greatest longevity.

Not all foods that one might consider to be fruits and vegetables offered the same benefits. For example: Starchy vegetables, such as peas and corn, fruit juices and potatoes were not associated with reduced risk of death from all causes or specific chronic diseases.

On the other hand, green leafy vegetables, including spinach, lettuce and kale, and fruit and vegetables rich in beta carotene and vitamin C, such as citrus fruits, berries and carrots, showed benefits.

once lived – most likely, primitive life, like Martian microbes.

Do-it-yourself oxygen

Among the seven instruments on board the Perseverance rover is MOXIE, an incredible device that takes carbon dioxide out of the Martian atmosphere and turns it into oxygen.

If MOXIE works the way that scientists hope it will, future astronauts will not only make their own oxygen; they could use it as a component in the rocket fuel they'll need to fly back to Earth. The more oxygen people are able to make on Mars, the less they'll need to bring from Earth – and the easier it becomes for visitors to go there. But even with "homegrown" oxygen, astronauts will still need a spacesuit.

Right now, NASA is working on the new technologies needed to send humans to Mars. That could happen in the next decade, perhaps sometime during the late 2030s. By then, you'll be an adult – and maybe one of the first to take a step on Mars.

Could people breathe the air on Mars?

Let's suppose you were an astronaut who just landed on the planet Mars. What would you need to survive?

For starters, here's a short list: Water, food, shelter – and oxygen.

Oxygen is in the air we breathe here on Earth. Plants and some kinds of bacteria provide it for us.

But oxygen is not the only gas in the Earth's atmosphere. It's not even the most abundant. In fact, only 21% of our air is made up of oxygen. Almost all the rest is nitrogen – about 78%.

Now you might be wondering: If there's more nitrogen in the air, why do we breathe oxygen?

Here's how it works: Technically, when you breathe in, you take in everything that's in the atmosphere. But your body uses only the oxygen; you get rid of the rest when you exhale.

The air on Mars

The Martian atmosphere is thin – its volume is only 1% of the Earth's atmosphere. To put it another way, there's 99% less air on Mars than on Earth.

That's partly because Mars is about half the size of Earth. Its gravity isn't strong enough to keep atmospheric gases from escaping into space.

And the most abundant gas in that thin air is carbon dioxide. For people on Earth, that's a poisonous gas at high concentrations. Fortunately, it makes up far less than 1% of our atmosphere. But on Mars, carbon dioxide is 96% of the air!

Meanwhile, Mars has almost no oxygen; it's only one-tenth of one percent of the air, not nearly enough for humans to survive.

If you tried to breathe on the surface of Mars without a spacesuit supplying your oxygen – bad idea – you would die in an instant. You would suffocate, and because of the low atmospheric pressure, your blood would boil, both at about the same time.

Life without oxygen

So far, researchers have not found any evidence of life on Mars. But the search is just beginning; our robotic probes have barely scratched the surface.

Without question, Mars is an extreme





Prediabetes: You Can Turn It Around

Prediabetes is when your blood sugar is higher than normal, but not high enough to be called diabetes. You won't necessarily notice any symptoms -- you can have it and not know it. A simple blood test can tell you if you do. You're at risk if you're overweight, over 45, and you don't exercise. It makes you more likely to have type 2 diabetes and heart disease, but you can take steps to change that as suggested by Jennifer Robinson, MD, for WebMD

Lose Weight

It doesn't have to be a lot. If you lose just 7% of your body weight, it can make a huge difference (that's only 14 pounds for a 200-pound person). The first step is to eat healthier food with fewer calories. Start by keeping track of your weight, eating habits, and physical activities.



Eat Healthy

A good rule of thumb is to fill half your plate with non-starchy vegetables (asparagus, Brussels sprouts, and carrots, among many others). One quarter should have starchy foods (like potatoes, corn, or peas). The remaining quarter should be protein -- chicken, fish, or



beans are best. Be extra careful with carbs like baked goods or pasta -- they can raise your blood sugar.

Exercise

You'll lose weight faster and feel better if you get out and burn more calories. You don't need to train for a marathon: A brisk 30-minute walk five times a week should do the trick. A workout buddy can sometimes help you stick to a routine, so call a friend or join a gym and make some new ones. Aerobic exercise (walking, swimming, dancing) and strength training (weight lifting, pushups, pull-ups) are both good. A little of both is best.

Get Your ZZZs

The right amount of shut-eye helps keep your blood sugar at healthy levels. If you can't stay asleep, wake up too early, or get less than 5 hours a night, you're more likely to get diabetes. About 7 or 8 hours a night is ideal. For better sleep, don't have alcohol or caffeine late in the day, keep regular sleep hours, and stick to a calm, quiet bedtime routine.

Don't Smoke

If you smoke, now's the time to quit. Smokers are 30% to 40% more likely to get type 2 diabetes than non-smokers. And if you get diabetes and still smoke, your symptoms may be worse and your blood sugar may be harder to control.

Medication

Certain drugs can help with blood sugar levels and obesity, as well as high cholesterol and high blood pressure. And you're more likely to have those if you have prediabetes. If you do, take your medication as prescribed -- it can improve your health and help you live longer.



Akshay Kumar told Hindustan Times a day before the release of *Raksha Bandhan*, he says, "I can easily make a *Rowdy Rathore 2* or *Singh is Kinng 2* and make triple the amount of money, but these are social awareness films, and I like making such films because they can make a difference. I was discussing with my director (Aanand L Rai) that after watching our film, even if just 10 people can make a decision to not take or offer dowry, then I consider it my success."

Talking further about the movie, Kumar says, "It has the very basic emotion of *bhai-behen, jo sabke ghar par chalta hai,* but people don't often think about it. We make films on all emotions and relationships, but it has been over four decades since we made a film on the brother-sister bond. *Tapasya*

(1976) was probably the last film on this."

Kumar surely shares a close bond with his sibling, Alka Bhatia. And fans saw him get incredibly emotional as he received a message from her while he was promoting his movie on a reality show. The 54-year-old says, "I rarely get emotional during a show. But when I saw the video where my sister spoke, I got carried away. We say men are strong and take care of their sisters, but I've seen sisters are stronger and take care of brothers more."



In 'The Foundations of Indian Culture', mystic and poet Sri Aurobindo laid much emphasis on the dharmic culture and ancient spirit of the land of the rishis. For him it was the prime force underlying its evolution through the ages and sustained its civilization.

Dharma is the Eternal Truth that enlightens every aspect of the exploration of the spirit, the scientific understanding of the Cosmic Energy and the Laws of Nature, how they illustrate the unity of beings, the various forms in which this unity is expressed and celebrated in the aesthetics, sculpture, arts, devotional songs, music, dance and the general outlook on humanity, life, politics and society. The spiritual dimension of this dharmic culture permeates all aspects of its age-old civilization. It is about spirituality being a prime motive, and not a cosmetic artifice that is evoked conveniently to give credibility to and justify actions undertaken by alien forces that clashed with Indian civilization over centuries up to modern times.

How long the ancient spirit of India will survive depends on the will of its sons and daughters to sustain it - or to let it be engulfed in the whirlwind of other pursuits and to then perish slowly. Sri Aurobindo pointed at the imitation of western political system, which started in the de-colonization period, as a warning sign of the corrosive effects such imitation might engender if it is swallowed wholesale, as it is not in harmony with the ancient spirit of Indian civilization.

In today's world, it should matter to the people of India, its diaspora and people of Indian origin whether the upbringing in their homes and the formal education imparted in schools and colleges open the doors to the knowledge of their own culture, past and history, and equip them with the necessary tools to guide and give a holistic sense of purpose to themselves, the society they live in, and Indian culture at a higher level. We cannot but agree with François Gautier, an outspoken voice on Indian culture, who underlines the fact that an intellectual of the calibre of Sri Aurobindo would have been held in high esteem in France and his books on culture, politics, philosophy, and poetry studied and discussed in universities. This is far from being the case in India itself.

Sri Aurobindo belongs to modern history when you think of it. How much the younger generation knows about the influence of the Vedas and the Upanishad on thinkers like Schopenhauer in Germany, Spinoza in the Netherlands and Thoreau in America is anybody's guess. Let alone the names and works of past mathematicians and scholars in various fields of science who are blithely ignored. For example, it would seem the findings of leading nuclear scientists in the 20th century do not receive


due recognition. The career of a contemporary space scientist, Dr Narayanan, has been ruined for political reasons by a Congress-led government in Kerala since 2009. He was harassed and thrown out of a rickshaw in Kerala. Despite the humiliation, Dr Narayanan remains a staunch patriot and refused a brighter future offered to him in the US.

Scientists are honoured in advanced countries, Europe, the US, Canada, Japan and China Their interviews and conferences are highlighted in the media. Intellectuals, philosophers and writers are treated like demi-gods in France, a status which has been monopolized by politicians in developing countries where political riva-Iry and ego issues overweigh national interests. Western countries have borrowed a lot from Indian thought and science without acknowledging it. Even Steven Spielberg's film 'ET' in the 1980s was an imitation of Bengali film producer and writer Satvaiit Ray's short story relating the accidental landing of a UFO in a village illustrated with a drawing of an alien being. Spielberg ignored the protests of Indians in New York.

Western countries did not predict the future and potential of Information Technology and were ill-prepared to cater for the huge demands in various sectors in the 1990s. It caused a brain drain of engineers, educated at Indian taxpayers' expense, to the West at a time when India was hardly beginning to emerge from under-development. Ayurvedic medicine recipes are copied by Americans and smartly marketed with different labels with capital A and exported to India to make it sound local. Cosmetic brands like the British Estée Lauder came to India to study Ayurveda and used it without paying a single penny to India. Just see how the Americans send lawyers to hound any foreigner who ventures to copy their brands with disrespect to property rights.

The point is how much credit India itself has given to its intellectuals, thinkers, and scientists so that they could be role models for the younger and upcoming generation. A policy of appeasement and a distorted sense of secularism that marked decades of Congress-led governments as from 1947 are singled out as the causes for an inadequate knowledge of history in Indian schools. To what extent a free market economy, borrowings from IMF, introduction of American TV channels have opened the way to further gross imitation as Sri Aurobindo warned about is an open question. An all-Sanskrit-based medium of teaching is reported to be undergoing experimentation in the US to create a new breed of mathematicians and scientists. By 2012, budget cuts in Sanskrit by the Congress government drew criticism in India. Interestingly there were then more foreigners studying Sanskrit in India than locals. Has the situation changed?

It seems that 800 years of foreign rule have created a mindset which is seen as yielding to the ones who shout loudest. However, the other half of the glass is full of energy, India's Shakti embodied by rulers who are striving to assert their values and national ambitions in a spirit of patriotism despite all the odds and obstacles.
