# The ICAC

hite-collar crime ranging from financial fraud, massive corruption, illicit gambling and the associated money-laundering and cross-border transfers involved have reached new heights internationally and have raised considerable angst locally for many years but with heightened concern these days.

First there is the thorny issue of the most appropriate mechanism for the appointment of the Director General of such an important institution in our investigative and democratic setup. Section 19 (4) the Prevention of Corruption Act 2002 (PoCA), as amended, provides for the appointment of the Director-General of ICAC by the Prime Minister after consultation with the Leader of the Opposition. We recall that the Leader of the Opposition had publicly expressed objection to the reappointment of Navin Beekharry as Director General of the ICAC. Given the weight that is given to the "after consultation" proviso in the law, it is the Prime Minister who in fine decides who should head the institution and he can ignore any such objections. Should this be reviewed and what mechanism would be better is open

Section 20 (2) & (3) of the Prevention of Corruption Act (POCA) provides that 'the Commission shall act independently, impartially, fairly and in the public interest', and 'subject to this Act, the Director-General shall not be under the control, direction of any other person or authority'. In a small island with multiple social connections and rubbing of shoulders, whatever the legal and constitutional provisions, it is ultimately dependent on the moral fibre of the appointee to detach him/herself from the political nominator to faithfully and efficiently execute the mandate conferred unto his office. Our legal contributor Lex has previously expressed the view that 'the POCA 2002 quarantees the independence of ICAC. The law is there. Its proper functioning depends on the holders of power within the ICAC.

Second, the POCA 2002 does not provide for any oversight mechanism that could have monitored the ICAC at its operational level, especially as regards the conduct of specific investigations or the delays and vagaries surrounding them. But there must necessarily be some form of oversight as it is allocated from

public and taxpayers a vast budget of Rs 200m or more annually. The current parliamentary oversight mechanism with 5 government and 4 Opposition nominees has turned it into such an inadequate toothless rubber-stamp that Opposition members have resigned collectively rather than give some credence to it. It is beyond the pale that this Committee cannot even access the salary and contract conditions of its DG while being asked to approve operational budgets and staffing of lower rungs. As there are a couple of Parliamentary Questions again on those ICAC issues, we trust the PM will see to it that demands for greater transparency are indeed answered for the benefit of the public.

Third, and interlinked with the lack of transparency, there have been repeated concerns that the long list of affairs where it is yet to be known where ICAC inquiries stand, such as the Dufry scandal (2015); the Alvaro Sobrinho scandal (2018); the Sugar Insurance Fund Board's highly excessive overpayment of land v/s valuation scandal (2018); the Yerrigadoo/ Bet 365 scandal (2018); the Glen Agliotti affair (2019), the Serenity Gate/Film Rebate Scheme scandal (2019), St Louis Power Station Redevelopment Project, the scandalous ripoffs at Commerce/Health and STC during the pandemic and more recently the Rs 460 million worth of banned roll-on cigarette paper approved over MRA objections. This is not even a comprehensive roll-call of higher-profile cases.

Moreover, a case had to be filed against ICAC by the Integrity Reporting Services Agency (another State agency) for allegedly failing to furnish it with detailed reports on cases of unexplained wealth and now we hear that CCID are investigating the DG's personal involvement in the refurbishment of his offices. Others have reported on the sorry state of the parking and grounds where seized cars, boats and a variety of other materials are rotting away under the Moka sun. Coupled with the lack of transparency and accountability, all this adds little to help the image of the ICAC.

Under public glare and pressure, the agency has issued belatedly some communique about a few cases but the public perception of a toothless dog that, forget the bite, has forgotten how to bark (except on orders?), is incompatible with its nobler calling or with the country's reputation internationally.



# Why some people think fascism is the greatest expression of democracy ever invented

arnings that leaders like Donald Trump hold a dagger at the throat of democracy have evoked a sense of befuddlement among moderates. How can so many Republicans – voters, once reasonable-sounding officeholders and the new breed of activists who claim to be superpatriots committed to democracy – be acting like willing enablers of democracy's destruction?

As a political philosopher, I spend a lot of time studying those who believe in authoritarian, totalitarian and other repressive forms of government, on both the right and the left. Some of these figures don't technically identify themselves as fascists, but they share important similarities in their ways of thinking.

One of the most articulate thinkers in this group was the early-20th-century philosopher Giovanni Gentile, whom Italian dictator Benito Mussolini called "the philosopher of fascism." And many fascists, like Gentile, claim they are not opposed to democracy. On the contrary, they think of themselves as advocating a more pure version of it

## Unity of leader, nation-state and people

The idea that forms the bedrock

of fascism is that there is a unity between the leader, the nationstate and the people.

For instance, Mussolini famously claimed that "everything is in the state, and nothing human or spiritual exists, much less has value, outside the state." But this is not an end to be achieved. It is the point from which things begin.

This is how Trump, according to those around him, can believe "I am the state" and equate what is good for him is by definition also good for the country. For while this view may seem inconsistent with democracy, this is true only if society is viewed as a collection of individuals with conflicting attitudes, preferences and desires.

But fascists have a different view. For example, Othmar Spann, whose thought was highly influential during the rise of fascism in Austria in the 1920s and 1930s, argued that society is not "the summation of independent individuals," for this would make society a community only in a "mechanical" and therefore trivial sense.

# Police: Restore Order from Chaos!

have time and again in these columns and in this paper stressed the respect and support that the police should receive as they go about their duties in a multi-cultural society aspiring to live in some harmony, where honest and hard-working citizens should expect to be protected and treated with integrity and professionalism independently of their sex, ethnic origins, personal beliefs, and political affinities. We have no reason to waver on those demands and expectations from both sides of the fence. And we still believe the majority of police officers, even if insufficiently trained or equipped, or working in some cases in unsatisfactory buildings, operating under conditions and pressures of a disciplined force, try to answer their noble calling or simply do an honest job.

It is in that spirit that we have and will continue to raise matters that distract from such ideals, and which seem to be taking the country on a steadily downhill path in practice where ordinary citizens, NGOs, members of the legal community and visible faces of the independent media are losing confidence in the ability of police hierarchy to steady the ship amidst turbulences that keep battering its credibility.

The fathers of our independence and national sovereignty went some lengths to ensure that some vital offices, including that of the Commissioner of Police (CP), had ingrained constitutional safeguards to guarantee that holders of such high offices were protected from the hubris of political masters and their courtesans. It may not have been perfect but by and large we had no reason to suspect that any CP, once duly appointed, would fail to rise to the challenges and opportunities to serve the population that such independence conferred unto his post.

Why then do the police force seem to be spinning away from those legitimate expectations and, more disquietingly, why do they seem unable to see the growing sense of disenchantment in many quarters and take the necessary steps to change course? For brevity, we need only consider some less trivial examples that have remained unexplained to the layman, let alone to lawyers or civil rights activists.

We recall police behaviour in the case of the Slovakian national who had been residing lawfully in Mauritius since October 2019 with, one assumes, PMO's approval, and his subsequent "manu militari" extraction by the police and handing over in April 2022 to a foreign power at SSR airport, ignoring either the Extradition Act or the Deportation Act and even flouting of the Interim Order of the Judge of the Supreme Court where legal deportation proceedings entered by the Attorney General(AG) were following their course. The PMO may well have been apprised in April this year that Mr Uricek was a wanted fellow of ill repute and terminated his residence permit but, even then his forcible extraction and expulsion by the police from the territory of Mauritius shook lawyers as it openly flouted the supervision of the Supreme Court in the AG's own proceedinas.

Much worse in terms of what's perceived to be a classic example of flouting of the law by those precisely supposed to uphold it, was to be thrown up this June by a succession of videos and clips of police officers of different units based at Terre Rouge station concerning brutality, torture, and humiliation of suspects. While they are not dealing with "enfants de chœur" in that particular region or even in other hotspots of the island, there can be no reason to defend such dysfunctions in a Force that should ensure that the law prevails fairly or equitably and command respect rather than sarcasm.

"Shocking and unacceptable", commented the PM, promising a transparent inquiry on 1st of June alluding to the possibility the disturbing videos may have been in police possession since earlier. In August news media

were still querying the Commissioner of Police or the Independent Police Complaints Commission for a full briefing on the matter and measures taken to ensure such flouting of the law or any judge's rules with respect to decency and rights in the treatment of suspects and we have not heard much since.

There must have been serious grounds for the Lam Shang Leen Drug Commission, in its comprehensive three-year hearings and 260-page report, to tackle institutional failures and police professionalism in matters

of drug trafficking investigations, recommending amongst others the winding up and reorganisation of its specialised cell, the ADSU. No such thing happened and instead we had the CP announcing early August the setting up of a "Police Headquarters Special Striking Team" (SST) reporting directly to him and which was designed to act separately and in parallel to ADSU, MCIT or Customs to tackle only "special cases" and major trafficking crimes.

Many Mauritians, lawyers and NGOs are wondering on social and other media whether drugs, hashish, or small envelopes of harder stuff can be "planted" in what would be a mind-numbing scenario. Allegations, confusion, and controversies, with heavily slanted political comments about suspects who have yet to be declared guilty by competent courts, distract from the national policing imperative to tackle the scourge of drug importation and trafficking with purpose and professionalism.

Vast cross-border financial movements that are required to fund drug purchases worth billions caught up fortunately in the notorious gas bottles saga, in the "tractopelle" affair, in the Pointe aux Cannoniers seizures, must leave financial traces. Agencies like the FIU, the Customs, the MRA or the Bank of Mauritius, have probably sufficiently able financial tracking specialists who can help the police in its investigations of that crucial aspect.

Drug trafficking and the associated money-laundering with their cross-border implications are probably complex and sophisticated operations requiring more than dedicated but traditional investigators. # **Suren Dayal's Election Petition**

n a small island where politicians, lawyers, judges and business community leaders rub shoulders formally and socially, where so many institutions are politicised and given the way some laws are interpreted, it is salutary, says Lex, that we still have the Privy Council as a supervisory court to set matters right and in their proper perspective whenever required, in addition to consolidating our jurisprudence.

#### **LEX**

\* Is it possible to anticipate what the Law Lords of the Judicial Committee of the Privy Council (JCPC) may decide in the appeal lodged by Suren Dayal against the judgement of the Supreme Court, which dismissed his petition against the election of Pravind Jugnauth, Leela Devi Dookun-Luchoomun and Yogida Sawmynnaden? Are there trends that could indicate the direction in which the Law Lords would be likely to take?

No, one cannot anticipate the outcome of the case. Each case is decided on its own merits and depending on what the Law Lords make of the facts and how they will apply the law.

\* The process of justice is supposed to be impartial, but Suren Dayal is challenging the election of, amongst others, the sitting Prime Minister of the current government. Could that be a consideration that may influence the decision of the Privy Council should it choose not to disturb the status quo at the level of the governance of the country?

Many people, including lawyers, believe that when a court of law is dealing with a sitting head of government or head of state, this might be something that judges would bear in mind. We are free to speculate, but we will never know if that's indeed the case.

\* But would you expect the Law Lords to go the way they did as in the MedPoint case?

Difficult to say. The turning point in the MedPoint case was the volte-face of the Independent Commission Against Corruption (ICAC), represented before the Privy Council by its director, Navin Beekarry, who filed a document to state that there was no case against Pravind Jugnauth. If the institution that filed a charge against an accused comes for-

ward to state that its earlier decision was wrong and that the case should not go ahead, what can the court do? The issue in the MedPoint case was whether the sister of the Prime Minister had a personal interest in the matter, and this was what the Law Lords decided:

'40. The Board notes that the Independent Commission against Corruption, which initiated this prosecution, now accepts in its written case on this appeal that it is difficult to see how "an internal reallocation of payments source for the external contract" would be a decision in which Mrs Malhotra would have a personal interest.

'41. This is sufficient to dispose of this appeal. The prosecution has failed to establish that the defendant's sister had a personal interest in the decision, an element of the actus reus of the offence contrary to section 13(2). However, it should also be noted that, by the same token, the defendant could not have had knowledge of the existence of facts giving rise to a personal interest in the decision in his sister, because there were none.

'42. For these reasons, the appeal will be dismissed.'

\* The layman may sometimes wonder whether judges are or could be completely free of 'predispositions, prejudices, and vulnerabilities that come from their own life experiences' or other vulnerabilities. Both locally and at the level of the Privy Council?



The Supreme Court should have a High Court and a Court of Appeal. It is high time that we have a Court of Appeal completely insulated from the High Court. To what extent does a judge's personal views or opinions really shape the outcome of a case, and what should be done about it, that's difficult to say. However, in a society where the media and general public are increasingly scrutinizing judicial decisions, judges and magistrates are expected to justify their decisions or risk facing public and even professional backlash.

\* Besides the Crown dependencies and the United Kingdom Overseas Territories, Mauritius is one of the 12 Commonwealth countries which still use the JCPC as their highest court of appeal. Australia was one of the first in 1901 which established its own highest court for constitutional matters. India abolished appeals to the Privy Council in 1949 - two years after

winning independence. Why did our political leadership decide to hang on to the Privy Council?

With the politicisation of so many institutions and given the way some laws are interpreted, it is salutary that we still have the Privy Council as the final court of appeal to set matters right and in their proper perspective whenever required. Many judgments of the Privy Council are living proof of this. For example, the Supreme Court held that the decision of the DPP is not reviewable, but the Privy Council held otherwise.

Besides Mauritius is a small country where judges rub shoulders with politicians. This is not to say that they are at the beck and call of the Executive. But then the choice of certain judges to act on commissions of inquiry or to sit on international bodies may lead the public to suspect that some judges could be in the good books of a sitting government or of the Prime Minister. \* One could argue that the UK has, through the Privy Council, retained influence over Mauritius' domestic affairs even after the country achieved independence. What's your take on that?

Even if that can be substantiated, it is not true. The Privy Council decides the cases submitted to it and help to set right erroneous judicial thinking of the Supreme Court as well as shape our local jurisprudence. At times the Privy Council may even make recommendations on how the legislator should amend certain laws or how the Supreme Court should mange cases in order to reduce delay. All this is perfectly in order.

\* A Presidential Commission, chaired by Lord Mackay, had recommended in 1997 the setting up of a Court of Appeal Section of the Supreme Court to which appeals from every level of court in Mauritius - the High Court Section of the Supreme Court, the Intermediate Court and the District Court - should be taken. This has not been implemented to this day. Is the time now ripe for our own Court of Appeal?

The Supreme Court should have

a High Court and a Court of Appeal. It is high time that we have a Court of Appeal completely insulated from the High Court. What is happening now is like a musical chair. On one day two judges will sit on appeal on a case of their colleague. The next day the same judge whose judgment is appealed against will sit on appeal on a judgment given by one judge who sat on appeal on his own judgment. This is simply ridiculous.

\* The slap down of the Supreme Court in the Betamax affair comes to mind. Is this supportive of a high court of appeal that is relatively dissociated from local considerations?

Of course. The Privy Council will very often refuse to interfere in aspects of a case by stating that the Supreme Court is more aware of local conditions. But in general, the Privy Council is totally dissociated from any matter - political or otherwise - that would influence their judgment

\* In the Resistans ek Alternativ case, were the Law Lords wise to have reckoned that ethnic representation in our Constitution is a matter better dealt with by the local body politic?

Yes. The Privy Council very diplo-

matically stated that they would not interfere in a matter that has wide political ramifications and therefore the matter must be decided locally.

\* Is there a case to be made for a Constitutional Court or an Election determination court instance that could hear and expedite matters that cannot wait years?

In August this year, former judge Vinod Boolell wrote the following in *l'express*:

'Mauritius has no constitutional court unlike some countries. In France, for example, there exists the Constitutional Council (Conseil Constitutionnel) which is the highest constitutional authority in France. One of the most important attributions of the Council is to determine whether a law passed by the French Assembly is in conformity with the Constitution before it is even signed into law by the President of the French Republic. Milan Meetarbhan in his book on the Constitution has advocated the establishment of a constitutional court. Such a court with the power to determine the constitutionality of a statute before it is signed into law will no doubt be a salutary move on the rocky path towards the consolidation of demo-

As far as elections are concerned, it is hard to understand why it takes years after an election to determine an election petition. Is that done deliberately by lawyers who oppose the election petitions? Is that condoned by the Supreme Court? A Constitutional Court would be able to fast track such petitions.

\* Are there other judgements of the Privy Council which have had a major impact on the governance of the country, on our judicial system, etc.?

These relate to many cases where the decisions of the Executive have been quashed especially in matters of tax and compulsory acquisition of property. These cases force those who run the country to bear in mind the factors that the Privy Council has discussed and determined. Let us hope guidance will also be given in election matters in the Suren Dayal case.

By June several financial observers were openly questioning whether the close working arrangement between the Finance Minister and the appointed Governor at BOM was taking the country adrift in matters such as inflation control, currency depreciation, lack of forex on the market starting to bite economic operators, or even the reserves available for the Central Bank to sustain cross-winds through periodic interventions. Since then, of course the BoM was under increasing pressure from all sides to intervene massively on the stressed forex market even at the cost of weakening its balance sheet further.

The recent publication of the Central Bank's financial position as at October 2022 has confirmed the worst fears that had been swirling over the Bank's real financial position and will leave finance specialists anxious or derisive about what one specialist observer called the "toxic tandem" at the helm of the country's economic affairs.

BOM reserves, already a meagre Rs 2.5 billion in September 2022, have one month later tumbled to less than Rs 1 billion, while it technically had more liabilities than assets in its balance sheet. That usually means technical bankruptcy for any ordinary company. Of course, a central bank cannot go bankrupt, but the plundering of reserves over the recent years through the MIC operations, the need to stem the nosedive of our currency and the massive injections of foreign exchange have spelt the fateful outcome the IMF and the World Bank had been warning about.

At a time when exports and balance of payments are weak and the world economy may be heading for some recession, lack of credibility and profligacy by political quacks have turned the BOM impotent for future interventions. Without a credible independence of the Bank and a significant injection of capital in the Central Bank by government, as repeatedly called for by international watchdogs and Moody's, economic operators and the population could face the dire straits looming ahead.

t the conclusion of the COP27 event in Sharm el-Sheikh, Egypt, Simon Stiell, the UN Climate Change Executive Secretary exulted: "COP27 has defined a way forward on a decades-long conversation on funding for addressing loss and damage. Let's use this success as a springboard to restore trust in our process. Let's use it to achieve greater ambition and faster implementation."

Contrast this with the closing remarks of UN

Secretary General António Guterres:

- \* "Our planet is still in the emergency room."
- \* "We need to drastically reduce emissions now and this is an issue this COP did not address."
- $^{\star}$  "COP27 concludes with much homework and little time."

So, which one of these two has the more accurate take on COP27? With a deeper look at what each said, perhaps it is a tie. Stiell is correct that at best, all that was accomplished was the promise of more talk, perhaps for decades before any progress is made. His comments imply that trust "in our process" whatever that means, has been lost. Certainly, there was little reason for people to walk away from COP27 with a sense of trust either in the process, or with the belief that the world's nations will take concrete steps to address climate change or actually contribute to a fund for loss and damage.

Guterres is entirely correct that COP27 simply ignored the subject of drastically reducing emissions now. And if one believes that the earth is nearing a tipping point — Guterres has sounded that alarm at every opportunity — one must also accept that the emergency persists and that there is very little time and much work to be done.

At the previous COP26 gathering, three of the leading emitters proposed to reach zero net emissions way in the distant future — the US in 2050, China in 2060, and India in 2070. Whereas after COP26 those goals were not seen as adequate to address the crisis, there was no attempt to do more. As of now, these large emitters promise more emissions.

COP27 may in the future be most noted for the fact that it did not even mention phasing out fossil fuel use in the final text of the conference agreement. There was mention of efforts towards "the phase down of unabated coal power" and phasing out inefficient fossil fuel subsidies. There are no surprises here. It has been reported that about 635 attendees at COP27 were representa-

# **COP27 Review**

66COP27 may in the future be most noted for the fact that it did not even mention phasing out fossil fuel use in the final text of the conference agreement. There was mention of efforts towards "the phase down of unabated coal power" and phasing out inefficient fossil fuel subsidies. There are no surprises here. It has been reported that about 635 attendees at COP27 were representatives of fossil fuel companies. Their influence on the final failure to curb emissions and reduce the use of fossil fuels seems almost palpable..."

So, was anything ac-complished at COP27?

There was much sound and fury about the creation of a fund to help developing countries pay for loss and damage due to drought, floods and other severe weather events claimed to be made worse due to climate change. At least three major problems remained unaddressed or unanswered.

First, there was no agreement on how the fund is to be set up and in what form, who will contribute to it and how much, and where the money will be allocated. The reality is that we have a nonexistent fund and an agreement to agree.

Second, there was the tacit assumption that the

cause of devastating floods in many countries is climate change. Coupled with that is the sometimes indignant, sometimes pleading, sometimes whining argument that developing countries whose contribution to worldwide emissions is minuscule, suffer the most. This flies in the face of the oft heard admonition that it is impossible to tie one weather event to climate change.

Third, the creation of the fund was marked by strenuous efforts by two major emitters, China and India to escape any responsibility or obligation to mitigate the damage suffered by smaller developing countries.

On this point, India and China both sought to temper the language regarding creation of the fund so as to allow them to avoid being called to account for actually paying anything into it. India insisted that it too is a victim of emissions and that historical cumulative emissions should inform the process of who pays rather than singling out today's top polluters. China which has long hid under the canopy of developing nations, now wants to remain in that category and ignore the fact that it is the world's largest greenhouse gas emitter and continues to build coal plants apace.

In the final analysis, the so-called fund is a chimera.

And finally, what of the goal to limit temperature rise to 1.5°C? Well, we were told that without a dramatic reduction in the use of fossil fuels, and a sea change in how we consume energy, we could not avoid a global temperature increase of 2°C. There you have it. Neither of these steps was taken.

In short, COP27 was a major cop out.

# China records its highest caseload since Covid pandemic started in 2019

China reported a record high in daily Covid-19 infections on Thursday as it imposed localised lockdowns in several cities including in Beijing and local authorities struggled to control the surging outbreak, given the promise of easing the controversial 'zero-Covid' strategy.

Mainland China reported more than 31,600 Covid infections for Wednesday, the highest daily number since the pandemic broke out in the central city of Wuhan in late 2019, surpassing the 29,317 high logged in April during the Shanghai outbreak.

The total caseload since November 1 now stands over 310,000, a surge that has left city governments across China struggling and searching for ways to curb the spread, reports Hindustan Times.

Beijing recorded over 1600 fresh Covid-19 cases for Wednesday, the third consecutive day of 1000 plus

cases, and one death related to the infection, taking the toll to six in the ongoing outbreak.

Several more areas in Beijing were put under targeted lockdowns on Thursday as city authorities attempted to cut transmission chains.

Beijing has converted an exhibition centre into a makeshift hospital to cater to Covid-19 patients, numbers

of which are expected to increase in the coming days.

The city has already closed shopping malls, restaurants, and office buildings and suspended access to many apartment compounds and especially in the worst-hit Chaoyang district, the most populous one in the city.

The large cities of Guangzhou in south China and Chongqing in the southwest of the country continued to log more than half of the mainland's cases and continued to implement various kinds of restrictions within city limits.

While China's count of Covid-19 cases and fatalities remains low, the sharpest surge in numbers since the pandemic started is expected to slow down even the gradual withdrawal of Beijing's 'zero-Covid' policy, which has led to simmering frustration among citizens and dampened the economy.

Meanwhile, the tension between workers and security personnel at the world's largest iPhone factory in central China's Zhengzhou city continued on Thursday, a day after the two groups clashed over Covid-19 restrictions and working conditions.

### Dubai 'hypertower' will be the world's tallest residential structure

Burj Binghatti Jacob & Co Residences, the newest skyscraper in Dubai and so-called "hypertower," is slated to become the world's tallest residential structure in the world. The 100-storey structure is situated in Dubai's Business Bay and was specifically constructed to set the record for being the tallest residential building.

"The skyscraper will feature the most lavish penthouses at the highest altitude of the hypertower," the Binghatti Developers' official Facebook page stated. "Our collaboration with Jacob & Co on this architectural tourde-force reflects our commitment towards marking a globally groundbreaking feat for Binghatti," it further said.



The luxury jewellery and watch company Jacob & Co has partnered with Binghatti Developers, a major player in the real estate industry, for the project, reports Hindustan Times.

The structure will surpass New York's Central Park Tower, the tallest residential building in the world at 472.4 metres.

The Princess Tower, which is 414 metres tall, and 23 Marina, which is 392.75 metres high, are the other structures that fit into the same category, according to the Gulf News

According to a New York Post report, the building has opulent two- and three-bedroom residences. A dedicated concierge team, offering a la carte services like daycare, a bodyguard, a chauffeur, and a private chef, was also mentioned in relation to the building.

The report added that the tower will house an "exclusive private club" with an infinity pool and a sizable lounge area.

## **Anwar Ibrahim becomes Malaysia PM after decades of waiting**

Veteran opposition leader Anwar Ibrahim will finally become Malaysia's prime minister, capping a tumultuous political career that veered from coming close to clinching the top job on more than one occasion to spending years in prison on sodomy charges, reports Bloomberg.

Anwar's reformist Pakatan Harapan will lead the next government after being chosen by King Sultan Abdullah Sultan Ahmad Shah, the palace said in a statement. The monarch intervened after no alliance secured a majority in a general election Saturday in which Anwar's coalition won the most seats.

### King Charles talks of 'profound sorrow' of colonialism

King Charles III said that Britain acknowledges "the wrongs which have shaped our past" in his first major speech ahead of a state banquet he hosted as the country's monarch. At a banquet at Buckingham Palace, King Charles delivered an address to his guest of honour, South African president Cyril Ramaphosa, and other attendees.

In his speech, King Charles talked on Britain's colonial history with South Africa, aspects of which



he said "provoked profound sorrow", he said.

"While there are elements of that history which provoke profound sorrow, it is essential that we seek to understand them. As I said to Commonwealth leaders earlier this year, we must acknowledge the wrongs which have shaped our past if we are to unlock the power of our

common future," King Charles said.

South African president Ramaphosa was seen gently nodding his head during the speech. King Charles also mentioned the Commonwealth, of which South Africa is one of the state members. South Africa, he said, "like the Commonwealth, has always been a part of my life".

Last year, Charles denounced the "appalling atrocity of slavery, which forever stains our history" in a speech given in Barbados.

The state banquet saw Kate Middleton, Princess of Wales, Sophie, Countess of Wessex, and Queen Consort Camilla in attendance.

### Iran team may face arrest for not singing national anthem at FIFA match

Members of the Iranian football team who stood silent during the playing of their country's national anthem prior to their FIFA World Cup match against England could face consequences back home, a report said.

The Iranian team chose not to sing their own national anthem as fans from the country also supported their stand with signs inside the Khalifa International Stadium in Doha in Qatar that read "Freedom for Iran" and "Woman, Life, Freedom" in support of the massive protests that have rocked the country. Demonstrations sparked in Iran following the death of 22-year-old Kurdish Mahsa Amini while in police custody for not wearing hijab properly.



David E. Guinn, a University of Albany research professor of international law and human rights, told Newsweek that not only the Iranian players but their families "could face significant consequences including detention and/or arrest" because of their stand in the match, reports Reuters.

### **World's most expensive drug** worth \$3.5 million a dose approved hemophilia

TS regulators approved CSL Behring's Hemgenixhemophilia B gene therapy worth \$3.5 million a dose, making it the world's most expensive drug, reports Hindustan Times.

Here are five points to know about the new drug:

- 1. Hemgenix works by delivering a gene that can produce the missing clotting factors into the liver, where it starts working to make the Factor IX protein.
- 2. A study of the therapy found that just a single administration of the drug cuts the number of bleeding events expected over the course of a year by 54%.
- 3. The drug can also free 94% of patients from timeconsuming and costly infusions of Factor IX, which is currently used to control the potentially deadly condition.
- 4. The gene therapy will be manufactured in Lexington, Massachusetts, by uniQure NV, which sold the commercialization rights for Hemgenix to CSL Behring in 2020.
- 5. Speaking on whether the costly drug will be a hit, Brad Loncar, a biotechnology investor said "While the price is a little higher than expected, I do think it has a chance of being successful because existing drugs are also very expensive and hemophilia patients constantly live in fear of bleeds. A gene therapy product will be appealing to some."

What is hemophilia? According to the NHS, hemophilia is a rare condition that affects the blood's ability to clot. It's usually inherited. Most people who have it are male. People with hemophilia do not have as many clotting factors as they should have in their blood. This means they bleed for longer than usual.

## **Elon Musk holds Twitter** poll for 'general amnesty' of suspended accounts

ays after reinstating former US President Donald Trump's account following a Twitter poll, Elon Musk held another poll to gauge public opinion on "general amnesty." The new Twitter owner held a poll asking users whether all suspended accounts that "have not broken the law or engaged in egregious spam" should be restored.

"Should Twitter offer a general amnesty to suspended accounts, provided that they have not broken the law or engaged in egregious spam?" the tech billionaire asked, with options to vote either yes or no.

The results of the poll survey, which has a 24 hours window, will be out on November 25, 202.

### Just to sit with Meghan, Harry, guests at award ceremony have to pay \$1million

eghan Markle and Prince Harry won the prestigious Robert F. Kennedy Ripple of Hope Award for taking a stand against racism in the royal family. The couple are set to attend the awards ceremony in New York next month with tickets priced up to £840,000 for guests who want to sit at the main table with the Sussexes, reports Hindustan Times.

Royal author Angela Levin said that the couple are "getting too big for their ambitions" as TalkTV presenter Mike Graham said, "If you wish to go and sit with them at the Ripple of Hope gala in New York on December 6, it will only cost \$1million."

"I hope they're getting too big for their ambitions and it will all go pop. I think we've all had enough really," Angela Levin said.

The award honours Prince Harry and Meghan Markle's stand against the royal family when they accused a member of the royal family of racism in their bombshell interview with Oprah Winfrey. They had claimed that a senior royal made a comment about the



skin colour of their then unborn son Archie

Prince William later defended the royal family saying, "We are very much not a racist family".

John F Kennedy's niece Kerry Kennedy, who is set to host the awards, said that she believed Meghan Markle and Prince Harry took a brave stance against the royals.

### **Bruce Lee's death caused by** drinking too much water, new **study says**

rartial arts legend Bruce Lee may have died from drinking too much water, a study reported by Sky News suggested. Bruce Lee passed away aged 32 in Hong Kong in July 1973. The autopsy showed that he died from cerebral oedema, or brain swelling, which was thought to be a reaction to a painkiller he had taken.

But since his death, several theories have been put forward including assassination by Chinese gangsters or that he died from heatstroke.

However, researchers have now suggested that the oedema which killed him may have been brought on by hyponatraemia, reports Hindustan Times.

"In other words, we propose that the kidney's inability to excrete excess water killed Bruce Lee," the team of researchers wrote in the Clinical kidney journal adding that several factors suggest he had been consuming high quantities of water, such as his wife Linda referring to a fluid-based diet and his biographer, Matthew Polly, repeatedly referring to water intake on the day of his death.



Bruce Lee also used cannabis, which causes increase in thirst, and is known to have taken the drug throughout the day he died.

"In conclusion, we hypothesize that Bruce Lee died from a specific form of kidney dysfunction: the inability to excrete enough water to maintain water homeostasis, which is mainly a tubular function," the researchers said.

"This may lead to hyponatraemia, cerebral oedema and death within hours if excess water intake is not matched by water excretion in urine, which is in line with the timeline of Lee's demise. The fact that we are 60% water does not protect us from the potentially lethal consequences of drinking water at a faster rate than our kidneys can excrete excess water. Ironically, Lee made famous the quote 'Be water my friend', but excess water appears to have ultimately killed him," they added.

Earlier, Musk had run an online poll asking Twitter users whether Trump's account should be reinstated on the micro-blogging platform. In the poll that received 15,085,458 votes, 51.8 per cent voted yes and 48.2 per cent were against it.

# The World Cup in Qatar – 4 things to know

Migrant workers' rights are indeed an ongoing issue in Qatar – but the country has passed reforms to improve workers' rights, and it isn't the only issue to define Qatar

world Cup on Nov. 20, 2022, soccer teams from 32 countries and tens of thousands of fans have converged on Qatar, a tiny Arab country on a peninsula in the Persian Gulf. But search "Qatar 2022" online, and the first nonsport results are about the country's human rights issues.

Like its fellow oil-rich Arab countries, Qatar has enjoyed immense wealth that nurtured grand ambitions of economic growth among rulers and citizens alike. Qatar and its neighbours, including Bahrain and the United Arab Emirates, have brought in millions of workers from other countries to support their fast-growing cities and businesses over the past few decades.

In particular, about 30,000 workers came from Bangladesh, India and Nepal to construct the World Cup stadiums. At least 37 died, according to official Qatari counts, while building the US\$220 billion infrastructure for the games.

I am a political scientist and legal scholar of the Middle East who has lived and worked in Qatar. Given the sudden media focus on the country, I think it helpful for both World Cup fans and people who don't know a soccer ball from a hockey puck to understand four aspects of Qatar's politics that relate to its human rights challenges.

#### 1. Qatar is ruled by a popular king

A sparsely populated country in a desert, Qatar gained independence from Great Britain in 1971. With its large oil and natural gas reserves, Qatar has the highest income per citizen in the world.

Qatar's ruler is popular among citizens. Sheikh Tamim bin Hamad Al Thani is part a family dynasty that has run the area's politics since the 1800s, even under Ottoman and British control. This makes Qatar one of eight Arab countries governed by hereditary kings.

Hereditary ruling monarchies may seem archaic to people living in societies with elected leaders. Yet these systems have held onto power, outlasting the Arab uprisings of 2011. The lack of democracy in Arab countries is also part of a broader trend, as autocratic go-



vernments are generally on the rise globally.

## 2. Yes – workers' rights have been a problem

Doha, the capital of Qatar, has become a major media, educational, diplomatic and recreational hub over the past few decades. Its breakneck development also required workers from all over the world. As a result, foreign workers make up about 85% of the country's total population, but they do not have the same rights as Qatari citizens. Qatari natives have been reluctant to share their extraordinary social welfare benefits, like free medical care, with millions of workers from abroad. This makes for a system that gives many more rights to Qatari nationals than the millions of others who live there.

Unusual, rapid growth like Qatar's is a magnet for foreign contract workers worldwide. I enjoyed my opportunity to work there myself as a visiting professor and Fulbright scholar 15 years ago. Yet less privileged foreign workers can fare badly.

In Qatar and its oil-rich peers, control by a minority of citizens over millions of workers with fewer rights leads to discrimination and abuse. Human rights groups, journalists and migrant workers themselves have sought to change harmful workplace practices, such as withholding wages and forbidding unions.

Qatar's summer heat, averaging 106 degrees Fahrenheit (41 degrees Celsius), can make working conditions especially dangerous for outside construction workers. Since it is hard to know whether the alleged worker deaths are due specifically to bad working conditions, work-related issues, or something else, exact mortality numbers have been disputed and may be prone to exaggeration. Yet no one doubts that conditions have been terrible for many of Qatar's most vulnerable workers.

Other rights issues in Qatar have also attracted global attention. The conservative form of Islam that is part of Qatar's identity allows little tolerance for LGBTQ rights. Human rights groups have documented detentions and other routine discrimination against LGBTQ people.

#### 3. Yet Qatar has made major reforms

While workers' rights have received appropriate Western media attention, Qatar's direct efforts to respond to local and international activism are less known. Qatar enacted the most significant labour rights reforms in the Arab world in 2021.

Working with the International Labour Organization, a United Nations agency that promotes fair and decent work worldwide, Qatar instituted a minimum wage of \$275 per month, along with allowances for food and lodging. It also prohibited outdoor work during the peak of summer heat and eliminated many of the laws that gave employers control over their workers' basic freedoms to leave their job or the country.

Because the reforms are recent, it is hard to know whether they represent important steps forward or



incremental steps that will change little.

In any case, legislation in and of itself cannot remedy a complicated challenge involving a wide range of companies and other organizations that Qatar's government does not control. Whether Qatar can and will enforce the new regulations consistently is one concern.

Most foreign migrants arrive in Qatar through foreign-based recruitment companies, which charge them to secure jobs. So even if Qatar tries to curb labour abuses, recruitment companies based in migrants' countries of origin would still profit by charging workers expensive placement fees, for example. Such recruiters often work with multinational companies within Qatar to blunt the force of the kingdom's recent reforms.

## 4. And Western critiques may conceal other agendas

Qatari officials have suggested that international attention to foreign workers' conditions is part of a broader pattern of Westerners belittling Arabs.

Calls in some parts of Europe for a widespread World Cup boycott add fuel to this and other arguments that the European and American impression of Qatar is hypocritical. Though hardly a neutral observer, Gianni Infantino, the president of FIFA, which carries out the World Cup, reflected many Gulf Arabs' views when he argued that Europe's history of exploiting Middle Easterners and others gives it little moral high ground on issues of non-Western rights.

Because no Middle Eastern country had hosted the World Cup before 2022, Qatar's achievement is significant. The Economist argues that Qatar's responsiveness to pressures to improve its human rights climate may make it a more appropriate host for a global sporting event than other countries with poor human rights records, such as China or Russia.

Yet genuine global concern about rights in countries like Qatar and mistrust between the Middle East and the West will persist. Can new global awareness of Qatar lead to more nuanced understanding of both cross-cultural similarities and differences between Arab Islamic countries and the rest of the world? For the moment, this is as hard to know as which country will win the World Cup.

Mauritius Times: As we are just a few weeks away from the end of the year, what are your thoughts about how the country is doing generally and where we are heading?

Rajen Valayden: In January 2022, many of us thought it just couldn't be worse. Again, we were proved wrong. The invasion of Ukraine, which started as an issue of Russia's national security and Ukraine's sovereignty, finally took an awful turn and now has the allure of a cold war impacting on faraway households.

On the local front, we have reaped in 2022 the consequences of years of mismanagement and foolishness. The crumbling down of our institutions, the increasing number of our children falling prey to drugs and with mediocrity on a rampage, we are swirling into the abyss. On the environmental front, while most local issues remain unresolved, and COP 27 has been as usual under par.

#### \* What about the state of the economy itself?

At the very outset, 2022 has been clouded by considerable uncertainties. The Ukraine crisis teaming up with the third year of Covid-19 made life really hard for middle-income families and others down the ladder. Though output bounced back after a steep decline over the last two years, the depreciation of our currency and high prices of commodity have impacted immensely on the lives of our countrymen.

2022 has been the year where we have witnessed the dire consequences of income inequality. Prior to Covid, our economy already had its alarm lights flashing. By outsourcing the task of rethinking our economic model to a handful of economic operators, the government is not only abdicating its responsibility but also putting at risk the future of the country. These conglomerates are far from being bright benchmarks and serve their own private interests first and foremost.

\* The latest report of the Bank of Mauritius informs us that its reserves, which were around Rs 2.5 billion last September, have one month later

come down to less than Rs 1 billion. That does not augur well for the financial stability of the central bank, isn't it?

The latest Central Bank Survey report indicating the poor status of the Capital & Reserves has sparked an unprecedented flow of reactions on all media platforms. Prior to Covid, I had affirmed from a common-sense point of view that the BOM would have to be recapitalised.

In all fairness, we should concur that the BOM has acted as a cushion in absorbing most of the Covid related shocks thereby avoiding a widespread trauma. Yet casting aside critics such as political interference, depreciation of the rupee, artificial bloating of assets, steep drop in Shareholder Reserve, manipulation of balance sheet, structure of MIC, etc., the most outrageous fact remains that the Central Bank acts as the coolie of a happy few.

While there is unanimity in the country on the extent on the rot, there seems to be a void when faced with the question of who's responsibility it is to take to task those running the institutions. Persisting along these lines will only get us closer to the brink of anarchy.

The political masters need to draw lessons from happenings abroad.

This perception rests on basically three assumptions: (i) the ethnic spread of the constituencies, (ii) the belief that people from the so-called "minority" communities live in urban areas, and (iii) these communities adhere mostly to today's main opposition parties.

A honest assessment would lead us to observe that there has been a shift since 2014. Every mainstream party has been cut down to size and can no longer claim to benefit from their traditional vote bank. There is no longer any such thing as an urban or a rural constituency. The voting behaviour of citizens has also changed and is extremely tough to decipher even when using granular data.

The MMM, which ruled undisputedly over towns such as Beau Bassin-Rose Hill, should be concerned by the constant loss of vote share in various wards. Though the campaign, should the elections be held, would revolve around national issues, we could see a record performance by non-traditional parties and independent candidates.

# Why bullying in politics is a matter of democracy

When civil servants and MPs can't speak up against ministers, they can't do their jobs properly.

ominic Raab, the UK's deputy prime minister, has become the latest figure in the government to be

accused of bullying. Bullying, harassment, and sexual misconduct are always serious matters. They can harm a victim's personal and professional development and wellbeing, and create cultures of fear and intimidation. In political contexts, however, they have effects beyond personal health and institutional welfare.

The impact of bullying in political institutions has the potential to undermine liberal democracy itself. It can distort political representation, decision-making and the implementation of policies that affect the lives of the public.

When ministers bully civil servants there are clear consequences for the quality of governance. Ministers rely on civil servants to get the work of government done – a breakdown in this trust can have significant implications for society. As a civil servant stated in response to the bullying allegations levelled at Raab:

It's shit for civil servants, but the overall culture is even shitter for the country.

Raab has denied these allegations.

The complaint that civil servants are vulnerable to bullying by ministers is a common one. Sir Gavin Williamson, former Cabinet Office minister, resigned at the beginning of November 2022 after denying allegations that he bullied civil servants and colleagues. The irony and potential hypocrisy involved in Williamson's recent lead in the government's anti-bullying campaign was not lost on the media, and his appointment resulted in reputational costs for Prime Minister Rishi Sunak.

In 2020 Priti Patel, the former home secretary, was also accused of bullying civil servants. Patel accepted

the findings of a Cabinet Office inquiry into her behaviour and apologised. The Home Office paid £370,000 to settle a tribunal over her conduct, ultimately costing the tax payer.

However, there are broader social harms inflicted by bullying. Intimidation inhibits the ability of civil servants to speak truth to power and act impartially, affecting how well government policy is both formulated and implemented.

#### **Bullying in parliament**

In March 2022, an independent expert panel found John Bercow, former speaker of the House of Commons, to be a "serial bully and a liar" in relation to his behaviour towards House of Commons staff. MP Christina Rees lost the Labour whip in October 2022 for alleged bullying of constituency staff.

And Boris Johnson's resignation as prime minister in July 2022 followed his handling of the Chris Pincher affair, when the deputy chief whip was accused of groping men. It emerged that Johnson had known about similar allegations but nevertheless appointed Pincher to a senior position of power and influence. Pincher subsequently quit as chief whip and apologised for his actions.

The power invested in the whips and its potential for abuse is well-known. In January 2022, William Wragg MP alleged that blackmail was being used by Conservative whips against his colleagues. And former Conservative MP Rory Stewart called the whole party system an "elective dictatorship", with whips engaging

in "blackmail and intimidation" to force party loyalty.

These tactics, while usually concealed within party machines, were highlighted in October 2022 during a "chaotic fracking vote", in which Conservative Party whips allegedly "bullied and manhandled" MPs into backing former prime minister Liz Truss.

#### Why it matters

Multiple investigations over the years have confirmed that these are not isolated incidents but part of a wider culture. The impact this culture has on the freedom of debate, the representation of views, the quality of decision-making and the shape of public policy is impossible to quantify.

However, it's clear that bullying can inhibit the ability of MPs and other parliamentary staff to represent their constituents and do their jobs effectively. Such behaviour is therefore a corrosive and even cor-

rupting force in the political life of Westminster.

While anyone can be a victim of bullying, it is clear that it affects some groups more severely than others. In a political context, this can lead to a lack of representation of those more likely to be exposed to bullying, by undermining their willingness or ability to participate.

Allegations about sexual harassment in Westminster are common and overwhelmingly affect women. There are long-standing rumours about lists of bullies and sexpests being circulated to new female MPs to help them avoid their advances. A culture that enables this kind of bullying can stymie the efforts and undermine the political aspirations of those subjected to it.

Despite earnest (if overdue) efforts, significant changes on paper, and some progress, institutional cultures interact with broader society and are notoriously difficult to change. Changing tolerance levels in parliament goes hand in hand with challenging tolerance for bullying and other forms of discrimination in society.

Evidence suggests that bullying has touched almost every kind of relationship in and around Westminster. This should alarm not only those concerned about the wellbeing of individuals but also those interested in the wellbeing of society, democracy, and our shared political future

To counter bullying will take time, humility, and a clear signal from the top that these behaviours are not only unacceptable and personally harmful but also corrode liberal democratic institutions and values.

# Choosing a Labour Candidate

Boundary Commission has reported, and the time of the postponed general election is but six months off, it may be of interest to learn how parliamentary constituencies in the UK get their candidates. As I can speak with personal knowledge only of the way in which Labour candi-

dates are chosen, I will confine my remarks to them; though I believe that the procedure is only slightly different (and then in detail only) as regards the Conservative and Liberal Parties.


First it is necessary to know how the Labour Party is organised. Throughout the country, it is organised on the basis of Constituency Parties (CLP for short). These CLPs are federations of trade union branches and individual members of the Party. In urban areas, the individual members are organised into Ward parties, each Ward being some convenient unit for local government election purposes. In rural areas, the individual members of the CLP are organised into local parties, based on villages or townships. When a candidate is wanted for an election, each trade union branch and ward — or local party is invited by the Executive Committee of the CLP to nominate possible candidates.

It depends on the constituency what response will be forthcoming to this invitation to nominate possible candidates. In constituencies where there is little chance of a Labour candidate being elected, people are put forward who have Parliamentary ambitions but who want the experience of fighting an election in a 'hopeless' constituency before going on to a better one. If there is a certainty, or a virtual certainty, that the Labour candidate will be elected, then often a well-known figure in the trade union world or in local Labour Party circles will be nominated

Once a candidate has been selected and elected to Parliament, he is a fixture in that constituency unless he chooses to go elsewhere.

Eventually the Executive Committee of the CLP will have received a number of nominations from its affiliated organisations (as the union branches and ward or local parties are called). On the Executive there will be representatives of the affiliated organisations. All the nominations will be discussed thoroughly; anyone who has personal knowledge of any of the nominees will be given particular attention when giving views on the suitability of that person for the constituency.

The Executive Committee will draw up, after its deliberations, a short list of nominated persons whom it wishes to interview for possible selection as the candidate. Usually, the short list will contain three names, sometimes four or five, but I have never known five to be exceeded or three to be fallen below. The short list of candidates will be interviewed not by the CLP Executive, but by the General Management Committee. The difference in these two bodies is that the Executive is much



smaller. The GMC has representatives of every affiliated organisation, each organisation (especially the ward or local parties) having representation according to size. The Executive, however, draws a limited number of members from the GMC; whereas the GMC may have a membership of a hundred or more, the Executive will seldom exceed 20 in number.

All possible candidates on the short list are invited to attend a meeting of the GMC. At this meeting every member of the GMC will be given a brief biography of the persons to appear before it. These biographies give an outline of the people's activities in the Labour and trade union movements; e.g., "GREGSON, Rex Michael, Age 25, Local Government Officer, Bachelor of Arts, Speaks 5 languages. Made first public speech at age 15 for Labour League of Youth and have since spoken for a variety of causes to audiences ranging from Labour Party branches to United States Air Force. Since joining the Party has held offices of Ward Secretary, Election Agent, CLP Social Secretary, delegate to Area Federation of CLP's and member of CLP Executive. Was President of University Union and has written pamphlets on the Middle East and North Africa. Member of North Paddington CLP and National Union of Public Employees."

The foregoing brief biography is of an imaginary person but is *based* on an actual biography which I saw in 1953.

The meeting at which the possible candidates are selected is known, naturally, as the Selection Confer-ence. In my time I have attended a number.

Each Interviewee is called before the GMC, usually in alphabetical order and has 10 minutes to speak, on any subject he chooses. Usually, he chooses either why he wants this particular constituency, or why he wants a constituency at all, or a pet topic on which he is particu-

larly fluent, or a quick *résumé* of his Socialist beliefs and an enlargement of his brief biography which everyone will have read

After his short speech, he has 10 or 15 minutes in which to answer any questions, on whatever subject, which anyone present may care to ask. Often the choice of candidate depends on how he answers these questions. Often, too, the questions may have little or nothing to do with Parliamentary constituency; e.g., at one selection conference I was asked "If you are selected as candidate, would you support the mayor's civic charities?" This was in a city over 120 miles from my home!

After each possible candidate has made his speech, and answered his questions, the GMC considers the performance of each. After discussion, which can go on a long time, they vote. Not by show of hands, but on ballot papers. The usual procedure is for everyone to vote for the person of his choice. The votes are counted. Failing a clear majority for any one candidate, a second vote is taken, this time leaving out of consideration the person who had fewest votes on the first ballot. If there are only three on the list, obviously only two ballots will be needed; more on the short list means more ballots. Finally, someone is declared to be the candidate with the most votes; and then the GMC formally votes that Mr Soand-so be the prospective candidate. This vote is usually unanimous. Mr So-and-so is then called into the room and told he is now the "prospective Parliamentary candidate for the X Division of Y-shire', and the meeting is over.

Until the date of the Parliamentary election is announced, and the candidates are formally nominated and their deposits of £150 paid, they must legally be referred to as 'prospective' Parliamentary candidates only. A person does not become a 'candidate' pure and simple (legally speaking) until he has been nominated on the prescribed form and has paid his deposit as by law demanded.

The choice of candidate in any constituency is therefore made democratically, and every member of the CLP has at some stage in the proceedings the opportunity to express his opinion about the choice of a prospective candidate. It may be only at the ward party meeting where the original invitation from the CLP Executive Committee is received and dealt with. It may be, if the member is active, at GMC level; even as a member of the CLP Executive itself. But the choice is democratically made, and no-one who is unsuccessful at a Selection Conference has any ground for complaint that undemocratic methods have been employed.

Selection conferences do not always have just local people before them. A conference in Leicester two years ago considered three possibles: two from different parts of London, one from Birmingham. In Birmingham in 1953, the possibles comprised one man from London, one from Rugby, and one from a different part of Birmingham.

So local choice and local organisation are the keynotes of Labour Party methods in the UK. The only thing that the Party does insist upon is that all potential candidates shall be (in addition, of course, as one would expect, to being paid-up members of their own CLP) members of their appropriate trade union.

# Why some people think fascism is the greatest expression of democracy ever invented

On the contrary, for Spann and others, society is a group whose members share the same attitudes, beliefs, desires, view of history, religion, language and so on. It is not a collective; it is more like what Spann describes as a "super-individual." And ordinary individuals are more like cells in a single large biological organism, not competing independent organisms important in themselves.

This sort of society could indeed be democratic. Democracy is intended to give effect to the will of the people, but it doesn't require that society be diverse and pluralistic. It does not tell us who "the people" are.

#### Who are the people?

According to fascists, only those who share the correct attributes can be part of "the people" and therefore true members of society. Others are outsiders, perhaps tolerated as guests if they respect their place and society feels generous. But outsiders have no right to be part of the democratic order: Their votes should not count.

This helps explain why Tucker Carlson claims "our democracy is no longer functioning," because so many nonwhites have the vote. It also helps explain why Carlson and others so vigorously promote the "great replacement theory," the idea that liberals are encouraging immigrants to come to the U.S. with the specific purpose of diluting the political power of "true" Americans.

The importance of seeing the people as an exclusive, privileged group, one that actually includes rather than is represented by the leader, is also at work when Trump denigrates Republicans who defy him, even in the smallest ways, as "Republicans in Name Only." The same is also true when other Republicans call for these "inhouse" critics to be cast out of the party, for to them any disloyalty is equivalent to defying the will of the people.

### How representative democracy is undemocratic

Ironically, it is all the checks and balances and the endless intermediate levels of representative government that fascists view as undemocratic. For all these do is interfere with the ability of the leader to give direct effect to the will of the people as they see it.

Here is Libyan dictator and Arab nationalist Moammar Gadhafi on this issue in 1975:

"Parliament is a misrepresentation of the people, and parliamentary systems are a false solution to the problem of democracy... A parliament is... in itself... undemocratic as democracy means the authority of the people and not an authority acting on their behalf."

In other words, to be democratic, a state does not need a legislature. All it needs is a leader.

#### How is the leader identified?

For the fascist, the leader is certainly not identified through elections. Elections are simply spectacles meant to announce the leader's embodiment of the will of the people to the world.

But the leader is supposed to be an extraordinary figure, larger than life. Such a person cannot be selected through something as pedestrian as an election. Instead,

the leader's identity must be gradually and naturally "revealed," like the unveiling of religious miracle, says Nazi theorist Carl Schmitt.

For Schmitt and others like him, then, these are the true hallmarks of a leader, one who embodies the will of the people: intense feeling expressed by supporters, large rallies, loyal followers, the consistent ability to demonstrate freedom from the norms that govern ordinary people, and decisiveness.

So when Trump claims "I am your voice" to howls of adoration, as happened at the 2016 Republican National Convention, this is supposed to be a sign that he is exceptional, part of the unity of nation-state and leader, and that he alone meets the above criteria for leadership. The same was true when Trump announced in 2020 that the nation is broken, saying "I alone can fix it." To some, this even suggests he is sent by God.

If people accept the above criteria for what identifies a

true leader, they can also understand why Trump claims he attracted bigger crowds than President Joe Biden when explaining why he could not have lost the 2020 presidential election. For, as Spann wrote a century earlier, "one should not count votes, but weigh them such that the best, not the majority prevails."

Besides, why should the mild preference of 51% prevail over the intense preference of the rest? Is not the latter more representative of the will of the people? These questions certainly sound like something Trump might ask, even though they are actually taken from Gadhafi again.

#### The duty of the individual

In a true fascist democracy, then, everyone is of one mind about everything of importance. Accordingly, everyone intuitively knows what the leader wants them to do.

It is therefore each person's responsibility, citizen or official, to "work towards the leader" without needing specific orders. Those who make mis-

takes will soon learn of it. But those who get it right will be rewarded many times over.

So argued Nazi politician Werner Willikens. And so, it appears, thought Trump when he demanded absolute loyalty and obedience from his administration officials.

But most importantly, according to their own words, so thought many of the insurrectionists on Jan. 6, 2021, when they tried to prevent the confirmation of Biden's election. And so Trump signalled when he subsequently promised to pardon the rioters.

With that, the harmonization of democracy and fascism is complete.

# Flu, RSV and Covid-19

Advice from family doctors on how to get through this 'tripledemic'

s community-based family doctors, we have been attending to patients who showed the early warning signs of the oncoming wave of our viral season. We are now in the middle of that wave: a "tripledemic" of RSV, influenza and Covid-19.

While much of the news coverage of this viral surge has focused on over-crowded emergency rooms and intensive care units, family physicians are an important front line of protection against serious illness.

We should remember that this wave of viruses hits us every year around this time, even though this appears to be a particularly bad wave of RSV and the flu. We don't yet know for sure why this wave is so much worse than recent years.

#### Observations by family doctors

Family doctors have learned important lessons through the Covid-19 pandemic that we need to apply during the current viral season.

First, the vast majority of viral infections will be mild to moderate in severity and can be managed by a family physician in an outpatient setting. Most children do not need to visit emergency rooms to seek care for viral infections.

Over the past month, our clinics have seen a surge of sick children presenting with RSV, the flu and other viruses. It has become more common to see fevers lasting longer than five days, ongoing coughs and superimposed lung and ear infections that require treatment.

In most cases, these conditions can be managed by a family physician. In a small number of cases, we reach out to our pediatric emergency colleagues to let them know a child is on their way for assessment and further management.

Second, patients should continue to seek medical care from a family doctor if they have a health concern, despite the presence of new or returning viruses. Throughout the pandemic, we have seen countless numbers of patients who delayed seeking care for serious health problems. These patients missed crucial time needed to diagnose and treat their conditions in a timely manner.

Patients should continue to see their family doctors to seek advice or treatment for a health condition, including guidance on concerning viral symptoms.

Third, we are also observing the ongoing and significant harm caused to children and young people by prolonged periods of social isolation. We are also seeing the impact of excessive screen time and social media on many of our young patients

Accepting or imposing repeated limitations on social contact has consequences in the form of depression and anxiety. While some vulnerable people may try to avoid crowd settings during the viral season, many of our patients — especially younger ones — need to continue to find safe ways to expand and deepen their social contact with others, rather than limit it further.

Finally, vaccination is an excellent protective measure against severe illness. And

masks can help to limit transmission. COVID-19 booster shots are widely available and recommended for those over five years old. Those over 12 years old can receive the bivalent booster, which offers more protection against the omicron va-

The flu vaccine can be given at the same time. It is strongly recommended for children ages six months and older. Masking indoors has now been recom-

mended by the Chief Medical Officer of Health for Ontario, to help reduce transmission for those that are symptomatic and to protect those who are vulnerable to serious illness as a result of contracting RSV, the flu or COVID-19.

### Supporting through the next wave

As we all push through another wave of illness, along with the pressures imposed on families, education systems and the healthcare sector, we can draw on the insights that family doctors have gained from the Covid-19 pandemic.

We can be mindful of our responsibility to protect our most vulnerable by getting vaccinated, staying at home when we aren't feeling well, and making responsible use of our medical system.

Family doctors are there to support our patients' health, attend to chronic disease management and provide advice and direction — especially in the case of viral infections. We are there to help our patients get through this viral wave and onto the other side.

By nature, human beings are social creatures. Yet, as we age, personal dynamics and lifestyles change, which can result in loneliness and isolation. With older adults increasingly moving into senior living or retirement communities, researchers at University of California San Diego School of Medicine sought to identify the common characteristics of residents who feel lonely in these environments.

"Loneliness rivals smoking and obesity in its impact on shortening longevity," said senior author Dilip V. Jeste, MD, Distinguished Prof of Psychiatry and Neurosciences at UC San Diego School of Medicine. "It is a growing public health concern."

The new study, published online in the issue of 'Aging and Mental Health', found that people's experience of living with loneliness is shaped by a number of personal and environmental factors.

Researchers conducted one-and-a-half-hour individual interviews of 30 adults ages 67 to 92, part of an overall study evaluating the physical, mental and cognitive functions of 100 older adults living in the independent living sector of a senior housing community in San Diego.

In this communal setting, 85 percent of the residents reported moderate to severe levels of loneliness.



"Different people feel lonely for different reasons despite having opportunities and resources for socialization. This is not a one size fits all topic," said Jeste.

Three main themes emerged from the study:

Age-associated losses and inadequate social skills were considered to be primary risk factors for loneliness. "Some residents talked about the loss of spouses, siblings and friends as the cause of their loneliness. Others mentioned how making new friends in a senior community cannot replace deceased friends they grew up with," said first author Alejandra Paredes, a research fellow in the Department of Psychiatry at UC San Diego School of Medicine.

The feeling of loneliness was frequently associated with a lack of purpose in life. "We heard powerful comments like, 'It's kind of gray and incarcerating," said Jeste. "Others expressed a sense of 'not being attached, not having very much meaning and not feeling very hopeful' or 'being lost and not having control."

The research team also found that wisdom, including compassion, seemed to be a factor that prevented loneliness. "One participant spoke of a technique she had used for years, saying 'if you're feeling lonely, then go out and do something for somebody else.' That's proactive," said

Other protective factors were acceptance of aging and comfort with being alone. "One resident told us, 'I've accepted the aging process. I'm not afraid of it. I used to climb mountains. I want to keep moving, even if I have to crawl. I have to be realistic about getting older, but I consider and accept life as a transition," Jeste noted. "Another resident responded, 'I may feel alone, but that doesn't mean I'm lonely. I'm proud I can live by myself.

### How and why resistance training is imperative for older adults

For many older adults, resistance training may not be part of their daily routine, but a new position statement suggests it is vital to improving their health and longevity.

"When you poll people on if they want to live to 100 years old, few will respond with a 'yes'," says Maren Fragala, Ph.D., director of scientific affairs at Quest Diagnostics and lead author of the position statement, which highlights the benefits of strength and resistance training in older adults for healthier aging.

"The reason mainly being that many people associate advanced age with physical and cognitive decline, loss of independence and poor quality of life," adds Mark Peterson, Ph.D., M.S., FACSM, an associate Prof of physical medicine and rehabilitation at Michigan Medicine.

"Aging, even in the absence of chronic disease, is associated with a variety of biological changes that can contribute to decreases in skeletal muscle mass, strength and function," Fragala says. "Such losses decrease physiologic resilience and increase vulnerability to catastrophic events."

She adds, "The exciting part about this position statement is that it provides evidence-based recommendations for resistance training in older adults to promote health and functional benefits, while preventing and minimizing fears."

Fragala adds that the benefits of participating in resistance training as an older adult outweigh the risks

"The coauthors of this paper and the hundreds of other prolific researchers whose work we synthesized in this position statement have found that in most cases, the vast benefits of resistance training largely outweigh the risks when training is properly implemented," Fragala



### **Curious** How many galaxies are there in the universe?

Many galaxies are too faint or small for us to observe easily – but science can help us work it out.

galaxy is a massive collection of gas, Adust and billions of stars all bound together by the force of gravity. Galaxies are also huge, measuring billions of billions of kilometres across.

To properly understand what a galaxy is, we should start by looking at our own Milky Way galaxy.

Our Sun is just one star out of billions of other stars contained within a galaxy called the Milky Way. In the same way that the Earth orbits the Sun, the Sun also orbits the Milky Way's centre.

When we look up at the night sky, the stars we can see with our eyes are all part of the Milky Way. If you've been outside on a really clear, dark night, you may have noticed a thin fuzzy band of stars and light stretching across the sky. This is our Milky Way galaxy viewed from the inside out. We see a thin line because our galaxy is shaped like a thin disk, and we're looking at the edge of the disk.

If we look towards the centre of this disk, we see a brighter region called the galactic core. Stars in the core are grouped much closer together, and form a shape that looks like a ball that peeks out



from the top and bottom of the disk.

By mapping the positions and motions of the stars in the Milky Way, we can start to build a picture of what our galaxy might look like if we could look down on the disk from above. The overall shape would be a

We would see the bright core, which would look reddish-yellow, as the stars here are cooler. Winding out from that core would be a number of spiral arms, bluish in colour because they contain hotter stars. The Milky Way would look a little like a whirlpool.

#### Beyond the Milky Way

Astronomers are confident that our Milky Way has spiral arms because we see lots of other galaxies like it when we look out into the universe. Most other galaxies that are thin disks similar to our Milky Way also have winding spiral arms. We call these spiral galaxies.

Not every galaxy looks this way, though. Some of the other galaxies we see in the universe look like smooth, fuzzy ovals of light, something between the shape of a basketball and a rugby ball. We call these elliptical galaxies, and they are mostly made up of cooler, redder stars. There are also galaxies that don't have any particular shape at all. These are called irregular galaxies.

Working out how many galaxies there are in the universe is actually pretty difficult. Many galaxies are too faint or small for us to observe easily, even with the most powerful telescopes. Despite this, astronomers came up with a clever way of working this out. Astronomers pointed the Hubble space telescope at a tiny patch of the sky for 11.3 days and collected the light from galaxies that are both nearby and very distant.

This tiny patch of sky was full of galaxies, almost 10,000, of all different sizes and shapes. By multiplying this number by the number of times this tiny patch of sky would fit into the entire sky, astronomers came up with an estimate of between about 100 and 200 billion galaxies. This number will almost definitely change, though, as we learn more about our universe in the future.



The priest nodded wisely and with sympathy. 'Son,' he said, 'that's the problem with most people, you can't tell the difference between a simple blessing and last rites.'


#### The Wife's Math

### **Surprising things that lead** to heart disease

What is heart disease? It's a group of conditions related to your heart. Some are problems with the muscle itself, the valves, or how it beats, including cardiomyopathy, atrial fibrillation, and heart failure. Others affect your blood vessels, like hardened arteries and strokes. Unhealthy foods, lack of exercise, and smoking are often what lead to heart disease. So can high blood pressure, infections, and birth defects. But other things might surprise you.

Cars, Planes, and Trains: Starting at around 50 decibels -- between the volume of a refrigerator humming and a friendly chat -- traffic noise can raise your blood pressure and the likelihood of heart failure. For each 10-decibel increase, your odds of heart disease and stroke go up even more. Scientists think it's tied to how your body reacts to stress.

Migraine: We're not sure why, but you're more likely to have a stroke, chest pain, and heart attacks when you get migraines, especially with auras. And if heart disease runs in your family or you've had heart problems or a stroke, you may not want to take medicines called triptans for your migraines because they narrow your blood vessels. Check with your doctor about the best way to control and treat your headaches.

Kids: Parents have a greater chance of getting heart disease, and the odds go up slightly with each child. Because that's true for both sexes, biology probably isn't

But women who get their first period before they're 12 or stop having periods before they're 47 are more likely to have a stroke as well as heart disease. Women's risk also



goes up if they have had a miscarriage or had their ovaries or uterus removed.

Loneliness: Having few friends or being unhappy with your relationships raises your odds of heart disease and stroke by about as much as second-hand smoke does. Feeling alone has been linked to high blood pressure and other effects of stress. So join a recreational sports team or your neighbourhood walking group. You'll get both exercise and a stronger social network -- a twofer to prevent heart disease.

Long hours at work: More people who work at least 55 hours per week have heart disease than those who work 35-40 hours. That could be the result of a number of things: more stress, more sitting, perhaps drinking more alcohol, for example. You may brush off signs of trouble and put off seeing your doctor. If you tend to stay late, it's especially important for you to take care of yourself to avoid heart disease and stroke.

Gum disease: Bacteria from your mouth, including periodontal disease, can get into your blood and set off inflammation in the lining of your arteries, which can lead to fatty buildup in them (atherosclerosis). Research shows that treating gum disease can lower the level of an inflammation marker called C-reactive protein in your blood. Doctors use this measurement, along with your cholesterol levels, to predict "cardiac events" like a heart

Troubled Childhood: Things like violence, bullying, and abuse when you were younger -- including seeing harm done to others -- have been linked to high blood pressure, obesity, and type 2 diabetes in adults. And these health problems give you a greater chance for heart disease. The ongoing stress early in life can change how your body works. You may also be dealing in unhealthy ways with the effects of feeling unsafe while arowina up.

You've got the flu: A 2018 study found that people ended up in the hospital with a heart attack six times more often in the week after they were diagnosed with influenza than in the year before and after. Doctors aren't sure why. It may be that when you're fighting an infection, your blood gets more sticky and clots more easily. It may have something to do with inflammation. (And there's another reason to get a flu shot.)

A short fuse: You're almost five times more likely to have a heart attack after you've been furious. In the 2 hours after an outburst of rage, the chance of a stroke or racing heartbeat goes up, too. You can't always avoid or control what sets you off, so find a way to deal with your anger in the moment and cool that fire. If it happens often, consider an anger management class or therapy to lower your long-term risk of heart trouble.







# **Domestic Violence. Any sign of sanity?**


If we go by police reports, a week without crime is hardly a cause for celebration. The worrying question that pops up is: Who is going to be the next victim? Among thousands of couples in this country, somewhere a male is

accumulating toxic loads of aggressiveness and might go berserk any time and take out a knife to resolve long-held frustrations and conflicts with his partner.

Call it woman slaughter, or 'feminicide', as the feminist movement #MeToo rightly emphasizes in France, it is an issue that boils down to women getting killed because they are women. Last week a man stabbed his wife during a guarrel in a supermarket, he then killed himself. Fortunately, she had a narrow escape from death. This week a police officer thought it cool to film himself shouting and yelling at his former partner before killing her. Videos of just anything have become a trend everywhere, and often used without any discernment. Let alone by men who lose all self-control and are no longer capable of calm and rational thinking, which is the very essence of being.

There is plenty of subject matter for local feminists and journalists to write about on International Women's Day and in fact all year round about the horrendous treatment being meted out to women here as elsewhere. One recent and most gruesome murder of a 27-year-oldyoung woman, Shraada, in India, by her live-in partner Aftab hit the headlines and sent shockwaves across that country. The man strangled her, drained all her blood in the bathroom, cut her body into 35 pieces while taking a break to smoke and drink beer all along that horrendous act.

He put all the pieces and the beheaded head of the victim in the




fridge, looked at her face every day and invited other women to his apartment before scattering the 35 bags in all corners of Delhi. He took care to have a selfie at the start of the criminal task he set himself to commit. A psychiatrist describes him as a pervert who feels that he has the right to deliver justice himself to get rid of his partner who wanted him to get into a proper marriage. For the victim, it is a tragic case of online dating and elopement against her parents' consent.

A repetition of crime against women should not be taken as a banal issue. Official statistics may inform us whether domestic crime has gone unabated over past years or whether it is declining. The good news is that prisoners are taking up music and art classes to develop the positive aspects of their nature.

Why wait for men to be in jail to think about making them more civilized? The point is more what is there in the upbringing of men that makes them think and act like men, not like human beings?

At the end of the day, it all boils down to relationships based on expectations. What we expect from our partners with regard to their relationships? How does romance go awry when one partner does not fit into the picture the other built up of him or her?

There is a deep need for philosophy



in our society, as in many other countries. Is it alright to expect things like fidelity and trust from others? Is it akin to colonizing other people's minds and enslaving them? Are these requirements conditional for a good relationship? Or should we rather focus on doing what is righteous and be good human beings, or being humans as much as we can, and a harmonious relationship with trust and loyalty will naturally ensue without you expecting it?

Philosophy is about asking questions, using your brains and promoting reason. What we observe is there is neither music, art or philosophy in everyday life to promote common sense, logic, sensibility and sensitivity across the country. This is not an era for enslavement. Nobody is your slave and nobody is going to go down on their knees to fulfill your desires and satisfy your ego.

If ever there is the will to bring back some degree of sanity in the way we interact with others, a great deal of attention needs to be given to bring philosophy to the people.

# Simplifying Your Schedule
