## Trusts, corruption, and money-laundering

Any of us at some time or other may have come across a requirement to specify the beneficiary owner or ultimate beneficiary of some company/société, and banks to have a Know Your Customer (KYC) requirement, it seems, to abide by corporate governance legislation. Non-charitable Trusts on the other hand are structures that seem wholly impervious, secretive and above such governance considerations. There are many valid reasons notaries and legal specialists find Trusts, which operate in Mauritius under the 2001 enacted legislation, very useful instruments for their generally wealthy clients: management of family wealth over generations, tax and succession planning, inheritance tax issues, asset protection and confidentiality for instance.

Those very features of confidentiality and secrecy are also powerful adjuncts in the marketing of the Mauritius financial jurisdiction by talented Assets Managers and other finance professionals, local or expatriate, but this aspect need not concern us unduly here. What may concern the financial and legal community, at a time when other types of structures are subject to good governance scrutiny, is whether Trusts should continue to operate under the cloak of total secrecy, without even a minimum need to register anywhere with any regulatory body. And what if there are good grounds by competent investigative agencies to believe that a trust may have been set up or may be used to hide or protect proceeds of a corrupt or an unlawful activity?

The question is not merely rhetorical for several reasons but obviously as laymen we can only suggest that legal and financial minds pore over the issues in the light of growing worldwide demands for greater transparency, less corruption and better governance.

Trusts were prime vehicles in the notorious Pandora Papers financial scams, while Russian and Ukrainian oligarchs have recently been found to have an avid appetite for trusts and their layers of complex ownership structures to hide massive amounts of luxury properties and assets suspected to have been unlawfully or criminally acquired. Under current local or international trust secrecy laws, authorities rarely even bother to scan or prioritise them in any investigation.

As the country painfully got out of the Financial Action Task Force/Eastern and Southern Africa Anti-Money Laundering Group (FATF/ESAMLAG) grey list and the EU blacklist, we mentioned then that those institutions, including the IMF and the EU, would be upgrading their sights to address the elephant in the room, that is, massive money-laundering generated through high-level corruption, something that took even greater prominence during the Pandemic as we know.

In 2022, FATF Ministers highlighted the serious impact of grand and systemic corruption on economies and societies, as well as impeding the effective implementation of the FATF Standards. Encouragingly therefore, both the FATF and the EU are now pressing for countries to apply greater transparency rules and are explicitly telling them that they need at least to set up a national register of Trusts and to record such necessary beneficiary information that would limit the scope for abusing trusts towards corruption and other financial crimes.

As we prepare for that next level, our legal/financial professionals and the concerned Ministry should have started assessing what changes might well be needed to our twenty-year-old trust legislation.

## How Al could take over elections – and undermine democracy

Artificial intelligence looks like a political campaign manager's dream because it could tune its persuasion efforts to millions of people individually – but it could be a nightmare for democracy.



ould organizations use artificial intelligence language models such as ChatGPT to induce voters to behave in specific ways?

Sen. Josh Hawley asked OpenAl CEO Sam Altman this question in a May 16, 2023, U.S. Senate hearing on artificial intelligence. Altman replied that he was indeed concerned that some people might use language models to manipulate, persuade and engage in one-on-one interactions with voters.

Altman did not elaborate, but he might have had something like this scenario in mind. Imagine that soon, political technologists develop a machine called Clogger – a political campaign in a black box. Clogger relentlessly pursues just one objective: to maximize the chances that its candidate – the campaign that buys the services of Clogger Inc. – prevails in an election.

While platforms like Facebook, Twitter and YouTube use forms of AI to get users to spend more time on their sites, Clogger's AI would have a different objective: to change people's voting behaviour. How Clogger would work

As a political scientist and a legal scholar who study the intersection of technology and democracy, we believe that something like Clogger could use automation to dramatically increase the scale and potentially the effectiveness of behavior manipulation and microtargeting techniques that political campaigns have used since the early 2000s. Just as advertisers use your browsing and social media history to individually target commercial and political ads now, Clogger would pay attention to you – and hundreds of millions of other voters – individually.

Third, over the course of a campaign, Clogger's messages could evolve in order to take into account your responses to the machine's prior dispatches and what it has learned about changing others' minds.

## The Lighter Notes of the 2023-24 Budget

The national budget will have been amply analyzed and screened by both economists and those who sought signs of electoral populism that might indicate the proximity of general elections. We will not add more floss to the debates if only to select and highlight a couple of more curious measures, some posited as boldly innovative.

Of that category, undoubtedly the proposal to pull down the 10-storey Emmanuel Anquetil Building in the heart of the capital in favour of a ground level «mini tropical forest» of a few hundred sq metres must hold pride of place!

It must be said that the Soviet-style architectural bunker is not particularly attractive, but one cannot doubt its utter engineering solidity that did not seem to call for drastic demolition.

We learned from this Thursday's PNQ in Parliament from Minister Hurreeram, that a 2016 report seems to have highlighted the prohibitive costs of demolition as opposed to other alternatives of refurbishment. And that this budgetary measure, which must have received Cabinet's blessing, was merely a proposal that would require full-fledged technical stu-dies before it could even be entertained, and a decision taken. His Cabinet colleagues, and Finance, in particular, must have gulped hard at such brazen admission of what sounds like giddy light-headedness.

En passant, its pull-down may well require dynamite by an experienced pro-

fessional team, that would be a first in our annals! But not being from Port-Louis, either for home or work, we can only marvel at the picture of a variety of tropical animals, land tortoises, stags, crocodiles, or macaques on display for our capital's lucky inhabitants and, added Minister Bobby Hurreeram, flocking tourists! Enough to digest what has been perpetrated at the venerable Champ de Mars, a few hundred metres away?

The second measure that showed the Minister in his bolder, more creative, attire, is the one-off grant of Rs 20 thousand rupees promised to all 15,000 of our youths attaining 18 years of age during the coming year. Honestly, I don't think anybody saw such forthright «goodie» populism coming to the point that government ministers and backbenchers were hard pressed to justify the utility of the measure against a volley of criticisms.

Fair enough and let us not begrudge the benefactors such nicety paid for by all of us said many, but paid out straight to their accounts, without parental guidance? Is that a spending spree in the offing or, in some cases, an exposure to risks that we need not dwell upon? How about those who turned 18 a few weeks ago queried some while others asked whether single mums giving birth were not equally or more deserving in the low to middle classes...

A memorable note to the mental structures of our ruling elites is the formidable display of greed entertained by our ministers, who, it must be said, earn similar salary packages to many of their EU counterparts. Under the 2015 regime,

ministers were renowned as world trekkers, backpacking at the drop of a hat for any international conference or seminar, of which there were quite a few every week, at our expense.

Some might have thought the ministerial appetite and thirst would quench with time. Alas, we had to witness the indecent Dubayjalsa of a dozen ministers, some accompanied by their close cadres at Rs 77m, while it was revealed this week that ministerial travels, missions and per diems over the past five years, had totalled near half a billion Rupees! Three of those years were lockdown, pandemic and after-effects of Ukraine during which our economy suffered heavily that the PM is fond of reminding us and sacrifices were called for. ## The Tram Back On Track

Natural priorities and common sense have been restored



e had the opportunity here to query the sudden announcement of the tramway's priority extension to Cote d'Or from Reduit at an extra cost of some Rs 13 billion to be borrowed from India and if this extension was substantiated by a feasibility and marketing study. We in particular wondered whether the natural priority extension would not have been from Curepipe down south towards Rose-Belle and other agglomerations to the Airport and up to Mahebourg.

In reply to PQ B/596 from Hon Osman Mohamed earlier this year, Minister of Public Utilities Bobby Hurreeram gave forceful assurances that such a feasibility study of that extension had indeed been carried out, with «a rigorous methodology and comprehensive approach, including an extensive Stakeholder Management Plan» - implying that it was clearly not born out of the PMO's fanciful whim for the pet destination of Cote d'Or. Pressed for more details, he even ventured that extra passengers on that stretch would be between 15,000 to 30,000 daily, contributing greatly to the tramway's overall financial sustainability.

We were tempted to applaud the minister's unambiguous statement in Parliament, until, that is, the PM was reported by *Week-End*, as stating that, after all, the extension of the Reduit line would stop at Saint Pierre, thereby not reaching Cote d'Or, and that the Curepipe line would be instead extended to La Vigie towards the South and the airport.

One assumes that this too must have been bolstered by rigorous marketing and technical studies which would be communicated at some future stage. But we can rejoice that natural priorities and common sense have been restored in the circuitous design and trajectory of the tramway.

## Tensions dans le détroit de Taïwan: le centre belliqueux mondial se précise

es incidents continuent de se multiplier entre l'armée chinoise et celle des États-Unis dans les alentours du détroit de Taïwan. Quelques jours après qu'un chasseur chinois soit passé à quelques mètres d'un gros porteur militaire américain, deux bateaux militaires ont failli entrer en collision en ces lieux.

En effet, l'incident a eu lieu il y a quelques jours. Les deux bateaux se trouvaient sur des trajectoires indiquant qu'il allait clairement y avoir une collision, mais aucun des deux bâtiments n'a bougé. Le bateau chinois aurait contacté le bateau américain pour signifier au commandant de dévier sa route, mais ce dernier n'a pas bronché. Néanmoins, il a ralenti la course du bateau américain afin d'éviter une collision.

Le secrétaire à la Défense américain, Lloyd Austin, s'est exprimé sur l'incident en qualifiant l'attitude de la Chine d'inacceptable, précisant que la marine américaine ne cherchait pas le conflit mais qu'elle y répondrait si elle devait le faire. Les officiels chinois ne se sont pas exprimés sur l'incident, mais plusieurs analystes chinois affirment que le Chine ne se laissera pas dicter sa conduite dans des eaux territoriales qu'elle considère comme relevant de sa souveraineté, et que les États-Unis devraient reculer devant leur tentative d'encerclement de la Chine.

Ce point est particulièrement pertinent, surtout que Lloyd Austin rentre tout juste d'un voyage officiel de l'Inde où il s'est longuement entretenu avec le PM indien Narendra Modi sur les questions militaires et sécuritaires. Narendra Modi prépare d'ailleurs un voyage officiel aux États-Unis, et les discussions préliminaires qui ont eu lieu avec le secrétaire à la Défense américain laissent présager des accords sécuritaires à venir.

Parallèlement à cela, des négociations ont été entamées quelques mois de cela avec le Japon afin que l'OTAN ouvre un bureau dans ce pays. Rien ne dit que ce projet ira de l'avant, surtout qu'Emmanuel Macron vient d'émettre de sérieux doutes quant au bien-fondé d'une telle entreprise. Mais il indique clairement la volonté américaine d'un élargissement de l'OTAN vers le continent asiatique et dont la visée serait forcément l'encerclement et l'isolation sécuritaire de la Chine.



Ce projet sécuritaire trouvera certainement l'adhésion du Japon, de la Corée du Sud et de Taïwan qui voient d'un œil de plus en plus inquiet la militarisation chinoise des eaux de la Mer de Chine et du Nord-Ouest Pacifique. Mais les États-Unis auront du mal à mettre en place un tel projet sans l'aval de leurs partenaires européens, et notamment la France qui possède un contingent militaire extrêmement important dans le Pacifique et dans l'océan Indien.

Ainsi, la posture d'Emmanuel Macron reste prudente. Ce dernier a récemment clairement indiqué qu'il n'entrerait pas entièrement dans le jeu américain sans pour autant le rejeter. Cette voie du milieu que prône Macron s'aligne avec la stratégie indienne et pourrait s'avérer salutaire pour la sécurité de cette partie du globe, car la voie du milieu privilégie le consensus et les équilibres aptes à produire la paix.

En tout cas, ce qui est certain, c'est que le centre belliqueux mondial se précise de plus en plus et avec la guerre en Ukraine qui est partie pour durer et maintenir un statut quo où l'Union européenne et la Russie y trouvent leur compte, c'est maintenant vers la Mer de Chine que nous devons nous tourner. Il se pourrait bien que l'avenir de la sécurité mondiale s'y joue actuellement.

e quatrième budget du Grand Argentier était attendu avec impatience par tout le pays. Maintenant que nous sommes sortis de la Covid et que l'économie mondiale est en phase de reprise importante, ce budget se devait de signaler la relance définitive de l'économie mauricienne également, et ce, à tous les étages de la pyramide sociale.

Le premier commentaire qui vient à l'esprit est que le ministre des Finances a livré un exercice prudent en tentant de faire plaisir à tout le monde. Mais faire plaisir à tout le monde implique le fait de n'avoir aucun parti pris, et ce budget pourrait apparaître fade et dénué d'orientation nationale forte de ce point de vue.

Mais pouvait-on s'attendre à un budget courageux quant aux orientations nationales à moins de deux années des prochaines échéances électorales? Certains diront que oui, mais le pragmatisme politique fait qu'aucun gouvernement n'oserait tenter un exercice budgétaire aussi risqué.

À partir de là, il est clair que le ministre des Finances a opéré dans un contexte précis: ouvrir les valves de

l'investissement afin de consolider la relance tout en finançant des mesures sociales pour permettre aux ménages les plus fragiles de résister à l'inflation.

Ainsi, l'abrogation de la 'Solidarity Levy' et la simplification fiscale sont des signaux forts envoyés aux investisseurs. Dans le cas de la 'Solidarity Levy', c'est même le signal clair que nous sommes sortis de l'ère de la Covid puisque cette dernière avait été mise en place afin de soutenir les mesures d'urgence mises en place à partir de mars 2020; le Grand Argentier n'avait pas arrêté de répéter qu'il s'agissait d'une mesure temporaire.

L'opposition a tout de suite crié au loup en affirmant que ce budget favorisait ainsi les classes moyennes supérieures et les riches. Cette affirmation peut sembler juste sur papier, mais elle met de côté la réalité économique du pays: le fait que sans investissement, sans croissance et sans consommation soutenus, nous ne pourrons plus financer notre modèle social. Ceci est dû à deux facteurs fondamentaux: le vieillissement de la population avec moins de jeunes qui vont devoir produire plus pour soutenir la même tendance à la croissance, et la tendance décroissante de la productivité.

Ces deux facteurs sont absolument déterminants dans les stratégies économiques, sociales et industrielles car ce sont elles qui dictent à nos gouvernants l'impératif d'ouvrir encore plus les valves du pays à l'investissement étranger (FDI) et au travail des étrangers (Occupation Work Permit et ouvriers étrangers). À partir de là, il est clair que nous sommes à Maurice dans une situation où le salariat (pour ne pas dire le prolétariat) n'est plus capable de négocier contre le capital, puisque sa survie elle-même dépend de la capacité du capital à produire de la croissance. Le gouvernement est ainsi parfaitement pragmatique: il choisit donc la voie du pragmatisme - pour reprendre une expression utilisée par les partis de gauche à travers le monde lorsqu'il fait un cadeau fiscal aux riches.

#### Modèle social, inégalité et instabilité politique

Il est essentiel de maintenir un climat favorable à l'investissement et au développement du capital à Maurice, en sachant que la structure fiscale n'est pas aussi avantageuse que dans des pays directement concurrents de Maurice sur le marché des investisseurs étrangers. La survie même des classes populaires en dépend, puisque sans les revenus qui découlent de l'investissement et de la croissance, nous serions obligés de privatiser le modèle social à Maurice.

Cela produit bien évidemment une situation d'inégalité qui ne fera que s'approfondir. Et il est clair que ces questions devront être adressées de manière sérieuse à un moment donné, surtout que l'approfondissement de ce système ne produira qu'une seule conséquence sur le long terme: la perte des acquis socioéconomiques des classes populaires. Ce qui produira à son tour de l'instabilité politique.



A noter toutefois qu'aucun gouvernement, quel qu'il soit, ne s'aventurerait à adresser ces problèmes dans le quatrième budget d'un mandat de cinq ans. Nous restons ainsi, pour l'instant, emprisonné dans le cercle vicieux de libérer les avenues de la croissance afin de permettre une augmentation des revenus de l'Etat, qui permettra à son tour de financer le modèle social et des mesures de soutien aux Mauriciens les plus fragiles.

Et parallèlement à des mesures favorables à l'investissement, le ministre des Finances a également adressé un certain nombre de mesures afin de soutenir les ménages les plus vulnérables dans une situation d'inflation mondiale qui risque de durer. Augmentation de la pension de vieillesse, augmentation du revenu minimum, augmentation de certaines allocations et soutien aux personnes nécessitant des soins à l'étranger, etc. L'exercice de distribution couvre un certain nombre de domaines.

Ces allocations peuvent sembler farfelues sur papier, et au regard de l'inflation - qui se situe légèrement audessus des 11% cette année pour Maurice -, mais l'exercice est périlleux. D'un côté, le Grand Argentier se doit d'augmenter les revenus des ménages sans tomber dans le piège bien connu des économistes: le fait qu'en situation d'inflation mondiale, faire augmenter les revenus trop rapidement fait également augmenter l'inflation. L'Argentine est un cas d'école de cette situation, et il est impératif que nous nous préservions de cette hypothèse.

Est-ce que l'exercice est réussi? Seuls les Mauriciens bénéficiant de ces aides et de ces soutiens auront une réponse à cette question, surtout que la baisse du prix de l'essence devrait également alléger les dépenses des ménages, voire même faire baisser le prix de certaines denrées alimentaires. En tout cas, le ministre des Finances semble miser sur le fait qu'une accumulation des allocations et des baisses puissent produire une dynamique favorable quant à la capacité des ménages à bas revenus à mieux résister à l'inflation mondiale, quitte à augmenter l'endettement du pays. Mais le ministre répondra qu'absolument tous les pays du monde financent la relance actuelle par de l'endettement, ce qui est vrai.

Ce qui semble certain en tout cas, c'est que les opposants ont eu beaucoup de mal à critiquer ce budget, ce qui expliquerait qu'ils se soient rabattus sur l'allocation de Rs 20 000 aux jeunes de 18 ans. Quant à l'allocation de Rs 20 000 aux jeunes de 18 ans, cette mesure est sans aucun doute la plus critiquable du budget, et apparaît pour ce qu'elle est: une tentative d'amadouer le vote des jeunes pour les prochaines élections.

Le MSM avait réussi un coup de maître en 2014 en adressant le problème de la pension de vieillesse. Ils se sont ainsi assurés du vote des personnes âgées - ce qui n'est pas négligeable dans une situation de vieillissement de la population. C'est cette mesure, parallèlement avec la consolidation de leur base électorale dans les régions rurales, qui leur a permis dans une grande mesure de gagner les élections de 2019. Et il semble clair que la même stratégie est maintenant déployée afin de capter le vote des jeunes. Est-ce que cela marchera? Seul l'avenir nous le dira.

En conclusion, qu'on le veuille ou non, le gouvernement a encore une très grande marge de manœuvre concernant les allocations sociales, et ce budget confirme une chose: les prochaines élections générales ne sont pas pour bientôt, et le pari du Grand Argentier est clairement de miser sur une relance soutenue afin de préparer un budget vraiment électoraliste l'année prochaine.

### Smart City à Roches Noires: Pourquoi donc une telle levée de boucliers?

a Smart City de Roches Noires continue de faire couler beaucoup d'encre. Il ne s'agit pas du premier projet Smart City qui va de l'avant à Maurice, mais c'est très certainement celui qui se heurte à plus de résistance.

En effet, certains habitants de Roches Noires notamment les propriétaires des campements pieds dans l'eau - ne cessent de réclamer des explications concernant l'obtention de l'*Environmental Impact Assessment* (EIA). Le promoteur, une entreprise française du BTP, a organisé plusieurs rencontres avec les habitants afin de leur expliquer les tenants et aboutissants du projet mais sans forcément parvenir à les convaincre.

Ces réunions ont également vu la présence remar-

quée d'activistes proches des conglomérats mauriciens, certains prenant position ouvertement contre le projet avec des publications dans les médias et sur les réseaux sociaux, et ce, malgré un manque total de compétence dans le domaine de l'ingénierie environnementale.

La député Joanna Bérenger a même posé une question au ministre des Finances afin d'avoir des informations sur l'investisseur, affirmant que ce dernier n'était pas en odeur de sainteté en France. Elle n'a toutefois pas donné aucune preuve pour soutenir ses dires. Pourquoi donc une telle levée de boucliers? Il est certain que les *wetlands* (zones humides) de Roches Noires constituent une zone environnementale sensible, et soulèvent donc des questions. Mais il nous apparaît également que les personnes venant de l'avant ne représentent pas le point de vue de la majorité des habitants de Roches Noires, mais bien plutôt des gens qui semblent décidés à défendre leur style de vie exclusif et privilégié.

En effet, à Maurice, la région de Roches Noires fait partie de ces zones historiquement exclues du développement économique. Il n'y a que très peu d'activités car les infrastructures ne permettent pas le même type de développement touristique et immobilier que celui du Nord ou de l'Ouest. La conséquence en est que les populations rurales des régions comme Roches Noires souffrent encore plus de la cherté de la vie et des conséquences de la crise économique mondiale. Chômage, manque d'activités, exclusion... Nous sommes là, à quelques kilomètres seulement du Nord développé, dans une périphérie exclue.

Il ne faut pas confondre exclusion et ghettoïsation. Contrairement à d'autres zones exclues, Roches Noires et ses alentours ne sont pas des ghettos mais de belles régions où la nature est conservée et où il faut bon vivre lorsqu'on est privilégié. Un campement pieds dans l'eau, par exemple, dans cette région est un bien extrêmement prisé des classes possédantes mauriciennes. Et il est extrêmement difficile de devenir propriétaire dans cette région.

Mais ce modèle de développement, basé sur des campements de vacances, n'apporte pas la prospérité économique que les habitants ont le droit d'espérer. BC caught with pants down' - that's one Indian how news channel, The Alternate Media, concluded its coverage of the 'tax fraud' committed by the BBC in India, which has been exposed by a survey that

was carried out in the BBC

Mumbai about two months

ago.

How does this concern me? Well, it does, because right from my student days at the Royal College Curepipe, our education was biased in favour of everything British. Both overtly and subtly, we were led to believe that Great Britain and British institutions, especially the monarchy, as well as British values of fairness and justice, were the ideals to be looked up to and lived by. Along with the monarchy, the British Parliament and the BBC were the two other arms of British rule that were impressed upon us – the parliament as the temple of democracy, and the BBC as the best source of reliable information and the supreme example of spoken English that should be emulated.

Only Queen's English was then acceptable at the BBC. Until Independence it was the tradition to have British Rectors at RCC, and in 1960 when I was in Form IV a new Rector took over, Mr Herbert Bullen. He not only exhorted us but actually tried to make us speak 'squeaky clean' Queen's English - though that largely didn't happen - by making us read passages which he would record on those big tape recorders, then play them out and correct our pronunciation one by one. Not only that, he stressed that we should listen to the 8 o'clock BBC news every morning, both for the accuracy of the information and the proper pronunciation. Those were the days of the box radios, and I tried to be as regular as possible in following the advice of Mr Bullen.

And that is why I was stunned by the news that the BBC, which has always tried to paint a whiter than white lily image of itself - vide Mauvilac's advert for its white paint: 'plus blanc que blanc' - had been found to be guilty of tax evasion by the Indian authorities, to the tune of nearly Indian Rs 400 million. Perhaps I ought not to have been surprised, because it is by now a known fact that one can no longer count on the BBC for the validity of its news, especially where India is concerned. Those who know better have drawn attention repeatedly to the 'wokeism' that has infiltrated that once venerable institution, and that its coverage can be very biased.

A glaring example was the film that BBC showed earlier this year titled 'India: The Modi Question'. It raked up old issues already disposed of by judgements of the Supreme Court of India, and those who made that film wanted to act as a supra-Supreme Court and give their version based on material that had already been discredited and dismissed by India's Supreme Court. The film was banned in India, and currently the BBC is being sued in the Supreme Court there. The plaintiff is represented by eminent jurist and constitutional expert, Harish Salve, who has a robust track record, having also successfully defended the Indian government at the International Court in The Hague.

accused the authorities of vindictiveness on the BBC for showing the film, when the survey was ordered by the tax department afterwards. However, this is not at all the case, because according to Indian media since well a year before the tax department had been seeking information about its financial data from BBC India, and this was not forthcoming, thus leaving it with no choice but to conduct the survey - the timing being a mere coincidence.

Apparently 'BBC has reportedly "acknowledged" that it may have paid lower taxes than required in India' but is 'yet to file revised returns or make a written submission to the I-T department.'

I don't care for BBC news now.

### **Democracies, such as they are!**

erhaps the British politician Winston Churchill was right about democracy after all, not that it is the best form of government, but the least bad. For what we have been witnessing in recent times has emptied the word democracy of any real meaning. All democratic countries have been convulsed by all manner of scandals - fraud and corruption both in government and private sectors, bank scandals leading to financial crises, violent street protests that have had to be met by equally violent counters so as to control the situation, refusal of democratically elected governments to provide answers to queries raised by the respective oppositions that, incidentally, do exactly the same thing when they in their turn assume power after an election!

Not to mention the postponement of elections, which happens in some democracies where the prime minister has the prerogative to fix election dates. Although in the US the Presidential election and the installation of the new president are held on fixed dates in November and January respectively every four years without fail, this does mean that it is the perfect example of democratic functioning either. There are so many fault lines in the US, from 'institutionalised racism' to the ills of runaway capitalism that keeps widening the gap between the haves and the have-nots - and that we find in all democracies as well, including our own country. Here, because of the smallness of the country, this is even more glaring, and no budgetary measures down the years have been able to correct this imbalance.

The US is the oldest democracy and India is the largest one, in both of which freedom of expression quite often takes extreme forms, which can be paradoxical too. This is the case with India currently. One of its former opposition MPs, Rahul Gandhi (who has been disqualified as such by a Court in India) has gone on a tour in some US cities sponsored by US-based supporters of his party the Congress and backed by organizations with dubious credentials that symbolize the Congress's vote banks. There he has openly criticized India's Prime Minister and said that democracy is dead in India. The fact that he can do that in foreign country as well as in India, and not get arrested and jailed, is itself proof enough of the exact opposite!

In a statement that contradicts him, the US authorities have qualified India as being a vibrant democracy and invited à qui de droit to go to India's capital city New Delhi and to see for themselves! Whether this stance, which comes in the wake of an earlier one on human rights issues in India, has anything to do with anticipated trade deals that may come up during the forthcoming PM Modi's official visit to the US is another matter. So too is the bipartisan invitation to him to address the US Congress. But it is undeniable that he has emerged as a respected and sought after global leader, under whose watch India's growth rate is expected to be the highest at over 6%.

As Rajya Sabha MP and BJP national president JP Nadda has remarked, 'Under his leadership, India has moved away from vote bank politics to report card politics, and from dynasty to democracy and meritocracy.'

Maybe there are lessons for our own country too in this remark.

## Pak Army's threat to Imran for May 9 violence signals power rise of Gen Munir

A lthough General Asim Munir's tough statement at the end of the formation commanders meeting in Rawalpindi on Wednesday targeted PTI chief Imran Khan Niazi for his role in instigating May 9 insurrection against Pakistan Army, there was an oblique message to civilian political leadership that no one is above "Fauj (army)" in the Islamic Republic, reports Hindustan Times.

The statement released by Pakistan Army said: "It is time that the noose of law is also tightened around the planners and masterminds (of May 9 events) who mounted the hate-ripened and politically driven rebellion against the state and state institutions to achieve their nefarious design of creating chaos in the country. Forum also resolved that endeavours by any quarter to create obstructions... will be dealt with iron hands."

With Pak Army applying the Army Act and the Official Secret Act on the May 9 instigators, planners, and executors, it is quite evident that the politics of former cricketer, who could swing the ball on both sides, is over for the present and near future with senior PTI leaders abandoning the Niazi bandwagon after pressure from the



Army. But the big picture is that Army Chief General Asim Munir will grow in stature and will exercise more power over the civilian leadership led by PM Shehbaz Sharif. This also means that the return of Nawaz Sharif to Pakistan will become all the more difficult as Gen Munir would prefer an amiable Shehbaz instead of the former PM who got him appointed as the Army Chief. It is learnt that Gen Sahir Shamshad Mirza, current Chairman, Joint Chiefs of Staff Committee, was the choice of former Pak Army Chief Gen Qamar Jawed Bajwa but got overruled in London, reports Hindustan Times.

Gen Munir was appointed by the Sharif government on the grounds that he would take on Imran Niazi as the latter had humiliated him by shunting him out as DG (ISI) and replacing him with his favourite General Faiz Hameed. A powerful Gen Munir could cause the same problems to Nawaz Sharif as his other two appointees — Gen Qamar Jawed Bajwa and Gen Pervez Musharraf as the former ensured the rise of Imran Niazi and the latter dethroned him in October 1999 after Kargil war.

While Niazi is now seeking protection from the same US that he had accused of removing him from the PM job, his statements attacking the Pak Army post-May 9 have ensured that Gen Munir will drive him into political oblivion for the present and for time to come.

Fact is that a powerful Army Chief is even in the interest of Pakistan allies like China, Saudi Arabia, UAE and even the US State Department as Rawalpindi GHQ is a single window clearance for the Islamic Republic.

## North Korea's Kim Jong Un passes 'secret order' banning suicide

North Korean's leader Kim Jong Un has reportedly passed a 'secret' order banning suicide in the country. The 39-year-old leader described the act as "treason against socialism" and has ordered local governments to take preventative measures.

With the worsening economic crisis, the South Korean spy agency found that North Korea witnessed a 40 per cent spike in suicide this year than the previous year, reports Hindustan Times.

The confidential suicide order was delivered in a spate of emergency meetings across the country, reports Radio Free Asia.

One meeting recorded 35 suicide cases this year in Chongjin city and Kyongsong county. Starvation deaths, meanwhile, in North Korea tripled last year. At a meeting in Ryanggang province, the attendees were told suicide has had a greater social impact than starvation, according to The Sun.

Speaking at the meeting, an official said, "Despite the suicide prevention policy ratified by the General Secretary, the officials were not able to come up with an appropriate solution.

"Most of the suicides were caused by severe poverty and starvation, so no one can come up with a countermeasure right now."

### Chinese influencer dies after alcohol binge in viral challenge

The 27-year-old live streamer's wife confirmed with Chinese media outlet Jimu News on Tuesday that her husband, known by his online moniker Zhong Yuan Huang Ge or Brother Huang from the Central Plains, died due to excessive consumption of alcohol on the morning of June 2.

He has died from drinking too much alcohol after a livestreamed drinking battle, making this the second fatality from such a game in a month, reports ANI.

Huang's death marks the second influencer to die from a viral drinking challenge in under a month.

The fatality occurred June 2 after the internet celeb, known as Brother Huang to his 176,000 social media followers, had reportedly downed an excessive amount of baijiu.

Colloquially called "Chinese firewater," the typically sorghum-based spirit boasts an alcohol content ranging between 35 per

Millions of Chinese students sit for notoriously tough college entrance exams on Wednesday, the first since the country lifted zero-Covid rules that forced classes online for months on end.

China's education ministry says nearly 13 million students, a record, are registered to take the "gaokao" exams — billed by state media as the "world's toughest" this year.



cent to 60 per cent.

In videos posted to Huang's nowdeleted account, the YouTuber desperate for fame can be seen swilling the grog, lighting tissue soaked in alcohol and showing off pyramids of empty bottles.

His wife, surnamed Li, said that Huang had been trying to earn cash to pay off a massive debt totalling hundreds of thousands of yuan that he incurred before his marriage.

"I've been waking up at 4 am every day, except on Sundays, to study for the past four years," Jesse Rao, a 17-year-old high school senior in Shenzhen, reports AFP.

Testing high school students on their Chinese, English, mathematics and other science or humanities subjects of their choice, the exams are critical to landing coveted spots at China's top universities.

Many parents shell out hundreds of dollars a month on cram schools or hire graduate students to sit with their children while they study late into the night.

Exams are notorious for testing the ability to compose essays in response to oblique prompts, with sample questions published Wednesday by the People's According to a video of Huang's room posted by his relative, the wall in his room had Chinese phrases including "money is more important than life" and "life is not all about money, but you will need money to live the life you want".

Huang's death comes less than a month after a fellow influencer, named Wang Moufeng or "Brother Three Thousand", was found dead on May 17 hours after livestreaming himself knocking back four bottles of baijiu for his fans on Douyin, China's version of TikTok.

Wang Moufeng, better known as Brother Three Thousand, had reportedly been involved in a "PK" challenge, in which two influencers typically compete for gifts or rewards from their audience.

The loser faces a penalty, which, in Wang's case, involved imbibing excessive amounts of hooch as punishment for losing three rounds, as seen in the video which is now deleted.

## 10 key revelations from Prince Harry's high court testimony

## UFO Whistleblower alleges concealed evidence of non-human craft, Pentagon investigation launched

In a series of intriguing developments over the past six years, the topic of UFOs and extraterrestrial phenomena has taken center stage in the United States.

It all started back in 2017 when the New York Times uncovered a revelation that former senator Harry Reid had discreetly allocated \$22 million in Defense funding to investigate unidentified foreign objects. Since then, numerous Navy pilots have come forward with reports of frequent UFO sightings, prompting the Pentagon to revamp its investigation process in a bid to treat the matter more seriously.

Despite heightened scrutiny, these investigations have yet to yield any significant breakthroughs, with many of the objects sighted by pilots turning out to be mere balloons, reports Hindustan Times.

However, a recent report by Leslie Kean and Ralph Blumenthal, part of the team that broke the Times story in 2017, offers hope to those who believe in the existence of extraterrestrial life.

Published on the science website the Debrief, the report unveils the account of a Defense intelligence whistleblower who alleges that classified evidence of "intact and partially intact craft of non-human origin" is being concealed by the Intelligence Community.

The whistleblower, David Charles Grusch, filed a complaint asserting that the Pentagon, along with other nations and defense contractors, has retrieved fragments "of exotic origin (non-human intelligence, whether



extraterrestrial or unknown origin)" based on the analysis of vehicle morphologies, material science testing, and the presence of unique atomic arrangements and radiological signatures.

Grusch further claims that the recovered material includes both intact and partially intact vehicles.

What sets Grusch apart from previous UFO experts discredited by skeptics is his credible background. A 36-year-old combat veteran of Afghanistan, Grusch served as a member of the Unidentified Aerial Phenomena Task Force—an Office of Naval Intelligence program dedicated to investigating UFO sightings.

# **"This is not a pro-poor budget but a budget for the rich by the rich.** There is nothing free for the poor and middle class"



Mauritius Times: How do you see the Mauritian economy doing right now, and where will that lead us to. What do the fundamentals inform you?

**Sameer Sharma:** To know where we are going, we must first understand where we really are. If the data that we have about the true health of the economy does not make complete sense, in other words, when the radar itself is not completely reliable, it becomes complicated for any economist to tell you where we really are and where we are going. In fact, if we do not understand where we really are in the short-term business cycle relative to our long-term real potential trend growth of 3.2%, then the conduct of both monetary and fiscal policies becomes error prone.

When we think about GDP growth, there are two types of growths: real growth which excludes inflation, and nominal growth which includes both real growth (volumes) and inflation as measured by the GDP deflator nvestment Analyst & Financial Risk Manager Sameer Sharma needs no introduction to our readers, and he is generally known not to mince words and call a spade a spade. As several other independent economists, he finds that the policies pursued before, during and after the pandemic have done little to strengthen the economy, increase its resilience or compensate the population for its sacrifices. This, he says, is a budget for the wealthy and well-connected which the smattering

Holding nominal GDP growth constant, an underestimation of the deflator would mathematically lead to an overestimation of real growth and vice versa. rent CPI basket was derived from the 2017 Household Budget Survey and given what has happened since 2017, this basket itself suffers from significant biases and is likely now underestimating true consumer price inflation.

In this budget, which comes just three months after the Statistics Mauritius 2023 estimates, the Finance Ministry is forecasting a financial year (July to June) change in the deflator of more than 9% and real growth of 8%. Even when adjusting for calendar vs financial year differences, these are two very different forecast estimates coming from the Finance Ministry and Statistics Mauritius.

The reality is that Statistics Mauritius is likely moderately overestimating real GDP growth and underestimating the change in the deflator. The Ministry of Finance, on its part, is overestimating real GDP growth by an even wider margin.

Estimating real and nominal GDP growth in Mauritius is no trivial task. We lack an adequate amount of high frequency economic data; data quality can sometimes be poor and there has been inadequate research done on the real size of the parallel economy which includes money laundering and drug trafficking. There is also a poor understanding of the interplay between this parallel economy and the formal economy.

The honest answer then is that we do not completely know where we are and those who throw forecasts around have no clue either. We have some indicators that provide us with evidence that we have had a recovery from a low base and that inflation remains the key driver of nominal growth and government revenues. We also know that in a debt-driven import dependent consumption model, the currency will remain under pressure which explains why the central bank has adopted a moderate form of capital controls after having run out of liquid ammunition despite more than 1.2 Billion in foreign central bank borrowings.

We also know that inflation favours the asset rich and leads to more wealth inequality. It is clear that there are two realities in Mauritius, one for the asset rich, the money launderers and highly connected, and another for the rest. Drive around Tamarin and then drive around central Curepipe and you will understand what I mean, or you could look at the struggles of the middle-class in a country where corporate profits are reaching new highs given the opening up of borders, depreciation and inflation.

The real value of debt also declines with inflation. Most of the conglomerates have no plans to make major investments in Mauritius beyond selling villas and energy. Their expansion is now abroad while they ensure that they maintain oligopolistic control over various sectors of the economy locally. Ignoring the MIC giveaways at losses to the State, which we called "love and care" bailouts, large enterprises will now be able to hire more foreigners across the wage spectrum. Their taxes have come down, dividends are not taxed, and inflation and depreciation are here to help too. What more could they ask for?

What we should have done is to tax the rent-seeking economy while encouraging those who work and add value. For example, we should have distinguished between distributed and non-distributed profits for local companies when it comes to taxation. We should have introduced a mild form of taxation on the rentier economy via land value taxation and reduced the share of consumption taxes and inflation taxes to total taxes. Reducing income taxes is a positive as we should reward work as long as we tax rent-seeking behaviors in a smarter way.

We should have also looked at fiscal consolidation by cutting and spending responsibly which would have helped to stabilize inflation and the currency. We should have moved towards a more targeted form of basic retirement pension that gives the well-to-do less of that basic pension so that the entire system can be made sustainable. We should have addressed the large actuarial hole in defined benefits plans and we should have sent all the printed money left back to the Bank of Mauritius in order to partially recapitalize it.

Most of the conglomerates have no plans to make major investments in Mauritius beyond selling villas and energy. Their expansion is now abroad while they ensure that they maintain oligopolistic control over various sectors of the economy locally. Ignoring the MIC giveaways at losses to the State, which we called "love and care" bailouts, large enterprises will now be able to hire more foreigners across the wage spectrum. Their taxes have come down, dividends are not taxed, and inflation and depreciation are here to help too. What more could they ask for?"

What we have done is to increase the dependence of a vast majority of the lower middleclass and the poor on the State largely funded by the inflation tax which is the source of their poverty. We are literally making the poor pay for their dependence.

\* It was to be expected however that the 2023-24 Budget would form part of a two-step strategy to be implemented in this year's and the next budget, the first one consisting mainly in easing the current economic hardships of low and middle-income earners, and the real big populism of vote-buying measures will come next year. The question is what reserves and leeway will government have to finance the long list of measures announced in the 2023-24 budget itself?

This budget has very little in it for the poor. Throwing what is left of the helicopter drops of the now undercapitalized Bank of Mauritius at the poor, who will consume most of this printed cash in imported goods given that we produce precious little locally, will only lead to a current account deficit that will remain above 5% of GDP for the foreseeable future, more pressure on the currency and an inflation rate that will remain above 5% for longer when the right level of inflation in Mauritius should be closer to 3%.

Money is neutral in the long term. Making the poor pay for their own State handouts is quite a farce. What is more worrying is that we are increasingly relying on the inflation tax to fund social programs rather than fair taxation. We seem to be relying on some form of nominal GDP targeting where the government focuses on a certain tax revenue target for the year. And if does not get enough real growth, then it will relax the capital controls a bit and let the currency slide and let inflation run hot in order to pay for it all.

Inflation is a dangerous animal to depend on. It has a life of its own especially when the Bank of Mauritius lacks credibility and the capital to fight it given fiscal dominance. The inflation game is a double-edged sword and while it makes everything on paper look good for a while, eventually it ends up costing you more and then you will need to engage in significant austerity measures when the next global economic shock comes around. When that reality check happens, it is game over.

\* Consider the Rs 20,000 grant to those reaching 18 years as from 1 Jan 2023, and who are lesser in number than the pensioners. One would expect other political parties would seek to outbid this particular handout as well as the basic retirement pension, which might go up to Rs 15,000 next time round. Where will all this will lead us to?

\* There's also the «Revenu Minimum Garanti» of Rs 15,000, which 85,000 men and women working on a full-time basis are expected to receive, according to the Finance minister, as from 1 July 2023. The immediate gut reaction of many employers was that they'll limit their available workforce, or they'll go for Bangladeshis from the informal labour market, until the Minister clarified that the CSG and the taxpayer would finance the top up from the current Rs 11,500. What's your take on this measure?

Have you not noticed that the ratio of Mauritian employees to foreign employees no longer exists?

This is fine at the higher wage spectrum but, at the lower wage spectrum, this will serve to depress wages overall, increase the share of State contributions to total revenues and of course increase the dependency of the average poor and lower middle-class worker on the increasingly autocratic state over time.

If you want to increase wages, then open up the competition landscape in this country by reducing barriers to entry and strengthening regulations on those who exercise oligopolistic power across various sectors of the economy, be it conglomerates or some state-owned entities. De-centralize government and break down contract sizes and allow new players to compete in a fair landscape.

Open up the country to immigration with a focus on business owners and innovators. Revamp a failing education system, so you produce better quality workers and stop thinking that the State is the answer to all problems. Wages will go up if you improve productivity. Focus on targeting funded by a fairer tax regime as I described earlier and empower people in general but let them take ownership of their own destiny and mistakes. Equal opportunity, not equality of outcomes.

\* There are also issues flagged by rating agencies and the IMF - elevated levels of budget deficits and public debt, rising inequality, inflation, depreciation of the rupee and acute cost of living crisis — matters of concern that ought to have been addressed head on by the Ministry of Finance, instead of the palliative measures proposed. Why are the required reforms not taking place? Is it only because of the popularity factor?

The likes of the International Monetary Fund provide mere recommendations. Mauritius is a small country and if it were to disappear tomorrow, the world would not even sneeze.

When it comes to Moody's, neither the State nor local corporates are major issuers of Eurobonds globally. They do not pay the same level of attention as they would for larger economies or for economies that are asking for assistance which come with conditions.

Recently one person from the IMF asked me about this MIC 2.0 which apparently will now become the new sovereign wealth fund of Mauritius. He was quite confused given that Mauritius - unlike all other countries which have sovereign wealth funds - has a large current account deficit, a large fiscal deficit especially when you adjust for special funds spending, large unfunded liabilities from the basic retirement pension to defined benefit plans and declining international reserves which look even worse if adjusted for liabilities and large unrealized losses. How will they fund this, he asked?

Well, when the Bank of Mauritius sells foreign exchange in the local market with the supposed objective of stabilizing the currency, it earns Rupees in return and the idea then would be to destroy those rupees in order to reduce the supply of rupees which helps by definition to stabilize the exchange rate at least temporarily.

In our case, we are not destroying the Rupees but reinjecting them via the MIC into the local economy. In a nutshell we are funding a so-called sovereign wealth fund not with savings of any kind but with money printing. We have become a global laughingstock and, sadly in Mauritius,

\* While there was undoubtedly some imported inflation over the past two years, the rate has ebbed considerably in other Indian Ocean islands, similarly affected, yet stays high in Mauritius and is projected to be around 10% next year. Isn't our inflation due in large part to the continuous depreciation of the Rupee against the dollar as the chief import currency?



There are various factors which explain our current inflation predicament. Initially, the inflation shock was indeed mostly imported in nature, but the central bank failed to act in time by tightening monetary policy aggressively by making real interest rates positive. This is because the sheer amount of public and private debt in the system would cause quite a heart attack to a patient currently on inflation steroids.

Eventually inflation gained a life of its own with what we call second round effects, especially given the dependence of the government on such a tax and today various factors from the currency, large fiscal deficit, money printing to our market structure dominated by inefficient oligopolies all explain our high level of inflation.

We should keep in mind that core inflation, which excludes a lot of the imported stuff, is currently at more than 6.3% on a year-on-year basis which is quite high for a country like Mauritius. The tolerable level of inflation for Mauritius stands closer to 3% and anything above 5% inflation is very high and hurts our competitiveness externally.

We are going to be stuck for a while to come with high levels of inflation despite favorable base effects which will kick in during the second half of the year.

\* Are you satisfied that this budget is laying the foundations for new growth pillars or even strengthening those that are frail, rather than simply handing out a series of targeted "freebies"?

No. This is not a pro-poor budget but a budget for the rich by the rich. There is nothing free for the poor and middle class in this budget. They will more than pay for it all via the inflation tax and via further currency depreciation.

\* 'The education system is so low and the mentality in Mauritius is so insular and so partisan and the alternative itself is so mediocre that I fear that this political party may come back to power again.' That's a comment posted by a Facebooker recently. Does this sound plausible to you?

This Facebooker you refer to sounds suspicious like me. What worries me right now is this populist bidding war to the bottom among relatively unpopular political parties and the level of fragmentation in the opposition. A large segment of the population have also become increasingly dependent on the State in terms of public sector and parastatal jobs and handouts. The level of discourse can sometimes be poor and contradictory.

For example, the opposition will warn us about mounting public debt and inflation and a few minutes later will say that the government should have done more when the majority of our revenues are being generated from money printing and inflation compared to real growth. They are encouraging a wage price spiral without realizing it.

There is zero mention about what will be done about the unfair tax system, structural reforms including overdue pension reforms and the large oligopolies that run the land because everyone is desperate for some election financing from them, and few want to tell it like it is to the population.

There are too many candidates for prime minister and not enough realism on who this person should be and from which party he/she should come from. While the opposition continues to shoot itself in the foot by remaining divided, the real powers who control the land are making a killing.

ans le budget 2023-2024, le ministre des Finances a introduit une réforme de l'impôt sur les revenus qui remplace le taux uniforme d'imposition de 15% par un barème gradué. À partir du 1er juillet 2023, l'impôt sur les revenus sera calculé selon un barème gradué allant de 0% à 20% avec une addition de 2% pour chaque tranche de revenu supérieure. Le ministre a présenté la nouvelle formule comme un système d'impôt progressif. Qu'en est-il vraiment?

Avant de répondre à cette question, examinons d'abord la structure du nouveau barème. Comme le montre le Tab-

leau 1, le barème gradué comporte 10 taux marginaux d'imposition (*Marginal Tax Rates*) applicables aux différentes tranches de revenus. Les premières Rs 390 000 des revenus annuels du contribuable ne seront pas imposables avec un taux d'imposition de 0%. L'impôt sur les revenus s'appliquera après cette tranche d'exemption.

Ainsi, un taux d'imposition de 2% frappera les premières Rs 40 000 après la tranche d'exemption de Rs 390 000 (dans la fourchette de Rs 390 000 à Rs 430 000). L'impôt dû sur les Rs 40 000 sera de Rs 800.

## <u>Réforme fiscale</u> L'impôt sur les revenus est-il vraiment progressif ?

Dans ce tableau, l'exemption pour les personnes à charge du contribuable, s'il y en a, n'est pas considérée afin de simplifier les calculs.

Par exemple, un salarié touchant des revenus annuels de Rs 590 000 sera assujetti à un impôt de Rs 10 800 après l'application des différents taux marginaux d'imposition. Ce salarié sera imposé à un taux d'imposition effectif (*Effective Tax Rate*) de 1,8%.Le taux marginal d'imposition de 20% frappe la tranche des revenus supérieure à Rs 2 390 000 par an. Nous avons ainsi calculé l'impôt sur des revenus annuels de Rs 3 millions pour illustrer l'impact du taux marginal d'imposition de 20%.

Le Tableau 2 indique l'économie réalisée à chaque tranche de revenu sous le nouveau système en comparaison avec l'impôt uniforme de 15%. Un salarié qui touche un revenu annuel de Rs 3 millions paiera un impôt de Rs 394 800, soit un taux d'imposition effectif de 13,2%. Au taux d'imposition uniforme de 15%, ce contribuable paie actuellement Rs 450 000 d'impôt. Il économisera donc Rs 55 200. Le contribuable qui a un revenu annuel de Rs 1 490 000 économisera Rs 104 700.

En général, la politique fiscale d'un pays vise trois objectifs:

(a) assurer l'équité fiscale entre les citoyens,

- (b) redistribuer les richesses en taxant davantage les riches, et
- (c) développer la capacité contributive de l'économie d'une façon optimale.

Une politique fiscale juste et efficace repose sur une assiette fiscale large qui comprend les sources des revenus, la propriété, la consommation et la richesse. Il faut évaluer la réforme fiscale par rapport à tous ces facteurs.

#### Équité fiscale

Le taux marginal d'imposition de 20% sur la tranche de revenu supérieure à Rs 2 390 000 sera le taux maximal d'imposition. Sous le présent système, jusqu'au 30 juin 2023, le taux marginal d'imposition le plus élevé est de 40%. Ce taux d'imposition est la somme du taux uniforme d'imposition de 15% et de la taxe de solidarité de 25 % qui frappe la tranche de revenu excédant les revenus annuels de Rs 3 millions.

Il faut souligner que le taux marginal de 40% est nominal parce que, dans la pratique, ce taux est limité à 10% du revenu net (le revenu brut moins la déduction personnelle). Lorsque le montant d'impôt calculé au taux de 40% sur la tranche de revenu excédant Rs 3 millions dépasse 10% du revenu net, c'est le montant de 10% du revenu net qui est perçu comme impôt marginal. Cette limitation fut introduite en 2020 après la levée des boucliers des gros contribuables qui s'opposèrent à un taux marginal d'imposition de 40%.

Aujourd'hui, en remplaçant le taux marginal d'imposition de 40% par un taux marginal d'imposition de 20%, le gouvernement abandonne pour de bon toute intention de taxer davantage les contribuables riches. Ce qui est plus significatif, c'est que la taxe de solidarité de 25% s'appliquait au revenu imposable incluant les dividendes. Avec l'abolition de la taxe de solidarité, tous les actionnaires résidents ou non-résidents d'une société résidente à Maurice seront exemptés de tout impôt sur les dividendes.

## L'impôt sur les revenus est-il vraiment progressif ?

La nouvelle structure de taux d'imposition apparaît progressive, mais la progressivité est limitée par un taux maximal d'imposition de 20%. Les contribuables les plus fortunés seront assujettis à un taux d'imposition effectif inférieur à 15% sur leur revenu annuel, comme on le voit au Tableau 1.

Dans les pays développés membres de l'OCDE, le barème gradué comporte 5 ou 6 taux d'imposition avec un taux de base de 15% et un taux marginal d'imposition supérieur de 30% ou plus. Au Canada, par exemple, les taux d'imposition sont 15%, 21%, 26%, 29% et 33% selon les tranches de revenu. Et les contribuables les plus aisés dans ce pays ne s'en plaignent pas.

A la suite des concessions fiscales offertes aux gros contribuables, ce sont les contribuables de la classe moyenne (salariés et travailleurs indépendants) qui seront appelés à porter le fardeau fiscal de l'impôt sur le revenu. Maurice retourne donc à la fiscalité directe légère qui fut en place depuis 2006 jusqu'à l'introduction de la taxe de solidarité en 2020. Cette fiscalité légère est l'un des aspects de la politique économique néo-libérale suivie par tous les gouvernements depuis 2006.

Le raisonnement sous-tendant cette politique est que l'impôt sur le revenu (des individus et des sociétés) devrait être maintenu à un niveau faible pour être une incitation au travail, à l'effort et à l'investissement. Or, ce sont les contribuables riches qui bénéficient de cette fiscalité directe légère. Toutes les mesures populistes du budget ne cachent pas cet effort spécial en faveur des riches.

#### Capacité contributive

La politique fiscale devrait pouvoir développer de façon optimale la capacité contributive de l'économie en exploitant toutes les sources de revenus (taxes directes et indirectes). En matière de fiscalité directe, les économies avancées taxent les dividendes comme une source de revenu entre les mains des actionnaires selon la théorie qui veut que toutes les sources de revenus actifs (revenu d'emploi, revenu du travail libéral, revenu d'entreprise) et les sources de revenus passifs (dividendes et intérêts, plus-values sur les biens, revenu de location) soient imposées en vue d'assurer l'équité fiscale entre tous les citoyens.

Le gouvernement, lui, choisit de rétrécir la base imposable (capacité contributive) de l'économie en abandonnant toute imposition des dividendes. Autre fait significatif: les plusvalues réalisées sur la vente des biens meubles et immeubles ne sont pas non plus taxées. La taxation des plusvalues est l'outil idéal pour combattre

le blanchiment d'argent auquel se livrent les trafiquants de drogue, les opérateurs de paris illégaux et d'autres personnes (travailleurs ou professionnels indépendants) qui ne déclarent pas tous leurs revenus au fisc.

La politique fiscale du gouvernement a une tendance significative de transférer le fardeau fiscal du pays de l'imposition des revenus à l'imposition de la consommation. Le nouveau système d'impôt sur le revenu causera un manque à gagner de Rs 3,5 milliards en termes de recettes fiscales directes. C'est un développement inquiétant au moment où le gouvernement prévoit un déficit budgétaire de Rs 21 milliards pour 2023-2024 (les revenus étant estimés à Rs 179 milliards contre des dépenses de Rs 200 milliards).

En taxant moins les revenus, le gouvernement accentue la dépendance de l'État sur les taxes indirectes (TVA, taxes d'accise), lesquelles représentent 68% des recettes fiscales totales du pays. La Taxe à la Valeur Ajoutée (TVA) générera des recettes de Rs 61,5 milliards en 2023-2024 contre Rs 49,4 milliards en 2022-23, soit une augmentation de 24%. Certes, l'inflation y est pour quelque chose, mais la propension à favoriser la taxation de la consommation est devenue structurelle. Vu le caractère régressif des taxes indirectes, c'est le petit peuple qui paie les pots cassés d'une politique fiscale limitée et sans imagination.

Le pays a une politique sociale ambitieuse avec toutes les promesses d'aides à gauche et à droite (pensions de retraite, prestations sociales, subventions diverses), mais il ne se donne pas les moyens d'élargir sa base fiscale pour financer les dépenses publiques. Le recours constant à l'endettement (Rs 500 milliards déjà) pour financer le déficit budgétaire est une recette pour le désastre financier à terme.

## Une page historique se tourne pour les amateurs de football

Tout amateur de football vivra le début de la nouvelle saison avec une nostalgie certaine. En effet, une page importante se tourne dans ce sport tant aimé des Mauriciens. Pour la première fois depuis plus d'une décennie, nous ne verrons pas Cristiano Ronaldo, Lionel Messi, Karim Benzema et Zlatan Ibrahimovic jouer dans un championnat européen ou en Ligue des Champions.



Cristiano Ronaldo avait déjà tiré sa révérence il y a quelques mois. Messi, Benzema et Ibrahimovic l'ont suivi à l'issue de cette saison. Ces départs laissent un vide qui risque de durer. Même s'il y a de jeunes talents qui jouent actuellement dans les grands clubs européens, cela prendra des années avant de retrouver des joueurs et des rivalités du niveau des clasico de la grande époque de Messi à FC Barcelone et de Ronaldo au Real Madrid.

C'est toute une ère même qui symboliquement se termine. La génération Messi/Ronaldo aura été celle qui a vu une transformation radicale du modèle économique et sportif du football, avec une centralisation des investissements par des clubs historiques et l'émergence de clubs rachetés par des fonds d'investissements souverains - comme le Qatar pour le PSG.

Ainsi, le football ne sera plus jamais le même, et il semble aujourd'hui acté que les petits clubs ne pourront plus jamais vraiment concurrencer les grands d'Europe comme le Real Madrid, Barcelone, le Bayern et la myriade des clubs milliardaires qui accaparent tous les joueurs de talent.

Cette constitution d'un capitalisme du football ultra élitiste et à tendance monopolistique est profondément problématique. Le football a toujours été un sport populaire, pratiqué par les classes ouvrières. Il sert même de canvas pour permettre aux classes populaires de rêver d'un avenir meilleur, comme en témoigne le personnage mythique que fut Maradona pour les ouvriers argentins ou la multitude des immenses talents brésiliens issues des ghettos et dont la seule avenue pour le progrès socioéconomique était le foot.

Ainsi le football donnait à certaines catégories sociales des mythes qui servaient d'exemples. Mais la transformation du milieu en un club pour ultra riches va modifier cela, en éloignant les classes populaires du football, en rendant cette dernière financièrement de plus en plus inaccessible. Déjà, nous voyons la répercussion sur les droits télévisés, où il faut maintenant avoir un abonnement privé pour suivre la Ligue des Champions ou la Coupe du Monde.

### From the Pages of History - MT 60 Years Ago MAURITIUS TIMES

• Men's second childhood begins when a woman gets a hold of him. — James M. Barrie

The second Legislative Council dissolved on the last day of last year, five and a half years after it was voted into power, will go down in our history as one of its most significant landmarks. In fact, it constitutes, so far, the most crucial period of our short history. This is so because, to a very large extent, of its glorious achievements and also, but to a lesser extent, because of its few but glaring failures.

In approving the Representation of the People's Bill, the Legislature voted the most revolutionary measure ever voted in the annals of the Island. Overnight, it changed the status of the entire adult population. By putting the right to vote into the hands of the people, the Legislature by one stroke transferred a large amount of political responsibility to a people who only recently was looked down upon as immature and who had no say in the running of the country.

Next in importance came the introduction of the ministerial system which was preceded by the appointment of a Speaker to our Legislature. By making the elected representatives of the people share in the responsibility of governing the country we made a bold step forward in our political progress.

But it is to be regretted that we have not had full responsibility yet. And the presence of Nominated Members in the Executive Council has turned out to be a great impediment in the development of party government. The Ministerial System or rather the Ministers have done well but the awkward system is largely responsible for the unpopularity of the system itself. So much so that anybody who is intelligent or demagogic enough to play upon the unsolved problems of the people and who identify those problems with the ministerial system are apt to win a following.

This is a very sorry state of affairs which goes to the detriment of the Labour Party which has left no stone unturned to bring about the political emancipation of

the country. Labour will have to make much hard thinking and must be cautious so as to salvage its prestige.

The elaboration of the five-year plan by a ministerial committee and its approval by the Legislature is another great milestone. It was indicative of the Government's wish to assess the position of the country and to plan for the future. But, as we pointed out previously, our planners could not put first thing first. They could not face the overpopulation problem



squarely and that probably for religious reasons. The religious susceptibilities of one section of the population stood in the way of the Legislature.

This question of overpopulation has simply been deferred. We have shrinked before it but the next Council may well have to face it in an acuter form.

The coming of Mr Luce goes to the credit of the Council especially the Labour Party. But the pity of it is that the Council could not ensure the immediate implementation of Mr Luce's revolutionary recommendations. Mr Luce came to this country too late. He succeeded in focussing attention on our real problems. That was much in itself.

The increase of old age pension and the abolition of the means test are two other measures of far-reaching consequences approved by the Legislature. In spite of the fears of Mr Koenig and the apprehensions of the Nominated Members, it was indeed high time that the means test was abolished and thus bring some solace to a larger number of homes. It will not be out of place to express the country's gratitude to the Council for sponsoring and implementing such a humanitarian measure. We note also with great satisfaction that a Ministerial Committee considered the advisability and possibility of endowing the country with a Social

In the field of education, we had the new Education Code which was what the country needed. There was also the Income Tax Ordinance as well as the Council's decision to subsidize religious bodies hitherto unaided by the State. The report of the Police Inquiry Commission cannot be ignored nor the Plaines Wilhems Sewerage Ordinance.

Looking back on the work done by the disbanded legislators, one cannot fail to

However, one can neither overlook two glaring omissions. But there is a dangerous tendency abroad which seeks to render Labour responsible for the miseries of the people and to ascribe all the good works of the party to the other factions of the Legislature.

This constitutes a challenge to Labour a challenge which it must face with courage and determination.

## How Al could take over elections – and undermine democracy

Clogger would be able to carry on dynamic "conversations" with you – and millions of other people – over time. Clogger's messages would be similar to ads that follow you across different websites and social media.

#### The nature of Al

Three more features – or bugs – are worth noting.

First, the messages that Clogger sends may or may not be political in content. The machine's only goal is to maximize vote share, and it would likely devise strategies for achieving this goal that no human campaigner would have thought of.

One possibility is sending likely opponent voters information about nonpolitical passions that they have in sports or entertainment to bury the political messaging they receive. Another possibility is sending off-putting messages – for example incontinence advertisements – timed to coincide with opponents' messaging. And another is manipulating voters' social media friend groups to give the sense that their social circles support its candidate.

Second, Clogger has no regard for truth. Indeed, it has no way of knowing what is true or false. Language model "hallucinations" are not a problem for this machine because its objective is to change your vote, not to provide accurate information.

Third, because it is a black box type of artificial intelligence, people would have no way to know what strategies it uses.

It would offer three advances over the current state-of-the-art algorithmic behavior manipulation. First, its language model would generate messages — texts, social media and email, perhaps including images and videos — tailored to you personally. Whereas advertisers strategically place a relatively small number of ads, language models such as ChatGPT can generate countless unique messages for you personally – and millions for others – over the course of a campaign.

Second, Clogger would use a technique called reinforcement learning to generate a succession of messages that become increasingly more likely to change your vote. Reinforcement learning is a machine-learning, trial-and-error approach in which the computer takes actions and gets feedback about which



work better in order to learn how to accomplish an objective. Machines that can play Go, Chess and many video games better than any human have used reinforcement learning.

#### Clogocracy

If the Republican presidential campaign were to deploy Clogger in 2024, the Democratic campaign would likely be compelled to respond in kind, perhaps with a similar machine. Call it Dogger. If the campaign managers thought that these machines were effective, the presidential contest might well come down to Clogger vs. Dogger, and the winner would be the client of the more effective machine.

Political scientists and pundits would have much to say about why one or the other AI prevailed, but likely no one would really know. The president will have been elected not because his or her policy proposals or political ideas persuaded more Americans, but because he or she had the more effective AI. The content that won the day would have come from an AI focused solely on victory, with no political ideas of its own, rather than from candidates or parties.

In this very important sense, a machine would have won the election rather than a person. The election would no longer be democratic, even though all



of the ordinary activities of democracy – the speeches, the ads, the messages, the voting and the counting of votes – will have occurred.

The Al-elected president could then go one of two ways. He or she could use the mantle of election to pursue Republican or Democratic party policies. But because the party ideas may have had little to do with why people voted the way that they did – Clogger and Dogger don't care about policy views – the president's actions would not necessarily reflect the will of the voters. Voters would have been manipulated by the AI rather than freely choosing their political leaders and policies.

Another path is for the president to pursue the messages, behaviours and policies that the machine predicts will maximize the chances of re-election. On this path, the president would have no particular platform or agenda beyond maintaining power. The president's actions, guided by Clogger, would be those most likely to manipulate voters rather than serve their genuine interests or even the president's own ideology.

#### **Avoiding Clogocracy**

It would be possible to avoid AI election manipulation if candidates, campaigns and consultants all forswore the use of such political AI. We believe that is unlikely. If politically effective black boxes were developed, the temptation to use them would be almost irresistible. Indeed, political consultants might well see using these tools as required by their professional responsibility to help their candidates win. And once one candidate uses such an effective tool, the opponents could hardly be expected to resist by disarming unilaterally.

Enhanced privacy protection would help. Clogger would depend on access to vast amounts of personal data in order to target individuals, craft messages tailored to persuade or manipulate them, and track and retarget them over the course of a campaign. Every bit of that information that companies or policymakers deny the machine would make it less effective. Another solution lies with elections commissions. They could try to ban or severely regulate these machines. There's a fierce debate about whether such "replicant" speech, even if it's political in nature, can be regulated. The US's extreme free speech tradition leads many leading academics to say it cannot.

But there is no reason to automatically extend the First Amendment's protection to the product of these machines. The nation might well choose to give machines rights, but that should be a decision grounded in the challenges of today, not the misplaced assumption that James Madison's views in 1789 were intended to apply to AI.

European Union regulators are moving in this direction. Policymakers revised the European Parliament's draft of its Artificial Intelligence Act to designate "AI systems to influence voters in campaigns" as "high risk" and subject to regulatory scrutiny.

One constitutionally safer, if smaller, step, already adopted in part by European internet regulators and in California, is to prohibit bots from passing themselves off as people. For example, regulation might require that campaign messages come with disclaimers when the content they contain is generated by machines rather than humans.

This would be like the advertising disclaimer requirements – "Paid for by the Sam Jones for Congress Committee" – but modified to reflect its AI origin: "This AI-generated ad was paid for by the Sam Jones for Congress Committee." A stronger version could require: "This AIgenerated message is being sent to you by the Sam Jones for Congress Committee because Clogger has predicted that doing so will increase your chances of voting for Sam Jones by 0.0002%." At the very least, we believe voters deserve to know when it is a bot speaking to them, and they should know why, as well.

The possibility of a system like Clogger shows that the path toward human collective disempowerment may not require some superhuman artificial general intelligence. It might just require overeager campaigners and consultants who have powerful new tools that can effectively push millions of people's many buttons.

## Online brain games can extend *in-game* 'cognitive youth' into old age

University of California, Irvine-led Astudy has found that online brain game exercises can enable people in their 70s and even 80s to multitask cognitively as well as individuals 50 years their junior. This is an increasingly valuable skill, given today's daily information onslaught, which can divide attention and be particularly taxing for older adults.

"The brain is not a muscle, but like our bodies, if we work out and train it, we can improve our mental performance," said lead author Mark Steyvers, a UCI Prof of cognitive sciences. "We discovered that people in the upper age ranges who completed specific training tasks were able to beef up their brain's ability to switch between tasks in the game at a level similar to untrained 20- and 30-year-olds."

The findings, published in 'Proceedings of the National Academy of Sciences', underscore the cognitive cost of multitasking, which dilutes function by splitting focus, as well as the ways in which people across the lifespan can overcome the brain drain brought on by



both the increasingly cluttered multimedia environment and the natural aging process.

For the study, Steyvers and his colleagues partnered with Lumosity, an online platform that offers a variety of daily brain training games. They focused on data from "Ebb and Flow" -- a taskswitching game that challenges the brain's ability to shift between cognitive processes interpreting shapes and movement. Of the millions of people who played the game between 2012 and 2017, researchers randomly sampled the performance of about 1,000 users within two categories: those who ranged in age from 21 to 80 and had completed fewer than 60 training sessions; and adults 71 to 80 who had logged at least 1,000 sessions.

They found that the majority of older and highly practised players were able to match or exceed the performance of younger users who had not played very much.

"Medical advances and improved lifestyles are allowing us to live longer," Steyvers said. "It's important to factor brain health into that equation. We show that with consistent upkeep, cognitive youth can be retained well into our golden vears."





odern life causes lots of different types of rubbish. MIt comes from households, hospitals, schools, farming, shops, offices, industry and building projects. Just the rubbish from our homes can include food, packaging, plastics, metals, glass, paper, furniture, clothes, shoes, electronics, broken toys and garden wastes

We produce billions of tonnes of rubbish every year, and we need to manage it carefully to protect human health and our environment. Waste is managed in many different ways across our planet.

A way of thinking about how we get rid of our rubbish is called the waste hierarchy. It puts the different ways we deal with waste in order of preference, from the worst ways - such as burning rubbish - at the bottom of the hierarchy, to the best ways at the top.

#### At the bottom

The bottom of the hierarchy is waste disposal. This means getting rid of rubbish without trying to use it or turn it in to something else.

One way of doing this is to put rubbish in an open dumpsite. This is land where people tip solid or liquid waste with no treatment or pollution control. Dumpsites

like this take 40% of the world's rubbish. But open dumpsites have bad impacts on the environment. They produce gases that lead to climate change, and they can make people ill. There is a plan to close all open dumpsites

Another way is to use landfill - putting rubbish in a hole or heap that has been designed to safely hold rubbish. Landfill sites are carefully built to stop liquid pollutants and gases escaping. Landfill gas can be very dangerous. When a landfill is full, it is safely covered with soil and can be used to make parks or sports pitches.

You may be surprised to know that we used to dump rubbish in our oceans. This is now banned, but lots of plastic rubbish still gets into our oceans, killing marine birds and animals.

Another way to get rid of rubbish is to burn it, which can produce energy. People worry about burning rubbish because incinerators may release nasty harmful pollutants into the air. In some places, the gases are cleaned before they are released.

Composting is another way of getting something useful out of rubbish. It turns waste food into compost, which we can use in gardens and on farms to improve the soil.

#### In the middle

In the middle of the hierarchy is recycling. This means collecting materials in rubbish, such as plastic, paper, metal or glass, and using them to make new products.

Rubbish that can be recycled is collected from our homes in special boxes or wheeled bins. It is then transported to a recycling centre where it is sorted into the various materials. The next steps depend on what is being recycled.

For example, glass is recycled by melting the jars and bottles being recycled. The melted glass can then be used to make new glass objects. Paper cannot be melted and so it is broken into smaller pieces. It is then mixed with water, and this mix is used to make new sheets of



paper.

#### The best approach

The best ways to deal with rubbish are reuse and prevention.

Reuse means using something again instead of throwing it away. For instance, instead of putting a jumper you don't like in the bin, you could give it to a friend or take it to a charity shop.

Reuse was very popular when people didn't have much money, and it is becoming popular again to save money and improve our environment. There is an increasing interest in activities such as "swap shops" where people swap items they don't want for items they would like. Lots of people use the internet to donate things to charity or buy and sell secondhand items.

Waste prevention means doing things to stop rubbish being created in the first place - such as using cutlery you can wash and use again instead of a disposable plastic fork or spoon.

So there are lots of ways to manage rubbish - and we need to focus on waste prevention, reuse and recycling to protect and improve the environment.

## Jeunes, Argent et Travail

La lecture du budget est un exercice annuel qui mobilise l'attention de tout un chacun - la classe politique, le monde syndical, les acteurs du secteur privé, et les mesures annoncées comme par exemple, l'éducation des enfants, sont prises très au sérieux.

Ce rituel dont le ministre des Finances tient le double rôle de grand prêtre et de vedette de l'Assemblée suscite un tollé de critiques reposant sur des analyses argumentées et fondées pour les uns et, pour d'autres, relevant d'un jeu annuel de mécontentement et de rejet, une comédie jouée sur la place publique par les acteurs aguerris des deux côtés de la barrière politique et diffusée à travers les médias.

L'accalmie résultant de la baisse du prix de l'essence (dont la hausse, déclare-t-on, a servi de machine à sous à l'État pour tenir l'économie à flot) risque d'être éphémère si l'Organisation des pays exportateurs de pétrole, sous l'égide de l'actuel prince héritier de l'Arabie saoudite, met à exécution le plan de réduire la production de l'or noir. La grogne populaire pointera alors de nouveau le nez. En attendant, deux mesures taxées de 'populistes' par les opposants et qui ne peuvent qu'être bien accueillies par les bénéficiaires: l'augmentation de mille roupies pour les plus de 60 ans, et le chèque de vingt mille roupies que toucheront les futurs jeunes adultes de 18 ans.

Rs 20,000 à chaque personne qui atteindra l'âge de la majorité : c'est une aubaine. C'est une somme qui pourrait contribuer aux frais d'inscription à l'université. En 2019, le parti mauve avait proposé une allocation mensuelle de Rs 5,000 à chaque étudiant. C'était aussi raisonnable. Cependant, le bon sens voudrait qu'il faille d'abord connaître la valeur de l'argent et du travail pour pouvoir apprécier à sa juste valeur une somme qui vous est offerte par l'État, une collectivité nationale.

Ne faudrait-il pas d'abord que les adolescents scolarisés apprennent à gagner de temps à autre un peu d'argent pendant le week-end et les grandes vacances? Cela leur permettrait de sortir du cocon familial où tout leur est offert sur un plateau, d'apprendre à accepter des règles du monde du travail, à laisser les caprices à la porte et s'adapter à la personnalité d'un patron et apprendre des compétences sur le terrain. Toute une expérience qui leur permettrait de cultiver le goût de l'effort, de grandir et de gagner en maturité.

Est-ce que cette offre s'accompagnera d'un exercice pédagogique visant à sensibiliser les jeunes gens sur le bon usage d'une manne déboursée des fonds publics? La question mérite d'être posée, surtout pour une génération élevée

avec *smartphone*, abreuvée d'internet, accrochée aux divertissements virtuels en ligne et bercée par Netflix le soir venu à chaque fois que les cours privés pour atteindre les 'credits' honorables à l'examen de SC et HSC leur laisse un peu de répit. Ne parlons pas des marchands de la drogue qui rôdent autour des collèges comme les vautours qui guettent leur proie!

Un sociologue averti est à même de pouvoir démontrer comment un développement rapide du pays en l'espace de quelques décennies a quelque peu bouleversé la société par le progrès matériel et les biens de consommation, une prospérité que certains pays pourtant riches ont mis des décennies à acquérir. Cet aspect positif a été terni par un chamboulement sur l'échelle des valeurs qui influent sur les relations sociales et familiales. Une génération de parents s'est jetée à bras-lecorps pour saisir les opportunités dans les secteurs florissants de l'économie qui leur assurent des revenus élevés. Le désir d'apporter un maximum de confort dans le nid familial a quelque peu mis au second plan la nécessité d'inculquer le goût de l'effort, la valeur du travail et de l'argent aux adolescents en âge de comprendre le fonctionnement de la société.

Nombreux sont ceux qui ont profité d'une vie facile sans lever le petit doigt pour soulager leurs parents des corvées ménagères ou apporter leur contribution au portefeuille familial. Devenus salariés à leur tour, mais sans quitter le nid familial, ils continuent à vivre sous les ailes protectrices des parents et, à attendre, les pieds sous la table, que le dîner leur soit servi le soir. Leur volonté en faveur d'une participation financière dans le budget familial est plutôt aléatoire.

Et après? La trentaine apporte son lot d'obligations professionnelles et de responsabilités conjugales et parentales. Confrontés aux affres de la vie quotidienne prêt bancaire, logement, tracasseries professionnelles, déboires conjugaux, et garde d'enfants - c'est vers les parents que l'appel à l'aide est lancé. Cette solidarité est érigée en vertu, un trait valorisant des pays tiersmondistes et de culture orientale. Mais c'est aussi la cause de multiples dérives qu'il convient de mettre en lumière et d'y remédier.

Jadis les collégiens dont les parents tenaient une *boutik* étaient embauchés pendant les vacances et ils recevaient comme récompense une boisson gazeuse en fin de semaine. Ce temps est révolu. Et ce n'est peut-être pas à la génération de leurs parents, pris dans le tourbillon de la consommation et du paraître, qu'il faut s'attendre à une prise de conscience de l'infantilisation des adolescents et des jeunes adultes, étudiants et autres.

Certains parents très aisés ont cru bien faire d'offrir à leurs enfants - ayant à peine obtenu leur permis de conduire - une voiture de marque coûtant un million de roupies. Au vu de ce qui se produit souvent par la suite, est-ce que ce n'est pas une erreur monumentale ? Quel pourcentage parmi ces jeunes travaillent à temps partiel pour subvenir à leurs besoins pendant leurs études?

Le but est de faire l'expérience du monde de travail, d'avoir une occupation saine dans la vie réelle, d'acquérir le goût de la responsabilité et le plaisir de gagner de l'argent par soi-même. Si le travail des moins de dix-huit ans est une pratique courante dans les pays développés, pourquoi pas à Maurice où le niveau de vie s'est nettement amélioré depuis plus de trois décennies?
