# Uncertain and hard times ahead

**A**lthough it may seem that life is going on as normal, the reality is that there are global and local undercurrents that threaten peace, prosperity, stability, and security in all countries. And this despite the fact that nearly 60 countries are to hold general elections this year. In fact, in Bangladesh, Cameroon and Pakistan they have already taken place. Not unexpectedly in the latter two countries there has been violence in the process, with a bomb blast in Pakistan that has killed several people. In the same country, though, ex-Prime Minister Imran Khan who was a serious contender to the PM post has been jailed by a judicial process within a seemingly democratic set-up and barred from standing for elections.

The point is that democracy is suffering in many countries, and we have seen this in our own polity too, where strong-handed arm tactics have been repeatedly used to try and gag justified criticisms of measures that are destabilizing to our national institutions, so that even their guaranteed constitutional prerogatives have been effectively curtailed. No less than a bulwark of the safeguard of the citizen's freedom, namely the Office of the DPP, has been practically 'under attack' – something which should be and has been a great cause for widespread concern and worry among both professionals and the population in general. And again, this has been done in the very so-called temple of democracy – the Parliament.

Perhaps this is a natural corollary of what we have been witnessing in the matter of discussions and exchanges among the MPs in the Parliament. Since these are now available on live, citizens have had the opportunity of a quasi-ringside view of the happenings within the august house, and to say that they have been repeatedly appalled by the level of interactions is to put it mildly. Further, suspensions and walkouts, which ought to be exceptions, seem to have become the rule, as well as refusal to provide answers to PQs on several issues of national importance. There is no indication that even as we ourselves are in an election

year, the replies will be forthcoming before they take place.

On the other hand, when this will happen is also a question mark, although the PM has declared that he will abide by the law in the matter, it being his prerogative to decide on the date for the general election. Undoubtedly, the largesse that has been seen in the matter of pensions to the elderly and the increase in the minimum wage are calculated moves with a view on the forthcoming election. However, much of these increases have already been gobbled up by the rising prices, and these are set to increase further as the conflict in the Middle-East deepens and the Ukraine war prolongs without any end in view in a foreseeable future.

In fact the overall situation globally seems poised to aggravate even more, with the EU having voted to grant almost 50 BN USD in support to Ukraine, the rationale being that they are defending the sacrosanct freedom that Russia doesn't respect. More aware analysts view this as the triumph of the military-industrial complex with its eye on profits. In fact, several arms manufacturers gleefully announced an upshot in profits – that have been passed on to the CEOs etc – within months after the Ukraine war began. And they have now been given a shot in the arm! Never mind the disruption of supply chains that has affected the poorer countries.

And as if this were not enough, they are now further at risk with the attacks by the Houthis in the Red Sea. The counter-attacks by the combined US and other forces have so far not been able to contain the situation, and in the months to come we will no doubt be witnessing further increases in prices and likely inflation and impoverishment in, again, the poorer countries.

But we must not think that we will be spared either. Definitely, the times ahead are going to be very trying for all of us. How will we prepare to face them is the critical question both as individuals and as a country that stares at us in the face.

# Un moratoire pour l'immobilier

*La proposition d'un moratoire est un pas vers une réflexion profonde sur le modèle de développement du pays axé sur les morcellements fonciers et la braderie de pans entiers du patrimoine national aux étrangers*

**A**u nom de l'alliance de l'opposition parlementaire, le leader du PMSD, Xavier Duval, a annoncé qu'un éventuel gouvernement PTr-MMM-PMSD, décrèterait un moratoire concernant les gros projets immobiliers (IRS, PDS, RES, centres commerciaux) en attendant une étude approfondie de leur impact sur l'aménagement du territoire.

Ce moratoire serait une cessation temporaire dans l'exécution de gros projets immobiliers dans le pays afin de permettre aux autorités d'évaluer leur impact sur l'environnement (terre, air, eau, organismes vivants) en tenant compte des critères d'un aménagement du territoire planifié et viable. C'est une excellente idée dans la mesure où les morcellements fonciers permettant le développement immobilier sont réalisés, dans la plupart des cas, au détriment des écosystèmes naturels à Maurice.

Nous savons que ces projets ne sont pas souvent conformes aux normes de l'évaluation environnementale prescrite dans la loi, notamment l'*Environmental Impact Assessment (EIA)* sous *The Environment Protection Act, 2002*. Parfois, les projets sont sujets à un EIA minimal, donc inefficace, ou ils sont carrément exemptés de l'EIA. L'exemple le plus frappant de cette insouciance environnementale est le projet d'aménager une ville intelligente (*smart city*) sur un terrain marécageux à Roches Noires. La société civile s'est élevée contre ce projet dont l'EIA ne fait pas l'unanimité.

### Types de projets

Au fil des années, Maurice a conçu une panoplie de plans pour offrir différents types de propriétés immobilières principalement à une clientèle étrangère :

- l'Integrated Resort Scheme (IRS)* qui construit des villas de luxe avec terrains de golf dans les régions côtières pour des résidents non-citoyens au prix minimum de \$ 500 000 par résidence;
- le Property Development Scheme (PDS)* qui permet aux étrangers d'obtenir le droit de résidence à Maurice en achetant une propriété résidentielle de \$500 000 ou plus ;
- le Real Estate Scheme (RES)* qui permet la vente de propriétés immobilières aux étrangers sans un investissement minimal, mais sujette aux frais d'enregistrement de \$ 25 000 et à une taxe de cession de 5% sur la valeur de la propriété à la revente;
- l'Invest Hotel Scheme (IHS)* qui permet à un promoteur de construire un hôtel en vendant des villas, suites ou chambres dans l'hôtel à des acheteurs individuels. Sous ce plan, l'acheteur

utilise la propriété pour 45 jours au maximum et la loue au promoteur pour le reste de l'année d'après les termes d'un contrat de cession-bail (*sale-lease back*);

- le Smart City Scheme (SCS)* qui permet la création de villes intelligentes (*smart cities*) dans le pays sur de grandes surfaces.

À l'origine, le projet IRS fut lancé pour développer certaines régions côtières dans le cadre d'un tourisme haut de gamme. Mais au cours des années, ce projet de construction de villas de luxe pour de riches étrangers s'est étendu à toutes les régions côtières. Le gouvernement a ensuite ajouté d'autres projets (PDS, RES, IHS) pour mettre le pays sur la voie d'un développement immobilier débridé sans un respect rigoureux des normes d'un aménagement du territoire viable et intégré.

Dans bien des cas, ces projets ont été réalisés sur des terres agricoles qui ont été converties à un usage résidentiel ou commercial. L'article 5 de la *Sugar Industry Efficiency Act, 1988* permet la conversion de terres agricoles à un usage non-agricole moyennant le paiement d'une taxe de conversion (maximum de Rs 1 million par hectare). Cette taxe n'est pas assez dissuasive et des milliers d'hectares de terres agricoles ont été converties à l'usage résidentiel ou commercial au cours des années. Les gros propriétaires fonciers du secteur privé en quête de rente économique ont trouvé un beau filon pour mieux exploiter leurs terres et maximiser les

profits.

### Nouvelle filière

Les établissements sucriers en particulier se sont engagés dans cette nouvelle filière économique depuis la chute des prix du sucre sur le marché d'exportation, laquelle a eu pour résultat une chute énorme de la production de sucre (de 700 000 tonnes à 300 000 tonnes) depuis les années 1990. Avec un prix de vente en chute libre, le coût marginal de production du sucre (par tonne supplémentaire) avait dépassé le revenu marginal. Le secteur privé a développé ce nouveau créneau économique grâce à une fiscalité favorable: l'impôt maximal de 15% sur les bénéfices des sociétés depuis 2006, l'abolition depuis novembre 2011 de la taxe sur les plus-values réalisées sur la vente de biens fonciers, et les faibles taux de taxe sur la conversion de terres agricoles, les morcellements fonciers et les cessions immobilières.

En effet, tous ces projets immobiliers ont fait du pays un vaste chantier de construction où les permis de construction sont alloués à gauche et à droite sans respecter les critères d'une planification urbaine raisonnée et intégrée à l'environnement.

Les inondations fréquentes dans le pays ne sont pas uniquement les résultats du dérèglement climatique. Elles sont aussi les conséquences de l'abattage d'arbres et du déboisement dans certains endroits. Les canalisations naturelles des terrains autrefois agricoles ont été bouchées avec pour conséquence des inondations en temps de pluies diluviales.

# La célébration des lauréats, un événement qui célèbre l'excellence académique

**L**a semaine en cours a vu l'annonce des résultats des examens du HSC, marquant la fin traditionnelle de sept années d'études secondaires. Le taux de réussite total, tant pour Maurice que pour ses îles extérieures, en particulier Rodrigues, s'élève à 84,4%.

Cette annonce traditionnelle, marquant la fin d'un cycle pour les étudiants de la Forme Six, s'accompagne de la publication officielle de la liste de ceux qui se sont distingués en tant que "lauréats" avec les meilleures notes aux examens de Cambridge, dans diverses disciplines, des arts aux sciences en passant par le côté technique, et qui bénéficieront d'une bourse d'État.

La consécration de sept années d'efforts de la part des étudiants, de leurs enseignants et des parents s'accompagne de nombreuses célébrations enthousiastes. Les étudiants, les parents, les enseignants et les recteurs des collèges honorés partagent une joie commune. Ces distinctions remarquables ne manquent pas de susciter des réjouissances, renforçant le sentiment d'accomplissement au sein de la communauté éducative.

Au fil des ans, les écoles, les collèges et même les universités, qu'elles soient locales ou à l'étranger, ont érigé des traditions pérennes. Ces pratiques contribuent à consolider leur identité unique et à tisser des liens durables. Malgré l'élément évident de compétition à l'approche de la dernière ligne droite, ces institutions parviennent à créer un environnement où la réussite

individuelle est célébrée collectivement, nourrissant ainsi un esprit de camaraderie et d'excellence éducative.

Les lauréats jouent le rôle de modèles au sein de leur école, incarnant l'effort et la persévérance. Certains d'entre eux bénéficient du soutien conscient de leurs parents pour éviter une concentration excessive sur les études académiques, tandis que d'autres développent leurs talents à travers des passe-temps ou des intérêts naturels. À une époque où les médias occupent une place prépondérante, les lauréats offrent d'innombrables opportunités pour alimenter les médias radio, télévision et Internet. Leurs réussites sont célébrées à travers des couvertures, des interviews et des émissions qui se prolongent sur plusieurs jours.

Les célébrations entourant les lauréats représentent un moment précieux tant pour les étudiants que pour leurs écoles, la communauté éducative et les parents. C'est l'occasion de reconnaître les efforts méritoires de dizaines de personnes qui, pour quelques points seule-

ment, ont manqué le statut de lauréat. Néanmoins, ces individus ont toujours la possibilité de poursuivre des études tertiaires, que ce soit à l'étranger ou localement, que ce soit grâce à d'autres programmes de bourses ou par leurs propres moyens, notamment dans nos universités publiques gratuites.

Les lauréats, distingués sur la base du mérite, sont ensuite suivis par ceux bénéficiant de bourses accordées en fonction des conditions sociales des parents et des candidats. Cette mesure, introduite en 2013, permet d'ajouter près de 30 lauréats aux 49 déjà annoncés.

Certes, de nombreux problèmes persistent dans notre système éducatif, que ce soit en termes de voies, d'approche centrée sur les examens, de pressions de sélection importantes ou même de coûts pour les finances publiques. Ces discussions sont cruciales et méritent d'être menées, permettant ainsi l'expression de diverses opinions. Les questions telles que la durée de la filière, le manque de voies alternatives structurées pour ceux désintéressés par de longues études académiques, ou encore la nécessité des Académies, qui ont elles-mêmes introduit une sélection supplémentaire pour la 10e année, sont autant de sujets pour amorcer un débat constructif.

Le phénomène des lauréats célébrés est incontestablement un moment précieux, honorant les réussites académiques des étudiants et reconnaissant leurs efforts soutenus. Cependant, la question persistante de la fuite des cerveaux pourrait être soulevée, se demandant si le système actuel encourage inconsciemment le départ des lauréats vers des horizons étrangers.

Il y a donc une réflexion à mener en vue de créer les conditions propices à l'attraction des lauréats de retour au service du pays. Ainsi, le défi consisterait à transformer le programme de lauréat en un catalyseur du développement national, encourageant les talents locaux à explorer leurs horizons tout en mettant en place des incitations et des supports significatifs pour favoriser leur retour. Il est crucial d'établir des mécanismes favorisant le retour volontaire des lauréats, garantissant ainsi que leurs compétences contribuent de manière optimale au progrès et à la prospérité du pays.

**L**a Malaisie est actuellement le théâtre d'une enquête de grande envergure contre la corruption, avec l'ancien ministre des Finances Daim Zainuddin et son épouse inculpés pour non-divulgation de leurs avoirs. Cette affaire découle des révélations des 'Pandora Papers', pointant du doigt des avoirs offshore d'une valeur de 31 millions de dollars. Daim, un homme d'affaires de 85 ans, ancien ministre des Finances de 1984 à 1991 et de 1999 à 2001, nie toute faute et plaide non coupable.

L'enquête a débuté en 2023 après que 'Malaysiakini', partenaire média-tique de l'International Consortium of Investigative Journalists (ICIJ), ait exposé les liens de Daim avec plusieurs sociétés et fiducies des îles Vierges britanniques. Ces révélations faisaient partie de l'enquête des 'Pandora Papers' de 2021, basée sur une fuite massive de 12 millions de documents de 14 fournisseurs de services financiers offshore.

## Lutte contre la corruption en Malaisie: Leçons pour Maurice à tirer du cas Daim Zainuddin

Le couple fait actuellement l'objet d'une demande d'annulation des charges, et une autre fiducie familiale offshore, évaluée à 52,5 millions de dollars, est également sous enquête. La Malaisie, par le biais de sa Commission Anti-Corruption (MACC), intensifie ses efforts pour lutter contre la corruption, mettant en lumière d'importantes ramifications politiques et économiques.

La MACC a déclaré qu'elle enquêtait sur toutes les personnes associées aux 'Pandora Papers' et aux 'Panama Papers', intensifiant son action contre la corruption. Cette enquête de haut niveau a déjà touché plusieurs anciens politiciens et leurs familles, avec des saisies d'actifs significatives, y compris un gratte-ciel de 60 étages à Kuala Lumpur appartenant à la famille Daim.

Les autorités ont gelé les comptes bancaires de la famille Daim et ont élargi leurs investigations à d'autres personnalités politiques, comme Mirzan Mahathir, fils de l'ancien Premier ministre Mahathir Mohamad.

L'implication de Mirzan dans une entreprise des îles Vierges britanniques a été révélée dans les 'Panama Papers',

suscitant des enquêtes supplémentaires. Ces développements soulignent la portée internationale des enquêtes anti-corruption et la nécessité de la coopération transfrontalière pour obtenir des résultats probants.

En ce qui concerne Maurice, il existe des leçons cruciales à tirer de ces affaires. La commission anticorruption (ICAC) et les institutions politiques devraient intensifier leurs efforts pour lutter contre la cor-

ruption à tous les niveaux et dans tous les secteurs. La coordination avec des organismes internationaux, comme l'ICIJ, pourrait renforcer la capacité de l'ICAC à enquêter sur des affaires complexes et transfrontalières.

Les récents scandales en Malaisie soulignent également l'importance d'une surveillance étroite des avoirs et des transactions financières des personnalités politiques. L'obligation de déclaration com-

plète des avoirs, y compris les biens à l'étranger, devrait être renforcée à Maurice pour garantir la transparence et la responsabilité des fonctionnaires.

L'affaire Daim Zainuddin en Malaisie offre des perspectives précieuses sur les défis et les opportunités liés à la lutte contre la corruption. Maurice peut s'inspirer de ces expériences pour renforcer ses propres mécanismes anti-corruption et garantir une gouvernance plus transparente et responsable. Cependant, il est essentiel que la volonté politique soit véritablement présente afin que tout effort de lutte contre la corruption puisse produire des résultats significatifs.

## La crise persistante au Pakistan et les incertitudes des élections

**L**a crise actuelle au Pakistan, marquée par des problèmes économiques sévères et l'emprisonnement de l'ancien Premier ministre Imran Khan, soulève des doutes quant à la capacité des élections tenues hier à apporter une alternative significative. Ces élections décideront de la formation du prochain gouvernement du cinquième pays le plus peuplé du monde et de quatre provinces - le Baloutchistan, Khyber Pakhtunkhwa, le Pendjab et le Sind.

Imran Khan, récemment condamné à 14 ans de prison supplémentaires pour corruption, se trouve au centre de cette crise complexe. Les difficultés économiques, notamment l'inflation, le chômage et une crise de capitaux, ajoutent à l'incertitude quant à l'avenir du pays.

Le processus électoral au Pakistan, fonctionnant sous un régime parlementaire, décidera de la composition de l'Assemblée nationale et des quatre assemblées provinciales. Cependant, des complications émergent, notamment le refus de la Commission électorale du Pakistan (ECP) d'accorder au Mouvement du Pakistan pour la justice (PTI) son symbole électoral désigné, la batte de cricket. Cette décision force la majorité de ses candidats à participer en tant qu'indépendants. De plus, Imran Khan lui-même a été disqualifié de participer aux élections, étant interdit d'occuper un poste public pour la prochaine décennie.

L'histoire de Khan en tant que personnalité approuvée par l'armée pakistanaise, qui est devenue son principal adversaire, ajoute une dimension supplémentaire à la crise. Le désaccord a surgi autour de la nomination d'un chef de l'ISI contre la volonté de Khan et de sa visite en Russie, marquant la position agressive du Pakistan au début de la guerre Ukraine-Russie. Les récentes inondations de 2022 ont également exacerbé la situation économique, provoquant une hausse de l'inflation et augmentant les difficultés auxquelles la population est confrontée.

Les défis économiques du Pakistan sont profondément enracinés, avec une inflation dépassant les 30 %, atteignant un pic de 50 % en 2023, et maintenant à 28,3 % en janvier 2024. Le pays se trouve parmi les plus bas en termes de PIB, de revenu par habitant et de croissance économique dans la région. Selon l'Indice de développement humain du PNUD, le Pakistan se classe au 161e rang sur 191 pays, signalant des réalisations médiocres dans des domaines cruciaux tels que

la santé et l'éducation. En 2022, le taux de pauvreté atteignait 39,4 %. La dépendance élevée du Pakistan à l'égard des prêts étrangers, avec une dette de 80 milliards de dollars à rembourser dans les trois prochaines années, aggrave encore la situation.

Cette crise complexe ne peut être résolue par un simple changement de parti politique au pouvoir. Elle est ancrée dans des problèmes structurels profonds tels que l'inégalité, la concentration du pouvoir entre les mains de quelques-uns, surtout de l'armée, et le manque d'engagement des leaders à présenter des alternatives viables. Tous ces dysfonctionnements suscitent des préoccupations, d'autant plus que la population traverse des difficultés, que le scepticisme à l'égard du processus électoral croît, et que le pays semble s'orienter vers un avenir incertain, dépourvu d'une trajectoire de redressement bien définie.

### Quelques données relatives aux élections:

- Un total de 128 millions de personnes sont éligibles pour voter, ayant plus de 18 ans, sur une population de 241 millions d'habitants.
- L'Assemblée nationale du Pakistan compte 336 sièges, dont 266 seront pourvus par le biais du vote direct.
- 70 sièges sont réservés - 60 pour les femmes et 10 pour les non-musulmans.
- Le Pakistan formera son 16e Parlement.

- 276 402 bureaux de vote ont été installés dans tout le pays.
- Il y a un total de 69 millions d'électrices et 59 millions d'électeurs.
- Parmi les jeunes électeurs, 23,51 millions ont entre 18 et 25 ans et 33,34 millions ont entre 26 et 35 ans. 44 % des électeurs ont moins de 35 ans.



# A Biden Win or Trump President Again: What difference will it make to the World?

*A Trump presidency promises upheaval in Europe and at home, turmoil in Ukraine, a possible invitation to China to attack Taiwan, and disruption of global trade and supply chains.*

When Donald Trump was elected President, one of his first shots was at the NATO alliance. He questioned the very need for its existence, questioned America's commitment to defend Europe, criticized NATO members for not paying their fair share of the costs associated with the alliance, and spoke of putting America first. Europeans, dismayed by such talk, saw it for what it really seemed to convey: putting Putin first.

Upon his inauguration, one of President Biden's first priorities was to patch relations with NATO countries and the EU writ large. Putin's invasion of Ukraine brought home the urgency of keeping NATO together as a cohesive defensive alliance as well as a consortium with the economic clout to hold Putin in check.

Notwithstanding early support from the US and NATO countries for Ukraine, shortly after Putin's invasion of Ukraine, I predicted that Russia having failed to overrun that country, would engage in a war of attrition, and that this did not bode well for Ukraine. I foresaw a time when Western support for Ukraine would falter at least as far as the EU and European members of NATO were concerned, but that American aid was likely to continue.

Well, despite protestations and grumblings from Viktor Orban, Hungary's Prime Minister, about providing further aid for Ukraine, a \$54 billion (€50 billion) funding package passed last week. However, I was wrong in my confidence about unwavering American support for Ukraine.

After the October 7 attack on Israel by Hamas, President Biden had sought to put together a package combining aid for Israel as well as Ukraine, and some humanitarian supplies to Gazans. Extreme right-wing Republican members of the US House of Representatives balked at providing aid for Ukraine. At first, they tried to stall passage of a funding package on border enforcement. But when the Biden administration agreed in principle to that deal, the Republican legislators who had clamored for border enforcement suddenly did not want to pass the bill. What happened? Well, Trump happened. He asked the House Republican members who are firmly in his camp and known as the MAGA Republicans to scuttle the bill. The ostensible reason is that he wants to run on Biden's failure to enforce US immigration laws and stem the flow of illegal immigrants into the country as a winning campaign issue.

## Sinister truth

The truth may be more sinister. Trump continues to have a strange fascination with Putin and a desire to kill funding for Ukraine. Last month, he urged House Republicans to condition aid for Ukraine on a commitment

from the Biden administration to cooperate with investigations into alleged crimes by his son, Hunter, and the Biden family in general. As people around the world know, Trump is a moving target. He has boasted that he would bring about a ceasefire in Ukraine and end the war within 24 hours but has offered no details of his supposed "secret" plan.

Harking back to a 2019 telephone call during which Trump asked Ukrainian President Zelensky to assist in finding emails of the US Democratic National Committee which he claimed without proof, were in Ukraine, and as well to assist in an investigation of Hunter Biden, readers will remember that call formed the basis of the first impeachment trial of Trump. The former president may be on some sort of vendetta here.

The stark difference between the approaches of Biden and Trump toward NATO, Ukraine, and Russia, are only part of the risk profile that the US presidential election of 2024 presents for Europe and the world. Whereas Biden has sought to strengthen NATO and America's alliance with its European friends, Trump still seeks to destroy NATO and indeed, the backbone of the rules-based order that these allies have so long promoted and nurtured.

No American president has damaged his own country as much as Donald Trump. His four-year term as President was bad enough, culminating as it did with the insurrection at the United States Capitol on January 6, 2021, and his petulant recusant refusal to attend the inauguration of his successor, a time-honored tradition in a country that has prided itself

a country that has prided itself on a peaceful transition of power every time a new President is elected.

Now, it seems that the EU overcame the objections of the lone authoritarian, Viktor Orban. America may not so easily overcome the authoritarian tendencies of a Donald Trump. The power of the American presidency is formidable as major policy decisions can be made by one person.

As the US Senate struggles to put together a bill that will ensure funding for both Israel and Ukraine, the MAGA Republicans in the House continue to play games. The consequences for Taiwan's security could be disastrous. Trump appears willing to risk all this even before being back in the White House for a second term. What will he do if he is indeed reelected? Trump continues to propagate the myth that President Xi is a "friend" of his and a person with whom he gets along well. The truth is that President Xi has his own agenda, and that is no surprise. That agenda does not include being a friend of Donald Trump.

The former president has made it clear that he abhors war and does not want American troops stationed around the world. He had his Secretary of State sign an agreement with the Taliban for American troops to be withdrawn from Afghanistan. That task fell to his successor. Quite frankly, the Biden administration botched the withdrawal, but what will Trump do with respect to American troops stationed around the world? Will he usher in a new era of American isolationism and withdraw more troops? Will he abandon the Pacific and the South China Sea to Beijing?

Trump's attempt to destroy America's Democracy entered a new chapter when, after Biden's inauguration, he refused to show the gracious acceptance of election results that Richard Nixon, and Al Gore had mustered after their bitter electoral defeats in 1960 and 2000. No, Trump persisted in the BIG LIE that he was the real winner and that the election had been stolen from him.

## A delusional autocrat

All of this may be risible to the world, as it is to most Americans save a subset of MAGA Republicans or, as I like to call them, the MAGA Maggots. But there is a serious side to Trump's quest for a second term as America's President and Commander in Chief of its armed forces. No, it's not the danger of his starting a nuclear war, he seems to have a genuine abhorrence for that, but rather, the prospect of a second Trump presidency is grave cause for concern in terms of the geopolitical order, America's alliances with other nations, and for the world economy writ large.

Aside from the fragmenting of NATO, abandoning Ukraine, and risking Taiwan, Trump also promises to upend global trade. He has promised to uproot and deport millions of undocumented immigrants even if they have been in the US for years.

It is one thing to enforce immigration laws, but just imagine the impact on services in the US, on GDP, and the potential impact of an inflow of millions into Latin America, Africa, and Asia.

Or consider that he plans to impose a universal baseline tariff on most imported goods. In 2022, the US imported \$3.2 trillion worth of goods. A 10% tariff would impose minimum cost of \$320 billion, a 15% tariff, \$480 billion on American consumers. When one considers that a large share of imports are incorporated into the supply chain and marked up on resale, the impact could be as much as \$1 trillion or almost 5% of GDP.

Getting back to NATO, whereas Trump wants to gut that alliance and pull American troops back from Europe, he intends to send US troops into Mexico to contend with drug cartels. Whereas his constitutional authority for this is ques-

# Nouvelle alliance politique?

# 'Il y des rumeurs qui circulent... A l'Île Maurice, tout est possible en politique'

**U**ne analyse de la situation politique par Jocelyn Chan Low, historien et observateur de la société mauricienne, fait ressortir une vérité crue. Le système politique est si défaillant que les électeurs ne sont pas intéressés par les partis politiques existants sur l'échiquier. Toutefois, ils font leur devoir civique de voter pour élire un gouvernement et une opposition. Notre invité insiste sur un phénomène bordant la schizophrénie chez certains: au moment des élections, il y a une autre attitude qui se met en place contrastant avec le vivre-ensemble en harmonie habituel. Le jeu de forces entre groupes devient alors palpable.

Pourtant l'heure est grave car le dérèglement climatique est une réalité...

**Mauritius Times:** Actuellement, de nombreuses spéculations entourent la question de la tenue des prochaines élections. Pensez-vous que le Premier ministre souhaite repousser l'échéance jusqu'au bout de son mandat, c'est-à-dire vers la fin de l'année, ou cherchera-t-il à éviter la saison cyclonique à partir de décembre, notamment après les dégâts causés par le cyclone Belal et la mauvaise presse résultant de la gestion de ce cyclone et des inondations qu'a connues le pays?

**Jocelyn Chan Low:** Pravind Jugnauth a souvent répété qu'il ira au bout de son mandat, ce qui amène certains à conclure que les élections générales seront organisées au début de 2025.

Personnellement, je crois que c'est un leurre pour endormir l'opposition qui a plusieurs obstacles à surmonter avant la concrétisation finale de leur alliance dans les détails - composition du "front bench", répartition des candidats, programme, etc.

C'est un fait connu que les autorités n'attendent pas la dernière minute pour organiser les élections, et ce, pour être à l'abri d'un contretemps majeur et inespéré, surtout dans des pays tropicaux où les risques de tempêtes tropicales et d'inondations sont très élevés, notamment en été. Belal et les pluies qui l'ont accompagné l'ont démontré d'une manière dramatique.

Les mois de janvier à mars peuvent devenir des cauchemars pour tout pouvoir en place, surtout pour un régime qui compte sur la création, souvent artificiel, d'un "feel-good factor" pour rallier l'électorat.

\* Les dégâts survenus lors du passage du cyclone Belal et les inondations dans certaines régions du pays auraient probablement neutralisé le "feel-good factor" engendré par l'augmentation du salaire minimum et de la compensation salariale de Rs 1,500 à Rs 2,000, celle de la pension de vieillesse de Rs 12,000 à Rs 13,500 pour les pensionnés de 75-89 ans, ainsi que le cadeau de fin d'année de Rs 2,000 aux fonctionnaires. Voyez-vous donc les questions environnementales, et surtout celle de la gestion des calamités, devenir un enjeu majeur lors des prochaines élections?

Dans un contexte de réchauffement planétaire et de bouleversements climatiques, les questions environnementales devraient être un enjeu majeur des élections dans toutes les démocraties du monde.

Il est vrai qu'à Maurice, en raison de l'exiguïté du territoire et d'une population restreinte, tous les efforts consentis

ne changerait pas grand-chose à la situation mondiale. Il faut cependant des mesures urgentes pour contrer les effets du dérèglement climatique sur le pays et sur la population en général.

Les constructions et le bétonnage effectués d'une manière désordonnée sans considération à l'évacuation des eaux de pluies ont rendu des endroits tels que des quartiers de la capitale ou les environs du cimetière de Saint-Jean et d'autres endroits encore à travers le pays en des zones à très haut risque pendant toute la saison cyclonique et les périodes de fortes pluies.

De plus, il faut se rappeler que l'île Maurice est située dans une zone géographique 'cyclone prone' et que l'idée que le pays puisse être victime de telles catastrophes est profondément enracinée dans la psyché du Mauricien.

Deuxièmement, pour que ce soit un enjeu majeur, il faudrait bien que les partis et les alliances en présence se focalisent dessus. Mais ni le gouvernement ni l'opposition n'ont intérêt à faire revivre les terribles mémoires des tragédies non seulement de janvier 2024 mais aussi de mars 2013 et de 2008...

\* **Quelles options s'offrent à l'alliance au pouvoir en ce qui concerne le timing des prochaines élections? Y a-t-il des facteurs particuliers qui pourraient influencer cette décision?**

Il est évident que l'alliance au pouvoir organisera les

élections après le budget 2024, l'effet des augmentations du salaire minimum, de la pension de vieillesse pour les plus âgés des "seniors", et d'une compensation salariale relativement élevée s'étant dissipé avec les inondations accompagnant Belal.

D'ailleurs le PM a fait comprendre à ses partisans que le gouvernement a un autre budget dans la poche avant les prochaines élections. Il dispose ainsi d'une fenêtre de temps entre juillet et mi-décembre 2023, ou le début de la saison des grosses pluies.

Au début du 20e siècle, l'île Maurice fut la proie d'une très grande crise économique et un très grand nombre d'artisans se retrouvèrent au chômage. Ils s'organisèrent en syndicat privé et envoyèrent des pétitions au gouverneur réclamant de l'aide.

Dans une note au Bureau colonial, le gouverneur ne put s'empêcher de constater que les Mauriciens sont de braves gens et que l'idée 'socialiste' est très ancrée dans le pays: le Mauricien s'attend que l'État lui fournisse tout-du travail, l'éducation de ses enfants, des services de santé et d'autres encore gratuitement ! Et on sait que l'Etat-providence est une des grandes réalisations de l'île Maurice contemporaine.

Dans plusieurs publications académiques, j'ai décrit Maurice comme un des rares "developmental social-democratic states" de l'hémisphère sud. L'idée du "Welfare State" est si ancrée, qu'au moment des réformes de réajustement structurelles de la FMI et de la Banque mondiale à la fin des années 70 et au début des années 80, ces deux institutions abandonnèrent l'idée de réduire l'Etat-providence, sachant que tout gouvernement qui y toucherait se verrait balayé par un 60-0 et qu'elles auraient à recommencer les négociations à zéro. C'est l'unique cas au monde où le "Structural Adjustment Programme" fut appliqué sans une réduction de l'Etat-providence.

Depuis, l'élargissement de l'Etat-providence, à travers le transport gratuit pour les étudiants et les personnes âgées, l'augmentation des allocations et des facilités pour les retraités, l'aide de l'Etat pour garantir le paiement du salaire minimum, etc., a été une constante dans la République de Maurice. Et tous les partis politiques se retrouvent désormais dans une situation où il leur est impératif d'inclure de telles mesures dans leur programme au risque d'être rejettés dans le 'karo kann'. Et il est évident que Pravind Jugnauth ne s'en privera pas pour rallier l'électorat.

\* Y a-t-il des facteurs particuliers susceptibles d'influencer la politique en marge des prochaines élections?

A ce stade, il est essentiel de souligner ce que je considère comme les trois fondamentaux de la situation politique de l'île Maurice d'aujourd'hui.

D'abord, nous avons un gouvernement au pouvoir qui dispose d'une faible légitimité populaire. En effet, le MSM et ses alliés n'ont récolté que 37% des votants aux dernières élections générales –moins de 30% de l'ensemble de l'électorat. Et la situation n'a guère évolué depuis. Selon le dernier sondage de Synthèses, réalisé en septembre 2023, parmi ceux qui s'étaient exprimés sur leur intention de vote, les partis au pouvoir ne recueillaient que 24% contre 36% en faveur de l'alliance de l'opposition.

Mais attention ! L'opposition parlementaire a beaucoup de points faibles alors que l'opposition extra-parlementaire est quasi-inexistante, son poids étant très marginal dans l'électorat. Ainsi, par exemple, les sondages révèlent que la popularité de Pravind Jugnauth devance de loin celle de Navin Ramgoolam. En fait, il existe un énorme "credibility gap" entre l'électorat et l'opposition traditionnelle et extra-parlementaire.

Et, finalement, les sondages révèlent que près de 70%

de l'électorat ne croient plus dans les dirigeants politiques actuels et seraient prêts à voter pour une nouvelle personnalité politique en tant que Premier ministre. Ce fort courant dégagiste et cette immense désaffection par rapport aux partis politiques existants constituent un phénomène totalement inédit dans l'histoire politique du pays.

Mais comme il est pratiquement impossible pour qu'un nouveau leader politique-homme ou femme- émerge d'ici les élections générales, il est évident que les prochaines élections se joueront entre deux alliances de partis traditionnels, menées par des dirigeants actuels, tentant tant bien que mal de gagner les faveurs d'un électoralat. Et ce dernier, pour la grande majorité, leur est potentiellement hostile! Cependant, le Mauricien étant en général un animal politique, il ira voter bien qu'on puisse prévoir une petite hausse du taux d'absentéisme.

Un tel contexte est évidemment propice à la démagogie populiste et aux promesses d'élargissement démesuré de l'Etat-providence.

\* Qu'en est-il de certaines questions spécifiques liées aux droits de l'homme, à la gouvernance ou à d'autres aspects tels que la situation économique actuelle du pays? Pensez-vous que ces questions influenceront le vote des citoyens?

Elles auront certainement une place de choix dans la campagne électorale surtout qu'on assiste actuellement à un glissement progressif de Maurice vers une démocratie illibérale, ce qui commence à inquiéter des observateurs étrangers. Il faut toutefois souligner que cet état de choses ne date pas du présent régime.

Sur la question de bonne gouvernance, le "track record" de ceux qui se présentent comme alternative au PM et au

gouvernement n'est pas très reluisant. Les allégations de scandales, de corruption, de népotisme, etc., ont aussi foisonné sous d'autres gouvernements. Et, quelques fois, même les bonnes intentions ont eu de mauvaises conséquences sur l'évolution des institutions du pays.

On sait que la Constitution de 1968, malgré certaines provisions restrictives, notamment par rapport à l'état d'urgence, avait érigé des garde-fous et un système de "checks and balances" pour prévenir tout glissement vers un "illiberal democracy" où tous les pouvoirs sont concentrés dans les mains d'un seul homme, en l'occurrence le Premier ministre. Par contre, l'article 113 restreint grandement les priviléges et les immunités des hauts fonctionnaires et même des détenteurs de postes constitutionnels. La Constitution de 1968 prévoyait que les détenteurs de postes constitutionnels évoluent dans un cadre où il pourrait agir indépendamment du PM. Ainsi le Commissaire de Police était nommé pour un minimum de 4 ans. Désormais, il pouvait être nommé pour un maximum de 4 ans et même pour une période de 3 mois ! Comment garantir l'indépendance de l'institution dans un tel cas?

Il faut ajouter que certains hauts fonctionnaires peuvent être mis à la porte “on grounds of public interest”. Ainsi l'administration civile conçue pour être indépendante du pouvoir politique devient un instrument au service du parti au pouvoir. Il est vrai que les dirigeants d'alors redoutaient les crocs en jambe d'une administration nommée par Sir Seewoosagur Ramgoolam et Sir Gaëtan Duval. Mais, sans le sa-voir, ils avaient ouvert une boîte de pandore, comme le souligne Joseph Tsang Man Kin.

\* En ce moment, comment évaluez-vous la perception publique à l'égard du gouvernement?

Difficile à déchiffrer car le public n'est pas homogène et les opinions vont inévitablement varier en fonction de la tranche d'âge, de l'ethnicité, de la classe sociale, etc.

Cependant, ce mécontentement n'entraîne pas, comme auparavant, un ralliement à l'opposition dont l'image est aussi très écornée. Or, un partage de 32 tickets pour le PTr et de 28 pour le MMM-PMSD aux prochaines élections serait-il de nature à rassurer la “Hindu belt”? Cela alors qu'on sait pertinemment bien que logiquement une bonne partie des candidats du PTr affronteront un MSM bien ancré dans les régions rurales alors que le MMM et PMSD peuvent théoriquement enlever des circonscriptions dans les régions urbaines où l'opposition a fait un meilleur score aux dernières élections générales...

Par ailleurs, la surface cultivable dans le pays rétrécit comme une peau de chagrin au moment où les besoins de sécurité alimentaire (garantie en partie par les cultures vivrières et l'élevage) et les besoins de sécurité énergétique (assurée par des énergies renouvelables) se font plus pressants, avec pour corollaire une dépendance accrue sur les importations.

**Ségrégation sociale**

Sur le plan social, tous ces projets immobiliers ont créé des agglomérations exclusives (*gated communities*) pour des étrangers et/ou Mauriciens bien nantis dans le cadre d'un système de ségrégation de classe. Certaines agglomérations sont uniquement habitées par des étrangers dans un système d'apartheid social. Un étranger qui visiterait Rivière Noire et Tamarin dans l'Ouest du pays se croirait en Afrique du Sud au temps de l'apartheid. L'opulence ostentatoire dans ces agglomérations contraste singulièrement avec la pauvreté de certains villages avoisinants.

La proposition d'un moratoire est un pas vers une réflexion profonde sur le modèle de développement du pays axé sur les morcellements fonciers et la braderie de pans entiers du patrimoine national aux étrangers. Il est probable que cette réflexion ne mène pas à une remise en question du modèle, mais au moins elle permettrait d'analyser les méfaits d'un développement foncier débridé, incohérent et néfaste à l'environnement. Si cette réflexion débouche sur des mesures susceptibles de corriger les excroissances du modèle et éviter les effets négatifs sur l'environnement, ce sera déjà un pas dans la bonne direction.

Dans les démocraties plus établies, la défaite aux élections entraîne le retrait automatique du leader du parti et la nomination d'un nouveau leadership chargé de la mission essentielle de "rebranding" du parti pour les prochaines échéances électorales.

Dans la République de Maurice, tel n'est pas le cas car les partis politiques sont des partis personnels, non collectifs ni démocratiques, mais sous le contrôle d'une seule personne qui, en outre, dans certains cas, finit par installer une dynastie.

Ceci rend l'exercice de "rebranding" extrêmement difficile, voire impossible et cela explique aussi la succession de défaites. Je vous rappelle qu'aujourd'hui les "hardcore" — les fameux 'dépôts fixes' — ont fondu comme neige et l'électorat semble dégouté de la classe politique actuelle et veut du nouveau - des vrais, pas des "fakes" comme on retrouve à foison dans les partis extra-parlementaires.

La tâche est ardue. Une solution possible serait d'introduire une majorité de nouveaux candidats compétents au passé politique irréprochable et désigner un "shadow cabinet" où les nouveaux seront majoritaires et où les anciens dirigeants deviendraient des "mentors". Idéalement, on proposerait un arrangement pour le poste de Premier ministre à l'israélienne, mais avec une personnalité crédible issue de PTr lui-même. Ce serait une manière forte d'acter la transition.

Il y a évidemment le programme. L'élargissement de l'État providence doit être l'un des piliers de ce programme non seulement pour contrer la campagne du gouvernement mais surtout parce qu'en démocratie, c'est l'un des moyens les plus efficaces pour atténuer le problème des inégalités historiques.

prend même pas la peine de lire les manifestes électoraux.

En ce qu'il s'agit de l'économie, il faut certainement des mesures fortes pour consolider nos acquis et éviter le désastre. Cependant, à trop mettre l'accent sur les difficultés économiques, l'opposition risque de voir son discours être perçu comme annonciateur d'une politique d'austérité à venir. Or, c'est exactement ce que l'électorat ne veut pas entendre.

Je me souviens qu'en 1983, le MMM avait fait campagne autour d'une politique de vérité au moment où des milliers de personnes étaient au chômage dont des maçons qui constituaient le gros de l'électorat des cités ouvrières. Sir Gaetan Duval, par contre, était venu avec la fameuse promesse de "Solange, amenn mo diary", et en tant que 'militant-coaltar' nous avions pu constater comment cela avait fini par faire basculer une bonne partie de cet électorat vers l'alliance bleu-blanc-rouge...

\* La prochaine campagne électorale risque d'en-gendrer une surenchère politique marquée par des attaques personnelles et d'autres abus. Même le meilleur joueur de football aura à quitter le terrain un jour. Croyez-vous que les leaders, plus particulièrement ceux de l'opposition, pourront survivre et rebondir face à une énième défaite? En fait, l'après-élections générales pourrait bien voir le début d'un nouveau cycle, avec de nouveaux acteurs et de nouvelles idées. Pour ceux qui militent pour un vrai changement dans la vie politique à Maurice, it could be a very exciting time ahead!

## Israel's Netanyahu rejects ceasefire proposal, renews pledge to destroy Hamas

Israeli Prime Minister Benjamin Netanyahu said on Wednesday total victory in Gaza was within reach, rejecting the latest offer from Hamas for a ceasefire to ensure the return of hostages still held in the besieged enclave.

Netanyahu renewed a pledge to destroy the Palestinian Islamist movement, saying there was no alternative for Israel but to bring about the collapse of Hamas, reports Reuters.

"The day after is the day after Hamas. All of Hamas," he told a press conference, insisting that total victory against Hamas was the only solution to the Gaza war.

Hamas had proposed a Gaza ceasefire of four-and-a-half months, during which all hostages would go free, Israel would withdraw its troops from the Gaza Strip and an agreement would be reached on an end to the war.

The Hamas offer, the contents of which were first reported by Reuters, is a response to an earlier proposal drawn up by U.S. and Israeli spy chiefs and delivered to



Hamas last week by Qatari and Egyptian mediators.

U.S. Secretary of State Antony Blinken discussed the offer with Netanyahu after arriving in Israel following talks with the leaders of Qatar and Egypt, the countries that have acted as mediators. Blinken later met Palestinian

President Mahmoud Abbas in Ramallah.

Israel began its military offensive after militants from Hamas-ruled Gaza killed 1,200 people and took 253 hostages in southern Israel on Oct. 7. Gaza's health ministry says at least 27,585 Palestinians have been confirmed killed, with thousands more feared buried under rubble. There has been only one truce so far, lasting just a week at the end of November.

Israel has previously said it would not pull its troops out of Gaza or end the war until Hamas was wiped out.

But sources described Hamas as taking a new approach to its longstanding demand to end the war, now proposing this as an issue to be resolved in future talks rather than a condition for the truce.

A source close to the negotiations said the Hamas counterproposal did not require a guarantee of a permanent ceasefire at the outset but that an end to the war would have to be agreed before final hostages were freed.

## Repeated US strikes pushing govt to end America-led coalition's mission: Iraq

Repeated US strikes against Iran-backed armed groups in Iraq are pushing the government to end the mission of the U.S.-led coalition in the country, the prime minister's military spokesman Yahya Rasool said on Thursday.

The US military said a strike on Wednesday killed a commander from Kataib Hezbollah, an Iran-backed armed group in Iraq that the Pentagon has blamed for attacking its troops, reports Reuters.

Rasool said in a statement that the US-led coalition "has become a factor for instability and threatens to entangle Iraq in the cycle of conflict".

The US-led international military coalition in Iraq was set up to fight Islamic State. The United States has 2,500 troops in Iraq, advising and assisting local forces to prevent a resurgence of the group.

Since the Israel-Hamas war in Gaza began in October, Iraq and Syria have witnessed almost daily tit-for-tat attacks between hardline Iran-backed armed groups and US forces stationed in the region.

## Maldives at high risk of debt distress amid heavy borrowings from China, warns IMF

The strategically-placed Indian Ocean nation of the Maldives, which has borrowed heavily from China and shifted allegiance from India, is at high risk of "debt distress," the IMF warned Wednesday.

Beijing has pledged more funding for the Maldives since pro-China President Mohamed Muizzu took power in November.

Muizzu thanked China last month for its "selfless assistance" for development funds after a visit to Beijing, reports AFP.

The International Monetary Fund did not give details of the Maldives' foreign debt but said there was a need for "urgent policy adjustment".

"Without significant policy changes, the overall fiscal deficits and public debt are projected to stay elevated," the IMF said after a review of the country's economy.

The archipelago, famed for its white sand beaches and where tourism accounts for nearly a third of the economy, has recovered economically from the Covid-19 pandemic.

But while a planned airport expansion and an increase in hotels are projected to boost growth, the IMF said "uncertainty surrounding the outlook remains high and risks are tilted to the downside."

Muizzu's mentor, former president Abdulla Yameen,

who ruled for five years until 2018, borrowed heavily from Beijing for construction projects.

That left it owing 42% of its more than \$3 billion foreign debt to China in 2021, according to the World Bank, citing the Maldives' finance ministry.

Muizzu, who has requested that Indian troops operating three reconnaissance aircraft in the Maldives leave by May 10, has vowed to strengthen his military to defend the country's vast maritime territory.

Global east-west shipping lanes pass through the nation's chain of 1,192 tiny coral islands, stretching around 800 kilometres (500 miles) across the equator.

# Indian students in US universities living in fear after 2 deaths in a week, 'Scared to travel alone'

The Indian community in the US is reeling from the recent string of sudden deaths among Indian students across American universities this month. The circumstances surrounding these tragic events vary, with one student losing his life in a shocking murder, another succumbing to suicide, and several deaths remaining unexplained. Numerous questions linger, leaving the community grappling with uncertainty and seeking answers.

Some of the deaths this year include the brutal murder of Vivek Saini, the suicide of Sameer Kamath, the mysterious demise of Neel Acharya, and Akul Dhawan's death due to hypothermia, reports Hindustan Times.

### 'You always have to be situationally aware'

In the aftermath of the recent deaths, Indian students studying in the US spoke with Hindustan Times about their concerns.

Kajari Saha, 28, from the University of California, Santa Barbara, said she felt a "sense of alienation" after learning about the incidents. "You always have to be situationally aware and surround yourself with people who feel safe to you," she said. "I live in California, a very liberal state compared to others. However, there is a bit of racial profiling, no matter where you go."

"Although I am mostly surrounded by friends, I can imagine how threatening it must feel for someone who lives by themselves and in the vicinity of where these incidents happened," she added.

### 'There were occasions when I felt scared to travel alone'

Vivek Saini, an MBA student in Georgia's Lithonia, was brutally attacked and killed by a homeless man named Julian Faulkner. The gut-wrenching incident was caught on camera.

Faulkner reportedly hit Saini about 50 times on the head with a hammer. The incident took place at the Chevron Food Mart at Snapfinger and Cleveland Road.

"I first came across the news on X and it shook me to the core. I think over the past year, there has been a growing number of crimes, including some hate crimes, among different communities and unfortunately some-

times students are on the receiving end of it," Anukta Datta, 28, also from the University of California, Santa Barbara, said.

On being asked whether Indian students in the US have reasons to feel threatened, she added, "Having lived in Michigan and California over the last six years, I think this is very subjective. Although Ann Arbor is a very buzzing and rather safe college town in the Midwest, there were still occasions when I felt scared to travel alone. These incidents can be very worrying for Indian students, mostly based on where they live and their surrounding community."

Anukta said that Southern California has appeared to be a relatively safer place to her. "However, over the course of the last winter break, we did get some news about sporadic thefts and robberies here, which did take me aback," she said, adding that "there is an added concern about security given the not-so-stringent gun control laws in the country."

Indian-American student Akul Dhawan was found dead outside the University of Illinois Urbana-Champaign (UIUC) in January. His father later criticised the police for inaction. The initial findings of the autopsy suggested he died from hypothermia, according to the Champaign County Coroner.

"It is terrible, of course, and somewhat scary," Aritra

Basu, 29, from University of Massachusetts Amherst, said of all the recent deaths. "I do not really think Indian students in particular are being targeted, or are victims of hate crimes on a wide scale. But I do feel threatened when I read reports of increasing gun violence, and white supremacist political movements. Increasing socio-economic inequality has spillover effects too."

### The Purdue deaths

In just a month, two Indian students of Purdue University in West Lafayette, Indiana, have lost their lives. Neel Acharya, a student who went missing days ago, was later found dead on the Purdue campus. An autopsy conducted on January 29 revealed that there were no signs of trauma on his body. The cause and manner of death are under investigation.

Indian-origin doctoral student Sameer Kamath, who studied at Purdue too, was found dead at a nature preserve this week. The 23-year-old reportedly died from a self-inflicted gunshot wound to the head.

The deaths have sent shockwaves across Purdue. A student of the university expressed his fear, saying on the condition of anonymity, "It sent a wave of disbelief and concern among the Indian student community. Neel's death, especially, has heightened my sense of concern about safety on campus. It makes me question the overall security measures and prompts us to consider what more can be done to ensure the well-being of students."

Acharya and Kamath's deaths are not the only ones to have rocked Purdue. In 2022, a 20-year-old Indian-origin student studying at the university, Varun Manish Chheda, was murdered by his 22-year-old Korean student Ji Min 'Jimmy' Sha, who was later arrested.


Elsewhere in the US, in January this year, two 22-year-old Telugu students were found dead in their room in Hartford town of Connecticut. Gattu Dinesh from Wanaparthy district of Telangana, and R Nikesh from Palakonda of Parvathipuram Manyam district, were found dead on January 14 after inhaling carbon monoxide emitted by a room heater.

## King Charles has cancer. Can this make astrologer Nostradamus' predictions true?

Buckingham Palace revealed on Monday that King Charles is facing a battle with cancer at the age of 75. The monarch will temporarily step back from public duties for treatment but hopes to return soon.

British author Mario Reading, in his book 'Nostradamus: The Complete Prophecies for the Future,' explained that the people might force out the King due to disapproval of his divorce. Reading stated, "A man will replace who never expected to be king."

**Nostradamus' track record:** Nostradamus has a history of accurate predictions about British Royals, including

the death of Queen Elizabeth in 2022 at around the age of 96, according to Reading.

**Prince Harry's return amid father's health:** Prince Harry, King Charles' estranged son, arrived in London on Tuesday after the cancer diagnosis. While the health situation may encourage reconciliation between father and son, healing the rift with Prince William, the heir to the throne, remains a challenge.

**Family dynamics and challenges:** Royal watchers suggest that Charles's health could be a catalyst for a reunion between father and son. However, reconciling with Prince William may prove more difficult due to the ongoing tensions from Harry's departure from royal life.

**T**he idea of using Creole as a medium for mass education in Mauritius has long been haunting me. I remember putting the suggestion forward to the late Seenevassen when he came to London with the delegation in February 1957. In June, the same year, when I called a meeting at the House of Commons to discuss the possibility of creating the *Mauritius League*, I again brought forward the question in the speech I then delivered. Most of our more perspicacious university students saw eye to eye with me and agreed that the language of the majority must be respected and be given prominence and dignity if the country were to forge ahead at a greater speed. I believe I also hinted at it in one of my articles, which appeared in *Advance* about that time.

It is most surprising and deplorable to hear even a section of our intelligentsia — those who are especially responsible for moulding the public mind — contending that Creole is a "mere dialect," that it cannot be made into a written and standardized language. It clearly shows how half-baked even a section of our élite can be. Perhaps it's sheer snobbishness not to recognise Creole just as another vehicle through which one puts over what one has to say, and as having as much 'dignity' as French or English or any other standard language. A knowledge of history would reveal to us that these European languages were, only four centuries ago, considered as "undignified" as Creole is today.

Writing about the Renaissance, the author of *Glimpses of World History* has this to say about the European languages: "The new spirit that was abroad affected the young European languages powerfully. These languages had existed for some time, and we have seen that Italy had already produced great poets. In England there had been Chaucer. But Latin, the speech and language of the learned and of the Church all over Europe, overshadowed them all. They were the vulgar tongues — the vernaculars. It was almost undignified to write in them. But the new spirit and paper and printing pushed these languages ahead. Italian was first in the field; then followed French and English and Spanish and, last of all, German. In France a band of young writers in the sixteenth century resolved to write in their own language and not in Latin and to improve their 'vulgar tongue' till it became a suitable medium for the best of literature." And H.G. Wells in his *Outline of History* tells us: "With the fourteenth century, the real history European Literatures begins. We find a rapid development of Standard Italian, Standard English, Standard French...These lan-

guages became literary languages: they were tried over, polished by use, and made exact and vigorous." It is high time we took a leaf out of the lesson of History in this country in connection with the "national language".

We should copy the first-class methods of priests who have used vernaculars and turned them into written languages in their relentless endeavour to reach the common people through the language they best understand. One example — not too far away from us — is Swahili in East Africa which has comparatively recently been made a written language. If we really want the advancement of the common people, who, after all, now have a greater say in the affairs of the country, we must come to their level and identify ourselves with them. There is, or should be, no shame in expressing an idea or speaking to a person in a language that is more current. On the contrary, it is quite logical — and sensible. It would be preposterous to speak to an Englishman or an Italian in Creole, in England or in Italy! We should be Romans in Rome!

Any well-meant information for the public must, to be effective, be in the language understood by all. It would in fact, be superfluous to write or to speak in other languages when one is universally understood in the country. Not all of us understand "Better careful than crippled". In our campaign for cleanliness, for instance, it would be much better for us to use "Tache manière garde la ville prope" than "help to keep Port Louis clean." In some buses one reads: "Please help the conductor by tendering the exact fare." If these words were meant for English tourists, perhaps it would have been suitable. We normally want those whom we are so pleased to call "the riff-raff" to know what they should do. Therefore, the easier the language, the more response we shall have.

On the other hand there are sensible

people among us who have had the courage of standing up against the barrage of carping criticisms, often aped by the fickle, narrow and mediocre mind. We must applaud the officers of the Department of Agriculture who showed exemplary initiative during the Agricultural Week organised by them at Triolet some months ago for addressing the public in general in Creole. We still remember the dialogue in Creole Messrs Walter and Jagatsingh had on the Radio. These I call true leaders who will, ignoring all the temptations of inarticulate vanity, come down to the level of the masses whom they sincerely wish to serve and condescend to talk to them in the language they all understand.

Mauritius must move forward with logic

and reason and forget nay laugh at the vain and ridiculous attitudes of some of our "great men" who will shun the language of the common people for fear of being looked upon as undignified. Wherever there is reason, there should be dignity. Our leaders should together take the initiative in freeing the country from all its false concepts which obfuscate the mind, prevent any clear and creative thought and retard our progress. This is or should be the Age of Reason, the age of new ideas when we must determine here and now to break away from the shackles of past and burdensome traditions, from the false sense of shame and from all other barriers to progress.

No progressive country in the world today can fail to realize the importance of the use of vernacular in the education of the masses. It appeals directly to all and is understood by all. Today, when we are striving for self-determination and sovereignty, it is all the more important to speed up progress, that we should use the language of the largest number, which is quite in consonance with democracy. It is inevitable that long-implanted and petrified ideas, or barriers that have grown up in our mind, will take time to be shed or broken down, for, to quote the author of *Glimpses of World History* once more "the most terrible of walls are the walls that grow up in the mind which prevent you from discarding an evil tradition simply because it is old, and from accepting a new thought because it is novel"; but if we only value a sense of freedom, the vacuum would easily be filled. Life, after all, perpetuates itself through changes and new creations.

**Cephalus:** (leaning back) True, but where's the fun in politics if we strip away the mystery? It's like attending a tragedy without the suspense – a dull affair.







## 'Broken heart' syndrome is on the rise in women

'Broken heart' syndrome is seeing an alarming increase among women, according to recent research. Takotsubo cardiomyopathy, colloquially known as 'broken heart' syndrome, is a condition often triggered by stress or loss, leading to long-term heart injury and impaired function. The study, featured in the Journal of the American Heart Association (JAHA), highlights a concerning rise in diagnoses among middle-aged and older women, occurring up to 10 times more frequently than in younger women or men of any age.

The investigation, based on national hospital data from over 135,000 individuals diagnosed with Takotsubo syndrome between 2006 and 2017, reveals a steady increase in cases, with women constituting the majority (83.3%), particularly those aged 50 and above. The annual incidence grew six to 10 times faster for women between 50 and 74 compared to other demographics.

Notably, this upward trend predates the Covid-19 pan-



demic, challenging assumptions about its impact on the syndrome. Susan Cheng, MD, MPH, MMSc, the senior author of the study and director of the Institute for Research on Healthy Aging, emphasizes the critical role the heart-brain connection plays in women's overall health.

### Key findings from the study include:

- \* The annual incidence of Takotsubo cardiomyopathy increased steadily, primarily affecting women (83.3%),

especially those over 50.

- \* Middle-aged and older women experienced a significantly greater increase in incidence compared to younger women and men of all age groups.

- \* The study is the first to explore age-based sex differences and changing case rates over time.

Cheng notes that the brain and nervous system response to stress changes as women age, potentially leading to a tipping point beyond midlife where stress excessively affects the heart. Ongoing research at the Smidt Heart Institute aims to explore the long-term implications of Takotsubo diagnosis, molecular risk markers, and factors contributing to rising case rates.

The study underscores the Smidt Heart Institute's leading role in identifying female-pattern heart disease, developing diagnostic tools, and advancing specialized care for women. While the link between stress and heart disease risk is acknowledged, there remains much to uncover. Christine M. Albert, MD, Chair of the Department of Cardiology at the Smidt Heart Institute, emphasizes the need for further exploration to unravel the underlying drivers of Takotsubo condition and other conditions predominantly affecting women.

## You don't need words to calm a grumpy kid. Parents around the world use a magic touch

In 'Psychological Care of Infant and Child', published in 1928, psychologist John B. Watson cautioned parents to keep physical affection with their children to a minimum, lest it make them dependent and unable to take on the world as adults. "You could give them a pat on the head if they did something really special,

but when you greet them in the morning, you could give them a handshake," he suggested.

Watson's advice may sound needlessly cold to our modern ears. Still, compared to many cultures around the world, many American moms and dads are underutilizing touch in their parenting,

according to NPR contributor Michaeleen Doucleff.

Take bedtime. Most advice around settling down young kids for bed focuses on how to talk to them. Yet from Korea, to India, to Mexico parents calm their kids with a type of gentle touch. This type of touch goes by different names in different

cultures, but generally involves softly scratching the head, back or arms. Neurologists have observed that such gentle stroking turns on special nerves, in the hairy parts of our skin, reducing pain perception and slowing heart rate. And it works for adults too.



## Why do people and animals need to breathe? A biologist explains why you need a constant source of oxygen

*Inhaling air is how you get the oxygen your body needs to turn your food into energy. Other living things use different strategies.*

You need to breathe for the same reason you need to eat: It helps you make the energy your body requires.

You probably already know that food is fuel for your body. When you eat, food gets broken down in your stomach and enters your bloodstream.

From there, it gets delivered to your cells. Inside your cells are even tinier structures called mitochondria, which are the engines that power your entire body. Your mitochondria use the nutrients from food as fuel. But to turn it into energy, they need one more ingredient – oxygen.

I am a biologist who studies animals and plants. All living things need oxygen, except for some bacteria and a few tiny animals that don't. You might be surprised to learn how many ways there are to get oxygen – breathing is only one of them.

### Lungs and their linings

When you breathe in, your lungs temporarily trap oxygen, allowing it to pass through very thin surfaces in your lungs into your bloodstream.

Because you need a lot of oxygen, your lungs need a lot of surface area to do their job. They achieve this by having millions of little air sacs lined with tiny blood vessels

called capillaries.

If you could somehow flatten out all the capillary surface area in your lungs, it would more than cover the floor of an average classroom – around 1,350 square feet (125 square meters).

### Getting enough oxygen

If breathing is kind of like eating, why can't you just take three breaths a day?

One reason is that air on Earth is only 21% oxygen – the rest is mostly nitrogen. That means you need to take five breaths just to get the equivalent of one complete lungful of oxygen.

Also, when you take a breath, only some of the oxygen makes it into your bloodstream. Even though people and

many animals make specialized proteins to grab and carry oxygen, there's a limit to how much they can hold at once. To keep your body's oxygen levels high enough to power all your cells, you need to keep breathing.

Of course, once you breathe in, you also have to breathe out. The gas you breathe out is called carbon dioxide. You can think of it as the exhaust from your mitochondria engines, the leftovers once the mitochondria burn oxygen and nutrients to release energy.

### Other animals and plants

Most living things get oxygen without lungs.

Many aquatic animals use gills, which are sort of like lungs turned inside out. Instead of a bunch of capillaries wrapped around air sacs, gills are a bunch of capillaries sticking out into the water. Just like in your lungs, the blood vessels take in oxygen from the water and release carbon dioxide.

Insects take in oxygen through a network of little air tubes just under their skin, sort of like the chimneys of a building. This

system works because insects are small, so the tubes are already close enough to their cells to give them oxygen. When large insects need extra energy, they pump air through the tubes with their muscles.

Plants have little holes in their leaves called stomata. They open and close to let in air when plants need it. Plant roots need oxygen, too, which they usually get from the soil.

You may have heard that plants are the opposite of people: They breathe in carbon dioxide and breathe out oxygen. That's true because carbon dioxide is a crucial ingredient in photosynthesis – the process plants use to make their own sugar fuel – and oxygen is a byproduct. But plants' mitochondria also need oxygen to make energy, just like yours do.

Even though most animals and plants don't breathe in and out the way people do, they all have ways of getting enough oxygen. Learning how organisms solve the same problem in different ways is one of my favorite things about biology.

Then, the girl took two cookies and lied about it. When asked why she had done that, she said because she thought that God was only watching oranges.



## Frequent Urination at Night: A Sign of Diabetes?

### Understanding Nocturia: Could Frequent Nighttime Urination Indicate Diabetes?



While it's normal for adults to go to the bathroom once during 6-8 hours in bed, frequent nighttime urination could be a signal of an underlying health issue, with diabetes being one of the potential culprits.

**Why could it be diabetes?** One of the early signs of diabetes is an increased need to urinate, both during the day and at night. Excess sugar in the blood, a common occurrence in diabetes, requires the kidneys to work harder to eliminate it, leading to an increased production of urine. This process does not cease during sleep, contributing to nocturia. Additionally, diabetes can cause damage to the kidneys or bladder, further exacerbating the need to urinate.

**Other reasons for nocturia:** While diabetes is a significant factor, several other reasons may contribute to frequent nighttime urination, including:

**1. Age:** Aging affects hormone levels that regulate urine production at night, leading to an increased volume in the bladder.

**2. Excessive Fluid Intake:** Consuming large amounts of water or beverages containing caffeine or alcohol before bedtime can fill the bladder and prompt nocturnal awakenings.



**3. Diabetes Insipidus:** Unrelated to type 1 or type 2 diabetes, this condition results in excessive urine production due to the kidneys.

**4. Medical Conditions:** Various health issues such as urinary tract infections, heart failure, an enlarged prostate, pregnancy, chronic kidney failure, tumors in the bladder or prostate, liver failure, and sleep apnea can contribute to nocturia.

**Other Diabetes Symptoms:** If diabetes is the cause of your frequent nighttime urination, you may also experience additional symptoms, including:

- \* Increased thirst
- \* Larger appetite
- \* Unexplained weight loss

- \* Blurry vision
- \* Fatigue
- \* Tingling or numbness in hands or feet
- \* Increased susceptibility to infections and slower healing

**Seeking Medical Advice:** If you notice any of these symptoms, it's crucial to consult with a healthcare professional. Diabetes is a serious condition that can lead to various health complications. Your doctor can perform specific blood tests to diagnose or rule out diabetes:

**1. A1c Test:** Measures average blood sugar levels over the past 2-3 months. An A1c level of 6.5 or higher indicates diabetes.

**2. Fasting Blood Sugar Test:** After an overnight fast, blood is tested. A level higher than 126 mg/dL on two tests indicates diabetes.

**3. Oral Glucose Tolerance Test:** After fasting, blood is sampled before and 2 hours after consuming a sugary drink. Levels over 200 mg/dL after 2 hours suggest diabetes.

**4. Random Blood Sugar Test:** Blood is sampled at a random time, and a level of 200 mg/dL or higher indicates diabetes.

These tests may need to be conducted twice to confirm a diabetes diagnosis. Early detection and management are crucial in addressing diabetes and preventing potential complications. If you suspect diabetes or experience any concerning symptoms, consult your healthcare provider promptly.

## Listening to Your Body: Understanding Signals and Taking Action

Our bodies are remarkably communicative, often providing signals when something is amiss or needs attention. Learning to listen to these cues is essential for maintaining overall health and well-being. "rehab" exercise routine, recommended by your doctor.

**Pay Attention to Heart Rate Changes:** If you experience lightheadedness, dizziness, or abnormal heart rates, it could indicate an underlying health issue. Consult with a doctor if symptoms persist, especially if accompanied by chest pain or difficulty walking and speaking.

# The Perils of IT and Social Media

*We have let loose the monsters of IT and social media onto every half-educated even uneducated Tom, Dick and Harry. Yet they feel empowered because they can access information without being educated*

“Your product is killing people”. This was US Senator Josh Hawley addressing Meta Chief Executive Mark Zuckerberg at a US Senate hearing which started on January 31. Zuckerberg's response was as evasive as ever. He apologised and said that “we will continue making industry-wide efforts to ensure that families do not suffer”. The hearings started with testimonies of parents and children about the social and psychological issues faced by youngsters exposed to social media platforms. Suicides, eating disorders, unrealistic beauty standards, bullying, sexually addictive behaviour, etc., were some of the issues raised by parents and children in their recorded testimonies. Child rights advocates have for long asserted that giant social media companies were not doing enough to protect users from the ill-effects of their platforms. The Committee will also hear CEOs of TikTok, X, etc.

Earlier, we had seen how over 40 States in the US were suing ‘Meta’ for building algorithms in its Instagram and Facebook platforms, which promoted addictive behaviour. Anti-trust regulators in several European countries have also heard pleas demanding greater regulation of social media companies and questioned the business models of IT giants like Microsoft and Google, etc. Amnesty International has produced a report titled ‘Driven into darkness’ which documents the many ills which users are facing.

So, do you see a glimmer of hope – a small sliver of light in the darkening dungeon of toxic social media? Perhaps yes. It is only the bright light of enquiry and transparency which can destroy the rot created by greedy IT companies. The question is, why are we not seeing enough debates on this mounting social crisis? Has this destructive technology already destroyed something in us? The spirit of questioning and enquiry?

Every student from the post WW-II generation will remember how, at one time or another, they were required to write an essay, or join a debate, on “Is nuclear power a boon or a bane? Is it a blessing or a curse?” Massive public mobilisations were seen across the world and most responsible nations backed away from large scale adoption of nuclear energy for civilian projects. All promises of clean and boundless energy, safety measures, etc., were rejected by the people. Strong non-proliferation treaties and laws also ensured restrictions on the widespread use of nuclear weapons.

We have also witnessed public debates on the health hazards of ‘processed and fast food’, ecological perils of

big hydroelectric, transportation and mining projects and dangers of introducing new pharmaceutical products without adequate clinical trials. Public awareness campaigns against tobacco effectively reduced smoking to a socially unacceptable behaviour. The debate against use of fossil fuels continues as we grapple with global warming and climate change. But we don't see IT causing any similar damage to our natural habitat and causing disease, do we? Their offices are made of shiny steel and glass. Right? No, the ubiquitous IT sector is polluting another natural resource, perhaps as precious as the air, water and land which we are struggling to save. It is polluting our minds, it is giving rise to mental issues and playing havoc with our social equilibrium.

If producers of spurious or potentially hazardous technology and substances could be hauled up for exemplary damages, then why are we not seeing enough regulatory activity against the global IT giants? The moot point is that public scrutiny alone can safeguard public interest, not proforma apologies and promises of “industry-wide self-regulation”. We need public spirited regulations and severe penalties for those selling deleterious technology to unsuspecting masses. But before that we need widespread public enquiries and debates on IT and, now the even bigger social disrupter, AI.

The occasional article in newspapers and journals on how IT and social media tools influence public opinion, and thus elections, in the ‘free world’, or how algorithms are designed to spread fake narratives, outright lies and create a ‘need’ for unnecessary and useless goods and services are helpful. But we are still not seeing enough disclosure on how digitisation of all data and processes is opening up the lives of people, institutions and countries to ceaseless surveillance, paving the path for massive subversion of nations and coercive control over common people. Peoples' lives were supposed to be personal under transparent governments, toady we have turned this paradigm on its head – opaque governments pry into each sphere of the common man's life.

Do some of you get a sense that I am opposed to technology? I am most certainly not. With an M.Tech in Systems Management from one of our most reputed institutions - where we were working on an IBM-360 mainframe, when most of the world did not know what a computer was - I am a great believer in how technology has helped humankind emerge from a life of drudgery, and

how the industrial revolution was perhaps the greatest wealth creator in recorded history. The difference is that the technology of the last two hundred years emerged out of felt needs of people, it was developed to ease the travails of industrial and agricultural work. So we consciously accepted that the price we paid in terms of ecological damage, for the benefits of a better lifestyle, was unavoidable – at least in the short term.

The IT sector, on the other hand, creates ‘products’ and then hunts around for people it can be sold to, of course making false claims of increasing efficiency and transparency. It thus invests large sums of money to create unnecessary demands. Does it sound like the junk food and sugary drinks industry? Well, it is exactly that. Just as junk food gives you an energy rush - a quick pick me up, the efficiency promised by IT ‘products’ is also nebulous, and the dependence, or craving for more of the same, keeps growing.

IT and the internet are certainly amongst the most powerful and useful tools developed by man. The technology has revolutionised the way we work and collate information for making better and informed decisions. But then so was nuclear power. The difference is that while access to nuclear technology was restricted to a few highly qualified educated and trained scientists, we have let loose the monsters of IT and social media onto every half-educated even uneducated Tom, Dick and Harry. Yet they feel empowered because they can access information without being educated, albeit without the faculties to discriminate between facts and falsehood. Therein lies the danger.

We must therefore start by asking questions and disabuse ourselves of certain notions about this technology propagated so strenuously over the last few decades.

You might say that the IT sector is providing highly paid jobs for our young, so what is wrong with that? Since the remunerations are fairly high, start by asking what these jobs are? Why the salaries are so high is a separate question which needs examination. Let us focus on the nature of these jobs. These are essentially of four types: The most challenging and creative ones are undoubtedly for writing original software, programming and systems analysis. Only a very few graduates land up jobs of this type.

The second category involves retrofitting existing software, tailoring it for specific consumers. They do nothing original but are the ‘Seventh Wonder’ type of tailors, who used to alter and refit your old suits. Still, they do add value to the products in the market. The third category revolves around maintenance of IT systems and software which is about fixing malfunctions and bugs. Still there is some technical contribution involved here. The fourth category of jobs, which draws the most number of youngsters is about data collection, processing of data, digital marketing and sale of the data processed by them.
