

Labour Day and Political Manoeuvrings

abour Day, a global tribute to the contributions of workers, arrives once more next Wednesday. This international observance, known as May Day, resonates deeply with nations worldwide, each marking it in their unique ways. From parades to protests, it serves as a poignant reminder of the ongoing struggle for fair labour practices and workers' rights.

Yet, in Mauritius, this occasion often serves as more than just a tribute to the labour force. It has become a battleground where political contenders flaunt their electoral prowess, vying for the attention and support of the masses. Amidst promises and inducements, the true essence of the day can sometimes get overshadowed by political theatrics.

This year, however, Labour Day holds particular significance, as the last before impending general elections. The political landscape is fraught with uncertainty, as alliances shift and allegiances waver. The recent departure of Xavier Duval and the PMSD from the Opposition alliance has sent ripples through the political landscape, potentially reshaping the balance of power in the run-up to the elections.

At the heart of the political manoeuvring lies a quest for strategic advantage. Both the ruling alliance and the Opposition are engaged in a high-stakes game of chess, each move calculated to outmanoeuvre the other. The alliances seek to bolster their ranks, to solidify their support base, and to sway the crucial bloc of undecided voters (some 50% or more of the electorate) whose allegiance could tip the scales in their favour.

It remains to be seen whether the departure of the PMSD from the opposition alliance has injected a new dynamic into the political equation, raising questions about the strength and cohesion of the Opposition bloc. Conversely, one may wonder why the ruling dispensation would have spent such inordinate efforts on seducing the PMSD if their existing construct of the MSM plus minor allies was so confident. Does the rapid split of the PMSD, with a major bloc sticking to the Opposition alliance as Nouveaux Democrates, sound the death knell for MSM courtship of the PMSD? Or is the road to victory more fraught with obstacles than ever before for Navin Ramgoolam and his Labour Party, as well as Paul Berenger and the MMM?

The ruling alliance, meanwhile, may see an opportunity to consolidate its grip on power, capitalizing on the vulnerabilities of its opponents. However, these assumptions would need verification, and the attendance at the rallies of the different political factions may not provide an accurate representation of the balance of power in the political arena, as is often assumed.

Yet, amidst the political jockeying and electoral posturing, there lies an opportunity for renewal and revitalization at the level of the Labour Party and the MMM. It's also an opportunity to create space for new voices and perspectives to emerge, challenging the status quo and injecting fresh energy into the political discourse. It is a moment for Mauritians to reflect on the direction in which they want their country to move, to envision a future that is inclusive, equitable, and just.

However, the path forward is fraught with challenges, both old and new. Economic inequality, unemployment, proliferation of drugs and access to essential services continue to plague Mauritian society, casting a shadow over the promise of progress. As political leaders trade barbs and make promises, it is imperative that they address these pressing issues with concrete policy proposals and solutions, rather than empty rhetoric.

Furthermore, the integrity of Mauritius' democratic institutions must be safeguarded at all costs. Transparency, accountability, and adherence to the rule of law are not mere buzzwords-they are the bedrock of a healthy democracy. Need we recall here that "vendetta" politics has cost the nation and ordinary Mauritians dearly already (Betamax, BAI/Bramer, Neotown) or that the US State Department latest report is rather sanguine on its perceived failures of the regime's democratic and governance functions? Political leaders must demonstrate a commitment to ethical governance and responsible leadership, earning the trust and confidence of the electorate through their actions, not just their words.

As Mauritius stands at the crossroads of history, it is essential that its leaders rise to the occasion, guided by a sense of duty and a vision for the future. The road ahead may be long and arduous, but it is one that must be travelled with courage and conviction.



South Africa's youth are a generation lost under democracy – study

Fewer young South Africans are doing as well as their counterparts from 30 years ago. They are hardest hit by unemployment

outh African president Cyril Ramaphosa recently painted a rosy picture in which the country's youth – "democracy's children" – had enormous opportunities for advancement, all thanks to successive post-apartheid governments led by the African National Congress (ANC) that he leads.

But what is the real state of young South Africans – defined as people below the age of 34 – after 30 years of democracy?

I have more than 30 years' experience in socio-economic and development research as well as political and governance reform. My recent research paper tracing 30 years of analysing youth marginalisation has found that youth in South Africa, who make up 34.3% of the population, have not fared well under democracy. They are the hardest-hit by unemployment and the lack of opportunities, and show high alienation.

Fewer young people are doing as well as their counterparts from 30 years ago; most are muddling along, searching for opportunities.

Measuring marginalisation

The idea of "marginalisation", as used in my analysis, had its origins in the early 1990s. In 1992 a large survey, 'Growing up Tough', was run by Mark Orkin and I among South African youth of all races so that the first democratic government could understand what they needed most. The survey recorded indicators like unemployment and level of education, as well as subjective views like feelings of alienation (not belonging in society).

The results were arranged on a scale of how far some young people had been pushed to the margins of

society. Those who scored in the negative on all, or almost all, indicators were labelled "lost". Those who barely featured or did not score at all on the negative indicators were labelled "fine". Others fell in between.

The survey was run again in later years, with amendments. The most recent, analysed here, was in 2018, as part of a broader quality of life survey.

Comparing data from the 1992 and 2018 indices of youth marginalisation, the same proportion (5%) is clearly "lost" – scoring off the chart on virtually every indicator. Sadly, at the other extreme, where 25% of youth were "fine" in 1992, this had dropped to 16% in 2018.

In the two categories in between – "marginalised" and "at risk" – the more worrying "marginalised" has shrunk, which is positive, while "at risk" has grown.

South Africa has changed profoundly since apartheid, and for some, including some young people, there are countless more opportunities than previously. But, analysed as a generational cohort, youth today are only a little better off than when apartheid ended in 1994. And the share of young people is doing well now has fallen by 9 percentage points

Looking at the 15-24 cohort in late 2023, using the "expanded" definition of unemployment, a staggering 60.7% are officially unemployed; among the group aged 25-34, unemployment only drops to 39.8%.

From Maroons to Trade Unions: The Persistent Spirit of Mauritian Workers

With jobless growth, workers have become easily replaceable, and the rupee in the pocket is no longer the same. Poor working conditions, alienation, and harassment are widespread

ight from the Dutch period, workers brought to Mauritius — whether coerced, voluntarily, or involuntarily have always sought to fight for human dignity and freedom. In spite of the odds against them, they never gave up and have continued to fight up to the present and will do so in the future. This consciousness of the worker to resist exploitation, whether in an economic system which was pre-capitalist or capitalist, was translated into various forms of action depending on the context and the resources available. Today, an enlarged and wider consciousness has become imperative so that they can face the multiple challenges of modern life and build a new society.

In South African literature, the concept of Black worker consciousness, as defined by historians like Ian R. Phimister and C. Van Onsenlen, refers first to the consciousness and concern of workers to maximize wages and move towards the highest paying employment centres to combat the law. Secondly, to combat coercive legislation, workers expressed their discontent not directly 'but in the nooks and crannies of the day-to-day work situation.' This response was not different from slave resistance in America, which 'side by side with ordinary loafing went deliberate wastefulness, slowdowns, feigned illness, self-inflicted injuries and the well-known abuse of livestock and equipment.'

Tn Mauritian history, we are all familiar with Imarooning and vagrancy which has marked colonial history during the Dutch, French, and British periods. Not only did slaves escape to the forest as soon as they landed during the Dutch occupation of Mauritius, but slave revolt was carried out by slaves, convicts, and freemen of different 'nationalities.' As Megan Vaughan has reminded us, in 1695 there were 11 of them from Madagascar, Bali, Batavia, Bengal, Goa, Mozambique, Malabar, Padang, and Patti. Direct and indirect forms of protest and resistance took many forms despite repression by planters assisted by colonial and religious authorities.

Even the free artisans from France were severely repressed under Labourdonnais, and one worker had to get his wife to write to the authorities in France to secure his release as he could not do it himself. So he wrote to her:

'If you want me to come you will have to ask the (authorities) since we are not allowed to make such request, and if we do they tie us to a cannon on a cheval de bois in the dungeons and we see nothing but this unjust treatment... and so I ask you to use your friends to get me out of this country. Our grandparents too were severely repressed and school-going children were brainwashed by reciting the first lesson in their textbook the ideology of the capitalist class - God is great. One has to work for one's bread.'

Even when the Code pénal prevented workers from coming to improve their wages, worker consciousness flowed into new channels in the form of worker organizations, friendly and mutual societies before the advent of trade unions. Dr Cure's 'Société de Bienfaisance' was a disguised form of trade union when the latter movement was still illegal.

In the 20th century, it was on the initiative of Edgar Laurent that the first trade union of railway workers was set up. He had gathered some railway workers in Curepipe and provided them with a template for a trade union organization. Wilfrid Moutou set up the first union, which was against the law. It was tolerated because railway workers constituted an 'aristocracy of labour' which was relatively harmless, though the union did go on strike on at least three occasions.

The best example of worker consciousness among labourers before the law on industrial associations was passed is the march of labourers on Union Sugar Estate in 1937. It was not a strike nor a spontaneous response on the part of labourers. It was a carefully planned march; the roads the protesters were to take were known in advance, and coordination took place among the various villages. When police blocked the roads they were to take, they used other bypass routes to reach Union Factory.

The employers had already been informed by the police on the eve; they armed themselves and were faced with what was a 'threatening crowd' according to Magistrate Osman. The employers panicked and fired on the labourers.

Trade union consciousness

After the setting up of industrial associations in 1938, worker consciousness moved towards trade union consciousness. Apart from individuals who continued to stand up for their rights, it was trade unions which took up the challenge of advancing the cause of the working classes throughout the colonial period. In the 1970s, great efforts were made to turn the unions into class-based organizations with mixed results, as trade unionists sought to pursue reformist and parliamentary strategies albeit more realistic, to safeguard the rights of workers.

In the 21st century, while trade unions continue to defend and protect workers in a world where the latter have to grapple with the challenges of globalization and technological revolution, workers need to expand their horizons and develop an expanded worker consciousness. This would empower them but at the same time equip trade unions to better protect, defend, and improve the welfare of workers.

The challenges facing workers, whether they do blue- or white-collar jobs, are daunting. With jobless growth, workers have become easily replaceable, and the rupee in the pocket is no longer the same. Poor working conditions, alienation, and harassment are widespread in the workplace. The worker at the computer suffers from musculoskeletal disorders and eye problems which are detrimental to health. The girl at the checkout in the supermarket is as alienated as the factory worker when she has to spend a whole day at the checkout with 'Bonjour, Scan, Bag, Payment and Bye'.

Even in the past, the workers did not fight only for wages; they sought better working conditions, better living conditions, and better health protection. The worker has his own conception of fairness, justice, right, and wrong - what historian EP Thomson has called the moral economy of workers. Today, workers continue to fight for these rights when their workload is increased in the name of productivity, when they are given punitive transfers, are discriminated against, or robbed of their wages to cut labour costs.

These daily struggles are important for the worker individually, for they transform him as he refuses to become a cog in the production machine or a cipher in the organization. They are also important collectively for the rest of the workers, for they provide models of resistance and point to workers the norms that they should aspire to and which should become the norms of society so that each worker can develop his human potential to the maximum. In so doing the individual struggle contributes to the collective struggle as workers identify themselves with these struggles, develop solidarity, sharpen their consciousness and see ultimately a commonness of purpose for workers and for society as a whole.

Given the interconnectedness of society, workers' struggles cannot be limited to work-place problems and will necessarily extend to other issues. Workers cannot ignore the fact that their leisure time has been reduced. The environment has become polluted and coal ash dumped here and there is lethal for the health of one and all just like asbestos and pesticide may have been responsible for the high incidence of cancer. The streets have to be claimed back for pedestrians and the protection of consumers is an ongoing struggle.

Ifforts to tackle drug addiction and alcoholism must be among our priorities. All this makes workers' education crucial for the present and the future of society. All these struggles which are being waged daily on the shop floor or in the office whether at the individual level, at the level of the community or within workers' organizations show us in practical terms what can be achieved, what new norms can emerge, in short a new moral economy for the workers where the final aim is the emancipation of one and all.

Deepfakes et désinformation: Les défis de l'ère numérique pour la démocratie en 2024

ous voulez qu'un opposant fasse campagne pour vous? Confondez les électeurs entre une vidéo réelle et une autre fausse? Alors que de nombreux pays se préparent à des élections en 2024, certains partis politiques se tournent vers l'IA pour employer des stratégies nouvelles - et dangereuses.

se terminent par le symbole électoral du Congrès et le slogan: "Votez pour la justice, votez pour le Congrès". Or, ces vidéos sont fabriquées!

Aamir Khan et Ranveer Singh ont déclaré que les vidéos étaient fausses. Facebook, X et au moins huit sites Web de vérification des faits ont déclaré qu'elles étaient altérées ou manipulées, ce que l'unité de vérification numérique de Reuters a également confirmé.

Amir Khan a été "alarmé" par la vidéo "fausse" virale et l'équipe de Ranveer Singh enquêtait sur la question, selon un porte-parole des deux acteurs. Singh a écrit sur X vendredi: "Attention aux deepfakes, les amis".

Près de 900 millions de personnes en Inde ont accès à Internet et une enquête menée par l'organisation de recherche Esya Centre, et l'école de commerce de l'Indian Institute of Management a montré qu'un Indien moyen passe plus de trois heures par jour sur les médias sociaux. Le pays compte près d'un milliard d'électeurs.

Certaines versions des vidéos ont été bloquées sur les médias sociaux, mais au moins 14 étaient encore visibles sur X samedi dernier. Facebook a supprimé deux vidéos que Reuters a signalées à l'entreprise, mais une autre était toujours visible.

Dans les élections de cette année, les politiciens utilisent l'IA de différentes manières.

ans les mois précédant les prochaines élections générales, on peut donc s'attendre à ce que de plus en plus de « deepfakes » générées par l'IA soient utilisées pour ternir l'image et la réputation des adversaires politiques. En tout cas, il est préoccupant de constater l'émergence de la technologie «deepfake» impactant le paysage politique à Maurice. L'expérience récente de Xavier Duval met en lumière les dangers potentiels associés à la désinformation générée par l'IA.

À une époque où la perception publique est fortement influencée par les médias numériques, les dommages causés par de telles «deepfakes» peuvent être significatifs et durables. VIRAL DEEPFAKE VIDEOS OF AAMIR & RANVEER

Dans le contexte politique indien, l'utilisation de «deepfakes» générées par l'IA soulève des préoccupations majeures quant à la manipulation de l'opinion publique et à la diffusion de fausses informations Bien que deux acteurs de Bollywood aient démenti l'authenticité des vidéos, leur propagation rapide sur les réseaux sociaux souligne la vulnérabilité des plateformes en ligne à la désinformation. Il faut savoir que «deepfake» est une forme d'intelligence artificielle (IA) qui peut être utilisée pour créer des images, des sons et des vidéos de canular convaincants. Le terme «faux profond» combine le concept d'apprentissage profond avec quelque chose de faux.

Les vidéos falsifiées, qui ont circulé en ligne, montrant deux des acteurs de Bollywood les plus en vue en Inde, critiquant le Premier ministre Narendra Modi et demandant aux gens de voter pour le parti d'opposition du Congrès lors des élections générales en cours dans le pays, se sont avérées être des faux profonds.

Dans une vidéo de 30 secondes montrant Aamir Khan et une autre vidéo de 41 secondes de Ranveer Singh, les deux acteurs de Bollywood s'exprimeraient ainsi: Modi n'a pas réussi à tenir ses promesses de campagne et n'a pas réussi à résoudre les problèmes économiques critiques lors de ses deux mandats de Premier ministre, rapporte «The Economic Times».Les deux vidéos générées par l'IA

gigantesques en Inde, qui ont commencé le 19 avril dernier et se poursuivront jusqu'en juin. L'IA et les «deepfakes» sont de plus en plus utilisées dans les élections ailleurs dans le monde, y compris aux États-Unis, au Pakistan et en Indonésie.

WhatsApp et Facebook s'inscrivent dans la campagne électorale

a campagne en Inde s'est longtemps concentrée sur le porte-à-porte et les rassemblements publics, mais l'utilisation extensive de WhatsApp et de Facebook comme outils de campagne a commencé en 2019. Les élections générales de cette année-là, au cours desquelles Modi devrait remporter un rare troisième mandat, sont les premières à utiliser l'IA.

Un porte-parole du Congrès, Sujata Paul, a partagé la vidéo de l'acteur Ranveer Singh avec ses 16 000 abonnés sur X le 17 avril et le samedi après-midi, son post avait été partagé 2 900 fois, aimé 8 700 fois et visionné 438 000 fois.

Sujata Paul a déclaré à Reuters par téléphone qu'elle était consciente que la vidéo était marquée "média manipulé" par X, mais elle ne voulait pas la supprimer car, lorsqu'elle l'a postée, elle pensait que la personne était un sosie de Singh et "elle a certainement de la créativité".

Le post n'était plus visible sur X dimanche, quelques heures après que Reuters ait envoyé une demande de com-

L'Afrique abrite 135 200 millionnaires et 21 milliardaires, mesurés en dollars américains. Si les projections se confirment, ce nombre passera à environ 220 000 d'ici 2033.

Les cinq États africains qui représentent la plus grande part des millionnaires du continent sont (par ordre du nombre de personnes fortunées) l'Afrique du Sud, l'Égypte, le Nigeria, le Kenya et le Maroc. Ils représentent collectivement 56 % des personnes fortunées d'Afrique et plus de 90 % de ses milliar-daires.

L'Afrique du Sud est en tête avec 37 400 millionnaires et cinq milliardaires, tandis que la richesse de l'Égypte est entre les mains de sept milliardaires et 15 600 millionnaires.

"Les 'cinq grands' sont les cinq pays les plus développés en termes d'infrastructures, avec des économies beaucoup plus avancées par rapport aux autres pays africains", a ajouté Volek.

Johannesburg est la ville la plus riche d'Afrique avec 12 300 millionnaires et deux milliardaires.

"Si l'on regarde globalement, il y a environ 54 milliardaires africains dans le monde, dont Elon Musk d'Afrique du Sud. Mais, parmi les 54, seulement 21 % vivent encore sur le continent", a ajouté Volek.

Presque la moitié des milliardaires nés en Afrique ont quitté le continent pour des endroits comme la Suisse, Singapour ou Monaco, ou encore les États-Unis.

Ils veulent avoir une meilleure qualité de vie, une meilleure éducation pour leurs enfants, de meilleurs soins de santé, de meilleures opportunités commerciales."Mais, l'Afrique est un continent qui reste proche du cœur", a

Elections in Bharat: PM Modi likely to win a third term

n an article on *Rediff*, News titled 'Exciting World of Data Science' by Ajit Balakrishnan, an internet entrepreneur, he writes: '... as I stroll through my neighbourhood in Bombay, I can see small roadside fruit vendors and fish sellers display a QR code near their coir baskets and ready to accept digital payments. Aadhaar now is carried by 1.2 billion Indians. Nearly 300 million Indians now do online shopping. And they all seem to have made this transition to the digital world enthusiastically and happily.'

Last year in Bangaluru and New Delhi, which I was visiting after several years, I had the same experience: from the roadside fruit/vegetable seller to the multifarious other outlets, my nephew made all payments using the QR code. I must confess that not only was this a revelation to me, but also that I myself have not quite got used to this now common and generalized mode of transaction there. But I guess I will have to sooner than later if I want to be part of this modern and future Bharat that I am bound to visit again.

The advent of the internet and social media has made it possible to track in real time via online sources happenings across the world, and that is the case too as regards the general elections in Bharat now under way, with a first phase completed, to end with the 7th phase on June 5. I regularly follow the developments that have taken place and the progress made there that I have also had the occasion to experience personally. The achievements of the NDA led by Prime Minister Modi for nearly ten years have been tremendous.

The first thing that comes to mind is the fact that from 10th place when Modiji took over, Bharat has now climbed to the 5th position in the global economy and, growing at the highest rate among major economies at over 7%, it is on an aspirational course to climb further to 3rd place by 2030.

From online sources we learn that this has been made possible through reform of the financial system by, amongst others, implementation of the GST, which made doing business much easier by consolidating several different taxes into one Goods and Services Tax, thus eliminating barriers to inter-state trade. Further, many schemes have enhanced investment in the country, leading to financial stability and increasing GDP.

The QR code mentioned above has become an integral part of India's retail businesses and, along with demonetization, has accelerated online transactions. It forms part of the UPI system, which is the most successful payment system in the world, with hundreds of millions of users and billions of transactions every month. There is also the Rupay card scheme which includes Mauritius, though which payments can be made instead of using e.g. Visa and Mastercard.

Undoubtedly, an outstanding achievement is Covid handling, which included the CoWIN platform (Covid Vaccine Intelligence Network) to administer the vaccination programme, development, and production of several vaccines in the country, administering free of cost over 2 billion made-in-India doses within a year.

This is something that people in developed countries take for granted, but the mind-boggling scale of the needs for water in a country of 1.4 billion people baffles the imagination..."

Besides becoming self-reliant in medical items like personal protection equipment and ventilators which mainly were imported earlier, the government made grants of almost 200 M vaccines doses to nearly 82 countries to kickstart their vaccination as they were unable to procure them initially, in addition to selling them afterwards.

Among other achievements, one can mention abrogation of Article 370 which has facilitated investment and tourism in Kashmir, along with other developments in healthcare, education, empowerment of women, as well as a significant drop in terrorist-linked activities, etc.

There is massive development in the infrastructure sector in the country, with the rapid construction of highways, expressways, and other roads (38 km per day), massive expansion of the railway network and introduction of the made-in-India Vande Bharat Express train, and the Udaan scheme in civil aviation. Electrification of railways is proceeding apace.

Tens of thousands of villages, earlier left out, now have electricity, and they have also had improvements in the availability and quality of water. This is something that people in developed countries take for granted, but the mind-boggling scale of the needs for water in a country of 1.4 billion people baffles the imagination. I

illustrate this with a personal example - when I was in New Delhi for my internship in 1971, its population was about 2 million. Today this figure is closer to 12 million if not more — while ours is a mere 1.2 M and is on the decline! — and yet every Delhiite has access to water. No need to comment on our own water supply situation here! So, before we criticize Bharat, let us have some humility!

Apart from these few developments, Bharat has also made great strides in inclusion of northeastern states, in foreign policy, and in indigenisation of the defence sector. Each topic requires a whole book to itself, and External Affairs Minister Subramaniam Jaishankar's two books: 'The India Way' and 'Why Bharat Matters' are a good place to start understanding 'Vixit Bharat.'

Perhaps the two iconic events that stand out are the successful Chandrayaan Mission that landed a vehicle on a hitherto hidden region of the moon - a first to add to the achievement of also being the fourth country to land on the moon - and the rebuilding and Pran Partishtha of the Ram Mandir in Ayodhya.

No wonder the overwhelming feeling all over Bharat is that Modiji should come back...

Interview: Chetan Ramchurn

s Mauritius gears up for potential general elections, all eyes are on the upcoming Labour Day rallies, which will reveal the current political dynamics. Chetan Ramchurn, a seasoned observer of Mauritian politics, sheds light on the implications of the PMSD's departure from the opposition alliance and discusses the strategies and obstacles faced by both the ruling and opposition parties. From addressing electoral fatigue to the need for new leadership, Chetan Ramchurn dissects the intricacies of Mauritius' political landscape. As the nation approaches a pivotal moment, the interview also explores the factors that will influence the outcome of the elections.

Mauritius Times: This 1st of May holds particular significance as it appears that the Prime Minister may announce general elections sometime this year. The crowds at the Labour Day rallies will provide insight into the "rapport de forces" on the ground, but the assistance of activists and party sympathizers at the "reunions de mobilisation" of both alliances indicates substantial support for each. It's shaping up to be a tough battle, isn't it?

Chetan Ramchurn: Indeed, there seems to be significant hype around the Labour Day rallies. The general elections are on the horizon and while the remote control for the short timetable of events rests with the sitting PM. I say short for the present mandate will soon come to an end, and the obligation to organise by-elections within 240 days hovers above the MSM's head. A defeat at the No.10 by-elections would verily disrupt their plans. Jugnauth will in all probability go for general elections sooner rather later.

This last first of May rally prior to the general elections also comes against the backdrop of a simmering political cauldron. The PMSD has left the opposition alliance, ending long months of tumultuous bed fellowship more with the MMM than the Mauritius Labour Party (MLP). This paves the way to serve the electorate an amended version of the 2014 remake; the MLP and the MMM join whatever is left of their forces

against the governing alliance in the last elections which should remind us of the following: despite the billions spent distributing money to key segments, despite the many lackeys hyping it, more than 6 out of 10 of Mauritians did not deem the winning alliance as trustworthy.

This should remind us of the following: the opposition in our country is still relatively strong, but the opposition parties are weak..."

once again with the trio of dissenters from the PMSD and in all likelihood a veneer of 'difference' or 'leftism' from fringe parties and their members.

Disappointingly, non-mainstream parties seem eager to auction their ideals even at the expense of losing their bearings in the finalisation of this pact. If they merely ape the thoughts of the main parties, where lies the difference? They have yet to get the narrative right. As Antoine de Saint-Exupéry would say: «Si tu diffères de moi, mon frère, loin de me léser, tu m'enrichis.»

The MSM watches. In the last decade, it has 'transformed' institutions into weapons that presently wait to strike its opponents should the need arise. It has campaigned consistently since it was elected in 2019. How could it not? 62% of the electorate voted against the governing alliance in the last elections which should remind us of the following: despite the billions spent distributing money to key segments, despite the many lackeys hyping it, more than 6 out of 10 of Mauritians did not deem the winning alliance as trustworthy. This should remind us of the following: the opposition in our country is still relatively strong, but the opposition parties are weak.

There are some days left before Labour Day and we have to hope that they use this event to bolster what Prashant Kishor terms the 4 Ms: the Message, Messenger, Machine (referring to the party or parties involved), and Mechanics (the process of connecting the leader with the masses).

* The departure of the PMSD from the LP-MMM-PMSD alliance, for reasons not entirely clear to this day, may have weakened the "force de frappe" of that alliance. Winning could now be more challenging for Ramgoolam and Bérenger. Do you share this perspective?

The timing of the separation certainly

raises questions on the intent of the PMSD. Bhadain claims that the 35-25 breakdown of tickets has been known for long. That the finer details of the deal were apparently not known to the PMSD surprises many. As leader of the opposition, Duval personified the rejection of the MSM and its many scandals and, overnight, he is mum about the billions allocated to drains and the clear project management issues.

To be honest, winning would have been challenging even with PMSD staying along-side the MLP and MMM. Their contribution to votes in the rural region is scant. What seemed clear to me since 2014 was that the MLP needed to introspect, reconnect with its base and grow organically. In business terms, it has pursued a merger and acquisition (M&M) strategy, once again embracing the 40+40 mantra. The electorate's high rejection of the MSM does not imply automatic allegiance to the mainstream opposition parties. The latter will have to work harder.

There seems to be renewed energy within opposition ranks since the PMSD's departure. Now no longer in an alliance with the MLP and the MMM, the PMSD will have no qualms in spreading the narrative that Ramgoolam is being manipulated by Bérenger. The MLP and the MMM must counteract this perception.

* Apart from what is widely suspected to be the ruling alliance's access to a significant war chest, the MSM has also shown a willingness to employ any means necessary to achieve its objectives. Do you believe the tide is turning against them this time?

* Just like in 2014, the need for regime change has once again brought the Labour Party and the MMM together. However, to win the electorate's confidence, they must also demonstrate that their partnership is going to be workable should they win the next elections. Do you believe there are valid concerns about this?

The situation in 2014 was different.

The ill-fated second republic... that constitutional imbroglio caused a backlash as well as the equal repartition of tickets. In 2024, nothing of the sort is on the agenda. Still, creating an alliance to overthrow the present regime means nothing if we do not know, to paraphrase Slavoj Zizek, what happens the morning after.

Let us hope that those advocating for change are aware of this. If not, we might be facing another Illovo or smart city scheme in the coming years.

* In addition to agreeing on key posts and electoral tickets, is it crucial for there to be consensus within the Opposition alliance on major economic policies? This question arises considering the minimal ideological differences between the parties today. What do you think?

The mainstream opposition hosts some of the architects of the first Illovo deal and the Integrated Resort Scheme as well as proponents of the flat tax regime (that enduringly crippling measure) and the Real Estate Scheme. The uninterrupted pandering to the oligarchy has to be stopped.

In 2023, the Fabian society gave its list of priorities for a Labour government. These included measures to protect against inequality in the early years, affordable housing and raising living standards amongst others. A common ground on economic direction would be the first step.

* When considering a common minimum programme for the LP-MMM alliance, governance of the country emerges as a key concern. What specific proposals do you have in mind that could signify a departure from what we have been subjected to over the last couple of years?

Greater opportunities for those at the lower rungs of the economic ladder have to be created. Assistance to entrepreneurs through a monthly stipend in the first 18 months would help them navigate through the turpitudes of the business world as would free training to them.

A special attention to the ageing population would be most welcome. Merely giving senior citizens money neither alleviates their loneliness nor ensures their safety. A more caring approach to them would include better access to medical facilities and a rethinking of our infrastructure.

Bolstering democracy through recall elections is a priority. So many sitting MPs have been found inept. Ensuring that these no longer remain in office would instill greater faith in our system.

A look at the state of public education and health clearly shows why private institutions are mushrooming. Uplifting public schools through stringent control and better project management (how can some students not have their text-books at the end of the first term) would go in the right direc-

* Do you believe the Opposition should also support the proposal to limit the Prime Minister's term and introduce a dose of proportional representation (PR) in our electoral system to ensure better representation of all parties in Parliament?

Limiting the Prime Minister's term would help keep democracy vibrant. Over the last 56 years, only three surnames have been given the golden PM ticket. Additionally, should there not be primaries for the selection of candidates for local and national elections? An all-powerful leader who selects candidates based on personal preference cannot be good for our democracy.

I am less enthused with PR because it could lead to an increase in extremist views and could disturb our already frail natural unity.

* Some Opposition members have drawn parallels between the upcoming elections and the struggle for Independence in 1967. However, the stakes may be even greater: it could be a make-or-break moment for the Opposition. If they fail to unseat the current government, they could potentially face an extended period in political wilderness. What are your thoughts on this?

If you look at the harm that the present government has done to our institutions in the last five years, it seems apparent that all elections are important. The last one was as important as the next one.

The erosion of trust in public institutions has lasting

effects; it could lead to the privatization of many of our services as well as to the disenchantment of the youth in the present and future and lives getting lost because of poor management.

Indeed, these elections are undoubtedly crucial. As were the last ones. Let's hope that all involved parties, especially the Opposition, approach them with the utmost seriousness and prioritize the concerns of the many over their own.

* Jean Claude de l'Estrac has been talking about "electoral fatigue" and that the electorate would want to see new faces and is calling for a renewal in politics. In that case, it could be in the interest of these two parties themselves if their leaders would consider the upcoming election as a transitional one that allows for significant reforms and changes like, for instance, younger and promising hands at the helm. Your opinion?

Leaders should look at the opinion the public has of them. Leadership of a party cannot be bestowed based on blood ties in 2024. We cannot blame politicians without blaming the electorate that keeps voting for them. Maybe nepotism is what people want.

A change of personnel can sometimes merely be a PR coup akin to what we witnessed in 2019. I often quote from Tancredi's line in Visconti's *Le Guépard, "Il faut que tout change pour que rien ne change"*; that is, "For things to remain the same, everything must change." New faces were brought to the dance, and nothing really changed. Corruption remained as high and even worsened, the bending over to the very rich continued, the institutions kept deteriorating.

Still, it would be a wise decision to retire some of those contributing little to our democracy.

* At the end of the day, what are your expectations for the outcomes of the upcoming elections, and what do you believe will be the key factors shaping those outcomes?

It is way too early to predict anything. Barely a couple of months back MSM supporters thought that it would be a walkover win for them. This is no longer the case. The government will have one last budget to sway voters in its favour. Distributing money creates a feel-good factor for a limited period. Meanwhile, there might be an assault on their nemesis's reputation, potential arrests, and fresh accusations.

While the government's strength has traditionally been in welfare initiatives, the current alliance in power has notably faltered in maintaining law and order and addressing other critical issues. With the approaching general elections, voters may come to the realization that there's a lack of any sustained feel-good factor, possibly leading to a hit-and-run scenario during the elections.

Merely responding to the present regime on their chosen battlegrounds will only strengthen the governing alliance. The opposition alliance has to give a vision, a dream of a better life to voters and not merely occupy battlegrounds already occupied by its adversaries. In short, they have to change the way people think.

"Irresponsible town planning and management have rendered Port Louis vulnerable in many ways"

sman Mahomed shares his insights on Mauritius' recurrent flooding issues, urban planning challenges, and environmental concerns. With his extensive background in urban development, he offers a critical perspective on the effectiveness of past initiatives and the way forward for sustainable development in Mauritius.

* The entire country was compelled to take an unexpected holiday on Monday due to the imminent risks of flooding caused by heavy rainfall throughout the day. Such forced holidays have become increasingly frequent in recent times. What does this pattern reveal about the adequacy of the government's contingency plans for calamities and its effectiveness in managing crisis situations?

A brief response to your question: it's not effective. However, it must be said that when the Labour Party left office in 2014, the foundation was laid for a different scenario.

I do recall that the very concept of disaster risk reduction emerged immediately after the flash floods of March 2013 at the Prime Minister's Office when Navin Ramgoolam appointed British expert Mrs Venetia Bellers to kickstart the department. I got to know Venetia well because she started off her work at the office of the Maurice Ile Durable Commission, which I was then chairing.

Furthermore, the country could do better in as much as it is now equipped with a state-of-the-art radar which the country obtained from Japan following diplomatic efforts from former Prime Minister Navin Ramgoolam at Ticad V in Yokohama in 2013, which I also attended as member of the Mauritian delegation, as Executive Chairman of the Maurice Ile Durable Commission, on invitation of UNES-

* Billions have already been allocated for drainage works across the island, with additional funds earmarked for future projects. However, despite these investments, recurring flooding continues to affect property and, in some cases, endanger lives. Does this persistent issue suggest that both past and recent initiatives to mitigate flood risks in Mauritius have proven to be ineffective?

It is observed that many projects that are currently being implemented raise doubts in the minds of professionals and of the people, about their effectiveness. I take the example of my own constituency for a drain project of Rs 353 million along Raoul Rivet Street for which the inhabitants are even prepared to go to the extent of refusing such massive investment in their locality because they do not believe in the effectiveness of the project. In such situations social consultation would have helped. I must say once again that I have approached the authorities for more details but to no avail.

But on a different level, a thorough assessment of how come after investing so many billions of rupees in drain works, the country still suffers so much from inundation, is very much warranted.

* To be fair, floods, particularly flash floods, are occurring in various regions worldwide, including China, Uruguay, the USA, France, Brazil, Indonesia, and unexpectedly, even in countries like the UAE and

Saudi Arabia. The main culprit is said to be climate change which is making it harder to predict the weather 22, although infrastructure vulnerabilities may be exacerbating the situation. What are your thoughts on this within the local context?

It is true to say that climate change is now a reality.

I flew through Dubai last week to attend the yearly meeting of the International Renewable Energy Agency in Abu Dhabi and I witnessed it all. I was compelled to stay in the plane for 16 hours for a flight of normally 6 hours because of the extreme weather conditions.

The situation in Dubai was chaotic even on the roads because the country is not equipped with extensive drain infrastructure given that it was not prone to such calamities before, unlike Mauritius which is a tropical island with cyclonic windows. The case of Dubai is therefore not comparable to ours because we always have to face cyclonic and rainy conditions.

* Regarding infrastructure vulnerabilities locally, there's the pressing issue of implementing an effective town and country-planning programme with a view to optimizing our limited land resources and ensuring their sustainability. Despite occasional debates on the matter, successive governments seem to have neglected proactive measures concerning "l'aménagement du territoire". Are vested interests obstructing the implementation of appropriate actions?

I have been canvassing for this issue on several occasions in Parliament, namely during my intervention on the Town Planner's Council Bill and through several parliamentary questions on the delay encountered by this government for the preparation of National Land Development Strategy, which is now way obsolete in as much as it's supposed to me of a maximum of 10 years of age and it's now 20. I do believe that this persistence of mine and my almost weekly parliamentary questions on the housing sector, which I follow passionately as former officer in charge of the Housing Unit of the Ministry of Housing and Lands and former Managing Director of the NDHC, has earned me a second portfolio at the Labour Party, that of Housing and Land Administration in addition with Environment, which I follow together with the Hon. David.

* Port Louis' location and disordered town planning may have exacerbated the capital's vulnerability to climatic hazards, particularly floods. We understand that many residents are considering migrating to other urban areas or returning to their villages. What do you think the future holds for Port Louis?

Port Louis became the capital city of Mauritius because it had all the necessary attributes to be so. However irresponsible town planning and management has rendered it vulnerable in many ways.

I started ringing the alarm bell when I initiated a petition during my first mandate against this government's action



to convert green spaces with tarmac for parking purposes at the Champ de Mars. Reducing green spaces has made the situation worse. The passage of the metro line at ground level in the Caudan area has also made Port Louis more flood prone notwithstanding the investments in drain infrastructure being made upstream.

Not taking any action on human intervention in Soreze that had clogged the cut off drain there leading to massive destruction of road infrastructure is deemed criminal. I have written officially to the Municipal City Council of Port Louis immediately after the passage of cyclone Belal. I wonder what action has been taken. And then there are basic things that are not being done, that is cleaning, clearing and maintenance of the vital drainage network and waterways.

* Roshi Bhadain's Heritage City project, advertised in 2016, ultimately failed for reasons that may not to this day be entirely clear. However, in hindsight, one could argue that the idea itself had merit. What are your thoughts on this?

I must say that I had canvassed against this project by organising a colloquium at the Port Louis Gymkhana which was attended by the leadership of the Mauritius Labour Party and some 1500 people. We were all against it

The project subsequently fell apart in unclear circumstances as you mentioned. It proved us right on all counts. There were major sunk costs accrued to taxpayers.

* We understand that you and Ajay Gunness have taken over from where Xavier Duval left off in drafting the electoral manifesto for the Opposition alliance. Regarding the environment, significant concerns include the proliferation of smart cities, which could be exacerbating the island's concrete sprawl, and the limited progress made in transitioning to renewable energy in the energy sector. What actions do you believe are necessary to address these issues?

It's a huge responsibility indeed. We were being told all along that the alliance that we had was wasting a lot of time on discussing the modalities of the alliance and not enough on the manifesto per se, which is a major expectation from the population wanting a major change in the administration of the affairs of the country.

Now that there is more stability in our alliance, we are focusing on its preparation. Already I can tell you that there will be some announcements of the 1st of May rally in Port Louis for which I extend a warm invitation to one and all.

World's largest military spenders in 2023: US, China, Russia, India, Saudi Arabia

Clobal military spending reached \$2,443 billion in 2023, marking a significant 6.8 per cent increase from the previous year and the most significant year-on-year rise since 2009, according to new data from the Stockholm International Peace Research Institute (SIPRI). The average military spending per person was the highest since 1990, at \$306.

The surge in military spending can be attributed largely to the ongoing conflict in Ukraine and rising tensions in regions like Asia, Oceania and the Middle East, reports Hindustan Times.

SIPRI report on global military spending

- In 2023, total military expenditure accounted for 2.3 per cent of the global gross domestic product (GDP), reflecting the significant financial resources allocated to defence worldwide.
- The world's five largest military spenders in 2023 were the United States, China, Russia, India, and Saudi Arabia, collectively constituting 61 per cent of global military spending.
- Russia's military spending surged by 24 per cent in 2023, reaching an estimated \$109 billion, equivalent to 5.9 per cent of Russia's GDP.
- Ukraine emerged as the eighth largest military spender in 2023, increasing its defence expenditure by 51 per cent to \$64.8 billion, accounting for 37 per cent of

'India spent the highest ever on procuring Made-In-India arms'

- India ranked fourth globally in military expenditure in 2023, totalling \$83.6 billion, marking a 4.2 per cent increase from 2022 and a substantial 44 per cent rise from 2014.
- The surge in India's military spending was primarily due to escalating personnel and operations costs, comprising nearly 80 per cent of the total military budget for 2023, the report said.
- According to the report, this increase aligns with the government's focus on enhancing the operational

readiness of the armed forces, particularly amidst ongoing tensions with neighbouring countries like China and Pakistan.

During the same period, Pakistan's military spending dropped to \$8.5 billion in 2023, a decrease of \$13 billion, relegating it to the 30th position globally. However, China's military expenditure grew by \$6 billion, allowing it to retain its second position.

- Despite the rise in overall spending, capital outlays for military procurement remained relatively consistent, accounting for around 22 per cent of the budget in 2023, the report added.
- Notably, a significant portion of these procurement funds, approximately 75 per cent, was allocated to domestically produced equipment, marking the highest level ever recorded and a notable increase from the previous year.

UK parliament passes Rwanda asylum law as Sunak vows flights will start in weeks

The House of Lords had long refused to back the divisive legislation without additional safeguards, but eventually relented.

British Prime Minister Rishi Sunak promised on Monday to start sending asylum seekers to Rwanda within 10 to 12 weeks as the upper house of parliament finally passed required legislation, delayed for weeks by attempts to alter the plan.

Sunak said the government had booked commercial charter planes

and trained staff to take migrants to Rwanda, a policy he hopes will boost his Conservative Party's flagging fortunes before an election later this year, reports Reuters.

The House of Lords had long refused to back the divisive legislation without additional safeguards, but eventually relented after Sunak said the government would force parliament to sit as late into Monday night as necessary to get it passed.

"No ifs, no buts. These flights are going to Rwanda," Sunak told a news conference earlier on Monday.

Tens of thousands of migrants - many fleeing wars and poverty in Africa, the Middle East and Asia - have reached Britain in recent years by crossing the English Channel in small boats on risky journeys organised by people-smuggling



gangs.

Stopping the flow is a priority for the government, but critics say the plan to deport people to Rwanda rather than handle asylum seekers at home is inhumane. They cite concerns about the East African country's own human rights record and the risk asylum seekers may be sent back to countries where they face danger.

Sunak's new law states some existing UK human rights statutes will not apply to the scheme and Rwanda must be treated by British judges as a safe destination, in a bid to override a Supreme Court ruling which declared the scheme unlawful.

It also limits individuals' options for an appeal to only exceptional cases.

Other European countries, including Austria and Germany, are also looking at agreements to process asylum seekers abroad.

Mark Zuckerberg reveals whether he would have sold Facebook if offered \$5T: 'I did some analysis...'

Reports in 2006 claimed that Yahoo came up with a \$900 million offer after Mark Zuckerberg got rebuffed after countering Viacom's \$750 million offer for Facebook. The deal, however, did not go through. At present, Facebook (Meta Platforms Inc.) has a market cap of \$1.22 trillion.

Zuckerberg has now opened up about his thought process when the deals were offered. He also revealed whether he would have sold the tech giant for \$5 trillion instead of \$1 billion.

'I didn't really have the financial sophistication'

In an interview, podcaster Dwarkesh Patel told Zuckerberg that he did not sell Facebook for \$1 billion in 2006, "but presumably there's some amount you would have sold for." "Did you write down in your head like 'I think the actual valuation of Facebook at the time is this and they're not actually getting the valuation right?' If they'd offered you \$5 trillion, of course you would have sold. So how did you think about that choice?" Patel asked.

Zuckerberg said that at the time, he wasn't "sophisticated enough to do that analysis." He also said that there were people who made arguments for and against the deals at the time. "It was very far ahead of where we were at the time. I



didn't really have the financial sophistication to really engage with that kind of debate," he said.

The Meta CEO said that he believed in what he was doing. The analysis he did revolved around personal questions and about what he would do if they sold Facebook. He thought that even if he did sell it, he would soon build another similar tech giant. Therefore, there was no point selling it.

"I did some analysis like 'what would I do if I wasn't doing this?" he said. "'So I think if I sold this company, I'd just go build another company like this and I kind of like the one I have. So why?"

Russia warns of direct clash with West over Ukraine military aid

Russia said on Monday that U.S., British and French military support for Ukraine has pushed the world to the brink of a direct clash between the world's biggest nuclear powers that could end in catastrophe.

President Vladimir Putin's 2022 invasion of Ukraine has touched off the worst breakdown in relations between Russia and the West since the 1962 Cuban Missile Crisis, according to Russian and U.S. diplomats, reports Reuters.

Just two days after U.S. lawmakers approved billions of dollars in additional military aid to Ukraine, Foreign Minister Sergei Lavrov said the United States and NATO were obsessed with the idea of inflicting "strategic defeat" on Russia.

Lavrov said Western support for Ukraine was putting the United States and its allies on the verge of a direct military clash with Russia.

"The Westerners are teetering dangerously on the brink of a direct military clash between nuclear powers, which is fraught with catastrophic consequences," Lavrov told a Moscow conference on non-proliferation.

"Of particular concern is the fact that it is the 'troika' of Western nuclear states that are among the key sponsors of the criminal Kyiv regime, the main initiators of various provocative steps. We see serious strategic risks in this, leading to an increase in the level of nuclear danger."

Since the war began, Russia has repeatedly warned of rising nuclear risks - warnings which the United States says it has to take seriously, though U.S. officials say they



have seen no change in Russian nuclear posture.

Putin casts the war as part of a centuries-old battle with a decadent West which he says humiliated Russia after the Berlin Wall fell in 1989 by enlarging NATO and encroaching on what Moscow considers to be Russia's historical sphere of influence.

Ukraine and its Western backers say the war is an imperial-style land grab by a corrupt dictatorship that will lead Russia into a strategic dead-end. Western leaders have vowed to work for a defeat of Russian forces in Ukraine, while ruling out any deployment of NATO personnel there.

Hot war?

As relations have deteriorated, Russia and the United States have both voiced regret about the disintegration of the web of arms-control treaties which sought to slow the Cold War arms race and reduce the risk of nuclear war.

Russia and the United States are by far the world's biggest nuclear powers, holding more than 10,600 of the world's 12,100 nuclear warheads. China has the third largest nuclear arsenal, followed by France and Britain.

Lavrov said that given the current crisis there was no basis for dialogue with the United States on arms control.

He accused the West of trying to impose restrictions on the nuclear arsenals of Russia and China while developing non-nuclear capabilities in an effort to achieve unilateral military superiority.

Lavrov said the West was building a global missile defence system which could decapitate a rival, basing nuclear weapons in Europe, basing medium- and shorterrange missiles in regions around the world and preparing to deploy weapons in space.

In February, Putin said Russia opposed the deployment of nuclear weapons in space, and his defence minister denied Washington's accusations that Russia was developing a nuclear capability for space.

The United States says it is developing its defence capabilities in accordance with international agreements. It says it wants only the peaceful use of outer space and that its missile defence plans are defensive.

Disease X: Scientists warn next pandemic could be triggered by virus of 'deadly infectious illness'

The World Health Organiza-tion (WHO) warns that seasonal flu isn't just a winter nuisance. Every year, flu affects an estimated 1 billion people worldwide, with millions more suffering from severe complications. Even worse, it claims hundreds of thousands of lives annually. The WHO emphasises the dangers of new flu strains, for which people have no immunity, urging us to take influenza seriously, reports Hindustan Times.

Cologne University's Jon Salmanton-García's research backs up this concern. His research indicates that influenza is the biggest threat to the upcoming worldwide pandemic because of its continual evolution and mutation properties. "Each winter influenza appears, you could describe these

outbreaks as little pandemics. They are more or less controlled because the different strains that cause them are not virulent enough – but that will not necessarily be the case forever." He said as cited by the Guardian.

Scientists warn of Disease X

The survey results will be announced at the ESCMID congress next weekend. The unidentified "DiseaseX" virus is seen as the next most likely pandemicausing virus, after influenza, according to experts. Experts believe a new strain of this virus could emerge 'out of the blue' just like Covid-19, which claimed the

lives of millions across the globe and still remains a threat

These concerning details come on the heels of the World Health Organization raising concerns about the alarming spread of the H5N1 strain of influenza spreading rapidly in parts of the US. The organisation has warned of an "unprecedented surge" in the number of cases.

"This appears to be 100 times worse than Covid, or it could be if it mutates and maintains its high case fatality rate. Once it's mutated to infect humans, we can only hope that the [fatality rate] drops." John Fulton a pharmaceutical company consultant, said in a statement earlier.

According to WHO records, the data highlights that since 2003, 52 out of every 100 patients infected with the H5N1 virus have died, resulting in a fatality rate exceeding 50 percent. This rate is comparatively much higher than the current COVID-19 fatality rate, which stands at 0.1 percent.

White House fact checks Joe Biden: The President's uncle wasn't eaten by cannibals...'

Mhite House press secretary Karine Jean-Pierre confirmed on Thursday that President Joe Biden's maternal uncle, Ambrose Finnegan, died during World War II when his plane crashed into the Pacific Ocean and was not eaten by cannibals.

The House press secretary said the president feels "incredibly proud" of his uncle's service in uniform. "You saw the president, he was incredibly proud of his uncle's service in uniform. You saw him at the War Memorial. It was incredibly emotional and important to him," she said.

Jean-Pierre declined to delve further into the matter, citing the presidential plane's imminent arrival in Philadelphia, where Biden was scheduled for campaign visits, reports Hindustan Times.

Biden's provably false personal anecdotes

During recent campaign visits to Pennsylvania Biden claimed that New Guinea natives had consumed his uncle. "He got shot down in an area where there were a lot of cannibals at the time. They never recovered his body, but the government went

back when I went down there and they checked and found some parts of the plane," he stated.

Later, in Pittsburgh, Biden reiterated that Finnegan "got shot down in New Guinea, and they never found the body because there used to be — there were a lot of cannibals, for real, in that part of New Guinea."

The official account of Finnegan's death provided by the US military contradicts Biden's narrative.

According to the Pentagon's Defense POW/MIA Accounting Agency, Finnegan's plane crashed into the ocean off the coast of New Guinea due to engine failure.

Biden's tendency to recount personal anecdotes with dubious accuracy or without supporting documentation is not new. Throughout his political career, he has often used such stories to connect with his audience, including Pennsylvania voters who could play a crucial role in his potential bid for a second term against former President Donald Trump.

Foodcrop Production

Would Mauritius' economy best be served by continuing as now — increasing sugar production and importing almost all foodstuffs; or by limiting sugar production and thus increasing the area of land potentially available for foodcrops?

prominent member of the British Labour Party's National Executive is famed for his ability to find two difficulties for any solution. I was reminded of him when reading the annual report

of the Chamber of Agriculture for 1958-59. "The Chamber is at present collecting information from all sugar estates with factories with a view to assessing the extent of foodcrop cultivation, the possibilities of further development, and also the difficulties encountered both in the growing and in the marketing of such crops."

It is well known that Mauritius imports nearly all her food requirements. The Department of Agriculture has for many years been trying to improve the local dairy cattle, so that people can have more milk and butter and cheese, and of a higher quality; and increased milk production at home would reduce the island's dependence on imported dairy produce, and so save foreign currency. Similarly, the more food produced at home, the less would have to be imported; again, saving foreign currency and releasing more funds for internal investment, so tending to increase self-dependence.

But the Chamber of Agriculture talks of the "difficulties" which may inhibit the full implementation of this laudable policy. Not only the "difficulties" of growing, but the "difficulties" in marketing when once the crops have been grown.

Let us look at some figures. In 1950, there were 11,456 arpents under foodcrops; they produced 15,053 tons of foodcrops, mainly

rice, potatoes, sweet potatoes, groundnuts, arouilles, manioc and maize. The next year, 1951, the area under foodcrops fell to 8,584 arpents; the deficiency of 3,000 arpents being due to encroachment by sugar and aloe producers. However, increased production per arpent meant that the tonnage of foodcrops produced fell only to 14,077 tons. The acreage under foodcrops fell by another 1,000 arpents in 1952; of the yield, the annual report for Mauritius for 1952 says that "yields were good... vegetable growers dispose of their produce with good ease at very remunerative prices."

In 1953, the area under foodcrops slumped to 8,328 arpents, producing about 15,000 tons of marketable produce. including 3,000 tons of maize, 5,000 tons of potatoes, but only 50 tons of rice as well as quantities of sweet potatoes, manioc, groundnuts, and eddoes. In 1954 about 8,000 arpents produced 16,000 tons of foodcrops, chiefly maize, potatoes, and vegetables. By 1957, the acreage had gone up again, to 9,500 arpents; and high prices were being realised for potatoes; a solution to the problem of suitable seed would make pota-

toes even more important as a foodcrop.

However, the figures I have just quoted for 1957, from the annual report on Mauritius, do not tally with those given in the Chamber of Agriculture's annual report for 1958-59. There we read that the area under foodcrops actually harvested was only 4,158 arpents in 1956-57, and less than that at 3,130 arpents in 1957-58. Production was fairly constant, however; 8,675 tons in 1956-57 and 8,490 tons in 1957-58. It was, however, a jump, in the production of manioc per arpent (4,608 kilos per arpent to 9,300 kilos per arpent) which helped to hold total production fairly steady: for the increase in tonnage per arpent for maize, arouilles, Irish potatoes and groundnuts was either negligible or absent.



These production figures are deplorable. In a country such as Mauritius, there should be far more arpents under foodcrops; there should be a far higher homegrown production of foodcrops. From 1948-49 to 1956-57 we have seen foodcrop plantations dwindle from 18,036 acres to a mere 4,338 acres; we have seen production tumble from 19,673 tons to 8,675 tons. Simple calculation shows that during the period in question, production per acre has roughly doubled; but suppose the same area as in 1948-49 was now under foodcrops. With the increased production per acre which has been achieved, the total food production would have been over 38,000 tons. Every potato consumed in Mauritius could be grown at home; every bit of maize and maize flour could be grown and produced at home.

Small planters must be encouraged to grow foodcrops instead of sugar. The estates must play their part in growing more foodcrops. The Chamber of Agriculture must stop doing its disservice to progress in Mauritius by talking of the "difficulties" in foodcrop production. It must take a positive instead of a negative stand with regard to food production. What, for example, is the Chamber doing to encourage the sugar producers to grow food in the *entre-lignes*? This policy is followed in Barbados, whereas in Mauritius there is a limited land area and a fast-growing population dependent economically on the one crop-sugar. Moreover, in Barbados the practice of growing food between the lines of canes has not had the result which was half-feared: reducing the yield of sugar. On the contrary, I understand that foodcrops in the inter-lines has led to increased yields of sugar!

Or the Chamber should get to work on the problem of the optimum sugar production for Mauritius. The remarks in its report on world sugar conditions suggest

> that it might well be wise to set an upward limit to sugar production in Mauritius. Say, 650,000 tons, a figure which is not, in the light of modern developments of technique, by any means starry-eyed and optimistic. Land not required to achieve this target would be planted with foodcrops. As improved techniques led to still higher production per arpent, still more land could be released for foodcrops. It would be in the interest of the small growers, the metayers, the peasant-proprietors, to abandon their sugar crops with their low yields and poor canes and turn to vegetables and other foodcrops. Why does not the Chamber of Agriculture advance such a policy? Why does it not enquire into the economics of the Mauritius sugargrowing industry?

> Why, in short, does not the Chamber undertake as a *public duty and service* a full-scale enquiry the results of which would (for a change) benefit the public as a whole instead of merely the handful of members of the Chamber?

The whole impression conveyed by the Chamber's report is one of smug complacency. "We have produced sugar for years, and we intend to go on producing sugar for years." — that is the tone underlying the Chamber's report. The secondary industries get a look-in; but only lukewarmly. Any development must "tend to supplement and not to replace any part" of the island's sugar production. This statement is made in the face of earlier remarks about the world sugar market which tend to suggest that sugar may be being overproduced. If there is no danger of overproduction, may we have such a firm assurance from the Chamber?

On the other hand, if there is such a danger, why does the Chamber insist that we must not replace any part of our sugar production with other production - vegetables, for example? I make no apology for suggesting once again that a competent economist ought to study whether Mauritius' economy would best be served by continuing as now — increasing sugar production and importing almost all foodstuffs; or by limiting sugar production and thus increasing the area of land potentially available for foodcrops.



Obituary

r Amrit Rajkomar passed away on 27 February 2024 after unfortunately suffering from a rather unusual recurrence of a viral infection that he had bravely fought and recovered from about six years prior. He bore this illness, as he had done before when he faced a couple of other life-threatening medical problems too, with great courage for several weeks before the untimely end came.

Untimely because, at 76 years, he was still in good health otherwise and continuing to do what he was professionally trained to do: treating children with the utmost care and compassion, having trained in paediatrics at the All India Institute of Medical Sciences in New Delhi where he had also obtained his MBBS degree in 1973. On his return, he joined the Ministry of Health, and retired in 2007. Coming from Dagotiere, he had proceeded to AIIMS in 1968 after completing his secondary schooling at the Royal College Curepipe, where his extra-curricular activities included being member of the St John's Ambulance, Photography Society, and the Indian Cultural Society. That's where we first met and became friends until I myself left for my own studies in 1965.

But we were destined to journey to-gether more often: he attended my wedding in New Delhi in 1971, when I was do-ing my internship at the Safdarjung Hospital across the road from AIIMS where he then was a student and was taught by my father-in-law who was Associate Professor of Tuberculosis and Chest Diseases there. In the early 1980s he was elected President of the Government Medical and Dental Officers' Association and I served with him as member of the Executive Committee. Our paths again converged when we were Consultants at Jeetoo Hospital, in the 1990s. Over the past several years we used to meet during Continuing Medical Education sessions organized by the Mauritius Medical



Association.

Our relationship deepened as we became family friends, although because of our separate professional commitments and personal circumstances we couldn't meet as often as we wished or ought to have always, alas, an afterthought! But he was always there when needed, and thus it was that not only did he make all the arrangements but both he and his wife, herself a trained nurse, readily agreed to accompany me when I had to undergo cardiac bypass surgery at Narayana Hospital in Bangaluru.

That is where he had been regularly taking children for surgery, both when he was

President of SACIM – Society for Aid to Children Inoperable in Mauritius – for several years, but even afterwards when he had stepped down from that position. That had also given us occasions to interact: he would re-quest me to assess and report on children prior to their being sent abroad, as had also done before him the founder of SACIM, Dr Julia Maigrot. I and other colleagues also were only too willing to volunteer our support. He also organised medical care in prestigious centres in South Africa and Australia for deserving children,



besides serving benevolently many NGOS and crèches across the island.

Passionate about sports, particularly Formula One driving, in his teens he was also table-tennis champion of the Moka district.

Undoubtedly what kept him going with dedication was his engagement with the Brahma Kumaris, an organisation in which he and his whole family – three daughters and one son (Amrish, a surgeon in Mel-bourne Australia) – were also deeply involved. They all attended regularly for meditation and other activities, and at the Shraddhanjali held on the 40th day of his passing, the expressions of affection, thanks, gratitude, and respect for him from family, relatives and friends were overwhelming.

For me, with his gentleness, kindness, compassion, and soft touch, he couldn't have been anything else but a paediatrician. He never ceased to learn and update himself so

as to serve his patients better – but then he also followed up quite a few of them until their adolescent years, and why, even until adulthood because often his advice as confidante was still needed, as he had told me once.

He richly deserved being decorated by the Republic of Mauritius with the award of the PDSM, President's Distinguished Service Medal in 2008.

South Africa's youth are a generation lost under democracy – study

Youth are meant to be a generation enjoying a democratic dividend and contributing to a demographic dividend. Neither appears true. In terms of how much potential South Africa has squandered, they represent an entire generation of opportunity lost to the country.

Marginalised but not lost

In the 1980s and early 1990s, youth had taken on adult roles in political struggles. As ever, they demonstrated their instrumental value to the adults controlling violence on various sides. Those same adults and the media spoke of a "lost generation" – specifically, black, male, urban youth.

For the South African Council of Churches and Southern African Catholic Bishops' Conference involved in organising the youth in the 1990-94 interregnum through their NGO, the Joint Enrichment Project, the lost generation discourse was anathema. Firstly, because in their view noone is ever "lost" in spiritual terms; and secondly because of the stigmatising and policy implications of writing off young (black) people entirely.

This gave rise to the "marginalised youth" movement, which sought to understand youth on their own terms, to identify those at risk, those who were doing fine, and those who were pushed right to the margins of society — and design policy responses accordingly.

Marginalisation over time

In 1993, after first presenting to assembled youth organisations in 1992, we released the first iteration of the marginalisation index, 'Growing up Tough'. It comprised 12 dimensions of concern and 32 variables. These included personal experiences of abuse, recidivism, exposure to violence, family status, attitudes to race, self-image, health, political alienation, social involvement, employment status, generational conflict and fatalism.

Despite the belief of our church sponsors that no-one is ever truly "lost", that became the central category of the index. In all, 5% of respondents scored high on all, or


most, of the indicators in the 12 dimensions. "We use the term 'lost' with care", we wrote at the time, but some 500,000 people had "slipped through, or been shoved through, the social net entirely".

We found that a quarter of youth were "fine" – they only registered positive outcomes on the index. Four in ten were "at risk": they were showing signs of concern on a few dimensions in the index. "Marginalised" youth were most in need of urgent intervention. They comprised more than a quarter (27%) of the 1992 sample and scored high on many of the 12 dimensions of concern. How to keep them from slipping further should have been a key policy challenge for the democratic period.

The index was changed after 1994, since some indicators were specific to the transition South Africa was going through and others, such as HIV and AIDS, had barely featured in the early iteration of the index.

It was rerun in 2000 (only on black African youth), and results suggested their status was improving: no respondent scored high on more than eight of the 12 areas of concern.

In other words, eight years after the first measurement, where 5% of youth appeared "lost", no urban black African youth in 2000 fell into the "lost" category. Four in



ten (44%) respondents were "at risk", scoring high on two or three areas of concern; another 33% scored high on slightly less than half the areas of concern. It seemed that progress was being made.

Most of the items in the index were later used by the Gauteng City Region Observatory in its early Quality of Life survey, allowing analysis of marginalisation across the entire Gauteng province population.

The total of those who are "fine" (using the 2018 data) fell to 16% of youth, from a high of 25% in 1992. At the other extreme, we found 5% of Gauteng youth were again "lost". The trend suggested that 2000 was a high point. After that, young respondents were doing less and less well, both objec-

tively and subjectively.

Behind the overall data is a predictable racialisation. For example, in the 2018 analysis, while a third of white (33.3%) and Indian (34.8%) youth were "fine", this was true for only 14.1% of African and 22.1% of coloured youth. This pattern has remained true since the index began in 1992. In 2018, to be young, black and male in Gauteng was to have the highest likelihood of being marginalised. Only 0.3% of white youth (and 0.5% of Indian youth) showed signs of high marginalisation.

Yet, despite having failed young people, the governing ANC's 2024 election manifesto only manages anodyne promises to "create opportunities" for young people, suggesting South Africa will continue to waste the massive resource represented by our youth.

L'escalade des tensions nucléaires: une course dangereuse vers l'inconnu

Poutine a désormais explicitement menacé de recourir à l'utilisation d'armes nucléaires trois fois depuis le lancement de l'invasion de l'Ukraine en 2022. Et il a récemment ordonné que des armes tactiques soient stationnées en Biélorussie. Ses stratèges voient clairement la menace d'une confrontation nucléaire comme un moyen de dissuasion réaliste contre l'intervention de l'OTAN en Ukraine.

Le tabou nucléaire

e comportement de Poutine est mon-dial d'attitude à l'égard du tabou nucléaire. D'autres dirigeants, parmi eux l'ancien président américain Donald Trump et Kim Jong-un de la Corée du Nord, ont ramené la guerre nucléaire à la table comme une stratégie viable au lieu d'une dissuasion.

Depuis le début de ce siècle, le monde a vu la résurgence du populisme et du nationalisme religieux, la quasi-ubiquité de la technologie numérique et une augmentation de la prolifération et des bras de fer nucléaires.

Ces facteurs rendent notre situation actuelle plus complexe que la guerre froide. Un nouveau nexus de la Route de la soie est apparu entre la Chine, la Russie, l'Iran, Israël et la Corée du Nord depuis les guerres en Ukraine et à Gaza. Ce réseau de relations est façonné par des dynamiques régionales, des intérêts stratégiques et des changements de pouvoir mondiaux qui influencent la sécurité et la prolifération des armes mondiales.

La Chine et la Russie ont récemment développé des liens stratégiques plus forts. Mais les tensions persistent le long des frontières communes - et des documents classifiés fraîchement divulgués révèlent la peur de la Russie d'une

attaque nucléaire chinoise. La Chine possède 500 têtes nucléaires actives et étend son arsenal nucléaire. Pékin tire également des leçons de la Russie et d'Israël sur la façon dont un futur conflit taïwanais pourrait se dérouler.

The alliance inattendue est née entre la Corée du Nord et la Russie. Pyongyang a fourni des armes à la Russie depuis 2023 en violation des sanctions du Conseil de sécurité de l'ONU et cherche à tirer parti de ce soutien pour être reconnu en tant qu'État nucléaire.

En 2019, le dirigeant nord-coréen Kim Jong-un a averti son peuple de se préparer à la guerre avec les États-Unis d'ici 2024. Un document militaire divulgué a confirmé cela, affirmant que "le Cher Commandant Suprême dominera le monde avec les armes nucléaires". Le 22 avril, Pyongyang a affirmé avoir testé un

nouveau système de commandement et de contrôle lors d'un exercice simulé de contre-attaque nucléaire.

a Corée du Sud a réagi en développant ses propres missiles balistiques lancés par sous-marin (SLBM) en 2022 et est le seul État-nation à posséder des SLBM sans tête nucléaire. En février 2023, le leader du Parti du pouvoir populaire, Chung Jin-suk, a soutenu que la Corée du Sud avait besoin d'armes nucléaires. Mais cette stratégie pourrait également rendre la Corée du Sud plus vulnérable aux attaques de la Corée du Nord, hostile envers cette première.

L'Iran et la Russie coopèrent dans le domaine nucléaire. Le programme d'armes nucléaires de l'Iran a été limité en vertu du Plan d'action global conjoint de 2015. Mais Trump a retiré les États-Unis du traité en 2018 et des preuves solides

(niées par l'Iran) montrent qu'il a revigoré son programme d'armes.

Israël a ciblé l'Iran avec des assassinats, des cyber attaques, des attaques de drones et des raids de commandos pour détruire son programme nucléaire naissant, ajoutant aux tensions existantes au Moyen-Orient. L'Arabie saoudite n'a pas d'armes nucléaires, mais des responsables ont déclaré qu'ils en acquerront si leur rival régional, l'Iran, devient nucléaire.

Une nouvelle course aux armements

L'ONU a déclaré qu'une course aux armements quantitative semblait imminente. La dernière revue de la posture nucléaire des États-Unis a révélé un plan d'une valeur de 1,5 billions de dollars pour moderniser la capacité nucléaire américaine et créer une "éponge nucléaire" de 450 silos nucléaires pour absorber une future attaque russe.

Maintenant, le Royaume-Uni a annoncé qu'il augmenterait son budget de la défense à 2,5 % du PIB pour le mettre sur un "pied de guerre". Le gouvernement a réaffirmé son engagement envers son arsenal nucléaire, malgré le fait que l'ambassadeur britannique aux Nations unies, James Kariuki, ait déclaré: "La guerre nucléaire ne peut pas être gagnée et ne doit pas être menée" lors d'une récente réunion du Conseil de sécurité.

La menace d'une course aux armements nucléaires s'intensifie alors que la Russie avertit d'un affrontement potentiel avec les grandes puissances nucléaires. Cette escalade souligne les défis actuels de la sécurité mondiale, alors que les relations entre les nations sont de plus en plus complexes et que de nouvelles alliances émergent. La prolifération nucléaire, associée à des tensions régionales, crée un paysage politique volatile. Alors que les États cherchent à protéger leurs intérêts stratégiques, il est essentiel de prioriser la diplomatie et la coopération internationale pour prévenir une catastrophe mondiale.



Do you sometimes feel like you just can't be bothered? Would you like to have exercised more, learned a new language, or pursued further education, but the effort seems insurmountable? If so, you're not alone. Many individuals struggle with a lack of grit and self-belief, essential qualities for realizing one's aspirations. However, a recent breakthrough offers hope for those seeking to break free from apathy and embrace a mindset of determination and resilience.

Professor Hermundur Sigmundsson and his team at NTNU's Department of Psychology have been at the forefront of uncovering what drives human performance and how individuals can enhance their capabilities. Through their research, they've identified the crucial role of grit—a combination of passion and perseverance — in overcoming obstacles and achieving success.

In a pilot study involving 38 Norwegian students, Sigmundsson and his colleague, Research Assistant Håvard Hauge, administered a transformative intervention. Participants embarked on a 35 to 40-minute online course titled 'I CAN,' aimed at instilling an empowering attitude of self-belief and determination. Remarkably, after completing the course, the students exhibited a significant increase in grit—a testament to the potential for rapid mindset shifts.

The 'I CAN' course isn't just about instilling confidence; it's about equipping individuals with practical strategies to maintain and reinforce this newfound belief in their abilities. By repeatedly evoking the 'I can' attitude, participants can strengthen the neural pathways



associated with grit, paving the way for long-term resilience and success.

Moreover, this intervention isn't limited to academic settings. Studies have shown that bolstering self-efficacy—the belief in one's ability to achieve goals—can have far-reaching benefits, particularly for individuals from disadvantaged backgrounds. By empowering individuals to believe in their potential, initiatives like 'I CAN' can help level the playing field and unlock opportunities for those who may face systemic barriers to success.

The implications of this research extend beyond personal achievement; they offer a pathway to societal transformation. As Professor Sigmundsson aptly puts it, "When people develop stronger belief in themselves, it's almost as if a switch is flipped." By scaling up interventions like 'I CAN' and integrating them into educational systems, we have the potential to ignite a cultural shift towards resilience, determination, and empowerment.

While the initial findings are promising, researchers are eager to delve deeper into the efficacy of 'I CAN' on a larger scale. A forthcoming study involving nearly 1000 Year 10 pupils aims to shed further light on the transformative power of this intervention. As we continue to explore the potential of grit-building initiatives, we inch closer to a future where every individual can confidently declare, "I can."



Why don't female crickets chirp?

Only male crickets have wing structures that produce sound, but females are very good at following the signal.

Insects communicate in lots of different ways, for many reasons. Some, such as butterflies and beetles, use color, patterns and other visual cues to attract mates or warn potential predators that they don't taste very good.

Others, like fireflies, use bioluminescence – light that they produce in their bodies – to attract potential mates. Still others send chemical signals to interact with other animals and plants, or to defend against predators.

Insects also use sound to communicate, most often to attract mates. The ways in which they produce sounds can vary a lot, depending on what insect is making the sound.

Ah, there's the rub

Most insects create sound through a behavior called stridulation, which is basically rubbing two body parts against each other to make a noise, like a bow rubbing across a violin string. In all cases, there is a ridged structure on one body part that is rubbed across the surface of another ridged structure on a different body part, producing sound.

Many arthropods – the group that includes insects, spiders, centipedes, millipedes and lobsters – stridulate for a variety of reasons. They may do it to establish territory or as a warning, but most commonly they use it to attract a mate.

Stridulation has been most thoroughly studied in grasshoppers, crickets and katydids, which all are members of an



insect group called orthopterans, meaning "straight wings." Grasshoppers and katydids rub a hind leg against a wing to make their songs; crickets rub one of their wings quickly over the surface of their other wing. People often describe this as singing, but it's really more like playing an instrument.

Among crickets, males are the only ones that make noise because females don't have sound-producing structures on their wings. But the female can hear very well and will come to a male who is signaling to her from some distance away. She also is very good at distinguishing the song of her species from those of other cricket species and zeroing in on the male who is singing to her.

When male crickets sing, they make themselves vulnerable to predators. So they tend to sing from hiding places, such

as tall grasses or cracks in rocks. This is why it can be hard to find a chirping cricket that's inside your house — it's probably tucked into a vent or the corner of an attic, and it will stop singing when humans approach because it feels the vibrations from their footsteps.

Different cricket species sing slightly different songs. You can learn to



recognize them with a little practice, even if you never find the actual crickets. And to know whether a cricket, katydid or grasshopper is singing, look at the time of day. Crickets start to sing beginning at dusk, just as the Sun is going down. Katydids mainly sing late at night when it is totally dark, and grasshoppers sing during the day.

Another insect tune

People in the U.S. Northeast, mid-Atlantic and Midwest will also hear another insect song this spring and summer: cicadas. Two large broods of periodical cicadas, which spend multiyear periods growing underground, will emerge in 2024 to mate. And that will involve a lot of singing.

As with crickets, only male cicadas sing. They make their buzzing and whistling noises using a special structure called a tymbal, which is a membrane on their sides that they vibrate very quickly to produce sound. Think of a drum, but instead of making sound by hitting it on the outside, the surface is vibrated by pulling on it using muscles from the inside.

When many male cicadas sing at once, it can be quite loud. During mass emergences of periodical cicadas, the noise can reach as high as 110-120 decibels – as loud as a jackhammer or a jet engine. If they're in your neighborhood, you'll know.

Suddenly there is a kissing sound and then a slap.


The train comes out of the tunnel.

La censure en votre nom

I semble qu'il y ait un consensus dans les milieux officiels, chez les grandes figures de la

vie publique et dans les milieux autorisés à penser, comme disait l'autre humoriste, de tenir à distance toutes les 'querelles extérieures'. En français mauricien, le terme "extérieur" signifie plutôt "externe" et "étranger", désignant ainsi toute polémique ou tout conflit qui polarise les peuples et les nations dans d'autres contrées au-delà des océans.

Cette mise à l'écart se fait dans le souci d'éviter toute manifestation ostentatoire d'un parti pris quelconque susceptible de reproduire dans l'île l'affrontement des blocs rivaux qui se déchirent ailleurs. Le mot d'ordre est: Silence, on construit... la nation.

Bien entendu, l'importation en masse de produits de consommation pour inonder les supermarchés, de tous types de véhicules et de gadgets, ainsi que l'implantation des grandes enseignes étrangères pour les articles de sport, principalement françaises, afin de pousser à la consommation un peuple qui vit au-dessus de ses moyens, sont acceptables car jugés inoffensifs. Tout comme l'intérêt pour le Bayern de Munich, dont l'animatrice d'une radio privée nous entretenait avec engouement pour amuser la galerie pendant la Covid, sans parler des exploits d'Arsenal, de Liverpool, de Manchester, de la PSG, etc., qui rassemblent les fans devant l'écran de leur téléviseur. sur le feu, afin de ne pas aggraver l'incendie dans la catégorie des têtes brûlées dont le nombre augmente à chaque fois que les fers se croisent à 'l'extérieur'.

Cela étant, les informations internationales se résument à deux éléments: la fonte de la banquise, les ours polaires en errance, les inondations et les catastrophes naturelles, et un événement politique mineur dans tel pays, ce qui témoigne d'une indigence intellectuelle en n'ouvrant qu'au minimum la fenêtre sur le monde.

Cette censure expose le public mauricien aux partis pris des chaînes étrangères telles que LCI, BBC, CNN, Al Jazeera, France 5 et autres, concernant les grands événements qui font l'actualité. Ces chaînes pratiquent une autocensure à outrance. Il en va de même pour la presse locale. En somme, l'État, les médias et les figures publiques s'accordent pour donner un seul son de cloche aux grondements qui déchirent le ciel, et

détruisent les édifices et les vies humaines sur terre.

Ceux qui sont aux manettes du pays ont toujours fait preuve d'une grande responsabilité, quel que soit le parti au pouvoir, en ménageant les uns et les autres, en appliquant quand c'est nécessaire la fermeté envers les malfrats prêts à la violence, et en tenant un discours neutre sur les conflits qui divisent les sociétés dans d'autres pays. En tant que rassembleur et gardien de la cohésion sociale, leur fonction première est de veiller à ce que le tissu social soit maintenu dans son intégralité, et d'éviter que le tissu ne s'effiloche à cause de quelques fils tordus.

La neutralité n'est qu'apparente, car la prise de position des représentants locaux à l'ONU s'aligne sur la voix du plus grand nombre de pays. La lâcheté est flagrante, à l'instar de bien d'autres dirigeants. Leur voix donne un seul son de cloche sur la scène internationale et ne reflète pas forcément leur conviction personnelle. Mais ont-ils le choix? Leur alignement est dicté par la realpolitik, les intérêts commerciaux, les liens économiques avec les grands pays, l'importation de l'énergie, etc. Le but d'étouffer une cacophonie sur le plan local n'est atteint qu'en apparence. Le public joue le jeu, teste les limites et s'accorde tacitement à ne pas franchir la ligne rouge.

La tendance serait de constater que Maurice adopte une ligne prudente de l'Inde sur les relations internationales. Mais un État insulaire ne peut jouer dans la cour des grands. Malgré la puissance des États-Unis, l'Inde se permet de ne pas obéir à l'injonction occidentale de condamner la Russie en 2022, et fut le premier pays à condamner sans tergiverser l'acte terroriste perpétré par le Hamas dans un kibboutz en Israël. Officiellement, Maurice se range derrière le bloc occidental sur la question russe, contrairement à la prise de position de ce qu'on appelle le Sud global. Quant au vote pour un cessez-le-feu à Gaza, cela ne coûte rien au pays de suivre le troupeau à l'ONU, alors que l'Inde s'est permis de s'abstenir.

Finalement, les autorités savent qu'il leur faut jongler et ménager les plus remontés tout en calmant les esprits libres. Le pays est une démocratie et le public mauricien est attaché à la valeur de liberté en général et celle de s'exprimer en particulier. Est-ce que c'est efficace et raisonnable de considérer certains sujets comme tabous et de museler le public à la longue? A noter que l'explosion sur internet évite les affrontements physiques dans les rues, sauf sur les campus universitaires de certains pays.

Il y a une forte conscience générale que ce qui se passe au Moyen-Orient est d'une gravité pour l'avenir de l'humanité d'où l'urgence d'une prise de position bien tranchée et nette à travers le monde. En fin de compte, il n'est pas si aisé de tourner le dos aux conflits qui agitent d'autres pays dans la mesure où il y a aussi un intérêt économique, une identification politique, idéologique, religieuse et culturelle qui a un impact sur les uns les autres.

he question "Who am I?" is a seed that can bear much fruit if given the chance to

So, when we find ourselves in the heart of unknowing, we can have faith that we are in a very human place, as well as a very divine one. "Who am I?" is a timeless mantra, a Zen koan, ultimately designed to lead us home into the part of our minds that finally lets go of questions and answers and finds instead the ability to simply be.
