Duval Crosses the Rubicon

come to pass: Xavier Duval's PMSD, with the nomination of Adrien Duval as Speaker in replacement of the controversial Soorooidev Phookeer, has taken its first irreversible step towards joining forces with the MSM. This alliance is poised to contest the upcoming elections against the united front of the Labour Party, MMM, and the Nouveaux Démocrates.

For the PMSD, this was the logical and perhaps the only option left after being ousted, some will say ousting itself out, from the LP-MMM opposition alliance. The PMSD would like to believe this ouster had been orchestrated by Navin Ramgoolam and Paul Bérenger, each for their own strategic political reasons: Ramgoolam aimed to ensure a front bench that would represent a sociologically balanced composition, appealing to the LP electorate, while Bérenger sought to secure the MMM's sole representation of minority interests in either a coalition with the Labour Party or alternatively with the MSM. Additionally, Bérenger aimed for a larger share of electoral tickets within the LP-MMM-MD alliance. That however does not appear to have been the feeling of a key PMSD parliamentary splinter group that stayed on as the Nouveaux Democrates. Be that as it may, a departure without an alternative plank in the offing would have been suicidal for the PMSD in our FPTP electoral system.

In joining forces with the MSM, the PMSD would surely seek to secure more favourable terms regarding electoral tickets, front bench presence, Cabinet positions, and a share of governmental power if an MSM-PMSD alliance were to emerge victorious in what promises to be a closely contested battle between the two major alliances in the upcoming elections. Pravind Jugnauth's expectation from Xavier Duval is that the PMSD will contribute significantly to winning a number of seats in urban constituencies, which would complement the more assured seats in rural constituencies (Nos. 4 to 14) needed to form the next government.

The extent to which the PMSD will deliver on these promises remains uncertain. Nevertheless, Pravind Jugnauth views Duval's alignment as a strategic move that provides the MSM with a dual insurance policy for securing victory in the next elections. What remains less recognized is the covert yet

Jocelyn Grégoire, a Catholic priest with considerable sway among the working-class Creole community — a support base potentially larger and more influential than that of the PMSD and the Duvals. Grégoire played a pivotal role in securing victories for the MSM in both 2014 and 2019, despite allegations of electoral malpractice tarnishing the latter

As for the PMSD, managing its transition from four years of robust opposition against the autocratic and repressive policies of the MSM-led government presents a formidable challenge. Their strategic pivot towards the MSM, seen as a "retournement de veste." raises questions about their credibility and consistency in the eyes of the electorate. It must be borne in mind that the urban electorate have been deprived of their democratic rights for almost ten years. Cozzying up to those he slammed regularly over four years as Leader of the Opposition, revealing many misdemeanours and malpractices, may be a bridge too far even for large parts of his electorate. However, for Xavier Duval, the immediate concern may lie in ensuring the PMSD's continued relevance in Mauritius' political landscape and securing a future for his political legacy and political heirs.

This unfolding scenario underscores a high-stakes power game where political lea-ders and their parties strategize to gain influence and control over the electorate, ultimately aiming to secure the majority needed to win elections. Playing one's cards adeptly in such power games demands a blend of strategic acumen, the ability to manage complexities inherent in a multi-racial and multireligious society like Mauritius, and above all, humility. Whether the PMSD's alignment with the MSM-led alliance in 2024 will replicate the conditions of 2014 remains to be seen. The outcome will hinge significantly on the opposition's strategic response to these familiar yet evolving circumstances.

If the noisy showdown around the selection of Adrien Duval as Speaker of the National Assembly is anything to go by, the country cannot afford a prolongation of higher echelon political survival jockeying. General elections that will be watched closely by many international observers and capitals, should not be delayed.

The global food system is owned by an ever smaller number of companies

It's damaging our health, our communities and the planet



cross the world, over 800 million people spend their days hungry. More than 2 billion have limited access to food. Yet today's global food system produces enough to feed every person on the planet.

This imbalanced situation can be explained in part by the effects of things like natural disasters, war, fragile supply chains and economic inequality. These are all significant factors which highlight the problems of a truly global food system, where shocks spread quickly from one place to another with sometimes devastating results.

But they do not provide the full picture and cannot fully explain the rise of ultra-processed foods, the financial difficulties facing farmers, or why the world has failed to address the harmful environmental impacts of food production.

To account for these trends, we need to look at market concentration, and how a small number of very big companies have come to dominate the production and supply of the food we all eat.

For the global food system has become much more concentrated in recent years, partly through an increase in mergers and acquisitions, where large firms buy up rival companies until they completely dominate key areas.

High levels of market concentra-

tion mean less transparency, weaker competition, and more power in the hands of fewer firms. And our research reveals that a rise in the number of mergers and acquisitions is taking place at all stages of the global food system - from seeds and fertilisers to machinery and manu-

This is all part of food being increasingly seen as a source not only of human sustenance, but as a profitable investment - or what is known as the "financialisation of food".

And while people have been buying and selling food for a very long time, the global system has seen a major incursion of big finance in recent decades. Pension funds, private equity and asset management firms have invested heavily in the sector.

The logic is simple. Everybody needs food, so the sector promises safe and potentially lucrative returns.

But feeding the world while looking after the planet costs money, and unfortunately, big financial actors are all about the bottom line.

La démission du Speaker, présage d'une nouvelle alliance politique

a marmite politique est en ébullition avec pour toile de fond une probable élection partielle dans la circonscription no. 10 le 10 octobre 2024, suivie de la dissolution du Parlement le 21 novembre 2024, et la mise en place d'un gouvernement de transition («caretaker government») jusqu'à la tenue des élections générales en avril 2025.

Ce scénario est devenu plus plausible avec un développement politique de taille survenu cette semaine: la démission du Speaker de l'Assemblée législative, M. Sooroojdev Phokeer. Si l'on parlait de son remplacement éventuel ces derniers jours dans le contexte de la formation d'une nouvelle alliance politique entre le PMSD et le MSM, personne ne pouvait prévoir à quelle vitesse les développements politiques allaient se cristalliser.

Les circonstances du départ de M. Phokeer sont surprenantes, au même titre que le scénario de la démission de Vikram Hurdoyal de son poste de député du MSM après sa révocation comme ministre de l'Agriculture. Dans les deux cas, il y a une impression d'opacité. M. Phokeer a-t-il démissionné de son poste de son propre gré ou a-t-il été forcé à la démission pour faire place à un successeur probable dont le nom a été mentionné cette semaine, celui d'Adrien Duval, ex- député du PMSD? C'est la question que tout le monde se pose.

Frasques du Speaker

L'admission du Speaker à l'hôpital pour cause de maladie, suivie d'une intervention chirurgicale, est en apparence le motif de son départ. Or, il a soumis sa lettre de démission deux heures après une rencontre avec le Premier ministre. L'explication la plus plausible de sa démarche est que le MSM a voulu le remplacer le plus vite possible afin de faciliter une alliance avec le PMSD, dont la première étape est la nomination d'Adrien Duval au poste de Speaker.

Cette nomination a pour but de redorer le blason du gouvernement dont l'image a été souillée par les frasques du Speaker (notamment les suspensions et les expulsions injustifiées de députés de l'Opposition et le rejet de questions parlementaires embarrassantes). M. Phokeer avait sans doute ses idiosyncrasies, mais il serait inapproprié de tout mettre sur son dos. Toutes les motions d'expulsion et de suspension des députés de l'Opposition ont été présentées par le «Leader of the

House» et secondées par son adjoint. Le Speaker n'aurait pu agir seul dans ces excès.

Le comportement du Speaker soulève toute la problématique du mode de nomination du titulaire à ce poste. Traditionnellement, le Speaker était un député élu de la majorité après le passage de Sir Harilal Vaghjee dans ces fonctions dans les années 70. Dans les années 90, le gouvernement a changé ce mode de nomination pour choisir un Speaker non élu, ce qui a placé le titulaire du poste à la merci de la majorité.

Un Speaker non élu est toujours redevable au gouvernement qui le nomme, et non pas à l'électorat. Un Speaker élu est conscient de son devoir d'indépendance et d'impartialité parce qu'il doit briguer les suffrages de nouveau en rendant des comptes à ses mandants.

Il faut souhaiter qu'un prochain gouvernement alternatif amendera la loi pour prévoir un Speaker élu en permanence. Ce serait enlever du Premier ministre le pouvoir de nommer un de ses fidèles supporters à un poste stratégique de l'État au défi de toutes les normes de bienséance. Est-ce que le successeur de M. Phokeer (Adrien Duval ou un autre) saura faire preuve des qualités nécessaires d'un

Speaker indépendant et impartial? L'avenir nous le dira.

Duval ferait partie des conditions d'une alliance MSM-PMSD. Le PMSD voudrait apporter certains changements au gouvernement pour justifier une telle alliance auprès du public. Il s'agit pour lui de montrer qu'il ne cautionne pas le statu quo 100% et que sa présence au sein du gouvernement avant les prochaines élections apportera un certain renouveau.

Si l'on se fie aux thèmes que le leader du PMSD a toujours soulevés dans le passé, le PMSD devrait amener le gouvernement à

- adopter une approche plus démocratique au Parlement,
- proposer des mesures pour alléger davantage les salariés et les retraités (par exemple, un boni de fin d'année équivalant au 14e mois),
- réviser la politique en matière d'éducation pour les recalés des examens du Primary School Achievement Certificate (PSAC) et les critères d'admission en HSC (4 au lieu de 5 crédits de SC),
- revoir les critères de nomination de chefs de service dans certaines institutions (FCC, MBC, FSC, etc.), et

-- préserver les pouvoirs de poursuite du DPP

l'indépendance du DPP, dont les pouvoirs de poursuite pour crimes financiers ont été usurpés par la Financial Crimes Commission (FCC), est l'enjeu majeur qui avait poussé le PMSD à démissionner du gouvernement MSM-PMSD en 2017. Le PMSD n'était pas d'accord avec le projet de loi créant une commission de poursuite parallèle au DPP. Comment acceptera-t-il l'usurpation des pouvoirs de poursuite par la FCC maintenant?

Conditions d'alliance

Si le MSM accepte les conditions du PMSD pour un renouveau démocratique. même si ce n'est que de manière apparente, les deux partis feront une alliance pour affronter l'Opposition PTr-MMM-ND aux prochaines élections. Ils tiendront l'élection partielle dans la circonscription no. 10 (Montagne Blanche/ Grande Rivière Sud-Est), en croyant remporter la victoire faute d'adversaire de l'Opposition parlementaire, et formeront un gouvernement de transition jusqu'aux prochaines élections générales en avril 2025 (soit dans le délai maximal prévu dans la loi). D'ici cette échéance, cette alliance aura le temps de présenter certaines mesures populaires (ex: 14e mois) et venir de l'avant avec d'autres mesures avec des effets d'annonce dans un manifeste électoral (ex : pension de vieillesse de base à Rs 18 000 dans le prochain mandat) et apporter certains changements symboliques ou cosmétiques dans les institu-

Après son départ de l'alliance de l'Opposition parlementaire, le PMSD n'a pas d'autre choix que de s'allier au MSM s'il veut être partenaire d'un prochain gouvernement, comme il le dit. Toutefois, il devrait pouvoir justifier cette alliance auprès de ses partisans par des conditions qui lui donnent un peu de crédibilité telles que le nombre de tickets aux élections (un minimum de 12), des postes ministériels importants (Finances, Tourisme, Premier ministre adjoint), et des nominations pour ses cadres dans les institutions et ambassades.

La question est de savoir si le MSM fera toutes ces concessions au risque de froisser ses autres alliés (Linite Militant, ML) et ses propres membres. Pour sa survie politique, il s'obligera sans doute de plaire au PMSD, qui lui apportera les "cinq sous" qui lui manque dans les régions urbaines et conférer à l'alliance gouvernementale une image nationale.

Sous ce rapport, la prochaine bataille électorale sera essentiellement la répétition du scénario de 2014 avec deux camps opposés (le PTr-MMM d'un côté et le MSM-PMSD de l'autre), avec quelques variations mineures ici et là.

perpétrées par des femmes. La première eut lieu le 5 septembre lorsque Lynette (Squeaky) Fromme, une disciple du chef de secte Charles Manson, tenta de tirer sur Ford alors qu'il traversait un parc à Sacramento, en Californie, mais son arme ne fonctionna pas. Le 22 septembre, Sara Jane Moore, liée à des groupes radicaux de gauche, tira un coup de feu sur Ford alors qu'il sortait d'un hôtel à San Francisco, mais manqua le président.

Les candidats à la présidence ne furent pas épargnés par les tentatives d'assassinat, notamment le sénateur Robert F. Kennedy, assassiné en 1968, et George Wallace, blessé et paralysé en 1972. lors d'événements mettant en danger leur sécurité. Trump a eu la chance de s'en sortir avec seulement des blessures mineures.

En revanche, la façon dont un présumé assassin a réussi à blesser Donald Trump et à tuer au moins un spectateur lors d'un rassemblement en Pennsylvanie samedi soir reste à déterminer par le FBI et d'autres enquêteurs gouvernementaux, à travers ce qui sera probablement une longue enquête. Mais pourquoi une telle attaque a-t-elle visé l'ancien président et actuel candidat du GOP à l'élection présidentielle de 2024 ? C'est une question qui devrait être examinée plus rapidement.

Arie Perliger, directeur des études sur la sécurité et professeur de criminologie et d'études sur la justice à l'Université du Massachusetts, qui étudie la violence politique et les assassinats, pointe du doigt la polarisation aiguë qui afflige la politique américaine comme une partie clé du contexte dans lequel cette tentative apparente d'assassinat s'est produite.

"La démocratie ne peut fonctionner que si les différents partis, les différents mouvements, sont prêts à collaborer sur certaines questions. La démocratie fonctionne lorsque plusieurs groupes sont prêts à trouver un consensus par des négociations, à collaborer et à coopérer. Ce que nous avons vu au cours des 17 dernières années, essentiellement depuis 2008 et l'émergence du mouvement Tea Party, c'est une polarisation croissante aux États-Unis. Et le pire de cette polarisation est que le système politique américain est devenu dysfonctionnel dans le sens où nous éliminons tous les politiciens et décideurs intéressés par la collaboration avec l'autre camp. C'est une chose.

"Deuxièmement, les gens délégitiment les dirigeants qui sont prêts à collaborer avec l'autre camp, les présentant comme des individus qui ont trahi leurs valeurs et leur parti politique. La troisième partie est que les gens délégitiment leurs rivaux politiques. Ils transforment un désaccord politique en une guerre où il n'y a pas de place pour travailler ensemble pour relever les défis qu'ils reconnaissent tous face à la nation.

"Lorsque vous combinez ces trois dynamiques, vous créez essentiellement un système dysfonctionnel où les deux camps sont convaincus que c'est un jeu à somme nulle, que c'est la fin du pays. C'est la fin de la démocratie si l'autre camp gagne," explique Perliger, ajoutant ceci: "Si les deux camps martèlent encore et encore aux gens que perdre une élection, c'est la fin du monde, alors ce n'est pas surprenant que finalement les gens soient prêts à prendre la loi entre leurs mains et à recourir à la violence."

a tentative d'assassinat de Donald Trump, où il a miraculeusement échappé à la mort samedi dernier, le 13 juillet, alors qu'une balle a frôlé son oreille droite lors d'un rassemblement de campagne en Pennsylvanie, met en lumière les dangers auxquels font face ceux qui cherchent à obtenir des votes dans un pays où la Constitution garantit aux citoyens le droit de porter des armes.

Trump rejoint ainsi un groupe peu commun de présidents, anciens présidents et candidats à la présidence américaine ayant été la cible des balles. Parmi les 45 individus ayant occupé la présidence, quatre ont été assassinés en fonction.

Thomas Klassen, professeur de politique publique et d'administration à l'Université de York, au Canada, souligne que, en raison du statut presque mythique des présidents américains et du rôle de superpuissance des États-Unis, les assassinats politiques frappent au cœur même de la psyché américaine.

Les assassinats d'Abraham Lincoln en 1865 et de John F. Kennedy en 1963 sont des moments clés de l'histoire américaine. Moins souvent évoqués, ceux de James Garfield (1881) et de William McKinley (1901) avaient aussi profondément ébranlé la nation à leur époque.

C'est après l'assassinat de McKinley que le Secret Service des États-Unis s'est vu confier la tâche d'assurer une protection à temps plein aux présidents.

Le dernier président américain touché par des tirs fut Ronald Reagan, gravement blessé et nécessitant une intervention chirurgicale d'urgence en 1981. Lorsqu'il sortait d'un hôtel à Washington après avoir prononcé un discours, le tireur John Hinckley Jr. tira sur lui avec un pistolet .22. Une balle ricocha sur la limousine présidentielle et le toucha sous le bras gauche. Après 12 jours d'hospitalisation, Reagan rentra à la Maison Blanche.

D'autres présidents ont été visés par des tirs sans être blessés. En 1933, un tireur tira cinq coups de feu sur la voiture du président élu Franklin D. Roosevelt. Ce dernier ne fut pas touché, mais le maire de Chicago, Anton Cermak, qui parlait au président élu après que ce dernier eut fait de brèves déclarations au public, fut blessé et décéda 19 jours plus tard.

En septembre 1975, le président Gerald Ford survécut à deux tentatives d'assassinat distinctes, toutes deux

En 1912, l'ancien président Theodore Roosevelt fut touché à la poitrine par une balle de calibre .38 alors qu'il faisait campagne pour regagner la Maison Blanche. Cependant, la majorité de l'impact de la balle fut absorbée par des objets dans la poche poitrine de la veste de Roosevelt. Malgré sa blessure, Roosevelt continua de prononcer son discours de campagne avec la balle toujours logée dans sa poitrine.

D'autres figures politiques d'importance, bien qu'elles ne fussent pas élues, furent également tuées par des tirs, notamment Martin Luther King Jr. en 1968, quelques mois avant la mort de Bobby Kennedy.

Dans un pays avec plus d'armes que de citoyens, où les armes à feu sont facilement accessibles, il n'est pas surprenant que les tirs soient souvent le moyen privilégié pour tuer ou tenter de tuer des titulaires de charges politiques.

Comme Trump, la plupart des tentatives d'assassinat surviennent lorsque les candidats et les politiciens se trouvent dans des lieux publics avec des foules à proximité. Il existe une longue tradition de politiciens insistant, contre l'avis de leurs conseillers en sécurité, pour "serrer la main"

es Jeux olympiques d'été de 2024, officiellement baptisés Paris 2024, sont prévus du vendredi 26 juillet au 11 août 2024, avec certaines compétitions commençant dès le 24 juillet. Paris sera la ville hôte principale, avec des événements organisés dans 16 autres villes à travers la France métropolitaine, ainsi qu'un site additionnel à Tahiti, une île relevant de la collectivité d'outremer de la Polynésie française. Paris 2024 marquera le début du "breakdance" en tant que discipline olympique. Les Jeux de 2024 devraient coûter 9 milliards d'euros.

es Jeux olympiques de Paris réuniront ⊿environ 10 500 athlètes de 200 pays ou régions. Mais au-delà du divertissement sportif les Jeux sont une immense entreprise qui génère des milliards de dollars de revenus pour le Comité International Olympique (CIO) selon Stephen Wade de l'agence de presse AP, tout en servant de levier pour l'influence géopolitique, perceptible à travers le classement des médailles. la présence des leaders mondiaux à la cérémonie d'ouverture et les hymnes nationaux célébrant les vainqueurs des médailles d'or.

Les Jeux olympiques sont un business, pas une œuvre de charité. Le CIO, organisation à but non lucratif basée à Lausanne, en Suisse, tire 91 % de ses revenus de la vente des droits de diffusion (61 %) et des parrainages (30 %). Le revenu pour le dernier cycle de quatre ans des Jeux d'hiver et d'été, se terminant avec les Jeux de Tokyo en 2021, s'élevait à 7,6 milliards de dollars.

Bien que le CIO prétende réinvestir 90 % de ses revenus dans le sport, les athlètes n'en reçoivent qu'une petite partie.

Il y a des discussions en cours pour changer cette répartition. En 2019, le CIO a inauguré un nouveau siège, coûtant environ 200 millions de dollars. Les nations hôtes supportent la majorité des coûts de l'organisation des Jeux. Les Jeux de Tokyo ont été officiellement budgétisés à 13 milliards de dollars, plus de la moitié étant pris en charge par les entités gouvernementales japonaises. Les coûts olympiques sont difficiles à suivre, mais un audit du gouvernement japonais a suggéré que les coûts réels pourraient avoir été le double du montant officiel.

Adhésion et privilèges

+Le CIO compte environ 100 membres. Les membres élisent leurs propres collègues et la plus ancienne est la princesse Nora du Liechtenstein. Au moins une demi-douzaine d'autres membres de familles royales font partie du CIO. Cependant, la plupart du pouvoir est concentré entre les mains du président Thomas Bach. avocat allemand et membre du CIO, ainsi que de son conseil exécutif.

Les membres du CIO sont techniquement des bénévoles, bien que toutes les

dépenses de Bach soient couvertes par le CIO. Le rapport annuel du CIO indique que cela s'élevait à 370 000 dollars en 2022, comprenant une "indemnité" annuelle de 275 000 euros, soit environ 295 000 dollars. Ses obligations fiscales de 163 000 dollars en Suisse ont également été payées. Les membres du CIO reçoivent des indemnités journalières entre 450 et 900 dollars pour assister aux réunions, ainsi que des voyages en première classe et un logement cinq

Mélange de sport et de politique

Dr S Jaishankar: Bharat Matters

auritius is honoured for the Dr R Neerunjun Gopee second time by the presence of the Hon External Affairs

Minister of Bharat, Dr Subramaniam Jaishankar, who had been here once before, in 2021. From the official commu-

niqué it is obvious, as expected, that he has a packed and tight schedule during this brief two-day visit. It is a pattern of work engagements that he is used to as he goes around both in Bharat and the world promoting Bharat's perspective and positions and defending his country's in-

I had the opportunity to interact with him as part of a media delegation that was generously hosted by the Government of India in 2017. I recall that he was asked some probing questions about the Diego Garcia issue and gave forthright answers. It is the same forthrightness and clarity, as well as politeness and firmness, that he displays when he answers queries in various settings on the global stage in his capacity as External Affairs Minister since he assumed the responsibilities of the post following the general elections of 2019. It came as no surprise that he was re-appointed to this position after the 2024 elections, as part of PM Modi's third Cabinet which comprises several other previous occupants of the same ministerial portfolios, such as for example Finance Minister Nirmala Sitharaman.

One of the very first of such responses was shortly following the breakout

of the European war between Ukraine and Russia, and in fact that response went viral and is still often referred to. It was during a press briefing in a European capital, and he was asked by a lady journalist of Al Jazeera about Bharat buying oil from Russia. > other countries. Et le comble, as we say in French, Europe too was buying crude from Russia refined in Bharat! Speak of double standards and hypocrisy!

> Dr Jaishankar is a seasoned diplomat with over four decades of experience of service in major capitals of the world, including Washington and Beijing, which gives him the breadth and the depth of knowledge and understanding of international affairs that he brings to bear as the global most well-known public figure of Bharat after PM Narendra Modi. The quote at the top of the page is part of the text on the back cover of his second book, 'Why Bharat Matters' which is worth citing in toto:

> 'India's quest to ascend the global hierarchy is an endless journey. But as we take stock of the progress made and anticipate the challenges ahead, it is certainly reassuring that this is propelled by such deep national commitment and confidence. Whether it is drawing strength from its heritage and culture or approaching challenges with the optimism of democracy and technology, this is certainly a New India. And hence 'Why Bharat Matters'.

The Mahabharata, in particular, is a historical narrative that stretches to the beginnings of Indic civilisation unknown thousands of years ago, wherein are to be found accounts of the rise and fall of dynasties - mankind's history in fact -, and embedded within are critical lessons in statecraft that are relevant for all times.

Indeed, it is said of the Mahabharata that 'whatever is found in it can be found elsewhere too, but what is not in it cannot be found anywhere.'

In an interview that he gave to the magazine India Today a few years ago, Dr Jaishankar shared some of the lessons and insights in governance and diplomacy that Mahabharata provides and concluded that Bharat must follow what he calls the Mahabharata Way. In fact, he always carries a copy of the Mahabharata with him when he travels.

In his first book, 'The India Way', he expands further on this as he describes the obstacles, opportunities and challenges that the changing world order, one of multipolarity and uncertainties, is throwing up and that every country is having to cope with. At the same time, this brings new responsibilities to countries concerned with maintaining peace and stability, such as Bharat, ensuring that development and progress can take place, and that the benefits can spread to and be shared by all peoples.

In this unfolding future, Bharat has a major role to play as a rising superpower which now ranks 5th in the global economy and, in all likelihood, it is on an unstoppable trajectory to rise to the third place by 2030

Mauritius should therefore consider itself fortunate to have such close historical and cultural ties with Bharat, whose global concerns and sought after skills and capacities perforce extend to all regions. It is inevitable that geopolitical considerations should drive Bharat's interest in the Indian Ocean and the coastal countries therein, and Mauritius being one of them is a natural partner quite apart from the historical reasons. These would themselves be sufficient justification for partnering, as Bharat pursues its goal of 'making friends and influencing the world.'

Many examples of this will be found in 'The India Way', a revealing one being how Bharat, over and above manufacturing and administering a staggering two billion doses of Covid vaccines to its own citizens, donated nearly 400 million doses to help out countries that had no manufacturing capacity or the means to source them from the then quasi-closed global market. Mauritius was one of the first beneficiaries of this 'Vaccine Maitri' (Vaccine Friendship).

En passant, it may be noted that among the early beneficiaries was Canada (500,000 doses), and that country's leadership's mode of expressing its gratitude for this lifesaving gesture is to be a haven for anti-Bharat terrorism.

As Dr Jaishankar wrote in 'The India Way': 'This is the time for us to engage America, manage China, cultivate Europe, reassure Russia, bring Japan into play, draw neighbours in, extend the neighbourhood and expand traditional constituencies of support.'

I presume Mauritus belongs to that last category, and it is therefore apt to reciprocate with a 'Namaste, Swagatam' to Dr Jaishankar in response to the 'Namaste Mauritius' that he has posted.

Breakfast with Bwana

n July 1, 2024, three days before America would celebrate the 248th anniversary of its creation as a nation conceived in Liberty and dedicated to the proposition that all men are created equal, we heard from the Supreme Court that all men are not created equal after all. A President or former President is more

equal than any other American.

Supreme Court opinions are preceded by a Syllabus, a summary of the court's quintessential rulings, prepared by the publisher (known as the Reporter) of the court's decisions. The decision in the case styled *Trump v. United States* (the original case was filed as *United States v. Trump*, but after the appellate court rejected Trump's claim of immunity, he petitioned the Supreme Court to hear his appeal, and since he was the petitioner, his name went first. In a strange way, this creates the misleading impression that Trump brought the challenge in the first place. Anyhow, the first paragraph of the Syllabus stating the core holding was straightforward:

Under our constitutional structure of separated powers, the nature of Presidential power entitles a former President to absolute immunity from criminal prosecution for actions within his conclusive and preclusive constitutional authority. And he is entitled to at least presumptive immunity from prosecution for all his official acts. There is no immunity for unofficial acts.

This conceals a major sleight of hand by the Supreme Court. The President's authority stems either from the language of the Constitution, or from Congress when it enacts legislation authorizing the President to act. In the former case, the President's authority is conclusive and preclusive, ergo this means that Congress cannot criminalize any aspect of presidential authority, and the courts cannot examine it. This grants him Total Immunity.

So far, that does not seem extraordinary. The President does have certain core powers under the Constitution, and when he exercises his discretion, the consequences should be something that we accept. But the Supreme Court could have ruled that in exercising those powers, the President is not authorized to violate criminal law. Indeed, the Constitution states that the President "shall take Care that the Laws be faithfully executed." The word "shall" is understood, in legal construction, to be a command. It would be extraordinary if the Founding Fathers and drafters of the Constitution intended to convey the notion that the President's duty in this regard implicitly includes a personal executive right to violate those same laws. The illogic is palpable.

The sleight of hand came regarding the suggestion that the President may not have immunity from prosecution for official acts that are not part of the core authority vested in him. But, at first, the Supreme Court stated, there is a presumption of immunity, and the burden is on the government to rebut that presumption. In short, it must be shown that the prosecution does not pose any dangers of intrusion on the authority and functions of the Executive Branch. The problem is that the Constitution states: "The executive power shall be vested in a President of the United States." Therefore, it can be argued that no matter what the President does, he is exercising that executive authority. Since the executive authority that is vested in the President is exclusive and preclusive, there is absolute immunity. The exception for some "official" acts is a mirage.

The Supreme Court could have ruled that the Constitution does not authorize the President to commit criminal acts in the discharge of his duties and that no indictment may be filed without presentment to and review by a federal judge, subject to appellate rights, showing good cause to believe that a crime was committed. The

court did not choose this sensible course.

We may well favour the antics of alley cats over the stumbling of the lobotomy section.

Trump, of course, lied his way through the debate. So, what else is new? It has been reported that he told 28 or 38 lies. Trump has for long lied to himself and to America. A people feeling abandoned by their government finds solace in lies and false promises. This is how fascism begins. This is how fascism sets in.

The disturbing and sad aspect of all this was that the two CNN talking heads (I refrain from calling them journalists) who anchor TV shows, couldn't bring themselves to call Trump out for his lies. Those who speak and believe their own lies the loudest, trump the feckless. So it was, that night.

Biden's debate performance was so disturbing that calls for him to step down came from his friends within his own party. Former Speaker Nancy Pelosi effectively threw him under the bus when, instead of a full-throated endorsement, she stated that Biden has to make the decision whether to stay in the race. Whereas that is stating

the obvious, even after Biden had vociferously denied that he is going to step down, she stated: "We're all encouraging him to make that decision, because time is running short."

Trump was quick to invoke the Divinity as his savior. So were fellow Republicans who arrived in Wisconsin for the Republican National Convention at which Trump will be anointed and declared the party's nominee for the presidential election.

But it would be a mistake to think that God had anything to do with this. There is no verifying the claim some make that God whispered in his ear: "Donald Duck!!" just in time and this was the graze of Gawd.

An almost instant caravan, a stream of pastors and politicians, flocking to the asylum, started to thank God for saving Trump. Senator Marco Rubio, whom Trump once derided as "Little Marco" chimed in: "God protected President Trump."

Franklin Graham echoed that sentiment. No surprise there. After all, it's another opportunity to raise money from those feeling abandoned by their God and finding solace in salving their consciences by donating money for a different kind of false promise.

The political overtones followed. Ronald Jeffress, a pastor who has shown almost as much dedication to Trump as to God, posited: "I believe God spared Donald Trump's life for a purpose ... for the purpose of calling our nation back to its Judeo-Christian foundation."

Did God really save Trump? Was this a case of being saved by the grace of God, or is it more appropriate to say "Gawd, Trump is lucky that the bullet just grazed him?" By the graze of gawd, for Chrissake.

piece by Shaine Claiborne writing in Religious News Service caught my eye. "Theology — the attempt by our finite minds to try to make sense of a God who is infinitely bigger than our imaginations — can be tricky. But in this case it's not that hard to see that there is something wrong with a theology that says God intervened to save Donald Trump, which implies in an awful way that God redirected the bullet into the person who was

killed at his rally, or the two people who were grievously injured.

"If our theology lands us with a version of God that hates all the same people we hate, excludes all the same people we exclude, kills all the people we want killed and saves all the people we want saved, there is something wrong with our theology. Claiborne has put his finger on a problem he did not describe fully. American politics has become about hate and hatred. We view our common problems, and Gawd we have enough of them, not as American problems looking for solutions, but as occasions to accuse our opponents as being the cause of our ills. In the process, although we likely would agree on the desired outcome if we were to

address the problem, we lose sight of the solution.

Each came to praise Caesar

Against this backdrop, Trump chose Senator J.D. Vance of Ohio as his Vice-Presidential running mate. Vance is a very smart guy, a graduate of Yale Law School.

But what is it about these Yale Law School chaps? Clarence Thomas, Samuel Alito, Brett Kavanaugh, all Supreme Court justices graduated from Yale. And Sonia Sotomayor too, but let's lie to ourselves a bit and let that one lie.

Back in 2016, Vance said to a television interviewer: "I'm a Never Trump guy, I never liked him."

That same year, he told NPR: "I can't stomach Trump. I think that he's noxious and is leading the white working class to a very dark place." He also wrote an op-ed for *The New York Times* titled: "MrTrump Is Unfit For Our Nation's Highest Office."

Later, after Trump supported Vance's bid for the Senate, Vance said: "I didn't think he was going to be a good president," he said. "He was a great president. And it's one of the reasons why I'm working so hard to make sure he gets a second term."

Vance also wrote to one of his college roommates that Trump is an American Hitler.

It's not just Trump. At the Republican convention, a procession of politicos showed up and praised Trump. These included people he had derided, Senator Ted Cruz, Rubio mentioned above, Nikki Haley, Ron DeSantis, to name a few. Each of them in the past has expressed the view at some level that Trump is unfit to be President of the United States.

Yet, each came to praise Caesar, not to bury him. The evil that Trump has done and promises to do, is interred with the bones of the nation.

They aim to maximise returns, provide value to shareholders, and meet the expectations of markets.

This makes mergers and acquisitions an attractive business proposition. Why make risky, long-term investments in sustainable food solutions, when you can buy your competitor, increase your market share, and potentially make a lot of money in the process? By boosting share prices and removing competition, buy-outs have been used wide-

ly throughout the global food system as an easier way to achieve further growth.

Hunger games

This has resulted in more concentration and fewer, more powerful firms. One report revealed that just four firms control 44% of the global farm machinery market, two companies control 40% of the global



seed market, and four businesses control 62% of the global agrochemicals market. This trend is matched in food retail, with four firms – Tesco, Sainsbury's, Asda, and Morrisons – estimated to control over 64% of the UK grocery market.

This level of concentration and power affects everyone. It means less bargaining power for farmers, who are forced to

negotiate with powerful conglomerates. Workers across key stages of the global food sector face downward pressures on wages, rights, and conditions. Local communities lose autonomy over how their land is cultivated and how the rewards are distributed.

And the negative effects are not limited to those working in food.

Fewer firms and less transparency can lead to higher prices. And research on Europe has shown that

places with higher food market concentration, including the UK and Germany, sell more ultra-processed food.

The global food system also plays a big part in climate change. Too much corporate power limits the opportunities for communities to tackle environmental issues and move towards sustainable provision of healthy food for everyone by

producing more food themselves.

With so much at stake, improved regulation should surely be on the menu. Our research revealed the majority of food system mergers and acquisitions take place between firms of the same nationality. This could provide an opportunity for governments to prevent further market concentration within their borders — and even to seek to dilute what already exists.

International arrangements are more complicated, and would require a coordinated, international approach. However, this may prove difficult given the first-ever UN "food systems summit" in 2021 remained "strategically silent" on the issue.

We believe market concentration must become a defining feature of food system reform. To address climate change, provide a fair deal for workers, and eradicate hunger, we need power to be less corporate – for the benefit of the entire global community.

"Scrap the FCC Act and restore the DPP's powers"

'We cannot create a parallel criminal system for financial crimes, which escapes the DPP's control. This is a fertile breeding ground for political interference'



with speculation regarding potential legal actions against political figures, particularly the Leader of the Labour Party, Dr Navin Ramgoolam, by the Financial Crimes Commission (FCC). The FCC's Director General, Navin Beekarry, has categorically dismissed these speculations, asserting that such claims are baseless and far from the mandate of the FCC. However, amidst these discussions lies a broader concern about the FCC's role and independence in high-profile cases, especially with political implications.

To delve deeper into these pressing issues, Sanjay Bhuckory, SC, who brings extensive experience in constitutional matters, shares his insights on these matters, including the cases involving the Director of Public Prosecutions (DPP) against the Financial Crimes Commission (FCC) and the Commissioner of Police.

Mauritius Times: There were speculations in recent weeks about an imminent arrest of the Labour Party's leader by the FCC in relation to an "Unexplained Wealth Order" of the earlier Integrity Reporting Services Agency. The DG of the Financial Crimes Commission (FCC), Navin Beekarry, has responded to the speculations, saving that "the suggestion that the FCC was created to arrest Dr Navin Ramgoolam is completely ridiculous and false". Aside from the political implications of such a decision, would it be correct to say that the FCC would be fully entitled to pursue that course of action if there is sufficient evidence or a legal basis to justify it?

Sanjay Bhuckory: I strongly disagree. It would be preposterous for the FCC to re-arrest someone nearly ten years after the alleged acts. Worse still, the politically controlled FCC has now

absorbed the independent Integrity Reporting Services Authority (IRSA), which was headed by no lesser than a former UK Chief Justice. The FCC Act, which was passed with a simple majority, cannot overnight be utilised to the detriment of a suspect's constitutional rights.

In fact, Dr Ramgoolam is challenging the constitutionality of two sections of the FCC Act before the Supreme Court: firstly, section 112(4), arguing that it places the burden on him, rather than the prosecution, to prove that his property is not unexplained wealth; and secondly, section 117(1), asserting that he cannot be unfairly deprived of his property through a confiscation order for unexplained wealth.

It is comforting to know that the Director General of the FCC has given the assurance that he will not arrest Dr Ramgoolam. Hopefully, he will, in the same breath, freeze all legal actions against the latter, pending the determination of the constitutional plaint.

to the perception that the FCC is being weaponised to target political opponents, particularly the main challenger to the current Prime Minister. This situation could be seen as another 'colourable device,' a term used by the late Chief Justice Rajsoomer Lallah in another case involving Navin Ramgoolam. What are your thoughts on this?

Recent events in India and the USA have sent strong signals to ruling parties across the world that prosecuting, not to say persecuting, political opponents on the eve of national elections may well backfire. Closer to home, the FCC and the Police are increasingly being perceived as having been weaponised to target political opponents. This is so because media reports are abundant with instances where the speed and outcome of FCC or Police inquiries appear to vary based on the individuals' proximity to power.

This weaponisation perception has, through the adoption of the FCC Act, become a reality because, contrary to the then ICAC, the FCC is now under no obligation to submit a comprehensive report of all its enquiries to the DPP. Thus, the DPP will henceforth be kept in the dark as to the outcome of the FCC's enquiries, thus depriving him of the power to decide whether to institute criminal proceedings or not

* In any case, how the FCC prioritises urgency in its investigations can indicate how it maintains its independence from political influences, particularly in high-profile cases. Unfortunately, the Parliamentary Committee may not provide much assistance in this regard. What are your reflections on this?

Far from gaining the trust and confidence of the people of this country, which the ICAC had already lost, the situation has worsened with the accrued powers vested in the FCC. There is only one way to redress the situation: scrap the FCC Act and restore the DPP's powers. He alone is empowered, under the Constitution, to be at the apex of the criminal procedural system in Mauritius. We cannot create a parallel criminal system for financial crimes, which escapes the DPP's control. This is a fertile breeding ground for political interference, delaying tactics and cover-ups.

The Parliamentary Committee has no say in investigatory matters, leave alone in querying the Director General about any ongoing or shelved enquiry. In these circumstances, the Committee has no means of safeguarding the FCC's independence from any form of interference.

* There are also the current DPP, Rashid Ahmine, as well as his predecessor, Satyajit Boolell, who have both challenged the constitutionality of the FCC Act. In your view, how does challenging the FCC Act serve the public interest and the integrity of the legal system?

I am one of the counsels representing both the current and former DPP. In the case of the incumbent DPP, his challenge is based on two main grounds. Firstly, the FCC's decision to discontinue an investigation concerning an alleged offender, coupled with the FCC no longer being legally required to report its decisions to the DPP, deprives the DPP of the opportunity to exercise his authority under section 72(3)(a) of the Constitution to initiate criminal proceedings against an offender. This also undermines his authority to terminate proceedings under section 72(3)(c).

The DPP's second ground of challenge is that the FCC's decision to compound an offence under section 150 of the Act impacts his constitutional powers to initiate and terminate proceedings. Once an Agreement to Compound is reached between the FCC and an alleged offender behind the back of the DPP, the criminal process comes to an abrupt end. This prevents prosecution of the individual and thus deprives the DPP of the ability to exercise his authority under section 72(3)(a) of the Constitution to initiate criminal proceedings against the alleged offender, as well as his power to discontinue proceedings under section 72(3)(c) of the Constitution.

* Rajen Valayden has applied for leave to appeal to the Privy Council, challenging the Supreme Court's decision to set aside his constitutional plaint regarding the 2023 amendment to the Local Govern-ment Act, which postponed municipal elections. How does this case relate to the broader context of local governance and electoral processes in the country?

Mr Rajen Valayden, of whom I am one of the counsels,

is challenging the constitutionality of the 2023 law that postponed municipal elections for a period of two years. His main argument is that Section 1 of the Constitution guarantees periodic and fair elections at both local and national levels, and that this guarantee can only be interfered with in exceptional circumstances.

Contrary to what has been asserted, he was not asking the court to interpret such a right into section 1 of the Constitution, thereby making it a constitutional right. Nor was he suggesting that he has a constitutional right to vote in local elections. Instead, he was arguing that holding free and fair local elections periodically is a fundamental structural element of section 1 — meaning that it has a constitutional foundation, drawing on the Privy Council case of *Maharaj v. Attorney General of Trinidad & Tobago*.

Furthermore, he does not dispute that local elections may be postponed. He agrees that this may be so, provided certain strict criteria are fulfilled in the making of such law, namely that it must be expressed in clear and unambiguous terms, the grounds for postponement must be established by law, the grounds must be objective and reasonable, and the period of an extension must not be unreasonable.

Mr Valayden's standpoint is that the above conditions were not met in the amending law, thus falling short of the democratic component under section 1 of the Constitution - the more so since they are in breach of the *International Covenant on Civil and Political Rights*, of which Mauritius is a signatory, and which provides for genuine periodic elections.

Lastly, Mr Valayden referred to the Prime Minister's speech during the parliamentary debates on the amendment Bill, where the Prime Minister clearly recognized the importance of local elections as the grassroots of democracy and their impact on the state's performance.

* What potential consequences could the outcome of this appeal have on future amendments to the Local Government Act? Additionally, what are the possible outcomes of this appeal, and how might each affect the political landscape?

Assuming leave is granted, the whole political class, not to say the whole country, will await with eagerness the Privy Council's views on the matter. Once for all, we need to know whether, in a democratic State, local elections may be postponed without any reason being specified in the law, as it has invariably been the case in the past, save for the 2021 postponement on account of the Covid pandemic; or whether reasons need to be inscribed in the amending law, and if so, what types of reasons. This becomes even more relevant in light of the Privy Council's pronouncements in the two recent Trinidadian cases of Maharaj on the subject.

The first possible outcome is that the Privy Council rules that the amending law was unconstitutional, in that no reason was provided therein. Government will then have to hold local elections, or else postpone them by providing cogent grounds in the law, which grounds should be objectively verifiable before a court of law. The second outcome is that the judgment of the Supreme Court is affirmed, meaning that local elections, which have already been postponed for an aggregate period of 4 years over a spent period of 6 years, may again be postponed *ad infinitum* without any reason.

* Regarding the case of the Commissioner of Police (CP) against the DPP, which challenges the DPP's powers in pre-trial matters as unconstitutional, what would be the implications for the DPP's prosecutorial authority if the Court were to decide in favour of the Commissioner of Police?

The CP's case is that only he and his officers, and not the DPP, "have decision-making powers regarding investigations by the Police, and connected matters such as provisional charges, bail matters and objections to departure". The CP has therefore sought a declaration from the Supreme Court that "criminal proceedings, for the purposes of section 72 of the Constitution, do not include matters such as provisional charges, bail, and prohibitions against departure".

The DPP, for whom I am acting as one of his counsels, has averred that his powers under section 72(3)(a) of the Constitution "to institute criminal proceedings before any court of law" include all supervisory and decisional powers in relation to provisional charges, bail matters and objections to departure.

The CP has also sought a declaration that the DPP has, by his acts and doings and those acting under his authority, usurped his powers under section 71 of the Constitution as regards investigation-related matters. The present Chief Justice has endeavoured to expedite certain constitutional matters. Speaking from my own experience, the case of *Valayden v. The State* was heard within a record time of 5 months, and the judgment was delivered 7 months after the hearing, amounting to an aggregate of one year. Likewise, the case of *CP v. DPP* is being fast-tracked, despite the difficulty of finding common dates with the three British KC's appearing in the respective legal teams.

I will reiterate what I wrote in an Open Letter to the Chief Justice upon her appointment: it is high time that a constitutional court be created, which will be dedicated to processing and hearing such cases in utmost priority. In the same breath, an election court should also be set up to deal with election petitions. The case of *Ringadoo v. Jugnauth* in which I appeared for the petitioner, both here and before the Privy Council, took a total of 3 years to be resolved. Although we were successful, the time taken to achieve this result is unacceptable.

Our current crop of judges should keep inspiring themselves from their illustrious predecessors. As I like to say: "The future of the law lies in its past". Recently, Supreme Court judges Hamuth-Lauloo and Naidoo in the case of Eco-Sud v. Ministry of Environment, in which I was one of the counsels, took a bold and liberal view of the 'locus standi' test of those entitled to appeal to the Environment & Land Use Appeal Tribunal against the granting of an EIA licence by the Minister. Their judgment, which marked a significant breakthrough, was upheld on appeal by the Privy Council, which cited their reasoning with approval. This is a great source of pride for our Judiciary. As the saying goes: "Where there is a will there is a way".

Donald Trump is a 'changed man' after being shot

Donald Trump's demeanour underwent a significant transformation following a recent assassination attempt, which narrowly missed him at a convention. The incident has deeply affected the former president, leading to what many describe as a profound emotional shift. According to Florida Rep. Maria Salazar, who maintains close ties with Trump's inner circle, he now perceives this

event as a second chance granted by God.

"He believes that God spared his life and that he is a changed man," Salazar told Daily Mail on July 17. The attempted shooting, carried out by 20-year-old Thomas Matthew Crooks using an AR-style rifle, left Trump with a grazed ear, causing him to bleed.

Salazar, reflecting on conversations with those close to Trump, noted observable changes in his demeanor. "I'm not sure if it's a newfound spiritual depth or simply a more contemplative attitude, but he is different," she remarked.

At subsequent public appearances, including the convention where he appeared with a bandaged ear, Trump's behavior underscored this transformation. Salazar recounted how he visibly affected attendees by displaying a more introspective and prayerful demeanor during the event's benediction.

"This experience has fundamentally changed him," Salazar continued. "When you undergo such a profound moment, touched by higher powers, it reshapes your outlook and your approach to life."

Trump and his campaign have since emphasized unity and a renewed sense of purpose following the incident, aligning their rhetoric to reflect this newfound perspective.

Former US President Donald Trump on Monday picked JD Vance, a first-time senator from Ohio, as his running mate and nominee for the Vice-President post.

JD Vance, 40 years younger to Trump, is married to Usha Chilukuri Vance, the daughter of Indian immigrants to the US. She brings with her a deep connection to India and also the legacy of Indian culture and values.

Usha Chilukuri Vance's parents hail from Andhra Pradesh, who migrated to the United States decades ago. Born and brought up in the US, Usha holds an impressive educational background, having graduated from top-notch American institutes. She holds a Bachelor's degree in History from Yale University and then pursued Master's in Philosophy from Cambridge University, reports IANS. She also has a track record of a distinguished career, with professional engagements across multiple segments. She clerked for Supreme Court Chief Justice John Roberts.

Usha and JD Vance met at the Yale Law School and it was there that they developed a close affinity for each other. They got married in Kentucky in 2014 and together they have three children.

Usha Chilukuri Vance also made some rare appearances along with her husband as the latter campaigned for the Ohio senator election in 2022.

In a 2017 interview, she told NBC News on how they met, "We were friends, and I liked that he was very diligent. He would show up at 9 a.m. appointments that I would set up for us to start working on the brief together."

JD Vance, in the same interview, praised Usha for unflinching faith and commitment in things that she believed.

India expresses displeasure to Canada over Khalistan referendum

India has formally expressed its displeasure to Ottawa regarding the upcoming Khalistan Referendum organized by the secessionist group Sikhs for Justice (SFJ), scheduled for July 28. The Indian High Commission in Ottawa communicated its concerns to Global Affairs Canada, particularly objecting to the use of Canadian territory for separatist activities and the choice of a public venue, the Calgary Municipal Complex Atrium and Plaza, for the referendum.

In Calgary, where the referendum is set to take place, several posters promoting the event, which included images of controversial figures like Talwinder Singh Parmar and Hardeep Singh Nijjar, were defaced



with spray paint over the weekend. SFJ's general-counsel, Gurpatwant Pannun, confirmed the defacement and ongoing acts of vandalism against their promotional materials.

Additionally, SFJ initiated a 24-hour "picketing" of India's consulate in Vancouver, citing allegations from a Washington Post report regarding the consulate's alleged involvement

in Nijjar's killing. Although Canadian investigators have arrested four individuals in connection with the incident, no direct link to India has been established, with investigations ongoing. India has vehemently dismissed these allegations as baseless and politically motivated.

The referendum's contentious history includes previous attempts to secure venues such as Tamanawis Secondary School in Surrey, British Columbia, which was ultimately cancelled due to contractual violations. Despite challenges, SFJ proceeded with the referendum at alternative locations, underscoring ongoing tensions surrounding the issue both in Canada and internationally.

Bangladesh students reject PM olive branch after deadly protests

Students in Bangladesh have rejected an offer of reconciliation from Prime Minister Sheikh Hasina following deadly protests over civil service hiring regulations. Despite Hasina's promise of justice for the seven protesters killed during the demonstrations, Students Against Discrimination, the leading group behind the protests, dismissed her words as insincere. They vowed to continue their nationwide rallies demanding equal access to public sector jobs, which have led to clashes with riot police and allied student groups.

The government's response has been severe, including the indefinite closure of schools and universities and the use of tear gas and rubber bullets to disperse protesters. The situation escalated with widespread clashes and casualties, including the death of an



18-year-old protester from police-fired rubber bullets. Over 500 others were reported injured in recent confrontations, further fueling condemnation from rights groups like Amnesty International, which criticized the authorities for using excessive force.

Despite these challenges, the protests persisted with a nationwide shutdown observed in Dhaka, marked by sparse traffic and mobile internet outages affecting social media platforms crucial for organizing protests. The unrest highlights deep-seated grievances over a quota system in government jobs that critics argue disproportionately favors members of the ruling Awami League.

South Korea's top court upholds landmark ruling over same-sex spousal state benefits

South Korea's Supreme Court upheld a significant ruling on Thursday, affirming that a same-sex partner is entitled to spousal benefits from state health insurance. This decision, hailed as a landmark victory for LGBTQ rights in a country known for lagging behind its regional counterparts, stems from a case brought by So Sung-wook and Kim Yong-min. The couple, who have held a wedding ceremony and are regarded as married but not legally recognized as such in South Korea, filed suit against the National Health Insurance Service in 2021 after their spousal benefits were revoked.

Kim Yong-min expressed profound happiness and emotion upon hearing the ruling, emphasizing the long journey and the need for continued efforts to legalize same-sex marriage in the future. Chief Justice Jo Hee-de condemned the denial of benefits based on gender, labeling it discriminatory and a violation of fundamental rights such as privacy, equality, and pursuit of happiness.



This decision marks the first legal recognition of a same-sex union in South Korea, overturning previous rulings that denied such recognition. Despite progress in neighboring countries like Taiwan and Thailand, South Korea lacks legal acknowledgment of LGBTQ partnerships, pushing couples to seek marriage abroad if they wish for legal recognition.

Activists and campaigners view the Supreme Court's decision as a crucial step towards marriage equality in South Korea, representing hope for same-sex couples who have long faced discrimination and invisibility. However, the ruling has also sparked opposition from conservative religious groups in the country, highlighting ongoing societal divisions over LGBTQ rights.

The journey of So and Kim, who have chosen to be visible and open about their relationship, aims to challenge prejudices and inspire courage among LGBTQ individuals. Their case underscores broader struggles for acceptance and legal rights within South Korean society, where conservative sentiments often clash with calls for equality and non-discrimination.

Trump shooter's search history included queries on the royal family and FBI



he FBI faced challenges due to Thomas L Crooks' limited digital footprint after his attempted assassination of former President Donald Trump in Butler County, Pennsylvania. The 20-year-old gunman was reportedly killed by the US Secret Service on Saturday after he targeted the Republican presidential nominee.

Investigators had turned up emptyhanded even days after the initial stages of the investigation didn't point them towards a possible motive for the attack. Recent reports claim Crooks seemingly searched online while "scoping out" numerous highprofile figures as targets of assassination. According to the FBI, these search results also included an unnamed member of the royal family, reports HT.

Since the day of the Trump assassination attempt in Pennsylvania, FBI agents have downloaded the content of the two mobile phones owned by the gunman.

Further investigation of his devices revealed that he also searched about the director of the FBI, Christopher Wray, and US Attorney General Merrick Garland. Moreover, photos of Trump and President Joe Biden were saved on his phones along with pivotal dates surrounding the two reelection bidders, including the former president's rallies and the Democratic National

Convention, set to take place next month in Chicago.

Several conspiracies have shaped up since the attack, with added pressure on the US Secret Service, facing severe allegations of negligence. Their failure to protect Trump beforehand has especially been a major point of discussion in the headlines since an eyewitness claimed to have alerted them about a suspicious presence near the stage an hour before the shots were

Although Crooks was initially removed from the venue after a metal detector redflagged him, he reportedly perched himself high with a "direct line of sight" on Trump from outside the rally's secure zone. He used an AR-15 semi-automatic rifle, with other explosives found in his car.

While Homeland Security Secretary Alejandro Mayorkas has admitted to the Secret Service's incompetence, the Secret Service director Kimberley Cheatle has since received calls to resign once she acknowledged no snipers were stationed on the roof due to health and safety reasons, claiming it was a sloping platform and dangerous.

1959 started with a bang! The whole country was engrossed in preparations for the general elections that were subsequently held in March. Everywhere everyone talked and hoped one way or another for the results of the elections. Although we were militating for the Labour Party, we thought it fit to point out to the Party certain tendencies which were crystallising in the minds of the people. In an editorial, **The Choice Before Labour**, we summarised the problems which the Labour Party had to face and the reforms it should bring about. We wrote:

"The two basic needs we are discussing concern mainly the labouring class. But there are other needs which affect other sections of the community or which by their very scope are bound to affect the over-all progress of the country. They are enumerated below and the Labour Party will have to pay attention to them.

They are:

- (a) Increase of the production of locally-grown foodstuffs and dairy produce.
- (b) A better and more productive use of Crown and Pas Geométriques Lands.
- (c) Land tenancy legislation.
- (d) The CEB should be brought back under direct state control.
- (e) The Sugar Industry Research Institute should be taken over by government.
- (f) Better use should be made of the fabulous sums accruing to the Sugar Industry Labour Welfare Committee (e.g., holiday camps for sugar workers and land settlement schemes), and we added: that the Labour Party's battle cry should henceforth be: Enough of coalition government! Let's have full responsibility!"

s the 9th of March approached the political situation became more tense and exposed Dr Millien's short-sighted policy of deserting the Labour Party. We have been proved right because we said that Dr Millien had been "caught into the meshes of his own making." When Mr Rault was disqualified for the Stanley constituency, we recommended Mr S. Indur and we took the Independent Forward Bloc, the latest brainchild of Mr S. Bissoondoyal, to task. When the general election came we gave our unstinted support to the Labour Party. And in our issue of the 27th March we published the picture of all the Labour MLC's.

We hailed the New Council, and we welcomed the creation of new Ministries in these words: "Some of the old ministries have been retained and others have been

recast with the result that we have today three new ministries. They are: Ministry of Housing, Town and Country Planning, the Ministry of Industry, Commerce and External Communications and the Ministry of Local Government and Co-operative Development.

"Whatever scandal-mongers may think of ministries and ministers' salaries the three new ministries are of vital importance and they are likely to play a decisive role in the development of the country. The Government should be congratulated on this happy decision."

Analysing the speeches of some new members of the new Council we found that the land problem was in the forefront of public mind. In an editorial, **The Cry For Land**, we said: "Most of the agricultural lands of this colony are in the hands of a few hundred persons or Companies. Of the 20,721 planters without factories only 35 planters own lands more than 500 acres. On the other hand, there are 6,380 planters who own less than one arpent; 5,884 own from 1 to 2 arpents: 3,043 own from 3 to 5 arpents. On the other hand the 25 factories which are managed by about a dozen companies own among themselves 99,552 acres."

We did not like the new philosophy Mr Barrett introduced into the trade union movement and we had to cross swords with him and when Mr John Hatch of the British Labour Party paid us a visit in June we welcomed him in these words: "We welcome him warmly because in him we find a distinguished representative of the great British traditions. And we welcome him because of the tremendous help he and the British Labour Party extended to our delegates when they were in London to discuss our Constitution. It can be said, without fear of contradiction, that the British Labour Party and its zealous and illustrious members of the calibre of John Hatch have tremendously influenced the course of our destiny."

We welcomed the establishment of the Police Service Commission and exposed the bankrupt campaign of Mr Barett and his local colleagues. The time for Sir Robert Scott's departure came and we paid him a deserving tribute. We said: "That Sir Robert's period of governorship over here is a crucial period in our history there is no doubt. Has it been beneficial to our cause or has it gone against us? Without fear of contradiction, we aver that he has laid down in this country the solid foundations upon which sound parliamentary democracy will be built. To the sceptics we can only say that history will do justice to Sir Robert's stay in Mauritius."

Welcoming Prof Kalelkar who paid us a visit in November, we said: "He therefore comes to us as an ambassador of goodwill, and we welcome him as such. Although our ancestors originally came here to seek fortune, we are today citizens of this country. Although we are to bury our bones in Mauritian soil, we wish to keep our culture and traditions which our forefathers have handed down to us. We want to be loyal Mauritians, but we want to preserve our "Indianness." We have no doubt that he will spend a happy sojourn in our midst." And when the terms of the **Economic Survey Mission** was made public we unhesitatingly said that it was going to bring about a great economic revolution in the

country. And finally, we had to tell Mr André Masson of Le Mauricien that courtesy could not be measured with a bowl of rice.

In August last B Ramlallah left for a tour of the UK together with 4 other colleagues of the local press as guests of the Colonial Office. In October on the invitation of the Soviet Government, he visited different parts of the USSR. He also visited Copenhagen, Stockholm and Helsinki. His impressions on his travel and the articles on a variety of subjects which he is writing every week are a unique feature in the history of journalism in this country.

Bien que la banque ait déjà été critiquée pour sa gestion par le passé, une perte d'une telle ampleur est sans précédent.

La banque nie les accusations de mauvaise gestion, affirmant que les pertes sont dues à des fluctuations du taux de change et au non-remboursement de prêts par des institutions publiques. Elle indique également que la décision du gouvernement d'emprunter 700 millions de dollars sans les rembourser intégralement a contribué à la crise.

es gouverneurs de la banque sont également accusés d'avoir alimenté une inflation galopante et des difficultés économiques par leurs actions. "Au moment où ils imprimaient des milliards pour le gouvernement, ne savaient-ils pas qu'il y aurait des répercussions?", demande l'avocat Martin Kepbu.

Pourquoi cela s'est-il produit?

Le Ghana traverse actuellement sa pire crise économique depuis des générations. L'année dernière, le taux d'inflation a atteint un record de 54 % et dépasse toujours les 40 %. Plusieurs agences de notation ont abaissé la note du pays, l'empêchant de lever des fonds sur les marchés internationaux.

En septembre 2022, la dette totale du Ghana s'élevait à 55 milliards de dollars. Cela signifiait que le gouvernement devait consacrer plus de 70 % de ses revenus au service de la dette, une tâche impossible à accomplir. Il n'a donc pas réussi à payer une grande partie de ses dettes.

e gouvernement a été contraint de demander l'aide du Fonds monétaire international (FMI). Pour obtenir un plan de sauvetage de 3 milliards de dollars plus tôt cette année, le gouvernement a dû accepter de remplir plusieurs conditions.

La plus importante d'entre elles était de réduire les paiements d'intérêts de la dette nationale à un niveau gérable d'ici 2028, afin de disposer de suffisamment de fonds

pour faire fonctionner l'économie.

Cependant, certains créanciers ont refusé de participer à ce programme d'échange de dette.

Le gouvernement du président Nana Akufo-Addo s'est tourné vers le FMI pour obtenir un plan de sauvetage. La banque est le prêteur de dernier recours et les experts affirment qu'il y a eu un abus de son statut par le gouvernement, dirigé par le président Nana Akufo-Addo, et que les règles de la banque ont été enfreintes.

"La loi sur la Banque du Ghana est très claire: l'impression de monnaie ou le financement du gouvernement est limité à 5 % des recettes fiscales de l'année précédente, ce qui signifie qu'en principe, soutenir le gouvernement n'est pas un crime mais ne pas dépasser 5 %", explique le Professeur Bokpin.

Les responsables de la banque sont tenus par la loi de rendre compte au Parlement si le seuil de 5 % est dépassé. Un défaut de rapport peut entraîner une amende ou une peine d'emprisonnement n'excédant pas deux ans.

Bien que d'autres banques centrales à travers le monde aient été confrontées à des défis similaires, la différence au Ghana réside dans le montant d'argent perdu par rapport à la taille de l'économie.

Au Royaume-Uni, la Banque d'Angleterre prévoit de faire une perte nette d'environ 180 milliards de dollars au cours des dix prochaines années, financée par le gouvernement britannique. Mais la taille de l'économie britannique se chiffre en milliers de milliards de dollars.

Le contexte mauricien

Nous semblons faire face à une situation similaire ici, mais heureusement pas aussi grave qu'au Ghana. Pourtant, les signes sont visibles pour tous, et les mêmes causes pourraient produire les mêmes effets ici aussi si l'on ne freine pas la prodigalité du gouvernement, financée par les réserves de la Banque de Maurice.

ans une analyse publiée dans ces colonnes la semaine dernière, l'économiste Vinaye Ancharaz souligne qu'une politique similaire pourrait également avoir de graves répercussions sur notre économie. Il nous rappelle les faits suivants:

En décembre 2019, le nouveau gouvernement élu du MSM a honoré sa promesse d'augmenter la pension de retraite de base à Rs9 000. Cela, ainsi que le paiement de la prime de fin d'année, a nécessité une quantité substantielle de ressources (environ Rs 2 milliards), que le gouvernement a mobilisée en puisant Rs18 milliards dans les réserves de la Banque de Maurice en janvier 2020. Ce fut une erreur politique majeure, selon lui, l'équivalant à ouvrir les vannes.

En 2020, le gouvernement a continué à piller les réserves de la Banque. Il a contraint la Banque à octroyer une "subvention" de Rs60 milliards pour soutenir le budget 2020-21 et, en juin 2020, la Banque a puisé Rs80 milliards supplémentaires dans ses réserves pour mettre en place la MIC. Ainsi, en seulement un an, Rs158 milliards ont été retirés des réserves de la Banque.

Dans un système de change géré comme le nôtre, le niveau des réserves internationales indique la capacité de la Banque centrale à maintenir une devise stable. Lorsque les réserves sont épuisées, les agents de marché deviennent nerveux et commencent à douter de la capacité de la Banque à défendre la roupie. Ils s'attendent à une dépréciation de la roupie, et leurs actions ne font qu'accélérer cette dépréciation. Malheureusement, c'est la situation actuelle, ajoute-t-il.

Selon Vinaye Ancharaz, avec des attentes d'inflation et de dépréciation désormais ancrées, il est urgent, parmi une série de mesures correctives nécessaires dans les circonstances actuelles, d'opérer un changement systémique signalant une rupture avec la taxe inflationniste en tant que machine de génération de revenus pour le gouvernement. Seul un nouveau gouvernement s'engageant à une gestion financière prudente et au contrôle des dépenses, tout en reconstruisant les tampons fiscaux, comme le recommande le FMI dans son dernier rapport de consultation au titre de l'Article V, peut signaler un tel changement de paradigme et ancrer les attentes d'une faible inflation.

En conclusion, il souligne que les macro-économistes ont depuis longtemps vanté l'importance d'une Banque centrale indépendante pour maintenir une cible d'inflation basse, et donc une devise stable. La relation incestueuse actuelle entre la banque centrale et le gouvernement est en grande partie responsable de la spirale inflation-dépréciation infligée à l'économie mauricienne.

Exploring the enigma of dominance hierarchies: 100 years of research

century ago, Norwegian zoologist Thorleif ASchjelderup-Ebbe introduced the notion of dominance hierarchies with his groundbreaking work on chickens, coining the term "pecking order."

Since then, researchers such as Elizabeth Hobson, an assistant professor of biology at the University of Cincinnati, have contributed to the understanding of conflict and competition among diverse species, including primates, whales, birds, and insects.

Hobson, known for her studies on birds like monk parakeets, has actively engaged in this discourse through several published works. Recently, she co-edited a special issue of the journal Philosophical Transactions of the Royal Society B, dedicated to a century of research on dominance hierarchies

In addition to her editorial contributions, Hobson conducted a study utilizing data mining in Google Scholar to track trends in the field of dominance hierarchies. Her analysis revealed a consistent increase in publications on the topic over each decade, amounting to a total of 26,000 papers published in the past century. This growing body of research, coupled with the diverse array of communities investigating the subject, underscores the enduring fascination with dominance hierarchies and their insights into animal behavior.

According to Hobson, the enduring interest in this topic stems from society's fascination with conflict and competition, evident in our enthusiasm for sports and other competitive endeavors.

Schjelderup-Ebbe's pioneering observations on chickens laid the foundation for understanding dominance hierarchies, akin to the contributions of Charles Darwin to evolutionary biology.

Despite the temptation to draw direct parallels between animal behavior and human interactions, Hobson warns against oversimplification. While there are analogies to be drawn, human emotions, motivations,



and relationships are far more intricate than those observed in animals

Nevertheless, the allure of understanding the dynamics of dominance persists.

The special journal issue was co-edited by Eli Strauss, a postdoctoral researcher at the Max Planck Institute of Animal Behavior; James Curley, associate professor of psychology at the University of Texas at Austin; and Daizaburo Shizuka, an associate professor of biology at the University of Nebraska at Lincoln.

Strauss emphasizes that dominance often hinges more on circumstance and opportunity than inherent qualities like genetic superiority or physical prowess. Dominant individuals may face greater risks, such as

injury from frequent conflicts, and their tenure in top positions may be short-lived. Moreover, many individuals are likely to experience periods of high status over their lifetimes.

Strauss, whose research focuses on spotted hyenas in Kenya's Maasai Mara, challenges popular perceptions of dominant animals as benevolent leaders. Instead, he suggests that high-status individuals primarily prioritize their personal interests, dispelling notions propagated by popular media, such as Disney's portrayal of lions in "The Lion King."

Over the decades, researchers have made significant strides in understanding dominance hierarchies, including the signaling mechanisms used by animals to assert superiority, strategies to avoid conflict, and the impact of factors like group size and social alliances.

Hobson highlights the importance of comparative analysis in elucidating the diverse ways species manage dominance. Collaborative efforts, such as the creation of a comprehensive database on dominance in 135 species, facilitate cross-species comparisons and deepen our understanding of these phenomena.

In her own research, Hobson has investigated how monk parakeets strategize to solidify their positions within colonies, showcasing a level of cognitive sophistication that transcends simplistic size-based dominance paradigms.

From vivid displays of dominance in fish to the formation of strategic alliances in baboons and hyenas, the complexities of dominance hierarchies continue to intrigue researchers.

Hobson and her colleagues remain eager to explore new avenues of inquiry in this field, recognizing that the more they uncover, the more questions arise. As Hobson aptly concludes, the terrain of dominance hierarchies promises fertile ground for another century of research.



How do sugar rushes

That a terrific question W.H! Let's explore this, starting with some of the basics.

What is sugar?

Sugar is an important substance for our body and brain to make energy.

Sugar comes from foods called carbohydrates.

Carbohydrates help our bodies to keep strong muscles. They help our brains to think and learn. They support our organs like the heart and liver to work well, and help our intestines to digest our food and remove waste.

When we eat fruits, vegetables, cereals and grains, we get helpful sugar that the cells in our body and brain need to make energy.

When we eat processed foods like lollies, ice creams and soft drinks, we get extra or added sugars that can be unhelpful in large amounts.

These added sugars were thought to provide extra energy - a "sugar rush" that makes us feel good, happy and energetic.

When we eat sugary treats, it was



thought that they make us do more jumping, playing, thinking and learning.

But this is where it gets interesting. A sugar rush is a myth because the body and brain work hard to keep sugar steady. This means you probably feel good from having a treat, not the sugar!

If a 'sugar rush' is a myth, what happens?

It can be hard to stay away from sugary treats and lollies when they are right in front of us.

When we eat lollies, we get an extra amount of sugar in our bodies. Our bodies, taste buds and brain like it because we can use the sugar to do things.

Sugar is taken up into your bloodstream quickly. Cleverly, our body then moves the sugar around in the bloodstream to your cells, muscles and organs, like your heart and brain.

The sugar in your bloodstream is very carefully handled.

Your body will make sure all the muscles and organs have just the right amount of sugar that they need to make energy and do their job.

This means that the flow of sugar in the body is kept steady and there is no "sugar rush".

The body and brain have lots of support systems in place to make sure there isn't too much or too little sugar.

Sometimes, if there is too much sugar in the bloodstream and the body doesn't use all the sugar at once, the sugar will be stored. There are lots of storage places in the body. In fact the body is very good at storing the sugar for use later so that your muscles and organs have just the right amount of sugar when they need it.

Because the body and brain are very busy making sure there is just the right amount of sugar, it can get tired. When this happens, this is called a "sugar



Huh?! We get a sugar crash instead?

Many experiments with lots of people show us that when we eat lots of sugar, we can get a "sugar crash".

Scientists have shown that even just 30 minutes after eating lots of sugar, you can end up feeling not quite as good as you did before. A sugar crash is why, after eating sugary treats, you may find yourself feeling sad and tired - even a little bit

So this means that if you've had a sugary treat and you're feeling good, you're probably feeling good because you're having fun with family and friends, rather than from the sugar.

Doing fun things, playing and trying new games and activities will help your body and brain to feel good, with or without sugar!

From the Motor Safari in Kenya to a Spiritual Safari in Pune

Kul Bhushan recounts his rugged journey with Osho that began fifty years ago

verything grinds to a halt during the Safari Rally in Kenya.
World Motor Rally Championship event spans four days and showcases top rally drivers from around the world. They navigate 3,000 km of rugged, dirt tracks through the African bush, encountering wild animals along the way. During the 1970s, local newspapers focused almost exclusively on the Safari Rally. For us, the news team of The Nation based in Nairobi, the Safari was both exhilarating and exhausting; we worked well past midnight day after day.

One night after returning home, I switched on my stereo and played a taped discourse by Osho (then known as Bhagwan Shree Rajneesh). I lay down on the carpet in the pitch dark, lis-

tening to his voice and relaxing. To my surprise, in plain Hindi, he remarked that only foolish drivers leave highways to traverse rough tracks solely to boost their egos. What? Was he referring to the Safari Rally in Kenya? Unbelievable! I turned off the stereo, my mind made up: "I have to meet this man, no matter what!"

After the Safari concluded, I persuaded my boss to grant me a two-week leave to visit Pune. The first hurdle cleared, but a bigger challenge loomed; lack of funds. I sold my Mercedes. Then came the ordeal of obtaining permission from the Central Bank to buy dollars (no small feat), followed by clearance from the Income Tax department for foreign travel.

hile tackling this paperwork, I attended a gathering of the local meditation group. Another striking comment hit me when Ma Yog Manju, the group's organizer, asked, "The boat is ready at the shore, the sails are unfurled, are you coming on board?" "Yes, I am coming," I resolved.

A few days later, accompanied by Ma Manju, I boarded a flight to Bombay en route to Pune. Upon arrival, I discovered that the ashram was simply another bungalow in Koregaon Park. Through a rusted metal gate, a path led to a building where Osho's secretary, Ma Yog Laxmi, welcomed us with her ever-present smile. It was evident that little had changed in the building since Osho's arrival on March 21, 1974, three months

We were informed of an evening lecture at 7:00 in his residence, Lao Tzu House, a bungalow behind the first one. Upon arrival, we ascended to the first floor, entered a spacious balcony, and silently awaited his arrival. The only furniture on the balcony was a tall yellow executive chair illuminated from above by a spotlight. Around 60 disciples were already seated on the floor; I posi-

tioned myself directly in front of the chair, brimming with excitement and anticipation. Soon, darkness enveloped us, the monsoon season prevailing*.

Moments later, Osho entered, and a hush fell over the gathering. He greeted each person with a namaste — a folded hands gesture — and an enigmatic smile. "Finally, I am seeing him in person!" I thought to myself. As he settled into his chair, he gazed deeply into my eyes and said, "You have come to me." I felt elated. "See." I assured myself, "he knows I'm an editor. He can garner good publicity overseas, which is why he greeted me." My ego swelled infinitely.

But this euphoria lasted only briefly as Osho continued, "You have taken a perilous step. It's a risk because near me, you can be lost forever. Drawing nearer to me means facing death and nothing else." "Oh God, where have I landed?" I wondered. The teachings of the Chinese Zen Master Chuang Tzu, in the form of a new series titled 'The Empty Boat' in English, had just begun. It was July 10, 1974.

Osho elaborated, "I am like an abyss. Coming closer to me, you will fall into me. The invitation has been extended to you. Understand that through me, you won't gain anything. Through me, you'll lose everything because until you are lost, the divine cannot happen; until you vanish completely, the real cannot emerge. You are the barrier."

"Oh no, where have I landed?" My mind went blank for much of the discourse. Yet, he continued, "And you are so much, so stubbornly much, so filled with yourself that nothing can penetrate you. Your doors are closed. When you disappear, when you cease to exist, the doors open. Then, you become like the vast, infinite sky. That is your nature. That is Tao."

Tao? What's that? I had no idea. And who was this Chinese master Chuang Tzu anyway? And an 'empty boat'? What did that mean? As his discourses progressed, I began to learn more about this Chinese master, a completely new world unfolding before me — a profound discovery.

Of course, I also desired a personal interview. So, the next morning, I returned to Laxmi's office and requested an appointment. She asked me to wait and suggested I engage in meditation in the meantime. I vividly recall participating in the Whirling Meditation held in a large courtyard under a temporary tent to shield us from the rains. At the back, a huge banner with a painted slogan adorned the space, while local musicians played light Indian classical music for the whirling.

very day, I visited Laxmi, and each Etime, she smilingly asked me to wait. Finally, one day she said, "Now you can have a 'darshan' tomorrow." I was going to meet Osho in his garden the next morning - on the final day of my stay in India!

It was a pleasant sunny morning as we entered the garden, accompanied by Manju and her three teenage children. When we entered the garden, Osho was already there, in a reclining chair. When it was my turn to speak, he greeted me warmly. I asked for an interview, suggesting it could be distributed to various overseas media outlets for which I wrote. To my surprise, he replied, "No need for an interview. Write what you wish and attribute it to me as if it were from an interview. If it's questioned, I will handle it." I was astonished; every person I had interviewed previously insisted on accuracy. Yet here was Osho, granting me unprecedented trust

Osho then proceeded with our personal interview, stating, "You must take sannyas." He placed a mala around my neck, wrote my sannyas name on a sheet of paper bearing his letterhead, and dated and signed it. My sannyas certificate! The date was July 10,

Upon seeing the blank letterhead, I remarked, "Osho, would you sign a blank letterhead? Could I now write anything on it and implicate you?" He smiled and replied, "Go ahead."

Again, what trust!

And thus began my journey — from the Safari Rally in Kenya to a spiritual safari with Osho — an odyssey over sharp bends and rough terrain that commenced fifty years ago and continues to this day.

Walking Through Your Fear

When we walk through our fear, we often discover that the strength of our fright was out of sync with reality

he situations, activities, and individuals that frighten us remain static. Their relative intensity does not change. Fear, on the other hand, self magnifies. When you are afraid and envisioning all that might go wrong, the energy underlying your fear grows. A tiny flicker of anxiety can easily develop into a terror that manifests itself physically and eventually paralyzes you into inaction. During the period before you face your fear, you may have to deal with a barrage of negative thoughts and emotions. Whether your fear is public speaking, taking part in an activity that makes you nervous, or asserting yourself when the odds are against you, walking through it may be equally as difficult. But once you emerge unscathed on the other side, which you will, you will likely wonder why you assumed the worst in the first place. While you spend time worrying about what might happen, it's good to know that your fear probably won't happen at all. It may feel like a great weight has been lifted from your shoulders, and you will likely feel a sense of passionate pride. Walking through your fear can mean taking risks and can require both practice and patience. Since it is challenging to act when you are gripped with fear, start

Each step you take into fear will strengthen you and help you confront future fears with poise, courage, and confidence. You also will find that when you are willing to stare your fear in the face, the universe will always offer you some form of aid or support. When you see the heights of accomplishment and personal evolution you can attain when you walk through your fears, your faith in yourself will grow, allowing your next step to be easier.
