Pension Reform: Lessons from the UK's Welfare Cuts

he recent dramatic U-turn by the Labour government in the UK regarding its proposed Personal Independence Payment (PIP) reforms offers a potent and timely lesson for democratic societies struggling with the seemingly intractable problem of budgetary constraints and precarious public finances. PIP is a UK benefit that helps people aged 16 to State Pension age with extra costs due to a longterm illness or disability. What began as a confident move to prune the welfare state, touted as a necessary step towards fiscal stability, ended in a humiliating climbdown, revealing the enduring strength of public sentiment and the formidable power of internal party dissent when core welfare principles are perceived to be under attack.

In the face of forecast savings of £4.8 billion, Chancellor Rachel Reeves' ambition to rein in welfare spending was met with a robust and multi-faceted backlash. This wasn't merely a political spat; it was a societal assertion of values, demonstrating that for many, particularly in the UK, the welfare state is not a dispensable luxury but an integral part of the social fabric, a promise of security and dignity for its most vulnerable citizens.

The very notion of "anti-social measures" - as the public and press are free to label them in a democracy - immediately sets a high bar for any government seeking to dismantle or significantly curtail welfare provisions. When measures are seen to disproportionately impact vulnerable individuals or those in precarious situations, the moral compass of a society is tested. The proposed PIP changes, which would have restricted eligibility and effectively cut benefits for hundreds of thousands, were widely condemned by disability charities and advocacy groups as "cruel" and "unjust." Their arguments resonated deeply with the public, with polls indicating a staggering 75% belief that such cuts were indeed cruel, a sentiment consistent across all demographics and political leanings.

This powerful public rejection underscores a fundamental truth: the "welfare state" in many democratic nations has evolved beyond a mere collection of economic policies. It embodies a social contract, a collective agreement that society has a responsibility to protect those unable to protect themselves and vulnerable members of society. Attempts to break this contract are often met with fierce resistance because they challenge deeply held beliefs about fairness and compassion.

Beyond public opinion, the Labour government also faced an unexpected and significant internal rebellion. Despite a considerable working majority, 49 Labour MPs defied the party whip, marking the largest



revolt of Sir Keir Starmer's premiership. This internal dissent highlights that even within a governing party, there can be a powerful ideological commitment to welfare principles that transcends electoral expediency or fiscal targets. For these rebel MPs, the proposed cuts likely represented a betrayal of the very values that drew them into the Labour Party, demonstrating that the pursuit of a balanced budget cannot always override core party principles.

he handling of the reforms itself offers several lessons. Critics consistently described the Bill as "rushed," "poorly thought-out," and lacking in genuine consultation. Effective policymaking in a democracv demands more than simply announcing a new direction. It requires comprehensive impact assessments, meaningful engagement with those directly affected, and a transparent process that builds trust. The British government's failure to adequately consult with disabled people and their representative organizations, and to publish a thorough human rights impact assessment, severely undermined the legitimacy of their proposals. When reforms are perceived as being imposed from above without genuine listening, the seeds of opposition are quick-

The British media, too, played a crucial role in shaping the narrative. While some outlets might traditionally lean towards austerity arguments, the sheer weight of expert and lived experience testimony, amplified by dedicated advocacy groups, ensured that the human cost of the proposed cuts remained front and centre. This allowed the public to see beyond abstract fiscal numbers and connect with the tangible impact on real lives, further strengthening the resolve against the reforms.

This unfolding events in the UK finds a

striking parallel in the current situation in Mauritius, where the government is grappling with strong protests over proposed pension reforms. Like the UK, Mauritius faces demographic shifts and the challenge of sustaining its universal old-age pension. The Mauritian government has put forth plans to progressively increase the eligibility age for the universal old-age pension from 60 to 65 years. This move, framed as essential for long-term fiscal sustainability, is generating significant public outcry.

Mauritius's old-age pension, established as a universal right in 1957, is deeply embedded in the nation's social contract. For many Mauritians, particularly those in the informal sector or those who have spent their lives in unpaid care work, the universal old-age pension is a vital lifeline, not merely a supplementary income. Protesters argue that raising the retirement age to 65 would inflict undue hardship on those who, often due to physically demanding jobs or lack of formal employment, are unable to continue working into their mid-sixties. The argument that people are living longer, while true, often overlooks the quality of life and the physical toll of certain professions.

The demographic imperative for extending pensionable ages is undeniable, yet the political and social challenges remain immense. Governments face the unenviable task of balancing financial sustainability with social equity and public acceptance. Mauritius' current struggles with pension reform highlight this global problem: how to manage strong public opposition while building a sustainable system for the future. While raising the eligibility age for the universal old-age pension age might help fix government's finances and address the sustainability of the pension system, its ultimate success depends on thoughtful implementation, particularly by engaging the public and allowing exceptions for vulnerable groups. Neither our dire financial straits nor Moody's ratings can be dismissed, and no reform will get unanimous consent, but the way forward is to find without undue delay a consensus that is acceptable for government and key stakeholders.

At the time of writing, the final Cabinet decision regarding the initially announced pension reform measures is still pending. Crucially, significant decisions are expected today, driven by the widespread protests. The government is under immense pressure to reconsider or at least amend its proposals, and the parallels with the Starmer government's PIP debacle are striking. Indeed, the Mauritian experience, much like the British, highlights that social security systems, particularly pensions, transcend their role as mere economic instruments to become deeply symbolic pillars of societal solidarity.

The government will need to proceed with the pension reform — there is no doubt about that. But the pension system has to be rationalised to ensure its sustainability, and the government should know where the money is for ensuring its funding—the IPPs, the MIC loans to the "distressed corporates" and corporate cronies of the previous government, amongst others. Seeking alternative solutions is imperative: just as a wealth tax was mooted in the UK as an alternative to PIP cuts, Mauritius might need to explore a broader range of revenuegenerating measures, or indeed, other forms of expenditure rationalization, before resorting to changes that impact the most vulnerable segments of its population.

The British Labour government's retreat on PIP reforms is not just a story of political embarrassment; it is a powerful affirmation of democratic principles at work. It demonstrates that in societies where citizens and the press are truly free to speak out, the collective will to protect fundamental social provisions can, and often does, triumph over technocrats' calls for austerity.

The Role of Advisors in Public Administration

Allowing advisors to benefit financially or concentrate corporate control through their appointments, despite a pool of qualified individuals, would be suspicious and violate good governance standards

ast week in Parliament, the Prime Minister made a statement on the functions of advisors in government. He revealed some very disturbing facts about the functions and privileges (emoluments and fringe benefits) of advisors in government and the broader public sector. With reference to the situation under the previous government, he revealed some dubious practices that involved influence peddling, political patronage, cronyism and waste of public funds.

The PM's statement gives rise to some crucial questions:

- (a) What is the specific role of advisors in the public sector?
- (b) Are advisors appointed based on merit (professional qualifications and experience) or according to some other criteria such as party affiliation, personal friendship or family relationship?
- (c) Are advisors political staff appointed to implement the ruling party's program or are they independent experts providing neutral, evidence-based advice to government?

Context

In Mauritius, there is no law that governs the recruitment of advisors in ministries and the broader public sector (parastatal bodies and public enterprises). Advisors are usually selected by ministers or CEOs of public sector organisations, and their conditions of employment are defined in a contract that remains private and confidential. Information about the emoluments of advisors in ministries is only disclosed in Parliament when there is a question from an MP. Government cannot refuse disclosure in this case because the advisors' emoluments are paid from public funds. However, Parliament does not have access to information on the emoluments of advisors recruited by State-owned enterprises (e.g., SBM, Air Mauritius Ltd.) although they may be political appointees because these corporate entities fall outside parliamentary

Under the previous government, there were four categories of advisors as described by the PM:

- (a) Special Advisors.
- (b) Senior Advisors.
- (c) Advisors on Information Matters.
- (d) Advisors on Public Relations.

The previous government employed a significant number of advisors whose quali-

fications and experience were kept secret. We don't know whether they were competent enough for the jobs assigned to them. While some Senior Advisors or Special Advisors were well known for having served successive governments (e.g. Dev Manraj in the Ministry of Finance and Bhinod Bacha in the PMO), others kept a low profile. In the latter category, we can identify certain individuals with some competence (e.g.,

economists) who served different Ministers of Finance under successive governments. Revolving door

When it comes to Information Advisors or Public Relations Advisors, they are clearly political staff, whose role is to disseminate information, develop public relations and promote the minister's image in the media. Over the years, a revolving door has developed between the media outlets (newspapers and private radios) and the government in power. It has become fashionable for all ministers to appoint a press attaché

(Information Advisor) once they assume office and, in most cases, the appointees come from the media. It makes one wonder how independent those political appointees were when they were working in the media.

Why do all ministers need an Information Advisor when there is a department called "Government Information Services" (GIS) whose role is precisely to disseminate information on official ministry activities? Besides, I see the GIS is more active now than under the previous government. By the way, we should note that the online information published by the Financial Crimes Commission (FCC) on ongoing enquiries is commendable. It looks objective and fair. I presume it's all done by regular staff.

In principle, advisors are appointed by government in some ministries to provide advice on specific matters in line with their technical competence and skills. They are subject matter experts and not all-rounders (i.e. a jack of all trades). Therefore, they are expected to hold only one advisory position.

Moonlighting

The Prime Minister revealed that some advisors under the previous government were holding multiple positions. In addition to their "home position" (i.e., where they were initially appointed), they were sitting on multiple boards of public bodies or enterprises covering different economic activities. For example, one Special Advisor earning a basic pay of Rs 162, 250 per month was chairing the boards of multiple corporate bodies, namely the Mauritius Revenue Authority, SBM (Holdings) Ltd, Mauritius Telecom, Multi-Carrier (Mauritius) Ltd and Metro Express Ltd. He also sat on the boards of directors of other corporate entities: SBM Africa Holdings Ltd, SBM Bank (Kenya) Ltd, Mauritius Duty-Free Paradise Co. Ltd, and Rodrigues Duty-Free Paradise Co. Ltd.

The PM mentioned two other cases where one person held multiple positions. Which begs the question: did all those advisors have the technical competence and skills required to understand and manage the files belonging to all those corporations with different missions and activities? What is more disturbing is that those advisors were earning fees (director's fees or advisor's fees) from each of the corporations for their services so that their fees for moonlighting exceeded their basic pay.

The logical question that arises is: did those corporations instruct the advisors to report all the fees they collected on their income tax returns together with their basic pay? The government should refer their names to the Mauritius Revenue Authority (MRA) for an enquiry on tax compliance to detect any possible tax avoidance or evasion. Their basic pay as we know is subject to PAYE deductions. The reporting of director's fees is a voluntary tax compliance obligation. It is also necessary for the FCC to look at the declaration of assets filed by senior public officers under section 8 of the Declaration of Assets Act 2018 at every interval of five years from 2014 to 2024.

Crime in Mauritius

pposition Member of Parliament Adrien Duval recently put a direct question to the Prime Minister, seeking crucial information on murders and violent deaths in Mauritius since November 2024. The prevalence of crime and violent deaths is, undeniably, a grave concern for all citizens, transcending political affiliations. It's an issue that demands serious, multifaceted attention from every quarter. To delve into the intricate layers of this critical challenge facing the nation, we turn to Lex for a detailed examination of its various facets, exploring common perceptions, underlying causes, and potential solutions.

* In many societies, including Mauritius, there's a common public perception that if crime rates are rising, it must be because the existing laws aren't sufficiently severe — "la loi pas bon!" as it's popularly expressed locally. This often leads to calls for harsher penalties including the death penalty and stricter enforcement. Is this an oversimplification of the complex issue of crime and its prevention?

According to criminal justice experts, it's easy to think that the threat of punishment will simply dissuade someone from doing the wrong thing. But it turns out that deterring would-be criminals by instilling doubt or fear of the consequences is more myth than reality.

Law Professor David Brown takes the following view: "I call it sentencing's dirty secret because it's just assumed that there is deterrence... but what the research shows is that the system has little to no deterrent effect."

The overall view of criminal justice experts is that harsher punishments, such as longer prison sentences, not only do not prevent crime but may actually have the opposite effect.

* Is there, however, a direct and proven causal relationship between the severity of laws and the crime rate? And between the application of the death penalty and falling crime rate?

The view has been expressed that sending an individual convicted of a crime to prison isn't a very effective way to deter crime. Prisons are good for punishing criminals and keeping them off the street, but prison sentences, particularly long sentences, are unlikely to deter future crimes. Prisons actually may have the opposite effect: inmates learn more effective crime strategies from each other.

The death penalty is just the ultimate punishment that can be inflicted on a criminal. There is no conclusive proof that the

death penalty deters criminals. In many countries that still retain the death penalty, the crime rate has not been reduced significantly.

* A multidisciplinary study would undoubtedly shed light on the true drivers behind the rising crime rate. However, it appears the proliferation of drugs is having a notable impact on murders and violent crimes, particularly those committed against close family members by addicts desperately trying to extract money for their drugs. Do you consider this issue to be one of the primary urgent challenges to public safety in Mauritius?

There is no doubt that many horrendous crimes are a direct result of drug abuse; a strong and undeniable relationship exists between the two. Individuals struggling with addiction often commit crimes, ranging from petty theft to more serious offenses, primarily to finance their drug habits. This desperate pursuit of funds to feed addiction inflicts significant damage upon society, impacting victims and communities alike.

Moreover, a concerning number of criminal acts are committed by individuals who are under the influence of drugs at the time, impairing their judgment and often escalating the severity of their actions. Beyond crimes committed for drugs, the illicit trade of substances itself, known as drug trafficking, constitutes a massive criminal enterprise, fostering violence, corruption, and instability. This creates a vicious cycle where drug abuse fuels criminal activity, which in turn perpetuates addiction and further social decay.

* While many crimes are resolved quickly, a few cases persist without any resolution. The police often attribute these unresolved cases to their complexity. Is there truly a category of inherently more complex crimes, or does this explanation conceal other reasons for their non-resolution?

Some criminal cases take a long time to

resolve due to a variety of factors, including the complexity of the case, the amount of evidence to be gathered and reviewed, the availability of witnesses, and the workload of the police. The more intricate the case and the more resources required for investigation and prosecution, the longer it will take to reach a conclusion.

It must be noted, however, that in some instances, the police may take what appears to be an easier route. This might involve concluding that no foul play occurred, as seen in the Kistnen case, or extracting a confession from a suspect or habitual criminal and subsequently accusing them of the crime. In the unresolved Dantier case, for example, a suspect 'confessed' to the murder, but DNA evidence later cleared him.

* How could transparency and accountability be strengthened regarding investigations into unresolved crimes, particularly those involving the so-called complex cases?

A live investigation cannot be conducted in the public eye; revealing intricacies and steps would indeed compromise cases and very likely prevent their resolution.

Transparency in criminal investigations has its inherent limits.

* It's clear that the police cannot be everywhere 24/7, and no law, on its own, can prevent all crimes. Given these limitations, how can police action and legislation be optimized for more effective crime prevention?

The police should actively employ preventive measures to deter and reduce crime. Indeed, prevention is often far more effective and efficient than merely reacting to crimes after they occur. Proactive policing strategies can significantly enhance community safety, improve the quality of life for residents, and ultimately reduce the long-term societal costs associated with criminal activity.

To achieve this, police forces can implement various preventive approaches, including robust community policing initiatives, strategically targeted patrols, and focused interventions in identified crime hot spots. These strategies collectively aim to deter potential offenders, increase the perceived likelihood of apprehension, and thereby foster a greater sense of public safety and security.

* Given reports of declining public trust in the police in Mauritius, linked to perceptions of corruption, favouritism, and excessive force from Afrobarometer's surveys, for instance, what concrete steps can be taken to rebuild confidence between law enforcement agencies and the community?

Building trust between the police and citizens is crucial for effective policing and a safe community. This can be achieved through various strategies, including community policing, transparency, accountability, and positive interactions.

The police should not use their powers to terrorize or intimidate citizens. Instead, they are paid to serve the public and must not be subservient to any hidden agenda or undue influence.

* Beyond internal reforms, what role can independent oversight bodies play in addressing allegations of police misconduct and ensuring accountability, especially in cases that remain unresolved?

Independent oversight bodies play a crucial role in holding police accountable by providing independent review of their actions, investigating complaints, and promoting transparency within law enforcement. They are instrumental in building public trust, identifying areas for improvement in police policies and procedures, and ultimately contributing to a more just and effective criminal justice system.

In Mauritius, however, there is currently no truly independent oversight body for the police in the comprehensive sense described. While the Police Complaints Commission exists, it could potentially fulfil the role of a robust oversight body, provided its legislative mandate is significantly amended to grant it the necessary powers and independence

* There is the view that the certainty and swiftness of punishment, coupled with comprehensive strategies that address the root causes of crime, might help better to bring the crime rate down. How are we doing as regards the elements of certainty and swiftness of punishment?

When punishment is swiftly administered – meaning it follows quickly after the commission of a crime – it is generally considered more effective in deterring future offenses. This efficacy stems from the clearer and more immediate connection the offender perceives between

their ac-tions and the resulting consequences.

Unfortunately, in Mauritius, investigations often unfold over extended periods, leading to significant delays. Consequently, the crucial element of swiftness in punishment is often lost, undermining its potential deterrent effect.

* The proliferation of synthetic drugs is mentioned earlier as a significant driver of violent crime. What are the underlying socio-economic factors that make vulnerable populations, particularly youth, susceptible to drug addiction and involvement in drug-related crime?

Drugs unequivocally represent a source of easy and substantial profit for criminal enterprises. Organized criminal networks adeptly leverage the immense profits generated from the production, trafficking, and distribution of synthetic drugs to meticulously fund and expand their broader criminal operations. This illicit financing directly contributes to per-

petuating destructive cycles of violence and instability within society.

According to international studies, governments and international organizations have consistently sought to adopt a multifaceted approach to counter this threat, combining robust law enforcement efforts with essential public health initiatives. While some of these efforts have indeed yielded positive results, particularly those rooted in public health strategies, **a** significant amount of work remains. The challenge persists in effectively combating drug traffickers, who operate through highly sophisticated global networks

* Beyond law enforcement, what long-term societal investments – in education, employment, mental health services, and social support – are crucial to address the root causes of crime and prevent future generations from falling into cycles of addiction and criminality?

It should not be believed that only individuals, whether young or old, from broken homes or impoverished backgrounds fall prey to drugs. In reality, many youngsters initially experiment with drugs or are simply tempted by peers. Once they fall into the trap, the nefarious cycle of addiction swiftly sets in.

Education can undoubtedly play a key role in drug prevention, but the precise form this education should take requires careful consideration. Schools alone cannot bear this responsibility; families must be actively involved, and the authorities have a crucial role to play. All these efforts represent a complex and necessarily long-term process.

The appointment of one advisor to multiple positions goes against the principle of equal opportunity for all. If one person is holding five advisory positions in addition to their home position, it's five opportunities denied to other people who may be competent to assume those jobs. The country has no shortage of qualified people to assume higher responsibilities. If the intent was to allow those advisors to make more money than they were getting from one job, it would sound very suspicious. If they were trusted by the powers that be to control so many corporate bodies, it would show a concentration of powers in the hands of one person that is contrary to good governance standards, namely the requirement of having different office bearers in different positions to avoid conflicts of interest.

The present government has promised not to allow this practice of moonlighting to continue except in rare cases where it wants to exercise close monitoring of activities. It is critical that two strategic positions in different organisations are not held by the same person to provide them with different perspectives in management. For instance, I don't understand why the Governor of the Bank of Mauritius should chair the Financial Services Commission (FSC) when they are two bodies with different missions. The BOM and FSC should operate independently from each other, as is the case in other countries, to avoid conflicts of interest. There is no lack of financial experts in Mauritius to manage the FSC.

Separation of powers

A parliamentary democracy is based on the separation of powers between institutions and the clear delimitation of roles and responsibilities for each institution in line with its statutory mandate. When these boundaries are blurred, we get into conflicts of interests such as the one where the Bank of Mauritius set up a subsidiary (Mauritius Investment Corporation) to lend money to or invest in private companies under the political directives of a government, regardless of corporate credit worthiness or economic viability.

In a functioning parliamentary democracy, there should be a clear line of demarcation between political staff (advisors) and civil servants. The former cannot give instructions to the latter. Civil servants are accountable to their heads of department who answer to elected ministers. Unelected advisors cannot call the shots behind the scenes. It is a travesty of democracy to allow a few political nominees give instructions to civil servants and even ministers in the name of a higher authority. That's what the previous government did by surrendering power to unelected people and it was rightly kicked out.

In some Anglo-Saxon countries, there are clear guidelines to delimit the roles and responsibilities of political staff (hired by a political party) as opposed to those of permanent civil servants (hired under a Public Service Employment Act).

Political staff, also known as ministerial staff, play a crucial role in supporting elected officials, particularly ministers, in their duties. They provide a partisan perspective, sometimes acting as a bridge between the political and administrative arms of government. This includes tasks like crafting communications, managing relationships with various external stakeholders, and offering political advice on policy matters. While political staff play a vital role, they are not involved in the day-to-day operations of the civil service and cannot direct civil servants. They are expected to adhere to ethical guidelines and avoid partisan activities that could impair the integrity of their office.

The End of American Soft Power; The Resurgence of American Hard Power

n March 1, 2025, Associated Press (AP) reported that the Trump administration had eliminated more than 90% of foreign aid contracts and cut some \$60 billion in funding. These decisions, AP stated, left millions of people without access to life-saving care. Some 10,000 contracts with the US Agency for International Development (USAID) were terminated. Letters from the administration said that the programs were being defunded "for convenience and the interests of the US government."

The list of abandoned programs is long, and it is difficult to pick out a representative sample without feeling that one should have mentioned a deserving cause that has suffered the misfortune of neglect. With that in mind, these cuts have affected healthcare for Afghan women, independent journalism in El Salvador, landmine harvesting in Cambodia, HIV/AIDS prevention and treatment, vaccination and anti-malaria programs, contraception, cancer prevention, nutrition programs, sex and drug trafficking. So far, there is no explanation of how these cuts serve the convenience and interests of the US government. Don't hold your breath waiting for one.

This is a remarkable change in America's exercise of soft power. The conventional wisdom is that such programs bring an immense flood of appreciation for America's outreach to the less fortunate across the world. And the hope is that such appreciation will breed goodwill. Well, perhaps not always, and that sense among some Americans that the USA's efforts are not appreciated, may help to explain why some are willing to terminate these initiatives. That there is no congruence between justifying their views and the notion that the best reasons for charity and kindness do not include an expectation of reward merely confirms that logic plays no part in such

n February 28, 2025, with barely enough time for a 40-day flood to have receded following Trump's second inauguration, there was the confrontation at the White House when Trump and Vice President Vance pounced on Ukrainian President Zelensky. A commentator for The Hill wrote that these events generated a sense of shock and dread, "a feeling that something terribly wrong and irreversible had just happened to America." That commentator's observation that the event "appeared to be a calculated decision by America's commander in chief to berate and humiliate a strategic partner at war with a foreign invader" suggested that America was abandoning not only soft power but also backing away on the world stage from



the use of its hard power. After all, if the US wasn't willing to support even indirectly, an ally under attack, perhaps the European members of NATO and Britain should be legitimately concerned that America was no longer going to be a player on the world stage, at least not when it comes to Russian aggression.

Just two weeks earlier, Trump said: "Taiwan took our chip business away. We had Intel, we had these great companies that did so well. It was taken from us. And we want that business back. We want it back in the United States." And there was the threat that the US would not come to Taiwan's aid in the event of a Chinese takeover.

It seemed that an American withdrawal from the world stage was happening right before our eyes.

Indeed, one commentator wrote that Trump's actions, including his tariff war, were emboldening Chinese hardliners to push to accelerate the timeframe for unification with Taiwan, suggesting that these hardliners see Trump's chaotic foreign policy as a golden opportunity for China to regain control of Taiwan.

Trump has never seemed a pacifist, but his calls for a ceasefire in Ukraine, a ceasefire in Gaza, a ceasefire between India and Pakistan, his deal with the Houthis, and his call for a ceasefire in Congo, suggested a reluctance to project American force. Indeed, his repeated statements that he would not get America involved in another war seemed to solidify the notion that America had a president recalcitrant about using its military might.

Then things changed. Trump ordered B-2 Stealth bombers to strike Iran's nuclear

facilities with bunker buster bombs. As I have previously written, the full extent of the damage to and setback of Iran's nuclear program remains to be determined.

Here was a President not just projecting America's power, but willing to use it. Just this past week, Chris Buckley, a New York Times writer commented that Trump's decision to attack Iran "introduces another complication for China's leaders trying to fathom how he might handle conflict over Taiwan." Unquestionably, as I have previously written, Trump has shown not only that America still has formidable force at its disposal, but also a President willing to use it. This should

come as no surprise. American presidents have the option to use massive force. Inevitably, during most presidencies, the opportunity to "pull the trigger" comes along. Few can resist. Every president since Eisenhower, not actively involved in an ongoing war, has deployed US forces in combat. Alter Russel Mead, writing in the Wall Street Journal, called Trump's attack on Iran, "the boldest use of American power since George W. Bush launched his shockand-awe campaign against Saddam Hussein in 2003." Mead includes the pithy assessment that "American presidents have blundered across the region, losing trillions of dollars and thousands of lives in one ill-judged escapade after another. These costly failures alienated a generation of Americans, fueling populist isolationism on the right and socialist anti-Americanism on the left."

At first blush, one might have expected that attacking Iran would prove to be another blunder. But not so far. Yes, we must keep in mind that Iran could retaliate.

But a strange calm has arrived. Israel and Iran have agreed to a ceasefire. The surprising thing is that although neither seems to have had anything to gain from continuing hostilities, such a consideration has never in the past deterred either from adventurism. So, was it Trump who brought the ceasefire about? It sure looks that way.

And now we have talk of an Israel-Hamas ceasefire. That may well never happen, but the subject of a ceasefire keeps coming up. This suggests an ongoing negotiation, perhaps just the indirect one, but both Israel and Hamas seem to confirm that it is happening.

Meanwhile, Taiwan's semiconductor giant has announced plans to build a massive chip fabrication plant in the US and China called on the US to use its influence with Israel to bring about a ceasefire with Iran.

Tunku Varadarajan writing in *The Wall Street Journal*, extolled Mead's writing and pointed out that Mead's observation that: "Just when the conventional wisdom that America was in terminal decline had congealed into place," he says, "the airstrikes suggest that American power remains unique in world affairs."

u lendemain du débat houleux sur l'archipel des Chagos, qui a mis en lumière les divisions profondes au sein de la Chambre des Lords, l'attention se tourne une fois de plus vers cette institution unique du système parlementaire britannique. Souvent méconnue en dehors du Royaume-Uni, et notamment à Maurice où son rôle a été questionné dans le contexte de l'accord sur les Chagos, la Chambre des Lords incarne un mélange fascinant de tradition et de modernisation, et sa pertinence dans le monde d'aujourd'hui est un sujet de débat constant

La Chambre des Lords est la seconde chambre du Parlement du Royaume-Uni, œuvrant aux côtés de la Chambre des communes élue. Sa caractéristique la plus distinctive est que ses membres ne sont pas élus par le public. La majorité d'entre eux sont des pairs à vie, nommés pour la durée de leur existence en reconnaissance de leur expertise et de leurs contributions dans des domaines variés tels que la science, les arts, les affaires, le droit ou la politique. À cela s'ajoute un nombre restreint de pairs héréditaires (dont le droit de siéger a été considérablement réduit par la réforme de 1999) et les Lords Spirituels, c'est-à-dire les évêques supérieurs de l'Église d'Angleterre.

Un héritage féodal, non colonial

Il est crucial de comprendre que la Chambre des Lords n'est pas, comme certains pourraient le penser, un vestige direct du passé colonial britannique. Ses origines remontent bien plus loin, au XIe siècle, une époque où l'Empire britannique n'existait pas encore sous sa forme reconnaissable. Elle a évolué à partir du "Grand Conseil" qui conseillait les monarques médiévaux, composé alors principalement de nobles puissants et de hauts dignitaires du clergé. Son existence et sa structure étaient donc solidement établies des siècles avant l'expansion coloniale.

Le rôle principal de la Chambre des Lords a toujours été la gouvernance intérieure du Royaume-Uni. Elle est chargée d'examiner attentivement la législation, de débattre des politiques gouvernementales et de demander des comptes au pouvoir exé-

cutif. Bien que de nombreux membres, notamment les pairs héréditaires, aient sans doute bénéficié des richesses et de l'influence générées par l'Empire, l'institution elle-même n'a jamais été conçue comme un outil d'administration ou d'expansion coloniale directe. L'administration coloniale était généralement assurée par des gouverneurs, des législatures coloniales et le *Colonial Office* à Londres.

Au fil du temps, la Chambre des Lords a connu d'importantes réformes. Les plus notables sont celles du XXe siècle qui ont considérablement réduit le pouvoir des pairs héréditaires. La loi sur la Chambre des Lords de 1999, par exemple, a supprimé le droit automatique de la plupart des pairs héréditaires de siéger et de voter, faisant pencher la balance en faveur des pairs à vie, nommés pour leur mérite et leur expertise. Cette évolution a éloigné l'institution de ses racines purement aristocratiques pour la rapprocher d'un modèle plus méritocratique, même si le débat sur une Chambre des Lords entièrement élue reste vif.

Sa signification et sa pertinence aujourd'hui

Dans le monde actuel, le rôle de la Chambre des Lords est principalement celui d'une chambre de révision et de "think tank"

législatif. Elle apporte une expertise précieuse grâce à la diversité de ses membres, qui incluent d'anciens hauts fonctionnaires, des universitaires renommés, des chefs d'entreprise et des personnalités du monde artistique et scientifique. Elle a la capacité de:

- Examiner minutieusement la législation: Les projets de loi adoptés par la Chambre des communes sont examinés en détail par les Lords qui peuvent proposer des amendements. Cela permet d'affiner la législation et de corriger des lacunes.
- Mener des enquêtes approfondies: Les comités de la Chambre des Lords produisent des rapports influents sur des sujets variés, contribuant au débat public et à l'élaboration des politiques.
- Demander des comptes au gouvernement: Les Lords peuvent interpeller les ministres et organiser des débats sur des questions d'actualité.

Le pouvoir de la Chambre des Lords face aux accords internationaux: Le cas Chagos

Pour Maurice, la question cruciale qui s'est posée, c'était de savoir si la Chambre des Lords aurait pu bloquer l'accord sur les Chagos. La réponse est nuancée.

- Si la Chambre des Lords a le pouvoir de retarder l'adoption d'un projet de loi

(généralement jusqu'à un an), son pouvoir de blocage total est très limité, surtout face à la volonté de la Chambre des communes sur les questions législatives majeures.

- Concernant la ratification des traités internationaux, son rôle est principalement celui de consultation et d'examen. Elle peut soulever des préoccupations, exiger des éclaircissements et même exprimer une forte désapprobation, comme on l'a vu avec le vote serré sur les Chagos.

En effet, la Chambre des Lords a été le théâtre, le lundi 30 juin, d'un débat passionné et divisé concernant la ratification de l'accord de souveraineté entre le Royaume-Uni et Maurice sur l'archipel des Chagos. Deux motions distinctes, l'une présentée par le conservateur Lord Callanan et l'autre par le libéral-démocrate Lord Purvis of Tweed, ont mis en lumière les profondes divisions et interrogations entourant ce traité lourd de conséquences stratégiques, juridiques, financières et humaines.

Le vote sur la motion de Lord Callanan, qui visait à bloquer la ratification, a révélé des opinions partagées: 185 voix pour (content) contre 205 voix contre (not content), démontrant la complexité et la sensibilité du dossier.

Chambre des Lords ne peut généralement pas empêcher le gouvernement britannique de ratifier un traité qui relève de ses prérogatives exécutives, à moins que des lois spécifiques ne lui confèrent un tel pouvoir

En somme, la Chambre des Lords, avec ses traditions séculaires et son composition unique, demeure une composante essentielle du système parlementaire britannique. Si son influence a évolué, elle continue d'exercer un rôle de contre-pouvoir et d'expertise, contribuant à la qualité du processus législatif et au débat démocratique, même si sa capacité à bloquer des décisions gouvernementales majeures, notamment sur les traités, reste circonscrite.

Les îles Falkland: La détermination argentine ravivée par un regain de soutien international

a revendication de longue date de l'Argentine sur les îles Falkland (Malouines) a connu un regain d'intensité suite à d'importantes démonstrations de soutien international et la décision britannique concernant l'archipel des Chagos. Buenos Aires a réaffirmé sa détermination à «récupérer pleinement la souveraineté» sur ces îles de l'Atlantique Sud.

Le président argentin, Javier Milei, a tonné «Les Malouines sont argentines» sur la plateforme X, célébrant le soutien «unanime» de l'Organisation des États Américains (OEA) à ses revendications territoriales, survenu juste après une nouvelle résolution de l'ONU. L'OEA, qui rassemble les 35 États indépendants des Amériques, a exhorté le Royaume-Uni à reprendre les négociations dans

le différend de souveraineté.

Une vague de soutien diplomatique

Cette marque de soutien de l'OEA fait suite à une résolution adoptée le 18 juin par le Comité Spécial de la Décolonisation des Nations Unies, qui a également appelé à la reprise des pourparlers entre les deux nations concernant ce "territoire britannique d'outre-mer". Le Comité a exhorté le Royaume-Uni et l'Argentine à trouver une solution pacifique et définitive au différend de souveraineté.

Le ministre des Affaires étrangères argentin, Gerardo Werthein, a salué chaleureusement l'appui de l'ONU et de l'OEA. Il a souligné que «juin a été un mois important pour notre pays concernant la question des Malouines», grâce à

Werthein a remercié tous les pays ayant accompagné l'Argentine et a mis en avant le travail des équipes argentines aux Nations Unies et au sein de l'OEA. «Ces avancées réaffirment la ferme détermination du gouvernement argentin à progresser, avec conviction et diplomatie, vers la pleine récupération de la souveraineté sur les Malouines, la Géorgie du Sud, les îles Sandwich du Sud et les zones maritimes environnantes.»

Le précédent des îles Chagos et la riposte britannique

Ce regain d'optimisme argentin intervient alors que l'Argentine a également salué la décision britannique concernant les Chagos. Suite à la décision de la Grande-Bretagne en octobre dernier de céder la souveraineté des îles Chagos à Maurice, la ministre des Affaires étrangères argentine, Diana Mondino, avait alors déclaré que cette décision marquait «la fin de pratiques dépassées» et était un «pas dans la bonne direction». Pour Buenos

Aires, cela semble créer un précédent qui pourrait s'appliquer aux Malouines.

Cependant, la position du Royaume-Uni reste ferme

concernant les îles Falkland. En novembre dernier, le ministre des Forces armées du Royaume-Uni, Luke Pollard, a visité les Malouines pour le Jour du Souvenir, réaf-

firmant le soutien total du gouvernement britannique aux insulaires. Il a déclaré que «l'engagement du Royaume-Uni envers la sécurité et la prospérité économique des îles Falkland est plus fort que jamais – de la protection de la faune incroyable de la région à la défense du droit à l'au-

todétermination des îles». Ce sont en effet les mêmes arguments que le gouvernement britannique a utilisé pour résister aux initiatives du gouvernement mauricien visant à récupérer la souveraineté de Maurice sur les Chagos.

a gouverneure des Falkland, Alison Blake, avait également envoyé le 4 octobre 2024 un message aux résidents le jour de l'accord sur les Chagos, les rassurant sur l'«engagement indéfectible» du Royaume-Uni et soulignant que le contexte historique des deux territoires était «très différent».

La guerre des Malouines de 1982, qui a fait des centaines de victimes, reste une cicatrice historique pour les deux nations. Tandis que l'Argentine s'appuie sur le soutien international et les récents développements, le Royaume-Uni maintient sa position en s'appuyant sur le principe de l'autodétermination des habitants

a deuxième réunion de la commission mixte francomalgache, tenue à Paris le lundi 30 juin 2025, n'a pas permis de faire avancer le différend cinquantenaire qui oppose Paris et Antananarivo concernant les Îles Éparses. Selon RFI, loin de trouver une solution, la rencontre a surtout mis en lumière la persistance du litige entre les deux parties.

En effet, Madagascar continue de réclamer avec fermeté la restitution des Îles Éparses et rejette catégoriquement toute proposition de cogestion avec la France tant que Paris ne reconnaît pas la souveraineté malgache sur ces micro-territoires inhabités du canal du Mozambique. Cette position inébranlable a dominé les échanges, empêchant toute avancée notable. À ce jour, la France n'a pas encore commenté les demandes formulées par Madagascar.

La délégation malgache était pourtant arrivée dans la capitale française avec une liste de revendications précises. Outre la restitution des îles, Antananarivo a explicitement demandé la suspension de toute décision unilatérale de la France sur ces territoires tant qu'une solution concertée n'est pas trouvée.

Des enjeux multiples et des leviers potentiels

Au-delà de la souveraineté, les demandes malgaches couvrent plusieurs aspects cruciaux. La délégation a réclamé une indemnisation pour les dommages et pertes économiques subis durant les années où Madagascar n'a pu exercer sa souveraineté, bien qu'aucun montant n'ait été communiqué. Elle a également insisté sur la possibilité pour les pêcheurs malgaches d'exploiter les ressources halieutiques dans les eaux avoisinantes. De plus, Madagascar souhaite que ses chercheurs puissent participer aux travaux scientifiques concernant les Îles Éparses et accéder aux données disponibles à leur sujet.

Toutes ces requêtes sont pour l'heure en attente d'une réponse. Cela n'a cependant pas empêché Madagascar d'annoncer un troisième cycle de négociations, dont la date et le lieu restent à déterminer sur la Grande Île. Face à cette lenteur, l'analyste politique Serge Zafimahova suggère que les autorités malgaches disposent d'autres leviers juridiques pour tenter d'obtenir la restitution des Îles Éparses. Il évoque la possibilité de saisir la Cour internationale de justice (CIJ), à l'instar de l'île Maurice pour les îles Chagos, ou

de porter l'affaire devant le Comité spécial de la décolonisation des Nations unies. M. Zafimahova penche personnellement pour "aller au contentieux si on ne veut pas en être au même point dans 50 ans", souliquant l'urgence d'une action décisive.

Un héritage colonial stratégique et contesté

Ces îlots, dispersés dans l'océan Indien, sont revendiqués par Madagascar mais administrés par la France depuis l'époque coloniale, représentant l'un des derniers vestiges de l'empire français dans la région. Historiquement, toutes ces îles faisaient partie de Madagascar, sous domination française de 1896 à 1960. Leur séparation, intervenue juste avant l'indépendance de Madagascar, est fermement contestée par Antananarivo, d'autant que l'Assemblée générale des Nations Unies a, par deux résolutions non contraignantes en 1979 et 1980, appelé à leur retour, jugeant la scission illégale.

'enjeu de ces îles dépasse largement leur petite taille. Elles revêtent une importance stratégique, écologique et symbolique considérable, offrant à la France le contrôle sur de vastes zones maritimes riches en ressources. Chaque île permet à Paris d'exercer sa souveraineté sur 200 milles nautiques d'eaux environnantes, lui conférant la maîtrise de plus de la moitié du canal du Mozambique, une voie mari-time essentielle pour le commerce mondial. Ce canal re-gorge également d'importantes réserves d'hydrocarbures, le faisant surnommer la "nouvelle mer du Nord", et de zones de pêche abondantes.

La question de la souveraineté est un point d'honneur national à Madagascar, symbole de fierté post-coloniale. C'est dans ce contexte que la visite du président Macron à Madagascar en avril 2025 avait remis en lumière ce différend persistant, souvent qualifié d'héritage inachevé de la

Les Îles Éparses – Tromelin, Glorieuses, Juan de Nova, Europa et Bassas da India – sont parsemées à travers le canal du Mozambique entre Madagascar et la côte africaine, habitées principalement par quelques scientifiques et du personnel militaire français.

Le différend sur la souveraineté persiste depuis l'indépendance de Madagascar en 1960. Bien que les Îles Éparses aient été administrativement rattachées à Madagascar à partir de 1895, la France les a placées sous son autorité directe en 1960, arguant qu'elles ne faisaient pas partie de l'accord d'indépendance. Madagascar maintient que les frontières coloniales de son territoire auraient dû rester inchangées.

The Paternity of Prosperity

A Socratic Inquiry into Economic Miracles

Socrates: Oh, something far more intriguing, Cephalus, and surprisingly... *paternal*. I was recently privy to a most peculiar pronouncement, made in a far-off land of sugar cane and sapphire seas, regarding an "economic miracle."

Cephalus: (Raising an eyebrow) An economic miracle, you say? Ah, then it must involve a great deal of commerce, industriousness, and undoubtedly, shrewd investment. I am listening, old friend. This sounds promising, unlike your usual forays into the murky depths of abstract concepts.

Socrates: Indeed. The tale comes from a leader named Ramgoolam, who, in a public forum, declared another man, Bérenger, to be the "true father of the economic miracle" in their nation, citing certain "difficult decisions" made long ago.

Cephalus: (Nodding sagely) "Difficult decisions," you say? Splendid! That's the mark of a true leader, Socrates. Taking the hard road. Visionary! No doubt Bérenger laid the groundwork, planted the seeds, and others, later, merely reaped the harvest. A commendable recognition, I must say. Shows a certain humility in Ramgoolam, does it not?

Socrates: Humility, perhaps. Or... something else. For Bérenger, it is said, conceded that a later group, the MSM, "reaped the fruits of his efforts." So, we have a father, and then, apparently, a group of fruit-harvesters.

Cephalus: (Chuckling) Well, that's just politics, Socrates! One man builds the vineyard, another drinks the wine. It's the way of the world. What's the philosophical knot here? Are you suddenly questioning the very concept of harvesting?

Socrates: Not the act of harvesting, my dear Cephalus, but the **paternity** of the prosperity. Can an "economic miracle" truly have a single father? And what constitutes this



fatherhood? Is it the one who plants the seed, or the one who diligently waters it for decades, or the one who finally brings the plump grapes to the market?

Cephalus: (Waving a dismissive hand) Oh, come now, Socrates. In business, it's quite clear. The one with the initial capital, the brilliant idea, the strategic vision – *that's* the father of the enterprise. The others are merely employees, managers, or, if they're lucky, inheritors. It's a matter of cause and effect! Bérenger made the "difficult decisions," therefore, the miracle is his offspring. Q.E.D. Case closed.

Socrates: Q.E.D., you say? How delightfully definitive. But tell me, Cephalus, if a man plants a fig tree, and then immediately leaves the city forever, never tending to it, and another man comes along, waters it, prunes it, protects it from pests for forty years, and finally reaps a bountiful harvest, who is the "father" of those figs? The planter, or the tender?

Cephalus: (Frowning, rubbing his chin) Hmm. A trickier fig than most, Socrates. One could say the planter is the *originator*, but the tender is certainly the *sustainer*. Without the planter, no fig. Without the tender, no harvest. Perhaps they are... co-parents? A joint venture in fig-fatherhood.

Socrates: "Co-parents"! An interesting biological concept for an economic miracle. So, if an economic miracle is like a strong, healthy fig tree, nurtured over decades, can we truly attribute its robust fruit to a single decision made in a single year, however "difficult" it might have been? Does a single difficult decision automatically guarantee a flourishing economy, irrespective of all subsequent decisions, global winds, and the general diligence of the populace?

Cephalus: (Shifting uncomfortably) Well, of course not, Socrates. The market is a fickle beast. One must adapt, innovate, remain competitive. Even the most brilliant initial strategy can be undone by poor execution or unforeseen circumstances. So, yes, the *sustenance* is crucial. But the initial *spark*, the *foundational difficult decision* — that's still paramount, wouldn't you agree? A house needs an architect before it needs carpenters.

Socrates: Indeed, an architect is vital for a house. But if the architect draws magnificent plans, and then a series of incompetent builders, corrupt material suppliers, and indifferent occupants follow, will the house truly be "magnificent" when completed, and shall we still praise the architect without reservation? Or if the house stands for fifty years, and then an earthquake, and then a meticulous restoration occurs, who is credited with its current resilience? The original architect, the restorers, or perhaps even the earthquake for providing the ultimate test?

Cephalus: (Spluttering slightly into his beard) An earthquake, Socrates? Now you're just being facetious! One credits the builders, and the current occupants for maintaining it! The architect, perhaps, gets credit for the *design*, but the *survival* is a different matter.

Socrates: Precisely! So, when a politician, in a public speech, declares another to be the "true father" of a long-term economic flourishing, are they acting as dispassionate historians, meticulously tracing cause and effect over decades, accounting for every tremor and every careful repair? Or are their pronouncements perhaps... influenced by the prevailing winds of the political Agora?

Cephalus: (Clearing his throat) Ah, now we get to the heart of the matter. Yes, Socrates, one must always view political pro-

nouncements with a healthy dose of scepticism. They are, shall we say, *strategic* utterances. To praise an ally, perhaps to mend fences, or even to subtly rewrite history to suit a current narrative. My cousin, who dabbles in public speaking, once told me that a good speech is never about truth, but about *persuasion*.

Socrates: "Persuasion," you say? So, the paternity of an economic miracle can be, shall we say, *persuaded* into existence for political gain? As if a father could be declared by popular vote, rather than by nature?

Cephalus: (Waving his hands in exasperation) Look, Socrates, it's simply about giving credit where credit is *convenient*. In the heat of debate, leaders make pronouncements. It reinforces alliances, strengthens messages. It's the grease that keeps the political cart moving.

Socrates: So, the "truth" of paternity, in this context, is less about an objective biological fact and more about a fluid, politically expedient narrative?

Cephalus: (Muttering) Well, when you put it like that, it sounds rather cynical. But yes, often. Who has the time, in the midst of running a nation, to conduct a rigorous historical inquiry into every economic boom? They need to make a point, and they make it.

Socrates: And who, then, should be the true adjudicators of such paternity? Should the task of definitively naming the "father" of an economic miracle, or any significant societal achievement, be left to the politicians themselves, engaged as they are in the immediate struggle for power and influence?

Cephalus: (Shuddering) Perish the thought! No, no. Not the politicians. They're too busy, too... *interested*. One needs distance. A detached perspective.

Socrates: Like a historian, perhaps? One who waits for the dust to settle, for the passions to cool, for all the hidden scrolls to be declassified after, say, fifty years?

Cephalus: (Eyes widening) Fifty years! By the gods, Socrates, that's an eternity! My business deals would be dust by then. Who would remember who did what?

Socrates: Ah, but that is precisely the point, is it not? The very passage of time allows for a broader perspective, unclouded by the emotions or the political agendas of the moment. It allows for access to varied sources – not just the public pronouncements, but the private memos, the dissenting opinions, the long-term data. It allows for a more *objective* assessment, insofar as objectivity is possible for mortals.

Pakistan intensifies US defence ties after recent tensions

Pakistan appears to be making concerted efforts to bolster its defence cooperation with the United States. This drive is highlighted by recent high-profile visits from its top military leadership, coming shortly after a period of heightened regional tensions.

Just days after a notable luncheon between Pakistan's Army Chief Field Marshal Asim Munir and President Donald Trump, the Chief of the Air Staff, Zaheer Ahmed Baber Sidhu, embarked on an official visit to the US. This marks the first visit by a serving Pakistan Air Force (PAF) chief in decades, signaling a significant push by Pakistan to deepen military engagements.

New avenues for cooperation

The PAF has hailed Sidhu's visit as a "strategic milestone" for the defence partnership. In the US, the Air Chief met with key figures including US Air Force Chief of Staff General David W. Elon and US Secretary of the Air Force for International Affairs Kelly L. Seybolt. Both



nations reportedly agreed on "new avenues" for bilateral military cooperation, with discussions focusing on establishing high-level military ties, enhancing collaboration on mutual interests, and expanding joint training and technology exchange.

Sidhu also engaged with prominent members of the US Congress, including Mike Turner, Rich McCormick, and Bill Heizenga. The PAF stated this "historic visit not

only reaffirmed the PAF's commitment to promoting regional and global peace, but also laid the foundation for institutional cooperation, strategic dialogue, and joint operations between the PAF and the US Air Force."

Munir's precedent-setting visit

Sidhu's trip follows closely on the heels of Army Chief Asim Munir's visit to the US. This move was particularly significant as it occurred weeks after the India-Pakistan conflict, during which Trump claimed to have brokered a ceasefire. Munir reportedly had a private lunch with Trump at the White House, an uncommon occurrence as US presidents rarely host foreign military leaders in such a setting. While specifics of their conversation remain undisclosed, Trump praised Munir for his role in "preventing the escalation of tensions" between India and Pakistan. New Delhi, however, has consistently denied Trump's involvement, asserting the truce was a result of bilateral talks.

These back-to-back high-level visits underscore Pakistan's determined efforts to fortify its strategic alliance with the US amidst evolving regional dynamics.

Ukraine boosts domestic drone production amid fluctuating US aid

Jkrainian President Volodymyr Zelensky announced a significant agreement on Thursday with American company Swift Beat for the joint production of drones, calling it a "crystal clear priority" for Ukraine's defense. This partnership aims to produce "hundreds of thousands" of drones this year alone, with plans for a substantial increase in output next

year.

This Ukrainian-American collaboration will encompass a range of drone types, including interceptors to neutralize enemy drones and missiles, quadcopters for reconnaissance and fire adjustment, and longrange strike drones. Zelensky emphasized that this ramped-up production is vital for achieving Ukraine's defense objectives and safeguarding Ukrainian lives. Swift Beat, founded by former Google CEO Eric Schmidt. already has a significant presence in Ukraine, specializing in Al-powered autonomous drones and actively with Ukrainian collaborating engineers and military officials for

The agreement comes as Ukraine

actively seeks to diversify and strengthen its domestic defense industry. President Zelensky revealed that Kyiv is also in talks with Denmark, Norway, Germany, Canada, Lithuania, and the United Kingdom to establish further joint production initiatives. Ukraine even intends to begin exporting weapon production technologies by this summer, signaling a broader strategic shift towards self-sufficiency.

However, this positive development in drone production is juxtaposed with recent reports regarding US military

assistance. Just two days prior to Zelensky's announcement, deliveries of air-defense interceptors and other weapons intended for Ukraine were reportedly halted by the United States. Citing Trump administration officials, the Wall Street Journal reported that this decision reflects a "loosening commitment" from Washington to aiding Kyiv's fight against Russia. White House spokeswoman Anna Kelly stated the decision was made to "put America's interests first" following a Pentagon review of US military assistance. The shipments, which included Patriot air-defense interceptors, air-to-air missiles, Hellfire missiles, artillery rounds, and Stinger missiles, were reportedly stopped while in

Kate Middleton reveals post-cancer recovery challenges: "The phase afterwards is really difficult"

onths after announcing her remission following abdominal surgery and a subsequent cancer diagnosis in early 2024, Kate Middleton, the Princess of Wales, has opened up about the profound difficulties of life after active cancer treatment. Her recent candid remarks, reported by The Daily Beast and Hindustan Times, shed light on the personal toll of her health battle and the ongoing process of finding a "new normal."

During a hospital garden visit on Wednesday, her first public appearance since an unexpected withdrawal from Royal Ascot in June, Kate did not directly address her Ascot absence, which reportedly caused "a real sense of panic" within the palace. However, she spoke broadly about the challenges of post-treatment recovery. "You put on a sort of brave face, stoicism through treatment. Treatment's done, then it's like, 'I can crack on, get back to normal,' but actually, the phase afterwards is really, really difficult," she explained.

Finding a "New Normal" Takes Time

The Princess highlighted the lack of immediate support once clinical treatment ends, even as daily life remains far from normal.

"You're not necessarily under the clinical team any longer, but you're not able to function normally at home as you perhaps once used to. And actually, someone to help talk you through that, show you and guide you through that sort of phase that comes after treatment, I think is really valuable."

She emphasized that recovery is not a linear process. "You have to find your new normal and that takes time... and it's a roller-

coaster, it's not smooth, like you expect it to be. The reality is you go through hard times.

Recalibrating Life and Priorities

Kate concluded her chemotherapy in September 2024 and confirmed her remission in January 2025. Her recent garden visit was framed by her office as an opportunity to "celebrate the incredible healing power of nature and raise awareness of the important role that spending time in nature plays in bringing us joy and supporting our mental, physical and spiritual wellbeing."

Insiders suggest that the Princess is undergoing a fundamental reassessment of her life. "Kate is recalibrating her entire life, her entire work-life balance," a source told The Daily Beast, adding that "Ascot

was a wakeup call, not a one-off." The source indicated that the past few years have been "horrific" for Kate, citing the public comments made by Prince Harry, relentless speculation about her and Prince William, the passing of the Queen, King Charles's cancer diagnosis (which led them to consider taking on more responsibilities), and ultimately, her own cancer diagnosis and treatment.

"It's all taken its toll, and if she needs more time to recover, William will fight tooth and nail to see she is given it," the source concluded, underscoring the immense personal challenges the Princess has faced and the priority now being given to her recovery and well-being.

Starlink on track for India launch

India is close to greenlighting the launch of Elon Musk's Starlink in the country, even as it intensifies a legal battle against the billionaire's social media platform X. Musk's satellite internet company has been trying for years to break into India's large and lucrative market, and in March signed deals with two top Indian telecoms firms to enter the country. With New Delhi reportedly clearing most regulatory hurdles, Starlink could launch within months, NDTV reported. Musk's X, meanwhile, is locked in a bitter dispute with the Indian government over content removal requests: The clash escalated Tuesday after lawyers for the site accused authorities of allowing "every Tom, Dick, and Harry" to issue takedown orders.

Manufacturing slumps on trade uncertainty

Much of Asia's manufacturing sector slumped as it entered the second half of 2025, reflecting uncertainty over US President Donald Trump's tariffs. Southeast Asia — a critical region for firms looking to diversify away from China — saw its downturn in factory activity deepen, while tech powerhouses Taiwan and South Korea reported declines in output and sales, S&P Global data showed. India bucked the trend, suggesting it has benefitted from a shift in demand away from other export hubs, The Wall Street Journal wrote. Trump's duties also slowed US manufacturing in June, as businesses grappled with uncertainty just before Washington's tariff reprieve expires on July 9.

Mexico cracks down on fuel theft

Mexican authorities arrested 32 people accused of fuel theft, which has in recent years taken a huge toll on the country's economy. The crime ring operated with the help of government authorities, Reforma reported. More than a quarter of Mexico's cars are thought to run on stolen fuel, much of it sold by cartels. This year, authorities confiscated a ship carrying 250,000 barrels of fuel, underscoring the sophistication of cartels' transnational operation. Mexico is dotted with thousands of clandestine fuel stations and refineries, which make up for the market shortfall created by a government refinery that runs at 30% capacity. Authorities are "totally blind and incompetent or complicit," an expert told the Financial Times.

Cities eye maggots for food waste

Municipalities in Australia, Kenya, and Lithuania are turning to maggots to dispose of food waste. Vilnius uses fly larvae to process all 3,000 tons of food waste the city produces each year. The company that does it uses the larvae for proteins in animal feed or industry, and their manure for fertilizer. Smaller programs are underway in Mombasa and Sydney, and other countries are interested: Food waste collection will become mandatory in England from next year, meaning local authorities will have to find ways of dealing with millions of tons of waste. Maggots are much more efficient at breaking down food waste than existing methods: In sufficient numbers, fly larvae can destroy a 16" pizza in under two hours.

Across The World

Iran's nuclear potential

The head of the United Nations' nuclear watchdog, Rafael Grossi, stated that Iran could produce enriched uranium within "months," contradicting US President Donald Trump's assertion that Tehran's nuclear program was "obliterated." Grossi's remarks echoed earlier US assessments and European intelligence suggesting Iran's nuclear ambitions were set back by merely months — senior Iranian officials also reportedly said the US strikes weren't as destructive as they'd expected. While the American attack in June 2025 may have stalled Iran's near-term ability to make a bomb, some of the targeted facilities might not have existed if Trump hadn't abandoned an earlier nuclear deal in his first term, experts told The New York Times.



Trump said Friday he would consider bombing Iran again if Tehran enriched uranium to worrisome levels, despite the fact that Iran is already enriching to 60%, significantly beyond the 3.67% permitted under the JCPOA.

US trade deadline looms

with the US before President Donald Trump's pause on his "Liberation Day" tariffs ends July 9. India's trade team has extended its stay in Washington, while new fractures have emerged within the European Union: Germany wants Brussels to strike a deal fast, but France wants the EU to take a firmer stance. It appears increasingly unlikely that US negotiators will agree dozens of deals within 10 days. "The idea that uncertainty will be resolved early this summer appears to be completely dead," one expert told CNN. Compounding the uncertainty is Washington's unpredictable approach to trade relations; Trump on Friday abruptly terminated talks with Canada, shortly after announcing a new agreement with China.

Central banks' warning

The world's "central bank of central banks" warned about the rising possibility of fresh outbreaks of inflation. The Switzerland-based Bank for International Settlements noted in a new report that consumers across the globe expect steep price increases in the next year — and that because of the lasting effect of COVID-era inflation, those predictions now risk becoming a self-fulfilling prophecy. "When it comes to inflation expectations, it's once bitten, twice shy," a BIS official said. The report gives clues to central bankers' thinking as they cautiously trim interest rates amid subsiding inflation. Washington's trade war adds to the volatility: Rising protectionism is eroding the global economic order, the BIS' chief said, creating a "new era of heightened uncertainty and unpredictability."

China doubles down on promoting yuan

China is devising more ways for foreign institutions to use the yuan, as international confidence in the US dollar falters. The moves aim at challenging the greenback, experts said, even as the USD remains by far the world's predominant currency, despite the USD index falling more than 9% this year, while the offshore yuan has strengthened more than 2% against the dollar.

US removes 'revenge tax'

Treasury Secretary Bessent said the US would no longer seek to impose retaliatory taxes on countries that tax US tech giants after resolution was achieved in G7 talks. Bessent now says he has struck a G7 agreement to instead recognise the US's own minimum tax regime on US investments in foreign companies ("GILTI"), which is between 10.5-13.125%. The US will also resume trade talks with Canada after Ottawa scrapped its digital services tax targeting US tech firms.



US same-sex marriages

The number of married same-sex couples The number of marriage since the Supreme Court instituted marriage equality across the nation. Same-sex unions were performed and recognized in 36 states before Obergefell v. Hodges changed the law in 2015. Then, there were 390,000 same-sex married couples; now there are more than 800,000. Public opinion has shifted, too. In 1995, just 27% of Americans believed gay people should be able to marry; now, 68% do, according to Gallup, although that represents a slight dip in support since 2023. Progress is not smooth, The Washington Post noted: This year, some officials have suggested Obergefell should be overturned, and the number of same-sex weddings has also dropped.



Portuguese Africa

The brutality of Portuguese colonialism is well attested by independent writers who have visited these black spots

here has been a lot of childish talk and thought about the tragedy of Congo. Imperialists and colonialists have used it as an excuse to attack the whole idea of colonial emancipation; they say "Look

at what happens when you give independence to the Africans - rioting and disorders. You can't trust the Africans. They're not ready for independence, they are children who must be told what to do."

Thus runs the illogical talk of the imperialists. They ignore the fact that the Congo tragedy was the logical outcome of years of Belgian dictatorship and denial of civil rights and liberties. They ignore the fact that the Belgians had never begun to educate the Congolese for political power but had retained all power in the hands of a few thousand expatriate Europeans. They ignore the fact that Belgium, while making a show of granting political independence to the Congo Republic, was nevertheless determined somehow to retain her stranglehold economic power over the wealthy metal-liferous Katanga province.


What is needed in the Congo is not cheap unthinking gibes from the imperialists, but people of goodwill, presumably under UN auspices, who will do the job which the Belgians, during years of brutal dictatorship, cynically refused ever to begin — the job of providing the administrators and technicians who will, under a free Congolese Government, teach the Congolese how to run their own affairs. And they must teach all the Congolese; there is no room in the Congo for an independent Katanga.

For an independent Katanga means the perpetuation of colonialism; Belgian economic colonialism in place of Belgian political colonialism. An independent Katanga would be no more independent than the 'banana' republics of Central America.

Dut the Congo is not the only tragic spot in Africa where colonialism is rampant. Worse is the situation in the Portuguese colonies of Angola, Mozambique, Guinea, Sao Tomé, and Cape Verde. In Angola, for example, 57 nationalist leaders are being tried in a street military court at Luanda. In June 52, Angolans, mostly civil servants and railway workers, were arrested in parts of central Angola. The well-known poet and doctor. Agostinho Neto, was arrested and flogged (in front of his family and neighbours) by the chief of the Portuguese Gestapo in Angola as well as by the assistant chief.

Father Joaquim da Rocha Pinto de Andrade, Chancellor of the Archbishopric of Luanda and the only Angolan graduate in theology at the University of Rome, has been arrested and deported to Portugal. The police have been raiding African houses in and around Luanda and other towns; every radio set that was found was smashed over the head of its owner. Indiscriminate beatings and shooting in the air have helped to spread terror in the villages. Extra troops have been sent from Portugal, and more are on the way; Portuguese settlers have been armed.

This is just a sample of the atrocities and brutalities to which the peoples of the Portuguese colonies are regularly

subjected. A further sample: on August 3, 1959, Portuguese troops shot dead 50 African workers at Bissau. In memory of these workers the second All-African Peoples' Conference (held at Tunis) decided to commemorate August 3 as the Portuguese Colonies Independence Day. On that day, anticolonialists all over the world have the opportunity to show their solidarity with the nationalist movements in all Portuguese colonies, in India as well as in Africa.

The brutality of Portuguese colonialism is well attested by independent writers who have visited these black spots in the last few years. Peter Ritner, in *The Death of Africa* (New York, 1960), says: "Portuguese Africa is one of the worst governed areas of the world." Professor Marvin Harris, an American anthropologist, says in his *Portugal's African Wards* (New York, 1958), "What makes Mozambique an unknown land is the silence of her African people. Overwhelmingly illiterate, carefully insulated against provocative news from abroad, subject to corporal punishment and deportation at the whim of the European authorities, their thoughts are never expressed, their real voice unheard."

Basil Davidson, in The *African Awakening* (London, 1955) has this to say, "In 1954, official figures in Angola showed 379,000 forced workers (none being in native industry or agriculture) and another 400,000 voluntary workers... the Government makes universal use of forced labour for its own needs..."

The year before, Alexander Campbell had said in *The Heart of Africa*, "Any adult male African may be compelled by Portuguese law to work for a white master for at least six months of every year... The same fate awaits Africans who fail to pay their poll taxes." Finally, in *Inside Africa*, John Gunther wrote (also in 1955), "The worst thing about Portuguese Africa is forced labour. Not only does this still exist; the Portuguese authorities admit that it exists... and condone it. It is not quite - but almost — a form of slavery. The man becomes a chattel." He earlier points out that Portuguese Africa is ruled as Portugal itself is ruled: by authoritarian methods, with press censorship, secret police, rigged elections, and all the other trappings of dictatorship.

The people of Portuguese Africa are a bedevilled and well-nigh forgotten people. 50 years ago, English writers such as Nevinson and Cadbury drew attention to the evils of Portuguese rule in her African colonies; and nothing since has been done to improve the fate of the peoples of those colonies. Potentially the colonies are economically rich; and some of the natural wealth is exploited by Portuguese companies who, however, condemn their African employees to

exist in a subhuman state of squalor and misery.

The total population of Portuguese Africa is 11 million. For these 11 million people, there are only 380 doctors! Cape Verde is best off, with one doctor to 10,000 people. In Angola, which is better off than Guinea or Mozambique, there is one hospital for every 280,000 people, one doctor to every 20,000 people, and one nurse and 30 hospital beds for every 10,000 people. 99 per cent of the people are illiterate; areas as large as Portugal have no schools at all. Only about one child in 100 attends school! There is a Roman Catholic monopoly of education for the Africans; African education is virtually confined to the primary schools. A few persistent Africans do make an extraordinary effort to complete secondary education, and a mere handful manage to achieve a university

education; at present, about 100 Africans are attending Portuguese universities (there are none in the colonies) — 100 out of a total population of 11 millions! Nearly all primary school teachers, and all secondary school teachers, are Europeans; except that in Cape Verde a few Africans teach in secondary schools.

portugal does not accept the principle of self-determination for the people of her colonies (which she terms 'overseas provinces' in order to keep out United Nations Commissions of Enquiry. She denies the right of all peoples to choose their own destiny; she denies the capability of the Africans to govern themselves or to contribute to human progress as independent and sovereign nations. The Fascist Salazar Government, maintained in office by all the trappings which Hitler used to such evil ends, is not yet apparently aware of the most important political reality of the present age: the end of colonialism. It keeps alive the spirit of anti-democracy and colonialism; it does not hesitate to use the weapon of terror and torture against people whose only 'crime' - if crime it be - is the desire for freedom. There are savage concentration camps; in the last few years a relentless campaign has been waged against the African patriots, a campaign in which there have been persecutions, deportations, tortures, and massacres of innocent persons.

But there has recently been formed an organisation linking together the various national independence movements. This organisation depends on the support and sympathy of individuals and other nationalist organisations all over the world; that is why I have written at length about the position in Portuguese Africa. Everyone in Mauritius who has at heart the cause of independence will be with the people of the Portuguese colonies in their struggle for freedom from the dictatorial oppression of Salazar and his secret police; everyone will be with me in extending to the Africans of Portuguese Africa the wish and hope that their domination by Portugal will soon be over, and that their appeals for help in their struggle will not fall on deaf ears among the governments of the world and at UNO.

Varadarajan summarizes Mead's analysis suggesting that it identified four distinct American approaches to foreign policy, which he called Hamiltonian, Wilsonian, Jeffersonian and Jacksonian. "Hamiltonians regard a strong alliance between government and big business as 'the key to effective action abroad." Wilsonians believe that the US has both "a moral obligation and an important national interest" in spreading democratic values throughout the world."

Trump is, of course, a Jacksonian at heart, believing that the security and well-being of the American people is paramount. Some might argue that Trump's definition of "the American people" does not encompass diversity, equity, and inclusion. But however, he defines his American diaspora (albeit localized in the US and not spread around the world) it is THEIR welfare that he espouses.

As Varadarajan explains Mead's thinking, a Jack-sonian holds that the US "should not seek out foreign quarrels, but when the US or its allies are attacked or threatened or even insulted, they can become very energized, like a hive of bees. If the hive is attacked, they will sting with everything they've got."

So, Trump has felt threatened by Iran and justifiably feels that Iran has sponsored attacks on America and its interests. This approach is similar to his threats against all who would cross him on the domestic scene at home.

With so much going on, we might well ask if there is a master plan and what is going on behind the scenes? Is Trump pursuing some coherent policy that will bring peace to the world, and win him a Nobel Peace Prize, or is this just another incoherent jumble akin to one of his rambling speeches at a campaign rally which have come to be known as his "weave?"

Perhaps it is all transactional. The rare earth minerals deal with China, mining rights for American in Congo as part of a ceasefire deal with Rwanda, a ceasefire between India and Pakistan, a ceasefire between Israel and Gaza (without mention of his fabled Riviera of the Middle East), allowing China to purchase Iranian oil notwithstanding sanctions on Iran speak to this. But how do we explain Trump's refusal to send more defensive missile interceptors to Ukraine even after a rare earth mining deal was agreed with that country? Given all his talk about achieving ceasefires, his failing with Putin in Ukraine is singular. There is no rational explanation.

As with all things Trump, the broad strokes tell one story, the tiny brush strokes of detail are often unfinished or altogether absent. Will a giant painting with peace as its theme be enough, or are the details necessary to fill in before the warring nations see that they are part of the bigger picture? Can Trump paint a bigger picture?

Identity Politics, Economic Injustice, and the Erosion of Moderation

he University of Pennsylvania is set to ban transgender athletes, a decision stemming from the controversy surrounding swimmer Lia Thomas. Power often proves intoxicating and corrupting, leading to a reckless disregard for those perceived as a threat to deeply held beliefs and interests. We've seen the immense and rapid influence gained by movements like #MeToo and, especially, Cancel Culture, primarily through social media. This has ruined the careers and lives of public figures, including those who dared to publicly challenge hard-line "woke" ideology and its resulting government policies.

I've long held that humankind, both individually and collectively, struggles with moderation. Yet, while the social and political pendulum can swing to extremes, such significant shifts are to be expected in response to historical social injustices, including those

endured by the transgender community.

A similar pendulum-swing effect might have occurred in Western neoliberal democracies in response to prolonged and immense economic injustices. However, this has largely been prevented by the formidable obstacle of virtual corporatist and significant power/money interests.

During major demonstrations against economic injustices, the police and military could—and likely would—claim they had to "bust heads" (to use political terminology) to prioritize maintaining law and order. With a complacent, if not compliant, corporate news media dominating nearly all news outlets, absurdly unjust inequities and inequalities can persist.

Ministerial Advisors & The Blurry Lines

here's been a lot of debate recently about the number of advisors appointed by pre vious governments, the criteria for selecting them, and their exact role. The answers to these important questions often depend on the specific context, and even what that individual advisor's job entails. As a former civil service official who has worked under different administrations, I can tell you it's rarely a clear-cut "either/or" situation. Generally speaking, you'll find two main types of advisors within government.

These advisors - admittedly not all - are typically aligned with the ruling party's agenda. Their main job is to help the government achieve its political goals and deliver on election promises. They often have personal connections to politicians, perhaps through campaign work, long-standing relationships with ministers, or shared ideological beliefs. Their advice tends to focus on feasibility and political impact, considering not only how effective a policy might be, but also its public reception and how well it fits with the party's platform.

There are also generally chosen for their expertise. Their primary qualification is deep knowledge, a strong research background, or extensive practical experience in a specific field, like economics, public health, etc. They're expected to be objective, meaning their role is to offer analysis and recommendations based on data and best practices, without letting political implications sway them. Their advice focuses on effectiveness and long-term outcomes, aiming for the most efficient or impactful solution to a problem, often looking beyond immediate political cycles. Sometimes, career civil servants within government departments also fall into this category when providing policy advice.

The truth is, the reality often exists in a grey area. Even highly independent experts might be selected by a political government, and their advice could be selectively used or interpreted to fit a political narrative. Conversely, many political staff possess significant expertise themselves and are genuinely striving for the best outcomes, even if they operate within political constraints.

The ideal scenario for effective governance usually involves a healthy tension and collaboration between both types of advisors. Politically aligned advisors understand the public's mandate, while independent experts provide a robust, factual foundation for decision-making.

Military Bases and National Sovereignty in Mauritius and Sweden

ne reason why I have, for some years, been interested in moving to Mauritius (myself and perhaps also my business) is that I have seen Mauritius as a possible model for a peaceful country. You seem to have avoided both civil wars and participation in foreign wars, so far.

However, I have now read that the extended territory of Mauritius will most likely include the military base on Diego Garcia, perhaps even hosting nuclear weapons at times, and that the Chagossians will most likely not be able to return to their former homes in the foreseeable future. This makes me incredibly sad, especially after living through how my home country, Sweden, has changed from a peaceful country with much respect for human rights to the opposite.

The risk seems to be increasing that both countries — Sweden and Mauritius — would be willing to partici-

pate even in a possible nuclear holocaust (at least by providing bases). If it does not come to that extreme, both our countries seem to have voluntarily given up an important part of democracy. If the military in a country is not under the democratic control of its people, can you truly say that you have a working democracy?

For example, if President Trump decides to launch further attacks against Iran, this may, in the near future, include aircraft taking off from Mauritian territory (Diego Garcia), but the people of Mauritius will not have anything to say about this. In the past, the US has also been able to do anything on Diego Garcia, including suspected torture, but the important difference is that soon this may happen under your watch.

In a similar way, if Trump decides to put military pressure on our neighbour Denmark regarding Greenland, Trump may use US military forces based in Sweden according to our "Defence Cooperation Agreement," and the Swedish people will not have anything to say about this. Our own military is even becoming an "escort service" for the US, having to provide assistance to the US. Sweden has already sent people to be tortured, in cooperation with the US. It is also unclear who will be responsible for cleaning up toxic remnants from their military activity, etc. In the case of Sweden, we will be bound by the agreement with the U.S. for at least the next ten years, and we don't get paid any lease or rent for US bases.

As I understand, the agreement that Mauritius has signed (but hopefully not ratified) with the UK is for a much longer time period, but Mauritius will receive substantial "blood" money for Diego Garcia. I hope you realize in time that no deal with the UK about Chagos is better than your existing bad deal. You should have justice on your side, to stand up for all the Chagossians' right to return, to continue being a role model for peace, and to keep democracy for all your territory.

And crucially, it allows us to see the *long-term consequences* of those initial "difficult decisions." For a seed planted in 1982 might only truly bear its full, complex fruit many decades later, revealing unforeseen benefits or drawbacks.

Cephalus: (Pondering, then a slow nod) You have a point, old friend. It's like judging a young wine. You can taste its potential, perhaps even its initial quality, but you can't truly know its greatness, or its eventual sourness, until years have passed, until it has aged in the cellar and truly matured. And a politician, like a hasty sommelier, might declare a vintage magnificent before its time, for the sake of a quick sale

Socrates: A delightful analogy, Cephalus! So, while politicians and citizens and journalists may comment on the wine in the bottle today, perhaps the definitive judgment on the true patemity of the vintage, and its ultimate quality, should be reserved for those with the patience, the tools, and the necessary distance: the historians. For they, unlike the politicians, are not trying to sell the wine; they are trying to understand its

true origins and its long-term legacy.

Cephalus: (Smiling faintly) Perhaps, Socrates. Perhaps. Though I still prefer to trust my own palate on a good wine, regardless of what the ancient historians might one day say. Now, if you'll excuse me, all this talk of paternity has made me rather thirsty. I believe there's a particularly well-aged amphora with my name on it...

Socrates: (Chuckling, watching Cephalus depart) Indeed, my friend. And may its parentage be beyond all dispute. Though I suspect, in the grand scheme of things, even the finest wine is a product of many influences – the soil, the sun, the vine, the vintner, and perhaps, a few timely difficult decisions about fermentation. And to declare a single "father"... that would be a humorous simplification, would it not?

Why it's good to be nostalgic: You may have more close friends

People who are more prone to nostalgia tend to have more close friends and invest greater effort in maintaining relationships, according to a new study published in *Cognition and Emotion*.

Researchers from the University at Buffalo and Kyoto University studied nearly 1,500 people across the U.S. and Europe. Their findings reinforce previous research linking close relationships to better mental health, greater life satisfaction, and even longer lifespans.

The study included three experiments:

• Experiment 1: U.S. undergraduates were surveyed about their level of nostal-gia and the strength of their friendships. Those who frequently experienced nostal-

gia reported an average of seven very close relationships and placed higher value on maintaining them.

- Experiment 2: A broader sample of U.S. adults (average age 40) completed the same survey and a personality test. Again, nostalgic individuals had more close friends -- on average, five very close and 14 other important relationships -- and put more effort into sustaining them. This remained true regardless of personality traits like extraversion.
- Experiment 3: Using data from the Dutch LISS panel over seven years, researchers found that participants became more nostalgic over time. Those with high or medium nostalgia maintained



their close relationships, while those with low nostalgia saw an 18% decline in their close social ties.

Lead researcher Kuan-Ju Huang noted, "People who feel nostalgic more often and value those memories are more aware of their important relationships and the need to nurture them. This means these friendships may be more likely to last, even as our lives and responsibilities change."

Huang also shared personal insights, recalling how nostalgic music and videos provided comfort during his time as an international PhD student in Japan during the Covid pandemic. He added that while young adults and older adults both experience high levels of nostalgia, the reasons differ: life transitions versus reflections on loss and a limited future.

The study's limitations include not differentiating between types of relationships and focusing only on two countries.



If people stopped having babies, how long would it be before humans were all gone?

Even though there are 8 billion people on Earth today, a catastrophe could send that number much lower within a few decades.

Very few people live beyond a century. So, if no one had babies anymore, there would probably be no humans left on Earth within 100 years. But first, the population would shrink as older folks died and no one was being born.

Even if all births were to suddenly cease, this decline would start slowly.

Eventually there would not be enough young people coming of age to do essential work, causing societies throughout the world to quickly fall apart. Some of these breakdowns would be in humanity's ability to produce food, provide health care and do everything else we all rely on.

Food would become scarce even though there would be fewer people to feed.

As an anthropology professor who has spent his career studying human behavior, biology and cultures, I readily admit that this would not be a pretty picture. Eventually, civilization would crumble. It's likely that there would not be many people left within 70 or 80 years, rather than 100, due to shortages of food, clean water, prescription drugs and everything else that you can easily buy today and need to survive.

Sudden change could follow a catastrophe

To be sure, an abrupt halt in births is highly unlikely unless there's a global catastrophe. Here's one potential scenario, which writer Kurt Vonnegut explored in his novel "Galapagos": A highly contagious disease could render all people of reproductive age infertile — meaning that no one would be capable of having babies anymore.

Another possibility might be a nuclear war that no one survives – a topic that's been explored in many scary movies and books.



A lot of these works are science fiction involving a lot of space travel. Others seek to predict a less fanciful Earth-bound future where people can no longer reproduce easily, causing collective despair and the loss of personal freedom for those who are capable of having babies.

Two of my favorite books along these lines are "The Handmaid's Tale," by Canadian writer Margaret Atwood, and "The Children of Men," by British writer P.D. James. They are dystopian stories, meaning that they take place in an unpleasant future with a great deal of human suffering and disorder. And both have become the basis of television series and movies.

In the 1960s and 1970s, many people also worried that there would be too many people on Earth, which would cause different kinds of catastrophes. Those scenarios also became the focus of dystopian books and movies.

Heading toward 10 billion people

To be sure, the number of people in the world is still growing, even though the pace of that growth has slowed down. Experts who study population changes predict that the total will peak at 10 billion in the 2080s, up from 8 billion today and 4 billion in 1974.

The U.S. population currently stands at 342 million. That's about 200 million more people than were here when I was born in the 1930s. This is a lot of people, but both worldwide and in the U.S. these numbers could gradually fall if more people die than are born.

About 3.6 million babies were born in the U.S. in 2024, down from 4.1 million in 2004. Meanwhile, about 3.3 million people died in 2022, up from 2.4 million 20 years earlier.

One thing that will be important as these patterns change is whether there's a manageable balance between young people and older people. That's because the young often are the engine of society. They tend to be the ones to implement new ideas and produce everything we use.

Also, many older people need help from younger people with basic activities, like cooking and getting dressed. And a wide range of jobs are more appropriate for people under 65 rather than those who have reached the typical age for retirement.

Declining birth rates

In many countries, women are having fewer children throughout their reproductive lives than used to be the case. That reduction is the most stark in several countries, including India and South Korea.

The declines in birth rates occurring today are largely caused by people choosing not to have any children or as many as their parents did. That kind of population decline can be kept manageable through immigration from other countries, but cultural and political concerns often stop that from happening.

At the same time, many men are becoming less able to father children due

to fertility problems. If that situation gets much worse, it could contribute to a steep decline in population.

Neanderthals went extinct

Our species, Homo sapiens, has been around for at least 200,000 years. That's a long time, but like all animals on Earth we are at risk of becoming extinct.

Consider what happened to the Neanderthals, a close relative of Homo sapiens. They first appeared at least 400,000 years ago. Our modern human ancestors overlapped for a while with the Neanderthals, who gradually declined to become extinct about 40,000 years ago.

Some scientists have found evidence that modern humans were more successful at reproducing our numbers than the Neanderthal people. This occurred when Homo sapiens became more successful at providing food for their families and also having more babies than the Neanderthals.

If humans were to go extinct, it could open up opportunities for other animals to flourish on Earth. On the other hand, it would be sad for humans to go away because we would lose all of the great achievements people have made, including in the arts and science.

In my view, we need to take certain steps to ensure that we have a long future on our own planet. These include controlling climate change and avoiding wars. Also, we need to appreciate the fact that having a wide array of animals and plants makes the planet healthy for all creatures, including our own species.
