



## **Dangerous Speech and Divisiveness**

he people of this country are being daily bombarded with an overload of coverage in print and online about the Soopramanien Kistnen case and the events (including the killing of Manan Fakoo) that have followed after an insulting post attributed to a certain Okeep that went viral on social media.

Of the many comments that have appeared on social media, most are tit-for-tats that are as vulgar and deplorable, and reflect a mindset that aligns with a kind of reporting in print that tends to exacerbate polarization and divisiveness.

However, a ray of sanity surfaced in a post by someone who declared his belonging to the same community as Mr Okeep. In a calm voice, he said the remarks made by Okeep to be entirely condemnable and unwarranted, and should not have been made. Equally condemnable, however, would be similar remarks coming from any community against any other community. But also unacceptable, he added, was the brutal way in which the police is alleged to have dealt with Okeep. They have to treat him - or any other person - with the respect due to any citizen, even as they proceed with charging or arresting him, which must be done according to proper procedures. And the rule of law must prevail at all times and let the courts decide.

It is sobriety and maturity of this level that is most required on the part of all who have a stake and an interest in maintaining stability and peace in the country, at a time when there is so much of hotheadedness around and a single spark may be enough to precipitate the country into chaos.

An article in The Conversation of January 26 by H. Colleen Sinclair, Associate Professor of Social Psychology, Mississippi State University makes a very thoughtful analysis of the phenomenon of dangerous speech. Although it focuses on statements by politicians, the contents are relevant broadly to all similar social situations and contexts.

Defining dangerous speech as 'communication encouraging an audience to condone or inflict harm', the author adds, 'Usually this harm is directed by an "ingroup" (us) against an "outgroup".'

Prof Sinclair refers to studies made by psychologists who found that the following emotions, particularly when combined, could ignite violence:

- Anger: The speaker gives the audience reasons to be angry, often pointing out who should be held responsible for that anger.
- Contempt: The outgroup is deemed inferior to

the ingroup, and thus unworthy of respect.

 Disgust: The outgroup is described as so revolting they are undeserving of even basic humane treatment.

The author points to how, 'Commonly, outgroups are depicted as evil, due to their alleged lack of morality. Alternatively, they may be portrayed as animalistic or worse', citing the example of the Rwandan genocide, when 'Tutsis were referred to as cockroaches in Hutu propaganda'. Allusion is also made to 'competitive victimhood', which is 'used to portray the ingroup as the "real" victim'. But more ominous is, 'a particularly dangerous fabrication is when outgroups are accused of plotting against the ingroup the very deeds the ingroup is planning, if not actually committing, against the outgroup'.

Observing that 'these are just some of the hall-marks of dangerous speech identified through decades of research by historians and social scientists studying genocide, cults, intergroup conflict and propaganda', she continues that this 'is not an exhaustive list'. 'Nor do all these elements need to be present for a speech to promote harm.' Further, the writer underlines that 'the elements described above are warning signs a speech is intended to promote and justify inflicting harm' but that 'people can resist calls to violence by recognizing these themes' and 'prevention is possible'.

If we analyse what is happening locally within this framework, we will realise that it captures the challenges that we too are battling, and that we must take the cue of resisting further calls to violence. Stakeholders who are intervening in the current matters must therefore be very mindful of their language so as not to cause more tension. By the same token, the excessive focus on the 'punishment' to the person amounts to denying that it is the offence caused that led to this reaction. And here, we condemn most vehemently this act too, for it should have been left to the police and the ICTA to take the necessary action. Under no circumstances is it acceptable that people should take the law in their own hands.

By the same token, as much as Mr Sawmynaden has a right to a fair trial, the presence of political heavyweights outside the court is apt to provoke a reaction, as it did, with sympathizers mobilizing to support Mrs Kistnen who was surely the person deserving of most empathy for having been widowed in addition to her other woes.

It is time to stop this dangerous slide towards divisiveness and polarization.

## Why the West is morally bound to offer reparations for slavery

anniversary of the UN World Conference on Racism, held Durban, South Africa, in 2001, will be celebrated this August. There was much discussion at the conference about reparations to Africa for the trans-Atlantic slave trade, in which millions of Africans were captured to provide free labour in North

and South America and the Caribbean for over four and a half centuries.

Unfortunately, the conference was overshadowed by the 9/11 attacks on the US several days after it ended. The question of whether reparations should be paid to the continent of Africa for the trans-Atlantic slave trade is still being debated.

It is unlikely that former Western slave-trading countries will engage in reparative measures in the near future. The turn toward authoritarianism, xenophobia and racism in Western democracies makes it unlikely that even well-intentioned governments will propose reparations to Africa.

But, despite these political changes in slave-trading nations, there remains a strong case for why the fight for reparations shouldn't be abandoned.

#### Apology for the slave trade

A 2005 United Nations document discusses different aspects of reparations, including apologies for past harms, the right to know the truth, and financial compensation.

Over the past 15 years (following the 2005 UN report) there has been no progress on these issues, not even over the issuing of an apology.

At the 2001 conference a Dutch representative spoke of his government's "deep remorse" for the slave trade and enslavement. In 2006, British Prime Minister Tony Blair issued a statement expressing "sorrow" for the slave trade, but not apologising.

None of these amounted to an apology. Nor has the US issued one. President Bill Clinton acknowledged the horrors of the slave trade in 1998 during a visit to Uganda. But he didn't apologise. On a visit to Senegal in 2003, President George W. Bush said that the trans-Atlantic slave trade had been one of the greatest crimes in history. Again, there was no apology.

Some people might object to their government apologising for the slave trade on the grounds that neither they nor their ancestors were involved. But as the late Kenyan-American scholar Ali Mazrui argued, if you are a citizen of a country, you must take on its responsibilities as well as its benefits.

Il Mauritians know about Maa Amrita who has visited Mauritius several times and conducted yoga, prayer and meditation sessions, as well as her signature hugging sessions which last for hours altogether, at the end of which she still looks as fresh as when she started, with no sign of tiredness. Like a true Mother, she knows the children who come to her and their minds. Not only did I receive a hug, but she signalled to the devotee channelling the crowd there



and when I was leaving, the book exhibition had closed already!

How did she know which book I had selected out of the dozens of titles there? And there was no particular reason for her to have singled me out to come and sit next to her, out of the hundreds that were filing past and receiving her darshan that last but a few seconds, but leave a forever imprint in one's being.

She had read my thoughts, and that was her shakti. As Sri M, mystic and Guru explains, it is the primordial conscious energy that pervades the whole of existence. Those who can attune to it by means of rigorous and demanding spiritual discipline (sadhana) know the past, the present and the future - like Sri M himself in fact. But they don't go about showing off. #### **Power corrupts**

America which was the first constitutional democracy to wisely limit the maximum number of terms of office of US Presidents to two was bang on. There is compelling evidence that the longer a President or Prime Minister remains in power, there is a higher risk that fuelled by the trappings and heady exercise of power, standards of governance and democratic values start to be seriously watered down.

Although three quarters of sub-Saharan African countries have limitations to presidential or prime ministerial terms of office, those in power in some 13 African countries have since 2015 'sidestepped or weakened term limits', according to the US Pentagon's Africa Centre for Strategic Studies. Political dynasties or ageing politicians have ruled Cameroun, Gabon, Togo, Equatorial Guinea or Uganda over decades and are more and more intolerant towards democratic forces in their countries.

The erosion of democratic values and plummeting standards of governance in Mauritius stem from the political history of the country.

ore than 100,000 people in the UK have now died from Covid-19 - a heart-wrenching, incomprehensible figure that many experts and scientists believe to be rooted in the failures of a "reckless" government that has overseen one of the largest "avoidable" losses of lives in generations, reports The Independent.

Few ever envisioned the UK reaching such a grim milestone, yet nearly 12 months on from the beginning of the pandemic - and despite countless opportunities and warnings to take corrective action - the country stands alone with the highest daily death rate in the world. More than a quarter of all UK deaths have been reported in the last month alone, the culmination of the government's failed tier system, pre-Christmas mixing and the emergence of the new coronavirus variant, critics say.

Against this backdrop, the NHS has found itself overwhelmed by a surge of hospitalisations previously unseen throughout the pandemic. Prime Minister Boris Johnson has pledged to launch an inquiry into Britain's handling of the pandemic but insisted on Tuesday evening that "we truly did everything that we could, and continue to do everything that we can, to minimise [the] loss of life and to minimise suffering."

#### Britain and EU on the brink of 'vicious vaccine war'

Pritain and the EU stand on the brink of a vicious vaccine war, after Brussels demanded the diversion of coronavirus jabs produced in Oxford and Keele to make up for shortfalls on the continent.

Europe's health commissioner, Stella Kyriakides, sent a blunt message to pharmaceutical giant AstraZeneca (AZ) after it announced a 60 per cent cut in projected supplies for the EU, telling the Anglo-Swedish company that it was obliged to hand over doses intended for the UK. But AZ insisted that its contracts made clear that Britain had the first claim on vaccines produced domestically and said its agreement with the European Commission was based on a promise to make "best efforts" to deliver the doses, but did not commit the company to a specific timetable, reports The Independent.

Boris Johnson has so far steered clear of confrontation with the EU, dodging a question at a Downing Street press conference on Wednesday on whether he might slap an export ban on UK-produced vaccines.

## Schools in England will remain closed until 8 March

chools in England will remain closed until at least 8 March, Mr Johnson told MPs on Wednesday. The prime minister dashed the hopes of millions of parents by announcing that classrooms will not reopen to all children after the February half-term as originally planned. And, with ministers promising that schools will be the first to leave lockdown, his comments signalled that no other relaxation of social and economic restrictions can be expected in England next month.

Speaking to the House of Commons, Mr Johnson made clear that the return of

schools in the second week of March will be dependent on coronavirus hospitalisation and death rates falling and the current vaccination programme remaining on track. The prime minister pledged to set out a wider roadmap to lifting England's lockdown in the week after parliament returns from its own half-term holiday on 22 February.

#### Biden to set a new tone for the US in relationship with Russia

oe Biden called his Russian counterpart Vladimir Putin on Tuesday for the first time since taking office, pressing his fellow president on the arrest of opposition political leader Alexei Navalny, the Kremlin's alleged cyberattack last year that compromised the files of multiple US federal agencies and the Russian military's alleged bounty scheme against US troops in Afghanistan.

Mr Biden is eager to set a new tone for the US in its relationship with Russia, its Cold War adversary throughout the second half of the 20th century that has sought to undermine American democracy and re-establish itself on the world stage under Mr Putin these last two decades.

Mr Biden's predecessor, Donald Trump, routinely gave Mr Putin the benefit of the doubt - despite objections from American intelligence officials - on everything from Russian interference in the 2016 and 2020 elections, the massive 2020 SolarWinds cyber attack, the Afghan bounty scheme and Mr Navalny's poisoning last summer.

Unaccompanied child refugees will no longer be given sanctuary in the UK, the immigration minister has said - sparking claims that Britain has "turned its back" on vulnerable youngsters in need of protection.

The Dubs Amendment, passed in May 2016 by David Cameron's government in the wake of an increase in refugees arriving in Europe during the Syrian war, required ministers to relocate and support asylum-seeking children from the continent. But Chris Philp, the immigration minister, said that although the Home Office took the "responsibility for the welfare of children very seriously", there would no longer be a legal route to Britain for these minors.

The only children still able to seek help in the UK are those who have relatives in Britain, who Mr Philp said would be able to come to Britain through the existing immigration rules. Campaigners warned that the decision meant hundreds of vulnerable children would instead turn to people smuggling gangs to assist them with travelling to Britain, placing them at greater risk of trafficking.

## Poland to implement near-total ban on abortion

controversial Polish court ruling that imposes a near-total ban on abortion will come into force this week, the government said, in an announcement expected to spark major protests. "The ruling will be published in the Journal of Laws," the government information centre said on Twitter.

Poland was rocked by massive demonstrations when the Constitutional Court ruling was first issued in October. The ruling said abortions in cases of foetal abnormalities were "incompatible" with the constitution.

It means that all abortions in Poland will now be banned except in cases of rape and incest and when the mother's life or health are considered to be at risk. The ruling is in line with the policies of the governing right-wing Law and Justice party (PiS). The government said the reasoning behind the October 22 ruling would also be published.

Women's Strike, the organisation behind the demonstrations, called for a protest outside the Constitutional Court in Warsaw.

"Express your anger today as you see fit," Marta Lempart, a leading protest organiser, told a press conference. "We are calling on everyone to go into the streets," she said.

Predominantly Catholic Poland already has one of Europe's most restrictive laws on abortion.

There are fewer than 2000 legal abortions every year and women's groups estimate that an additional 200,000 women abort either illegally or abroad.

The government had delayed publishing the ruling after nationwide demonstrations held in defiance of coronavirus restrictions banning rallies.

The protests sparked by the abortion ruling soon became an expression of wider anti-government sentiment.

The biggest protests brought together tens of thousands of people in what organisers said was a generational "revolution" against the status quo, including against Poland's Catholic hierarchy.

The government has defended the verdict, saying it will halt "eugenic abortions", but human rights groups have said it would force women to carry non-viable pregnancies.

## Prepare for next pandemic like a "war": Bill Gates & Wife Melinda

Billionaire philanthropist Bill Gates has warned that the world must prepare for the next pandemic as it would for war, including the investment of tens of billions of dollars each year, in a letter released Wednesday.

'We can't afford to be caught flat-footed again," wrote the Microsoft co-founder and his wife Melinda in an annual missive.

"The threat of the next pandemic will always be hanging over our heads -unless the world takes steps to prevent it."

To avoid future destruction on the scale of that caused by Covid-19, "pandemic preparedness must be taken as seriously as we take the threat of war," Gates said, reports AFP.

"Stopping the next pandemic will require spending tens of billions of dollars per year -- a big investment, but remember that the COVID-19 pandemic is estimated to cost the world \$28 trillion," he added.

The American, ranked the thirdwealthiest person in the world by Forbes, urged rich countries to provide the bulk of the investment, pointing out that their governments stand to benefit most.

Investments in future diagnostic and vaccination technologies should be supplemented by "a global alert system, which we don't have at large scale today," allowing epidemics to be detected and responded to early, the letter said.

Gates famously sounded the alarm about the risk of global pandemics at a 2015 TED conference.

He now advocates the creation of a team of around 3000 fully trained, professional pandemic "firefighters" available on permanent alert.

Many believe the long-drawn and physically draining protests - hundreds of thousands of farmers camped out in cold and rain for two months, some 60 of them dead so far, and 11 rounds of failed talks with the government - could have resulted in growing frustration in the "young radicals" amongst them. "Maybe the radical approach was finding currency with many followers. The government also allowed the pressure to build up. After the violence the leaders have lost credibility. Their right to represent the farmers will be guestioned," KC Singh, a former diplomat, told

The farm leaders have said they will isolate the rogue elements. What is clear is that the protesters have lost considerable public goodwill and their leaders have a lot of work to do to restore it. "It has been an orderly, peaceful, lawful protest until now. If some elements have broken the peace and created a situation of anarchy, the leaders will have to do some damage resolution and rise to the challenge," says historian Mahesh Rangarajan.

## **China tells Taiwan that** independence 'means war': report



hina on Thursday intensified its ✓rhetoric directed towards Taiwan and said its independence would result in war.

Reuters reported that Chinese Defense Ministry spokesman Wu Qian was holding his monthly press conference when the subject turned to regional tensions.

Taipei accused Beijing of flying a dozen military jets in its airspace on Sunday in an act of intimidation. U.S. observers said China was intent on testing President Joe Biden, who had been sworn in just days before.

Wu said the "military activities" in the Taiwan Straits "are necessary actions to address the current security situation" there and then he warned, "Those who play with fire will burn themselves, and 'Taiwan independence' means war."

Taiwan and China separated amid civil war in 1949 and China says it is deter-

mined to bring the island under its control by force if necessary. The U.S. switched diplomatic recognition from Taipei to Beijing in 1979, but is legally required to ensure Taiwan can defend itself and the self-governing democratic island enjoys strong bipartisan support in Washington.

Secretary of State Antony Blinken, who served as then-Vice President Biden's national security advisor before being elevated to deputy secretary of state under Barack Obama, said in a confirmation hearing Tuesday: "President Trump was right in taking a tougher approach to China," said Blinken, who served as then-Vice President Biden's national security advisor before being elevated to deputy secretary of state under Barack Obama. ur interviewee this week is sociologist Sheila Bunwaree who, while despairing at the current dispensation and governance of the country, sees as a positive development the possibility that a new political group could emerge. The country is in dire strait in many respects and it only by the infusion of new blood and new ideas that we salvage it.

Searching for the Truth, for Justice and assisting the oppressed is a component of a different kind of engagement in politics, so badly needed in our society.

It is important to remember that the different layers of the Kistnen case symbolise all that is morally reprehensible with the current system. If certain politicians are shying away from denouncing these wrongs, ordinary citizens who are concerned about the Mafioso democracy that we are becoming, should not hesitate a single minute to bring their contribution for a much needed moral renaissance.

And if the Avengers' move brings in more competition to a system that remains blocked with electoral reforms apparently stalled for ever, with little possibility for greater inclusion and a diversity of ideas, a system which remains 'unfree and unfair' due to the prevalence of money politics, I cannot see any true democrat be it from the MMM or Labour Party or elsewhere unable to appreciate the significance of such competition. The latter can contribute towards getting rid of the rot. Competition can be healthy at times and can consolidate democracy.

\* The 'Avengers' might have rightly gauged the existence of a vacuum on the political front at this point in time for want of a credible alternative to the current government, and feel that with the right political message and theatrics they might make some headway in the opposition camp. What do you think?

The existence of a vacuum on the political front has certainly been gauged not only by the Avengers but a number of other groupings/new political parties, not satisfied with the way that the mainstream parties and the current regime are handling the affairs of the country. The question to ask however at this critical juncture of our history is 'what is the right political message' and 'from whose perspectives is it right or wrong?'

True, denouncing how law and order has become topsy-turvy is of utmost importance but not sufficient in these very trying times. We have some serious challenges and people want to know how you will improve their daily existential conditions, what the new normal in the post-Covid and post-Wakashio era, will look like.

#### \* Do you think it's really difficult for the Labour Party and the MMM to challenge such a 'ruling alliance'?

The latter referring to his son's leadership as 'fort', at a time when the multiple indicators of poor governance, opacity, mismanagement are systematically calling for people to take to the streets is revolting. I prefer not to comment any further on this scenario.

Anything morally wrong, false and unjust can and should be challenged. The march of 13th Feb. as well as the Avengers meeting of 31st Jan speak to this. Every single citizen who has the interest of the nation at heart should give a helping hand, especially at a time when the Speaker has hollowed out democracy by all sorts of strategies to shut the opposition out.

\* It's possible that a majority of the people are not comfortable with the government's doings and misdoings, but that remains to be ascertained. But there might also be a dichotomy between those who have already made up their minds about whom to support next time round and the others who feel they have no choice than make do with the current team. What's your take on that?

Recent studies by Afro Barometer and Kantar highlight the extent to which people are uncomfortable and

dissatisfied with the current state of governance. Talking to people on the ground also points to a similar situation. There is almost no need for any further ascertaining.

The accumulation of scandals, the injustices of the system, the lack of transparency and accountability, the differential treatment of citizens in front of the law, the different excluding mechanisms of our society disempowering the poor and vulnerable even further, imposes an obligation on us to defend the fundamental human rights of fellow citizens, particularly if we want durable peace.

Hopefully enough, the dichotomy you refer to would get smaller with at least some in the current team actually speaking to their conscience and exercise the choice of being on the right side of history. Otherwise, they may not be able to look in the eyes of their children when the latter ask them where were they when the entire nation was under siege.

\* But isn't it premature and odd to talk about an alternative to the current government, which has only completed one year in its mandate and has four more years to go?

Premature and odd? Not at all. This is a government by default. It is important to remember that only some 28% of the population voted for them.

Some people may continue to describe those who oppose this government as bad losers, but this is not a question of bad or good losers. The disgust with the government started since 2014 - when some of us could see what was being plotted. The transfer of power from father to son widely decried as illegitimate by some led to the manufacturing of PKJ – a weak leader - increasingly seen as a danger for our society in certain quarters.

The slide towards new forms of authoritarianism, surveillance and control is not auguring well. It is good that last week through the debate organised by the PMSD on the role of the DPP, we were reminded of the dangers associated with this regime especially when they wanted to bring in the Prosecution Bill. Being concerned by the erosion of democratic norms and seeing Duval's sacrifices for democracy, I can recall saluting his initiative in a press article a couple of days after he left government.

\* We were talking earlier about the Soopramanien Kistnen case and the determination of the 'Avengers' lawyers to resolve this murder case. I cannot but agree more with you that certain institutions seem to be unwilling to take the bull by the horns.

Constituency Clerk. The law is very clear regarding such cases. I certainly do not wish to substitute myself for the court nor engage in any form of contempt of court but suffice it to say that a ten-year-old kid, if informed of what the law says and if presented with all the evidence gathered so far, would not find it difficult to see what is just.

If we fail to do so, the country will enter in one of its darkest chapters.

Despite the difficulties, I believe the 3 Rs – **Resilience**, **Resolve** and desire to **Re-engineer** state-society relations by many of us will assist in the process of deciphering the truth and help in getting to the bottom of this matter. It may however take a long time!

\* As regards the St Louis Redevelopment Project being investigated by ICAC, a former Vice Prime Minister has been kept on a leash - outside of the Cabinet -, and Prof Kasenally has lately been hauled up for questioning by the anti-corruption agency. The credibility of ICAC itself has taken a hit with the long list of high profile cases which remain unresolved to date. Is there a problem therefore with the oversight such institutions that are deemed by virtue of the related legislations to function independently of political proximity?

There are far too many cases that remain unresolved, and as Transparency international Mauritius bureau's director reminds us that there is no national strategy to combat corruption. We have an arsenal of laws but enforcement remains poor. We often catch the small fish

The method of nominations at institutions such as ICAC should definitely be revisited - it can no longer be in the hands of the PM if we truly want an independent, well functioning institution.

\* All this would mean that in our present set-up a


government with a comfortable parliamentary majority can, with the support of some institutions, do as it pleases and operate in a manner that makes it almost unaccountable to anyone, isn't it?

The perversion of our current electoral system often leads to a government with a comfortable majority. Such tyranny of numbers is very unhealthy for our democracy. Comfortable majorities often mean the rise of authoritarianism, populism and the clamping down on certain fundamental rights. Yes, they can do as they please - the emergency procurements/pack and blister story during lockdown, Safe City project with millions of rupees going down the drain without ensuring our safety, the white elephant that the Cote d'Or Stadium represents - just a few examples, to show how unaccountable they can be. This cannot go on. We must stop it.

\* 2021 will no doubt be a very challenging year for the economy, for the middle and working classes and the jobless and society as a whole. It's also likely to be tough times for the government. Are you worried that our social peace might be jeopardised?

Yes, being 'une militante de paix et du développement', I am deeply worried and concerned. As you may know, I had several years back founded the Institute of Social Development and Peace. We researched and studied how exclusion in various forms could pose a threat to peace and development. And now with Covid-19, the economic crisis, the ecological crisis, and new forms of poverty arising and people competing for the few resources available, there is bound to be conflicts and violence.

This is why I referred to the necessity of reengineering state-society relations earlier and in so doing ensure more inclusion and justice for all. Without justice, there can be no peace, particularly in a multiethnic society as ours. We need to shift from what Johann Galtung calls 'negative peace' to 'positive peace' - if we want to hold the nation together in a lasting manner.

## Your gut microbiome may be linked to dementia, Parkinson's disease and MS

Our gut microbes play a key role in sending and receiving signals that influence the brain

Ithin our body and on our skin, trillions of bacteria and viruses exist as part of complex ecosystems called microbiomes. Microbiomes play an important role in human health and disease and even help us maintain a healthy metabolism and immune system. One of the most important microbiomes in our body is our gut microbiome. It helps us maintain overall wellbeing by helping us to absorb all the vitamins and minerals from the food we eat.

But when our gut microbiome's balance becomes disrupted (from things like stress, illness, or poor diet), it can not only result in digestion and gut problems, but has even been linked to obesity, diabetes, and surprisingly, brain disorders. This shows us that it might be time to look outside the skull to understand the cause of some brain conditions.

Our gut and brain are closely connected. They communicate with each other through the system known as the gut-brain (or brain-gut) axis. This axis influences the digestive system's activity and plays a role in appetite and the type of food we prefer to eat. It's made up of brain cells (neurons), hormones, and proteins that allow the brain to send messages to the gut (and vice versa).

The gut-brain axis is known to play a role in irritable bowel syndrome, celiac disease, and colitis. Stress signals from the brain can influence digestion through this axis, and the gut can also send signals that similarly influence the brain. Gut microbes appear to play a key role in sending and receiving these signals.

One way they do this is by making proteins that carry messages to the brain. The microbiome can also influence brain activity through the vagus nerve, one of the brain's 12 cranial nerve pairs. This nerve snakes through the body connecting internal organs - including the gut - to the brainstem at the base of the brain. In this way, the vagus nerve provides a physical pathway between the gut and brain, enabling a different route to the chemical pathways of the gut-brain axis for communication between brain and gut. Through this connection, an unhealthy microbiome can transmit harmful pathogens and abnormal proteins to the brain, where they may spread.

#### **Dysbiosis**

When the microbiome becomes unbalanced, the first sign is usually digestive problems - known as gut dysbiosis. Symptoms can include, intestinal inflammation, leaky gut (where the gut wall begins to weaken), constipation, diarrhoea, nausea, bloating and other gut-based metabolic changes. Immune

response and normal bodily functions such as liver, heart and kidney function may also be negatively affected by dysbiosis. Dysbiosis can be reversed depending upon cause. For example, a stomach bug or poor diet can be more easily fixed than disease a or illness such as cancer, obesity, or diabetes.

Scientists have investigated the impact of dysbiosis on different neurological disorders, including Alzheimer's, Huntington's and Parkinson's disease, and multiple sclerosis, with early research finding a link between the two. For example, researchers found that in patients with Parkinson's disease gut dysbiosis, often

as constipation, is common. Gut problems may be present several decades before typical symptoms appear, with evidence showing the microbiome is altered early in the condition. Research also shows that the mix of bacterial species present in the gut is different compared to people without the disease.

Gut dysbiosis, in the form of diarrhoea and constipation, is also associated with multiple sclerosis (MS). Researchers have found that patients with MS have a different microbiome compared to those who don't have the condition. Other research has found that patients with dementia-like conditions, including mild

cognitive impairment and Alzheimer's disease, have dysbiosis compared to those without memory problems.

All of this early research suggests a disrupted microbiome contributes to the development of neurological disorders by negatively affecting the gut-brain axis. It does this by transmitting abnormal proteins and pathogens along the vagal nerve route. However, the initial cause of microbiome disruption in those with neurological conditions is not yet known.

But on a positive note, our gut microbiome can be modified. A diet rich in fibre, limiting stress, alcohol use and smoking, exercising daily, and using a probiotic can all bolster our gut microbiome's health.

It's currently uncertain whether daily probiotic use can help prevent neurological diseases, which is something we're currently investigating. We are the first team to investigate probiotic use in Parkinson's disease patients to study their microbiome before and after use.

As our knowledge increases, microbiome-targeted therapies might present a new way of treating or minimising diseases. Probiotic use is a promising approach because there are few adverse effects, medications are likely to be better absorbed in a healthier gut environment, it's less complicated than changing your diet, and is quick and easy to implement. It s early days, and there is still much to learn, but based on current research it appears that gut microbiome health is more intimately tied to our brain health than we imagine.

## FINANCIAL SUPPORT TO SMEs FOR PAYMENT OF SALARY COMPENSATION 2021

Following Government's decision to provide financial support to Small and Medium Enterprises (SMEs) for the payment of **Salary Compensation 2021** for the months of **January** to **June 2021**, the measures mentioned below are being taken by the Mauritius Revenue Authority (MRA).

SMEs wishing to benefit from this financial support are required to apply to the MRA and this facility will be made available on the MRA website: <a href="www.mra.mu">www.mra.mu</a> shortly. After appropriate verifications of the application, the MRA will credit the bank account of the SME with the refund of the salary compensation amounting to Rs 375 for each full-time employee earning a basic wage or salary of up to Rs 50,375.

Where the SME is an Export Enterprise, the refund of the salary compensation will be **Rs 235** in respect of each full-time employee who is a Mauritian citizen. A Special Allowance of **Rs 140** will be credited directly to the bank account of these employees.

Export Enterprises are required to submit a Special Allowance Statement (SPAS) in respect of every month, on or before the 20<sup>th</sup> of that month, giving the details of:

- Mauritian employees deriving a basic wage or salary of up to Rs 50,235; and
- Expatriate employees deriving a basic wage or salary of up to Rs 10,235,

to enable the MRA to credit the applicable Special Allowance to their bank account.

SMEs including Export Enterprises benefitting from the Government Wage Assistance Scheme (GWAS) in respect of a month, are not eligible to the financial support for payment of salary compensation 2021 for that month.

For the purpose of this financial support, an SME is an enterprise whose turnover for the accounting year ended in the year 2020 did not exceed Rs 50 million.

Western slave-trading countries have a moral, if not a legal, obligation to apologise.

## A truth commission on the slave trade

One way to identify the responsibilities of former slave-trading Western states might be through a truth commission on the slave trade.


Critics might argue that such a truth commission should discuss all actors in African enslavement. About 14 million people were taken from Africa in the trans-Atlantic slave trade, but another 10 million were taken in the Arab trade.

Africans also participated in the trans-Atlantic trade and held their own slaves. The Nigerian writer Adaobi Tricia Nwaubani was shocked to learn that her great-grandfather was a slave trader, selling slaves to Cuba and Brazil after the trade was abolished by the US and Great Britain. When her great-grandfather died, six slaves were buried alive with him.

Acknowledging both Arab and African participation in enslavement, a truth commission on the slave trade could explain that internal African slavery was generally much more benign than American slavery. Enslaved people within Africa were frequently incorporated into the families of their owners. Similarly, Arab slave-owners were more likely to free enslaved children than were Western enslavers.

This type of information would counter arguments that the trans-

Atlantic slave trade was no worse than internal African slavery or Arab slavery.

In any event, the fact that other entities committed similar wrongs is not an excuse for a perpetrator state not to apologise.

#### Financial reparations

One problem in the discussion of financial reparations for the trans-Atlantic slave trade is which former slave trading and slave-holding nations might owe financial reparations to Africa. About a quarter million enslaved Africans disembarked in the US between 1626 and 1875, whereas 5.1 million disembarked in Brazil between 1401 and 1875. Does Brazil owe reparations to Africa? Or does Portugal, a slavetrading nation, owe reparations to Brazil, which was then its colony?

Similarly, do Arab countries and African slave-traders owe reparations for their part in the slave trade? The case of philosopher Anthony Appiah is instructive. He is of mixed Ashanti (Ghanaian) and British ancestry. Both his British and Ashanti ancestors traded in slaves. Do the Ashanti owe reparations to other ethnic groups within Ghana from whom they took slaves?

As with apologies, however, these questions don't absolve Western slave-trading powers of their particular responsibilities. The US, the UK, the Netherlands, France, Spain and Portugal still bear collective ethical responsibility for the wrongs their societies committed in the past.

Yet even if these countries are responsible to pay financial repa-

rations, critics might ask who should be the recipients of reparations. Yet it is now possible through genetic research and research on slave-trading ships for Western slave-trading countries to determine where the bulk of their captives originated (for example Ghana, Nigeria, Senegal or Angola). Western states could then compensate those countries.

Western critics might still ask why they should pay reparations to Africa. The trans-Atlantic slave trade ended in the mid-19th century.

In reply, some scholars and activists argue that, without the slave trade, Africa would be much more developed today. Moreover, the West could not have developed without the trans-Atlantic trade. According to this argument, Western slave-trading states should compensate African states because the West developed while Africa was actively underdeveloped.

Western countries willing to pay reparations could finance specific projects connected to the slave trade. They could donate funds to maintain African museums and historic sites of the trade. They could also fund educational programmes to study the trans-Atlantic trade, or fund a truth commission on the slave trade.

The small amounts dedicated to this type of reparation would not satisfy advocates who argue for reparations in the billions, even trillions, of dollars. But they would at least be a material acknowledgement of the harms the slave trade caused.

The question of whether aid should be part of the equation also raises a host of tricky issues. Have, as some might argue, Western countries not already compensated for the slave trade via foreign aid? And what of the misuse of aid which has been stolen by corrupt governments?

Whether reparations or aid, the same problems of mismanagement, lack of transparency, and corruption emerge.

#### Making amends

Whatever celebrations the UN organises to mark the 20th anniversary of the Durban conference, former Western slave-trading states bear moral responsibility to offer reparations to Africa.

Apologies, a truth commission on the trans-Atlantic trade, and symbolic financial compensation will not solve the problems of Africa's continued underdevelopment. But they would at last constitute an admission that the West should never have engaged in this trade. They would also be an acknowledgement of the West's responsibility to try to remedy the continued legacy of the slave trade in Africa.



#### Substance Abuse

## 4 behavioural signs your loved one may need help

When people are confronted about their substance abuse, they often underestimate how much and how often they use. If you're wondering whether a loved one - be he/she a family member or someone close to you - is struggling with substance abuse, changes in behaviour can signal something is wrong. Here are some key signs to look for when assessing a loved one's need for outside help.



#### Failure to fulfill obligations

Repeated absences from work, school, family events, and more is not like them. They're usually dependable, but now promises are broken and they can't seem to do what they say they will do.

"They repeatedly show up to social engagements inebriated or are unable to show up at all due to the level of intoxication," says Dr Kasey Nichols NMD who is trained in administering both conventional and naturopathic medicine.

#### Quick shifts in emotion

"Another behavioral sign to keep an eye on if you suspect your loved one has a substance abuse disorder is the new onset of rapid shifts in emotion for seemingly benign reasons," says Dr Nichols. "These quick shifts in emotions can be a sign your loved one is either craving the substance or experiencing withdrawal and its accompanying anxiety."

#### Denial of addictive behaviours

They refuse to acknowledge the severity of their drug dependency. They may lie about where their money went or where they spend their time.

"One sign is the person is lying a lot, making you feel as though you are crazy. The situation is turned on you," says certified alcohol and drug counsellor, Charity Collier. Research shows that when people are confronted with facts about their drinking habits, they

tend to underestimate the amount they drink, how often, and deny the impact drinking has had in their lives.

#### Isolation



According to the National Institute on Drug Abuse, when a person is abusing drugs or alcohol, they often pull away from family and friends. They spend most of their time at home and decline invitations to social outings.

.Are they more distant and reserved? Often when someone is abusing alcohol more, they spend much of their free time drinking and want to spend less with friends and family. They also might feel ashamed of this behaviour which also causes isolation.

## Here's what happens if your substance abuse goes untreated

Seeking treatment for addiction can seem like a daunting task at first, but letting substance abuse go untreated can lead to a variety of negative consequences beyond just your health.

Addiction can eventually affect all areas of life, from work to relationships to finances, causing deep and lasting damage.

"When substance abuse or addiction is not treated, it can lead to a snowball effect in one's life, including increased health problems, disability, and failure to meet major responsibilities at work, school, or home," Lisa Westerson, Senior Clinical Supervisor at Mountainside Treatment Center in Connecticut, says.

#### Long-term brain damage

The physical effects of long-term addiction include damage to major organs, including the heart, lungs, liver, kidneys and brain. Alcohol, for example, can cause symptoms that mimic those of dementia. Drugs can affect the brain's regions that control impulses, pleasure seeking, and other cognitive functions needed for daily life.

However, brain damage from drugs can be reversed. Abstaining from the addictive substance for long periods of time while sticking to treatment can eventually repair brain function.

The disease gets worse

Substance abuse is a chronic disease, and treating it like one can help with treatment. For instance, addiction can be a lifelong battle, and like other lifelong conditions, it requires a commitment to treatment and maintaining good health.

"If [an addiction] goes untreated for a long period of time, there is typically relapse and progression of the disease," Dr Joseph DeSanto, a doctor of internal medicine who is also a former addict, says. "There is a small percentage of individuals that achieve spontaneous sobriety and recovery, but these are seen less frequently because of the availability and potency of illicit and prescription drugs."

But this doesn't mean treatment isn't possible. Addiction can be managed successfully. The key is maintaining the tools you learned in treatment through support groups and counselling.

#### Relationships suffer

Substance abuse can wreak havoc on relationships. Addiction can also make other mental health conditions worse while masking them. For instance, more than a quarter of those living with addiction also have a mental health condition that needs addressing.

"People who seek addiction treatment often have characteristics of co-occurring disorders such as depres-



sion, anxiety, and trauma," Patrick Dunn, a licensed therapist and President of Recovery Services at Landmark Recovery in Kentucky, says. "All of these issues including addiction block people off from creating relationships with others."

However, treatment can mean getting to the core of these problems. A dual diagnosis can mean addressing mental health and substance use disorder at the same time.

## Advice on kicking the habit for good

Tackling a substance abuse problem can be overwhelming, but with the proper treatment it can be done. The

first step, admitting you have a problem and asking for help, is often the hardest.

"The greatest myth about addiction is that people 'struggle' with it their whole life, [but] 60% of all people entering treatment for addiction will achieve sustained remission," Brad Lander, PhD, a clinical psychologist and addiction medicine specialist in the Department of Psychiatry at The Ohio State University Wexner Medical Center, says. "This number is better than rates for other chronic diseases such as hypertension, diabetes and asthma."







## Slave Trade in Africa There is a moral obligation to assume responsibility for one

the colonies. Apparently, the first slaves in Mauritius were Tamilians from South India and Africans brought here by Dutch settlers. The biggest chunk of the slave population was purchased by the French East India Company and sold to French settlers in the island.

Brazil, the West Indian islands - Trinidad, Barbados, Jamaica, Haiti, Guyana, the Bahamas, Martinique, Guadeloupe -, and the Indian Ocean islands of Madagascar, Seychelles, Mauritius and Reunion began in the late 20th century, when colonial history and slavery were serious topics of research work and study after the Second World War opened the way for decolonization and independence movements in countries ruled by European administration. Academics and descendants of slaves finally obtained a public holiday to commemorate the abolition of slavery in various countries.

The topic of slavery was analyzed and put in the light of historical context of a period of European exploration, economic competition and expansion in far-flung areas of the globe. The purchase of captives in Africa, the conditions of transportation in slave ships, their sale in the colonies, the working conditions, cruel punishment meted out to runaways, their status as commodities to be used at the free will of slave masters, and the intellectual construct to justify slavery on the grounds of racial superiority have been widely documented, published and shown in films.

Continuous research carried out in academic circles constantly supplies much valuable information which lifts the veil and sheds light on dark areas of the infamous trade across the Atlantic and in the Indian Ocean. Memorials and statues remind today's generations of slave history. Slavery is no longer a taboo subject since 40 years; it is openly debated in

Western nations and due tribute is paid to African slaves on the commemoration day of its abolition. It is widely known that the use of war prisoners as slaves was common practice in ancient Greece and Rome, and other places in the classical era. However, the scale of African slave trade is unparalleled in the history of slavery.

#### Zanzibar slave market

Apparently, there is not much information on the native lands of former slaves in Mauritius. Judging from linguistic similarities with the Kreol spoken in Guadeloupe and Haiti, part of the slave population must have also originated from the West African coast. What is better known is the slave central market on the island of Zanzibar, a semi-autonomous part of Tanzania, of slaves brought in from Sudan, Ethiopia and Somalia.

Slavery is no longer a taboo subject since 40 years; it is openly debated in Western nations and due tribute is paid to African slaves on the commemoration day of its abolition. It is widely known that the use of war prisoners as slaves was common practice in ancient Greece and Rome, and other places in the classical era. However, the scale of African slave trade is unparalleled in the history of slavery"

centre of East African slave trade in the 17th century. Arab merchants and middlemen gathered in Zanzibar to trade raw materials, cloves and ivory. Oman settlers imported slaves to work in clove plantations in Zanzibar; captives from Sudan, Ethiopia and Somalia were shipped through the Indian Ocean to the Persian Gulf and worked in Oman, Iran, Saudi Arabia and Iraq. Europeans bought slaves from Oman merchants to work in Madagascar, Seychelles, Mauritius and Reunion, besides captives purchased in Mozambique.

#### The longest slave trade

Military conquests and expansion to North Africa, the Persian Gulf, Central and Eastern Europe created more demand for slaves. Arab merchants in Morocco went on expeditions to the European coast and kidnapped white males they encountered on the coast. Torture chambers in Morocco are testimony to the cruel punishment European males were subjected to when they rebelled against enslavement. Arabs in Eastern and Central Europe sold white slaves, including women, to the Arabian Peninsula. The growing military power of Europe put an end to expansion and white slavery. A shortage of slaves led Arabs to turn to black Africa.

Senegalese historian Tidiane N'Diaye writes about the humiliating and near-death experience slaves were subjected to. An estimated 50% died along the way owing to inhuman conditions, hunger and thirst. The brutal operation caused loss of lives, and many survivors committed suicide in despair. The trade stripped Africa of its population, altered the entire social, reproductive and economic life of black

people in a way that made it more brutal and painful than the trans-Atlantic slave trade, historian Tidiane N'Diaye writes.

#### Abolition of slavery

Slave revolts and new discourses in Europe gradually made the slave trade and slavery illegal in the 19th century: 1835 in Mauritius by the British even though the French plantocracy tried to sneak slaves into Port-Louis harbour; much later in the French colonies, and 1865 in America.

Arab countries protested against abolition of slavery. It was outlawed and suppressed in Arab lands largely due to pressure by the West, mainly Britain and France. The Sultan of Zanzibar signed the treaty in 1871, but did not enforce it until 1905. The Ottoman Empire led by Turkey outlawed slavery in 1924, Iran in 1929, Saudi Arabia and Yemen in 1962 under pressure by Britain, Oman in 1970. The African state of Mauritania was the last state to abolish it - resuming it after a first abolition in 1905, then in 1981, and ended it in 2007.

For the past decades up to now, it has been customary and convenient to blame the West. Historian Tidiane N'Diaye opines that it also is high time to talk about the past crimes of Arabs slave traders. Muammar Gaddafi, the late Libyan leader, was the only Arab statesman to have asked for forgiveness for crimes committed against Africans. Truth is a liberating factor. In brains full of make-believe narrative of a peace-and-love history, there must be room for reality and facts. There is a moral obligation to assume responsibility for one of the most inhuman trades in modern history.
