

Accountability vs. Impunity: Why Sarkozy's Sentencing Matters

ormer French President Nicolas Sarkozy was sentenced to five years in prison for criminal conspiracy in the Libyan campaign financing case yesterday. The Paris court found him guilty of criminal conspiracy over efforts to secure campaign funds from the Gaddafi regime for his successful 2007 presidential bid. The sentencing of Sarkozy is more than just a judicial footnote; it is a profound inflection point in the global narrative of political accountability. This verdict, building upon two previous convictions for corruption and illegal campaign financing, sends a clear and resounding message: no one, not even a former head of state, is above the law in a functioning democracy.

The complexity of the ruling — convicting Sarkozy on the serious charge of "criminal conspiracy" for allowing his aides to seek Libyan funds, even without conclusive proof that the money was actually used — underscores a crucial aspect of French law: the **intent** to corrupt or conspire against public trust is itself a crime. This principle is vital. It shifts the focus from merely tracking laundered cash to upholding the integrity of the democratic process, recognizing that the mere **attempt** to solicit opaque foreign funding is a profound breach of faith.

The Dark Side of Political Financing

Sarkozy's case throws a harsh spotlight on the shadowy world of political financing and what invariably comes with it: opaque deals with financiers and, in this instance, foreign regimes. Political campaigns are expensive machines, and the vast sums required often create a dangerous dependence on wealthy donors, powerful corporations, or, most alarmingly, foreign governments.

When these funds are not transparent, a corrupt bargain is struck. The transaction ceases to be a donation and becomes an investment, where the currency of exchange is not money but future policy, or regulatory leniency. These opaque deals allow powerful individuals to buy influence, effectively hijacking the democratic mandate for private (or foreign) gain. The public, whose trust and taxes fund the state, is kept in the dark about who truly holds the leash on their elected officials. This deliberate obfuscation corrodes the very foundations of public life, transforming political leadership from a public service into a commodity for sale. Sarkozy's alleged dealings with Muammar Gaddafi represent the most serious form of this corruption: exchanging a foreign leader's money for diplomatic leverage. While Sarkozy and his co-defendants, including former close associates Claude Guéant and Brice Hortefeux, will undoubtedly continue their strenuous legal battles, the court's judgment has already served its primary purpose: exposing the conspiracy to the court of public opinion.

The independence of the institutions

The French judicial system's determination to hold a former President accountable — symbolised by the judge's surprising decision that Sarkozy will face imprisonment even while appealing — stands in stark contrast to the impunity enjoyed by political leaders in many other parts of the world.

In numerous countries, particularly those with weak



democratic institutions, authoritarian regimes, or entrenched oligarchies, the political elite operate within a fortress of shielded power. Here, political leaders are often protected from prosecution by a combination of weak rule of law, compromised judicial systems, and constitutional immunity clauses designed not to facilitate governance but to protect personal enrichment.

We frequently see leaders or their henchmen in these regions amassing huge wealth while their populations toil to make ends meet. The national wealth, intended for public goods and services, is systematically diverted into private accounts, often held offshore or invested in opulent real estate abroad. When citizens dare to question or protest, the state's apparatus — police, security forces, and in some cases captured media — is used to silence them.

The difference lies in the strength and independence of the institutions — specifically, an independent judiciary and a free press. In France, a prosecutor could bring a case, judges could rule, and a sentence could be passed against a former president because the state's institutions possess a degree of autonomy and a commitment to the rule of law that transcends any single politician.

The Rise of the People's Determination

However, the tide is turning. Across the globe, there is a palpable determination of citizens to hold their leaders accountable, even where official institutions fail. Recent years have seen massive protests in some countries aimed at driving away leaders perceived as corrupt.

From the streets of Latin America to the squares of South-East Asia and Africa, populations are no longer willing to tolerate the blatant disparity where politicians flaunt ill-gotten gains while public hospitals lack basic medicines, daily living becomes a headache due to rising commodity prices and infrastructure crumbles. These are not merely economic protests; they are moral uprisings against a broken social contract. They are a rejection of the idea that political office is a licence for theft.

The energy behind these movements is often fuelled by the very transparency that corrupt leaders seek to suppress. Social media and an increasingly globalised network of investigative journalists (both official and citizenled) are making it harder for the corrupt to hide. Whistleblowers, often at immense personal risk, leak documents; databases expose offshore holdings; and citizen

monitors track the flow of public contracts. This constant surveillance — the "digital flashlight" on corruption — is providing the evidence that fuels public outrage and mobilises street action.

These protests are an essential check on power in places where legal checks have failed. They force the hand of complacent parliaments, pressure compromised judiciaries, and ultimately, they can lead to the fall of seemingly untouchable figures. While such transitions are often messy, they represent the ultimate democratic impulse: the sovereign will of the people demanding justice.

The Imperative of Transparency and Integrity

The Sarkozy verdict, therefore, is a moment for reflection. It is a powerful reminder to every political leader that accountability is not an option; it is a non-negotiable requirement of democracy.

To safeguard our political systems against the cancer of corruption, two imperatives must be met. First, there must be Mandatory Transparency in Political Financing. This means that every donation, every expenditure, and every campaign debt must be public, fully traceable, and subject to independent audit. Crucially, the loopholes that allow for dark money, shadow groups, and the exchange of "in-kind" favours must be permanently closed. Second, we must ensure Unbreakable Judicial Independence. The separation of powers must be fiercely protected, guaranteeing that judges, prosecutors, and anti-corruption agencies are granted the resources and institutional safeguards necessary to investigate and prosecute anyone, regardless of their past or present office.

The Sarkozy case, the global protests against corruption, and the relentless pressure of informed citizens are all pieces of the same puzzle. They signal a collective, global awakening to the threat that corruption poses to democratic legitimacy and social stability. The battle against impunity remains difficult and ongoing, but the principle established by the Paris court — that the law must reach the very pinnacle of power — is a profound victory. This precedent should embolden every citizen striving for a truly fair, transparent, and accountable polity.

Quelles leçons de gouvernance à tirer de la situation à la BOM?

a crise de gouvernance à la Bank of Mauritius (BOM) a connu un dénouement positif avec la démission de Rama Sithanen de son poste de gouverneur telle qu'exigée par le Premier ministre Navin Ramgoolam. La situation avait atteint un tel point de pourrissement que la crédibilité et la réputation de la Banque centrale dans le monde étaient en jeu. Il fallait désamorcer cette crise au plus vite et le Premier ministre a agi correctement. Toutefois, remettre la BOM sur les rails demande une nouvelle équipe de direction compétente avec un sens poussé de l'éthique des affaires.

En effet, la situation scandaleuse à la Banque de Maurice posait un test de leadership pour le Premier ministre. Il avait deux options: soit crever l'abcès en demandant au gouverneur de rendre son tablier, ce que tout le monde souhaitait ; soit temporiser pour laisser la tempête passer en espérant des lendemains meilleurs, ce que souhaitait une petite coterie acquise au statu quo.

Première option


En choisissant la première option, le Premier ministre a pris le taureau par les cornes pour permettre un changement salutaire à la tête de la Banque centrale, laquelle s'enlisait dans un marasme sans précèdent où se mêlaient des conflits d'intérêts, des tergiversations sur les décisions à prendre pour faire la lumière sur les largesses financières de la Mauritius Investment Corporation (MIC) et des ingérences alléguées d'une tierce partie dans les affaires internes de la banque. La Banque centrale n'avait jamais été autant discréditée dans ses annales. Pourtant, il lui fallait être prudent car le FMI, le Groupe d'Action Financière de l'OCDE et les agences de notation internationales surveillaient son évolution erratique.

S'il avait choisi la seconde option, le Premier ministre aurait permis une dégradation de la situation jusqu'à un point de non-retour qui aurait été catastrophique pour l'image du pays. L'actuelle équipe de direction de la BOM était incapable de faire son autocritique ou de changer de cap. Elle faisait montre d'un déni non-plausible des allégations de gouvernance douteuse et d'arrogance face à la critique. Elle péchait par suffisance intellectuelle en essayant de défendre l'indéfendable à travers une communication d'amateur (interview radio, communiqués officiels).

Condition nécessaire, mais pas suffisante

Si le départ de Rama Sithanen est une condition nécessaire au changement désiré, il n'est pas une condition suffisante pour assainir la situation à la BOM. Pour permettre à la BOM de prendre un nouveau départ, il faudrait remanier son conseil d'administration de fond en comble afin de lui permettre d'agir en toute indépendance par rapport aux recommandations ou décisions du gouverneur, quel qu'il soit.

Le conseil d'administration est composé de huit membres: le gouverneur, ses deux adjoints et cinq directeurs dits indépendants. Le 29 août 2025, les cinq directeurs dits indépendants du conseil d'administration



La nomination de personnes proches du pouvoir, aussi compétentes soient-elles, à la tête d'institutions stratégiques ne permet pas nécessairement une gestion efficiente, au-dessus de tout soupçon. Les conflits d'intérêt potentiels existent du fait de leur passé politique et de leur engagement récent dans les affaires. Il faut des garde-fous pour empêcher les conflits d'intérêts d'entraver une gestion saine et efficace. L'éthique personnelle des nominés, évaluée à partir de leurs antécédents professionnels ou de leur passage dans les affaires, devrait être un critère déterminant...»

ont émis un communiqué dans lequel ils ont pris parti pour le gouverneur dans le conflit qui l'opposait à son deuxième gouverneur adjoint, Gerard Sanspeur. Il est impensable qu'aucune voix au sein du conseil d'administration n'ait tenté de trouver un compromis entre les deux protagonistes.

A posteriori, on se rend compte que le communiqué émis par les cinq directeurs pour clouer le deuxième gouverneur adjoint au pilori, en solidarité avec le gouverneur, était un acte hasardeux, dépourvu de l'objectivité requise des directeurs dits indépendants. Ce communiqué avait mis le Premier ministre au pied du mur en l'obligeant de demander au deuxième gouverneur adjoint de quitter son poste.

Directeurs indépendants

Il est essentiel qu'un nouveau conseil d'administration soit constitué avec un gouverneur compétent et intègre et deux adjoints non moins compétents. Le nouveau gouverneur devrait avoir de l'expérience professionnelle, une vision de la réforme institutionnelle nécessaire, une connaissance profonde de la politique monétaire et une indépendance prouvée en matière d'analyse économique. Il est aussi crucial que les directeurs dits indépendants du conseil d'administration aient la capacité d'exercer un esprit critique, sans devoir s'aligner systématiquement sur les avis du gouverneur.

Au lendemain des élections, le gouvernement du changement avait sans doute l'obligation de se doter de conseillers et de gestionnaires a priori fiables pour assurer une transition douce dans les institutions vers un style de gestion plus adapté à l'agenda de nouveaux gouvernants. Or, cette époque transitionnelle a connu des inepties dans le processus de nomination avec pour résultat que certaines institutions ont vu un changement de tête sans aucun changement de méthode de gestion...»

En sus de la gestion de la politique monétaire qui relève des fonctions intrinsèques de la BOM, avec pour objectifs la stabilisation de la roupie et le contrôle de l'inflation, le nouveau conseil d'administration aura du pain sur la planche avec trois dossiers prioritaires.

Le premier dossier est la MIC, une filiale de la banque, dont les investissements dans des sociétés privées (Rs 49 milliards) et des actifs fonciers (Rs 8 milliards) ont subi une baisse de valeur significative pour cause de surévaluation au moment de leur acquisition. Plus que jamais, un audit judiciaire de ces investissements est nécessaire pour faire une évaluation correcte des actifs de la MIC avant de les transférer à une entité publique indépendante de la BOM, comme recommandé par le FMI.

e deuxième dossier est la banque en faillite, Silver Bank, dont les prêts toxiques de Rs 7 milliards sont un scandale sans précèdent avec des soupçons de corruption et de détournement de fonds. Une enquête rapide sur ce dossier est nécessaire pour épingler les coupables et récupérer autant que possible les fonds déboursés. Dans ce dossier, la BOM a fait preuve d'amateurisme à ce jour.

Le troisième dossier est l'état déplorable des relations industrielles marqué par la suspension d'un syndicaliste pour une cause banale. La BOM devrait privilégier le dialogue avec le syndicat des employés au lieu d'adopter une approche unilatérale et cavalière.

he Prime Minister, reacting to the police questioning and seizure of a journalist's devices (Narain Jasodanand) over allegations against the Bank of Mauritius Governor, publicly denounced the action. He claimed the incident occurred without the knowledge of the Deputy Prime Minister or the Commissioner of Police, alleging it was an act of "sabotage" by stooges from the previous regime who are trying to undermine the current government. This week's Qs & As examines the specific actions the government can legally take -- from formal disciplinary processes and mandatory transfers to the difficult task of proving misconduct/sabotage while respecting the fundamental principles of job security and political neutrality.

* At a press conference last Saturday, the Prime Minister commented on the police questioning of journalist Narain Jasodanand. The journalist had llevelled allegations against the Governor of the Bank of Mauritius and his son. The Prime Minister stated that neither the Deputy Prime Minister nor the Commissioner of Police was made aware of the action, which he claimed was an act of sabotage by "stooges" from the previous government. The Prime Minister's statement lends credence to a similar accusation made earlier by the Minister of Education, who claimed that officials in his ministry were also carrying out acts of "sabotage." If those claims are true, what course of action should the government take?

Instead of delaying action, the government should take firm and decisive steps to identify and address those officials who are allegedly impeding or sabotaging the implementation of the new administration's mandate. Allowing internal resistance, potentially driven by residual loyalties or a reluctance to shift from the previous regime's operational "culture," hinders effective governance.

If governmental decisions regarding civil servants — including postings, promotions, or disciplinary measures — are perceived to be guided primarily by political considerations, family connections, caste, or race, officials who are resisting the new policies will be emboldened to continue their uncooperative actions.

The actions of civil servants must adhere to established professional standards. As stated in the 'Code of Ethics for Civil Servants' (prepared by Mr Suresh Seeballuck):

"Ministers bear political responsibility for government policies and Public Officers have a long-established role in assisting with the development as well as implementation of such policies. The relationship between Public Officers and Ministers shall be based on mutual trust and

confidence. Public Officers shall work with their Ministers to the best of their abilities, with integrity, courtesy and respect."

The government must ensure that this professional standard of mutual trust and diligent cooperation is enforced to ensure the effective functioning of the public service.

* If the government believes a civil servant has committed misconduct, it must follow a formal disciplinary process — issuing a charge, giving the official a chance to respond, and conducting a formal inquiry. The Public Service Commission (PSC) ultimately makes the final decision on any disciplinary action, including dismissal. But that's a long and hazardous process, isn't it?

It is and it is not. The Head of the Civil Service can identify the culprits and request the Public Service Commission to take appropriate action. What causes the delay is the repeated request by the lawyers representing the civil servant before a disciplinary committee. Here, the ball would be in the camp of the members of the disciplinary committee, who should be firm.

* What is the specific legal definition of misconduct for a civil servant in this context? Does "sabotage" or "political sympathy" meet that definition?

Misconduct by a civil servant is a serious, deliberate breach of established rules, codes of conduct, or duties that negatively impacts the integrity of the public service or the public's trust. It encompasses acts like corruption, dishonesty, misuse of public resources, harassment, and gross negligence, and it can result in severe disciplinary actions, including dismissal from their position.

"Sabotage" would fall under the definition of misconduct. While the word "sabotage" may not be explicitly listed in the regulations, the act itself would constitute a severe form of misconduct. Sabotage, which involves intentionally damaging or hindering operations, directly violates several key duties of a civil servant

* Isn't it correct to state that, simply put, the government cannot easily dismiss civil servants given that the law provides job security to prevent politically motivated or arbitrary firings?

Yes, there is a security of employment for civil servants. But employment carries responsibility and obligations. In the Seeballuck 'Code of Ethics', the factors that should guide a civil servant are clearly set out.

* We presume that simply being a "sympathiser" of a previous government is not a legal ground for dismissal; the government must provide evidence of the alleged misconduct or sabotage, isn't it?

In the 'Code of Ethics', it is clearly stated that: "Whatever be their own political beliefs, Public Officers owe loyalty to the Government of the day. They should always serve the Government of the day. Public Officers should observe political neutrality in their day-to-day functions and avoid activities likely to impair, or seen to impair, their political impartiality or the political impartiality of the Civil Service. They should not, therefore, act in a way that is determined by party political considerations or use official resources for party purposes." If a civil servant cannot subscribe to this principle, either he quits or is made to quit.

* Are there any precedents where the PSC has ruled on a case of alleged politically motivated misconduct or sabotage by a civil servant?

No, not to my knowledge. But if a civil servant is believed not to be politically neutral or is sabotaging the work of the government, he must be dealt with.

The Dragon and the Elephant. Is the US-India relationship in peril?

he conventional wisdom is that China and India are adversaries. The conventional wisdom is that India is too dependent on Russia for oil and fighter aircraft. The conventional wisdom is that the US and India need each other to counter the threat posed by China. The conventional wisdom is that it is in India's and America's interest for the two countries to forge a strategic partnership to keep China from achieving overwhelming dominance in Asia and the Pacific. The conventional wisdom is that India must resist bullying by the US and therefore find rapprochement with China while maintaining a solid trading relationship with Russia. The conventional wisdom is that India must find a way to navigate this maze. Conventional wisdom is right to some extent. But the conventional wisdom may be too simplistic.

Viewing the Sino-Indian relationship from a 2024 perspective, one would hardly have expected President Xi Jinping and Prime Minister Narendra Modi to commit to strengthening strategic ties at the recent meeting of the Shanghai Cooperation Organisation. But that meeting took place against the backdrop of both countries facing significant tariffs imposed by President Trump on their exports to

the US. To be sure, China had worked a pause during which tariffs were reduced but the prospect of higher levies remained. From an Indian perspective, Trump's reasons for imposing a 50% tariff on India, viz., because it imported Russian oil and thus funded Putin's war against Ukraine and is a member of BRICS which is generally opposed to the US, seemed unfair and one-sided. After all, China too imported Russian oil. And let us not forget that the EU countries as well continued to import Russian natural gas and oil.

President Xi seemed on a charm offensive when he declared in remarks in a meeting with the Indian delegation, that China and India were among the world's great civilisations and said to Prime Minister Modi that it is vital to be good friends, a good neighbour, and for the dragon and elephant to come together.

So, are the US and India drifting apart and the China and India drifting closer together?

The steep 50% tariffs levied by Trump's executive order are a punitive threat to India's trade with its largest export partner, the US. The Indian government estimated that the tariffs will impact some \$48 billion worth of exports. Business owners and government spokespersons have fretted that exports to the US market will no longer be commercially viable. In turn, the tariffs if continued will lead to job losses and dampen economic growth.

A think tank founder, Ajay Srivastava, a former Indian trade official, was reported to have described the new tariff regime as a strategic shock that threatens to wipe out India's long-established presence in the US

And over 300,000 Indian students are studying in the United States. In fact, international students in the US come from India more than any other country in the world

ust last month, President Trump's nominee for ambassador to India, Sergio Gor, dismissed fears that India was drifting towards China. He pledged to draw India closer to the US and to open its markets to American goods. Nevertheless, he also pledged to get India to end purchases of Russian oil. That, of course, was a theme in Trump's recent address to UN General Assembly — that not only India, but China and Europe must stop purchasing Russian oil and thus funding its war against Ukraine. Perhaps India wasn't being singled out after all. And Sergio Gor told US senators, during his confirmation hearing, that India and

China had little in common and were unlikely to forge closer ties. "While we might have our moments of hiccups right now, we are on the track of resolving that. Our relationship

with the Indian government... is much warmer," said Gor.

Mr Gor said he would make it a top priority to ensure that India "is pulled in our direction, not away from us," and added that he will deepen ties on defence and technology cooperation. Elaborating, on his pledge, he committed to prioritizing deepening defence and security cooperation with India, expanding joint military exercises, advancing joint development and production of defence systems and concluding critical defence sales.

It seems that the US commitment to the Quadrilateral Security Dialogue (QUAD) comprising the United States, India Japan, and Australia remains very much in place.

Mr Gor seems to echo the sentiments expressed by Mr Blinken, then Biden's Secretary of State that: "This is a moment of unprecedented strategic alignment among our four countries. We have four countries that are united by a shared vision for a free and open, connected, a secure, a prosperous, resilient Indo-Pacific region."

So, who wins here? Does the dragon succeed in courting the elephant, or is there more to the story?

One would think that the deep penetration of the Indian diaspora in America's tech, defence, and financial businesses would predispose India to tilt to the US.

And, of course, there is the longstanding hostility between India and China, lingering border disputes and now trouble over water rights, all of which suggest that papering over the differences is a Herculean task. Are Trump's tariffs enough to push China and India closer together? Can there be a new era of cooperation between China and India?

If there is to be such cooperation, can India stand to let China dominate, unchallenged, the Indo-Pacific region? That hardly seems possible.

The recent signing of the Strategic Mutual Defence Agreement between Saudi Arabia and Pakistan with the extension of Pakistan's nuclear umbrella to Saudi Arabia may be the factor that changes everything. Although, according to CNBC, an unidentified "senior" source told that outlet that Saudi sales of oil to India would continue uninterrupted despite that agreement with Pakistan, it is difficult to predict what will happen if another India-Pakistan conflict flares up.

The dilemma for India is that it probably needs to continue buying Russian oil and thus antagonizing Trump. China is not the answer because it has no oil to sell to India. On the other hand, Trump's efforts in bringing the leaders of Armenia and Azerbaijan together in the White House, opens the possibility for the flow of Central Asian oil and gas to India as well as to Europe.

Further complicating the US-India relationship is Trump's recent announcement of a \$100,000 one-time application fee for H1-B visas, under the program that allows skilled tech workers, doctors and nurses visas to work in the US. One must think that given the provisions of Trump's Executive Order allowing for exemptions and waivers for certain companies, the H1-B fee is unlikely to survive to any meaningful extent. So, I see this as a disappearing problem.

To me, the conclusion seems clear. India and the US are too important for each other's success and security in too many ways for a dragon to drag them apart.

A Story of Land and Legacy


The Tapestry of Old Mahebourg: People, Place, and Progress

isiting the different sites of old Mahebourg, one can only imagine all the people who lived and worked there in the past. Ruins of buildings, streets, roads, canals, and a wharf remind us of African, Mozambican, and Indian slaves, White, Coloured, and Indian artisans, Indian convicts, indentured labourers, and the White and Coloured proprietors who transformed that disregarded flat piece of land from Cent Gaulettes Road to the seacoast into what became known as the town of Mahebourg. Whoever they were, one needs to give some names to this heterogeneous group of people, although we can hardly put faces to their names unless we probe deeper into family albums.

After the grid plan of the town had been mapped and the land allotted, either bought or rented to the inhabitants, land clearing by slaves enabled the first houses and buildings to emerge from the ground. Early government buildings sited at Pointe de la Colonie were functional. After 1810, the British administration not only made use of them but also added new buildings. By the 1840s, it was a quiet, small town with a buzzing commercial street, a river wharf,

The main commercial street, along Rue des Créoles. had a number of retail shops, owned by merchants such as the Decube, Gestas, Montille, Boete, Quesnel, Montille, and Fabien Rault. Shops belonging to Fayd'herbe and Adonsce were luxury shops for the elite, indicating the existence of a consumer culture. From these outlets, one can imagine women and men shopping for fabrics, hats, ribbons, and shoes for their social gatherings at Pastourel's house or for balls and receptions held at the Robillard mansion. As indentured labourers grew in numbers on sugar estates, they provided a market for Indian goods and tex-

Indian merchants and hawkers stepped in to supply the Imarket and by the mid-nineteenth century, there were already 150 little Indian shops in town, mostly run by Muslim and a few Tamil merchants. There were also two pharmacies belonging to Baillace and Etienne. At Baillace pharmacy, newspaper subscribers could collect Le Cernéen, La Balance, and the Government Gazette. When it was announced that a new publication, Le Mauricien, would appear on the 2nd of October 1833, subscribers had



to turn to Mr. Font for their copy.

On the wharf, Rochecouste, Etienne, Pastourel, Fabien, and Desmazures owned warehouses to store sugar and other agricultural produce. Goods were loaded on boats and canoes, either ferried to villages along Grand Port Bay, or sent to or received from Port-Louis for their shops. A few of the proprietors also owned boats, ferries, and coasters. The wharf would have been busy with bags of goods being loaded or unloaded by slaves while Indian sailors, living in the nearby bancasal, would be operating the different vessels.

ome of the inhabitants living in the town were Brodelet, Poulet, Avice, Keating, Suran, Cheron, and Montille. There were a few Indians from Pondichéry such as Nayna, Pitchen, Maniacara, Saveriya, and Pachimoutou. The townsfolk had built houses made of wood, usually with one storey, in the middle of a yard surrounded by gardens and trees. They cultivated some crops to feed them throughout the year and reared animals: cows. pigs. and poultry. Some used the house frontage as a shop. With the continuing development of the town, the services of several artisans and other skilled workers were required. There were masons, sailors, carpenters, wheelwrights, blacksmiths, carters, but also tailors, seamstresses, and laundresses, all of them assisted by both skilled and unskilled slaves.

The anti-slavery laws

No one could live or survive without two or three slaves. Names of some of the slaves were Alexis. Marianne. Jean Louis, Coralie, Brigitte, Jeannot, Papillon, Cécile, Felix, Désiré, and Modeste. Alexis, who failed to give a shave to Mr Robillard because he was drunk, had impudently replied to his master that he could go to Mahebourg for his shave. He was condemned to receive 25 lashes from the

In the 1830s, when the abolitionist John Jeremie was in Mauritius to implement the anti-slavery laws, slave owners opposed abolition. Volunteer corps were formed to maintain control over the slave workforce and mobilize against the British government. In Mahebourg, five inhabitants

> were arrested and imprisoned on a charge of collecting arms for an insurrection. They were Brodelet, Robillard, Keating, Fenaillet, and Grandemange from the elite class. There were several witnesses in the Grand Port case and among them were Saminaden Arlanda mason; Favori - carpenter; Ladaube - butcher; Romarin Poisson - carpenter; and Pierre Thibault - cabinet maker. In Le Cernéen were published letters and petitions to support the accused. The petitioners deplored the fact that they were lodged in prisons in Port Louis together with hundreds of slaves, among whom one was awaiting execution. A rumour that they were chained in irons was quickly dissipated so that their reputation might not sink low among their slaves.

The 1830s was a period of great expectations among slaves that they would be free.



It appears that they had become restless, increasingly defiant, and challenged orders from their owners. Proprietors regularly lodged complaints against them and they were severely punished. Le Cernéen too wrote about increasing slaves' defiance of their owners in this period, but one should guard against such depictions because it was in the interests of slave owners to exaggerate slaves' behaviour to oppose and delay emancipation. Nonetheless, it is well known that slaves always rejected their enslavement, and protests, both overt and covert, including marooning, were endemic to slavery.

here were several schools in the first half of the nineteenth century. There was a government school where George Clark was teaching. He was the one who discovered the skeletons of the Dodo at Mare aux Songes. A prize-giving day in 1854, unusually held in the Magistrate Court of Mahebourg, provides the names of pupils at school and hence the names of inhabitants of Mahebourg. The pupils were Adelcy Poisson, Aurele Poisson, J. Joseph François, David Saveriya, Honoré Fabien Rault, P. Eole Simonet, Cyril Lefevre, Canon Rasou, Arthur Avice, Evariste Michaud, Auguste Barbe, Céline Baptiste, Rosalina Poisson, Adonia Potage, Eugénie Lucile, Elmire Michaud, Élodie Rose, Héloïse Andore, and Evrestie

After the abolition of slavery, many of the ex-apprentices cultivated small gardens, turned hawkers, were selfemployed artisans, and many became fishermen, for there were a few fisheries and two of the proprietors were Aufrey and Etienne.

Indian immigrants

When Indian immigrants were first employed on Rivière la Chaux Sugar Mill is not known. But during the apprenticeship period, 1835-1839, apprentices and Indian labourers worked side by side, and later, more Indian labourers worked for Rivière la Chaux Estate, later Villeneuve and Beau Vallon sugar estates. The area extending from L'Allée Gheude to and around the Catholic Church is mostly inhabited by Indians, mostly descendants of Indian indentured labourers. With more laborers in Mahebourg and during the early sugar boom, the town attracted Indian merchants and in 1845 there were around 150 Indian shops in the town, mostly Muslim merchants and a few Tamil merchants. Names like Mamoojee, Moolna, Dustgheer, Salejee, Atchia, Haboo, Natoo, Cassim, Bahamia, Mussajee, Mahmod, together with a few Tamil merchants.

In the 1850s, the great landowners and proprietors were given new responsibilities by the government. Two planters, P. Mollieres and A. Rochecouste, formed part of the committee presided over by the local magistrate to deliver licenses for restaurants, taverns, and distilleries. They also were members of the Comité des Pauvres (Committee of the Poor).

In 1854, the country was visited by cholera, and the two most affected areas with high mortality were Port-Louis

and Mahebourg. The early cases occurred in Mahebourg

from people coming from Port Louis. In Port Louis, the Health Committee opened a new cemetery in Roche Bois. In Mahebourg, the Health Committee was presided over by Robertson and the other members were the district doctor and two inhabitants, Mollieres and Montochio. Early measures included whitewashing houses with lime, and all pigs were removed to Ville Noire.

During French rule, Catholic religion was the official religion, but the different groups freely practised their own religions, whether they were slaves or Indians. This religious pluralism was maintained by the British in the Capitulation terms signed by the inhabitants, including Indians, particularly Tamils, who were allowed to retain their customs and religion.

Religious pluralism

Taking advantage of this religious pluralism, the inhabitants built several places of worship with or without assistance from the government. In the nineteenth century, a new Catholic church was built in 1849, although Avice the Commissioner had made an appeal for subscription since 1837. There was an Anglican Church for British soldiers and a Church of Scotland. After the cholera epidemic,

which killed about hundreds of people in Mahebourg, Tamil merchants and proprietors — Sanassy, Kathan, Tasabady Chetty, Priambitaby Valaydon, and Pachimootto — appeared before notary Macquet in 1854 to buy a plot of land at Beauvallon to build a kovil (temple) to protect their village. They spelled out their objectives: to set up schools, to teach their language, to build a kovil, and to set up a solidarity fund to help those in difficulty because of diseases and epidemics and to preserve their culture and values. The kovil was completed in 1856 and in 1869, Muslim merchants built their own Mosque.



Today, Mahebourg may be the only town with places of worship for every religious and sub-religious group. It has remained a dynamic plural society as it was since its origins and almost a face-to-face society where most families know, meet, and encounter each other as they did 200 years ago.

Britain's Shrug: Talent Versus Ancestry

Other democracies place a premium on symbolism. Britain prefers pragmatism. Competence is celebrated; ancestry is waved away. It is a habit that has allowed spies to keep their pensions, plunderers to be bronzed

n October 1, Blaise Metreweli will take over as the first woman to lead Britain's Secret Intelligence Service, MI6. Whitehall is preparing to hail it as a landmark: a career officer with three decades of service, fluent in Arabic, a veteran of Middle Eastern operations, and architect of MI6's technology strategy

Yet her rise comes with a shadow. Earlier this year The Times revealed that her grandfather, Constantine Dobrowolski, was identified in German archives as a Nazi collaborator. Known as "The Butcher," he was linked to the killing of Jews and resistance fighters in the Second World

In response to my query, the Foreign, Commonwealth and Development Office offered this: "Blaise Metreweli never knew or ever met her paternal grandfather. Blaise's ancestry is characterised by conflict and division and as is the case for many with Eastern European heritage, only partially understood. It is precisely this complex heritage which has contributed to her commitment to prevent conflict and protect the British public from modern threats." That, in essence, is the official shrug.

Policymakers are not naïve. They knew the Nazi connection would surface. That they pressed ahead anyway shows how highly they value her. Metreweli is unusual among British spymasters.

She speaks Arabic fluently, and unlike many chiefs who rise through management, she spent years in operational roles across the Middle East. In an era when linguistic skills are scarce, she could run assets directly rather than through

She also broke the mould by crossing into MI5, where she ran hostile-states counter-intelligence. That role meant tackling Russian, Chinese and Iranian penetrations on home soil — an unusual crossover for an MI6 officer.

ost recently, she served as MI6's Director-General for Technology and Innovation, informally "Q." She has been credited with pulling the Service into the digital age, deve-loping tools to confront cyber intrusions and Al-driven es-pionage. In 2024 she was awarded a CMG for services to British foreign policy. Colleagues describe her as steady, professional, and scandal-free. Whitehall's calculation is clear: her skills are rare, her record is clean, and she is uniquely qualified to face the challenges of Russia, China, Iran, and Islamist networks. The ancestry is treated as a footnote.

Elsewhere the story would play differently. In Germany, the very notion of a Nazi collaborator's descendant leading the Bundesnachrichtendienst (BND) the country's foreign intelligence service, is inconceivable. The German word Vergangenheitsbewältigung — "working through the past" - describes a collective duty of remembrance.

Robert Clive was condemned in Parliament for plunder in India yet is still honoured with statues in Shrewsbury and outside the Foreign Office, while his loot is celebrated as heritage in British museums.

General Reginald Dver, architect of the Amritsar massacre in 1919, was officially censured but pensioned off comfortably after the British public raised a subscription in

William George Archer, a colonial magistrate who ordered troops to fire on unarmed student protesters in Bihar in 1942, killing seven teenagers, later returned to London as a curator at the V&A and is remembered mainly as a scholar of Indian art. The pattern is consistent: brutality abroad, rehabilitation at home. Men who presided over killings and loot returned not in disgrace but as honoured servants of the state.

> Metreweli herself cannot be blamed for her bloodline. She is not complicit in her grandfather's crimes. But ancestry carries symbolic weight. If she succeeds, she may be remembered as the first female "C," the spymaster who modernised MI6. Abroad, the risk is greater. In Berlin and Tel Aviv, the past is never just a footnote. In Washington, the CIA-bin Laden analogy would

Britain has played this game before. When Keir Starmer appointed Peter Mandelson as ambassador to Washington. he knew the baggage: the Epstein connection, the history of controversy. He judged that the pluses outweighed the ne-

or a time, the calculation seemed sound, until fresh disclosures about Epstein brought the whole appointment crashing down. Whitehall is making the same gamble with Blaise Metreweli. They know the shadow of her grandfather; they believe her record eclipses it. The risk is that, as with Mandelson, the past may yet return to demand its

What this appointment reveals is less about Metreweli herself than about Britain. Other democracies place a premium on symbolism, sometimes excessively, sometimes

Of Pensions and the Perils of Longevity

he setting is contemporary Mauritius, yet the dilemma is timeless: the clash between promised social security and grim fiscal reality. The newly elected Alliance du Changement (ADC) government, citing the financial ruin left by its predecessors, has announced a drastic pension reform, forcing citizens to work five years longer. Here, the great Athenian philosopher Socrates — a stranger to modern budgets but no stranger to virtue — finds the recently "un-retired" Cephalus, an elder raging against the tyranny of arithmetic. In this humorous dialogue, they grapple with the true meaning of justice when the cost of living long collides with the price of governance, and the pursuit of a dignified retirement is complicated by spreadsheet terrorism and the lingering scent of political profligacy.

Plutonix

Characters:

Socrates: The tireless philosopher, slightly exasperated by the modern political theatre, and still seeking to define the true nature of "justice" in an era of fiscal collapse.

Cephalus: The recently "un-retired" elder. He is deeply invested in the immediate, tangible aspects of the social contract — namely, his promised pension and the right to a comfortable nap.

Setting: A gathering in Port Louis. A massive, slightly damp protest banner reading "60 ANS, C'EST ASSEZ! — NOUS SOMMES FATIGUÉS!" flutters in the background. Cephalus is trying, and failing, to unfold a complicated government information leaflet.

Socrates: Good Cephalus! By the beard of Zeus, you look less like a serene sage basking in the afterglow of a life well-lived and more like a man who just discovered his stock portfolio is now invested entirely in a defunct dodo farm. What profound contemporary tragedy has curdled the serenity of your golden years? Is it the *quality* of the harbour coffee, perhaps?

Cephalus: (Gesturing wildly with the crumpled leaflet) Worse than coffee, Socrates. Worse than bad coffee! They have declared war on my dignity, my repose, and, most criminally, my nap schedule! The Alliance du Changement (ADC) — the very government we so recently entrusted with power, the people who promised us paradise, free WiFi, and perhaps a small unicorn — have decided that my official age of blessed, pensioned decrepitude is no longer sixty, but sixty-five! They call it a "gradual, phased implementation" over five years. I call it five extra years of being forced to wear trousers and pretend I understand email attachments.

Socrates: Ah, the Great Pension Pause. They claim it is a matter of justice — specifically, fiscal justice. They say the national treasury is lighter than a politician's promise in the wind, hollowed out by the previous regime's "huge, unsustainable expenses" and relentless "financial wastage."

Cephalus: Wastage! Yes! They funded grand, shiny projects with all the fiscal sobriety of a toddler with a bank vault key. And now, *I*, who have been a model citizen and only occasionally exceeded the speed limit, must pay for their fiscal carnival! My poor back, which has honourably supported three different Mauritian economic pillars over four decades — from the sweat of the sugar fields to the precision of textiles to the endless paperwork of offshore banking — must now prop up the national debt for five extra years! Tell me, Socrates, is it my fault that the former administration treated the public purse like an ATM with unlimited withdrawals and no



need for a receipt?

Socrates: You posit that the virtue of accountability dictates that the financial burden must fall solely upon the profligate. And a compelling point it is. But consider this, old friend: If a ship is demonstrably sinking because the previous captain drilled holes in the hull to install a lavish jacuzzi, must the current passengers refuse to bail water until the former captain has been properly tried and summarily dunked in the ocean? The state, they argue, faces an immediate crisis. The present need, they say, transcends the history of blame. And what, precisely, is their elegant *intellectual* justification for this agonizing delay?

Cephalus: (He gestures towards the official government communique with disgust) They cite "Demographic Reality," Socrates. They speak of a "rapidly ageing population" and, with a distinct lack of poetry, a "shrinking base of young taxpayers." They say people live longer now — a true miracle of science and good island air — and so the system designed for a shorter lifespan is no longer viable.

Socrates: This is where the notion of justice becomes exquisitely murky. We have a conflict between the Justice of the Past (the promised contract at sixty) and the Justice of the Future (the solvency of the state). Is it a greater injustice to the current elderly to delay their benefit by five years, or a greater injustice to the future young to demand that a small, shrinking number of them finance an ever-growing number of pensioners for an ever-increasing duration? Which generation's survival is paramount?

Cephalus: But the young must also honour the implicit "social contract" with the old! That is the very foundation of civilization, Socrates. We laboured, paid our taxes, and contributed under the promise of retirement at sixty. The trade unions are livid — and rightly so. They call this an act of "betrayal," forcing those in arduous manual labour — the fishermen, the factory workers, the bus drivers, the labourers — to work five

extra years with weary bones. They say the "standard of living" is rising, but for many, that means a higher cost of living, not a greater physical capacity to endure hard labour past sixty! For these labourers, an extra five years is not a philosophical meditation on work; it is a profound physical toll!

Socrates: An excellent point, worthy of a philosopher king's chief accountant. The contract is indeed two-sided. But if the terms of life itself — longevity, health, and crucially, the birth rate — have changed so drama-

tically since the contract was drafted, does absolute, rigid adherence to the original terms still qualify as *ultimate* justice? Or does true justice require a re-negotiation to ensure the contract itself does not become an impossible debt that crushes the very young who are meant to inherit and perpetuate the society? The system of Universality, which grants the BRP to all regardless of contribution, is now colliding with the hard wall of Sustainability.

Cephalus: I fear the young will be crushed regardless, Socrates. The public anger is not just about the principle; it is venomously exacerbated by the perception of "financial wastage" under the past rulers. When citizens see vast sums squandered on dubious projects and hear tales of corruption in the papers, they are monumentally loath to accept personal, painful sacrifice. They see the mass protest in the capital not as an exercise in democracy, but

as a necessary expulsion of pent-up economic rage!

Socrates: The method of implementation is also a stain upon their claim to justice. The Opposition Parties call the reform "undemocratic and disproportionate," pointing to the perceived "lack of public consultation" and the "rushed" manner of its implementation via the Finance Act 2025. They feel *silenced* and *coerced*. If the ADC government, despite winning a magnificent supermajority, acts in a way that is perceived as coercive and ignores the collective, established voice of the people, have they secured true authority? Or merely momentary power? Power, Cephalus, is easily acquired by the simple majority of the ballot box. But authority is secured only by persuasion and demonstrable prudence. Did they use persuasion before the act, or merely cite necessity after the fact?

Cephalus: They cited necessity and then offered a small, statistically complex olive branch: the targeted Income Support scheme for the most vulnerable between sixty and the new pension age.

Socrates: Ah, the Mitigation Measure — a political tourniquet. This is a critical detail. What is the true intent of this measure? Is it an act of genuine, philosophical compassion, or merely a cold political calculation designed to prevent a full-blown revolution? If it is truly aimed at the most vulnerable and poor, does that not elevate the reform above mere fiscal prudence to the level of social equity?

Cephalus: Perhaps. But the critics are not appeased! The original BRP, while costly, fostered a profound sense of social solidarity, Socrates. It was a birthright, a foundational assumption of simply *being Mauritian*. To introduce means-testing feels like a descent into cold, inhuman calculation, treating citizens not as co-owners of the state, but as mere fiscal liabilities to be managed and itemized on a spreadsheet by some humourless bureaucrat.

Former French president Nicolas Sarkozy sentenced to 5 years in prison in Libya campaign case

Former French President Nicolas Sarkozy on Thursday was sentenced to five years in prison after a Paris court found him guilty of conspiring criminally with Libya over illegal election campaign funding.

The court spared the 70-year-old the humiliation of being marched out of the court-room by police officers by saying that the date of his incarceration will be decided later. However, in a major surprise, the judge said that Sarkozy will be imprisoned even if he appeals, reports HT.

Sarkozy was found guilty on a key charge of acquiring illegal financing from the then-Libyan government of leader Muammar Gaddafi for his 2007 presidential campaign. He reportedly took money from Libya in a criminal association plot from 2005 to 2007 to finance his campaigns in exchange for diplomatic favours.

The Paris court cleared Sarkozy of the three other charges, including passive corruption, illegal campaign financing and concealment of the embezzlement of public funds, the Associated Press reported.

Additionally, two of Sarkozy's close associates from his presidential era, former ministers Claude Guéant and Brice Hortefeux, were also found guilty of criminal association. The men conspired to seek Libyan funding for Sarkozy's 2007 campaign, but the judges weren't convinced that the conservative leader was directly involved in the funding effort or that any Libyan money was actually used in his winning presidential campaign.

In his verdict, the chief judge said that Nicolas Sarkozy allowed his close aides to reach out to Libyan officials "to obtain or try to obtain financial support in Libya for the purpose of securing campaign financing."

The court clearly stated that it couldn't be sure that the Libyan money ended up being used in Sarkozy's campaign. It went on to



explain that, however, as per French law, a corrupt scheme can still be a crime even if money was not paid or cannot be proven.

During the hearing and sentencing, Sarkozy was also accompanied by his wife, the singer and model Carla Bruni-Sarkozy, in the courtroom.

After being elected in 2007, Nicolas Sarkozy lost his bid for reelection in 2012. He has denied all the charges levelled against him during the three-month trial earlier this year.

'Will fight until the end'

After the court's verdict, former French president Nicolas Sarkozy said the ruling poses "extremely serious" concerns about the current state of law in France. He said the Paris court's ruling undermines confidence in the French justice system. Sarkozy affirmed his "innocence", adding that he will appeal against this ruling.

Sarkozy said "this ruling means those who convicted me want to see me sleep in prison as soon as possible".

"I will fight right after until the end to prove my innocence in this affair," the former French president affirmed.

Slovakia accuses Western Europe of 'hypocrisy' on Russian gas

Slovakia's populist-led government is pushing back hard against mounting pressure from the European Union and the United States to completely halt its purchases of Russian energy, arguing that it would be economically devastating and accusing some Western European states of hypocrisy for increasing their own Russian gas imports.

Speaking on the sidelines of the UN General Assembly, Slovak Foreign Minister Juraj Blanár asserted on Wednesday that his country and its ally, Hungary, have no immediate, sustainable, or affordable alternative to Russian supplies. Blanár stated that forcing Slovakia to break contracts running until 2034 could result in a crippling loss of as much as **10 billion euros**.

The Sticking Point: Infrastructure and Cost

Slovakia, like Hungary, is heavily reliant on Russian oil and pipeline gas due to infrastruc-

ture built over decades. Both EU members have maintained political ties with Moscow despite the war in Ukraine, arguing that immediately weaning themselves off Russian supplies would be too costly and logistically impossible in the short term.

The resistance comes as the EU advances its **19th sanctions package** against Russia, aiming to phase out Russian Liquefied Natural Gas (LNG) imports by the start of 2027 — a year earlier than originally planned. Additionally, EU nations are negotiating legal proposals to end imports of all Russian fossil fuels by 2028.

However, the sanctions proposal requires unanimous backing, and both Hungary and Slovakia have threatened to oppose new energy sanctions. The current LNG ban is designed to spare them, as it does not affect the pipeline gas and oil they continue to receive.

Across the Globe -

China promises to slash emissions

Chinese leader Xi Jinping vowed to cut his country's emissions by up to 10% below their 2035 peak, taking a veiled swipe at US President Donald Trump who this week railed against renewable energy. "Green and low-carbon transition is the trend of our time," Xi said, pushing other countries to pursue renewables even if some are "acting against it."

Earlier, Trump had called climate change "the greatest con job ever," and said renewable energy was destroying Western nations. Since the start of his second term, Trump has slashed funding for green energy and boosted oil and gas production. However, China's emissions remain far greater than those of the US: Beijing's proposed 10% cut equates to roughly four times the UK's entire output.

US government risks shutdown

The US federal government will shut down next week if Congress and the White House cannot reach a budget deal by midnight Tuesday, Sept. 30, sparking recession fears. All discretionary federal spending would halt, and non-essential employees would be furloughed, although mandatory outlays such as Medicare and social security would continue.

Washington has narrowly averted several similar shutdowns in recent years, often by imposing short-term continuations, but "the two sides did not even appear to be talking," The New York Times reported. The Trump administration told agencies to prepare for a round of mass firings if funding runs out. Moody's chief economist warned that a prolonged shutdown could push the "quite vulnerable" economy into recession.



HO rejects rejects Tylenol autism link

Global health authorities rejected the US government's claim that the popular painkiller acetaminophen, better known as Tylenol in America, causes autism when taken during pregnancy. The World Health Organization said that "extensive research" had found no link between acetaminophen and autism, and recommended that pregnant women continue to follow medical advice.

Health regulators and government officials in Australia, the EU, South Africa, and the UK issued statements reassuring citizens that the drug — known as paracetamol outside North America — is safe. Acetaminophen is the only over-the-counter painkiller recommended for pregnant women; US President Donald Trump said that women should "tough it out" if they are experiencing discomfort while expecting.

US vows to help Argentine economy

Use Secretary of Treasury Scott Bessent said Washington was ready to prop up Argentina's economy, after an electoral setback for President Javier Milei's government led to investors losing confidence. "Treasury remains fully prepared to do what is necessary," Bessent said, announcing the \$20 billion package.

The move reflects US President Donald Trump's personalistic approach to foreign policy: He vowed support for Milei — an ideological ally — after a regional electoral loss for his party sent equities and the peso tumbling. Investors fear Milei will fail to secure enough congressional seats in October's legislative election to deliver on his anti-austerity agenda, which has sparked economic growth and led to the first budget surplus in decades, though spending cuts have angered many.

Kenya eves US trade deal

enyan President William Ruto said he expected to sign a trade agreement with the US before the end of the year, as he looks for a reprieve from Washington's punishing tariffs. Ruto also vowed to pursue a five-year extension of the African Growth and Opportunity Act — a 25-year-old free-trade agreement between sub-Saharan Africa and the US — in a meeting with the American secretary of state.

Though the region's trade reliance on Washington has rapidly diminished as China has become its biggest market, several nations still rely on the US for a large share of their exports, the loss of which would put millions of livelihoods at risk.



EU may scrap cookie law

The European Commission wants to change the cookie pop-up law that has hounded web users for the last 16 years. Cookies allow websites to store information about users, such as whether they've logged in before, or what they viewed. The 2009 ePrivacy directive requires websites to let users opt out of all but "strictly necessary" cookies, which in practice means that consent banners appear every time a user accesses a new website and are usually clicked away without thought.

Brussels wants to reduce the burden of red tape on its businesses, and cookies are a focal point of those plans, Politico reported: One possible workaround would be letting people set their cookie preferences once, for example in their browser settings.

Russia's economy shows cracks

Russia will raise its value-added tax rate to 22%, an indication the Ukraine war is dragging on its economy. President Vladimir Putin had pledged not to raise taxes before 2030, but spiraling military and security expenditure — and reduced income from oil thanks to sanctions and Ukrainian drone attacks on refineries — have hit Moscow's exchequer.

US President Donald Trump said this week that Russia was in "big financial trouble," which Moscow dismissed, but the budget deficit is expected to reach 2.6% for the full year, against an expected shortfall of 0.5%. Economic growth is also slowing, with

official forecasts falling from 2.5% to 1% for this year.

Taiwan plays export geopolitics

Taiwan briefly imposed controls on semiconductor exports to South Africa in an attempt to use its global chip dominance as a geopolitical tool, sparking a row with China. South Africa had moved Taiwan's de facto embassy from Pretoria to Johannesburg to placate Beijing, a symbolic downgrade that angered Taipei. Beijing does not recognize Taiwan's independence and uses its economic and diplomatic might to discourage others from doing so too.

Taipei has long used its chip industry as "a shield from Chinese aggression," Bloomberg reported, but this represented its first use as a "diplomatic sword." Beijing said the decision would backfire, and Taiwan backed down after two days, suggesting it was uncomfortable weaponizing its exports, Bloomberg said.

Zelenskyy warns of new arms race

Tkrainian President Volodymyr Zelenskyy called on allies to send more arms to defend his country against Russia, saying "the only guarantee of security is friends and weapons." Addressing leaders at the UN General Assembly Wednesday, Zelenskyy appeared to echo US President Donald Trump's criticism of international organizations' peace efforts, saying they are "too weak" to stop global conflicts.



In his call to arms, Zelenskyy also raised concerns about Al-driven warfare and blamed Russia for spurring the "most destructive arms race in human history." Zelenskyy's speech came a day after Trump suggested Ukraine can win the war, but it's unclear whether the US president will back that rhetoric up "with money and materiel," The Atlantic wrote. "Until then, it's just talk."

'Triple sabotage': Trump calls for arrest over 'sinister' tech glitches at UN

S President Donald Trump has called for an investigation into three "sinister events" at the United Nations headquarters, describing them as a "triple sabotage" during his visit to the UN General Assembly on Tuesday.

The incidents, which included a stalled escalator, a malfunctioning teleprompter, and sound issues in the Assembly hall, were highlighted by Trump as deliberate attempts to undermine his appearance, reports HT.

In a post on Truth Social on Wednesday, Trump said the UN should be "ashamed" of itself. "A REAL DISGRACE took place at the United Nations yesterday — Not one, not two, but three very sinister events!" he wrote.

The first incident occurred when the escalator leading to the main speaking floor came to a "screeching halt" shortly after he and First Lady Melania Trump stepped onto it.

"It stopped on a dime. It's amazing that Melania and I didn't fall forward onto the sharp edges of these steel steps, face first. It was only that we were each holding the handrail tightly or, it would have been a disaster. This was absolutely sabotage," Trump said, adding that those responsible should be arrested.

As he began his address to the 80th UN General Assembly session, the teleprompter failed. "Then, as I stood before a television crowd of millions of people all over the world, and important leaders in the Hall, my teleprompter didn't work. It was stone cold dark. I immediately thought to myself, 'Wow, first the escalator event, and now a bad teleprompter. What kind



of a place is this?" he said.

Trump delivered a 57-minute speech without the teleprompter, which resumed functioning about 15 minutes later.

"The good news is the speech has gotten fantastic reviews. Maybe they appreciated the fact that very few people could have done what I did," he added.

The third issue, according to Trump, was that the sound system in the UN General Assembly hall was allegedly off after his speech, preventing world leaders from hearing him unless they used interpreters' earpieces.

"The first person I saw at the conclusion of the speech was Melania, who was sitting right up front. I said, 'How did I do?' And she said, 'I couldn't hear a word you said,'" Trump said.

Trump said that the three incidents were not coincidental, calling them a "triple sabotage at the UN." He said he had sent a letter to the UN Secretary-General demanding an immediate investigation and asked that "all security tapes at the escalator should be saved, especially the emergency stop button. The Secret Service is involved."

Syria redefines itself on world stage

Syria's president hailed his country's return to the global stage, in the first UN speech by a Syrian head of state since 1967. Ahmed al-Sharaa's address Wednesday, nine months after he led a faction of rebels that toppled the government of Bashar al-Assad, reflected Damascus' desire to redefine itself to the international community, much of which

has long associated the country with war and oppression.

Sharaa called on countries to help develop Syria's economy, but despite

his diplomatic efforts, his past as an al-Qaida fighter has "fueled questions about what he truly believes," The New



York Times wrote: Sharaa has the backing of Washington, but ongoing sectarian violence has posed a challenge for his young government.

ast week, I suggested that the economy of Mauritius needed diversification if the national income was to be maintained. I also suggested that a very real help to such diversification would be the setting up of a Development Board with certain statutory duties: to stimulate, facilitate, and undertake the development of industry and of agricultural undertakings or projects not already sufficiently well established (including the tourist hotel industry). The main objectives of such a Development Board would be to increase employment prospects within Mauritius and to improve the external balance of trade by expanding the production of locally made goods and foods. In the initial stages, three lines of approach would appear to be indicated: expansion of existing local industries, encouragement of new local industries, and stimulation of investment from overseas.

Economic development requires the best possible use of the three factors of production — labour, raw materials, and finance. In Mauritius, there is a surplus supply of (mostly lowgrade) unskilled labour, a paucity of raw materials except clay and coral sand (which could, in certain circumstances, be used as the raw materials for a cement industry), but a good supply of agricultural land, and a considerable amount of capital investment concentrated mainly in the mono-crop sugar. That means Mauritius exhibits all the phenomena of a plantation economy. The absence of minerals has prevented the building up of a manufacturing industry, and the price of land has so soared as to make any considerable expansion into crops other than cane impracticable (without fully subsidised agriculture). Cane alone employs a large labour force, besides being suited to local conditions and yielding a high return per arpent. In any case, historical accident made Mauritius a producer of basic raw material to be exported to the colonial power in exchange for consumer goods and capital equipment. In other words, the philosophy of co-Ionialism in the nineteenth century exploited Mauritius, and the present-day economy is an unhappy hangover from those days.

The small secondary industries which have grown up have done so in spite of the economic system, not because of it. To manufacture a local product to replace the imported article cut directly at the interest of the importer, who had previously drawn his commission on importing a branded product with an assured sale and was now asked to handle a local product of unproved quality and problematical demand. Nonetheless, vested interests of importers must not be allowed to stand in the way of economic development. The whole is greater than the part; the economic well-being of Mauritius is more important than the private profit of a few importers. How can the economic position be improved? Professor Arthur Lewis, whose advice has often been sought in and by colonial territories, says that if there are metallic ores, then try and develop heavy industry. Otherwise, such development is impossible except uneconomically. Alternatively, try and develop secondary industries based on processing any raw materials or natural produce found locally; or try and produce consumer goods, relying on a plentiful supply of local hand labour to outweigh the cost of importing the raw materials in whole or in part. Any type of industry could be encouraged which can absorb a high percentage of labour


cost in the finished article, or in which the products are very bulky and so incur heavy freight charges in relation to total

The attack on the balance of payments can be two-pronged. Local or imported raw materials can be fabricated and exported in order to earn revenue; or the products can be sold locally (even if made from imported raw materials) in order to reduce import costs. (Clearly, raw materials would cost less than manufactured goods so that the balance of payments, put in very simplified terms, would be reduced by at least the amount of the labour cost in the manufactured imports.) Ideally, the effort should be directed at building up an export industry; but the second prong of the attack should not be neglected, provided that the locally-made product is at least as good as the imported product and costs less rather than more.

It has been established in the Caribbean that industry which is highly capitalised needs fewer workers but pays higher wages per worker. Low capitalisation is concomitant with large working staffs but lower wages per worker. Thus, a soft drinks factory employing 50 workers had a capital cost of £70,000 — that is, capitalisation of £1,400 per worker. Against this, a mixed citrus and banana plantation employing 200 workers had a capital cost of £74,000 (capitalisation of £370 per worker) and paid average annual wages of only £93 per worker. A raw sugar factory would call for capitalisation of £8,500 per worker, with correspondingly higher wages per worker.

A cement factory in Mauritius would need high initial capitalisation per worker, and the wages would therefore tend to be high. If there is continued disinclination to utilise the existing clay and coral sand (plus bagasse ash) for cement manufacture, then the local clay could well be used to manufacture hollow clay blocks and other domestic building products. Coral sand could have a building use; certainly, coral block can be utilised in certain types of constructional and foundation work. Fishing, like the fishing industry of many another colony (e.g., Barbados, Fiji, Seychelles), is at present under-capitalised and under-organised. Has every effort been made to utilise sugar by-products in the most efficient manner possible?

And, given efficient production and distribution, there is no reason why market gardening and fruit farming should not be so developed that import of vegetables and fruit could virtually cease. Market gardening is essentially a small man's business, but the actual marketing of fruit and vegetables calls for a marketing cooperative or a marketing board (the one arising from the growers' own initiative, the other from government sponsoring). If the yield of sugar per arpent continues to increase, there is every reason to believe that the export quotas under the Commonwealth Sugar Agreement

could be met from the estates; thus, the land at present farmed by the small planters and *métayers* could be released from sugar and turned over to market gardening — unless the small planters and *métayers* grew sugar under an internal quota system, so that some of the estate lands became free for market gardening.

A Development Board could assist all such undertakings; it could also assist the establishment of secondary manufacturing plants relying on imported raw materials. Barbados and Malta, which are like Mauritius in that they are small, overcrowded islands, have each established a Development Board in the recent past. In its first year of operation, the Barbados Board provided capital for a new printing works, mechanisation of a limestone quarry, establishment of a frozen fish processing plant, mechanisation of a furniture works, the buying of a new packaging plant for a confectionery works (confectionery ought to be made in Mauritius), set up a shoe factory, and expansion of a plant for the manufacture of acetylene gas. In later months, the Board has materially assisted the development of the tourist hotel industry.

In Malta, the Aids to Industry Board has launched a drive in the last six months to attract new industries; new factories at low rentals, tax concessions, and grants are among the inducements to set up in Malta. Nine firms are already going ahead; they include a cotton mill to employ 500 and a car assembly plant to employ 250. Another eleven applications are under consideration by the Aids to Industry Board, including projects varying from plastics, clothing and knitwear to the propagation of plant cuttings. Reviewing the success of the Board's campaign recently, *The Times* said that the great attraction of the island to industrialists was presumably "a source of abundant and relatively cheap labour."

Africa, and the Middle East, while Barbados can catch the American market, and Mauritius is more remote. But Hong Kong is far from the markets to which it exports great quantities of clothing, and Japan can compete with the European market in Europe itself. There is no reason why Mauritius cannot compete on the world market despite its comparative remoteness from centres of population; and development of the tourist industry can be aimed at capturing some of the East, South, or Central African tourists.

But private enterprise in Mauritius seems to lack initiative; in fact, it is rather private unenterprise! Given that lack of energy and initiative, the only alternative is for a Government Development Board to be set up, charged with the statutory duties outlined at the beginning of this article. And it should be set up under the managership of an energetic person who realises the importance and vital urgency of economic development and diversification in Mauritius.

In Guyana, there is an Integrity Commission Act that makes it a legal offence to disobey the Civil Servants' Code of Conduct. Such an act in Mauritius would be a significant step toward strengthening public accountability and fighting corruption by clearly defining misconduct as an offence and establishing an independent body to enforce ethical standards.

* What are the legal limits on the government's power to "clean up" the civil service?

The government cannot clean up the civil service whole-sale. The work of the State must continue irrespective of the political allegiance of civil servants. Recently, the Head of the Civil Service, Mr C. Seeballuck, reminded all civil servants of their obligations and duties. This is a good move.

However, he should go further by holding regular meetings with civil servants in each ministry to personally reinforce the Code of Ethics. Crucially, every civil servant must be provided with a copy of the Code. Furthermore, the Permanent

Secretary of each ministry must be held accountable for ensuring their officials consistently maintain professional and ethical standards.

* Could a civil servant who is disciplined or fired on these grounds successfully sue the government for wrongful termination? What would be the legal basis for their claim?

A civil servant may apply to the Supreme Court for a judicial review. Such applications are, however, rarely successful. The Court will not interfere with findings of fact made by the original decision-maker. Instead, the Court's role is to ensure that the decision-making process itself is not flawed — specifically, by determining whether the proper proce-

dure was followed and the rights of the civil servant were respected.

* Besides formal disciplinary action, are there any other legal tools or mechanisms the government could use to address this issue? For example, can an official be reassigned or transferred against their will?

Yes. The Head of the Civil Service (or the competent appointing authority) generally holds the legal power to transfer or reassign a civil servant without their consent. This mechanism is a common administrative tool and is a valid legal means to address various issues, including operational necessity, professional development, and even internal friction.

Alibaba makes superintelligence push



libaba unveiled plans to ramp up Al spending past its previous target of \$50 billion, sending its shares soaring on Wednesday. The Chinese tech giant joins other global firms in pledging eye-watering sums toward Al develop-

ment, aimed at supercharging advancements and providing enough power to meet demand. The Al drive by Alibaba and peers like Baidu could reignite foreign investor interest in the sector after years of retreat from China, Bloomberg wrote.

In a rare turn for Chinese tech, Alibaba is leaning heavily into superintelligence — a hypothetical AI system surpassing human intellect — mirroring efforts by US firms like OpenAI

and Meta. It indicated "a remarkable departure from the cautious, instrumentalist rhetoric that has dominated Chinese tech discourse," one China tech commentator wrote.

Yet, I grant you, you make a strong, irritatingly logical case for focusing limited resources on the truly needy. It is a terrifying paradox: The just principle of universality appears to be the ultimate engine of injustice for the future. I understand the complexity now, Socrates. Justice in the public sphere is not merely a simple, abstract transaction of debt and due, but a continuous, high-stakes calculation of intergenerational equity, fiscal necessity, and the fragile restoration of public faith.

(Cephalus suddenly brightens, a mischievous, politically charged glint in his eye.)

Cephalus (Cont.): I think we should therefore seriously think of campaigning to retire our politicians at 65 years — in line with what they are themselves proposing to the people! If they decree that sustained, difficult labour for the masses must extend to sixty-five for the good of the nation, then should not the sustained, difficult *management* of the nation require the same standard? Wouldn't that, Socrates, amount

Volcano erased an island's plants: DNA reveals how life starts over



Scientists from Tokyo Metropolitan University have unlocked new insights into how life takes root in freshly devastated landscapes.

By tracing the genetic lineage of a now-extinct plant population on Nishinoshima, a volcanic island repeatedly wiped clean by eruptions, researchers examined DNA from common purslane collected just before a 2019 eruption. They found that the plants were closely linked to populations from nearby Chichijima Island, but also bore unique

traits caused by a "founder's effect," where a handful of seeds carried by wind or birds shaped the entire gene pool.

The study offers a rare, timelapse look at colonization dynamics in isolated ecosystems, revealing how chance events, seed dispersal, and volcanic resets interact to guide early plant evolution. Understanding this process not only enriches ecology but could help inform restoration projects on other fragile islands and volcanic zones.

Guava's secret molecule could fight liver cancer

Chemists at the University of Delaware have made an important breakthrough in the fight against liver cancer by developing a cost-effective way to synthesize complex molecules found in guava plants.

Using advanced techniques in natural product total synthesis, Professor William Chain's team designed a scalable pathway to reproduce compounds that target hepatocellular carcinoma, one of the deadliest forms of cancer worldwide. Their research, published in Angewandte Chemie, highlights how plant-derived chemicals can be turned into affordable treatments when sophisticated laboratory methods make them accessible at scale.

With more than 42,000 U.S. diagnoses projected for 2025 and survival rates below 15% for



advanced cases, this innovation may spur further global collaborations to transform natural compounds into life-saving therapies. Future work aims to optimize these molecules for clinical testing, potentially opening new horizons for precision cancer medicine.

Sleepless nights may raise dementia risk by 40%, Mayo Clinic reveals

Chronic insomnia could accelerate brain aging and significantly heighten dementia risk, according to new research from the Mayo Clinic published in Neurology. Following over 2,700 older adults for an average of 5.6 years, scientists discovered that participants reporting persistent difficulty falling or staying asleep experienced

faster declines in memory, problem-solving, and reasoning skills. Brain imaging showed more amyloid plaques and white matter damage among poor sleepers, hallmarks of Alzheimer's and other dementias

The study underscores how restorative sleep is not just a luxury but a cornerstone of cognitive health. Researchers recommend that anyone struggling with long-term sleep problems seek professional help, as therapies ranging from behavioral strategies to targeted medications could help preserve brain function and quality of life as people age.



Why do we dream?

Why scientists still can't agree what dreams are for.

Think about it: how easy do you find it to remember your dreams every night? Not everyone can do this. If we can't remember our dreams, we can't study them.

Some ancient cultures like the Egyptians, the Greeks and the Romans believed that dreams were important messages from the gods. But even they could not agree about exactly where dreams come from, why they happen or what they might mean.

In the last 100 years, many scientists across the world have learned a lot about the science of dreaming. But even still, there is disagreement.

Some scientists think dreams have an important job, others do not. I'll explain some of the most well-known ideas.

Around the year 1900, an Austrian psychologist (someone who studies how we think) called Sigmund Freud published an influential book called The Interpretation of Dreams. In it, Freud wrote about his experiences of talking to other people about their dreams (and his own dreams too).

He believed that dreams came from wishes or desires buried deep in the mind. He thought these wishes were usually transformed in some way to disguise them in the dream, as they could be quite scary or rude.

Freud would help people to work out what these hidden wishes and desires

might be, so they could address them in waking life. He also wrote that dreams are a part of the process that helps keep us asleep, that dreams protect sleep from disturbances. And there is some evidence to support that idea.

Freud's ideas had a great influence on thinking about dreams for many decades. But since Freud's time, we have learned much more about how sleep works. And that has inspired new ideas about what dreams might (or might not) be doing.

In the 1970s, scientists like Allan Hobson started to reject Freud's ideas about dreams, and suggested that perhaps dreams don't do anything important. In Hobson's view, dreams had no hidden meaning or function to them.

He thought they might just be random side-effects of chemical processes going on in the brain during sleep. It is one good explanation for why dreams often seem so strange. Hobson thought little bits and pieces of knowledge and imagination get activated and merge together meaninglessly.

But other scientists since then have noticed that not all dreams are strange. Many of them are in fact quite ordinary, and some have content that is important to the dreamer.

Perhaps you have dreamed about something that happened in your life recently, like a fun day out with your school friends or family, or maybe you



dreamed you were in a film you watched the day before.

We often dream about things that had a significant effect on us in waking life, or are related to worries we carry with us. And this I think is the most important thing we need to realise: our dreams are connected with our waking lives.

Some scientists now believe that dreaming about these things might help us to process them, or give us new ideas about what to do in our waking life. This is still difficult to test though. Whether or not this is what dreams are really doing by themselves, you have the choice to look at your dreams and decide what new ideas you can draw from them.

Another interesting idea is that dreams evolved long ago to help us survive threats. A lot of people seem to report dreaming about being chased by monsters or dangerous animals. Maybe you have too.

Some scientists see this as evidence for a threat simulation system that emerged back when we were living in caves and had to hunt for our food while trying not to be hunted ourselves.

If we survive a threatening encounter in a dream, that could better prepare us for surviving real threats when we are awake. The problem with this idea though is that it is too dangerous to test properly.

Even if someone dreams about fighting a tiger, for example, scientists cannot then lock people in a cage with a real tiger and see how well they survive!

That's one of the exciting things about being a scientist. There are still lots of questions to answer and we're learning new things all the time.

She hands me her card and asked for the rate. I tell her: "\$125."


She blinks. "Why is it less than the first room?"

14 Common Cancers and How to Spot Them

Most people are aware of someone in their family who has been diagnosed with cancer. The sooner doctors find cancer, the sooner treatment can begin. Therefore, it is helpful to be familiar with the most common types of cancer and their warning signs.

There are more than 100 types of cancer, and some are more common than others, depending on factors such as age, gender, and racial or ethnic group. For instance, prostate cancer exclusively affects men, while breast cancer is significantly more prevalent in women. It is important to remember that many cancers do not have symptoms in their early stages. If you do experience symptoms, they could also be indicators of other conditions, so you will need to undergo tests to determine the cause.

Here are 14 of the most common types of cancer and their potential warning signs.

1. Non-melanoma Skin Cancer


Non-melanoma skin cancer, which includes basal cell carcinoma and squamous cell carcinoma, is the most common form of cancer, affecting over a million Americans annually. The exact number of new cases each year is not clear because doctors can often treat it in their offices without reporting the cases to cancer registries.

- Basal Cell Carcinoma Signs: Sores that do not heal, or heal and then reappear; raised, scaly red patches; small, shiny, smooth lumps that are pink, red, or white; pale, flat areas of skin that look like scars; sores or growths that bleed, itch, or have small blood vessels on their surface; pink growths with raised edges or indents. Basal cell carcinoma is most likely to develop on the head, face, neck, and torso.
- Squamous Cell Carcinoma Signs: Scaly, red patches with uneven borders; wart-like growths; sores that bleed easily, do not heal, or form a crust that does not go away; growths that are itchy, irritated, or painful. This type of cancer usually forms on areas of the body that have been repeatedly exposed to sunlight, such as the face.

2. Breast Cancer

 Signs: A new lump or mass in the breast, armpit, or around the collarbone (most lumps are painless, but some may be painful or tender); swelling, irritation, or dimpling of the skin on the breast (which may cause the skin to look like an orange peel); thickening, redness, or scaliness of the skin on the breast; pain in the breast or nipple; nipple discharge that is not breast milk; nipple retraction (a nipple that is "dented" or turned inward).

3. Lung Cancer



 Signs: A persistent cough that does not go away and worsens over time; coughing up blood; wheezing or shortness of breath; constant chest pain; bone pain; hoarseness or other voice changes; regular lung infections; unexplained weight loss; loss of appetite; frequent headaches; blood clots. Lung cancer often does not cause symptoms until it is in advanced stages because the lungs have few nerve endings.

4. Prostate Cancer

• Signs: Problems with urination, such as trouble starting or holding back urination, leaking, interrupted flow of urine, or a sudden uncontrollable urge to urinate; pain or burning sensation during urination; frequent need to urinate, especially at night; difficulty getting or keeping an erection; changes in ejaculation, such as pain or a decrease in the amount of fluid ejaculated; blood in the urine or ejaculation fluid; pain in the lower back, thighs, hips, or pelvic area; pressure or pain in the rectum. Prostate cancer does not typically cause early warning signs.

5. Colon and Rectal Cancers (Colorectal Cancers)

• Signs: Unexplained weight loss; weakness and exhaustion; changes in bowel habits (like constipation, diarrhea, or narrow stool) that last for more than a few days; abdominal or gut pain that comes and goes but lasts for more than a few days; pressure in the rectum or abdomen (which might feel like a constant need to have a bowel movement); blood in the stool (which may look dark red or black); rectal bleeding (which may appear as bright red blood on toilet paper).

6. Melanoma

 Signs: A mole or mark on the skin that is asymmetrical, with uneven, scalloped, or notched edges; a mole or freckle that has a variety of colors (such as brown, black, white, red, pink, or blue); a mole that is larger than the tip of a pencil eraser; a mole or mark that is growing quickly or has changed color or shape; a mole or mark that is bleeding, itching, or crusting.

7. Bladder Cancer

· Signs: Blood in the urine (the first and most

common sign); changes in urination, such as difficulty urinating, a weak urine stream, pain during urination, or being unable to urinate.

8. Non-Hodgkin's Lymphoma

 Signs: Enlarged lymph nodes (which may feel like lumps under the skin); unexplained weight loss; con stant weakness or fatigue; chills, fever, or night sweats; a swollen abdomen; feeling full after eating only a small amount; shortness of breath or a persistent cough; pain or pressure in the chest; a severe or regular infections; easy bruising or bleeding.

9. Kidney Cancer

 Signs: Blood in the urine; pain in one side of the lower back that is not caused by an injury; a lump on one side of the lower back; constant fatigue; low appetite; unexplained weight loss; a persistent fever; anemia.

10. Leukemia

 Signs: Fever, chills, or night sweats; exhaustion or weakness; unexplained weight loss; swollen lymph nodes; an enlarged liver or spleen; frequent nose bleeds; easy bleeding or bruising; tiny red spots on the skin called petechiae; bone pain.

11. Pancreatic Cancer

 Signs: Unexplained weight loss; pain in the upper abdomen that may radiate to the back; depression; blood clots; developing diabetes; exhaustion or weakness; yellowing of the skin and the whites of the eyes (jaundice). Pancreatic cancer often does not cause signs until the disease is advanced.

12. Thyroid Cancer

• **Signs:** A lump or swelling in the front of the neck; pain in the front of the neck that may radiate up to the ears; trouble swallowing or breathing; persistent voice changes, like hoarseness; a constant cough.

13. Liver Cancer

• Signs: Unexplained weight loss; lack of appetite or feeling very full after eating a small amount; nausea or vomiting; an enlarged liver or spleen; pain in the gut or near the right shoulder blade; a swollen abdomen; unexplained skin itching; yellowing of the skin and the whites of the eyes (jaundice); abnormal bruising or bleeding; fever; enlarged veins on the belly; lightheadedness or fainting; weakness or confusion; constipation.

14. Endometrial Cancer

Endometrial cancer is a type of uterine cancer that affects the lining of the uterus.

Signs: Abnormal vaginal bleeding, such as bleeding between periods or after menopause; abnormal vaginal discharge; pain or pressure in the pelvic area; unexplained weight loss.

Bollywood Fights Back: Stars Demand Personality Rights Amid Deepfake Surge



India's top Bollywood celebrities are taking a stand to legally shield their identities against commercial misuse and the growing threat of deepfakes. In recent weeks, major figures like director Karan Johar, and actors Aishwarya Rai Bachchan and Abhishek Bachchan have petitioned the Delhi High Court to protect their "personality rights," also known as publicity rights, reports BBC.

These rights grant an individual commercial control over their unique persona, including their name, image, voice, mannerisms, and catchphrases. However, India lacks a dedicated statute for this, forcing judges to rely on common law and judicial precedent — a system experts say is insufficient compared to codified laws in the US and Europe.

This legal fight isn't new. It traces back to a landmark 2002 ruling where singer Daler Mehndi successfully sued over unauthorized dolls made in his likeness. More recently, actor Anil Kapoor sued to protect his voice and the catchphrase "jhakaas," while Jackie Shroff won protection for his image and nicknames.

The Need for Codification

Despite these victories, the reliance on common law presents major challenges. Legal experts argue that codifying personality rights would provide clarity and consistency.

Crucially, it could address the issue of heritability. Currently, Indian courts link personality rights to the constitutional right to privacy, which is deemed to die with the individual. This was highlighted in 2021 when the father of the late actor Sushant Singh Rajput was unable to stop a film based on his son's life, as the court ruled the right to publicity was not heritable.

Codified law could also integrate clauses for compensation and damages, acting as a stronger deterrent than current measures, which can often only stop the material's circulation after reputational and financial harm is already done.

The Al Threat

The urgency for stronger legal safeguards is amplified by technology. With generative AI creating realistic deepfakes and the recent use of a celebrity's voice by a major AI model, laws are struggling to keep up. While some argue that an uncodified system allows for greater judicial interpretation, others insist that the complexity of modern technology demands clear, statutory definitions.



Ultimately, while the courts offer some recourse, experts agree that increased public awareness of these rights and a strong desire by individuals to enforce them remain key to fighting the persistent exploitation of celebrity identities in the digital age.

Former Narcotics Control Bureau Chief Sues Over 'Ba***rds of Bollywood'

Former Narcotics Control Bureau (NCB) zonal director Sameer Wankhede has filed a defamation suit in the Delhi High Court seeking an injunction and Rs 200 million in damages against the producers of the Netflix series, "Ba*ds of Bollywood". The damages, if awarded, are requested to be donated to the Tata Memorial Cancer Hospital.

Wankhede alleges the series was deliberately conceptualized to malign his reputation and negatively portray antidrug enforcement agencies. The suit names Red Chillies Entertainment Limited, headed by Shah Rukh Khan and Gauri Khan, along with Netflix, X, and Google as parties.

The series is co-written and directed by Aryan Khan, Shah Rukh Khan's son, whose 2021 arrest followed Wankhede's raid on the yacht Cordelia in Mumbai. While Wankhede led the initial action, a Special Investigation Team (SIT) of the NCB later found "several irregularities" in the raid and exonerated Aryan Khan and



five others in 2022. Wankhede himself later faced a probe for allegedly demanding a Rs 250 million bribe from Shah Rukh Khan.

In his plea, Wankhede also pointed to an alleged violation of the Prevention of Insults to National Honour Act, 1971, stating the series depicts a character making an obscene gesture after reciting the national slogan 'Satyamev Jayate'. The suit contends that the series "outraged national sentiment" through the use of offensive material.

- Classic Stars: Madhubala and Asha Parekh were cited as the "gold standard" of beauty in the past.
- Contemporary Stars: Kriti Sanon, Kajol, and Madhuri Dixit were named as modern-day examples who come very close to the scientific ideal.
