

Wakashio: The Anatomy of a Systemic Collapse



he long-awaited report from the Court of Investigation into the grounding of the MV Wakashio, on 25 July 2020, is not merely a document; it is a searing indictment of systemic failure. Released yesterday, the findings confirm what many feared: one of Mauritius's gravest environmental catastrophes was not an act of God, but the predictable, tragic result of a combination of human error, institutional paralysis, and a shocking lack of preparedness. The price of this collective negligence? A nearly \$2.5 billion bill and the contamination of the country's most precious natural heritage for generations to come.

The report forces us to confront an uncomfortable truth: in the final, desperate moments, a 300-metre bulk carrier was allowed to steam at full speed toward a sensitive coral reef because the officer on watch was preoccupied with finding a phone signal to call home, his cadet had abandoned post, and the captain was allegedly distracted by alcohol and a futile quest for internet connection. The Court speaks of a "total disregard for basic navigation rules." The blame on the crew is absolute, but for Mauritius, this maritime disaster is a story of internal systemic collapse.

From Preparedness to Paralysis: The Institutional Blunder

The inquiry's most damning revelation lies in the failure of the Mauritian surveillance system. The *Wakashio*, clearly violating the rule of innocent passage, was allowed to approach the coast dangerously without any contact from the National Coast Guard (NCG). Fifteen minutes before impact, no alert was raised. The report points to a "culpable omission" by the authorities.

This official silence was followed by a staggering lethargy in the response phase. It took nearly two weeks to declare a state of environmental emergency, critically delaying essential pumping and containment operations. Institutions, rather than cooperating, worked in "silos," breeding confusion and sparking justified outrage from local NGOs, who decried the lack of transparency and coordination. The result is quantified devastation: an estimated 96 km² of coral reefs and marine habitats destroyed, with long-term health risks from heavy metal contamination looming over coastal communities reliant on fishing and tourism.

The report's call for fundamental reforms — including revising the National Oil Spill Contingency Plan, enhancing inter-institutional coordination, and establishing marine exclusion zones — is a necessary but insufficient step toward accountability. As Minister of the Blue Economy,

Arvin Boolell, rightly asserts, the report censures the previous government, noting the telling absence of the former Prime Minister and environment/fisheries ministers before the inquiry. The publication of this document is not the end of a chapter, but the opening of an era of reckoning.

The Paradox of Preparedness: What Went Wrong?

The court's findings on institutional failure stand in stark contrast to expert analysis on Mauritius's historical capacity. As highlighted in a previous editorial, international experts like Professor Christian Bueger found it "puzzling that there was such a lack of preparedness." The truth, however, is not a lack of *planning*, but a failure of *execution*.

A rchival evidence confirms that Mauritius was, on paper, "very well prepared." It was one of the first African nations to finalize an oil spill contingency plan in 1990, benefiting from substantial capacity building through the International Maritime Organisation (IMO), the World Bank, and the UN Environmental Programme (UNEP). Records show that Mauritian officials were acutely aware of the "high risk" posed by the country's proximity to one of the world's busiest shipping routes, and possessed "sophisticated planning, response and disaster assessment tools."

Furthermore, the authorities had practical experience. They successfully prevented a major oil spill after the 2005 collision between the *MSC Katie* and the *MV Nordsun*. Crucially, in 2016, when the *MV Benita* ran aground nearby, a minor spill was contained swiftly due to quick action by salvage companies.

The evidence points to a massive disconnect: how could a country with decades of training, detailed contingency plans, and proven experience suffer such a debilitating paralysis?

The Questions of Will and Wisdom

This paradox begs a fundamental series of questions regarding the two weeks between the grounding (July 25, 2020) and the visible oil spill (August 6, 2020) — the critical window lost to inaction:

Was the government properly advised or alerted about the imminent risk of a spill from the 4,180 metric tons of fuel oil aboard the *Wakashio*?

If the then Prime Minister, as he claimed, deferred to expert advice, what was the precise content of that advice?

What factors — including weather conditions, wave calculations, and risk quantification — were factored into the

advice given to the highest political office?

Only a truly independent inquiry, empowered to review the operational decisions of the day, can illuminate this chasm between institutional preparedness and actual response. This investigation must specifically scrutinize the role and responsibilities of the Director of Shipping — the designated "Receiver of Wrecks" under the Merchant Shipping Act 2007 — who was best placed to advise the government on the wreck and salvage efforts.

The two-week delay transformed a manageable grounding into a catastrophe and, more dangerously, ignited the public's imagination, lending credence to conspiracy theories that the vessel was covertly transporting a drug consignment. The political imperative now is not just to fix the system, but to restore public trust. Acknowledging any specific mishap or lapse in judgment will be the first essential step toward future resilience.

The Vulnerability Tax and the Way Forward

The Wakashio catastrophe exposed Mauritius's profound vulnerability as an island state located on a major global shipping artery. The cost — both economic and ecological — is the tax we now pay for institutional amnesia. The disaster was not simply a navigational error by an inebriated captain; it was a failure of the national security apparatus to utilize its own, well-developed tools and protocols.

The recommendations of the Court of Investigation are a roadmap to recovery and future proofing. We must:

Implement the *Freedom of Information Act*: The current lack of transparency has allowed doubts and theories to fester. A robust FOIA will empower citizens and the press to hold institutions accountable.

Strengthen the NCG and Surveillance: Invest heavily in the equipment, training, and operational capacity of the National Coast Guard to ensure that no vessel can ever again approach the coast without immediate, decisive intervention.

Integrate Local Communities: The extraordinary, spontaneous mobilisation of the Mauritian people, who used hair booms and local knowledge to fight the spill, must be formalized by integrating them into the revised National Oil Spill Contingency Plan.

"We cannot afford a second *Wakashio*," concludes the report. This is more than a cautionary warning; it is a profound truth. The integrity of our unique marine environment, our economy, and the very soul of the island demand that the government not just publish this report, but act upon it with unreserved commitment and transparency. The window for change, unlike the crucial two weeks in 2020, must not be missed. We must convert negligence into resilience.

eux développements majeurs sur le plan juridique ont retenu l'attention publique la semaine dernière: (a) l'arrestation de l'ancien commissaire de police Anil Kumar Dip par la *Financial Crimes Commission* (FCC) sous une charge provisoire de maldonne dans l'affaire de la monnaie de récompense («reward money») payée aux informateurs de la police, et (b) la décision du Directeur des Poursuites Publiques (DPP) de rayer la charge provisoire de trafic de drogue contre six individus qui se disaient victimes d'un complot ourdi par des «brebis galeuses » de la police.

Ces deux développements ont une forte valeur de symbole dans le cadre de la lutte contre les crimes financiers et l'exercice de l'État de droit à Maurice. Ils sont emblématiques d'une nouvelle approche institutionnelle visant à mettre fin à des dérives dans le système administratif tout en faisant prévaloir les principes de la justice.

Pendant trop longtemps, l'impunité des suspects de crimes à col blanc, et surtout celle des forces de police accusées d'actions arbitraires contre des opposants politiques ou des citoyens osant critiquer les gouvernants tout-puissants du jour, fut érigée en politique d'État par un gouvernement autocratique empêtré dans des combines les plus louches. Le changement politique du 11 novembre 2024 exprima le ras-le-bol général d'un peuple qui en avait assez du statu quo pourri et espérait une nouvelle approche en matière de gouvernance. Malgré l'impatience populaire face au rythme du changement, force est de constater que les choses changent dans ce pays peu à peu dans deux domaines cruciaux de la démocratie: la poursuite des crimes financiers et l'administration de la justice.

Il faut sans doute relativiser la portée de certaines actions de la FCC accomplies à ce jour, vu l'ampleur des crimes financiers et du trafic de drogue. D'ailleurs, les suspects ont droit à la présomption d'innocence en attendant que le judiciaire statue sur les charges contre eux. Toutefois, de petits pas dans le sens de l'assainissement général des mœurs sont toujours salutaires.

Monnaie de récompense

L'arrestation de l'ancien commissaire de police, sous la charge de fonctionnaire utilisant sa fonction à des fins de gratification personnelle («public official using office for gratification») en vertu de la section 7 de la loi relative à la lutte contre la Corruption («Prevention of Corruption Act» - POCA) pour son rôle allégué dans l'affaire de la monnaie de récompense, était attendue vu qu'il était le chef d'une police qui était en théorie comptable des agissements de ses subalternes, selon la reddition de comptes. La monnaie de récompense payée aux informateurs de la police qui donnent des tuyaux menant à des saisies de drogue est un scandale financier avec des implications très graves.

Comme indiqué dans le tableau ci-dessous, une somme de Rs 250 millions a été déboursée en quatre ans. A ce jour, l'enquête de la FCC a mené à l'inculpation provisoire de plusieurs anciens haut-gradés de la police pour cause de blanchiment d'argent sous la loi (Financial Intelligence and Anti-Money Laundering Act – FIAMLA).

L'investigation a révélé douze aspects très troublants de l'affaire, notamment :

 (a) le versement de sommes considérables dans les comptes bancaires personnels de certains officiers (Rs 160 millions dans un cas) pour les besoins de

- (c) la faillite du contrôle interne au département de la police sur la validation et l'autorisation des demandes de récompense ainsi que sur les décaissements d'argent aux informateurs;
- (d) l'absence d'une liste fiable des informateurs ayant été payés;
- (e) les chevauchements de rôles entre officiers responsables dans l'administration du fonds de récompense, ce qui enfreint la règle de la séparation des fonctions;
- (f) les instructions présumées données par un haut gradé de la police dans un memo adressé à une banque (SBM) pour que des retraits quotidiens de montants élevés (Rs 1 million par jour), destinés aux informateurs, soient permis en contournant les règles bancaires;
- (g) la possibilité que des sommes destinées aux informateurs ayant quitté le pays au gré des

- voyages entrepris à l'étranger par de tierces parties;
 (h) le lien possible entre la monnaie de récompense et l'acquisition des avoirs (véhicules et terrains) par de tierces parties sous des prête-noms;
- (i) la surévaluation de la récompense, dans certains cas, par rapport à la valeur de la drogue saisie;
- (j) la responsabilité du ministère des Finances dans cette affaire, car cette institution fait voter les dotations budgétaires au fonds de récompense;
- (k) la non-traçabilité des bons de paiement authentiques signés par l'officier concerné au moment du déboursement des récompenses;
- (I) l'usage de la loi relative aux Secrets d'État («Official Secrets Act») par des suspects pour refuser de révéler l'identité des informateurs et les récompenses qui leur ont été payées, ce qui va contre tout principe de transparence

Un procès éventuel contre l'ancien commissaire donnera sans doute lieu à un débat byzantin sur les responsabilités du chef et de ses subordonnés dans une hiérarchie fondée sur la discipline, la décentralisation des pouvoirs et le devoir de rendre compte de ses actes.

- Qui était redevable à qui dans l'exercice de ses fonctions?
- Qui prenait les décisions en consultation avec qui?
- Qui donnait des ordres et qui les exécutait?

Autant de questions à éclaircir dans la chaine de commandement de la police ! Pour toute défense, l'ancien commissaire invoque une vendetta politique contre lui. Il incombera au DPP d'évaluer la justesse de cette thèse en toute indépendance en se basant sur le dossier d'enquête de la FCC.

Police Accountability, the SST, and the DPP's Power

his week's Qs & As column critically examines the constitutional powers of the Director of Public Prosecutions (DPP) in Mauritius, particularly as they confront major public controversies, including the Wakashio grounding and serious allegations of misconduct — such as evidence planting — against the now-disbanded Special Striking Team (SST). The focus is on the legal necessity of further investigations, the complex issues of police accountability, and the fundamental guarantee of a fair trial for the accused.

* Let's first address the Wakashio grounding incident. The DPP has indicated, in a communique dated 19 Sep 2025, that there are "sufficient elements that would justify a police investigation" against officials responsible for monitoring the vessel. Since the DPP's power is, to our understanding, to institute criminal proceedings, not investigations, what is the legal significance of the DPP publicly issuing this 'view,' and does the police force have a legal obligation to act upon this directive?

It has been a long-standing practice for the Director of Public Prosecutions (DPP) to request the police to carry out a further inquiry in any file submitted to his office if the circumstances so demand. The DPP cannot blindly accept all that is contained in a police file. He and his team of officers study the file to determine whether there are any omissions or failings in the investigation. He then sends the file back to the police for further investigation on specific lines. There is nothing wrong with this long-standing procedure.

* The DPP has requested that "further investigation" be conducted by the Police into the cases of alleged drug trafficking against Akil Bissessur, Avinash Bissessur, Doomila Devi Moheeputh, Jean Bruneau Laurette, Jean Luca Ryan Laurette, and Vimen Sabapati — cases which were all investigated by the Special Striking Team (SST) under the supervision of the same high-ranking police officers. How important is this decision of the



DPP? Is it unusual for the DPP to recommend further investigations in a case of this nature?

Drug offences are very serious. The Director of Public Prosecutions (DPP) has taken note of the allegations of planting made by suspects arrested by the Special Striking Team (SST), and he has rightly qualified these allegations as very serious. While that decision may appear unusual, the underlying accusation — that evidence was planted — is itself highly irregular and strikes at the very heart of the rule of law.

* Would it be correct to say that when the DPP orders a "further investigation" where the police themselves (especially high-ranking officers) are the subject of serious allegations, the DPP must use their constitutional and procedural powers to take effective control of the investigative process?

The DPP has no power to investigate a case himself. His authority is limited to supplementing an investigation by requesting the police to conduct a further inquiry. The Constitution has very clearly allocated distinct powers to the DPP and the Commissioner of Police (CP).

The CP, through a combined reading of Section 71 of the Constitution and the Police Act, holds the full power to investigate an offence. Section 72 of the Constitution, conversely, empowers the DPP to institute criminal proceedings.

The DPP cannot exercise that power if an investigation is faulty and if all relevant avenues have not been thoroughly explored.

* In the context of the DPP taking effective control of the investigation, we would assume that the investigating team — under a new Commissioner of Police — would strive to get to the bottom of the different cases and question the high-ranking police officers of the SST and whoever in and outside the police force directed them to carry out these operations?

Once the Commissioner of Police (CP) receives the police file from the DPP for a further inquiry, he would and should comply. This compliance is paramount in the interest of justice and in the public interest.

The investigating team is legally and procedurally bound to follow the evidence wherever it leads. This means the scope cannot be limited only to high-ranking police officers; it must explicitly include all individuals who may have directed, authorized, or influenced the SST operations, even if they are outside the police force.

The credibility of the entire investigation hinges on its willingness to probe the chain of command, from the on-theground operatives all the way up to any external political or administrative figures who may have instigated these activities.

* There is one commonality as regards the accused parties: most of them publicly opposed the former government, and it's quite possible that the alleged planting operations, if they actually took place, were meant to silence them. But proving that the drugs and evidence were indeed planted by the SST might prove extremely difficult. What kind of evidence would satisfy a court of law?

Proving that drugs or evidence were planted is extremely difficult, as it requires the police inquiry to probe the matter very deeply and searchingly to uncover a specific, malicious intent and a coordinated act by police officers to subvert justice. If the inquiry reveals evidence of planting, the DPP will take appropriate action against the police officers. Should he order a prosecution, he must ensure the evidence is capable of satisfying a trial court beyond reasonable doubt of the officers' guilt.

In essence, the evidence must establish a clear pattern of motive and opportunity, coupled with scientific proof that the planted items did not belong to the accused and were handled only by the police.

* Given the multiple "planting" allegations against the SST, what concrete, systemic steps can the Commissioner of Police, collaborating with other authorities, take beyond the specific case files to address such misconduct, restore public trust, and ensure the police force upholds its constitutional duty to administer justice fairly?

It is the responsibility of the Commissioner of Police (CP) to hold training sessions with police officers and advise them how to act and behave according to professional standards. The SST was, however, a special case — a police unit that was allegedly acting outside the boundaries of the Rule of Law. Its leadership reportedly dismissed criticisms that it brushed aside as a farce.

Once the Commissioner of Police (CP) receives the police file from the DPP for a further inquiry, he would and should comply. This compliance is paramount in the interest of justice and in the public interest. The investigating team is legally and procedurally bound to follow the evidence wherever it leads. This means the scope cannot be limited only to high-ranking police officers; it must explicitly include all individuals who may have directed, authorized, or influenced the SST operations, even if they are outside the police force..."

The Mauritius Police Force's Code of Ethics establishes the bedrock of police conduct, demanding integrity, fairness, and accountability to foster public trust. It mandates that all members must:

Act only within the law and due legal process

Uphold fundamental human rights and treat all individuals with respect.

Act with fairness, integrity, and impartiality.

Accept personal accountability for their acts and omissions, and actively oppose any malpractice.

Are police officers acting accordingly? While the majority of the Police likely upholds its ethical code, the reported misconduct of the SST demonstrates a critical breakdown of accountability where ethical standards were systematically ignored or subverted by those involved. The investigation is necessary to enforce the accountability required by the Code of Ethics.

* How does the prolonged need for "further investigations" by the DPP's office — necessitated by "allegations of planting" — impact the constitutional guarantee of a fair trial within a reasonable time for the accused persons, given the severity of the bail and prohibition orders?

* If the "further investigations" ultimately fail to either substantiate the charges or definitively rule out the allegations of planting, what are the competing public interest factors the DPP must balance in making the final decision to prosecute or to formally enter a nolle prosequi?

The DPP's decision to prosecute rests on both a strong Evidential Test and the Public Interest Test. The evidence must be sufficient and admissible to provide a realistic prospect of conviction. This means the DPP must be satisfied that a court, properly directed, is likely to find the accused guilty beyond a reasonable

Even if the evidential test is met, the DPP must consider whether a prosecution is required in the public interest. This involves weighing factors such as: the seriousness of the offence, the accused party's degree of culpability, the prevalence of the crime and the need to maintain public confidence in key institutions.

Interview: Me Rama Valayden

"La FCC affiche un mélange de vitesse et de précipitation; son action ne doit pas être guidée

par la seule satisfaction d'une opinion publique volatile"



'e Rama Valayden dresse, dans l'interview de cette semaine, un réquisitoire virulent contre la corruption endémique, l'impunité historique et l'inertie politique à Maurice. En confirmant la réactivation des "Avengers" — un réseau d'avocats pénalistes œuvrant pro bono contre les cover-ups —, il dénonce l'échec d'un certain nombre d'institutions à fournir des résultats concrets. La crédibilité de la nouvelle Financial Crimes Commission (FCC) est mise en doute face à la réalité d'un petit pays où l'indépendance des gardiens est constamment menacée par des pressions politiques, financières et communalistes. Face à la montée de la criminalité de rue et à la menace d'une explosion sociale, Rama Valayden appelle à une stratégie de choc inspirée de l'opération Mani Pulite et exige une réforme institutionnelle d'envergure.

Mauritius Times: Les «Avengers» – ce «rempart contre les *cover-ups*», comme vous les avez qualifiés à l'époque – seraient en voie de réactivation, à en croire la presse. Reste à savoir: quelle cible ont-ils dans le viseur cette fois-ci?

Rama Valayden: Les «Avengers»: ce n'est pas une organisation structurée avec un organigramme où chaque membre a un rôle précis. C'est un réseau d'avocats pénalistes, imbus des droits humains, qui militent pour la vérité, pour que la justice triomphe, peu importe la situation politique, la popularité ou l'impopularité de l'affaire traité. En tout,

ce qu'on a fait ou que l'on fait est «pro bono». Nos membres sont «colour blind», c'est-à-dire que nous ne pratiquons pas la politique partisane. Mais force est de constater qu'aucun de nos avocats ne vient de l'écurie orange.

Je suis convaincu que les «Avengers» ont joué un rôle prédominant dans le combat contre les «cover-ups». Sans l'apport des «Avengers», beaucoup d'affaires auraient sombré dans l'oubli. Nous avons eu le respect que nous méritons. Mais nous n'avons jamais été attirés par les nombreuses propositions de faire de la politique.

La réactivation est certes en cours. Il y a plusieurs affaires qui n'ont pas abouti. On ne sait pas qui sont les tueurs, les commanditaires dans les affaires suivantes: (a) Kistnen, (b) Mouniarack, (c) Martingale, (d) Permes et tant d'autres.

Dans toutes les affaires mentionnées, c'est grâce à nos efforts conjugués que nous avons abouti à des enquêtes judiciaires. La seule «judicial enquiry» complétée, c'est l'affaire Kistnen. Cela étant dit, l'opacité demeure.

Parmi les membres les plus actifs, certains ont souhaité que nous travaillions bien plus de concert avec les syndicats et les ONGs. Nous nous attellerons à la tâche, car nous savons que le peuple nous a fait confiance.

* Les «Avengers» avaient trouvé leur raison d'être suite à l'inaction – ou l'inefficacité – de l'ICAC au cours des dix dernières années. Mais le contexte a changé: aujourd'hui la «Financial Crimes Commission» (FCC) affiche une volonté affirmée de lutter contre la corruption. Comment réagissez-vous à cette évolution?

C'est encore tôt pour juger la FCC. Ils sont mieux armés que l'ICAC. Sous le même toit, ils ont des enquêteurs, des commissaires et des avocats. Mais la corruption n'est pas seulement «orange». Les pourris sont ailleurs aussi. Des informations crédibles sur la corruption et d'autres crimes financiers qui circulent m'inquiètent. J'ai logé une plainte où un actuel ministre est impliqué depuis trois mois mais, comme dans le conte de Charles Perrault, 'La Barbe Bleue, je suis toujours en train d'attendre : «Anne, ma sœur Anne, ne vois-tu rien venir?».

Scrutons l'horizon: 2025, l'année des arrestations. Bravo ! Mais l'année 2026, à partir de mars, sera l'heure de l'annulation des accusations provisoires («Striking Out Provisional Charges»). Nous allons assister à la série des documents perdus, des pertes de mémoire, des morts naturelles pas trop naturelles... Nous allons peut-être observer des scandales qui effacent d'autres scandales ou justifient d'autres scandales. Comment réagira le pouvoir si l'un des siens est impliqué dans une affaire? Comment réagira le bureau du DPP?

Je le répète: la lutte contre la corruption ne peut être gagnée sans une transparence totale et sans l'éducation d'un peuple — un peuple malheureusement trop souvent avide de gains. Bien que la FCC ne soit pas chargée de ce type d'éducation, d'autres institutions le sont. Les outils sont variés. C'est la raison pour laquelle j'ai déjà préparé in toto la «Freedom of Information Act» que Linion Moris a fait circuler lors d'une convention à Bagatelle.

La bataille de la perception est une chose, mais la réalité, elle, reste à prouver. Dans cette optique de pédagogie et de transparence, je suis favorable à la retransmission en direct des procès. D'ailleurs, nous avions envisagé cette idée pour le procès de Michaella Harte. Cependant, certains milieux ont estimé que je risquais de gagner en popularité, si mon collègue Sanjeev Teeluckdharry et moi-même obtenions gain de cause.

* La création de la FCC est perçue comme un changement de paradigme et un outil législatif puissant pour lutter contre les scandales passés et la corruption, mais sa crédibilité à long terme dépendra uniquement de l'indépendance et de l'efficacité de son exécution, mesurée par des résultats concrets et des condamnations. Dans quelle mesure ses actions et ses résultats à ce jour témoignent-ils du sérieux et du professionnalisme attendus d'une institution anti-corruption crédible?

Affirmer que la FCC est un changement de paradigme... permettez-moi d'exprimer mes doutes. L'argent n'est-il pas roi et n'achète-t-il pas tout, comme l'a si bien démontré mon acteur préféré, Raj Kapoor? Nous avons fêté son centenaire en décembre dernier, mais avons-nous retenu la véritable portée de son message?

Pour l'instant, les résultats concrets se font attendre. Si nous voulons réellement un changement, la FCC doit être radicalement fortifiée. Plusieurs mesures urgentes s'imposent.

Souvenons-nous de l'opération *Mani Pulite* (Opération Mains Propres) en Italie dans les années 90: cette action coup de poing contre la corruption politique s'attaquait frontalement aux mafieux. À Maurice, la tâche de lutte contre la corruption n'est peut-être pas aussi complexe qu'ailleurs, mais elle exige impérativement une stratégie de choc similaire à celle de l'opération Mani Pulite. Il faut frapper fort, cibler le cœur du système et y mettre fin.

Cette approche doit se dérouler en deux temps pour garantir l'effet de surprise et l'efficacité. Primo, il faut cibler les têtes et arrêter les figures clés de la corruption en une seule nuit. Secundo, il faut assurer une surveillance efficace. Pour cela, il faut mettre les suspects sur écoute, car, même si cela se fait sans«fiat» légal, leur ignorance de l'Histoire et leur présomption pourraient leur coûter très cher.

Ceux qui sont en charge ne sont peut-être pas médiocres, mais ils ignorent l'Histoire. Regardez comment Zuma a pu se débarrasser des "Scorpions" pour échapper à la justice en Afrique du Sud. Ici même, à Maurice, on a noirci Madame Manrakhan et on a dissout le Tribunal Anti-Corruption pour protéger un dirigeant en vue du MMM.

Quand les partis politiques vivent grâce à des revenus occultes, croyez-vous encore au Père Noël?

* En ce qui concerne les affaires en suspens (les «cover-ups»), la FCC a clairement indiqué qu'elle donnerait la priorité aux enquêtes sur les scandales non résolus de l'ère précédente. Où en sont concrètement les enquêtes sur les anciens scandales, et ces progrès suffisent-ils à convaincre le public que l'ère de l'impunité est révolue?

Il y a toujours des «cover-ups». C'est la machinerie de tout pouvoir, partout dans le monde. Richard Nixon n'a pas été destitué pour l'écoute électronique, mais pour avoir tenté de dissimuler le crime.

Aujourd'hui, l'opacité est la règle. Dans l'affaire des reward money, les documents manquants deviendront des "missing links" qui mèneront inéluctablement à un maillon faible de preuves. Où sont les progrès? On nous parle de reward money, mais quid des papiers d'examen? Quid des gros appels d'offres de ces cinq dernières années? Quid des passeports vendus, de l'affaire Lee Shim ou de la GRA? Moi, je ne vois que du Tollywood et des miroirs aux alouettes.

Avez-vous vu des enquêtes sur l'enrichissement sans cause des anciens ministres et de leur entourage? Non, ce sont toujours les mêmes compagnies puissantes qui en bénéficient. Le système est basé sur le favoritisme: "Tu me grattes le dos, je te gratte le dos".

La presse est censée être notre chien de garde, mais elle est souvent déviante, ressemblant à Rantanplan devant des malfaiteurs bien plus intelligents que les Daltons. L'impunité règne... mais pas pour tout le monde. Les récents troubles à la prison de Melrose, impliquant les enfants des pauvres, a fait du bruit pendant une semaine, puis silence radio. La durée de ces prétendues "arrestations" et des rumeurs qui les accompagnent est celle d'un moustique.


Cela étant dit, la bataille légale s'annonce moins difficile que la politique ne le croit ; le vent tourne déjà avec l'affaiblissement du pouvoir.

Pink Ball, Stolen Gods: The British Museum's Gala of Contradiction

A museum built on empire's loot is poised to celebrate itself with chandeliers, champagne, and celebrity

he British Museum, custodian of more than 30,000 Indian artefacts taken during the Raj, will this month host its first ever "Pink Ball". According to *The Times* newspaper in London, tickets are priced at £2,000 (around Rs 120,000 Mauritian rupees) and 800 guests will dine in the Great Court only yards away from the Amaravati Sculptures — Buddhist treasures hacked out of Andhra Pradesh by the East India Company.

On stage will be Anoushka Shankar, the sitar virtuoso and daughter of the late Ravi Shankar, whose music brought Indian classical traditions to audiences worldwide. The event is co-chaired by Isha Ambani, daughter of Reliance chairman Mukesh Ambani, alongside museum director Nicholas Cullinan.

On the surface, it is a spectacle designed to rival New York's Met Gala. The committee features Naomi Campbell, the British supermodel; Edward Enninful, the Ghanaian-born former editor-in-chief of *British Vogue*; Courtney Love, the American rock musician and actress best known as widow of Nirvana's Kurt Cobain; and Zadie Smith, the acclaimed British novelist. The evening will be themed around the "colours and light of India". But beneath the pink glow lies a contradiction: a gala intended to raise millions for a museum that still refuses to return the treasures it took by conquest, coercion, or theft.

The Amaravati Sculptures illustrate the point. Carved between the 2nd century BCE and 3rd century CE, they once adorned a great Buddhist stupa on the banks of the Krishna River. Their panels told the life stories of the Buddha to pilgrims. When East India Company engineers dis-

mantled the site, hundreds of blocks were crated for London. What remained in India was left exposed to decay. Today, those carvings, once alive with ritual and devotion, are reduced to dinner décor for wealthy donors.

The Indian presence in the British Museum is vast. More than 30,000 objects from the subcontinent form the largest collection outside South Asia. Chola bronzes once worshipped in Tamil Nadu, Hindu deities from Bengal and Odisha, and relics from Buddhist shrines now sit in storerooms or under glass. Many have never been catalogued; most will never be displayed. To priests and pilgrims, they were once living gods. In Bloomsbury, they are lifeless curiosities.

The museum also stores human remains. It admits to holding more than 6,000 sets of remains from across the world, including South Asia — bones looted from battlefields, burial grounds and temples. Scholars say the denial of dignity to the dead is even more shocking than the hoarding of bronzes or carvings.

Critics ask: what exactly is being celebrated? The institution is already scarred by scandal. In 2023, it admitted that more than 1,500 objects had gone missing from its storerooms. Only 634 have been traced. Hundreds remain unaccounted for, many never photographed or catalogued. The museum blamed a former curator, Peter Higgs, while police investigations continue. Reports suggest missing pieces passed through dealers in Britain, Switzerland and the Middle East before disappearing into

private collections. Far from being a model custodian, the museum has shown itself unable to protect even what it keeps.

Financially, too, the contradictions are glaring. Freedom of Information requests answered by the museum show that in 2024/25 it received £44 million in operating subsidies and another £30 million in capital grants — more than £74 million (around Rs 4.4 billion Mauritian rupees) in total tax-payer funding. Its director Nicholas Cullinan earns between £215,000 and £220,000 a year (Rs 12–13 million Mauritian rupees), more than the British Prime Minister. A further £14 million (Rs 840 million) was spent on public relations, press handling and security — a sum larger than the annual budget of many regional museums.

Yet the Pink Ball seeks more money, this time from diaspora pockets. Its Indian theme and its celebrity endorsements are deliberately pitched to attract wealthy donors, especially among the Indian diasporas. Just as India seeks the Amaravati Sculptures and Greece the Marbles, Mauritius continues to demand the return of what was taken. The struggles are linked by a common theme: restitution as dignity, restitution as justice.

ritain's fiscal pressures add another Bedge. Chancellor of the Exchequer Rachel Reeves, the UK's finance minister, must find tens of billions without raising taxes or slashing services. The British Museum squats on 5.5 acres of prime Bloomsbury real estate worth more than £2 billion. Its collections, valued conservatively at £30-50 billion, could transform public finances if restitution, sales or shared custody were seriously pursued. Advocates say that such measures would not only redress past wrongs but also fund hospitals, housing and schools, while decentralising cultural infrastructure to cities like Manchester or Birmingham.

Instead, chandeliers will sparkle, and sitar strings will sound. Anoushka Shankar, Isha Ambani and a roster of international celebrities will lend their prestige to an institution scarred by thefts and scandals. Yet for all the glamour, the contradictions are impossible to conceal. A museum built on empire's loot is asking the heirs of the looted to pay again.

Around the world, migrants are being deported at alarming rates

The US, UK and Australia are all expanding efforts to deport non-citizens, reframing the act of seeking asylum from a human right to a criminal act

Inder President Donald Trump, the United States is expanding its efforts to detain and deport noncitizens at an alarming rate. In recent months, the Trump administration made deals with a number of third states to receive deported non-citizens.

In Australia, the Labor government has similarly established new powers to deport non-citizens to third states. The government signed a secretive deal with Nauru in September, guaranteeing the small Micronesian island A\$2.5 billion over the next three decades to accommodate the first cohort of deportees.

In both countries, migrants can now be banished to states to which they have no prior connection.

Last year in the United Kingdom, Prime Minister Keir Starmer's Labour party promised that the previous Conservative government's plan to deport people to Rwanda was "dead and buried". Yet, Labour removed close to 35,000 people in 2024, an increase of 25% over the previous year.

Starmer has also proposed establishing "return hubs" in third countries for people with rejected asylum claims.

Meanwhile, the far-right Reform Party has put forward a "mass deportation" plan involving the use of military bases to detain and deport hundreds of thousands of people, if it wins power in the next general election.

Similar policies may soon come to Europe, too. In May, the European Commission published a proposal that would allow EU member states to deport people seeking asylum to third countries where they have no previous connection.

The deportation of populations deemed problematic is not a new practice. For centuries, states have used forms of deportation to forcibly remove people, as Australia's own history as a British penal colony illustrates

Today, deportations are a staple of migration governance around the world. However, the recent expansion of detention and deportations reflects an accelerated criminalisation and punishment of non-citizens, tied to a rising authoritarianism across purportedly liberal Western countries.

Criminalising movement

The expansion and outsourcing of deportation is underpinned by long histories of criminalising migration.

Over the past three decades, legal

obstacles and securitised borders have increasingly forced those fleeing war, persecution and insecurity to rely on unauthorised routes to seek refuge.

Governments have simultaneously reframed the act of seeking asylum from a human right to a criminal act, brandishing those on the move as "illegal" as a way of justifying onshore and offshore immigration detention.

Racialised people living in the community have also been subject to increased policing, regardless of their migration status.

In the US, UK and Australia, this criminalising language, once the preserve of the right-wing press, is now echoed by politicians across the political spectrum and enshrined in legislation. This has accelerated what migration expert Alison Mountz has termed "the death of asylum", and normalising deportations.

In Australia, for example, the government lowered the threshold for visa cancellations in 2014, resulting in people with minor offences being detained and scheduled for deportation. Those who could not be returned to their home countries continued to languish in detention until a 2023 high court ruling mandated their release.

Despite having served their sentences, in addition to protracted periods in immigration detention, a media frenzy framed these people as a major threat to the community. The Labor government then legislated to deport them, in addition to thousands of others on precarious visas, to a third country.

Deportations have also been a central

facet of US immigration enforcement for many years.

Former President Barack Obama was branded "Deporter in Chief" for achieving a record three million deportations while in office.

While Obama focused on "felons not families", Trump has equated migration itself with crime and insecurity. His administration has cast a much wider net, rounding up those with and without criminal convictions, including citizens.

Detentions and deportations have also been used to suppress political dissent on issues, such as the genocide in Gaza.

To expedite his pledge to deport one million people in his first year, the Trump administration hastily set up detention centres in former prisons and military bases, including at Guantánamo Bay.

Reports suggest the government has also approached 58 third countries to accept deported non-nationals. Countries that have agreed, or already received people, are shown in the map below.

In many cases, people are then redetained on arrival in hotels, prisons and camps, with some subject to further deportation

Rising authoritarianism

These recent developments reveal an explicit authoritarianism in which deportations are achieved through the elimination of procedural fairness. Reducing notice periods, the ability to appeal decisions, and access to legal counsel allows for rushed

and opaque procedures.

In June, eight people were deported from the US to South Sudan without the chance to contest their removal. After a failed court intervention, the three liberal US Supreme Court justices stated:

The government has made clear in word and deed that it feels itself unconstrained by law, free to deport anyone, anywhere without notice or an opportunity to be heard.

In the UK, the Labour party expanded the "Deport Now Appeal Later" scheme in August, extending the countries to which people can be deported without appeal rights from eight to 23.

And this month in Australia, the Migration Act was amended to expunge the rules of natural justice for people scheduled for deportation.

Across all three countries, the rapid expansion of detention and deportation practices terrorise those targeted, leaving whole communities living in fear. Australian human rights lawyer Alison Battisson described deportation as "a creeping death to the individuals and their families".

These policies have also legitimised and emboldened far-right, neo-Nazi groups, who have taken to the streets in both the UK and Australia in recent weeks calling for an end to migration. In both countries, the effects of decades of neoliberal policies, such as a lack of affordable housing, jobs, and health care, are redefined as a problem of migration.

How communities are responding

Communities are now organising and making the case for a different sort of politics.

In Los Angeles, for example, grassroots organisations mobilised earlier this year to counter escalating raids by Immigration and Customs Enforcement (ICE) agents. Networks also began providing information and support to those targeted by ICE arrests. In July, Detention Watch Network relaunched the Communities Not Cages coalition of grassroots campaigns against detention.

In the UK, far-right rallies at asylum hotels have been met by counter demonstrations, with people insisting on a politics of welcome and unity.

But the challenge remains how to turn local and national opposition into a coalition capable of confronting this rise in authoritarian politics of exclusion and expulsion.

Morocco erupts in Gen Z-led protests over World Cup spending, hundreds injured

Morocco said almost 300 police officers and civilians were injured in the latest night of youth-led protests against failing government services and lavish spending for the 2030 men's football World Cup.

Demonstrations that started during the weekend spread to new parts of the North African kingdom late Tuesday. The deepening unrest mirrors recent 'Gen Z' protests in countries such as Madagascar, where President Andry Rajoelina fired his government this week following days of turmoil.

The Moroccan Interior Ministry said Wednesday at least 263 members of the security forces and 23 civilians were hurt in protests across 17 cities the previous night. Some 409 individuals were taken into police custody, reports Bloomberg.

Upheaval on this scale is rare for Morocco, an investor favourite that's seen as a beacon of stability in the Middle East and North Africa. It comes as authorities plan an estimated \$35 billion in infrastructure spending over the coming years, some of which will go toward facilities to co-host football's top event with Spain and Portugal.

Such outlay has enraged many in the country of 38 million people on Europe's doorstep, where youth unemployment is rampant and health and education facilities languish. A leaderless and tech-savvy group named GenZ212 has spearheaded the opposition, drumming up demonstrations via social media.

'Health Care First'

"Health care first, we don't want the World Cup," protesters have chanted.

The ministry accused demonstrators of a "dangerous escalation" and alleged they used knives and firebombs. "All persons proven to have committed acts or behaviours that fall under the scope of the law will be dealt with firmly and strictly," it said in a statement.

AMDH, Morocco's main human rights advocacy group, estimates more than 1,000 people have been arrested since last Saturday. In the capital Rabat alone, 148 protesters have faced charges ranging from disparaging public security to committing acts of violence, it said.

Damir, a prominent advocacy group, urged the government to reconsider its national investment priorities and "strictly respect" citizens' constitutional right to assert their opinions peacefully.

In a statement, it expressed regret over "the disproportionate response of public authorities to these demonstrations, rejects the excessive use of force, and condemns the use of violence by intruders within the protests."

Colombia expels Israeli diplomats over Gaza flotilla intercept

Colombian President Gustavo Petro on Wednesday expelled all remaining Israeli diplomats in the country over Israel's interception of a Gaza-bound aid flotilla and reported detention of two Colombian activists.

Petro said two Colombian women, "who were engaged in human solidarity activities with Palestine," were detained by Israeli forces in international waters.

In a statement, his office said Manuela Bedoya and Luna Barreto were part of the Global Sumud Flotilla and called for their immediate release, reports AFP. The Israeli foreign ministry confirmed that "several vessels" in the flotilla had been "safely stopped" and that the passengers were being brought to an Israeli port.

The leftist Petro severed relations with Israel last year but four diplomats remained posted in the country, said a source at

the Israeli consulate in Bogota.

Writing on X, Petro announced the expulsion of "the entire diplomatic delegation of Israel" over what he called "a new international crime" by Prime Minister Benjamin Netanyahu.

He also terminated a free-trade deal in force with Israel since 2020.

Colombia's leader is one of Netanyahu's most vocal critics, calling him "genocidal," while also slamming US President Donald Trump as an "accomplice" to "genocide."

Last week, Petro attended a pro-Palestinian protest in New York, where he called on the US military to "disobey" Trump.

Washington revoked Petro's visa over his remarks.

European leaders backed a plan to build a so-called drone wall to bolster the Continent's defenses, aiming to send a clear message to Moscow after multiple Russian incursions into NATO airspace. The continent is scrambling to build the necessary capacities to defend against drones, highlighting not only its lagging technology but also how rapidly warfare has shifted to the use of unmanned aircraft.

According to NATO, the Russian army is now capable of making drones for a few thousand dollars that Europe can only shoot down with missiles that cost millions of dollars apiece. Moscow's ongoing hybrid war makes a drone wall necessary, Finland's prime minister argued: "Russia will continue and we have to be ready."

Israel intercepts Gaza aid flotilla

Israeli naval ships intercepted a flotilla attempting to deliver aid to Gaza and detained several activists, including Greta Thunberg. The "Global Sumud Flotilla" of more than 40 vessels set sail in September, intending to breach Israel's naval blockade of the enclave, where the UN says a humanitarian catastrophe is underway.



Israel said several vessels

were taken to port, citing what it called a violation of a "lawful naval blockade," but flotilla organizers said their boats had been illegally boarded and targeted with water cannon and drones. The boats have become an international cause célèbre: They were escorted part-way by Italian and Spanish naval ships, and their interception has been met by protests in several European countries.

US vows to protect Qatar

S President Donald Trump signed a NATO-like security guarantee for Qatar, part of efforts to reassure the emirate after an Israeli strike on Hamas leaders in Doha last month. The executive order pledges to take all measures, including US military support, to defend the Gulf state, though its legal and practical value is in question.

Such agreements have historically required the approval of the US Senate, and the announcement was met with criticism from some of Trump's conservative supporters. The move was ostensibly made to reassure Washington's Gulf allies following the Israeli strike — Saudi Arabia has already reached a mutual-defense pact with nuclear-armed Pakistan — but Politico nevertheless called it a "shocking departure from the administration's America First approach."

Al upends Chinese education

China is integrating AI into more aspects of childhood, spurring the growth of a multibillion-dollar industry. Robot toys that help with tutoring, homework-grading systems, and Alenabled tablets are becoming more common in Chinese homes and classrooms, accompanying a government directive for AI to be embedded throughout early education.

The push has created a vast business opportunity for Chinese tech firms, though analysts say Al hasn't yet positively trans-

formed education, Rest of World reported. "People are buying things randomly because it's AI," one expert said. Some Chinese teachers have complained the new systems only add to their workload, and that their adoption is performative.

Chernobyl and Europe's biggest nuclear plant at risk?

Russia's sustained bombardment of Ukraine's power grid is deepening concerns about the safety of the country's nuclear facilities after a drone knocked out power for more than three hours to the site of the 1986 Chernobyl nuclear disaster and as Europe's biggest atomic power plant remains disconnected from the grid, officials

Both Chernobyl and the Russianoccupied Zaporizhzhia Nuclear Power Plant are not working but they require a constant power supply to run crucial cooling systems for spent fuel rods in order to avoid a potential nuclear incident, reports AP.

A blackout could also blind the radiation monitoring systems, installed to boost security at Chernobyl and operated by the UN nuclear watchdog, the International Atomic Energy Agency.

"Russia is deliberately creating the threat of radiation incidents," Ukraine President Volodymyr Zelensky said late Wednesday, criticizing the U.N. watchdog and its chief Rafael Mariano Grossi for what he described as weak responses to the danger.

"Every day of Russia's war, every strike on our energy facilities, including those connected to nuclear safety, is a global threat," he said. "Weak and halfmeasures will not work. Strong action is

Zelensky said in his nightly video address that Russia launched over 20 Shahed drones against energy infrastructure in Slavutych, the city whose

power supply services Chernobyl, the site of the world's worst nuclear acci-

A wave of drones overwhelmed defences and caused a blackout, he said, affecting the sarcophagus that prevents radioactive dust from escaping the destroyed fourth reactor and storage housing more than 3,000 tons of spent fuel. He did not provide details of how it was affected.

"The Russians could not have been unaware that a strike on Slavutych would have such consequences for Chernobyl," Zelensky said.

Last February, a drone armed with a warhead hit Chernobyl's protective outer shell, briefly starting a fire. Radiation levels there did not increase, officials said.

Meanwhile, the Zaporizhzhia plant, which is one of the 10 biggest nuclear facilities in the world, has been disconnected from the grid for over a week.

Zaporizhzhia has repeatedly been caught in the crossfire during the war. Zelensky blamed Russian artillery for cutting the power line to the plant, but Kremlin spokesman Dmitry Peskov said it was Ukrainian shelling.

The facility is using emergency diesel generators to run cooling systems for its six shutdown reactors and spent fuel.

The IAEA says the plant is not in immediate danger but wants it swiftly reconnected to the grid.

AGOA trade pact gets US reprieve

he White House reportedly backed a one-year extension for a key US-Africa uncertain. Since the African Growth and Opportunity Act was implemented in 2000, sub-Saharan African nations have exchanged goods duty-free with the US, boosting trans-Atlantic trade. But the deal has been effectively scuppered by American tariffs, while pleas by African leaders to extend AGOA have gone

A formal end to the agreement would signal that the Trump administration is disengaging with Africa at a time when other global powers, including China and several Gulf nations, are ramping up their presence across the continent.

China woos top foreign talent

hina launched a new program to woo top scientists and tech experts from around the world, in sharp contrast with a recent US policy that dramatically increased the price of talent visas. China's new "K visa" seeks to attract foreign experts to boost the country's standing as a global technological superpower: In a symbolic move, a worldleading Italian battery scientist recently left a top position in Europe to lead a research facility at a Nanjing university, the South China Morning Post reported. Beijing's openness to foreign talent is at odds with Washington's recent decision to hike the price of visas for talented workers as much as 50-fold. "The US has definitely shot itself in the foot," an expert told Reuters.

Chatbots enforce caste bias

penAl's products including ChatGPT are steeped in caste bias that affects Indian users, according to a new report. Caste-based discrimination is outlawed in India, but persists through stereotypes depicting some groups as unhygienic and poor, and others as scholarly and sophisticated

An MIT Technology Review investigation found that ChatGPT, as well as OpenAl's video generator, gravitated toward stereotypes when assigning characteristics to different castes. It shows the ongoing challenges surrounding bias in AI, especially in India, which is OpenAl's second-largest market — but also reflects the paradoxical nature of such

Al models are trained on bodies of text from across the internet, so chatbots inevitably reflect real-world prejudices. "The experience [of Al] actually mirrored society," one Indian user said.

Europe's modern-day Machiavelli

Swiss-Italian writer is playing the role of a modern-day Machiavelli for European Aleaders. Giuliano da Empoli accompanies French President Emmanuel Macron on state visits and is quoted in his speeches; the Danish prime minister consults him regularly. Da Empoli writes fiction — his bestseller 'The Wizard of the Kremlin' is a thinly veiled portrait of Russian President Vladimir Putin's inner circle — and also analysis, examining how strongman leaders such as Putin or Saudi Prince Mohammed bin Salman gain and keep power. His modus operandi is to understand, rather than condemn, the autocrats, Politico wrote. The comparison to the 16th-century diplomat Niccolò Machiavelli is irresistible, not least because da Empoli once worked in the office next door to Machiavelli's in Florence's Palazzo Vecchio.

Russia's 'hybrid war' in Europe

 ${f R}$ ussia's "hybrid war" against NATO is only just beginning, Denmark's prime minister warned. Speaking ahead of a meeting of European leaders where they're set to

discuss regional security, Mette Frederiksen told the Financial Times that the military alliance must step up its response to Russian aggression after repeated cyberattacks and incursions into its airspace.

Latvia's defense minister gave similar warnings, saying Europe is "not formally at war, but we are not at peace, we are in hybrid warfare," including alleged Russian sabotage and signal jamming. Officials believe recent moves by Russia's ally Belarus to apparently encourage thousands of migrants to cross into EU countries is part of that hybrid warfare: An attempt to seed a humanitarian crisis in the

Editorial

7thin ten days, the Legislative Council will resume its activities. The hitherto drab political atmosphere will be greatly enlivened by the cut and thrust of the Council's debates. But not only by that. The coming session bids fair to become the most crucial stage of the present Government, which is regarded by both sides of the House as the precursor to a Cabinet system of government. During this session, it is expected that Government will unfold its reconstruction plan; discuss and adopt or reject the Titmuss and Meade Reports; consider the findings of Mr Ringadoo's delegation; and last but not least, discuss and adapt or reject the revised Five-Year Plan. It is precisely in connection with the Five-Year Plan that the Council's decision will prove most critical.

On previous occasions, we have drawn attention to what we consider the lack of a sense direction in the plan. We do not rule out the plan as worthless nor do we think like the Opposition, that the Plan should be thrown overboard. There is much good in it, but it is inadequate. Because for obvious reasons it cannot even contemplate controlling the rise in population, it becomes more of a palliative than anything else: by the time the plan is completed, no one will be able to tell us by how much the standard of living will have increased. Furthermore, the list of priorities has not been properly drawn — or to be precise, it has been wrongly drawn.

In an economy like ours, walled in by both natural as well as man-made difficulties, can we decently give priority to building of police stations, quarters for government officers and the sewerage scheme? Of necessity, all our eggs remain in one basket: the sugar industry. Since it is no news to our planners that Mauritius as a country is at the mercy of cyclones, don't they think that it is unrealistic to freeze millions of rupees in cement? Planning is a continuous process, which must be delicately sustained, and above everything, its continuity must be kept. Therefore, we must have a sense of

Sense of Direction

The time will soon come when our growing population asks if new police stations, posh offices, or civil servant housing can truly feed an empty stomach or ease a burdened mind



direction. We must know what we want, and our planning must be geared so as to enable us to satisfy our needs over a period of years. This is planning.

Ramgoolam after his return from London have both said that the Five-Year Plan, which is half way through, would be amended in light of the circumstances created by the cyclones. In what respect will the plan be modified? The only thing we know is that housing will be given a larger share. But what kind of housing? And what about the other items of the plan? Let us try to answer these two vital questions.

It is agreed that housing must be given pride of place in the Government's thinking if it is at all felt desirable to insure the population against future cyclones. But we fail to understand why at this critical juncture in our history we should spend hundreds of thousands of rupees on building quarters for government officers. General Notice No. 960 of 1960 published in the *Government Gazette* of Saturday last says that "tenders will be received for the construction of fifteen houses together with garages, drainage, site

works, services, access roads and ancillary works at Moka (Houses for Government Officers)." What is all this nonsense? This is but one isolated illustration of misspending. Examples like this are legion. Rs 204,000 were spent to build a new sanitary office in Vacoas. And you must see the garage at that sanitary office — it is better, far better than the houses of thousands of people.

Next, the plan must be so revised that we can reduce our dependence upon imported goods. The plan is perfunctory about prospects of increasing our milk and fish production. The promotion of local foodstuffs seems to have been left out completely. This is just inconceivable especially when one considers that all the major countries where planning is well understood and where common sense and pragmatism reign supreme, production of foodstuffs is given top priority. Another pointer to our lack of effective planning is the fact that we have spent, during the last three years, about Rs 22,000,000 in compensation to planters of the North only who have suffered from droughts. With half that amount a reservoir could have been built to capture the waters now being wasted in the sea.

We therefore feel that as the plan is being revised the opportunity could be availed of to give a sense of purpose to our planning. Mr Boolell must claim the lion's share of the huge amounts voted for the plan for his ministry. Then and only then shall we be able to look into the future with hope and confidence. Otherwise, the time is not far away when our swelling population will wonder whether new police stations, posh sanitary offices or civil servants quarters can help to soothe an empty stomach and a burdened mind



Mauritius in the Global Economic Landscape

The New World Trade (Dis)Order: Implications and The Way Forward

he end of World War II in 1945 led world leaders to rethink the global political and economic architecture with the creation of multilateral institutions. Economic stability was considered as important as political alliances. The war itself had shown how protectionism, competitive devaluations, and trade rivalries in the 1930s fuelled resentment and conflict. To prevent history from repeating itself, nations came together to design a new global economic order — one that would bind economies together, reduce trade frictions, and ensure prosperity was shared more widely.

Out of this determination came the Bretton Woods institutions, the General Agreement on Tariffs and Trade (GATT) in 1947, and later the World Trade Organization (WTO) in 1995. The philosophy was simple but profound: instead of a chaotic marketplace where power dictated outcomes, trade would be governed by rules. Transparency, non-discrimination, and reciprocity would ensure predictability. Disputes would be settled by arbitration, not retaliation

For decades, this rules-based order worked remarkably well. Tariffs fell across successive negotiating rounds. Global trade expanded faster than global GDP. Supply chains linked continents in ways previously unimaginable. Above all, trade became a stabilizing force, helping integrate former adversaries like Germany and Japan into a cooperative world economy.

But today, the very foundations of that order are cracking. And one of the clearest triggers has been the return of tariffs as political weapons. The tariff war unleashed by President Trump, justified in the name of fairness and national security, have not only disrupted global trade flows but also undermined the very principle of multilateralism. It has led from a world characterized by trade order to trade disorder.

The Erosion of Multilateral Rules

What make these tariffs particularly destabilizing is not just their scale, but the fact that they have bypassed the WTO's rules. The organization, designed precisely to prevent tit-for-tat retaliation, has been sidelined. The formula used to calculate the reciprocal tariff has left economists and observers bewildered, which is obtained for each country by dividing the US trade deficit by total exports. Even if President Trump wanted to deliver on his promises to reindustrialize the US and bolster Domestic Manufacturing, one would have expected small exporters to be exempted from his reciprocal tariff. But surprise, they have been caught full swing in the disorder



caused by the tariff.

The WTO Dispute Settlement Mechanism has become dysfunctional since the US has blocked the appointment of new judges to the WTO's Appellate Body, effectively paralyzing the whole system. Without a functioning court of appeal, the WTO's enforcement arm has been neutralized. It is a blow from which the institution has yet to recover.

The very foundation of the WTO system - the most-favoured nation (MFN) clause at the heart of multilateral trade has been eroded. This vital principle is meant to discard discrimination and to ensure that all WTO Members are treated equally in terms of trade. It does make provisions, though, for exceptions and waivers that allow countries to conclude preferential trade agreements, and for developed countries to grant unilateral preferential treatment to developing countries to enable them access their markets. One such initiative is the AGOA which operates under a WTO waiver.

Implications for Mauritius

The implications for Mauritius are likely to be dramatic.

First, because of the reciprocal tariff of 15% levied on Mauritian exports which exposes our products to competitive pressure on the US market. When compared to the tariffs of 19% applicable to our direct competitors like Bangladesh and Vietnam, we seem to be in a relatively better position. However, under the AGOA, Mauritian products were exempted from tariffs compared to Bangladesh and Vietnam which were taxed at the prevailing MFN rate of duty, for instance 16% for cotton garments and 30% for garments made from synthetic fibers which provided a high margin of preference for our products. For cotton garments, for e.g., the margin of preference stood at 100% [(16/16) x100], but now with the reciprocal tariff, it has now dropped to 21% [(19-

Second, if AGOA is not re-authorised by 30 Sept, the prevailing MFN tariff will add on to the reciprocal tariff, implying that cotton

garments made in Mauritius will be taxed at 31% (15 +16), and synthetic garments at 45% (15+30), compared to 19% for both Bangladesh and Vietnam, providing them an effective margin of preference of 30% for cotton garments and 45% for manmade fibres respectively. If measures are not taken to mitigate the tariff impact in Mauritius, we risk to lose the US market which absorbs 10% of our exports, with the ensuing consequences of firm closures and job losses.

Third, the Trump reciprocal tariff will automatically result in trade diversion strategies by many countries to neutralise the impact of the US tariff. There is a serious risk that Countries will compensate the loss of the US market by increasing exports to other markets, including by resorting to massive subsidization, dumping and other unfair trade practices. The result is a possible displacement of exports from Mauritius on the EU and UK and other important markets. In addition, there is now a sudden rush by many countries to open new export avenues by concluding Free Trade Agreements. The EU-MERCOSUR Agreement, India-UK FTA, India-EU FTA are cases in point. Not only will this create a new trade dynamic for the Parties to the FTAs, but it will add competitive pressure on small, highcost producers like Mauritius with a real risk of trade displacement.

The India-UK deal makes 99% of Indian goods duty free into the UK market. India is a high volume, low-cost clothing exporter-so price sensitive buyers and fast fashion chains can source more cheaply from India, squeezing Mauritian exporters on price and volume. The India-EU deal will follow similar concessions for textiles and other products and the pressure will extend on that market too.

The Way Forward

A change in market conditions requires a re-think of strategies both at the Government and firm levels. The new world trade disorder is here to stay. There is no fixing it unless the international community

decides to revert course and put back on track the WTO and its rules at the heart of world trade. But the WTO system itself is in deep crisis. It has not reacted to the Trump tariff policy which clearly undermines the WTO system. With the multiplicity of trade negotiations under way between the US and some 90 Countries, as the US President has put it, but with no visibility on the details, it is most likely that they will create a web of conflicting trade deals that will further increase entropy or disorder.

We have no option than to adapt to this new world trade disorder.

I had recently argued in an article that Mauritius must work with the African Union to lobby for a short-term extension of AGOA, but with a clear roadmap for African Countries to negotiate a partnership Agreement with the US, either at the continental level or with regional or sub-regional groups, modelled on the EPA between the EU and ACP Countries. US Congressman may be more willing to legislate AGOA's extension in the short time left on this basis rather than to have a seamless extension for a long period of time as advocated by the AGOA beneficiaries. In addition, we should pursue our strategy of opening new markets such as EURASIA, EFTA, AUSTRALIA, CANADA, MERCOSUR amongst others. We may consider joining the Comprehensive Progressive Trans Pacific Partnership (CPTPP). The world has come to realise how important market access is, and we should realise it too. We should continue creating the best market access conditions for our products and services.

The Government, through the EDB and the private sector, must henceforth be more proactive in harnessing the huge trade opportunities that our vast network of Free trade Agreements provides. Mauritius is one of the few developing countries in the world, and the only one in Africa to have concluded trade deals with all the major economies in the world: the EU second largest economy with a GDP of 20 trillion USD, China, third largest economy with GDP of 19 trillion USD, India, fourth largest economy with a GDP of 4 trillion USD, African continent, combined GDP 2.8 trillion USD, Turkey GDP 1.4 trillion, UAE 537 billion USD.


Government must undertake a complete diagnostic of the industrial sector, in collaboration with industry captains to assess the competitive strengths or weaknesses and implement measures to close competitive gaps. Mauritius can survive the competitiveness challenge if we build our production systems on a sound technological basis and produce high end products with high intellectual property content.

The sugar industry is a perfect example of how we can transform a sector by creating more value-added products, adapt to changing market conditions and use Intellectual Property to enhance quality. And so is the Rum subsector. The Mauritian speciality sugar and the Mauritian Rum are now labelled as Geographical Indications (GIs) which automatically increases the value in the eyes of consumers. This is the way ahead.

Cannabis use may quadruple diabetes risk

major analysis of health records covering more than 4 million adults across the U.S. and Europe suggests that cannabis users face nearly four times the risk of developing type 2 diabetes compared to non-users. Presented at the European Association for the Study of Diabetes, the research followed participants for five years and found that 2.2% of cannabis users developed diabetes, compared with just 0.6% of controls

Half of adults suffer from dry eyes, but most never get help

Alarge, multi-country survey presented at the European Society of Cataract and Refractive Surgeons' annual congress shows that more than half of adults in the U.S. and Europe experience symptoms of dry eye syndrome, yet most remain undiagnosed or untreated for years.

The NESTS study revealed that only about 20% of sufferers receive a formal diagnosis despite daily discomfort affecting reading, computer work, driving, and even outcomes of routine eye surgeries. Researchers warn that untreated dry eye can lead to persistent inflammation, blurred vision, corneal damage, and decreased quality of

Experts emphasize that timely management — ranging from lubricating drops and lifestyle changes to prescription



therapies — can dramatically improve comfort and eye health. Public health advocates are calling for greater awareness among both patients and primary care doctors to address what has become a silent, widespread problem.



Who invented the light bulb?

Thomas Edison is just part of the answer, and the light bulb is just part of what he achieved.

Then people name the most important inventions in history, light bulbs are usually on the list. They were much safer than earlier light sources, and they made more activities, for both work and play, possible after the Sun went down.

More than a century after its invention, illustrators still use a lit bulb to symbolize a great idea. Credit typically goes to inventor and entrepreneur Thomas Edison, who created the first commercial light and power system in the United States.

But as a historian and author of a book about how electric lighting changed the U.S., I know that the actual story is more complicated and interesting. It shows that complex inventions are not created by a single genius, no matter how talented he or she may be, but by many creative minds and hands working on the same problem.

Making light - and delivering it


In the 1870s, Edison raced against other inventors to find a way of producing light from electric current. Americans were keen to give up their gas and kerosene lamps for something that promised to be cleaner and safer. Candles offered little light and posed a fire hazard. Some customers in cities had brighter gas lamps, but they were expensive, hard to operate and polluted the air.

When Edison began working on the challenge, he learned from many other inventors' ideas and failed experiments. They all were trying to figure out how to send a current through a thin carbon thread encased in glass, making it hot enough to glow without burning out.

In England, for example, chemist Joseph Swan patented an incandescent bulb and lit his own house in 1878. Then in 1881, at a great exhibition on electricity in Paris, Edison and several other inventors demonstrated their light bulbs.

Edison's version proved to be the brightest and longest-lasting. In 1882 he connected it to a full working system that lit up dozens of homes and offices in downtown Manhattan.

But Edison's bulb was just one piece of a much more



complicated system that included an efficient dynamo – the powerful machine that generated electricity – plus a network of underground wires and new types of lamps. Edison also created the meter, a device that measured how much electricity each household used, so that he could tell how much to charge his customers.

Edison's invention wasn't just a science experiment – it was a commercial product that many people proved eager to buy.

Inventing an invention factory

As I show in my book, Edison did not solve these many technical challenges on his own.

At his farmhouse laboratory in Menlo Park, New Jersey, Edison hired a team of skilled technicians and trained scientists, and he filled his lab with every possible tool and material. He liked to boast that he had only a fourth grade education, but he knew enough to recruit

men who had the skills he lacked. Edison also convinced banker J.P. Morgan and other investors to provide financial backing to pay for his experiments and bring them to market

Historians often say that Edison's greatest invention was this collaborative workshop, which he called an "invention factory." It was capable of launching amazing new machines on a regular basis. Edison set the agenda for its work — a role that earned him the nickname "the wizard of Menlo Park."

Here was the beginning of what we now call "research and development" – the network of universities and laboratories that produce technological breakthroughs today, ranging from lifesaving vaccines to the internet, as well as many improvements in the electric lights we use

Sparking an electric revolution

Many people found creative ways to use Edison's light bulb. Factory owners and office managers installed electric light to extend the workday past sunset. Others used it for fun purposes, such as movie marquees, amusement parks, store windows, Christmas trees and evening baseball games.

Theater directors and photographers adapted the light to their arts. Doctors used small bulbs to peer inside the body during surgery. Architects and city planners, sign-makers and deep-sea explorers adapted the new light for all kinds of specialized uses. Through their actions, humanity's relationship to day and night was reinvented – often in ways that Edison never could have anticipated.

Today people take for granted that they can have all the light they need at the flick of a switch. But that luxury requires a network of power stations, transmission lines and utility poles, managed by teams of trained engineers and electricians. To deliver it, electric power companies grew into an industry monitored by insurance companies and public utility regulators.

Edison's first fragile light bulbs were just one early step in the electric revolution that has helped create today's richly illuminated world.

About 13-15 years ago, I started a job at a government agency managing a large fleet of cars. Alia also finally addressed the couple's decision to opt for an intimate wedding ceremony at their Mumbai home, Vastu, in April 2022, instead of a grand


Bollywood spectacle.





The Historian's Pen: Celebrating the Legacy of Pahlad Ramsurrun

ctober 3rd, 2025, marks the 88th birth anniversary of Pahlad Ramsurrun, an academic, author, and cultural historian whose prolific output has enriched the intellectual landscape of Mauritius. Across a career spanning over half a century, P. Ramsurrun has wielded his trilingual pen — writing in English, Hindi, and French — to capture the folk wisdom, historical narratives, and complex socio-political threads that weave the fabric of the Mauritian nation.

Born into a society grappling with the legacy of indentured labour, P. Ramsurrun took it upon himself to formally document the cultural and historical struggles of the Indian community, thereby injecting longoverdue perspective into the island's historical narrative. His journey into authorship began, somewhat serendipitously, in 1969 when he won two essay competitions: one focusing on the Arya Samaj movement in Mauritius, and the other on Indo-Mauritian relations. This dual victory was a powerful catalyst, leading to his first book, The Illustrated History of Arya Samaj in Mauritius (1970), and providing the impetus for his higher education at the University of New Delhi.

P. Ramsurrun's subsequent studies in Hindi, English, History, and Political Science not only cemented his academic credentials but also exposed him to the intellectual rigour of seasoned Indian writers and journalists, transforming him from a budding writer into a committed one. Upon returning to Mauritius in 1973, he was appointed Education Officer at the Royal College, Curepipe, where he eventually became the Head of Oriental Languages. Yet, it was outside the classroom that his true lifework flourished.

Mauritian folk culture

Perhaps Pahlad Ramsurrun's most crucial contribution lies in his meticulous preservation of Mauritian folk culture. He understood that the collective memory of the indentured community resided not just

in official archives, but in the oral traditions passed down through generations. His Mauritius ki Lok Kathayen (Folk Tales of Mauritius), published in Hindi in 1974. upholds this commitment. The inspiration for the book came from the simple stories he had heard from his mother in his childhood. By transcribing and publishing these tales, Pahlad Ramsurrun ensured that a vital, authentic piece of Mauritian cultural heritage was formally documented and secured for posterity. The book's recognition, including a literary prize from the UP Government in 1975-76 and subsequent translations into German, Japanese, and Marathi, highlights the universal resonance of these local narratives.

Pahlad Ramsurrun's bibliography is impressive. With over 50 books to his name, his expansive range covers everything from philosophical treatises and political analysis to biographies and cultural studies. Key titles like Mahatma Gandhi and His Impact on Mauritius, Swami Dayanand and His Impact on Hinduism, and Manilal Doctor Historic Court Cases in

Mauritius provide invaluable insight into the forces and figures that shaped the modern Mauritian identity.

The 'Rainbow'

n addition to his personal authorship, Pahlad Ramsurrun has made a significant contribution as the chief editor of the trilingual literary quarterly, Indradhanush (Rainbow). Launched in 1988, the magazine transitioned to a trilingual format (Hindi, English, and French) in 2000, consciously embracing the complex, diverse linguistic reality of Mauritius. Under his guidance, Indradhanush has dedicated special issues to both Francophone and Indo-Mauritian literary giants from Robert Edward Hart and Malcolm de Chazal to Manilal Doctor and Sir Seewoosagur Ramgoolam. This editorial practice has fostered a truly integrated literary dialogue, bridging the

island's cultural divides and promoting a holistic view of its intellectual heritage.

Crucially, Ramsurrun views his historical work through a lens of balance and truth. He has consistently championed the belief that Mauritian history must move beyond biased interpretations to become an "integrated history of the Mauritian People." In his view, this requires a deep. subjective, and objective study of all components of society, demanding extensive research and a conscious avoidance of "sensational analysis that may provoke the outrage of a component of society." By editing and publishing the works of earlier historians like Pandit Atmaram Vishwamath and William Bolton Draper, he provided essential foundational texts, urging a more nuanced and comprehensive understanding of the past.

On this anniversary, Pahlad Ramsurrun is rightly recognized not merely as an author, but as a tireless contributor and editor who has diligently preserved the vibrant cultural memory of a nation woven from diverse streams.



So often, we come into this world carrying the fear of our parents as it's passed down and lived through us.

then we really examine our fears about something, we sometimes notice that the fear we have is not based on our own experience. Often, if we trace our fear back to its source, we find that one of our parents may have handed it down to us. For example, your mother or father may have had an intense fear about the lack of money, stemming from their own life experiences.

If that fear was not resolved by the time you came into the picture, chances are you inherited it. Meanwhile, you may have no actual experience with this issue, so being fearful doesn't make sense. It may even block you from doing certain things you want to do.

Keeping in mind that your parents were only trying to protect you and that most of the errors in judgment they made were made with the best intentions, it might be time to release this fear symbolically. You cannot resolve someone else's fear for them, but you can decide to let go of it on your own behalf. Whether your parents are still alive or not, it is best to do this in a symbolic way, using visualization and, if you like, a ritual.

One simple visualization involves inviting your parent to sit across from you in your heart space and sharing your desire to move on from this fear. Let them know that you will not carry it anymore. You may be surprised at the response you get because it's possible they will be grateful and proud of you and your courage.

The more we do this deep inner work with our fears, the better we will be able to parent our own children without burdening them with fears that don't belong to them. Some of us will do much of this work before we become parents, while others will be working on this even as our children become adults. Either way, the effects will be felt. Once we break our ties to the fears of the past, our children's ties to those fears are greatly weakened. It's important to remember that it's never too late.
